THE DECISION IS FINAL. Coal Barons will Permit No Interference in Miners' Strikers.

WILL NOT ARBITRATE. Operators Declare that Their Position Cannot be Changed by Any Outside Influence.

New York, Aug. 27.—No new plans for arbitrating the coal strike, no matter by whom they are inspired, will be considered by the operators, and no influence that President Mitchell and the United Mine Workers can bring to bear on them will change their position one iota.

Such was the conclusion reached last night by the president of the United Mine Workers in conference with the coal barons at the Hotel Hamilton in New York.

The meeting of the coal operators was held in a private room in the Hamilton building. It was in many respects the most important held by the representatives of the United Mine Workers since the strike began.

There were present President J. P. Morgan, President Barstow of the Philadelphia and Reading, President J. B. McLaughlin of the Pennsylvania, and President T. C. McLaughlin of the Lackawanna.

The situation at the mining districts was discussed in detail, and the various reports from the mines were considered. The reports showed that the strike had not occurred yet.

President Barstow was seen in the following interview: "I am glad to see that the operators are a unit in standing by their original position."

Mr. Morgan said: "I believe it will be taken back every day, but I cannot undertake to say."

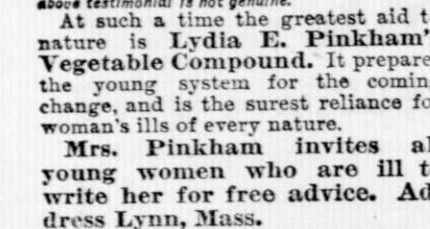

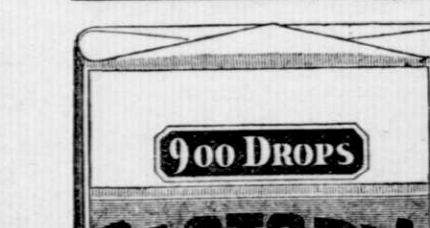

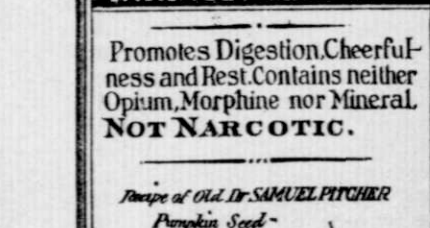
