SHERMAN ACT THE BASIS.

Proprietary, Wholesale and Retail National Associations Are Accused in the Indiana Court.

EFFORT TO STOP ALLEGED COMBINE

WASHINGTON, D. C., May 9.—The attorney general today made public the following statement:

"The evidence so far filed in the circuit court of the United States for the district of Indiana a petition for an injunction against certain associations, corporations and individuals, comprising the National Wholesale Druggists' Association, and the National Association of Retail Druggists."

"The parties defendant specifically named in the bill have voluntarily combined together to control the prices at which proprietary medicines and drugs shall be sold to the consumer through the retail druggists in violation of the Sherman anti-trust law."

"The parties to the combination include the Proprietary Association of America, the National Wholesale Druggists' Association, and the National Association of Retail Druggists."

Tells Government's Findings. Continuing the statement says:

"The Proprietary Association of America is an unincorporated association of 90 per cent of all the manufacturers and proprietors of patent medicines, chemicals, and proprietary articles in the United States. The various combinations of these associations and do business in the various states, and the products in which they deal are manufactured in the various states of the Union, and sold and distributed from the states in which they are manufactured."

"The National Wholesale Druggists' Association is also an unincorporated association composed of delegates from affiliated local organizations of retail druggists located in various parts of the country."

The evidence produced upon the trial for the purpose of showing the existence of a conspiracy, established a case substantially the same as that which is set forth in the present bill. The Loder case was decided by the court in favor of the defendants, and the court held that the National Wholesale Druggists' Association, the National Association of Retail Druggists, and the Proprietary Association of America were not guilty of a conspiracy to fix the price of such articles, and to regulate the price at which such articles shall be sold to the consumer.

SOFT COAL MEN TO BREAK STRIKE.

Want to Import 50,000 Non-Union Men to Replace Strikers in Their Fields.

CHICAGO, Ill., May 10.—The application of heroic remedies to the bituminous coal strike was considered seriously yesterday by mine operators of seven states at a convention at the Auditorium hotel.

The conference was announced originally as a "peace" meeting, but it developed such strong symptoms of hostility that the importation of 50,000 non-union men to break the miners' strike next thirty days is a probability.

In a partial programme of action the mine owners set one month as the limit for the strike, after which they would bring their men to the aid of the dictation of the strikers.

They resolved upon a final effort to bring about arbitration through President Roosevelt. Failing in this, they intend to throw their shafts open and operate the mines under the protection of the militia.

WINTER WHEAT BETTER

AVERAGE ACREAGE, HOWEVER, LESS THAN LAST YEAR.

GOVERNMENT SURVEY OF CONDITIONS OF GRAINS IS ISSUED—MAY BE BEHIND IN PLOWING.

WASHINGTON, D. C., May 10.—The report of the board of the bureau of statistics of the department of agriculture, from the reports of the correspondents and agents of the bureau, finds the area under winter wheat remaining in cultivation on May 1, 1906, to have been about 29,623,000 acres. This is 6 per cent, or about 1,718,000 acres, less than the area reported as sown last fall, and 1 per cent, or about 241,000 acres, less than the area of winter wheat reported as harvested last year.

The average condition of the growing winter wheat crop on May 1, 1906, is reported as 91, compared with 94 on May 1, 1905, 76 on May 1, 1904, and 83, the mean of the May averages for the last ten years.

The following table shows for the eleven principal winter wheat sections the average sown last fall that is now reported as abandoned; and the average condition of the crop on May 1, 1906, compared with the mean of the May averages of the last ten years:



Illegal Stallion Posters.

It should be understood by all concerned that any poster used to advertise a stallion for public service is illegal, under provision of Chapter 116 Laws of 1905, unless it shows a full and complete copy of a license certificate issued by the Department of Horse Breeding, Wisconsin College of Agriculture, and any party posting such illegal posters makes himself liable to cancellation of his license and a penalty of fifty dollars.

A full and complete copy of the license certificate must also appear in newspaper advertisements of stallions used for public service and upon all cards, handbills or other papers used to advertise the horse.

No stallion can be used legally for service in the state unless the owner affixes to the outside and inside of main door leading into every barn where horse is used a poster showing a full and complete copy of the license certificate referred to here.

Application blanks, text of the law and other necessary information may be had by addressing the undersigned.

—Many people believe that the \$50,000 a year which the President gets as salary is the sum total of his official income. It is a mistake. This is how he is paid: \$36,064 is given him in addition to his salary of \$50,000 to pay the salaries of his subordinates and clerks. His private secretary is paid \$3,250, his assistant private secretary \$2,250, his stenographer \$1,200, five messengers (each) \$1,200, a steward \$1,800, two door-keepers (each) \$1,205, four other clerks at good salaries ranging from \$1,500 to \$2,500, one telegraph operator, two ushers, \$1,200 and \$1,400, a night usher, \$1,200, a watchman, \$700, and a man who takes care of the fires who receives \$864 a year. In addition to this there is given him \$8,000 for incidental expenses such as stationery, carpets and the care of the presidential stables. And under another heading there is given him nearly \$40,000 more. Of this \$12,600 is for repairs and refurbishing the White House, \$2,500 is for fuel, \$4,000 is for gas, matches and the stable. The White House all told costs the country in connection with President considerably over \$125,000 a year.
