OLDEST SETTLER OF VILLAGE DIES

Mathias Theisen Sr. Passes Away at Campbellsport. Leaves a Large Family

Mathias Theisen Sr., the oldest settler of Campbellsport, died at 8 o'clock Thursday evening at the home of his daughter, Mrs. Nicholson, a Mrs. Theisen, who was born in the village of Campbellsport. He was born at Luxemburg, Germany, July 3, 1823 and was married there in 1829 to Elizabeth Schaefer. They came to America in 1854 and settled in the town of Ashford, where they lived for ten years. They then moved to the town of Lomira, where they resided for the next thirty-two years after selling their property there they moved to the village of Campbellsport, where they lived until Mrs. Theisen's death in December, 1905. Since then Mr. Theisen has lived with his children. Mr. Theisen leaves six children Mrs. Nicholas Enfelt, Campbellsport; Mrs. Barney Walters, Hartford; Mrs. Louis Gundrum, Allenton; Bertram, John and Mary of Campbellsport. Two children, William and Mrs. J. A. Tesch, preceded him in death. He also leaves twenty-eight grand children and eleven great grandchildren.

Meeting of Farmers to be Held at West Bend

Farmers will assemble at Washington county's experiment station the County Asylum farm at West Bend—on Thursday, August 11, to review the year's work and examine the numerous interesting and valuable tests that have been run this season. Further details of programs of the event will be announced later by Supt. John Homig.
Hemp, which is becoming one of the state's important crops, and for which war time prices are being paid at present, has been given a general test here for fiber and seed production. It is possible that Washington county can do as well in hemp culture as the area near Fond du Lac and Green Lake counties, but that remains to be seen. Sudan grass, the so-called "camel of the grass family," a heavy yielding forage crop, is being tried out at West Bend, as well as pedigree plots of oats, and variety and seeding tests with soy beans.
They say bean promises to become a leading field crop in Wisconsin, for seed, hay, pasture, silage and as a manuring crop. It may be grown with profit and advantage to the soil. It can withstand cold climates better than corn, cow peas or field beans. All classes of ordinary soil are adapted to its culture, but as a legume it is particularly fitted as a nourisher and builder of fertility in worn out sandy soils. Inoculation with bacteria laden soil, scattered broadcast or sown with the seed, is desirable, especially where the land is not in high fertility. Reasons for growing soy beans have been stated by J. B. Dewitche, R. A. Moore and E. J. Dewitche, of the field crops department, State Experiment Station as follows:
They are more resistant to drought than clover or alfalfa.
They may be substituted as a catch crop for clover, when the latter kills out or is buried in sand drifts.
They rank with linseed and cottonseed meal as concentrated feed for live stock.
They gather nitrogen from the air and store it in their roots, thus improving the soil in which they grow.
They may be grown with good results on soil too acid for clover.
Dissection of various types of insects in this locality, cultural pointers and methods of harvesting, as well as comparative studies of plots of soy beans sown at different times and different dates, will be taken up at the county farmers' meetings.
