## Ordinance Setting New Wastewater Charges Passed by Village Board

An ordinance that sets new wastewater treatment charges for the Village of Kewaskum was passed by members of the village board Monday night. The new rates go into effect April 1 and will be reflected on the water bills rendered for the quarter ending June 30.

The revised ordinance sets forth service charges that meet with approval of the Environmental Protection Agency (EPA) in order for the village to qualify for reimbursement grants on expansions made to the village wastewater treatment plant in 1972.

The EPA ruled that all users must pay their way equitably. The sewage rates in force now are not equitable by EPA standards.

Residential users will be charged on water usage at the rate of 79 cents per 1,000 gallons per quarter. Under existing rates, each household pays a flat quarterly charge of \$14 regardless of how much water is used. It will mean lower bills for many households.

Commercial users will also pay according to water usage. Presently they are charged a flat fee of \$35 or \$21 per quarter depending upon the size of the water meter, which in turn depended on the size of the establishment.

Industrial users will be billed on the recorded volumes of flow determined from the control manhole measuring device, required under the new ordinance, plus surcharges on concentrations of bio-chemical oxygen demand (b.o.d.) and suspended solids, greater than 250 milligrams per liter.

The b.o.d. surcharge will be at the rate of 10 cents per pound on the excess. Suspended solids surcharge will be at the rate of 6 cents per pound on the excess. The new rates will mean industries will get a boost in their bills.

The revised ordinance also states that no surface or sub-surface water flowing from roof, yard or sump pump will be allowed to enter sanitary sewers. Such water must be drained on to lawns. Cooling waters and other non-polluting waters are also not permitted to enter sanitary sewers.

Village residents will be so notified and given 90 days from April 1 to correct any such violations.

The new rates and related ordinance were prepared at village request by Dr. Raymond Kipp, professor of civil engineering at Marquette University. He worked with EPA to meet its requirements.

In other business, Peter Albers, superintendent of the wastewater treatment plant was given permission to attend two one-week seminars at Madison sponsored by the University of Wisconsin College of Engineering and the

Department of Natural Resources. He said he is especially interested in going because much of the seminar will deal with chemical treatment and he has not attended a seminar in four years. Cost to the village will be \$20 per week for a dormitory room plus meals and mileage.

She was born May 24, 1881, in the Town of Auburn, a daughter of the late August G. and Bertha Beilke Bartelt. She was married to Robert Bartelt at St. John's Lutheran Church, New Fane, Oct. 13, 1903, and the couple farmed north of Kewaskum for many years. Her husband preceded her in death on Aug. 17, 1963.

Mrs. Bartelt was a member of St. Lucas Lutheran Church, Kewaskum.

Survivors include three daughters, Bertha (Edwin) Paskey, West Bend, Mrs. Irene Prost, Kewaskum, and Elenore (Elmer) Schultz, West Bend; one son, Robert A. (Doris) Bartelt on the homestead, R. 2, Kewaskum; six grandchildren, five great-grandchildren, other relatives and friends.

Visitation was at Miller's Funeral Home, Kewaskum, after 3 p. m. Sunday. Complete funeral services were held at 8 p. m. Sunday at the funeral home. Pastor Paul Hoenecke officiated and interment was in St. Lucas Cemetery.

## Village, School Board Members To Be Elected

Next Tuesday, April 2, is Spring Election Day. Polls in the Village of Kewaskum and eight townships or parts of townships in the Kewaskum School District will be open from 9 a. m. to 8 p. m.

Four candidates, including three incumbents, will be after three vacancies on the village board. Incumbents are Kaynor Herriges, Gregor Nigh and Elmer Yoost. Richard Zarling is the challenger. Herriges will be out for his fifth two-year term, Nigh out for his third two-year term, and Yoost seeking his fifth two-year term. This will be Zarling's second attempt at election as he ran in 1972.

Clara J. Trapp, Richard L. Edwards, Richard Theusch and Thomas W. Gundrum will compete for two positions on the board of education for Kewaskum Community Schools Joint District No. 2. These four captured the most votes among six candidates in a school board primary election March 5. Mrs. Trapp is a first time candidate. Edwards has been on the board for 10 years. Theusch was a board member from 1970 to 1973 but did not seek re-election last year. Gundrum, who now serves as board chairman, will be after his second three-year term.

On the county supervisor ballot, Charles F. Miller of Kewaskum will be unopposed for re-election.

On the judicial ballot, Justice of the Supreme Court Horace W. Wilkie will be opposed by Raymond C. Johnson. These two won out in the recent primary.

Three referendum questions will also be voted on Tuesday's election.

## Memorial Services for Capt. Fickler

Memorial services for Capt. E. James Fickler, USMC, of Kewaskum, who has been officially presumed to have died in the Vietnam war, will be held at 2 p. m. Saturday, March 30, at Peace United Church of Christ in Kewaskum. Rev. Daniel Schowalter will officiate at the services.

Capt. Fickler, whose plane went down while on a night mission in Vietnam Jan. 17, 1969, was born in West Bend May 4, 1943. He graduated from Kewaskum High School in 1961, Wisconsin State University-Stevens Point in 1965 and received his wings in April, 1967. He left for Vietnam a year later.

Survivors include his parents, Mr. and Mrs. Edwin Fickler, Kewaskum, two sisters, Mrs. Nancy (Larry) Wickert, West Bend, and Mrs. Colleen (Steve) Bradford, Downers Grove, Ill., and a brother, Gary, Kewaskum.

Capt. Fickler was a member of Sigma Phi Epsilon Fraternity.

## Kiwanis Club Donates \$77,000 For Park Site

It is now official that the Kewaskum Kiwanis Club will donate \$77,000 to the Village of Kewaskum for some 35 acres of land to be used as a park site here.

Voting by ballot, the club membership approved the donation after the Kewaskum Kiwanis Foundation Board earlier this month went on record to recommend to the club that the donation be made. Ballots distributed two weeks before were tallied at the weekly Kiwanis meeting last week.

The foundation is made up of Kiwanis members but is a separate entity formed to be in charge of these funds and has its own officers. Funds were raised from live turkey shoots the club sponsored beginning in 1952. When live turkey shoots were outlawed several years ago, the club went to using balloons as targets on the firing lanes.

A Kiwanis Foundation spokesman said that its board will meet to draft a communication to the village board stating that the money will be available when needed. The village voted last December to take an option on approximately 34 acres of land for park purposes at \$2,200 per acre. The option is with Mrs. Viola Spoerl on land at the southwest limits.

The village is also seeking funds through the state Outdoor Recreation Act Program (ORAP-200) toward park costs.

## Cancer Drive To Open; Name Local Committee

Every year during April, about 2,000,000 volunteers of the American Cancer Society ring doorbells and ask the American people to dig down and give to help defeat cancer.

"This year ACS budgeted more than \$79 million, of which over \$62 million went for research, education, service and rehabilitation," declared John C. Hubbell, residential chairman of the Kewaskum Committee today announcing the opening of the ACS annual educational and fund-raising Crusade. Besides direct contributions the Society also receives support from legacies.

"Research which is making gains against cancer will receive about 30 cents of each dollar or about \$24 million," he noted.

"Informing people about cancer's Seven Warning Signals and urging regular health checkups to discover cancer at its earliest and most curable stage are at the heart of our public education program and received about 18 cents of each dollar or \$14 million," Hubbell said.

Patient and community services such as the Reach to Recovery program for women who have had breast surgery or teaching people who've lost their voices after throat cancer surgery how to speak again will receive more than \$15.5 million or about 19 cents of each dollar.

(Cancer is the leading cause of death among women aged 30 to 54. Therefore the Washington County Cancer Society will have a free breast and uterine cancer education program on Tuesday, April 23, at 8 p. m. at the West Bend West High School, Room 235. The speaker will be Dr. I. H. Bae, gynecologist and obstetrician).

Nearly 11 cents of each dollar or about \$8.6 million will be devoted to professional education. These programs provide physicians, dentists, nurses and other medical personnel with the latest information on diagnosis and treatment of cancer.

Fund raising will take 11 cents of each dollar or \$8.9 million; management of the Society's affairs takes 10 cents or \$7.9 million.

"Together we can win the war against cancer," declared Hubbell. "We want to wipe out cancer in your lifetime. Join us by being alert to cancer's warning signals and by having a periodic health checkup. Then help others with a check or cash."

Eugene Bohn, Mrs. Robert Schlamer and Gerald Stollenwerk are helping in promoting the American Cancer Society drive through the Kewaskum community.

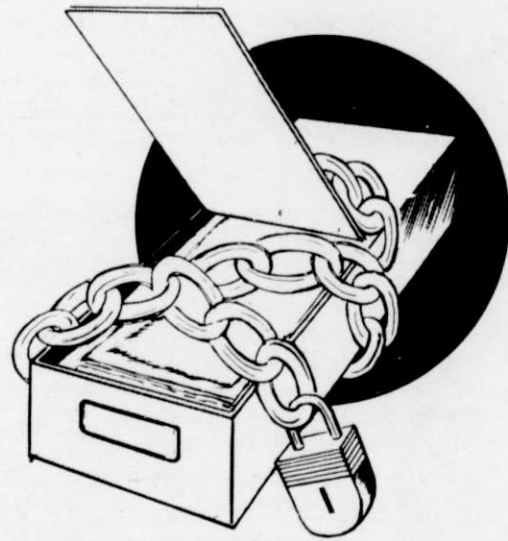

## Facsimile Ballot Notice of Village Election Village of Kewaskum, Wisconsin

Notice is hereby given of village election to be held in and for the Village of Kewaskum, Washington County, Wisconsin, on the 2nd of April, 1974, at which the officers named below shall be chosen.

### INFORMATION TO ELECTORS

The following instructions are given for the information and guidance of electors:

(a) Upon entering the polling place, an elector shall give his name and address before receiving the ballot from the ballot clerk. The initials of 2 ballot clerks must appear on the ballot. Upon receiving the ballot, the elector shall retire alone to a voting booth and mark his ballot. A ballot clerk may inform the elector of the proper manner for marking a ballot, but he shall not in any manner advise or indicate for whom to vote.

(b) To vote for a person whose name is printed on the ballot, make a cross (X) or mark in the square after the name of the person for whom you desire to vote. To vote for a person whose name is not printed on the ballot, write the name in the blank space provided for the purpose.

(c) The ballot should not be marked in any other manner. If the elector spoils a ballot, he shall return it to an election official who shall issue another in its place, but not more than 3 ballots shall be issued to any one elector. Not more than 5 minutes' time shall be allowed to mark the ballot. Unofficial ballots or a memorandum to assist the elector in marking his ballot may be taken into the booth and copied. The sample ballot shall not be shown to anyone so as to reveal how the ballot it marked.

(d) After the official ballot is marked, it shall be folded so the inside marks do not show but so the printed indorsements and ballot clerks' initials on the outside do show. After folding the ballot, the elector shall leave the booth, give his name to the inspector in charge of the ballot box, hand him the ballot to be placed in the ballot box, and leave the polling place promptly.

(e) An elector may be assisted by 2 election officials of different political parties in marking the ballot if he declares to the presiding official that he is unable to read or that due to physical disability he is unable to mark his ballot. If an elector declares that he is visually handicapped, he may have anyone assist him in marking his ballot. The presiding official may administer an oath as to a person's disability.

(f) Any qualified elector who is absent, or expects to be absent from the village in which he is a qualified elector, or who, because of sickness or physical disability cannot appear at the polling place on election day, may vote at such election by means of an absent voter's ballot to be secured upon application to the Village Clerk, not more than sixty days and no less than three days, or by personal application, not later than the close of office hours on the day prior to such election.

(g) The following is a sample of the official ballot:

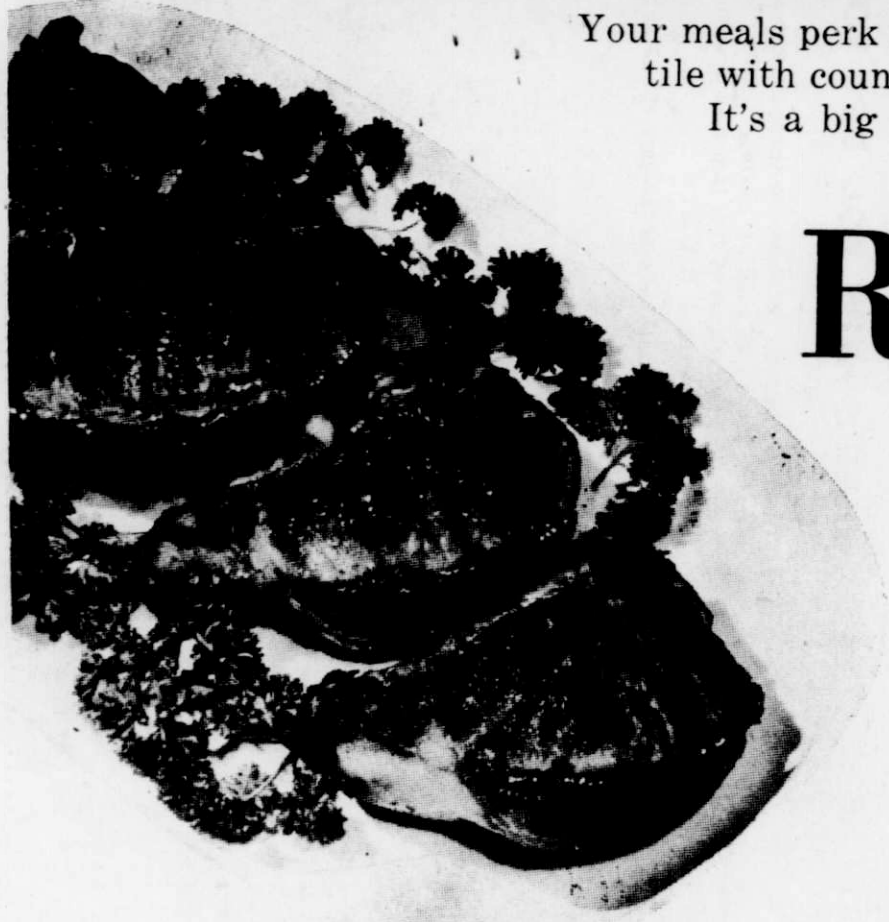

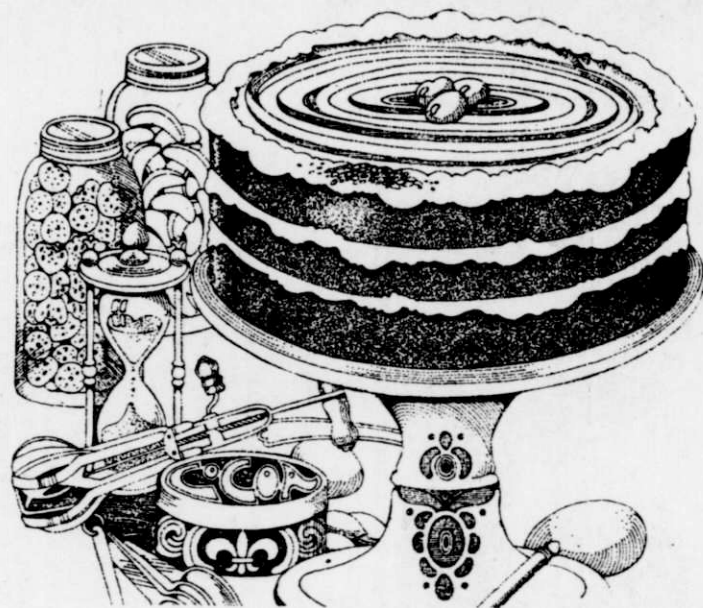

**ORDINANCE NO. 74-1**

The Village Board of the Village of Kewaskum does ordain as follows:

SECTION I. Repeals ordinance number 71-3 in its entirety and hereby recreates an ORDINANCE TO REGULATE, RESTRICT, AND LIMIT, IN THE INTEREST OF THE PUBLIC HEALTH AND SAFETY, THE DEPOSIT OR DISCHARGE OF CERTAIN SUBSTANCES INTO ANY SANITARY SEWER NOW MAINTAINED AND/OR OWNED BY OR WHICH MAY BECOME THE PROPERTY OF THE VILLAGE OF KEWASKUM, WISCONSIN.

**SECTION II. DEFINITIONS**

1. **Sanitary Sewer** is a sewer intended to receive domestic sewage and industrial waste, except that of the type expressly prohibited by this ordinance, without the admixture of surface water and storm water.

2. **Domestic Sewage** is that liquid waste from bath rooms, toilet rooms, kitchens and home laundries.

3. **Industrial Wastes** are the liquid wastes, other than domestic sewage, resulting from processes or operations employed in industrial and commercial establishments.

4. **"B.O.D."** (Denoting Biochemical Oxygen Demand) shall mean the quantity of oxygen utilized in the biochemical oxidation of organic matter under standard laboratory procedure in 5 days at 20° C., expressed in milligrams per liter.

5. **"Properly Shredded Garbage"** shall mean the wastes from the preparation, cooking, and dispensing of food that have been shredded to such degree that all particles will be carried freely under the flow conditions normally prevailing in sanitary sewers, with no particle greater than 1/2 inch in any dimension.

6. **"Suspended Solids"** shall mean solids that either float on the surface of, or are in suspension in water, sewage, or other liquids; and which are removable by laboratory filtering as specified in the latest edition of the **Standard Methods for the Examination of Water and Wastewater**, published by the American Public Health Association.

7. **"pH"** shall mean the logarithm of the reciprocal of the concentration of hydrogen ions in grams per liter of solution. A stabilized pH will be considered as a pH which does not change beyond the specified limits when the waste is subjected to aeration. A pH value indicates the degree of acidity or alkalinity.

8. **Color** is the "true color" due to the substances in solution expressed in wave lengths of light.

9. **Person** is any individual, firm, company, association, corporation or institution.

10. **Village** is the Village of Kewaskum, Wisconsin.

11. **Receiving Stream** is that body of water, stream or water course receiving the discharge waters from the wastewater treatment plant or formed by the waters discharged from the wastewater treatment plant.

12. **Approving Authority** shall be the Village Engineer.

**SECTION III. USAGE OF MUNICIPAL SANITARY SEWERS**

1. No person shall discharge or deposit any of the following waste materials into any Village sewer:

(a) Any liquid or vapor

having a temperature higher than 160° F.

(b) Any water or waste which contains a concentration greater than 100 mg/liter of fat, oil, or grease, exclusive of soap.

(c) Any flammable or explosive liquid, solid or gas, including, but not limited to gasoline, benzene, naphtha, and fuel oil.

(d) Any garbage that has not been properly shredded.

(e) Any ashes, cinders, sand, mud, straw, shavings, metal, glass, rags, feathers, tar, plastics, wood, paunch manure, or other solids or viscous substance capable of causing obstruction to the flow in sewers or other interference with the proper operation of the wastewater treatment works.

(f) Any waters or wastes having a stabilized pH lower than 5.5 or higher than 9.0, or having any other corrosive property capable of causing damage or hazard to structures, equipment, and personnel of the wastewater treatment works.

(g) Any waters or wastes having a Biochemical Oxygen Demand in excess of 2000 mg/liter.

(h) Any waters or wastes containing more than 2000 mg/liter of suspended solids.

(i) Any waters or wastes having an objectionable color which is not removable in the existing wastewater treatment plant processes.

(j) Any waters or wastes containing a toxic or poisonous substance or any other materials in sufficient quantity to injure or interfere with any wastewater treatment process, or constitute a hazard to humans or animals, or create any hazard in the receiving stream at the wastewater treatment plant.

The following materials are listed as toxic and hazardous substances along with the limits.

(k) Any waters or wastes containing suspended solids of such character and quantity that unusual attention or expense is required to handle such materials at the normal wastewater treatment plant.

(l) Any noxious or malodorous gas or substance capable of creating a public nuisance.

2. No surface or subsur-

face water flowing from surface drains, roof drains, yard drains, foundation drains, etc., shall be permitted to enter the sanitary sewers. Cooling waters and other nonpolluting waters are also not permitted to enter the sanitary sewers.

3. The Approving Authority, without limitation by other sections of this ordinance, may authorize any person to discharge industrial waste of unusual strength or character into the sewers of the Village under approved conditions or pretreatment. Unusual strength or character refers to those wastes which may exceed the limits set in Section III, paragraph 1, but which may be amendable to pretreatment or which, in the opinion of the Approving Authority, will not interfere with the treatment of the wastewater or constitute a hazard to humans or animals or to the receiving stream. The Approving Authority may prohibit entry of particular industrial wastes into the sanitary sewer whenever such action is necessary to prevent damage to the system or to determine the effects of such wastes on the sewage system. Pretreatment of wastes may be required by the Approving Authority to meet the limits imposed in Section III, (1) or to a degree which will make the waste amenable to treatment in the village's STP.

**SECTION IV: STRUCTURES REQUIRED**

1. **Storage Tanks:** In order to equalize flows over a 24-hour period, each person discharging a waste into the Village's sanitary sewers having a volume in excess of 500,000 gallons in any one day, shall construct and maintain at his own expense a suitable storage tank. Said tank shall have a capacity of at least 80% of the normal volume of one 24-hour production period of waste and whose outlet to the sewer is controlled by a water works type rate controller, or other approved device, the setting of which shall be directed by the Approving Authority.

2. Any person discharging industrial wastes into Village Sanitary sewers shall construct a suitable control manhole, downstream from any pretreatment, storage, or other approved works, to facilitate observation, measurements and sampling of all wastes including domestic sewage, from the industry. The control manhole shall be constructed at a suitable and satisfactory location and built in a manner approved by the Approving Authority.

Where a storage tank is not required, the control manhole shall be equipped with a permanent type volume measuring device such as a nozzle, or other suitable device, with a recorder as may be approved by the Approving Authority. The manhole shall be installed at the expense of the person discharging the wastes and shall be maintained by the Village so as to be safe, accessible and in proper operating condition at all times.

3. Plans for the construction of said storage tank, control manhole, and controlling devices shall be approved by the Approving Authority prior to the beginning of construction.

**SECTION V: PERMITS**

Any person desiring to deposit or discharge any industrial waste into the sanitary sewers shall make application for the disposal of indus-

trial waste to the Approving Authority. The Approving Authority shall approve such applications only when evidence is submitted by the applicant that the discharge into the sanitary sewer will comply with all of the regulations of this ordinance.

**SECTION VI: OUTSIDE CONNECTIONS**

Any person owning or controlling premises located beyond the corporate limits of the Village of Kewaskum and desiring to install a plumbing system for the purpose of discharging domestic sewage and/or industrial waste into the sanitary sewers of the Village of Kewaskum must obtain permission from the Village Board. If permission is granted, the user must comply with all of the requirements of this ordinance and will be required to pay a permit fee of \$100.00. Each service connected must include a meter, approved by the Approving Authority, for purpose of flow measurement. In addition to the quarterly fees determined according to the rates set forth in this ordinance, a surcharge of 25% will be assessed on each quarterly statement.

**SECTION VII: POWERS AND AUTHORITY FOR INSPECTION**

The Approving Authority and other duly authorized employees of the Village, bearing proper credentials and identification, shall be permitted to enter upon all properties for the purpose of inspection, observation, measurement, sampling, and testing, in accordance with the provisions of this ordinance.

**SECTION VIII: WASTEWATER TREATMENT CHARGES**

1. **Residential Users**  
All persons discharging wastewater into the Village sanitary sewer system shall be rendered a quarterly bill determined from the volume of flow. The rate will be

\$0.79 per thousand gallons. The volume of flow used in computing the charges shall be based upon metered water consumption as shown in the records of meter readings maintained in the Village Water Department.

2. **Commercial and Industrial Users**

All commercial units and industrial users discharging wastewater into the Village sanitary sewer system shall be rendered a quarterly bill determined from:

(a) Volume of flow as determined by metered water consumption as shown in the records of meter reading maintained in the Village Water Department or from recorded volumes of flow determined from the control manhole measuring device required under Section IV of this ordinance, at the rate of \$0.79 per thousand gallons, plus

(b) For all wastewater discharged into the sanitary sewer system which contains a concentration of B.O.D. greater than 250 mg/liter, a surcharge of \$0.10 per pound of B.O.D. on this excess, plus

(c) For all wastewater discharged into the sanitary sewer system which contains a concentration of suspended solids greater than 250 mg/liter, a surcharge of \$0.06 per pound of suspended solids on this excess.

(d) The total cost for each industrial discharge shall be computed from the quarterly analyses as follows:

(e) An annual audit as applicable to the wastewater treatment plant, of all revenues and costs, to include, but not be limited to, construction, amortization, operation and maintenance, shall be required by the Village Commissioner. If the cost-revenue pattern changes, the charges to all users shall be adjusted.

#### SECTION IX: DETERMINING OF CHARACTER AND CONCENTRATION OF WASTES

1. The Approving Authority or an assistant designated by it shall make a quarterly determination of the character, concentration and quantity of wastes discharged.

2. The location and design of sampling sites should be approved by the Approving Authority.

3. Samples shall be collected in such a manner as to be satisfactory to the Approving Authority or the assistant designated. The laboratory methods used in the examination of said wastewaters shall be those set forth in the latest edition of the **Standard Methods for the Examination of Water and Wastewater**, published by the American Public Health Association.

4. The determination of the character, concentration and quantity of the industrial wastes by the Approving Authority, or his authorized assistants, shall be binding as a basis for charges. Industries desiring to have another sample taken other than at regular intervals may request the Approving Authority to take such samples, at the expense of the industry making such request.

5. Costs incident to sampling and analyzing of wastes that are applicable to surcharges shall be paid by the Village.

#### SECTION X: BILLING

1. Bills will be sent with the water bill through the United States mail notifying all persons of the amount and date due. Failure to receive notice is not an excuse for non-payment of bills.

2. Bills are rendered every three (3) months, and are mailed on the tenth (10th) of the month following the quarter.

3. Persons not having paid their bills by the 25th of the

month following the quarter, that being the due date, will be delinquent. A 10% penalty is added to all sewage bills that are not paid by the due date, the water connection serving the premises will be turned off without further notice if the bill is not paid on or before the last day of the month following the quarter and will not be turned on again until said bill is paid.

4. Bills are payable at the office of the Village Commissioner.

5. In case a person discharging wastes into the Village sanitary sewer system does not procure his water supply from the Village of Kewaskum and becomes delinquent in his payment of the aforesaid surcharge, his connection with the Village sewer system will be severed and will only be reconnected at his expense.

6. The sewerage service charges as levied pursuant to this ordinance shall be a lien upon the property served pursuant to section 66.069 and 66.076 (7) Wisconsin Statutes, and shall be collected in the manner therein provided.

7. The funds received from sewerage service charges shall be deposited at regular intervals in a depository to be designated by the Village Board. Said funds shall be available for the payment of the cost of construction, cost and expenses of management, maintenance, depreciation and repair of the sewerage treatment plant, and to provide funds for the retirement of bonds as they mature, and interest thereon.

8. The amount received from the collection of the charges authorized by the ordinance shall be credited to a sanitary sewerage system. When appropriate by the Village Board, the credits to said account shall be available for the payment of the requirements for operation, maintenance, and repairs of the sewerage system. Any surplus in said account shall be available for the payment of principal and interest of bonds issued and outstanding, or which may be issued, to provide funds for said sewerage system, or part thereof and all of a part of the expenses for additions and improvements and other necessary disbursements or in-

debtedness, and the Village Board may by resolution pledge such surplus or any part thereof for any such purpose.

#### SECTION XI: PROTECTION FROM DAMAGES

It shall be considered a misdemeanor to maliciously, willfully, or negligently break, damage, destroy, uncover, deface or tamper with any equipment or materials belonging to the Village of Kewaskum used for the purpose of making tests or examinations and left upon the premises of a person discharging wastes into the sewers.

#### SECTION XII: DISCHARGES CAUSING DAMAGES AND PENALTY PROVISIONS

1. Any damages which occur at the wastewater treatment plant or to the receiving waters downstream of the wastewater treatment plant which are caused by an accidental discharge from an industry and which must be repaired or corrected by the Village are the liability of that industry. The Village Commissioner will assess all costs, for such repair and corrections, in time and materials, to the industry responsible for the accidental discharge. A fine of \$100.00 for each day that the accidental discharge occurs will be assessed in addition to the costs for repair and correction.

2. Any person who shall violate any provisions of this ordinance other than the provisions of paragraph 1, Section XII above shall, upon conviction of such violation, be subject to a penalty, which shall be as follows:

(a) **First Offense—Penalty.** Any person who shall violate any provision of this ordinance other than paragraph 1, Section XII above shall, upon conviction thereof, forfeit not more than \$100.00 together with the costs of prosecution and in default of payment of such forfeiture and costs of prosecution shall be imprisoned in the county jail until said forfeiture and costs are paid, but not exceeding 30 days.

(b) **Second Offense—Penalty.** Any person found guilty of violating any provision of this ordinance other than paragraph 1, Section XII above who

shall previously have been convicted of a violation of the same provision shall upon conviction thereof, forfeit not less than \$10.00 nor more than \$100.00 for each such offense, together with the costs of prosecution and in default of payment of such forfeiture and costs shall be imprisoned in the county jail until said forfeiture and costs of prosecution are paid, but not to exceed 3 months.

(c) Each violation and each day a violation continues or occurs shall constitute a separate offense. Nothing in this ordinance shall preclude the Village from maintaining any appropriate action to prevent or remove a violation of any provision contained in this ordinance.

#### 3. Execution against Defendant's Property

Whenever any person fails to pay any forfeiture and costs of prosecution upon the order of the court for violation of this ordinance the court may, in lieu of ordering imprisonment of the defendant, or after the defendant has been released from custody, issue an execution against the property of the defendant for said forfeiture and costs.

#### SECTION XIII: REPEALING CLAUSE

All ordinances or parts of ordinances in conflict with this ordinance are hereby repealed. If any section, paragraph, sub-division, clause, or provision of this ordinance shall be adjudged invalid, such adjudication shall apply only to such section, paragraph, subdivision, clause or provision so adjudged, and the remainder of this ordinance shall be deemed valid and effective.

#### SECTION XIV: EFFECTIVE DATE

This ordinance shall take effect and be in full force from and after the 1st day of April, 1974.

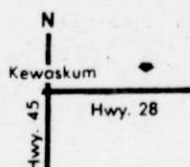

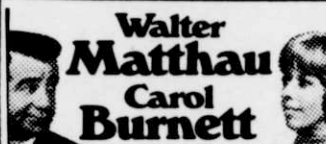

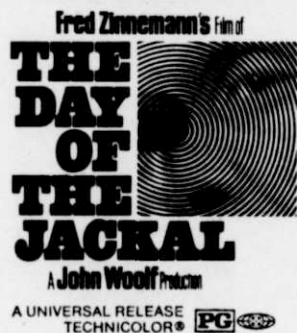
