## Win First Annual Jaycee Awards

Kathy Spencer (shown with Principal Clark Pearson) has been chosen the Outstanding Young Educator for 1975. The award which was presented to her at the School Board meeting on March 29, was the first annual OYE award given by the Kewaskum Jaycees. Miss Spencer has taught Spanish and Math at Kewaskum High School for the past five years. She has been an advisor of the American Field Service Club and the Spanish Club. She has also served as a chaperone to groups of students on trips to Mexico, Spain, New York and Washington, D. C.

Miss Spencer is very active in education associations such as Kewaskum Education Association, Wisconsin Education Association, and the Council of Teachers of Span-

ish. Miss Spencer is a coordinator of the educational staff for the advancement of foreign languages. She also served as a member of the North Central Steering Committee.

The Outstanding Young Educator Award is presented annually to a teacher in the Kewaskum School District between the ages of 18 - 35 who shows exceptional job performance. ## Village Trustees, School Board, Presidential Preference, 3 Other Ballots to Be Voted on Tuesday

Next Tuesday, April 6, is Spring Election day in Wisconsin. Polls will be open from 9 a. m. to 8 p. m. in the village and area townships. Balloting in the village will be at the municipal building and for the Town of Kewaskum at the Labor Center in the village.

Three village board trustees will be elected and there are four candidates. The three incumbents are Gregor A. Nigh, Elmer Yoost and Raynor Herriges. They will be opposed by Robert A. Danielsen.

Two school board members of Kewaskum Community Schools, Jt. School District No. 2, will also be elected. There are three candidates for the two positions. They include two incumbents, Byron W. Gessner and Gerald Secor. The third candidate is Richard A. LaFleur.

On the county supervisory ballot, Charles F. Miller, village president and incumbent member of the Washington County Board for the Village of Kewaskum, District No. 10, will be unopposed for reelection. In District No. 9, Town of Wayne and Town of Kewaskum, John A. Oelhafen, incumbent, is unopposed. In District No. 11, Town of Farmington and Town of Trenton, Norbert Dettman, incumbent, is also unopposed.

On the judicial ballot for justice of the supreme court

Roland B. Day, incumbent, is opposed by Leander J. Foley.

Ballots will also be cast on a Presidential Preference Vote for candidates on the Republican and Democratic ticket. Candidates on the Republican ticket are Gerald R. Ford and Ronald Reagan. Those listed on the Democratic ticket are Sargent Shriver, George Wallace, Lloyd Bentsen, Jimmy Carter, Morris Udall, Fred Harris, Ellen McCormack, Henry M. Jackson, Birch Bayh and Milton Shapp. There are no candidates listed on the American Party ballot.

Voters will also cast their ballot on a referendum question which reads as follows: "Shall section 3 of article XI of the constitution be amended to increase the debt limit for counties, cities, towns, villages or other municipal corporations from 5% to 10% of the state equalized valuation of the taxable property located in each such district?"

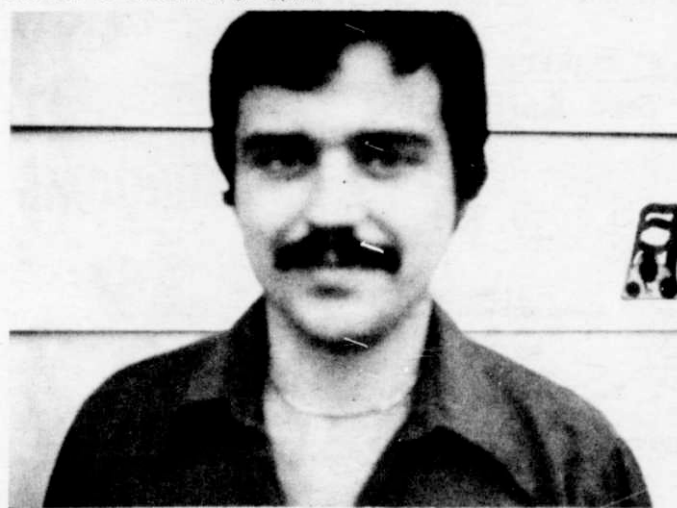
### STORY HOUR TO BEGIN APRIL 15

**Workers Can File for Storm Disaster  
Unemployment Assistance April 1-3**

On March 23, the President declared 22 counties in Southern Wisconsin a major "disaster" due to the severe rain, ice and snow storms between March 1, 1976 and March 12, 1976.

People living or working in a designated county who wanted to work between March 1 and 12, but were unable to do so because of the ice storm, may be eligible for Disaster Unemployment Assistance (DUA).

Individuals living or working in Washington or Ozaukee counties who wish to file DUA claims may do so at the

Washington County Court House Auditorium on April 1, 2, or 3, between the hours of 10:00 a. m. and 8:00 p. m. Claimants should present any available evidence of the amount of their earnings and the number of weeks worked in the past 52 weeks to establish their claims. Income tax records are considered to be valid evidence.

Special federal funds are provided to finance DUA. Funds for DUA do not come from employer taxes used to pay for regular state unemployment compensation program.

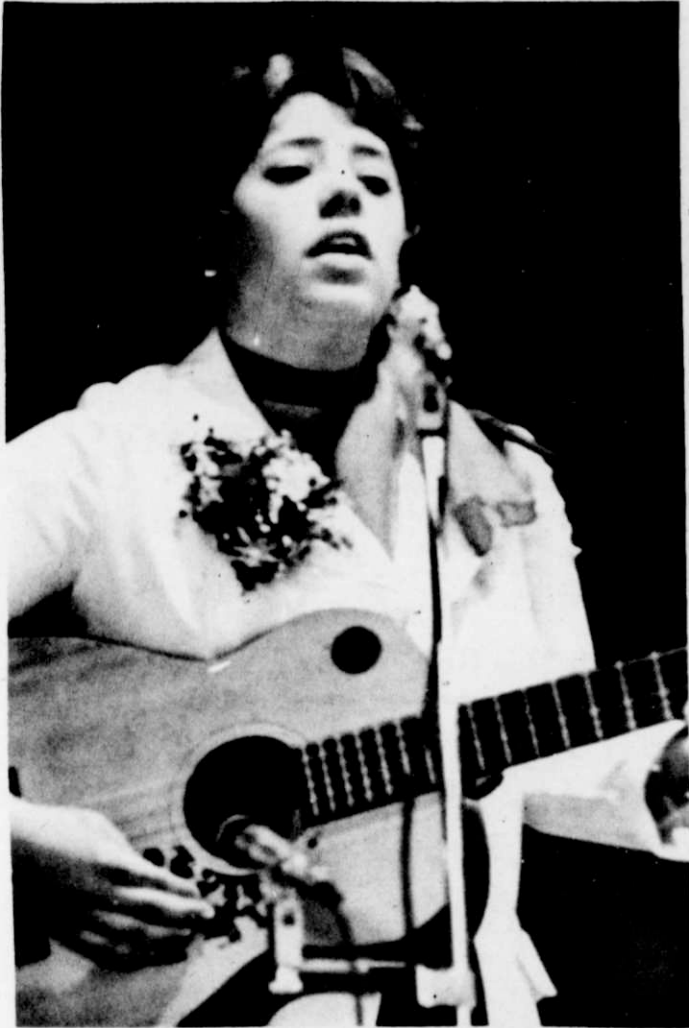

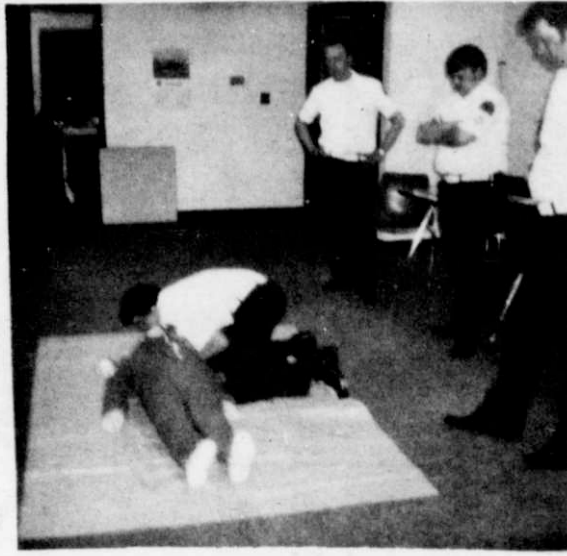

## Rescue Squad Gives Demonstration on Emergency Care

The Kewaskum Junior Women's Club and the Kewaskum Fire Department Rescue Squad sponsored a demonstration on emergency care given by the rescue squad and its emergency medical technicians. It was held last Thursday evening, Mar. 25, at 7:15 p. m. at the Valley Bank meeting room.

The demonstration was not only of the practical, but the theory behind today's modern up-to-date emergency care by rescue squads and their technicians.

The demonstrations included emergency treatment of heart attacks (C.P.R.), auto accident and possible back injuries, child household ac-

cidents including burns, glass cuts, eye injury and hand cuts, skiing and snowmobiling injuries including fractured femur (large bone in the upper leg) and dislocated elbow, etc.

## NOTICE

The Wisconsin Flammable and Combustible Liquids Code requires that gasoline and diesel fuel storage tanks shall be installed underground when the stored motor fuel is dispensed into the fuel tanks of motor vehicles. Approval for the tank installation shall be obtained from your local fire chief before installation or operation.

Gasoline and diesel fuel storage tanks may be installed aboveground on farms and construction projects providing the tank is located outside and at least 40 feet from any building. Approval from the fire chief is not required for tank installations on farms.

Fuel oil storage tanks used for heating and not exceeding 275 gallons individual capacity, may be installed outside, aboveground and may be adjacent to buildings or the line of adjoining property. Approval from the fire chief is not required for the heating oil tank installation for one and two family residences, but the installation shall comply with code.

This is state code and your fire chief is hereby required by state statute to enforce these regulations.

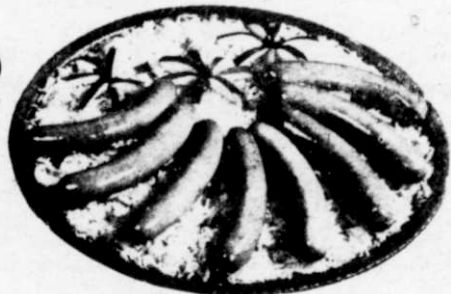

Notice is hereby given of a Spring Election to be held in the several wards in the County of Washington, on the 6th day of April, 1976, at which the officers named below shall be chosen. The names of the candidates for each office to be voted for, whose nominations have been certified to or filed in this office, are given under the title of the office and under the appropriate party or other designation, each in its proper column, together with the questions submitted to a vote, in the sample ballot below.

## Information to Electors

Upon entering the polling place an elector shall give his name and address before receiving the ballot from the ballot clerk. The initials of 2 ballot clerks must appear on the ballot. Upon receiving the ballot, the elector shall retire alone to a voting booth and mark his ballot. A ballot clerk may inform the elector of the proper manner for marking a ballot, but he shall not in any manner advise or indicate for whom to vote.

When casting a presidential preference vote, the elector shall select the party ballot of his choice and make a cross or other mark in the space at the right of the candidate's name for whom he intends to vote or shall in the alternative, make such a cross or mark in the space at the right of "no" when only one candidate is shown on the ballot or "none of the names shown" when several candidates are shown on the ballot or shall write in the name of his choice for a candidate. At a nonpartisan election the elector shall place a cross or other mark in the square at the right of the candidate's name for each office for whom he intends to vote, or insert or write in the name of his choice for a candidate.

On referendum questions, the elector shall make a cross or other mark in the square at the right of the answer which he intends to give. If the elector spoils a ballot, he shall return it to an election official who shall issue another in its place, but not more than 3 ballots shall be issued to any one elector. Not more than 5 minutes' time shall be allowed to mark the ballot. Unofficial ballots or a memorandum to assist the elector in marking his ballot may be taken into the booth and copied. The sample ballot shall not be shown to anyone so as to reveal how the ballot is marked.

After the official ballot is marked, it shall be folded so the inside marks do not show but so the printed indorsements and ballot clerk's initials on the outside do show. After folding the ballot, the elector shall leave the booth, give his name to the inspector in charge of the ballot box, hand him the ballot to be placed in the ballot box, and leave the polling place promptly.

An elector may be assisted by 2 election officials of different political parties in marking the ballot if he declares to the presiding official that he is unable to read, that he has difficulty reading, writing or understanding English or that due to physical disability he is unable to mark his ballot. Alternatively, an elector making such declaration may have another elector of the county assist him in marking his ballot or operating a voting machine. The presiding official may administer an oath to a person making such declaration.

(4) An indebtedness created for the purpose of purchasing, acquiring, leasing, constructing, extending, adding to, improving, conducting, controlling, operating or managing a public utility or a town, village, city or special district, and secured solely by the property or income of such public utility, and whereby no municipal liability is created, shall not be considered an indebtedness of such town, village, city or special district, and shall not be included in arriving at such debt limitation.

Now, therefore, be it resolved by the assembly, the senate concurring, that the foregoing amendment to the constitution is agreed to by this legislature; and, be it further

Resolved, That the foregoing amendment be submitted to a vote of the people at the election to be held on the first Tuesday of April 1976; and, be it further

Resolved, That the question of the ratification of the foregoing amendment be stated on the ballot as follows:  
"Shall section 3 of article XI of the constitution be amended to increase the debt limit for counties, cities, towns, villages or other municipal corporations from 5% to 10% of the state equalized valuation of the taxable property located in each such district?"; and, be it further

Resolved, That if a majority of the voters voting thereon approve the foregoing amendment it shall, as stated herein, become a part of the constitution of this state but if, at the same election, the voters also approve the amendment already submitted to them by 1973 Senate Joint Resolution 55 [Enrolled Joint Resolution 33], then both amendments shall become part of the constitution of this state and in that case article XI, section 3(1) to (3) shall be shown to read as stated hereinbefore, and section 3 (4) shall be shown to read as follows:

"(Article XI) Section 3 (4) An indebtedness created by a town, village, city, county or special district for the purpose of purchasing, acquiring, leasing, constructing, extending, adding to, improving, equipping, conducting, controlling, operating or managing a public utility or public project, the latter of which produces regular income from its normal operations, and secured solely by the property or income of such public utility or public project, and whereby no general obligation is created, shall not be considered an indebtedness within the meaning of the limitations on indebtedness herein imposed, except that this exception shall not apply to a county-owned gas or electric power utility or project."

## EXPLANATION

The constitution presently provides that no county, city, town, village or other municipal corporation may become indebted in an amount that exceeds 5% of the state equalized valuation of the taxable property located in each such district. A "yes" vote on this amendment would permit a county, city, town, village or other municipal corporation to become indebted in an amount not exceeding 10% of the equalized valuation of the taxable property located in each such district.

NOTICE IS HEREBY GIVEN, that at an election to be held in the several towns, wards, villages and election districts of the State of Wisconsin, on the first Tuesday of April, A. D. 1976, being the sixth day of said month, the following proposed amendment to the Constitution of the State of Wisconsin, having been approved by two successive legislatures, will be submitted to a vote for the people pursuant to law:

### Enrolled No. 6 1975 Enrolled Joint Resolution

To amend section 3 of article XI of the constitution so as to authorize counties, municipalities and certain school districts to become indebted up to 10% of equalized valuation (2nd consideration).

Whereas, the 1973 legislature in general session proposed an amendment to the constitution by Assembly Joint Resolution 58 [Enrolled Joint Resolution 35] and agreed to it by a majority of the members elected to each of the 2 houses, which amendment reads as follows:

"(Article XI) Section 3. (1) Cities and villages organized pursuant to state law are hereby empowered, to determine their local affairs and government, subject only to this constitution and to such enactments of the legislature of state-wide concern as shall with uniformity affect every city or every village. The method of such determination shall be prescribed by the legislature.

(2) No county, city, town, village, school district or other municipal corporation may become indebted in an amount that exceeds an allowable percentage of the taxable property located therein equalized for state purposes, provided by the legislature. In all cases the allowable percentage shall be five-per-centum (5%) except as follows: (a) For a) for any city authorized to issue bonds for school purposes an additional ten-per-centum (10%), shall be permitted for school purposes only, and in such cases the territory attached to the city for school purposes shall be included in the total taxable property supporting the bonds issued for school purposes. ## Attend Explorer Career Conference

Miss Kim Neitzel, Miss Lynn Belger, Miss Dawn Mixdorf, Mrs. Dorothy Swarthout, Post Advisor and her husband Lyle, all of Kewaskum; Mrs. Phyllis Nelson, Committee Member and her husband, Kenneth, of West Bend, members of Explorer Post No. 9640 of Kewaskum and West Bend were among some 800 participants in a statewide Explorer Career Conference Saturday (March 20) at the University of Wisconsin - Green Bay. ## Facsimile Ballot Notice of Village Election Village of Kewaskum, Wisconsin

Notice is hereby given of village election to be held in and for the Village of Kewaskum, Washington County, Wisconsin, on the 6th day of April 1976, at which the officers named below shall be chosen.

### INFORMATION TO ELECTORS

The following instructions are given for the information and guidance of electors:

(a) Upon entering the polling place, an elector shall give his name and address before receiving the ballot from the ballot clerk. The initials of 2 ballot clerks must appear on the ballot. Upon receiving the ballot, the elector shall retire alone to a voting booth and mark his ballot. A ballot clerk may inform the elector of the proper manner for marking a ballot, but he shall not in any manner advise or indicate for whom to vote.

(b) To vote for a person whose name is printed on the ballot, make a cross (X) or mark in the square after the name of the person for whom you desire to vote. To vote for a person whose name is not printed on the ballot, write the name in the blank space provided for the purpose.

(c) The ballot should not be marked in any other manner. If the elector spoils a ballot, he shall return it to an election official who shall issue another in its place, but not more than 3 ballots shall be issued to any one elector. Not more than 5 minutes' time shall be allowed to mark the ballot. Unofficial ballots or a memorandum to assist the elector in marking his ballot may be taken into the booth and copied. The sample ballot shall not be shown to anyone so as to reveal how the ballot is marked.

(d) After the official ballot is marked, it shall be folded so the inside marks do not show but so the printed indorsements and ballot clerks' initials on the outside do show. After folding the ballot, the elector shall leave the booth, give his name to the inspector in charge of the ballot box, hand him the ballot to be placed in the ballot box, and leave the polling place promptly.

(e) An elector may be assisted by 2 election officials of different political parties in marking the ballot if he declares to the presiding official that he is unable to read or that due to physical disability he is unable to mark his ballot. If an elector declares that he is visually handicapped, he may have anyone assist him in marking his ballot. The presiding official may administer an oath as to a person's disability.

(f) Any qualified elector who is absent, or expects to be absent from the village in which he is a qualified elector, or who, because of sickness or physical disability cannot appear at the polling place on election day, may vote at such election by means of an absent voter's ballot to be secured upon application to the Village Clerk, not more than sixty days and no less than three days, or by personal application, not later than the close of office hours on the day prior to such election.

date of this ordinance the territory described in section 1 shall be a part of the Village of Kewaskum for any and all purposes provided by law and all persons coming or residing within such territory shall be subject to all ordinances, rules and regulations governing the village of Kewaskum.

**SECTION 3. Severability.** If any provision of this ordinance is invalid or unconstitutional, or if the application of this ordinance to any person or circumstances is invalid or unconstitutional, such invalidity or unconstitutionality shall not affect the other provisions or applications of this ordinance which can be given effect without the invalid or unconstitutional provision or application.

**SECTION 4. Effective Date.** This ordinance shall take effect upon passage and publication as provided by law.

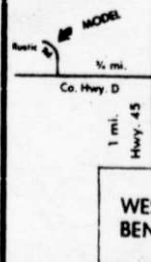
