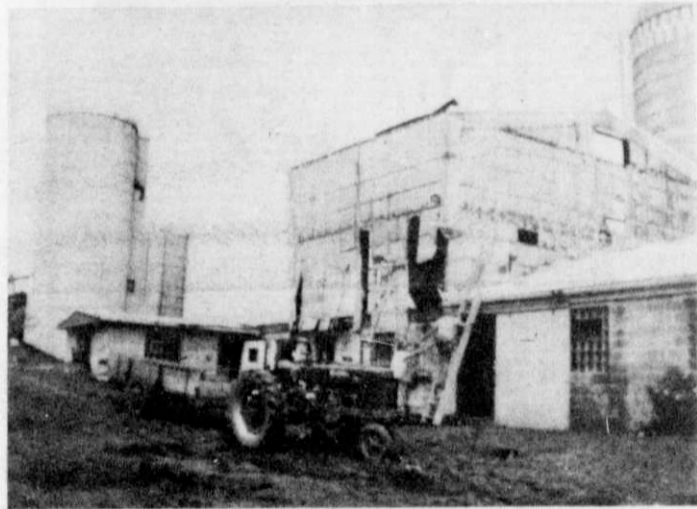

## Fire Destroys Beechwood Barn

A fire late Sunday night totally destroyed the upper barn and damaged a silo on the Reys-En-Shine Dairy Farm located on Highway "S" just west of Beechwood. The farm is owned and operated by the Orville and Marshal Reysen families.

Firemen from Beechwood answered the first call turned in by Orville Reysen who awoke about 10:30 p.m. to the sound of fire crackling and the bedroom being filled with light from the flames. The Reysen residence is located just to the west of the barn. With additional help from the Batavia and Boltonville fire departments, the Reysens and neighbors were able to save the lower floor of the barn. Kewaskum tanker truck also answered the call.

Firefighters were still on the scene late Monday morning. Friends and neighbors remained to help clean out debris and water from the lower level enabling the Reysens to repair the milking system and get their herd of 80 cows milked.

Orville Reysen stated the fire apparently began in the straw. He estimated that approximately 75 to 100 tons of hay and over 30 tons of straw had been destroyed along with the barn. A machine shed containing an antique car and miscellaneous items was also destroyed. One

pig died from burns when flames were blown toward the pen area and one calf was reported missing. The rest of the animals were saved.

Mrs. Marshal Reysen said this was the second misfortune to hit the families in recent months. Her husband is recuperating from a stroke which he suffered approximately a month ago.

## School Administrative Salaries Approved With Little Opposition

After more than two hours in closed session, the Kewaskum School Board returned to open session and approved 1981-82 administrative salaries in less than a half hour. Although over 16 people attended the meeting, only two spoke up against the proposed increases.

Ralph Horner stated he felt the "increases are way too large across the board." He asked the board to again reconsider these figures and bring them more in line with today's economic conditions. Horner's example was the Chicago School System which is considering a contract for two years that will see no increases the first year and only a 7% in the second year.

Harold Manthei stated, "I'm a farmer and I got cut in April and got dropped again yesterday." (referring to prices paid for his milk). "We're getting less and less and less and we

pay our own insurance, we have to pay all our own fringe benefits and we have to pay our total social security. I've got a \$400,000 investment here, how much money do the teachers have invested in the school, and I'm getting less."

School Board President John Tessar noted that over the past nine years teacher salaries increased 156% while administrative salaries fell behind this by 74%. Administrative raises have been consistently less than the Kewaskum Education Association. In 1976 KEA received 10.7% compared to Administrative 7.6%, 1977-78 was 13.1% against 7.3%, 1978-79 increase were almost equal 6.0% and 6.3%, 1979-80 teachers 9.6% administration, 4.8%, 1980-81 13.3% compared to 9.2%.

Tessar stated, "somewhere along the line we're going to have to try and get them up and get them a little bit more and I guess this is the year we're trying to do it." Salaries Committee Chairman Gerald Secor stated, "how can we expect the administrative staff who has more responsibilities, work at a lesser level than the teachers?" Tessar noted, "way down deep, how can you justify to the administrators that we always

keep giving them less than the KEA members are getting. Like Mr. Secor said, we made an offer to the KEA and they turned us down. The same thing we're offering the administrators. So, this is some of the board's thinking, 156% to 80%, would you be happy with this?" Horner commented he just felt the time was poor and a better time (for large increases) would be in an expanded economy.

On a 5-2 vote, Tom Brigham and Dr. Ogi voting "no," the board approved the following salaries:

## Truck Driver Dies on Hwy. 41 In Town Wayne

A 46-year-old Waterford, Wis. man died Saturday morning when he apparently suffered a heart attack while driving his semi-trailer on U.S. Highway 41, two miles south of County Trunk H in the Town of Wayne.

Donald E. Peterson of 8111 Apple Tree La., Waterford, was pronounced dead on arrival at St. Joseph's Community Hospital, West Bend, according to Coroner Robert Boltz. The victim was removed to the hospital by the Kewaskum rescue squad.

Peterson was driving his truck south on U.S. 41 at 11:25 a.m. when he drove off the left shoulder of the road and into the median, the Wisconsin State Patrol said. The truck then continued to the shoulder on the northbound side of the road and then crossed back into the median before rolling over, the patrol said.

The accident, classified as a traffic fatality, was Washington County's 17th of the year.

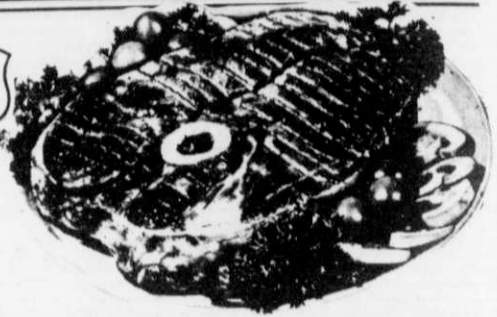

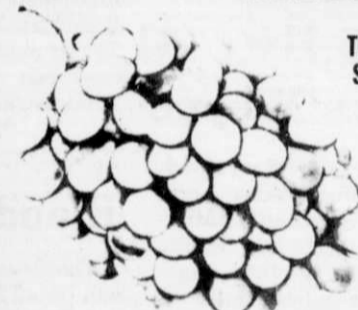

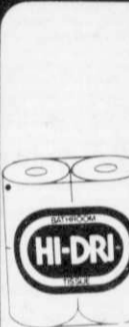

If, by chance, there are still taxpayers that choose to put up with the conditions mentioned in the first part and are present at the meeting requesting some considerations, pretend to listen to them, thank them for their comments and proceed to do what you want to do anyway because they don't know anything anyway.

How was this lesson presented to us?

As stated above, a group of taxpayers had come to the supposed 9:15 p.m. open session of the Kewaskum School Board. The idea of having a meeting starting at this late hour is already a definite deterrent to its attendance by not only many of the working taxpayers who have to get up early to go to work but also by many of the retired senior citizen taxpayers of our community.

This as I indicated is bad enough, but the assembled taxpayers had to wait until 10:05 p.m. before the session was finally opened to them. How does the Board expect citizen input at this late hour? If there were to be two sessions, one closed and one open to the public, why not hold them on separate days so as to accommodate the taxpayers? Let the public know exactly at what time the meeting will be held and also give them some assurance that they will be home at a reasonable hour. It makes one ask the rhetorical question: Doesn't the Board want citizen input?

The Board by a vote of 5 to 2, approved an average raise for seven administrative personnel of \$3332 a price for an average raise of 12.5%. The low raise was an 11.4% increase and the top raise was a 14.8% raise. These figures are the total cost to the taxpayers and include fringe benefit increases.

These raises were approved despite the expressed request by some of the taxpayers that the raises be toned down to reflect the sacrifices that many of the taxpayers are making. These include the fact that farmers are receiving less for their products, unemployment is still up, citizens on social security are worrying about the future of that system and for

those taxpayers that are working, a lot smaller raises for them than those that were proposed for the administration. Coupled with these sacrifices are the ever real uncertainties as to how much and for how long the federal and state governments will fund some of the school costs and the very real prospect of substantial property tax increases even without the burden of these inflated raises.

This is how our two part lesson was presented to us.

How much is 2.2 acres? Well, the playing boundaries of a football field cover just over an acre.

Two million acres per year of our prime farmland is being lost of urban sprawl. In 1976, agricultural land sales in Washington County alone were 2,960 acres. One thousand and thirty-one acres or 34.8% of this stayed in farming and 1,929 acres or 65.2% went to other uses. This compares to 58,685 acres or 13% of farmland sold statewide diverted to other uses in 1976.

The trend will continue if we don't exert an effort to reverse the loss of farmland to other uses. For once it is lost, it cannot be renewed.

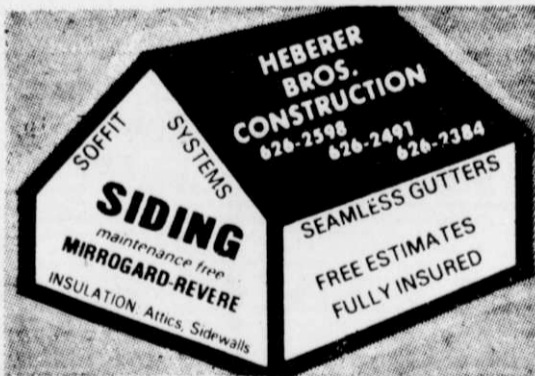

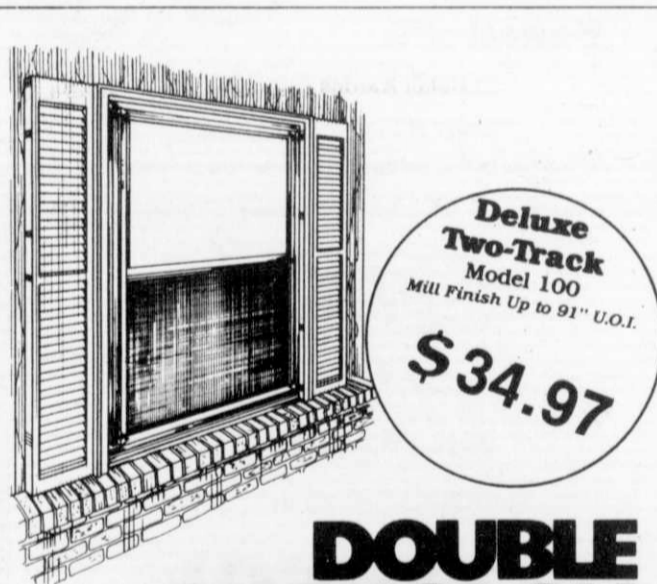

## Brucellosis Rule In Effect Sept. 1

All female cattle and American bison entering Wisconsin must be vaccinated for brucellosis, under the requirements of an emergency rule which will go into effect September 1, 1981.

Dr. Willis Lyle, chief state veterinarian with the Wisconsin Dept. of Agriculture, Trade & Consumer Protection, reports that the 120-day emergency rule is designed to prevent Wisconsin from becoming a "dumping ground" for unvaccinated cattle from other states. In the past, unvaccinated cattle have become mixed with other cattle through several ownerships when enroute to Wisconsin, greatly increasing the risk of exposing healthy cattle to brucellosis.

The only exceptions to the rule are heifers under six months of age, steers and feeder cattle going to an approved feed lot, and cattle for exhibition or slaughter.

Dr. Lyle urges all Wisconsin herd owners to vaccinate their calves for brucellosis and to buy only official vaccines as herd replacements. He points out

that "brucella vaccine" is noted for its stability, safety and efficacy when properly handled and used correctly.

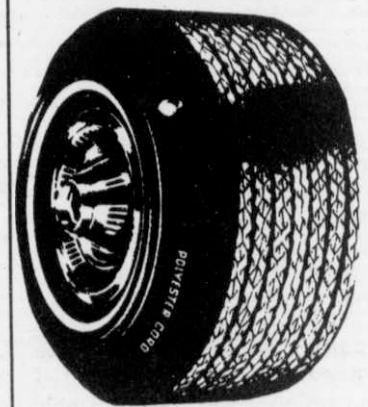

### St. Agnes Hospital Obtains New Equipment For Cancer Radiation Therapy Department

With acquisition plans for a CT scanner and linear accelerator now complete, construction on the new and expanded Radiation Therapy Department will begin soon, according to James J. Sexton, president of St. Agnes Hospital, Fond du Lac.

Final approval from the state to proceed with the purchase of the linear accelerator and expansion of facilities in Radiation Therapy was received in mid-August, said Sexton.

Construction of the new facilities is scheduled to begin in October with completion of the department in January. The linear accelerator is scheduled to be delivered in April, 1982 and to be operational by the summer of 1982.

"What this means for the consumer is that all patients can receive cancer treatment at St. Agnes Hospital," said Sexton. "We will now have sophisticated cancer treatment equipment and facilities that will eliminate the need for patients to travel to other facilities for cancer care."

According to Dr. Hong Chu Wang, radiation oncologist, "Getting this new equipment and facilities is very encouraging. It's one step toward providing complete oncology services in the Fond du Lac area."

The present cancer treatment unit, the cobalt 60, will continue to be used as the choice for certain types of cancer as well as back-up in case of mechanical problems with the accelerator.

"Both units will provide good quality treatment for the patient. However, we wanted the newer unit because for certain kinds of cancer, the linear accelerator is more capable," said Wang. "Also, the science of radiation therapy is improving at such a rapid pace each year, that we wanted to keep up with the new

technology," he added.

The expanded Radiation Therapy Department will be in the lower level of the basement beneath the Physical Therapy Department. The actual treatment room, in which the linear accelerator will be placed, will be shielded by 2 to 3 feet of concrete and steel from top to bottom. The linear accelerator is a twelve million volt unit that directs high-speed photons or electrons at a tumor. It destroys the tumor cells by interrupting the biochemical metabolism. Because of its speed, the elderly, the very young and the very ill tolerate the painless treatment much better.

"We had been sending most of our pediatric cancer patients to other facilities for treatment," said Wang. "This, too, will no longer be necessary with this new equipment."

According to Sexton, the new CT scanner should arrive at the hospital December 1 and be operational January 1, 1982. This will mean that people in this area will no longer have to travel long distances for diagnostic or specialized testing.

"It will make it especially beneficial to the patient who comes into the hospital with a severe head injury or the trauma of a potential tumor, stroke or other serious illness or disease," said Sexton. "They will be able to be treated immediately by the most sophisticated and modern diagnostic piece of equipment in medicine today," he continued.

According to Sexton, the CT scanner combines computer technology and x-rays to present a clear picture of a cross-sectional slice through the body. This enables radiologists to make diagnoses with a high degree of accuracy with minimal risk and discomfort to the patient.

In addition, this information is so complete and accurate, that some exploratory surgery is no longer necessary.

### Camping Up, Day Use Down at State Parks

Camping pressure is up significantly for the summer season at state parks, while day use activities have attracted fewer visitors this year, according to DNR state park officials.

Camper days for the period May through July this year are up six percent over the same period a year ago, Loren Thorson, Chief of Recreation Programs for state parks noted. This year's camper days total 818,974 compared with 773,253 a year ago.

Total visitations, however, for a like period this year are down three percent from last year. There have been 5,183,020 visitations to state parks for the three month period compared with 5,355,451 during a like period in 1980.

Thorson noted that the pattern of weather statewide this year could have affected some of the traditional day use

activities at state parks such as picnics and swimming. "A cool summer is always a factor in use of state park facilities. The rainfalls we have had this summer may have also contributed to a concern on the part of the public regarding mosquito populations," Thorson said.

The increase in camping use he said did not surprise him. "Camping is an activity that has been increasing in popularity each year. This is reflected by the continuing increase in the yearly retail sales of camping and camping related equipment," Thorson added.

Vehicle sticker sales this year through the month of July are up about three percent over last year with both the resident and nonresident stickers reflecting the increase.

Use of the advance campsite reservation program continues to increase. Park officials project a 10 percent increase in that program this year over a year ago. Advance campsite reservations can be made through September 30. One exception to that ending date is Peninsula State Park in Door County, which accepts campsite reservation through October 25.
