## FFA National Secretary Visits Kewaskum

John Pope, National Future Farmers of America Secretary, made a visit to Kewaskum's FFA chapter Thursday. With John were State President Neal Wellner of Cadott and State Vice President Todd Luepke of Bonduel.

John's visit was very special since this is the first time Kewaskum has been host to a national officer. There are only six national officers in the United States.

Pope, a 20-year-old student at North Carolina State University, has taken a year's leave of absence from school to travel throughout the United States and several foreign countries speaking on behalf of FFA and its various programs.

Pope stated during this year of service he expects to cover 200,000 miles meeting thousands of people in the U.S. as well as traveling to Tokyo, Japan, and Korea where he will live with host families.

John, who is from Maiden, North Carolina, said his experience in FFA centered around agri-business where he was involved in working with feed suppliers developing feed formulas and programs and in

processing such as meats and vegetables for market. Pope noted his visits were interesting for him since they gave him an opportunity to see how other FFA chapters work. Kewaskum presents another side of FFA, that of agri-production, which includes raising of livestock for dairy production and meat along with growing of various crops.

Pope noted that while some of the largest dairy herds in his state are near his home, North Carolina is better known for its cash crops, tobacco being no. 1, followed by sweet potatoes and forestry products.

John said he did not grow up on a farm but became involved in FFA through working with his father and grandfather, who owned the largest garden in his county, supplying fresh vegetables to local supermarkets.

Upon completion of his term as secretary Pope plans on continuing his education to become a teacher in vocational agriculture.

As a remembrance of his visit, Kewaskum FFA President Gary Kempf presented John with a picture designed and made by FFA member Debbie Tackes.

## Six Children Injured in Car-School Bus Collision

An accident Monday morning between a Johnson School bus and car resulted in transportation of six children to the hospital.

The accident occurred on Hickory Drive just north of Highway 28, at 8:48 a.m. when a southbound car driven by Mrs. Verna Reindl came over the crest of a hill and met the

northbound bus driven by Mrs. Judy Schuette. Both drivers applied their brakes, however, due to large snowbanks on each side of the road, the left sides of the vehicles collided. The Washington County Sheriff's office said the roadway was too narrow for the two vehicles to pass each other. The accident scene was cleared of snow by the Town of Kewaskum later that day.

Those injured were bus passengers Tammy Clement, 10, with a possible dislocated knee; Sara Lemke 7, bump on head and mouth injury; Sherry Luterbach, 7, head and mouth injury; Stacie Donnicks, 11, head and mouth injury; Buffy Reesburg, 9, bruised knee, and Stephanie Reindl, 7, a passenger in the Reindl vehicle, bumps and bruises and possible concussion. The children on the bus were treated and released according to St. Joseph's Hospital. Stephanie was being held for observation.

The 35 uninjured students were transferred to another bus and continued on to Kewaskum Elementary School.

No Citations were issued.

# Memories...



**This is a photo of the late Edward M. [Mush] Bauer, former proprietor of Bauer's Hotel, Restaurant and Tavern in Campbellsport. He passed away late in January about 25 years ago at the age of 50 years. At one time "Mush" weighed 785 pounds but at the time of his death was down to 370 as a result of a four-year reducing diet.**

Like other members of the Bauer family, he began helping out in the family business when he was young. He had been its proprietor for 28 years. Associated with him at the time of his death were his brother, George, and a sister, Mrs. James Farrell. The business was first operated by his parents for 44 years.

His enormous weight was the result of a childhood bout with scarlet fever. According to physicians, the disease affected his pituitary gland, an important weight-control mechanism in the body. Death was said to have been brought on by uremic poisoning, resulting from a longstanding heart condition.

The photo was submitted by Isabelle Muckerheide who found it at a flea market in Green Lake. Miller's Furniture of Kewaskum had a red chair specially built for "Mush" to maintain his enormous weight.

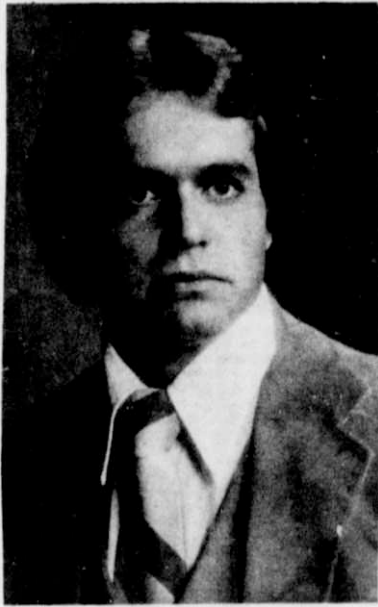

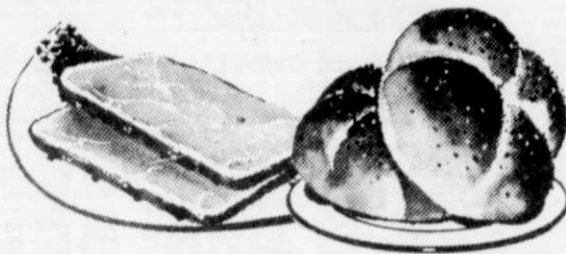

**Is Your Home Prepared for a Disaster?**

Is your home prepared for a natural or human-caused disaster? A blizzard, an explosion, a tornado, a power blackout, a radiation leak...? The International Affairs Department of the Kewaskum Junior Woman's Club, as a part of its International Policy division, provides the following information about our community's Civil Defense program.

The Kewaskum Civil Defense community program works with the fire and police departments in conjunction with the Civil Defense programs of Washington County and a multi-county district. Marvin Martin, Ke-

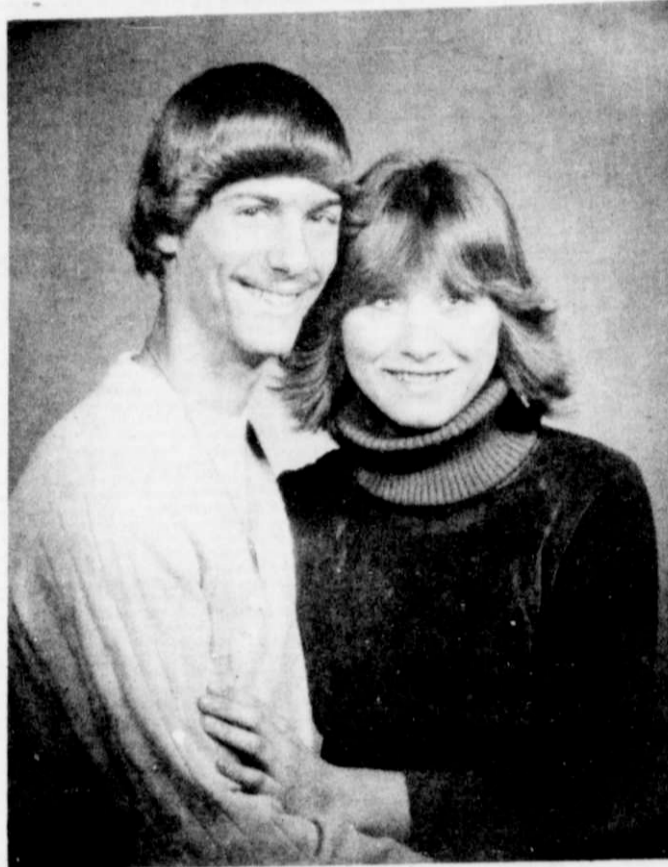
waskum's Civil Defense director, acts as advisor to the group. The program concerns itself primarily with weather emergencies, although such problems as nuclear waste and chemical spills are also discussed. The emergency siren in Kewaskum is tested the first Thursday of every month at 10:00 a.m.

Everyone can prepare for an emergency in his own home. Participating in a survival course such as First Aid or CPR can be invaluable. Below is an emergency check list designed to be placed inside a cupboard door in every home.

**AN EMERGENCY CHECK LIST**

- Food stored for two weeks
- Water and Fruit Juices
- Medicines
- First Aid Kit
- Battery Operated Radio with extra batteries
- Flashlight with extra batteries
- Candles and matches (do not use if gas present)
- Extra wood if you have fireplace (or synthetic logs)
- Fire Extinguisher
- Basic tool kit
- Dried Milk, infant food if children in family
- Road map
- Blankets
- Emergency flares (optional)
- Central spot for storing valuable papers (glass jar with lid; if evacuation, leave in refrigerator)
- WBKV** Call letters of Emergency Service designated radio station
- Provisions for pet
- Know immediate neighbors, how many at home

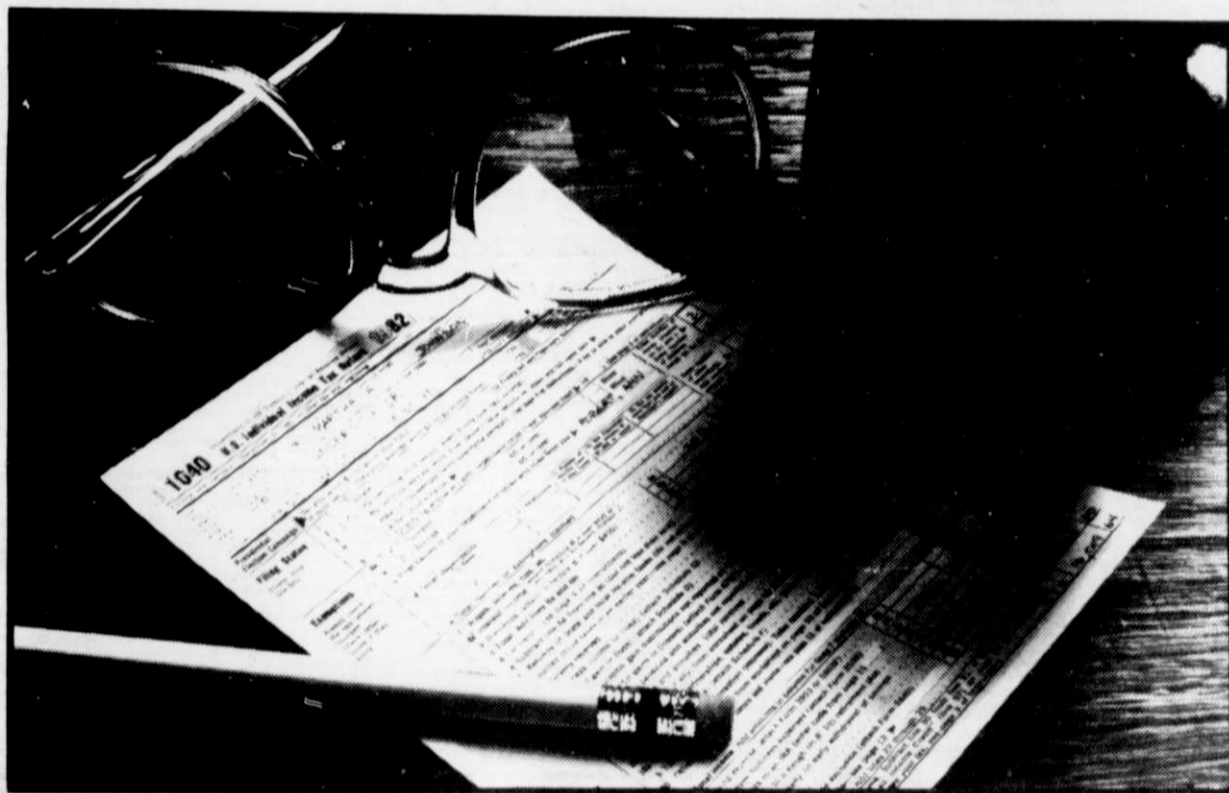

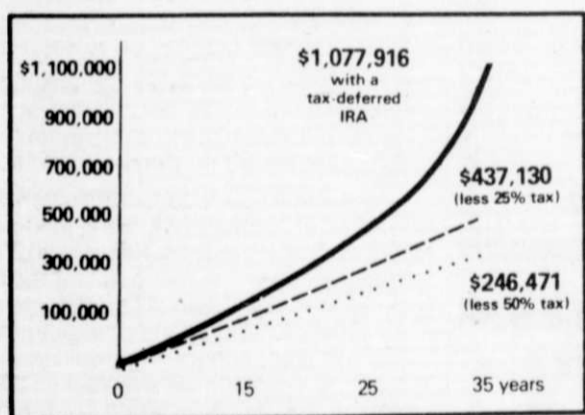

### NOTICE TO USERS OF LONG DISTANCE TELEPHONE SERVICES WITHIN WISCONSIN

Wisconsin Telephone Company has applied to the Public Service Commission of Wisconsin for a general rate increase including some long distance rates.\* Because authorized changes in long distance rates would apply to calls made between locations within Wisconsin, the Company is providing a notice to all users of long distance services in the state. A summary of the Company's proposals follows:

- Discontinue the present operator handled station-to-station and person-to-person rate schedules which contain a minimum charge of three minutes for each call and apply the existing dial station-to-station one minute minimum rate schedule to all calls. In addition, the Company proposes to establish a 50 cent charge for each customer dialed Calling Card\*\* call, a \$1.50 charge for each operator assisted station-to-station call, and a \$3.00 charge for each person-to-person call.

- Discontinue the present Full Business Day and Measured Time classifications for both Inward WATS (800 Service) and Outward WATS and establish the following WATS rates:

Access line	\$50	\$55
First 15 hours	\$16/hour	\$17/hour
Next 25 hours	\$14/hour	\$15/hour
Next 40 hours	\$12/hour	\$14/hour
Next 40 hours	\$8/hour	\$11/hour
Over 120 hours	\$4/hour	\$4/hour

The Company estimates that the proposed WATS rate changes would result in charges lower than under the current rate schedule for a large majority of its customers, but will also result in substantial increases for the high volume users of a service.

- Increase the rates for special private line services by 25 percent across the board. These services are used mainly by businesses.

- Change the way long distance, Tel-A-Visit and Call Pak messages are billed when a call originates during one rate period and continues into another period. Currently, such calls are billed at the rates in effect at the time the call originates. It is proposed that usage within each rate period be recorded and billed at the rate applicable to the respective period in which usage occurs.

- Discontinue the 35 percent long distance rate discount now provided between 8 a.m. and 5 p.m. on the Friday or Monday observed as the holiday when Christmas, New Year's Day, or Independence Day fall on a Saturday or Sunday.

- The charges for each leg of a long distance conference call arrangement would be the dial station-to-station initial period and additional minute rates measured from the originating location, plus the \$3.00 person-to-person additional charge.

The Public Service Commission will hold a pre-hearing conference on February 11, 1982, in room 426 at its offices in the Hill Farms State Office Building, 4802 Sheboygan Avenue, Madison, Wisconsin, at 1:30 p.m., for the purpose of 1) identifying the persons who will actually participate as full parties; 2) scheduling the times, locations and dates of public hearings; 3) scheduling witnesses; 4) scheduling additional pre-filed testimony and exhibits; 5) resolving data requests; 6) identifying and designating issues; and 7) considering such other matters as will facilitate the hearing. In its Notice instituting this proceeding, the Commission stated that full parties will be bound by the designation of issues and the schedules adopted at the pre-hearing conference. Consequently, persons who consider themselves to be potential full parties should be represented at the pre-hearing conference.

\*During the course of these proceedings, the Company's request may be updated or amended. For example, if there are changes in Federal Communications Commission approvals of accounting and depreciation procedures, or other changes which impose additional costs on the Company, larger revenue and rate increases would be requested. If such changes lower the Company's costs, lower revenue requirements and rate increases would be requested.

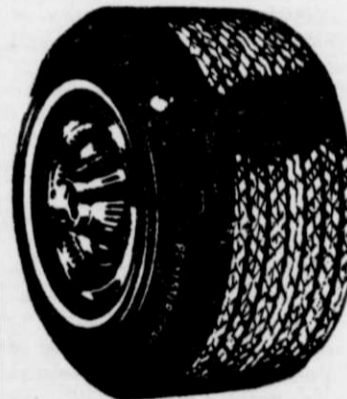

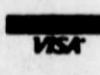
