Sentry Store Opens in Kewaskum Mall

Wednesday, Nov. 17, marked the opening of the Sentry Store in the Kewaskum Mall, less than a mile away from their previous location on Main Street in Kewaskum.

The new larger store was

made available recently when Roundy's Shop Rite closed their store, after less than a year in business in the Mall.

The new store increases their selling space by about 4,000 square feet, allowing for an expanded Crestwood Bakery section and addition of a delicatessen department which

wasn't possible in the Main Street store, according to Bill and Judy Geidel, owners.

A grand opening will not be held until after the first of the year, due to the holidays.

'Tiny' Terlinden Injured When Struck by Pickup

Sylvester "Tiny" Terlinden, 64, of 234 Forest Ave., Kewaskum, was seriously injured at about 4:54 p.m. Monday, while walking at the corner of Main and Railroad streets when he was struck by a pickup truck.

According to reports "Tiny" was crossing Railroad Street from east to west and was almost across the intersection when he was struck by the pickup truck which was traveling east on Main street and made a left turn onto Railroad street. The truck was driven by Thomas L. Hug, 18, of 5772 Main St., West Bend, it was reported by Kewaskum Chief of Police Don Hlavaty.

Terlinden suffered severe head injuries, a fractured left ankle and injury to his left wrist. He was transported to St. Joseph's Community Hospital, West Bend, by the Kewaskum Rescue Squad and later the same evening was transferred to Columbia Hospital, Milwaukee. He was placed in the intensive care unit at Columbia. He was taken out of the intensive care unit Wednesday.

Pin Found In Candy

An incident in which a child bit into a candy bar and found a pin inside was reported on Monday of last week to the Fond du Lac County Sheriff's Department.

Dennis Jacak of Route 1, Kewaskum, told authorities at 6:16 p.m. Monday that one of his children recently bit into a Milky Way candy bar they received on Halloween and discovered a pin. He said his children were taken trick-or-treating in New Fane since the family used to live there.

Jacak told detectives he does not remember where the children got the candy bar. No injury to the child was reported.

The incident originally was reported to Kewaskum police, but since New Fane is located in the Town of Auburn, Jacak was instructed to contact the Fond du Lac County Sheriff's Department. When Kewaskum police informed county officials of the report on Monday, they were instructed to have Jacak contact the Fond du Lac County Sheriff's Department.

The recount of 88th Assembly District election results now underway shows that three Washington County townships gave challenger Jerominski, (Democrat-Campbellsport), a net gain of 11 votes.

Incumbent Esther Doughty Luckhardt, (Republican-Horicon), received an additional three votes in one district but lost three votes in another voting area, for a net gain of zero.

The recount expected to be completed later this week cuts Luckhardt's election day lead from 36 votes to 25.

Options Considered for Budget

Town of Kewaskum Fire Contract Approved

The Kewaskum Village Board approved a fire contract for the Town of Kewaskum at Monday night's meeting.

The township's new contract, which runs from January through December of 1983, will cost \$35,717.00. This is a drop of \$12,000, as compared to the 1982 contract of approximately \$48,000.

Village Administrator Dan Schmidt had explained at a previous meeting the reduction is a result of a drop in the Town of Kewaskum's equalized valuation along with a decrease in the number of fire calls over the last three years. Both factors are used in a set formula used to calculate service charges.

In other business, the board approved Wastewater Superintendent Pete Albers' request to repair the main air line at the treatment plant. Albers told the trustees there was a severe air leakage problem, so bad, that on a rainy day you could see the escaping air bubbling up through the puddles of water. "The leaking air is costing us too much on electricity," said Albers. "I think we can recoup the repair costs in six months, that's how much we're leaking," stated Albers. The board approved \$2,000 for labor and parts with work to begin immediately.

Dan Schmidt ran through a list of all proposed revisions for the village's new code book. He said the revised book would be ready for a public hearing and action at the December 6th meeting. Some of the major changes include fee increases in various building permit areas, as well as bartender, dance hall, and pet licenses. Many of the revisions are corrections and additions in code wording.

The board was reminded that the proposed 1983 budget will have a public hearing on Monday, November 29th, at 7:00 p.m. Schmidt told the trustees there were three options they could consider in approving the budget. The first is to accept it as presented, secondly, delete park outlay or transfer another \$10,000 to \$11,000 from the Park Development Fund increasing that transfer to approximately \$38,000, which would be going into the '83 budget.

Although this could drop the village budget increase from

11.3% to 8.4%, or \$1,019 to 72c per \$1,000, Schmidt noted he was somewhat hesitant to suggest such a move. He felt this could present some budget problems in 1984, as far as coming up with funds to pay the 1984 \$70,000 payment on the Kiwanis Park long term note.

The third option is to use the higher dollar figure in anticipated state shared revenues. Presently Schmidt is working on the lower anticipated revenue figure of \$329,357.00. Schmidt noted there might be a chance this could be \$20,000 higher. This item has not been finalized as several cities, including Milwaukee, have begun a suit against the state. This suit will not be settled until after January 1983. Should the village go ahead on the basis of receiving the higher revenue figure and the courts approve the lower amount, the village could end up "scratching" to come up with the difference.

Schmidt said he knew of only one nearby community which was planning its budget on the higher revenue return. Schmidt was cautious and noted he wondered if this was such a good idea.

Schmidt told the board it would be difficult to completely drop the park funds since the village had obligated itself to two projects in 1983. Trustee Dick Schmidt noted \$2,500 had been earmarked for rewiring at River Hill Park. This has to be done said Schmidt because of a very dangerous situation which could result in serious problems. The second project is fencing for the horseshoe courts which will cost approximately \$4,000.

In another effort to reduce expenditures, Schmidt asked board approval to send a "letter of intent" to the School Board informing them the village is considering dropping its \$5,000 expenditure which covers the cost of two crossing guards. Schmidt noted action would not be taken on this for at least a year since the school district and village set up their budgets at different times of the year.

Schmidt showed the board a new book which has been published on the nature trail in Kiwanis Park. Copies are available for use at the Kewaskum Library.

The village received a check for \$6,000 more than had been anticipated for 1982 state shared revenues. Administrator Schmidt said he had just received the check.

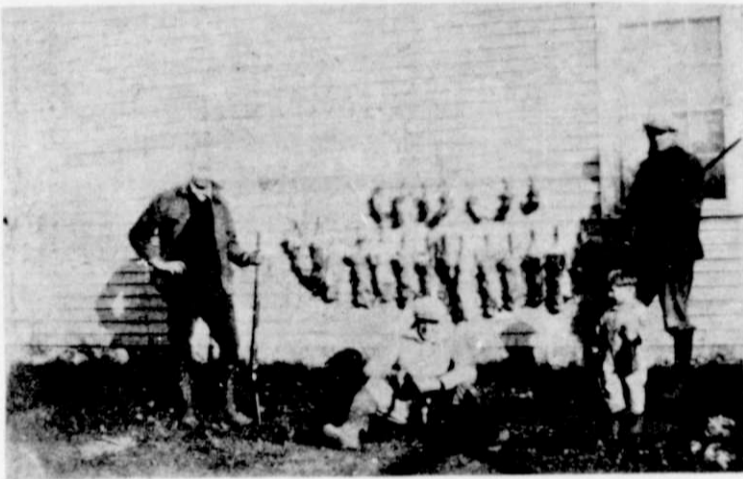

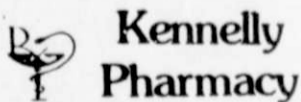
The time is rapidly approaching when KES seniors must make important decisions. The touring group unanimously felt their visitation time was a big step forward in this direction.

Pre-Employment Program Available For Kewaskum Displaced Homemakers

A West Bend based program, Turning Point II, has been in operation for Washington County women since June of 1982. The program is sponsored by Friends for Battered Women and is specifically geared to the woman who, because of her life circumstances, is head of the household with no marketable skills, has been out of the work force for a number of years and CETA eligible.

Mary Pat Thompson, a local resident is the group facilitator and oversees the 4 week 5 hour a day classroom sessions. Ms Thompson covers, in depth a vast range of pertinent subjects including single parenting, assertiveness training, resume writing and interview techniques.

Regal Ware, Kewaskum, has opened their facility to Turning Point II for a tour allowing

women to get an inside view of a large company.

Since June, 45 women have been in the program. One-third have been placed and others have opted to go for skill training.

Turning Point II staff consists of another Kewaskum resident, Judy Munson, who is office manager. Sonia Rasmussen, Program Director, completes the staff. Turning Point II is fortunate to have the volunteer services of many Washington County professionals who conduct sessions for the group in their particular areas of expertise.

We really need the right to consult someone who is knowledgeable in school law. As far as the proposed policy—which I assume is dead since none of the Board members at the meeting felt a need for a change—I would like to quote Lloyd George: "No quarrel ought ever to be converted into a policy."

It was also heartening to note how receptive both the audience at the last Board meeting and the general public are to the Superintendent's statement about the ineffectiveness of bickering. Frankly, I think we're all sick of empty words that simply waste time and interfere with the workings of the Board. The Board can work together for the betterment of our schools; after all, that was what we were elected to do. We must continue working together, as every intelligent Board member must realize.

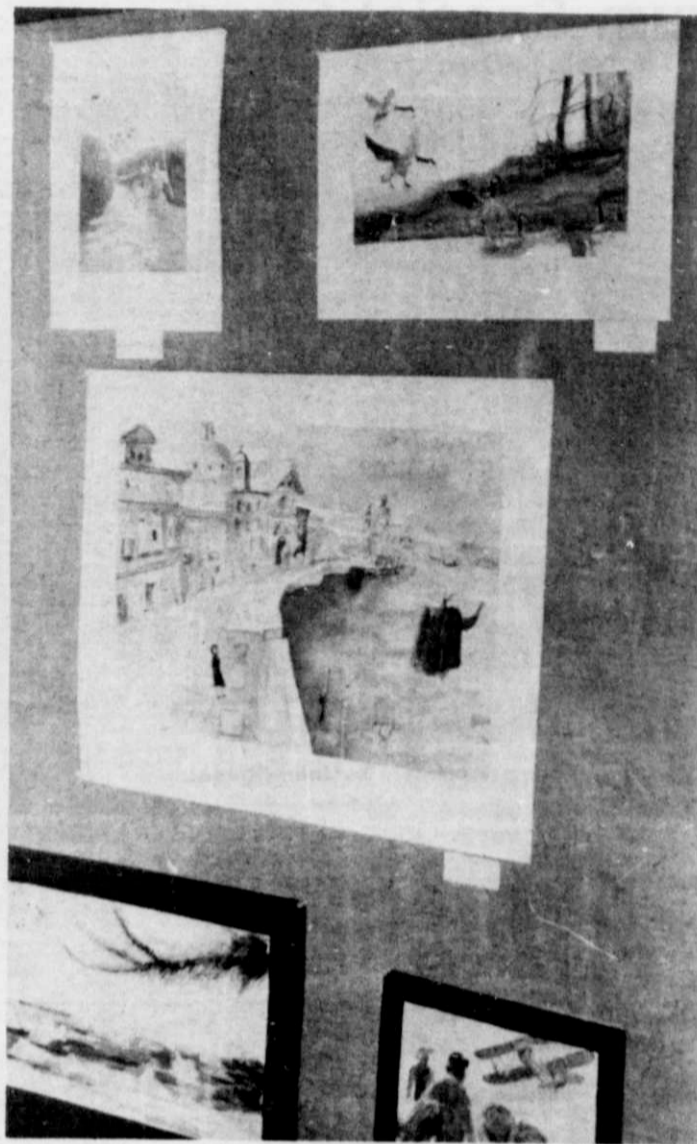
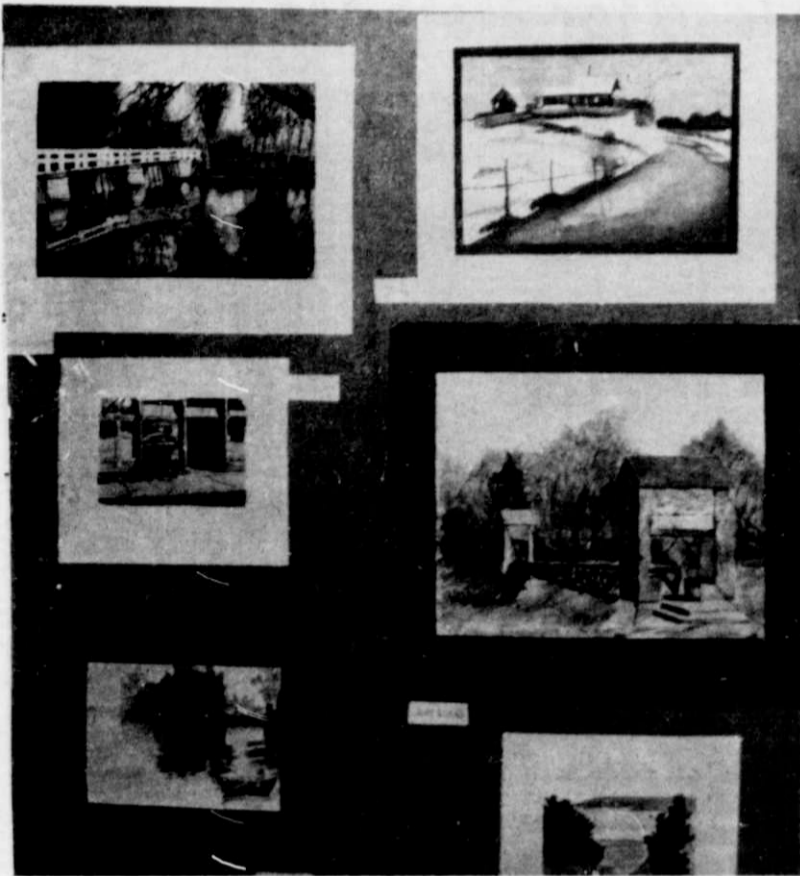

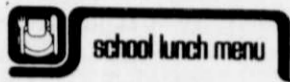

Purpose of the toll-free reporting service is to provide condition reports on a statewide basis and to keep telephone lines to State Patrol districts open for reporting accidents or other emergencies that may occur. A total of 18 phone lines feed into three automatic recorders.

The road condition reports will be maintained until about April 15. During the summer months these same numbers are used for providing detour information.

Regular Meeting
November 1, 1982
8:00 P.M.

The Village Board of Kewaskum, Washington County, Wisconsin, met in regular session in the Council Room of the Municipal Building, 204 First Street.

Administrator Schmidt called the meeting to order. President Stollenwerk asked to be excused and was absent. All other Trustee Members were present.

On a motion by Trustee Jeffrey Rohrer, seconded by Trustee Howard Laubenstein and unanimously carried, the Board appointed Trustee David Nigh to serve as President Pro-Tem.

The Minutes of the meeting of October 18, 1982, were approved as printed upon a motion by Trustee Richard Schmidt, seconded by Trustee Howard Laubenstein. Voice vote was unanimous.

A public hearing was conducted on the application of Richard H. Roehrborn for a Combination Class "B" Fermented Malt Beverage and Intoxicating Liquor License for the premises at 1139 Fond du Lac Avenue. There were no objections from the floor on the application as publicly read by President Pro-Tem David Nigh. The Police Department had no reason to protest the issuance of the license at this time. On a motion by Trustee Donald Mlodzik, seconded by Trustee Howard Laubenstein and unanimously carried the public hearing was declared closed.

Motion was made by Trustee Richard Schmidt, seconded by Trustee Paul Blumer to suspend the rules to take action on agenda item IX. A. Discussion and possible action on the application of Richard H. Roehrborn for a tavern license. Roll call vote was 6 "Aye," 0 "Nay," 1 "Absent." The motion was carried by the majority.

On a motion by Trustee Jeffrey Rohrer, seconded by Trustee Paul Blumer and unanimously carried, the application for Richard H. Roehrborn for a combination Class "B" Fermented Malt Beverage and Intoxicating Liquor License was approved upon the proper payment of fee. It was noted Mr. William Edwards has already surrendered his license. The Clerk was authorized to issue the proper license. The motion was carried by the majority. (The address of the license is 1139 Fond du Lac Avenue and is formerly known as the Homestead).

Superintendent of Public Works, Augie Bilgo, discussed with the board the possible excavation of a retainage and ice skating pond at the Kewaskum Kiwanis Community Park. The proposed size of this pond would be 80' x 200' and the cost estimates are as follows: Harold Mueller excavating - \$600 to \$1,500; Ray Wollner excavating - \$800 to \$1,000.

On a motion by Trustee Donald Mlodzik, seconded by Trustee Howard Laubenstein and unanimously carried, the Board approved the excavating of the retainage pond provided it would be dug at a minimum depth and that a proper drain and overflow could be installed. Also that the work would be done on a time basis by Harold Mueller excavating, using the

swamp cat.

The opening of the sealed bids as specified for the police squad replacement for 1983 were as follows:

The building permit application has been approved by both the Building Inspector and Zoning Administrator. The office was authorized to issue the proper permit upon proper payment of fees, for the construction of a single family home.

On a motion by Trustee Paul Blumer, seconded by Trustee Donald Mlodzik and unanimously carried, the Board approved the building permit application for Marigold Foods, Inc. 110 & 138 First Street. The building permit application has been State approved, approved also by the Zoning Administrator, and the Building Inspector. The office was authorized to issue the proper permits upon proper payment of fees, for the installation of the foundations and footing as approved by the State.

Administrator Schmidt gave the new/recodified Municipal Code Books to all Village Trustees for their review. It was noted the public hearing on the code would be December 6, 1982.

Administrator Schmidt read a letter of resignation sent to him by the Assessor Virgil Samsal. Mr. Samsal asked for his resignation to take effect October 1, 1982.

The topic of the letter was the so desperately needed space for the library. The Library Board encourages the Village Board to seriously consider the remodeling and expansion of the Municipal Building in the upcoming 1983 budget.

Discussion and review of the preliminary 1983 budget was held. The discussion will be continued at upcoming meetings of the Board.

On a motion by Trustee Donald Mlodzik, seconded by Trustee Howard Laubenstein and unanimously carried, the Board called for a special meeting of the Board for Monday evening, November 8, 1982, at 7:00 P.M. The main topics to be discussed will be, the preliminary budget review and then adjourn to closed session for employee negotiation etc.

Motion was made by Trustee Richard Schmidt, seconded by Trustee Jeffrey Rohrer to accept the police squad bid from Mayfair Chrysler - Plymouth at a cost of \$8,636.86 as recommended by the Chief of Police. It was noted this was the low bid by an estimated \$1,100. It was also noted that the delivery must first take place after January 1, 1983 and that the price is to stand firm. Roll call vote was 6 "Aye," 0 "Nay," 1 "Absent." The motion was carried by the majority.

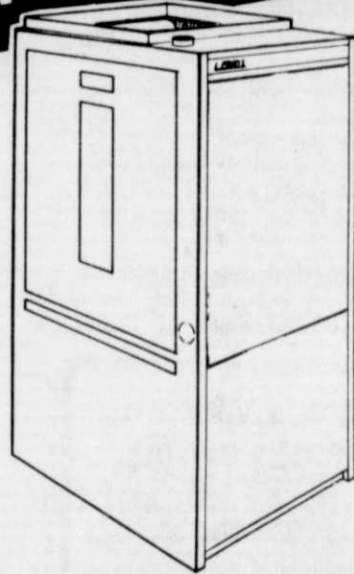

Child Restraint Law Is 'Law of the Month' for November

Wisconsin's new child passenger restraint law is the State Patrol's "Law of the Month" for November, which has been proclaimed by Governor Lee Sherman Dreyfus to be "Child Passenger Safety Month" in Wisconsin.

Captain W. C. DeGuire, Commanding District 3, of the Wisconsin State Patrol, said Troopers will issue warnings to violators until May 1, when the penalty portion of the new law goes into effect.

The new law provides that parents or legal guardians must transport their children under the age of 2 in an approved child safety restraint system. Two and three-year-old children may be transported either in an approved child safety system or secured in the vehicle's regular safety belts.

DeGuire said that as of May 1, 1983, the penalty provision will go into effect calling for a forfeiture of not less than \$30 nor more than \$75 when the child is under the age of two. If the violator subsequently pro-

vides proof that a child restraint system has been installed in the vehicle within 30 days of the violation, the forfeiture will be waived.

In the case of a violation involving children two and three years of age, the penalty is a forfeiture of not less than \$10 nor more than \$25 for a first offense, and not less than \$25 nor more than \$200 for a second or subsequent offense within three years. There is no provision for waiving the penalty by installing a child restraint system for a violation involving a child between 2 and 4 years of age.

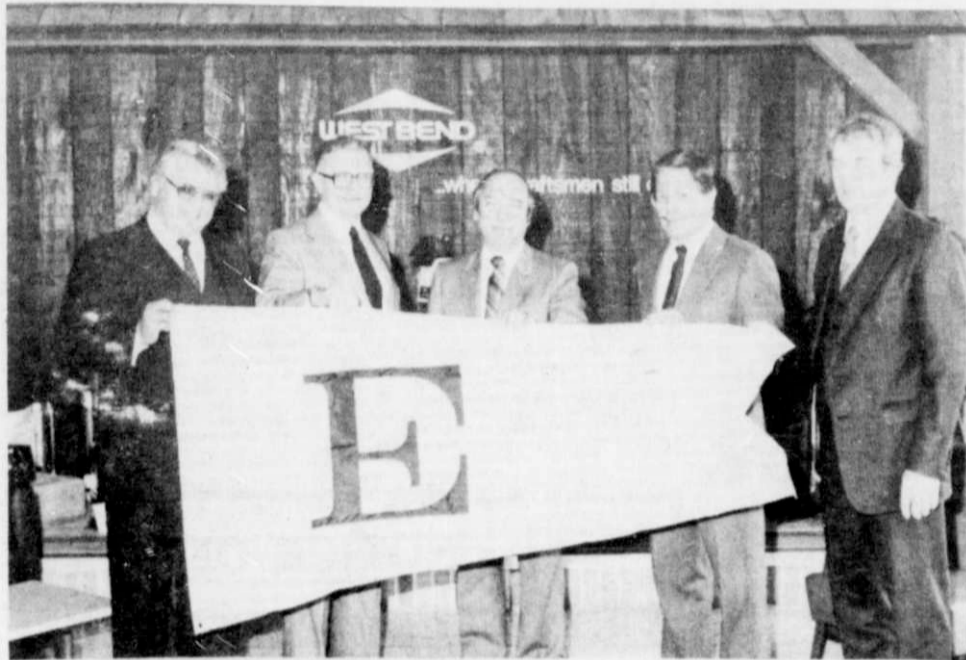

Choose Right-Size Turkey This Year

Count on a half pound of whole turkey per serving, and that means about one pound per person if you want second helpings. Thus a 16-pound turkey will feed sixteen to twenty. But, if you want leftovers, buy a 20-pounder, which is a good size for taste and tenderness, too.

A 20-pound bird takes three to four days to defrost in the refrigerator, or about 12 hours in a sinkful of water. In either case, leave the turkey in its original plastic wrapper until it seems thawed. Then unwrap as soon as possible, and pull out the package of giblets from inside the turkey. Often these are still frozen, indicating that the inside of the turkey is also still frozen. Finish thawing either at room temperature or, if you are not in a hurry, in the refrigerator. Keep thawed turkey under refrigeration, since it spoils more rapidly than fresh turkey, and plan to roast it within a day, or at most two days, of thawing.

Traffic Death Toll On Way to New Record Low, DOT Reports

Traffic deaths on Wisconsin highways for the first 10 months of 1982 are at the lowest point in over three decades, the state Department of Transportation reported.

Through October 31, 634 lives have been lost in traffic accidents, compared to 799 on the same date a year earlier. It is the lowest 10-month traffic death toll since 598 deaths were recorded through October, 1949. The highest 10-month totals on record were 1968 and 1970, when 971 persons were killed.

Preliminary data show 68 traffic deaths in October 1982, the lowest October death toll

since 1959, when 65 persons died. Of the past 15 months, only September 1982 exceeded the previous year in number of fatalities, the department reported.

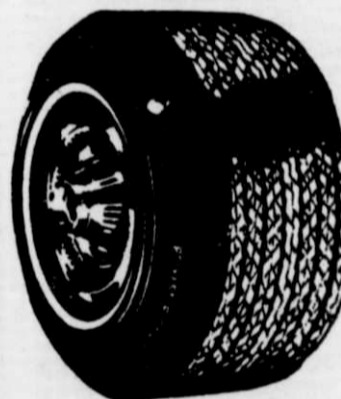
With the continuing downward trend in traffic deaths, Wisconsin is well on its way to a record low for the year. The previous low of 749 in 1949 occurred at a time when there were only 1.1 million Wisconsin registered vehicles on the road, compared to 3.4 million today, traveling 9.9 billion miles compared to more than 31 billion a year predicted for 1982.

In terms of mile death rates,

the 1949 rate was 7.56 deaths per 100 million miles of travel, compared to 2.76 in 1981.

**Firearm Casing
And Handgun Rules**

Certain handguns will be legal for the first time this gun deer season in Wisconsin, and hunters are urged to make sure they understand the casing requirements which apply to all firearms while being transported.

The rule was defined by the DNR this year in response to a request from a Wisconsin Legislative committee. It is in effect for the 1982-83 hunting season and applies to shotguns and rifles as well as handguns. The rule is as follows: "enclosed in a carrying case" for firearms means completely contained in a gun case expressly made for that purpose which is fully enclosed by being zipped, snapped, buckled, tied, or otherwise fastened, with no portion of the firearm exposed.

The new rule is more restrictive than the rule on handguns encasement while being transported in a vehicle. That rule is stated on Page 11 of the 1981 and 1982 Wisconsin Hunting Regulations pamphlet.

To be legal for taking deer this year, a handgun must be loaded with .357, .41 or .44 magnum caliber cartridges, or be any other caliber chambered for commercially manufactured cartridges which produce a minimum muzzle velocity of 1,000 foot pounds. The handgun must have a minimum barrel length of 5-1/2 inches measured from the muzzle to the firing pin with the action closed.

The use of handguns for deer is restricted to areas open to rifle deer hunting, and hunters using handguns for deer may not possess any other gun while in the field. A Deer License or Sports License is required to hunt deer with a handgun.

The gun season opens on Saturday, November 20, and runs through Sunday, November 28.

Have a Safe Deer Hunting Season, Sheriff Suggests

To have a safe and successful hunting season, deer hunters should not only obey the law, they should be extra careful, suggests Washington County Sheriff Clarence A. Schwartz.

Sheriff Schwartz also says that a true sportsman obeys hunting laws for his own protection of others. A true sportsman is careful of the lives and property of others. This includes always asking permission of the landowner to hunt on or to cross his property, as you could be subject to a charge of criminal trespass to land, in accordance with Wisconsin State Statutes.

Every year the misbehavior of a few hunters damages the reputation of thousands of hunters who obey the law and follow the codes of good sportsmanship, the Sheriff adds.

If you are a careful, thoughtful, lawful hunter, you will earn the respect of thousands of hunters and non-hunters alike. Then, whether you bagged a deer or not, you had a successful hunting season.

Deer Hunting Season Precautions

For nine days each November, hunters take to Wisconsin fields and woods in search of that prize doe or buck. More than 600,000 hunters are expected to test their luck and skill during the 1982 Wisconsin deer hunting season November 20-28.

Deer hunting is serious business. At any given time, 80 percent of all hunters will be out in the field and unless they take special precautions, some hunters will be killed or wounded in hunting accidents.

Hunting accidents can be averted if hunters follow some basic safety rules:

- * Treat every fire arm as a loaded weapon. The only safe safety is an open action.

- * Be sure of your target.
- * Make certain that the muzzle of your gun is always pointed in a safe direction, especially during loading and unloading.

- * Exercise year round. Don't wait until opening day to find out what kind of physical shape you're in. Check with your doctor on your physical condition.

- * Plan your hunt. Know the location of the nearest phone, doctor, ranger station or Fish and Game Department personnel.

- * Inform family and friends where you'll be hunting.

- * Take plenty of short rests and avoid unnecessary exertion.

- * Hunt at a steady, unhurried pace.

- * Keep an eye on the weather. Don't try to do as much in hot, humid weather as in cool weather.

- * Limit your drinking. Alcohol affects physical stamina, judgement and perception. Higher altitudes may lower your tolerance to alcohol.

- * Eat moderately. Take a rest or nap after each meal.

- * The hunter with a known heart condition should make certain at least one member of the party knows of his con-

dition, what medicine he takes and how to administer it. He should never hunt alone.

- * Report any violators you see to the nearest warden or law enforcement officer before another accident occurs.

- If someone in your hunting party does suffer a heart attack, follow these procedures:

- * Contact a doctor immediately. Don't let the patient walk. If you are unsuccessful in getting help to come to you, make a litter and carry the patient where he can get medical attention.

- * Help the patient into a position that is most comfortable for him. Most likely this will be halfway between lying and sitting. He may have difficulty breathing if he lies flat.

- * Loosen tight clothing such as belts or collars.

- * Make sure the patient does not become chilled, but don't induce sweating with too many blankets.

- * Don't give the patient anything to drink without the doctor's advice.

Remember, only you can make this a safe and happy

hunting season.

Deer Registration Stations in Area

The 1982 gun deer season will open statewide on Saturday, November 20th.

In the Southeast District, the season will run through Sunday, November 28th, in Zone A (north of Highways 60 and Q), with a bag limit of one buck or one antler-less deer with a hunter's choice permit. In Zone D (south of Highway 60 and Q), the season will run through Wednesday, November 24, with a bag limit of one of either sex.

The Southeast District includes the counties of Kenosha, Racine, Walworth, Waukesha, Milwaukee, Ozaukee, Washington and Sheboygan.

Hunters are reminded that rifles and handguns are NOT allowed for hunting deer in these counties with Milwaukee County being closed to hunting. Tagging and registration requirements can be found on

page 18 of the 1981-82 Wisconsin Hunting Regulations pamphlet.

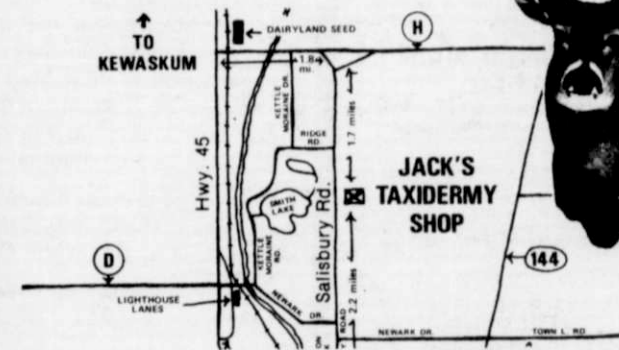
