Board Ratifies Business Manager's Contract

No Popularity Awards for Kewaskum School Board

The approximately 150 Kewaskum residents who attended Monday night's special school board meeting found little to be happy or optimistic about after the almost three-hour session came to a close.

Faced with a 1985-86 proposed budget carrying a double-digit increase of 13% to 14%, depending upon final cuts, residents became a little more than upset when the board ratified a contract for business manager Cherna Gorder. According to the board's calculations, the new contract gives Gorder a 14.89% raise plus a \$25.00 a month car allowance for 1985-86.

Clara Trapp, Town of Scott, challenged the board's figures saying Gorder's actual increase amounted to over 25%. Trapp based her statement on the grounds that Gorder's original

1984-85 contract was for 240 days at a salary of \$29,500. That contract was later amended to add an additional 20 days, increasing her 1984-85 salary to \$32,204. However, when the new contract was negotiated, the work days were dropped back to 240, but the increase noted Trapp was calculated on the \$32,000 figure.

Board member Kim Peterson made a motion to rescind the contract and send it back to the Negotiations Committee for review. Board President Tom Brigham told Peterson his motion was out of order since he was not one of the majority votes that had approved the contract during the closed session.

After one resident asked if Mrs. Trapp's comments were true or not, Board Member Jean Goeden, (who made the original motion to grant the 15% increase in closed session), amended her ratification motion

to raise the work days from 240 to 260. The motion passed on a 4-3 vote, with Kim Peterson, Perry Ankerson and Neal Weare voting "no."

Another district resident wanted to know how the board could approve the contract when electors at the Annual Meeting voted down the budget and demanded the board look for more cuts.

Following the Monday meeting, Trapp said she had talked with board member Ron Theusch at last Thursday's Town of Wayne Board meeting. "Theusch told me he didn't know what he was voting on, that he thought all she (Gorder) was getting was \$5,000," said Trapp.

The meeting then went on to discuss the 1985-86 budget. District Administrator Penny Kleinhans presented a list containing \$143,000 in district-wide budget cuts. She noted that the

Ground Broken for Cedar Valley Campus, Town Wayne

Plans for an ecumenical Church - Bible - Camp - Retreat center for Christians of all denominations has received the green light and construction has begun, the Kewaskum Statesman learned this week.

The Cedar Valley Campus, located on approximately 98 acres in the Town of Wayne, will be operated by the not for profit Benevolent Corporation of the Cedar Lake Home Campus. This corporation, affiliated with the United Church of Christ, operates the Cedar Lake Home Campus in the Town of West Bend.

"The new campus, recently received as a gift to the corporation, will enhance our outreach mission to the larger community with exceptional and creative programs for people of all ages and walks of life," explained Rev. L. C.

Riesch, Superintendent of the Cedar Lake Home Campus. "We will be working closely with people from all walks of life who seek spiritual and educational enrichment."

The Cedar Valley Campus will have a multi-facet structure which will contain rooms for 34 guests for overnight stays, a dining room, sanctuary for ecumenical services, plus meeting rooms. The building has been designed to emulate early Wisconsin farm building architecture. A mediation chapel is already on the site.

The natural beauty of the Kettle Moraine will be preserved and enhanced to encourage individuals to come to meditate and find refreshment through nature and works of art.

Completion of the building is slated for early 1986.

Closed Campus for Freshmen

On a five to one vote, the Kewaskum School Board has approved closing the High School campus beginning with the freshman class in 1985-86, followed by the closing of the entire campus, freshmen through senior, at the start of the 1986-87 school year.

The approval came after a motion by Policy Committee Chairman Neal Weare to institute a closed campus for all high school grades this year died because of a three-three tie vote. Board member Kim Peterson, who would have cast a deciding vote was absent from Wednesday night's meeting.

Weare was disappointed by the board's action since his motion had been unanimously backed by the members of his committee who had put a lot of time and study into the recommendation. At a previous meeting, Weare had told the board he felt the high school's neighbors had suffered long enough with vandalism and bad behavior and he hoped the board would take some affirmative action to resolve the situation. Board member Perry Ankerson cast the only dissenting vote on the second motion.

In other action, the board approved District Administrator Penny Kleinhans' request to set up a location and crossing guard

for Bel-Ric Acres area students. After completion of sidewalks along Highway 45 and H, students from that area will have to walk to school since

busing will no longer be required. According to state law, busing must be furnished for students living two or more

Kewaskum Youth Killed In Car/Truck Collision

John C. Harju, 18 of 1932 Trails End Lane, Kewaskum, was killed in a collision at 1:04 p.m. Monday, at the intersection of Whitewood Road and Highway 144, Town of Farmington. Barbara Harju, 43, the victim's mother, who was a passenger in the Harju car, was also injured in the accident. The Washington County Sheriff's Department report stated Harju was driving his vehicle on Whitewood when he stopped for the stop sign, then

proceeded to turn left (south) onto Hwy. 144. Harju apparently pulled out in front of a northbound tractor-trailer driven by Raymond J. Herriges of 9347 Boltonville Road, Kewaskum. The Harju vehicle was hit in the left side by the semi. He was reportedly on the way to take his driver's test, an official noted.

The Newburg and Kewaskum Rescue Squads were called to the scene and the victims were transported to St. Joseph's Community Hospital, West Bend. Hospital personnel said, at the patient's request, they could not release any information on their condition, or injuries, but reports indicated John Harju was pronounced dead on arrival of internal injuries at the hospital and his mother suffered fractured ribs and a bruised spleen. The truck driver was not injured.

Harju was a 1985 graduate of Kewaskum High School, participated in baseball, basketball and track, and had worked for the Kewaskum Statesman during his junior and senior years reporting sports news.

No citations were issued, said a Sheriff's Department officer.

Harju's death is the county's ninth traffic fatality of the year.

\$143,000 in reduction would end up to be less, around \$136,000, since there were \$6,300 in property insurance and workers compensation increases which had to be added to the proposed budget.

A Town of Wayne resident asked Kleinhans how she could talk about cuts when everyone was getting raises. Kleinhans told the man the district has little control over raises since a mediator will make a final decision if negotiating teams can't come to an agreement on their own.

Another taxpayer told Kleinhans, "we're at least getting your attention since you're attempting to cut the budget but the things you've shown us so far are just tokenism."

Kleinhans was asked why the board had not looked into teacher and program cuts. She indicated such decisions would have had to be made back in February according to law. Neal Weare backed Kleinhans by saying those things should have been looked at by the person whose job it was at that time.

Ted Stude, Town of Farmington, told the board, "sixty-seven cents out of every dollar I pay in taxes goes to the school district and now you're asking for another 14%. When we see a person get a raise of 15-25%, we have a right to be concerned." Stude pleaded with the board, you've got to understand our situation and be reasonable, we can see salary increases in line with the cost of living rise and that's all we're asking is for you to use reasonable judgment.

The meeting was then addressed by Business Manager Cherna Gorder who presented four options as ways to finance the 1985-86 tax levy. Option #1 contains a 14.2% levy increase with a 13.22% rise in the mill rate (the present proposal). Option #2 has a 9.68% levy increase, 8.67% mill rate

increase. Option #3, levy up 5.8%, mill rate up 4.9%. Option #4, levy increase of 1.92% and mill rate increase of 1.05%.

After hearing Gorder's detailed explanation of each option, Dr. Charles Ogi, a former school board member, stated "what you're telling us is, every step down on the levy means we're increasing our deficit, just like the federal government." Gorder said that was correct.

The board took no action on deciding which option to follow. The information was presented for discussion and will be reviewed further before a final decision is made.

The question of busing students from the Bel-Ric and trailer court areas was brought up by a parent. Kleinhans again advised the public that once the sidewalks are completed the district is no longer legally obligated to bus students who live less than two miles from school. A designated crossing and guards would be provided to aid children in crossing Highway 45 and H.

Many of the parents were upset asking if the district would guarantee that the walks would be shoveled during the winter in non-residence areas such as the cemetery and milk re-load station. Brigham said that did not fall within the board's jurisdiction.

Following the meeting, some parents of students in other areas of the district indicated they could not sympathize with the Bel-Ric parents. One man noted, at least they'll have sidewalks, our youngsters and the neighbor's kids have been walking along the side of our road for years with almost no shoulder during the winter to reach their bus pick-up points and they've learned to be careful and watch for cars.

A Bel-Ric resident noted that they have watched the children walk to the swimming pool the last few summers. Not having sidewalks hasn't seemed to bother them or stop them from getting into town then.

The board also discussed the busing of 14 Beechwood kindergarten students to other schools. Kleinhans said dividing the children among the other classes would not overcrowd any particular class and the move would eliminate the need for a 1/2 time kindergarten teaching position at Beechwood. In the closing minutes of the

meeting Mr. Marvin Berg of the Department of Public Instruction addressed the district's budgeting dilemma. Berg said he had been working with the board in an effort to help them find solutions to its budgeting difficulties, and would continue to work with it as long as it felt his assistance was needed.

During the meeting board member Ron Theusch made a comment that the board could not please everyone with its decisions or cuts because there were always special interest groups. After Monday's meeting it was hard to find anyone who felt their special interests had been served by the board's actions.

son and Winnebago Lutheran Academy of Fond du Lac.

miles from their school. The Bel-Ric subdivision is 1 1/2 miles from school. Dropping service to the area will save the district \$16,000 in busing costs, said Kleinhans.

Business Manager Cherna Gorder asked for board approval on gasoline, oil and milk bids for the 1985-86 school year. She also informed the board that the district is having money problems. Gorder said the district is expending \$2,600 more per month for loans than if it had borrowed \$1.5 million through a plan she was to have proposed had the district's electors approved the 1985-86 budget last month. Gorder had been prepared to present a borrowing program at a meeting scheduled to follow last month's annual meeting. However, when the proposed budget was defeated the second meeting was cancelled.

The board also accepted the Administrator's recommendations on acceptance of resignations, a contract rejection and approval of teaching contracts for replacement teachers in

existing positions.

Kleinhans also informed the board that the district has lost a Workmen's Compensation claim amounting to approximately \$23,000. She said she had met with Mr. Gene Bohn of the Kettle Moraine Insurance Agency and asked him to investigate the possibility of having some of the district's cases reviewed.

Town Scott Board to Clamp Down on Farmers

Town Scott farmers will need to do some careful planning for the 1986 growing season. The town board will be cracking down on those who choose to plant their crops right up to the roadway. Chairman Charles Fick said that he has observed corn planted right in the gravel on the shoulder of the road. In one place the "Stop Sign Ahead" is hidden by several rows of corn. Consideration was given to have the road superintendent cut down any crops which are planted in the right of way as part of the roadside mowing program.

Supervisor Clara Trapp suggested that because the feed crop was not in abundant supply this year, that the town postpone such action until next year.

There are other instances of farmers plowing in the ditches and obstructing the flow of water. These ditches will be cleaned out in the spring and all farmers will be advised that in 1986, anything within the right of way (33 feet from the center of the road), will be removed. This also pertains to construc-

tion of fences within the right of way.

A letter is being drafted to send to all property owners either with the tax billing in January or with the new assessment notices in April.

A resolution was passed authorizing the board to borrow \$74,865 from the Trust Fund of the State of Wisconsin Board of Commissioners of Public Lands for the purchase of a road grader. The rate of interest to be paid will be 7 1/2%. The loan must be paid in 10 years.

Shortage of money is hampering the board from making much needed road repairs. Road Superintendent Leroy Gnacinski reported that a bad spot exists on Lone Pine Road. It is about 200 to 250 feet long with estimated repair work to cost about \$3,000. Dropping a previous commitment to pave Church Street in Beechwood was considered but because the project had already been postponed a year or two the board's decision was to honor the commitment and to include Lone Pine Road on the 1986 Road budget.

Copies of a mobile home parking ordinance which is in

effect in the Town of Middle Inlet in northern Wisconsin was reviewed and action was tabled until September. If adopted, the ordinance will provide additional revenue for the town and the schools as well.

A policy was established concerning private work done by the Sheboygan County Highway Department. In the future it will be necessary to have an approval slip signed by either the town chairman or Supervisor Dale Burke before work can be done or items such as culverts are purchased.

Rezoning of 5 acres in the SW 1/4 of Section 34 from A-1 to A-2 for David Jung was approved.

Several changes in the zoning ordinance were also approved. Buildings, signs, or other attachments to buildings where there is a non conforming use can be no closer to the highway than the non-conforming use. This means that if you have a building on a spot which does not conform to the zoning ordinance, you will not be allowed to add anything to that building which would extend beyond the original building.

All mention of individual rear yard requirements of 100 feet

have been deleted from the ordinance. The revised wording will require all rear and side yards to be 20 feet from the lot line in the A-1, A-2, A-3, A-5, P-2, R-1, and R-2 classifications.

State of Wisconsin census figures show that the Town of Scott has 30 more citizens than it did in 1984. Total population is now 1655.

Village Board Makes Annual Inspection Tour

Members of the Kewaskum Village Board made their annual inspection of village facilities prior to its monthly meeting Monday night and found only minor items needing action.

The board directed Village Administrator Dan Schmidt to work with the village's attorney in contacting Fiberglass Engineers Incorporated regarding finishes on the sidewalls of the Water Treatment Plant's two dome covers. Schmidt said there were no problems with the covers other than some cosmetic work to improve an unsatisfactory appearance of the dome sidewalls.

In other action the board discussed the feasibility of reversing the north baseball diamond at Kewaskum Kiwanis Park. Schmidt will turn the matter over to the village's engineers for study and a recommendation. The cost to reverse the field would be \$1,500.

Remodeling of the Municipal Building is progressing on schedule and costs, so far, are running below projected estimates. At the present time it looks like there will be about \$25,000 to \$30,000 left in the Building Fund after work is completed, said Schmidt. Between that balance and higher than anticipated budget revenues earned from investments, the village may be able to reduce the amount of the Municipal Building's Wisconsin Trust Fund loan from \$300,000 down to \$270,000 or even \$240,000, noted Schmidt.

Schmidt said he would have a more complete financial report on the project ready for the October meeting and a resolu-

tion ready for adoption by the board if it decides to adjust the loan amount.

The board also approved the purchase of council room desks which will replace the present tables used by the trustees.

Because of the Labor Day holiday, the September 2nd village board meeting has been cancelled and unless some unexpected business comes up, the board will not meet again until September 16th.

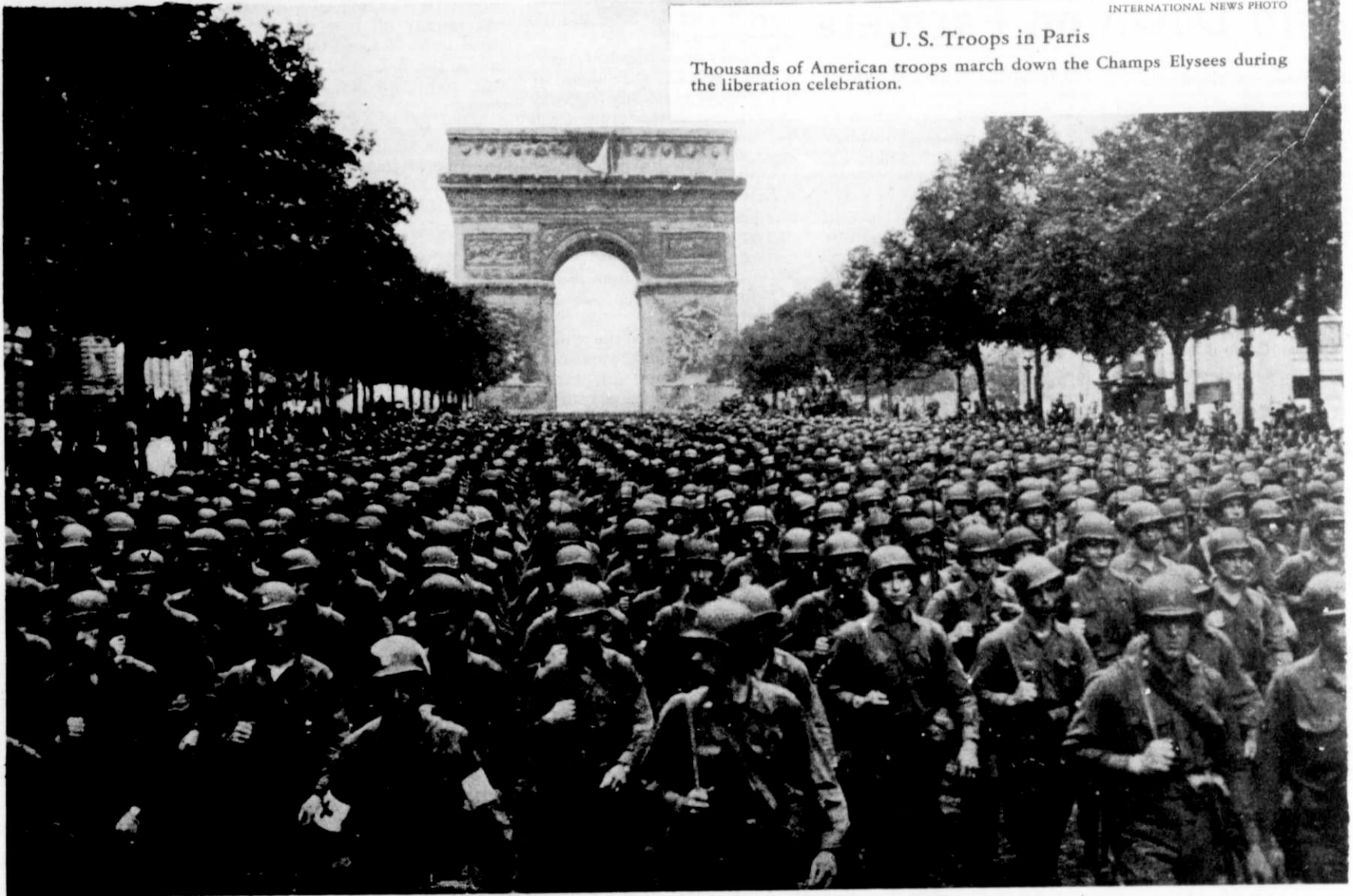

Four Injured In Collisions

County Treasurer Disburses \$11.4 Million in Tax Levies

Fredric A. Seefeldt, Washington County Treasurer, announced that on Tuesday, August 20, he had disbursed \$11.4 million in final payments on local and school tax levies.

These taxing entities received an initial payment in March based on the percentage of the tax roll collected by the local treasurers through February 28. The tax rolls were then turned over to the County Treasurer for the collection of the postponed and delinquent taxes. Following the July 31 deadline for payment of postponed real estate taxes, the County Treasurer made the final payment on August 20 as required by State law.

"Under the Wisconsin real estate tax collection system, the County Treasurer must pay out any remaining balances on the current tax levy whether or not the money has been collected. 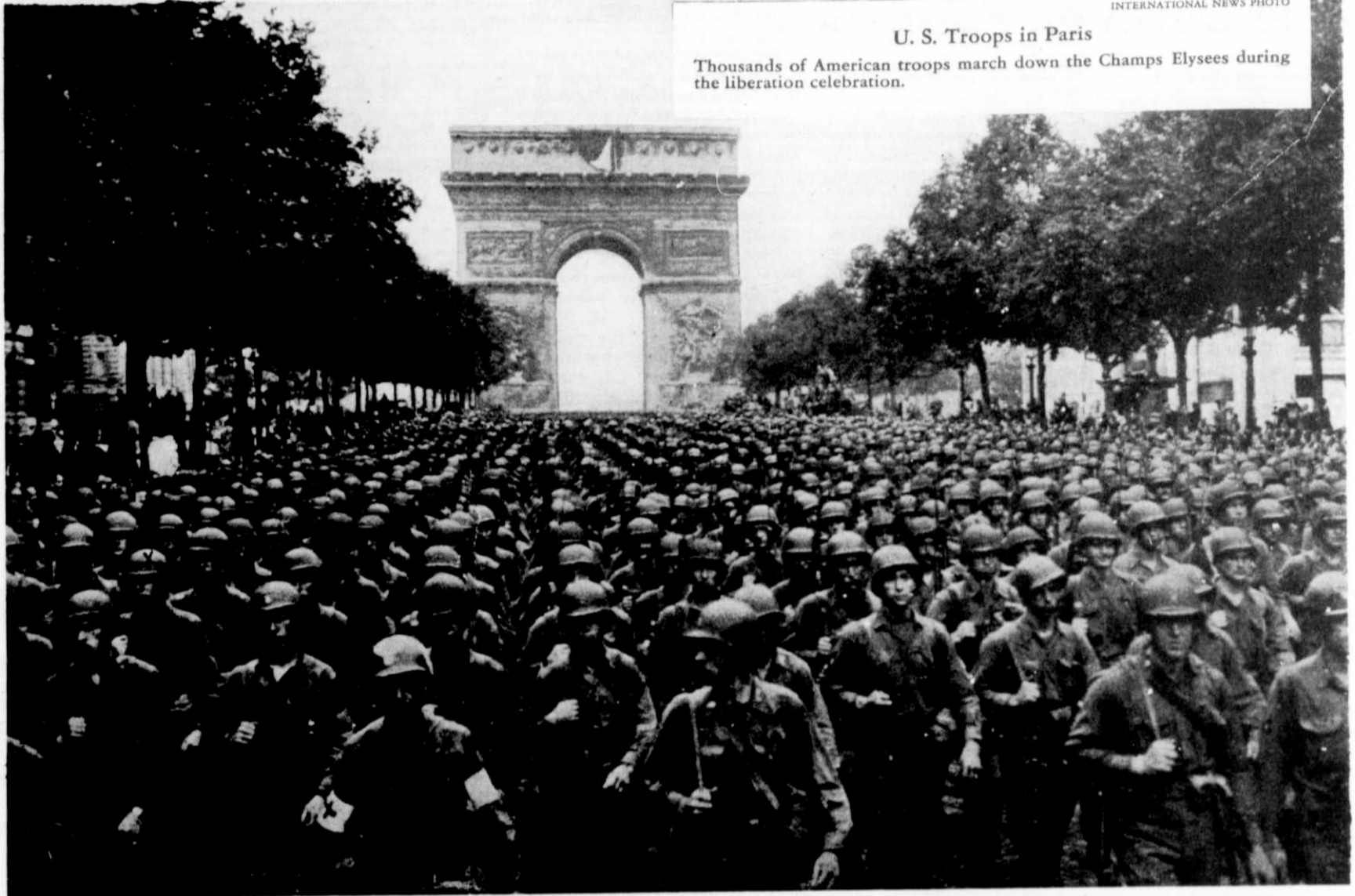

County Treasurer Disburses \$11.4 Million in Tax Levies

Fredric A. Seefeldt, Washington County Treasurer, announced that on Tuesday, August 20, he had disbursed \$11.4 million in final payments on local and school tax levies.

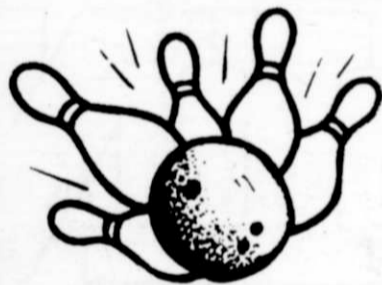

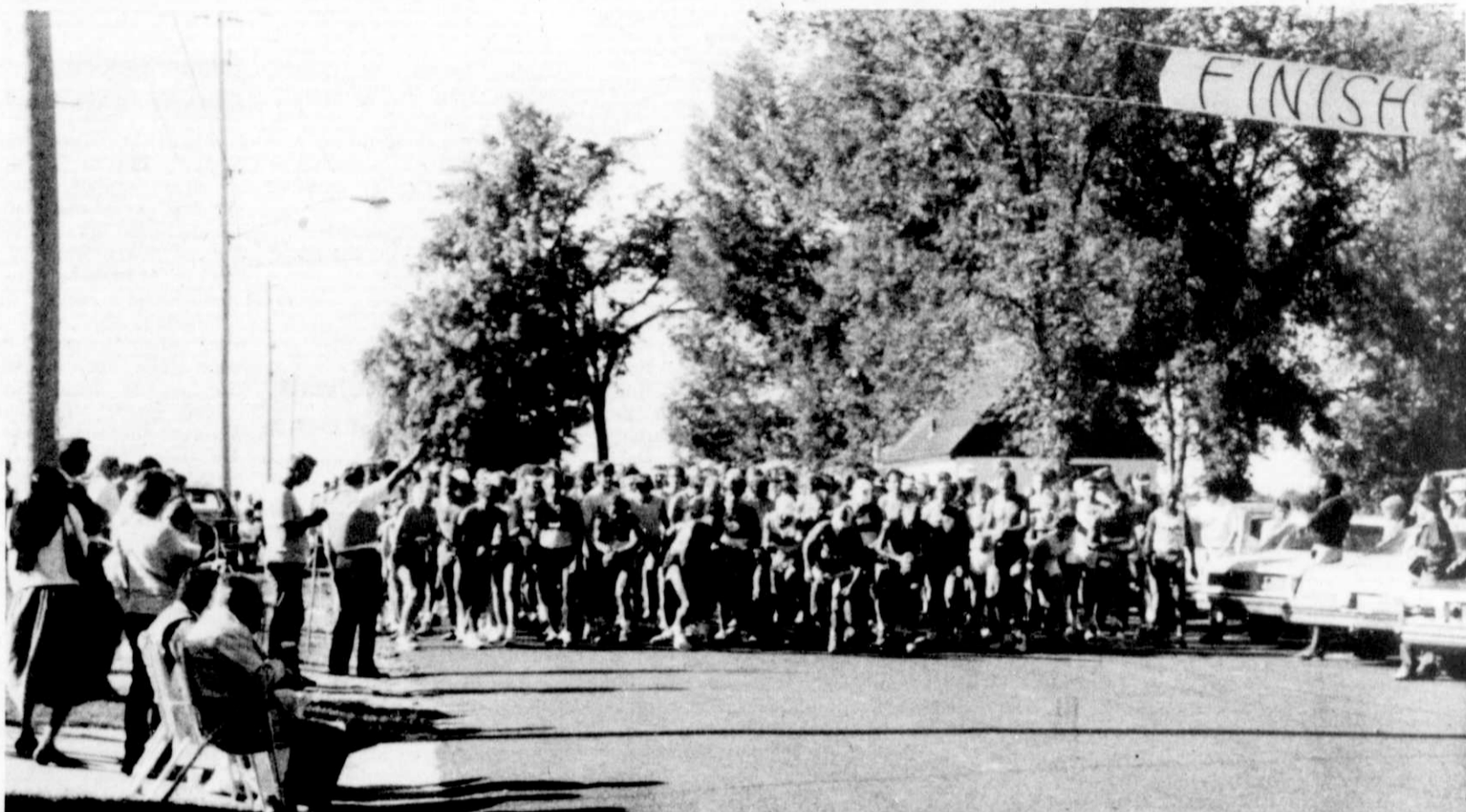

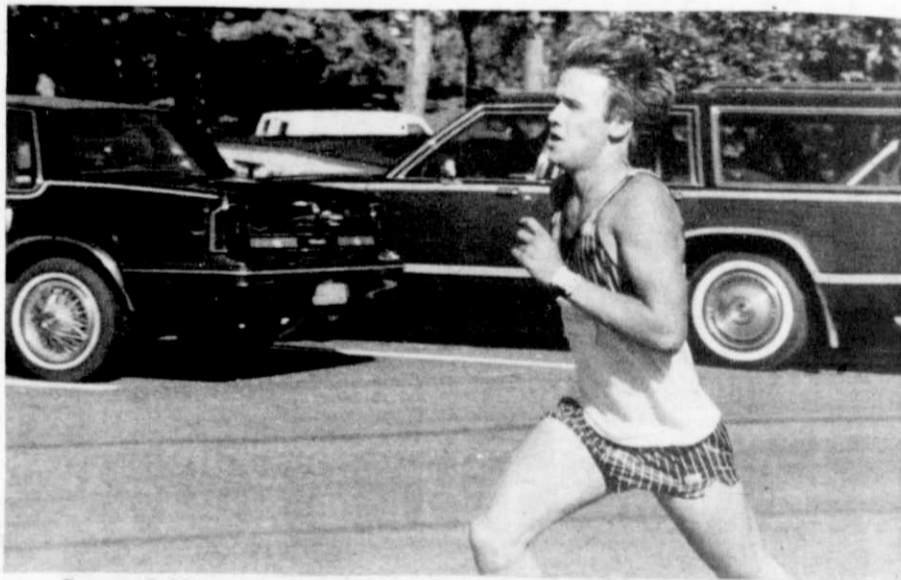

Washington County Joins Milwaukee River Cleanup Program, DNR Reports

Two more counties have signed contracts to participate in the Milwaukee River cleanup program, the Department of Natural Resources reports.

Ozaukee and Washington Counties recently joined Fond du Lac and Sheboygan Counties in contracting with the DNR to do inventory work on portions of the Milwaukee River system that lie within their boundaries. Washington County also will handle inventory work for Waukesha County which contains a segment of the Menominee River, a tributary to the Milwaukee.

Under the contracts, participating counties will be reim-

bursed by the state for identifying sources of nonpoint pollution in watersheds within their boundaries. Nonpoint source pollution is caused by erosion or runoff from a variety of rural and urban sources.

State funding will provide \$26,380 to Ozaukee County and \$51,140 to Washington County for the inventory programs. Later, participating counties will enter a second agreement with the DNR to cover expenses of counties undertaking corrective actions to reduce non-point source pollution.

KHS Teachers Attend Session at MPTI

Three Kewaskum High School teachers joined their counterparts at Moraine Park Technical Institute in Fond du Lac earlier this summer to jointly plan curriculum and develop a common language relative to the competencies they teach.

Dale Schatz, business education teacher, David Stradtman, chairman of the industrial arts department, and Keith Amundson, drafting instructor, joined ten other high school teachers from around the Moraine Park VTAE District in working with four MPTI instructors in the areas of secretarial, food services, drafting, and farm operations.

The one-week session, held in late June, was the first step in an ongoing project on "Task Level Articulation," wherein teachers on the high school and post-secondary levels seek ways to coordinate their curriculum.

The first step in the articulation project was to identify the tasks normally performed in the four occupational areas chosen for the project. These tasks then become the competencies which a student must master in preparation for a career in those fields.

The project's participants then identified the standards of performance (criteria) for each competency that a student would have to meet.

The next step in the articulation process is to identify curriculum and course sequences through which students can progress in pursuit of a career. A student reporting form is then developed to document and track student progress on common competencies.

By receiving credit at the post-secondary level for skills attained while in high school, a student can be eligible for advanced standing, thus avoiding course duplication and saving valuable time and money. "The key is to enable the student to transfer credit for the education he or she has already received," explained Ron Speich, instructor in MPTI's food service programs.

Equally important, a clearly defined sequence of competencies from the high school to post-secondary level provides the student with a greater understanding of what is necessary to achieve their career goal. Defining such a career

ladder serves as an "incentive to get (high school) students into post-secondary schools," said Kewaskum High School's Dave Stradtman.

Betty Brunelle, assistant director for instruction at MPTI, stressed that the project's purpose was not to mandate curriculum in the high schools. "It is still up to the local school districts as to how they teach these competencies," she explained. In the meantime, MPTI is working with the project's eight schools to finalize formal articulation agreements. Future activities could include adding more schools and working with other program areas.

New State Budget Encourages Families On Aid to 'Escape to Wisconsin'

By Senator Don Stitt

In the southeast part of Wisconsin, there are obvious signs of new residents coming to Wisconsin from Illinois and other nearby states. Many say the sudden influx of out of state residents to this area is directly related to the recent increase in state welfare programs contained in the new state budget.

Wisconsin is number three in the nation for average welfare payments per month. Even more remarkable is the fact that welfare families can move to Wisconsin from Illinois and collect as much as \$281 more in Aid to Families of Dependent Children (AFDC). In May, almost 40% of the new AFDC cases for Kenosha County alone were from out of state.

Only two other states, Alaska and California, pay more than Wisconsin in AFDC payments per month. Any neighboring state resident, therefore, has a strong incentive to relocate to Wisconsin. In addition to an increase in caseload, these resi-

dents also increase the costs of local and state services further increasing the pressure on property taxes and state income taxes.

Notwithstanding our high national ranking, Governor Earl increased AFDC payments by 6% or \$23.5 million in his two year budget proposal. The State Legislature, however, reduced this proposed increase to 4% or \$15 million.

Our disadvantaged, poor citizens certainly deserve some level of support, but it should be kept low enough to create a strong incentive for those people to seek employment and become productive, taxpaying citizens. In addition, our welfare system must not be so generous that we attract welfare recipients from other states.

Hog Barn Looking Fine

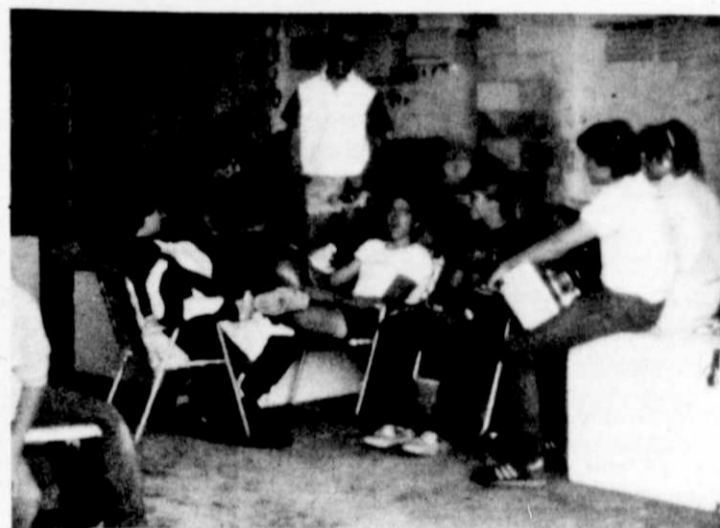

supplied by the Washington County Fair Board.

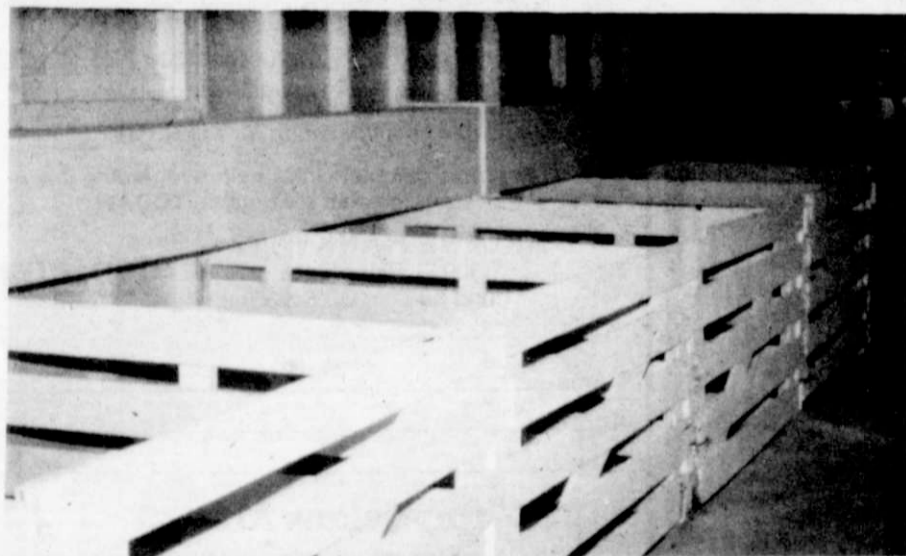

Earnings Growth Reported By Valley Bancorporation

For the second quarter of 1985, Valley Bancorporation reported earnings of \$2,934,666 compared with \$2,165,106 earned in the second quarter of 1984. Per share earnings in 1985 amounted to \$.85, a 13.3% increase over the \$.75 earned in the second quarter of 1984. Six month earnings were reported at \$5,164,772 compared with \$4,324,299 in 1984. Earnings per share amounted to \$1.63, an increase of 8.0% over the 1984 six month earnings per share of \$1.51. Weighted average shares outstanding totaled 3,165,108 in 1985 and 2,857,774 in 1984.

At June 30, 1985, Valley reported total assets of \$1.410 billion, an increase of 30.2% over the \$1.083 billion recorded June 30, 1984. Net loans increased 27.2% to \$805 million, compared with \$633 million, one year earlier. Deposits stood at \$1.203 billion, an increase of 30.6%, over June 1984 deposits of \$921 million. The increase in assets, loans and deposits reflects both internal growth of approximately 10% and growth through the recent acquisitions of the \$56 million-asset Valley First National Bank of Rhineland (October 31, 1984) and the \$170 million-asset BANCWIS Corporation - Janesville (March 31, 1985). Both acquisitions were accounted for as purchase transactions and therefore, results of operations are included only for the period subsequent to their respective acquisition dates.

During May, 1985, Valley completed the acquisition of Valley Bank of Oregon with \$38 million in assets. This acquisition was accounted for as a

pooling of interests and consequently, all prior period financial information has been restated to include Valley Bank of Oregon.

Stockholders' Equity totaled \$84.8 million, an increase of \$20.6 million over the \$64.2 million on June 30, 1984. Of this increase, \$14.3 million was attributable to the issuance of approximately 579,000 shares of Valley common stock (including \$5.5 million in cash) to acquire all of the outstanding shares of BANCWIS Corporation. DNR Issues Master Plan on Gilbert Lake Fishery Area

The Department of Natural Resources has prepared a Master Plan on the proposed establishment of a Gilbert Lake Fishery Area, Town of West Bend, Washington County. This Master Plan was developed by a task force comprised of Department specialists in various disciplines including fish, wildlife, and forestry.

The Master Plan identifies goals, and objectives as well as recommends a management and development program for the Gilbert Lake Fishery Area.

A number of public meetings last year identified some issues that generated several changes in the original project proposal. The environmental assessment that was previously prepared has also been amended to reflect these changes. The amended environmental assessment evaluates and examines the issues and concept elements that are identified in the Master Plan.
