## Nashville Music Sounds From the Hills of Kewaskum

When this reporter asked Debbie Nigh, of Kewaskum, how she got started, she replied simply, "I guess I've always been doing it." What "it" is, is writing country and western songs which has led her to become a protege of one of America's most popular country music groups, "Alabama."

Debbie, the daughter of Charles and Beverly Schultz, Kewaskum, had always enjoyed creating lyrics and she continued to write songs on her own following her graduation from Kewaskum High School in 1978, and after her marriage to Michael Nigh.

As with all songwriters, Debbie had hopes that some day her songs would be published and recorded, and that time has come. Although she knows it still does not mean a successful career, it is another step in that long way to the top. Nigh quickly admits the advances she has made in her fledgling career are due to a large amount of luck and being in the right place at the right time. A writer can have all the talent in the world but if you don't know the right people and get the right break at the right time, you're just another one of the hundreds struggling for success in Nashville. Timing is so important in this industry.

That first right place for Debbie a while back, turned out to be a Milwaukee recording

studio where a group from Random Lake was recording one of Nigh's songs. It was during that recording session that Debbie met Jim Reith, one of the studio's personnel who would become one of Debbie's co-writers and eventually a producer on an album featuring two of Nigh's songs. "There was no tie-in," said Nigh, "we were just lucky to meet each other." Coincidentally, Reith has his own company which does TV commercials, including one for Regal Ware, Incorporated, Kewaskum.

That meeting resulted in Reith and Nigh collaborating, with their first success published by Alabama's recording company, Maypop Music in Nashville. Nigh was quick to point out that there is a big difference between getting your songs published and getting a song recorded. She has a couple of songs which have been published and demo taped for possible future release. In this business, there are so many ups

## Village Receives State Tax Credit Figures

Administrator Dan Schmidt informed the Kewaskum Village Board Monday night, that he has received the village's 1985 state tax credit. The credit of \$3.71 per \$1,000 of assessed valuation will bring the Village of Kewaskum's total net tax rate of \$22.93, up \$2.90 or 14.5% over 1984. Schmidt indicated that while the village's portion of the total rate had dropped slightly, there were major increases in other areas such as the school tax.

In other action, the board discussed an analysis of library service costs for a village family. Schmidt said that the study showed it cost \$33.00 a

year. The board was reminded that the village is presently charging non-resident families \$20.00 a year for library privileges. After a short discussion, the Village Board approved the recommendation of the library committee to increase the annual fee for non-resident families to \$36.00. Schmidt noted this would be 10% higher than the break-even point for library costs.

The board discussed garbage collection and some potential hazards. Schmidt said the Public Works Department is running into situations where residents are not using adequate or standard containers for their garbage. Some people are using large barrels, which

## Efforts Being Made to Eliminate Dangerous Highway 28 Curve

The Kewaskum Town Board will meet Friday, Dec. 6, with Department of Natural Resources, Department of Transportation and State officials in hope of getting a dangerous curve along Highway 28 removed.

Town Chairman George Allmann said he has been working for some time to have a curve, located on Highway 28 at the gravel pit east of Kewaskum eliminated. There have been several accidents on that curve resulting in injuries and death, noted Allmann.

The State has already begun preliminary shoulder and culvert work on 28 heading east out of the village of Kewaskum in preparation for reconstruction of that section next year. However, Allmann has not been able to find out if removal of the gravel pit curve has been included in those plans.

Allmann said his early efforts to get the area straightened as

part of next year's road work were hampered because the DNR did not want to give up some state forest land which would be needed to reconstruct the curve. That situation has now changed, said Allmann, and the DNR is now willing to give up the necessary real estate. He said, however, that he has not been able to find out where the DOT stands on the request. Allmann hopes Friday's special town board meeting will bring some answers.

The groups will be meeting at the area at 1:00 p.m. to review the area and Allmann's request. Allmann is also scheduled to appear before the Washington County Safety Commission later this month regarding the proposed removal of the curve.

One factor which may affect a decision is the speed limit. Removal of a hazardous condition can be considered if the speed limit must be reduced because the area cannot be safely traversed at the normal 55 mile-per-hour speed limit.

and downs that a song which looks like it has a good chance one day may be out the window the next, noted Nigh.

One of her biggest breaks was becoming friends with the members of Alabama, noted Nigh. They're a down-to-earth group of guys and they've helped me by introducing me to people in the business, many of whom I might never have met on my own because of the limited amount of time I spend in Nashville.

Nigh said one of her biggest problems with writing is the fact that she works out of her home in Kewaskum, as she says, "away from the action in Nashville." It's one of the reasons she works on her songs with two co-writers, Reith and Ron Scaife, who are both very musical. I write my songs rhythmically and play just enough guitar and piano to give myself an idea of how a song will sound. When I have the opportunity, I work with Jim or Ron going over the verses, picking out what we can use, until we come up with a finished song. Most professional lyricists and musicians can get together in a room and work on their songs, that's one of the advantages of living in a place like Nashville.

Debbie does make frequent trips to Nashville as well as other parts of the country. I'm lucky my husband Mike is understanding and encourages my songwriting.

Nigh's most recent opportune encounter came through a friend, Joanne Beacham, of Milwaukee radio station WMIL. Through Beacham's efforts, Nigh met Jim Hudson, a singer from Greenfield who was performing on the south side at the Red Carpet Inn.

Nigh began working on music for Hudson. This past fall, Hudson entered the regional Marlboro Talent Round-Up sponsored by the Marlboro Cigarette Company. On October 15th, Hudson and his group, The Music City Drifters, won, earning a \$5,000 first place prize and the opportunity to be the opening act for the Marlboro Country Music Concert in Milwaukee which featured country music stars Merle Haggard, Eddie Rabbitt, Ricky Skaggs and Exile.

In his act Hudson sang two of

Nigh's songs, "Will It Ever Be Enough," and "Bring Back The Thunder," the latter of which is also the title for Hudson's new album which will be released shortly on an independent label by executive producer Tim Rudden, a former Milwaukeean who now lives in San Jose, California. Reith is producer of the album and Nigh associate-producer.

Although Nigh is happy with her accomplishments so far, she is cautiously optimistic about her future in the music business. You really need a major label backing you but stranger things have happened in this business, and I wish Jim all the luck in the world with his album, said Nigh.

I've been very fortunate in meeting people like Alabama who have taken me under their wing and helped me with my career but there are lots of talented people in Nashville and only a few will be lucky enough to make it to the top.

when full, cannot be lifted by one person without possible injury to the workers. Schmidt said the village will begin tagging all improper containers and the ordinance will be enforced.

The board also passed a resolution which will reduce the amount of the Wisconsin Trust Fund loan, secured for the Municipal Building remodeling, from \$300,000 to \$240,000. Because the last installment of \$60,000 on the loan has not been received yet, and final figures show the project was done for less than the estimated cost, the village will amend its loan to the lower figure.

The board also approved the proposed route of the Kewaskum Sno-Chiefs Snowmobile Trail in the village for 1985-86.

The Fire Department also received authorization to advertise for bids for a new tanker apparatus body.

The board heard a Plan Commission report regarding a building permit application by Dr. Cesar Sison. A public hearing on the request has been scheduled for December 16th.

The board then adjourned to closed session.

## Cedar Lake Home Campus Invests in Slinger Land

The non-profit Benevolent Corporation of the Cedar Lake Home Campus, in conjunction with its long range investment and future planning program, has purchased 35.97 acres of land in the Slinger community, Washington County. The land, which lies adjacent to the Slinger Village Hall on Slinger Road and Highway 60, was formerly owned by five members of the Nehm-Mechenich family.

The Benevolent Corporation has operated the Cedar Lake Home Campus, West Bend, Wisconsin, for the past thirty-two years. It presently is expanding its ministry to the aged in the city of West Bend, where it is erecting a 120 unit apartment complex to provide retirees with facilities and programs for wellness and

purposeful retirement. It also is expanding its community educational and ecumenical Christian outreach program through developing a ninety-eight acre gift - parcel of land in the town of Wayne.

"It is our belief," Burt Lass, corporate board president, stated, "considering the rapid present and projected growth of the aged population, that our present and future generation of board members, staff, residents, and volunteers will find the future challenge to one day utilize the Slinger site in providing additional services on behalf of aging humanity. As a non-for-profit corporation our board needs to ever be community-service orientated both in the meeting of present as well as future needs."

### Christmas Decorations in Public Buildings Must Be Flame Proof, Fire Department Advises

The Christmas Season is once again upon us, which brings to us a number of inquiries about the use of real Christmas trees, wreaths and tree boughs for decorations inside public buildings such as churches, schools, halls, etc.

The Wisconsin Department of Industry, Labor and Human Relations Code #ILHR55.19 applies to decorations. This code #ILHR55.19 states that all decorations used shall be flame proof.

This law applies to all churches, schools, assembly halls, dining rooms, dance halls, gymnasiums, lecture halls, lodge halls, union halls, theaters, factories, offices, stores, taverns, restaurants, etc. that can accommodate 100 people or more.

The law on decorations applies not only for Christmas trees, wreaths and bough decorations, but to all types of decorations put up throughout the year.

Materials can be made usable for decorations by spraying or dipping with a fire retardant. This chemical is available through chemical supply firms.

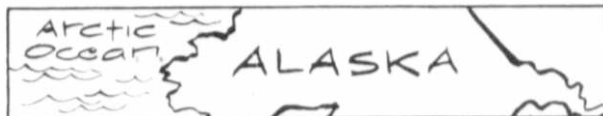

### Wrap Holiday Parcels Right, Postal Service Advises

Milwaukee Postmaster James D. Oster has half a dozen "dos" and "don'ts" for customers who want to be sure their holiday parcels get delivered.

**\*Don't box yourself in — use the right container.** Boxes must be adequate in size for the items being mailed and provide enough space for cushioning material. They must also be strong enough to hold the weight of their contents. If the box has adequate space for an address (cross out confusing information), it is not necessary to wrap it in paper. If you use paper, however, be sure it is equivalent to the kind used in grocery bags (60-pound weight). Fiberboard tubes and similar long packages are acceptable if their length does

not exceed 10 times their girth. Maximum size is 108 inches in combined length and girth and 70 pounds.

**\*Give yourself some cushion.** Cushioning absorbs and distributes shock and vibration. Examples of good cushioning materials are foamed plastics, corrugated cardboard and loose fill material such as polystyrene, popcorn and shredded newspaper. Loose fill material should completely cover the items being mailed.

**\*Close parcels up right.** Use tape, not string or rope, to close packages. Cellophane and masking tape should not be used. Pressure sensitive, filament-reinforced tape is recommended and should be wrapped around the parcel at least twice.

**\*Addresses are important.** You can spend a fortune on wrapping, but your package will never reach its destination if it is not addressed right. Print or

type the address clearly on one side of the parcel only. It is also a good idea to put the name and address inside the package in case the address label comes off.

**\*Don't mail your pet elephant** Packages must not exceed 70 pounds. They must also be at least 3 1/2 inches wide and 5 inches long, and total length and girth cannot exceed 108 inches.

**\*Don't overinsure.** If your parcel is valuable, you might want to insure it, but insure it only for its actual value. The Postal Service pays claims based on the actual value of lost or stolen or damaged items and not a higher insured amount.

"If you follow these six suggestions, it'll help us get your package where it's going on time, in good shape," Postmaster Oster said.

### New Marital Property Law Seminar at UWWC

On January 1, 1986, Wisconsin will have a completely new and different property law system that applies to married couples. It is based on the Uniform Marital Property Act drafted by a national group of judges and lawyers, and it is like the community property systems of Arizona, California, Idaho, Louisiana, Nevada, New Mexico, Texas, and Washington.

The implications and complications of this new law will be discussed and explained in an evening seminar December 17 at UWWC.

Kurtis P. Klumb, Attorney,

and Lecturer in the School of Business Administration at the University of Wisconsin - Milwaukee, will conduct the seminar from 7-9 p.m. in UWWC's lecture hall, 400 University Drive, West Bend.

Dr. Klumb will explain how this new law could radically change economic and even personal family relationships that can conceivably effect the managing of our businesses. He will also cover how this law will effect taxes, credit, divorce, real estate, estates, marital agreements, and accounting. The concept of this law and the transition from present law to the new law will also be covered.

**State Workers  
Receive Large Pay  
Hike, Stitt Reports**

The State Legislature, in the Special Session held recently, approved new two-year labor contracts that generally gave 6% per year pay raises to 28,000 state employees represented by unions. These raises will mean hundreds of dollars in retroactive pay just before the Christmas holiday.

Under the new contracts, most state workers will receive additional pension benefits, reduced health insurance costs, restored length of service bonuses and a paid holiday on Martin Luther King's birthday. State employees who are not represented by the union, about 23,000, are likely to receive the same benefits.

A study released by the Public Expenditure Survey indicated that state workers are paid 18% more than their counterparts in private industry. In addition, these raises are substantially above the current inflation rate.

Further, these contracts will exceed the \$136 million set aside for the state employees in the 1985-87 state budget, which spends 18.7% more than the last state budget. The excess cost of the contracts has been estimated between \$7 and \$12 million. This could place the Wisconsin budget into deficit which is unconstitutional.

Furthermore, in several

neighboring states, tax collections are down considerably. If Wisconsin's tax collections decline substantially, then our state will almost certainly fall into deficit and steps will have to be taken to balance the budget.

When taking private sector wages, the inflation rate and the current budget condition into consideration, it is certainly unfortunate that Governor Earl has agreed to such generous wages for state employees. Wisconsin does have a fine civil service, but state workers do

not deserve raises that exceed those of the private sector and come at the expense of a possible budget deficit.

The taxpayers' interest must come first when addressing state employees' wage increases. Therefore, I opposed the new state employee contracts.

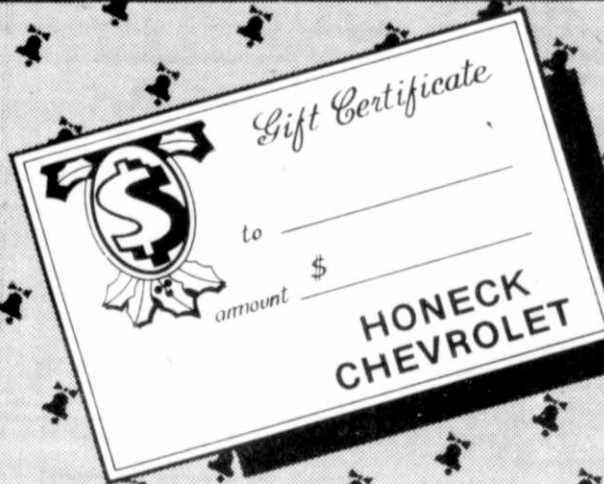

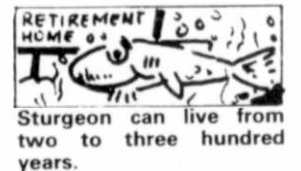

## Catholic Appeal Tops Its Goal

MILWAUKEE — Contributions to the Catholic Stewardship Appeal have exceeded its \$5,500,000 goal by more than \$20,000, Gerald M. Schaefer, director of the Office for Development, announced this week.

Noting that payments on pledges are still being received for the 1985 appeal, which officially ends December 31, Schaefer said this marks the 16th consecutive year the annual campaign has exceeded its quota.

Last year CSA exceeded its \$5,250,000 goal by some \$31,000.

Schaefer said that the 1985 appeal had some 112,500 donors, about 52 percent of potential contributors, which is considered above average when compared with major funding programs in other dioceses.

The current average individual gift of \$49 exceeded the \$46 donated in the 1984 campaign, \$31.35 in 1978 and \$19.81 in 1973.

With 10 of the 13 districts setting new records, Schaefer pointed out that District 1, Kenosha County east of I-94, including the City of Kenosha, the state's highest unemployment area, topped its goal by the greatest percentage.

Schaefer said the 1985 campaign also recorded more bequests, \$104,000 this year compared with only \$2,000 in 1984.

Schaefer described CSA, initiated as a charities campaign in 1933, as probably the most successful area fund raising effort next to United Way.

Clifford Kowalski, general chairman of CSA in 1985 and 1986, praised those who participated as contributors and volunteers.

"Parishioners of the archdiocese were very generous in meeting the obligation of the Catholic Stewardship Appeal. They recognized the need and responded properly.

"Credit also must be given to district chairpersons, their associates and parish volunteers for working at it."

## FHA Disaster Loans Available To County Farmers

Farmers Home Administration disaster loans are available for farmers in Washington, Waukesha, Ozaukee, and Milwaukee Counties who have suffered qualifying damages or losses as a result of drought which occurred during the period of April 15, 1985 through July 25, 1985.

Actual loss loans for physical damage or loss will be based on the market value of the property destroyed or damaged at the time of loss. Also the damaged or destroyed property must be essential to the continuation of the operation.

Actual loss loans for production losses will be based on the disaster year production compared to the previous 5 year production history.

Interest rates for actual loss

loans not to exceed \$100,000 will be five percent (5%). Any amount of actual loss in excess of \$100,000 but not to exceed the maximum of \$500,000 will be at eight percent (8%) for those who cannot get credit elsewhere, and 11.875 percent for those who can get other credit.

### Stitt Explains New Liquor Liability Act

In two recent cases, the Wisconsin Supreme Court ruled that a person who serves alcoholic beverages to another person could be responsible for any injuries the intoxicated person may cause to a third person. A bill which would significantly ease this responsibility recently passed the State Legislature and contains certain important implications for all Wisconsin residents.

The bill basically exempted social hosts, service organizations, charities, bartenders and other servers of alcohol from responsibility of injuries to third persons if a result of the intoxication. However, this bill provided no exemption from responsibility for a person who forces another person to drink.

The effect of this bill is best illustrated by the following situations: If a person hosts a cocktail party and his/her guest becomes intoxicated and causes an injury to a third party, without this bill the host would be partially responsible for the injury. Further, without this bill a charity or service organization that hosts a fundraiser or special event would have been responsible for any injuries to third persons caused by their participants.

Thus, under this bill, people who drink too much will be held more accountable for their own actions. Their hosts, in almost all circumstances, will not be held responsible.

Since this bill may be too broad in terms of the scope of responsibility alcohol servers are exempted from, the Governor may call a Special Session to ask the Legislature to narrow the scope of the bill.

In a democratic society, people must be held responsible for their own actions if they are legally capable. The state should not hold innocent people responsible for the acts of irresponsible, careless citizens.

### Panzer Endorses Tuition Exemption

The University of Wisconsin may replace high social welfare payments as a magnet to lure out-of-state residents into the state, according to State Representative Mary Panzer. The West Bend Republican made these remarks while endorsing Special Session Senate Bill 6, a bill providing a nonresident tuition exemption for full-time workers who relocate to Wisconsin.

Rep. Panzer stressed the potential for a high rate of return for a minimal investment.

"For roughly \$150,000 a

year," she pointed out, "we have the potential to attract people to this state who have the ability to contribute ten times that amount to our economic progress. A highly-respected university such as Wisconsin," she continued, "is attractive to management personnel interested in improving themselves and their companies. By offering them the ability to attend the University at in-state tuition rates, we provide a strong inducement for them to secure employment in Wisconsin," Panzer concluded.

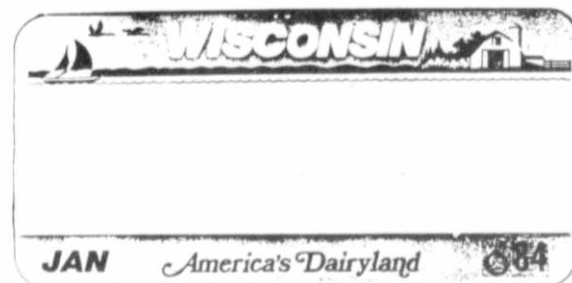
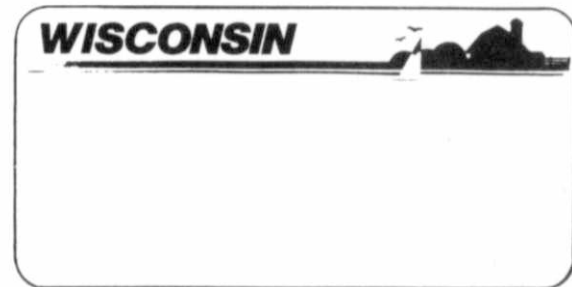

In addition to being many colored, the new checks show a full-length replica of the Statue of Liberty on the left side. A muted close-up of her head and torch is in the background near the right side.

The new check contains features that discourage alterations, forgeries, and counterfeiting, Becker said. The new lightweight paper stock is less expensive and takes less space to store. Use of the new check is expected to result in a savings to taxpayers of about \$6 million a year.

**VOTING BY ABSENTEE BALLOT**

Any qualified voter, unable to get to the polling place on election day, may ask to vote by absentee ballot. A qualified voter is one who is a U. S. citizen, will be 18 years of age or older on election day, and who has resided in the ward or municipality where voting is desired to be accomplished for at least 30 days prior to the election. If the voter resides in a municipality which requires voter registration, then registration is also a requisite for the voter who is qualified in other respects.

To obtain an absentee ballot, you must request it in writing. Contact the clerk in the city, village or town in which you reside by mail or telephone, or in person, and request an application form. After properly completing and returning the application to the municipal clerk, an absentee ballot will be sent to you along with a postage pre-paid return envelope, or given to you if the application is submitted to the clerk in person. An application mailed to the clerk's office must be received by the clerk no later than 5:00 p.m. on the Friday before election day. An application made in person in the clerk's office may be done up to 5:00 p.m. on the day before the election.

With one exception, the voter who wants to cast an absentee ballot must make a separate application before each election. Voters indefinitely confined to their home or care facility because of illness, age or disability need not file an application before each election; a special statement on the application form can be completed asking that an absentee ballot be automatically mailed to them before each election. However, if the elector fails to mark and return the ballots sent to them for an election, it will be necessary to complete an application form before receiving absentee ballots for a subsequent election.

Absentee ballots can be voted at home anytime after they arrive in the mail. They can also be voted in the clerk's office if the application is made in person. If an elector requires assistance in casting his or her vote, the assistance must be rendered by someone authorized to administer oaths, such as a clerk or notary public. If the ballots are returned by mail, the affidavit-certificate must be properly completed and signed by two persons. If returning the ballots in person, the affidavit-certificate must be properly completed and subscribed and sworn to before the clerk or the deputy clerk who are authorized to administer oaths. In either case, the marked, sealed ballot must be in the hands of the issuing municipal clerk on or before election day. Any absentee ballot received in incomplete or improper form, or received after the polls close on election day cannot be counted.

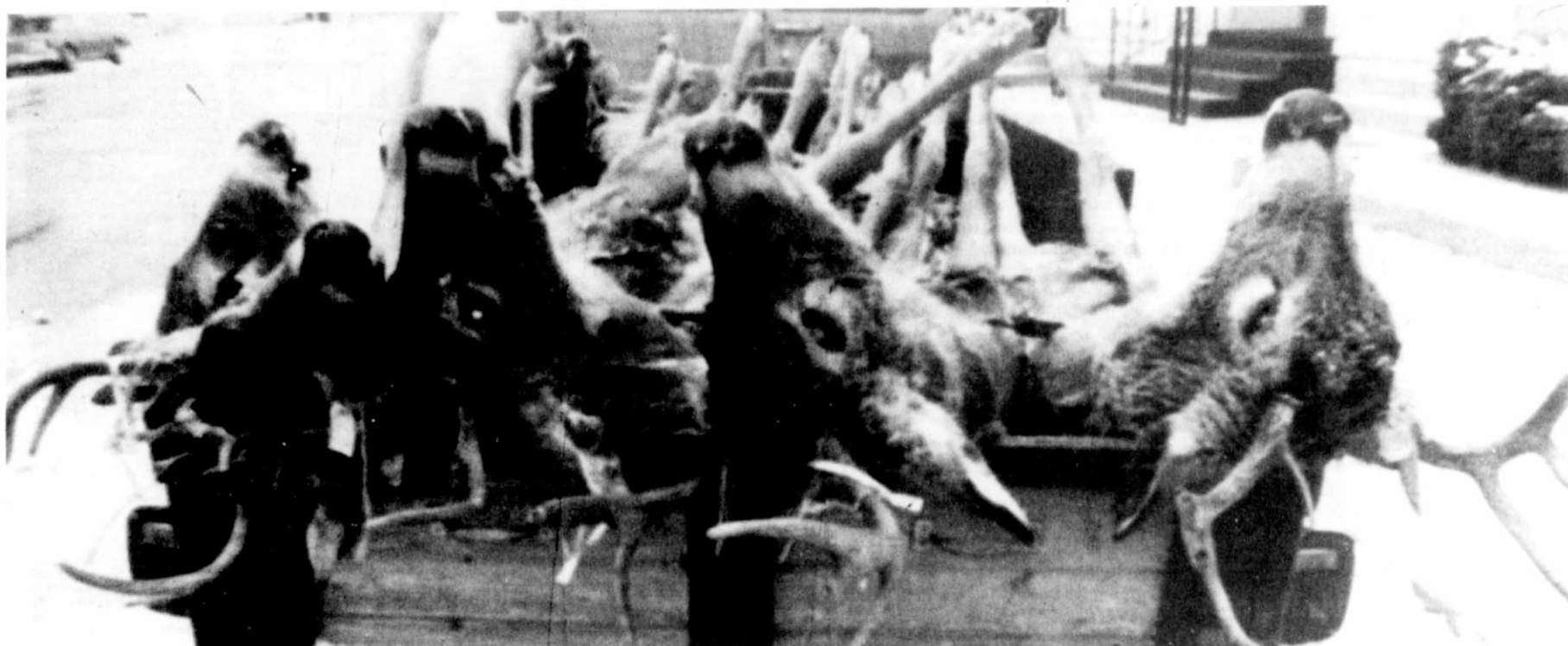

"Nevertheless, I am very happy to have this as details of the best I know of in baseball and congratulate Mr. Notheis on his fabulous achievement."

Oldtimer secretary-treasurer Bud Bellon, Horicon, says that he interprets the Guinness response to mean that "Tony's dedicated service is a first on record in his category in the Book of Records."

The Rock River Oldtimers honored Tony and his wife, Rose, at their Annual Hall of Fame Banquet on Oct. 12th.

He was inducted into the Rock league's Hall of Fame on Sept. 18, 1982, prior to his retirement by special exception as allowed in the Oldtimers' By-Laws, and he continues to serve the league as vice-president.
