Contests Shaping Up For Area Elections

With only two posts opening on the Kewaskum Board of Education, a race for the positions is already taking shape.

Incumbents Neal Weare and Lynelle Dieringer have already indicated they will seek re-election on April 1st. Also in the running is former School Board member Ralph Horner, Jr. Horner served one term and was defeated in his bid for re-election in 1985. Ruth Schmidt, a first-time candidate for the board has also submitted nomination papers. A possible fifth candidate, Clara Trapp, has taken out papers but has not returned them as of Monday morning.

Weare, who won a seat on the board as a write-in candidate in 1983, has already returned his nomination papers. Weare has served as vice-president since

his election. One of his children is a graduate of Kewaskum High School, the other resides in Waukesha.

Dieringer, also a write-in winner in the 1983 election, has not returned her papers yet. She presently serves as board treasurer. Dieringer and her husband, Jim, have six children; three have graduated from Kewaskum High School, one is presently a junior, and the other two are in grade school.

Horner has three children attending school in the district, two are in high school and one is in grade school. During his term on the board he also served on the CESA 6 Board.

Schmidt has three children, one is a Kewaskum High School graduate, one child is currently a junior and the third is in the Middle School. Schmidt works as a substitute teacher for the

Kewaskum and West Bend School Districts.

Trapp serves as a supervisor on the Town of Scott Board. She and her husband Charles own a farm near Beechwood. Trapp's children are all out of school, however, she has grandchildren attending in the Kewaskum School District.

In the Village of Kewaskum, three seats on the village board will be open. Incumbents Howard Laubenstein and Tom McElhatton have indicated they will be seeking re-election. Incumbent Donald Mlodzik, a trustee since 1978, has announced he will not seek re-election.

Laubenstein has been on the village board since 1982, and will be running for his third term. McElhatton has been on the board since 1984, and will be seeking his second term.

8 Miles of New Trail

New Fane Hiking And Skiing Trail Opens

A new cross-country ski trail has opened in the Northern Unit Kettle Moraine State Forest to accommodate the forest's fastest growing winter sport, according to Forest Superintendent Walter J. Adams.

The New Fane hiking and skiing trail near Kewaskum, under development since fall 1984, offers almost 8 miles of new trail in four separate loops graded for difficulty. The trails wind through a diversity of terrain — glacial features, brush and hardwoods.

A new 80-car parking lot was opened to serve skiers just before Thanksgiving off County Line Road, near the Kettle Moraine scenic drive, one mile southeast of New Fane. It expands skier parking facilities which until then had consisted of a 120-car lot at Zillmer trail and three lots for 160 cars at Greenbush trail.

The forest this season also has added another 1.2 mile of easy cross-country ski trail to the Zillmer trail near New Prospect. This brings Zillmer trail to a total of 11.4 miles. The forest's first cross-country trail

was developed by the WPA program at Greenbush in 1939-40 and is still in use. It consists of four loops and 11.3 miles of trail.

The three cross-country ski trails meet a need that has been rapidly expanding since the mid-1970's, Adams said.

"Cross-country skiing is the most rapidly expanding recreational activity on the forest," he noted.

"Cross-country skiing has been around many years, but the present boom began here in the mid-1970's," he said. At that time, the Greenbush trail began becoming overcrowded and, to relieve the congestion, the Zillmer trail was opened in 1981.

"Now that is pretty much loaded up on weekends," Adams observed.

The first weekend of December, 1985, brought almost 3,000 cross-country skiers to the 30 miles of trail that now traverse the forest's 27,500 acres, Adams reported. Headquartered at Campbellsport, the forest covers part of three counties — Fond du Lac, Washington and Sheboygan.

County Incineration Plan Back to Local Governments

With a less than favorable return on its first vote, Washington County has again sent the question of participating in a county-operated incineration plan back to the municipalities.

A lukewarm response to the proposal earlier this month showed 23% of the population were against the incineration proposal, 23% indicated maybe, 30% said they would support the incinerator but wanted amendments to the proposal, while only 12% returned an unconditional "yes" vote.

The County Solid Waste Management Board, however, refused to let the plan die, defeating, by a 6 to 2 vote, a recommendation that the county not build an incinerator.

The County Board was informed, instead, that two resolutions were being sent back to the municipalities, this time seeking only a simplified "yes" or "no" vote. "There will be no 'maybe'" stated John Kohl, chairman of the Solid Waste Management Board. The municipalities are to return their replies by March 1st.

If less than the 60% support level is achieved, the Solid Waste Management Board will

be disbanded, said Kohl.

Members of the county's Land Use and Parks Department have indicated they feel the county should stay out of waste disposal, allowing private firms to provide such services. One Parks Department staffperson said, private firms can undercut you in setting rates

and attracting municipal trash.

Dianne and Pat Horlamus of Renewed Resources, West Bend, are trying to get the county to back a plan that would turn garbage into compost and paper pellets which could be burned as fuel. The Horlamus' expect their service to be in

School District Again Offers Olympics of the Mind Program

The Olympics of the Mind program is again being offered in the Kewaskum School District.

The Olympics of the Mind Association Inc. is a non-profit corporation. The program began in 1978 in New Jersey. Today the program has expanded. It now includes over 3,000 schools across the United States, Canada, Mexico and several other countries.

Olympics of the Mind is a problem solving competition. It involves divergent solutions to long term problems. A good example of a long term problem might be: design a device using a mousetrap which will put out the flame of a typical birthday candle. A good example of a spontaneous problem solving might be: name as many grants

as you can.

In competition, the judge scores the answers to the long term problem and the spontaneous problem by how much creativity and originality the answers show.

Olympics of the Mind is a program for students kindergarten through twelfth grade. There are three different levels of competition: Kindergarten through fifth grade, sixth grade through eighth grade, and ninth grade through twelfth grade.

All students qualify for the Olympics of the Mind program. It is not based on a student's I.Q. but rather on his/her ability to come up with creative answers.

Last year was the first year of the program at the Kewaskum

In the Washington County Board election, all 30 supervisory positions are up for grabs, with 12 of the 30 seats facing contests.

Early indications are that at least four districts will be having preliminary elections on February 18th. Some sources speculate the 18% increase in the 1986 tax rate may be causing the activity, along with the defeats of the proposed countywide library system.

Currently, 18 of the 30 supervisors are 60 years old or over, and only one woman presently serves on the county board.

Electors in Washington County will also vote on a referendum asking them if they want countywide library service beginning in 1987.

Candidates have until 5:00 p.m. Monday, January 7th, to return their nomination papers.

operation by January 1st, and consider it an alternative to incineration.

The machine used in the process separates plastic and metal from paper and organic materials. The organic matter is shredded and packaged as compost, while the paper products would be pressed into fuel pellets for residential and industrial use.

Dianne Horlamus said, removing foreign matter by processing the garbage would result in a "cleaner" burn than incineration. For every 5 tons of garbage processed, approximately 3 1/2 tons could be converted for useful purposes. The remaining 1 1/2 tons would go to a landfill.

The board did not take any action on the presentation.

KHS Guidance Dept. Offers Wide Range of Programs

The Guidance Department under the direction of Sharon Blank and David Wietor, offers a wide range of programs that benefit the students at Kewaskum High School.

Among the services offered are scheduling/course offerings, career education, scholarships, preparation for college, personal counseling, college visitations, financial aid information and freshman orientation.

The guidance department helps students prepare their class schedules for the following year. The counselors make sure that the students are in the classes both they and their parents want the student in.

In the guidance office there is a career computer. Students may use this computer to find out about careers. The guidance department also sets up speakers from various careers.

All scholarships are done through the guidance department. The counselors inform the students of all the scholarships available to them.

ACT, SAT and PSAT applications can be received from guidance. These tests are used for college entrance. Guidance also fills out college applications for college entrance and sets up visitations to colleges.

The most major part of counseling is the personal counseling. The counselors deal with problems with friends, parents, teachers, school, chemical use and abuse, and vocational choices.

The guidance department sets aside a night for incoming freshmen and their parents to orientate them. At this program students and their parents are introduced to Kewaskum High School.

Every year the guidance department sets up a financial aid night, for the parents of college-bound seniors. This meeting introduces parents to all of the means of obtaining financial aid.

The guidance department is open to all students. The students may go to guidance

during their study halls. "We generally like to have students come to use during their study halls. However, if the problem is urgent we will see them anytime," remarked Blank. All students see their guidance counselor at least once a year for scheduling purposes. Students are encouraged to stop in more than that one time set aside for scheduling.

Guidance also takes care of the personal files of students, school grading, and the counselors serve on curriculum committees. The counselors are able to make objective opinions on issues concerning the high school curriculum.

Wietor commented, "Guidance is here as an aid in counseling the students. They are encouraged to use it to the fullest."

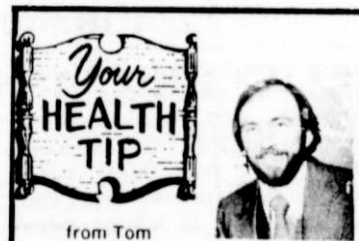

VILLAGE OF KEWASKUM NEWS NOTES

Garbage and Refuse Disposal

The Village Board would like to remind the residents of the Village that the ordinance in reference to "Garbage and Refuse Disposal," Chapter 14 of the Municipal Code, explains the manner in which garbage and refuse is to be disposed. This is to reiterate the fact that this ordinance will be enforced and all residents and commercial establishments will be asked to comply with these rules and regulations.

These are some points that should be emphasized:

I. Commercial establishments are allowed only two garbage cans or one mobile container if the Village is to pick up their garbage and refuse. Resident units are to provide garbage cans or plastic bags for the disposal of their garbage and refuse.

A. A mobile container shall be capable of fitting the Village's garbage truck, hydraulic attachment for unloading. Such container shall be flyproof, ratproof and leakproof and shall be fitted with 14 gauge metal constructed covers. The minimum size for a mobile container shall be 1.5 cubic yards and the maximum shall be 2 cubic yards.

B. A garbage can may be a plastic or galvanized metal container of the type commonly sold as a garbage can, of a capacity not less than 20 gallons and not to exceed 30 gallons, having two handles upon the sides thereof or bail by which it may be lifted and a tight fitting metal or plastic top with a handle, and so constructed as to permit the free discharge of its contents. No garbage can shall weigh more than 60 pounds when filled.

C. A plastic or polyethylene disposal bag is a container other than a garbage can, which is used for garbage disposal. Such bag shall meet the same criteria as a garbage can and shall withstand a drop of 5' onto smooth concrete when filled to a total weight of 30 lbs. with a material having a weight density of 15 lbs. per cu. ft. The bags shall be securely closed with a twist tie.

II. If appropriate containers are not used or if a container has been condemned as unfit for a garbage receptacle the Department of Public Works may tag the containers and until a proper container is provided may discontinue collection service. The owner or user thereof may be subject to the provisions of section 14.15.

NOTE: Barrels Prohibited - (steel, plastic and card board barrels are not allowed).

Within the next few months the Department of Public Works will be monitoring and tagging condemned and non-permissible containers. The Village does ask for your cooperation.

As required by the federal Education Consolidation and Improvement Act (ECIA) of 1981, the 22-member committee advises the Wisconsin Department of Public Instruction (DPI) on the use of federal block grant funds.

The federal law consolidated 30 categorical programs into one block grant. Instead of allocating money for each of the programs, Congress allocated a lump sum to each state. Wisconsin received nearly \$10 million for this school year.

School districts apply to the DPI for the funds which may be used for programs to improve basic literacy skills in reading, mathematics, and communication skills; support services such as counseling and guidance; and special needs to support innovative and experimental projects. Allocations to the school districts are based on the 1984-85 school enrollment of private and public school children, the number of families who receive Aid to Families with Dependent Children (AFDC) funds, and a sparsity factor.

Commenting on York's appointment, State Superintendent of Public Instruction Herbert J. Grover said, "Representative York will be an excellent addition to the committee considering his legislative expertise and his experience as a former administrator of the Lomira School District."

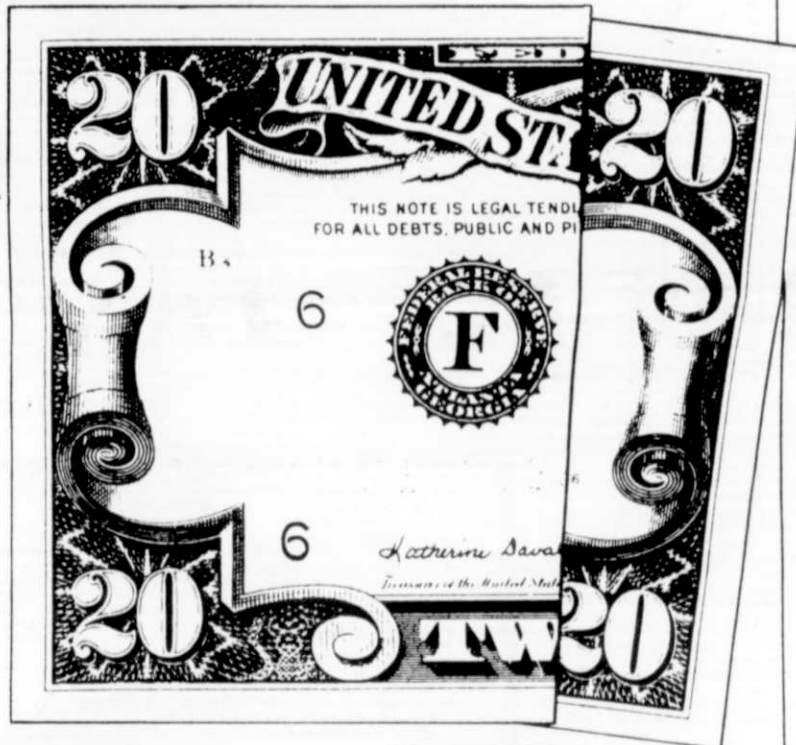

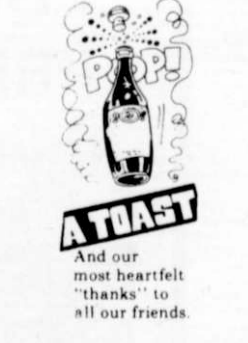

change for most of us, it is good to know that state law affirms what most Wisconsin citizens have always believed marriage is - a legal partnership between two equal persons, a husband and wife, who owe to each other mutual responsibilities and support. This recognition of marriage as an economic partnership based on sharing is the most significant pro-family and pro-marriage piece of legislation enacted by our Legislature.

The act gives equal value to the contributions made by each spouse to the family, whether the contribution is money or services or both. It is a move to equality and fairness in marriage.

Since there is so much misinformation being reported on the marital property reform, I want to alert your readers to the recently revised "Marital Property Fact Sheets" written and distributed by the Wisconsin Women's Council and the Wisconsin Women's Network. They can be obtained by writing the Wisconsin Women's Council, 30 W. Mifflin St., Suite 512, Madison, Wisconsin 53702.

Agreement Reached by MPTI Board, Teachers

The Moraine Park VTAE District Board approved a two-year Bargaining Agreement with the Moraine Park Federation of Teachers, Local 3338, at their meeting on Tuesday, December 17, 1985.

The agreement is for the 1985-86 and 1986-87 school years, and provides for a 6.46% salary increase of total compensation for the first year, and a 5.39% salary increase of total compensation for the second year.

The total increase in salary and fringe benefits for the first year is 7.72%, with teachers paying the additional one percent increase in state-mandated teachers' retirement, and a 7.03% total increase in salary and fringe benefits for the second year, with the district paying the one percent teachers' retirement.

For the third straight year the Village Board has lowered the tax rate by 1¢ per \$1,000 of assessed value. The tax rate for the year ending December 31, 1985, is \$6.63 per \$1,000 of assessed value.

The total gross tax rate however, increased from \$22.29 last year to \$26.64 this year. The increase of \$4.35 or 19.5% comes from taxes levied by the Kewaskum School District, Washington County, Moraine Park Technical Institute and State. The Board of Education added \$3.67 to the rate this year. The County Board increased its rate by 57¢, MPTI added another 11¢ and the State 1¢. The Village Board has no authority to approve or disapprove these rate increases.

As you can see from the chart below, the Village Board has not raised your property tax in the last three years. All rate increases have come from other taxing jurisdictions. The percent of increase for each jurisdiction is shown in the right-hand column below.

The 1986 Village Budget will allow us to promote essential services and continue to provide the quality of life the citizens desire and deserve. Thank you for your cooperation and continued support.

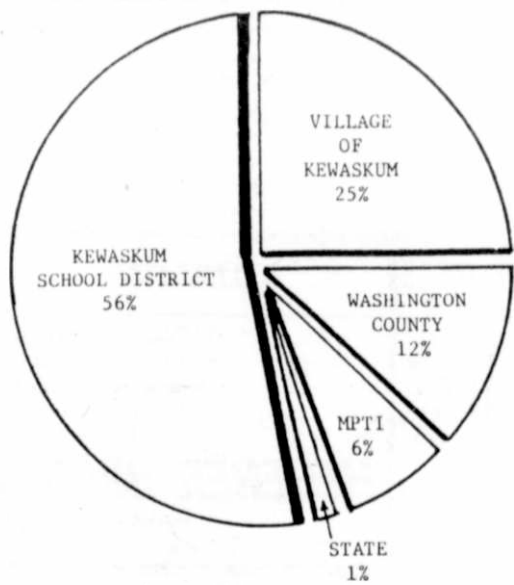

Lebanon-Grenada Vets of County Can Get State Veterans Benefits

Washington County veterans who participated in the recent U.S. military actions in Lebanon and Grenada while serving on active duty with the U.S. Armed Forces are reminded that they are eligible to apply for Wisconsin "wartime" veterans benefits programs administered by the Department of Veterans Affairs. Joe Fischer, County Veterans Service Officer noted that the Wisconsin Legislature authorized extension of benefits to Lebanon and Grenada veterans in May of 1984. Wisconsin was the first state to do so.

To be eligible for benefits, Washington County veterans must have served in Grenada between October 23, 1983 and November 21, 1983, or in Lebanon between August 1, 1982, and August 1, 1984. Proof of such service is normally indicated by the award of either the Armed Forces Expeditionary Medal or the Navy or Marine Corps Expeditionary Medal, and these awards are usually shown on the veteran's Report of Separation (DD Form 214) which should be brought to the County Veterans Service Office, Fischer said.

Of special interest to Lebanon-Grenada veterans are the department's educational grants. The Part-Time Study Grant Program used to be available only to Vietnam Era veterans; now it has been extended to Lebanon and Grenada veterans. All state veterans are eligible to apply for the Part-Time Study Grant Program, Fischer said. Under the Full-Time Study Grant Program, grants per academic year of up to \$200 for single veterans, and \$400 for married veterans, are available. The veteran must be a full-time undergraduate student. Part-Time Study Grants provide the veteran with reimbursement for the costs of tuition, fees and textbooks for parttime classroom study or correspondence

courses from most public and private schools in Wisconsin, including all high schools, the VTAE system, the UW system and most private colleges. Reimbursement is made upon satisfactory completion of the courses.

For a time it was feared that Lebanon and Grenada veterans would be unable to take advantage of the department's popular First Mortgage Home Loan Program because of Congressional passage of Federal Tax Reform Act of 1984 which said that veterans of Lebanon and Grenada who apply for the home loans which are funded by future general obligation bond issue will have to have had active military service before January 1, 1977, to be eligible. This would exclude most of the veterans in this group from the First Mortgage Home Loan Program.

However, on May 8, 1985, the Board of Veterans Affairs voted to provide \$2.133 million for home loans to these "disenfranchised" veterans at an interest rate of 10.6%. The \$2.133 million was derived from interest earnings on the current bond issue. As of December 4, 1985, \$1,612,220 was still available for direct home loans by the department to Lebanon and Grenada "disenfranchised" veterans and to otherwise eligible veterans whose last day of active military service was 30 years prior to the date of the loan application, Fischer said.

All Washington County veterans of Lebanon and Grenada are urged to visit or call the County Veterans Service Office, located in the Courthouse, 432 W. Washington St., West Bend, for more details on state and federal veterans benefits.

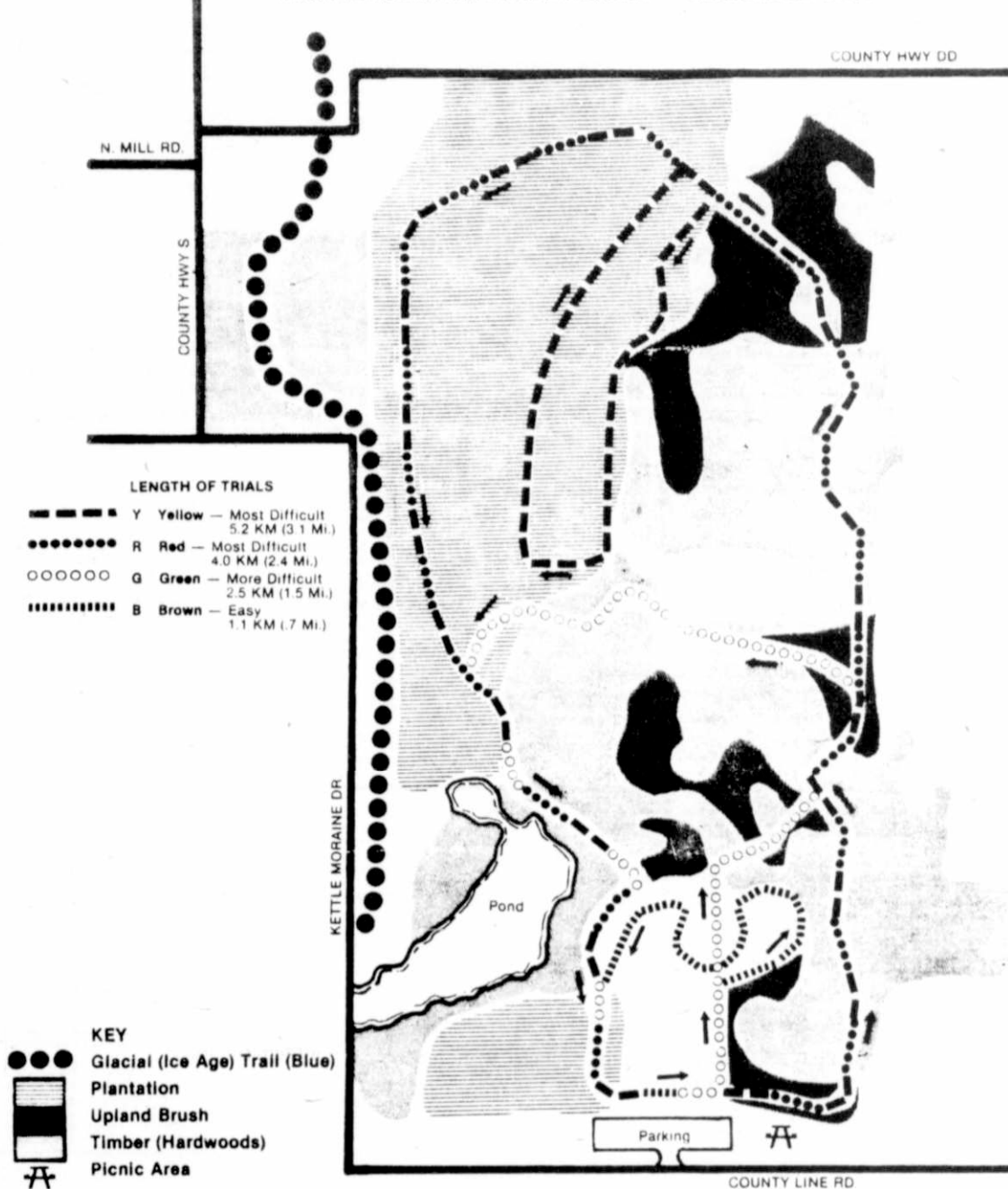

Besides the cross-country ski trails, the Northern Unit forest has more than 40 miles of additional hiking trails, 3.5 miles of nature trails, 6.5 miles of bridle trails, a 33-mile combined bridle and snowmobile trail, and 25 miles of snowmobile access trails, state trails that connect towns and villages with the 33-mile bridle-

snowmobile trail.

New Fane trail's 7.7 miles consist of several loops marked with colored signs to designate their difficulty. Minutes of Village Board Meeting

Mid-Monthly Meeting
December 16, 1985
8:00 P.M.

The Village Board of Kewaskum, Washington County, Wisconsin met in mid-monthly session in the Council Room of the Municipal Building, 204 First Street.

President David E. Nigh presided. All Trustee Members were present.

On a motion by Trustee Howard Laubenstein, seconded by Trustee Paul Blumer and unanimously carried by voice vote, the Board approved the minutes of December 2, 1985.

The Public Hearing was held on the request of a Conditional Use Permit on the application of Dr. and Mrs. Sison for the parcel of property located at 1040 Fond du Lac Avenue, Kewaskum, Wisconsin which is zoned B-2 General Retail and Service District. The Conditional Use Permit would allow for the construction and placement of a 44 unit Multi-Family building for the elderly.

Mr. and Mrs. James Roe, Mr. and Mrs. Dennis Giese and Mr. and Mrs. Elton Ludwig were present and asked several questions regarding the proposed project. Dr. Sison, Mr. Lew Herro and Mr. Harold Woodhouse responded to the questions. Village Attorney Gerald Kiefer reviewed several requirements the Village should consider prior to final approval. Zoning Administrator Richard Zarling and Administrator Daniel Schmidt provided some additional information.

Motion was made by Trustee Howard Laubenstein, seconded by Trustee Donald Mlodzik to close the public hearing. Roll call vote was passed unanimously. Roll call vote was 7 "Aye," 0 "Nay," 0 "Absent."

Motion was made by Trustee Mary Krueger, seconded by Trustee Paul Blumer to suspend the rules to take action on agenda item IX. (A) (the Conditional Use Permit for Dr. and Mrs. Sison). Roll call vote was passed unanimously. Roll call vote was 7 "Aye," 0 "Nay," 0 "Absent."

The Board reviewed the request and recommendations of the Plan Commission. On a motion by Trustee Howard Laubenstein, seconded by Trustee Paul Blumer the Board approved a Conditional Use Permit as recommended by the Plan Commission on November 20, 1985, for the application of Dr. and Mrs. Sison, for the parcel of property located at 1040 Fond du Lac Avenue, which is zoned B-2 General Retail and Service District. The Conditional Use Permit would allow for the construction and placement of a 44 unit Multi-Family building for the elderly. Contingent upon approval and signing of the developers agreement, easements and subsequent agreements regarding the sewer and water. The Administrator was authorized to issue the Conditional Use Permit with the following restrictions:

I. The signing of the aforementioned items by the property owner (developer), the Village Attorney, Zoning Administrator and Administrator.

II. The inclusion of the definition for elderly defined as being 55 years of age, with the requirement of at least

one (1) individual residing in an apartment being 55 years of age.

III. The points of clarification for the agreements encompass the following:

- a. Road width being 24'.
- b. The roadway being marked with stripping.
- c. The roadway being brought up to Village standards by adding two additional inches of asphalt.
- d. The placement of a 48" wide sidewalk on the north side of the clinic property.
- e. The inclusion of the many other points as provided by the Village Attorney.

Roll call vote was passed by the majority. Roll call vote was 6 "Aye," 0 "Nay," 0 "Absent," 1 "Abstention." (Trustee Mary Krueger abstaining).

On a motion by Trustee Thomas McElhatton, seconded by Trustee Richard Schlice and unanimously carried by voice vote, the Board approved the certified survey map of the SE 1/4 of the SE 1/4 of Section 9 T12N R19E submitted by Ted Meilahn for Dr. and Mrs. Sison.

On a motion by Trustee Richard Schlice, seconded by Trustee Donald Mlodzik, and unanimously carried by voice vote, the board approved the splitting of payment in reference to the open space fee as follows: \$400.00 immediately for the division of land with the balance in reference to the 44 unit Elderly Housing Project, that being 8,600, divided by 2 equalling \$4,300 due with the building permit and the other \$4,300 due on the first tax bill as a special assessment.

A public hearing was conducted on the application of Jeanne A. Marchant for a Combination Class "B" tavern license. There were no objections from the floor to the application as publicly noticed and publicly read by President David E. Nigh. The Police Department had no reason to protest at this time. On a motion by Trustee Mary Krueger, seconded by Trustee Paul Blumer the Board declared the public hearing closed. Roll call vote was passed unanimously. Roll call vote was 7 "Aye," 0 "Nay," 0 "Absent."

The public hearing was held on the proposed Water Pollution Control Department Budget, Water Department Budget, TIF/CIP Budget and Special Revenue Fund Budget. Administrator Schmidt reviewed the four proposed budgets with little discussion on the material presented. VILLAGE OF KEWASKUM NEWS NOTES

Village Board Meetings

The Village Board and Village Board meetings are covered under Chapter 2 of the Kewaskum Municipal Code. The Village Board shall consist of the Village President and six (6) trustees who shall be elected for 2 year terms. The Board shall govern and run the business of the Village.

Regular meetings of the Village Board shall be held on the first and third Monday evenings of each calendar month, at 8:00 P.M. Any regular meeting falling upon a legal holiday shall be held on the following Monday, at the same time and place, unless the rules are suspended and other provisions are made by the Board. All meetings of the Board shall be held in the Municipal Building, 204 First Street, including special and adjourned meetings.

Notice and agendas for each meeting will be sent to the Board Members, News Media who requested such information and be posted at the Valley Bank, Post Office and the Municipal Building. Anyone requesting to appear on the agenda must do so prior to the Wednesday preceding the next regular meeting.

The Village President shall be the presiding officer of the Board and in case of absence, the trustees shall elect one of their members President pro-tem. A quorum, meaning a majority of the members shall be present, counting the Village President, prior to proceeding with a meeting.

The members of the Village Board shall be appointed to standing committees by the Village President, subject to approval of a majority of the members of the Village Board, at the first regular meeting in May of each year. These standing committees are the administrative, protection & public safety, public services, public works and park & recreation. Each committee shall consist of 3 members. The chairman of the committees shall be designated by the Village President. Each member shall serve as appointed unless excused by a majority of the members of the Board.

The members of the Village Board also serve on other community boards and commissions, along with citizens at large. These boards and commissions are appointed by the Village President, subject to approval of a majority of the members of the Village Board, at the second meeting in April, or the first meeting in May of each year.

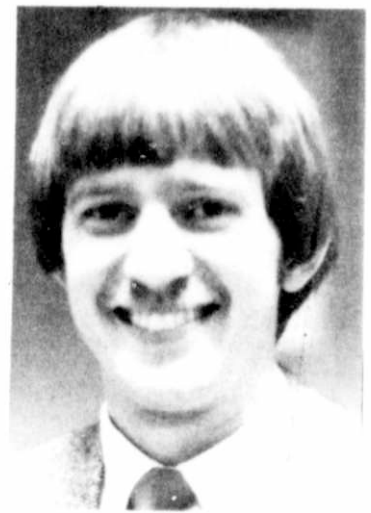

In spite of a Two Rivers offense that looked very ragged and haphazard, the Raiders did one thing very well throughout the whole game. That was "get the big man open and hit him consistently." That big man for the Raiders was 6 foot, 4 inch center Mark Meneau who finished up the night with a total of 26 points and 22 rebounds for the Raiders with Pat Johnson adding another 21. Starting at guard for the Indians were Ramthun and Menzel, at forward Bob Jahr and Steger with Ron Theusch at center once again.

Right from the start in the first period Two Rivers came out in a full court press and the Indians did well against it, getting an open man down court quickly and scoring several times on fast break situations.
