## Kewaskum School Tax Levy Statistics Disheartening

Business Manager Cherna Gorder's breakdown of the Kewaskum School District's tax levy figures, presented during Monday's School Board meeting, did little to soften the blow received by property owners when they received their tax bills last month. The only consolation some townships may receive comes from the fact that there are other municipalities whose increases are larger than theirs.

According to Gorder's report, the Village of Kewaskum, the only municipality to have an increase in its equalized valuation in 1985, saw the biggest jump in its share of the levy. Its increase was 17.97%, a hike in the net levy of \$116,930, from \$650,850 in 1984, to \$767,780 for 1985. The village's equalized valuation rose 2.22%.

The Town of Ashford had an

increase of 14.88% in its net levy, from \$2,271 in 1984, to \$2,609 in 1985, a difference of \$338. The Town of Wayne rose 14.74% or \$81,233, from \$550,977 to \$632,210. The Town of Auburn increase was 14.51% or \$32,040, from \$220,767 to \$252,807 for 1985. The Town of Scott net tax levy went up 13.54% or \$40,507, from \$299,061 to \$339,568 for 1985. The Town of Farmington is up 13.31%, an increase of \$115,091, from \$864,931 in 1984 to \$980,022 for 1985. The Town of Mitchell, up 12.52%, from \$4,688 to \$5,275, a difference of \$587. The Town of Barton increase is 10.13%, up \$19,546, from \$192,959 to \$212,505.

The Town of Kewaskum saw the smallest increase, 7.15%, in its net tax levy, from \$433,783 to \$464,785, up \$31,002. The Town of Kewaskum, however, also saw the biggest drop in its equalized valuation at 7.15%.

The next tax levy is the figure arrived at after the state tax credit has been applied.

Gorder also told the board that projections indicate the district's enrollment will decline by another 63 students, which would result in a loss of \$112,000 in equalization aids. She noted, however, that right now it was hard to say if there would be a \$100,000 shortage. Gorder said it depended upon several factors including which figures the state would use to determine the district's share of those aids.

Board member Neal Weare questioned whether the state's projected deficit would have any affect on schools. District Administrator Penny Kleinhans indicated that while nothing has been said so far, "There are whispers about a 2% reduction in state aids, with the potential that those cuts could become effective as soon as July."

## Four Others Injured Crash Takes Lives Of Two Area People

A three-car accident on Highway 57 south of Random Lake, in Ozaukee County, Thursday afternoon, January 9th, killed two people and injured four others according to a report from the Wisconsin State Patrol office at Fond du Lac.

Killed were Evangeline A. Heise, 64, of 137 Lake Drive, Random Lake, formerly of Beechwood, and Lawrence C. Watry, 34, of 5878 Sands Drive, West Bend.

According to the patrol's report, Watry's southbound car hit a patch of ice on Highway 57, just south of Jay Road in the Town of Fredonia, at approximately 3:47 p.m. The car spun out of control, crossing the centerline into the northbound lane and collided broadside with a car driven by Norbert Heise, 66, Random Lake. Heise's car

was then struck by a second northbound car driven by Eileen A. Rueden, 23, of DePere. Heise was a passenger in her husband's car.

Norbert Heise was hospitalized at St. Mary's Hospital-Ozaukee in Port Washington with internal injuries and listed in satisfactory condition. Audrey V. Rueden, 64, Eileen Rueden's mother, and a passenger in her car was hospitalized with facial cuts, bruises and an arm injury. Eileen Rueden and her 11-month-old daughter, Jolene, also a passenger in her car were treated for bruises and released.

A State Patrol spokesperson said Rueden was cited for traveling too closely for road conditions.

The Heises operated the Beechwood Cheese Factory until 1979.

## High School Program Under Review

At its meeting Monday night, the Kewaskum School Board got its first look at the Administration's efforts to reconstruct the high school's class program. The plan for the 1986-87 school year is to provide curriculums which will best meet the needs of students while eliminating class duplication and courses with extremely low enrollments.

In her report, Director of Instruction Julie Backus indicated the district will try to offer the broadest type of program which meets the students' needs while utilizing staff time in the most cost effective way. In the report, Backus addressed the areas of Consumer Education, Mathematics, Business Education, Agriculture and Physical Education. She discussed each area, explaining the rationale behind the changes, from declining participation to providing more time for students to take elective courses.

Backus also presented the concept of "every-other day courses" which would be offered as alternatives to the every-other day physical education schedule. Instead of a study hall, students could take a variety of courses during that

period, from business to shop subjects.

Because of previously small enrollments, some classes will be offered only once a year. This will call for careful schedule planning, noted Backus, but it's hoped this will help to increase class size, at the same time reducing staff time requirements.

Health would be available to both freshmen and sophomores to provide more flexibility in elective course registrations for freshmen.

Based on the changes presented Monday night, predicted high school staff changes would include, reduction of one math position, reduction of 20% in agriculture, reduction of 20% in art, and the potential for the reduction of one special education staff member on decreased enrollments in emotionally disturbed students.

Backus stressed all areas of the program, including science, art, social studies, and english will be reviewed and she will present more changes at a special school board meeting scheduled for February 3rd.

Board member Perry Ankerson told the meeting, "I have a real concern with reductions in students and not being in a position to reduce staff. There is going to be some intense scrutiny. This is going

to be a year that I'm going to take an extremely hard line," stated Ankerson. "I have children in school," noted Ankerson, "but something has to be done to reduce these huge tax increases."

District Administrator Penny Kleinhans told the board that the administration would be presenting various options. "You are going to have to make some difficult decisions," said Kleinhans. "I have no problem with making difficult decisions," said Ankerson, "I just don't want to be forced into any eleventh-hour decisions."

If any staffing reductions are to be made, the board will have to make those decisions by February 28th, when the district begins issuing teacher contracts.

In other action, the board discussed policies covering support staff, public participation procedures for meetings, and the protective behaviors program.

The board approved the purchase of a new dishwasher for the high school at a cost of \$5,124, and the repair of the high school bell system.

The board tabled action on purchase of a school van, instructing Buildings Superintendent Fred Boehlke to look into the purchase of a larger

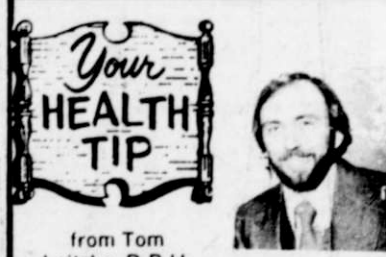

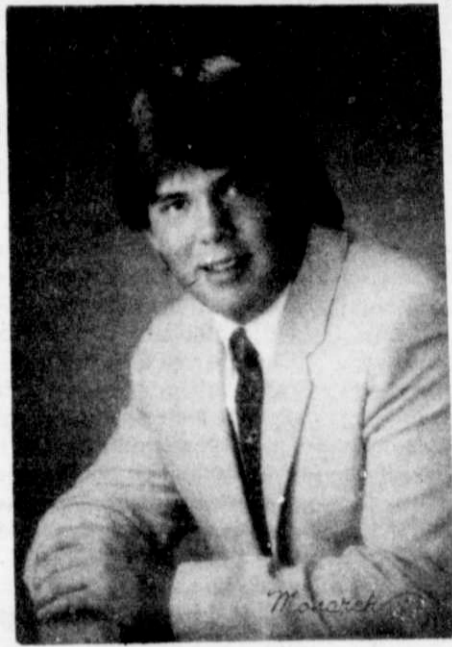

Main St.; Germantown, Senior Activity Center, W162 N11960 Park Ave.; Slinger, Village Hall, 220 Slinger Road; Allenton, Addison Town Hall, Village of Allenton; Kewaskum, Kewaskum High School, north entrance; and Jackson, Jackson Fire Department, S. Jackson Dr.

Eligibility is based on the current monthly gross income (before taxes) of all household members with the following limits; Household size 1, income limit \$656; 2, \$881; 3,

\$1,106; 4, \$1,331; 5, \$1,556; 6, \$1,781; 7, \$2,006; 8, \$2,231; 9, \$2,456; 10, \$2,681.

Eligible households will receive butter and processed cheese. In addition they may choose rice and one of the following: honey, corn meal, flour, or dry milk. Home delivery is available for Elderly and Handicapped if there is no one in the household who can get to a distribution site. To make arrangements, call the distribution site in your area. West Bend residents please call 338-4671.

Although no income verification information is required, a self declaration form must be signed by the recipient and is subject to state audit. You may also be asked to provide proof of residence.

This program is being coordinated by the Washington County Department of Social Services, and handled locally by various volunteer groups in each community.

## To the Editor:

We all make decisions every day — sometimes right and sometimes wrong. Nevertheless, we do make them every day. Everytime we make a decision, there is some definite consequence — either to us alone or to those around us. I've made a decision to run for the Kewaskum School Board. Why? I feel that NEVER has the School Board made so many BAD decisions with the potential for serious and detrimental effects on so many people in this community as those made by the Board since the annual meeting in July.

One of these decisions has been to continue to spend money on fixing the administrative office. At a time when we hear that our district enrollment is shrinking, they continue to talk about spending additional money on this building, laughingly called the "chicken coop" by some in the community. When the Board decided to move the administration back to this building, they spent in excess of \$8000 dollars to refurbish this building. Now the Board is talking about taking another \$3000 dollars from the money borrowed from the State Trust Fund to provide

equipment and physical repairs for the benefit of our children for the administration building. As an aside, I wonder where the money came from to pay for the new beautiful pink and brown venetian blinds that suddenly appeared in this building.

Yet another decision I have real problems with is the hiring of another administrator in the form of a Director of Instruction at the November 25th meeting at a salary of \$32000 dollars. Is this the best way to spend \$32000? Or could this money have been spent instead to better use for items that directly affect our children — like textbooks? or in providing our students with a chance to participate in the Academic Decathlon? or in the Olympics of the Mind program with experienced coaches? or in providing them with a classroom where the roof does not leak?

At the October 14th meeting, the consensus of the Board was that this position would be postponed and readvertised during the second semester. Why was it then filled at the November 25th meeting? Couldn't curriculum development and improvement be provided by CESA 6 at a fraction of the cost? Couldn't one of our present staff trained in this area have been approached to do some of this work? Even more interesting, is the fact that the Board is just now writing the job description. Is this going to be their new policy — to hire people and then write a job description?

There are many other decisions that affect the students and taxpayers that I will be questioning in the upcoming weeks.

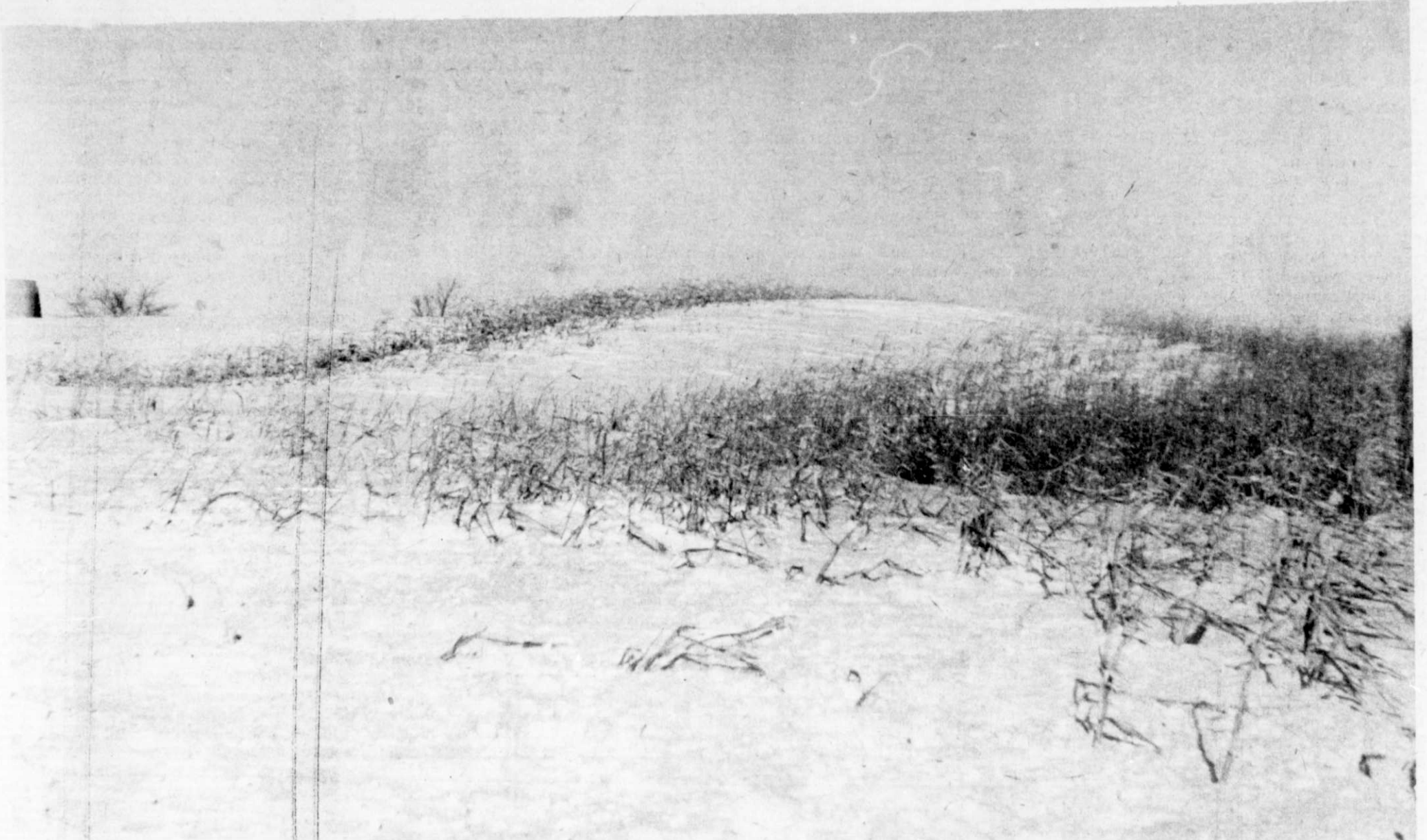

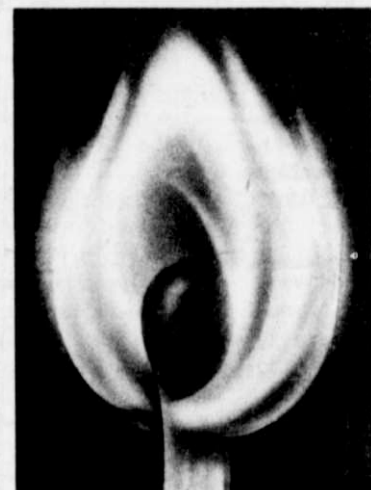

**RESOLUTION NO. 86-1  
ACCEPTANCE OF  
WASHINGTON COUNTY  
WASTE TO ENERGY ACTION  
PLAN-COMMITMENT TO USE**

WHEREAS, The Washington County Board of Supervisors by Resolution of June 11, 1985, has requested an expression of community commitment to the Waste to Energy Plan Phase 3; and

WHEREAS, this plan would result in the construction of an incinerator with energy recovery near the courthouse, which would provide steam to heat the courthouse complex buildings; and

WHEREAS, this plan would require a subsidy from the county tax levy to cover both the principal and interest costs of the project; and

WHEREAS, the proposed tipping fee is estimated to be \$21.00 per ton which may provide limited revenue to help offset capital costs; and

WHEREAS, it is recognized that there is a significant risk that air pollution requirements may result in intermittent and even permanent shutdown of the incinerator system, and further that the ash produced by the incineration system may be classified as hazardous waste; and

WHEREAS, it is recognized that construction of an incineration system as proposed will result in other unavoidable risks that cannot be fully insured against and could result in major financial loss to Washington County; and

WHEREAS, in spite of these risks and higher costs, incineration remains the best, safest alternative for waste disposal currently available; and

WHEREAS, the Village of Kewaskum is presently willing and able to commit itself to use

of the incinerator for solid waste disposal when the facility is available.

NOW, THEREFORE, BE IT RESOLVED by the Village of Kewaskum Board that the recommendations of the Waste to Energy Action Plan Phase 3, which will provide for the construction of an incinerator in the City of West Bend, be and are hereby approved;

BE IT FURTHER RESOLVED that the Village of Kewaskum hereby commits itself to use the incinerator upon its completion, but in no event prior to January 1, 1990, as its exclusive source of solid waste disposal to the extent the facility is available and with the understanding that a competitive tipping fee will be maintained;

BE IT FURTHER RESOLVED that the concept of establishing a tipping fee based upon operation and maintenance costs only, with all debt service to be funded from the county tax levy be and is hereby approved in principal with the understanding that the balance between the actual operation and maintenance costs and the competitive tipping fee, if any, be used to reduce dependence of principal and interest on the county tax levy;

BE IT FURTHER RESOLVED that the Village of Kewaskum agrees to enter into a contract with Washington County or its designee to provide for use of the incinerator for solid waste disposal subject to formal acceptance by the Village Board.

The Campbellsport ARROW MASTERS archery club is back in full swing again, with competitive and practice shooting at the Amerahn just outside of Kewaskum.

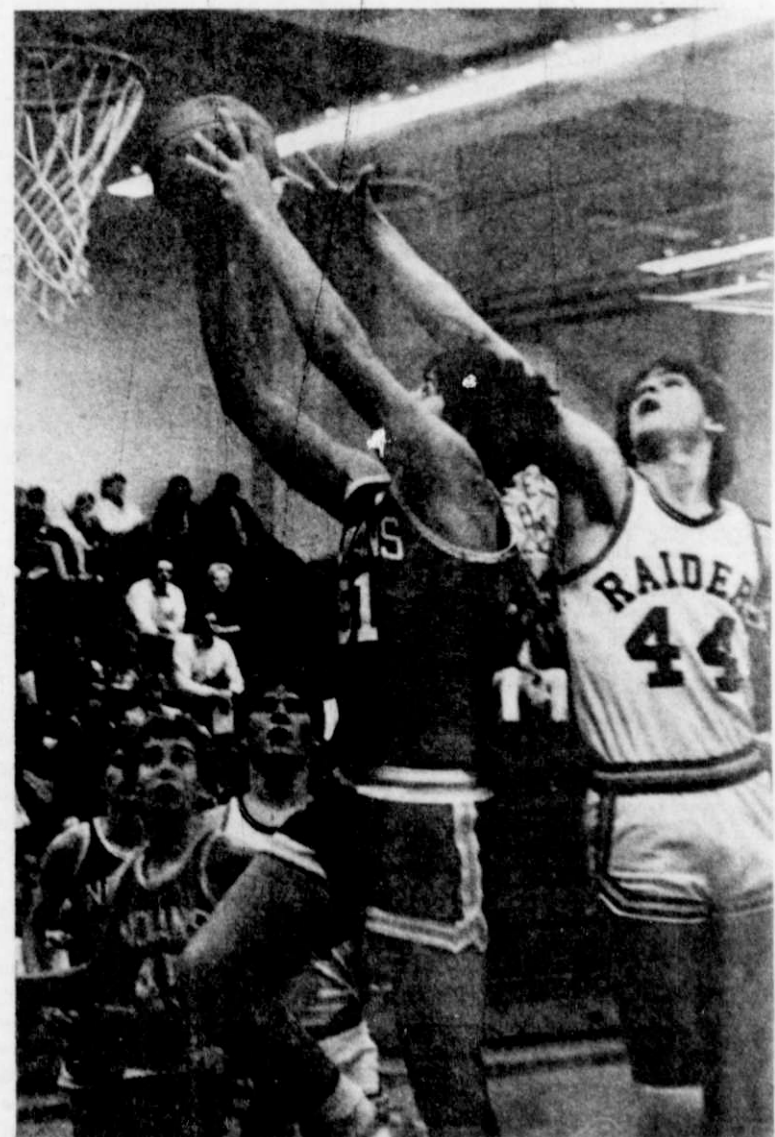

The Kewaskum boys basketball teams made a clean sweep of its Friday night, Jan. 10, taking all three games as they traveled to Kiel to do battle with the Raiders.

Both the freshmen and junior varsity won by big margins of 51-32 for the JVs and 60-36 for the freshmen, with DEFENSE being the key to the freshmen win.

It was another story for the varsity, however, as the Raiders took the Indians into overtime on a shot that came with only 36 seconds left in the game that tied the score at 58.

The varsity game came as close to getting out of control of the officials as a game can get without crossing that fine line that separates a loud and unruly crowd from one that erupts and starts throwing things out onto the floor to express their dissatisfaction.

This powder keg of tension was loaded and fused in the last three minutes of regulation play and the overtime period that followed. During that period just about every call that the officials made went against the Indians, as well as those that should have been made but weren't. In this second half hailstorm of foul calls Kewaskum's Ramthun, Menzel, Theusch and Coulter fouled out as well as Zorn and Luloff for Kiel.

Most disturbing was the change of pace of calls by the officials between the first and second halves.

The first half had plenty of contact and general rough stuff on both sides but without problems, because calls by the officials were consistent both ways. "They left 'em play."

The second half was a different story, however. Both officials seemed to tighten up and get picky and that can cause problems with players not knowing just what to expect. The situation literally invited the Indians to start mouthing off in their own defense, however, that just didn't happen, and it was that restraint that finally won it for the Indians. One technical at the wrong time in this 63-62 win and the game might very well have gone the other way. Strength of Indian character came through again. Well done guys!

Starting at forward for Kewaskum were Coulter and Steger, Ron Theusch at center, and in a big lineup change, Bob Yahr started at guard, along with Tim Rohlinger. Yahr is normally a base line player and not used in the back court.
