Elimination of KMS Principal Position Reduces Salary Costs 5.92%

Board Approves '87-88 Administrative Raises

At a special meeting Monday night, the Kewaskum Board of Education reviewed administrative contracts for the 1987-88 school year. After the lengthy meeting convened to open session around midnight, the board announced it had approved a total salaries only package carrying an increase of 5.76%.

Business Manager Cherna Gorder said Wednesday, that because there have been reductions in retirement costs, the actual figure for the package, including wages and fringe benefits, will be 5.45%.

Gorder also noted that because the figures were calculated on the basis of excluding the Middle School Principal position, the total cost of administrative salaries for 1987-88

will decrease by 5.5% (5.92% including fringes) resulting in a reduction of \$25,000 from 1986-87, which included the position. The reduction of the Middle School Principal position has in effect, absorbed all the administrative salary increases for 1987-88, Gorder noted.

By position, the raises approved were as follows; District Administrator 8%, from \$44,250 to \$47,790; Business Manager 5.5%, from \$37,000 to \$39,035; Director of Instruction 7.5% from \$34,240 to \$36,808; Kewaskum Elementary School Principal 5.5% from \$37,873 to \$39,956; Farmington/Wayne Elementary School Principal 5.5% from \$35,278 to \$37,218, Kewaskum High School Principal 3.5% from \$37,980 to \$39,309, Assistant High School Principal 5.5% from \$39,364 to \$41,529, and

Buildings and Grounds Superintendent 4.5%, from \$27,321 to \$28,550.

The salaries for the positions of District Administrator, Business Manager, and High School Principal were not increased in 1986-87, therefore the figures listed were for both the 1985-86, and 1986-87 school year.

The raises were passed on a four to one vote. Board members Perry Ankerson, Tom Brigham, Kim Peterson, and Ron Theusch voting for, and Jean Goeden against. Board members Ralph Horner and Clara Trapp left the meeting before the vote was taken.

Goeden said her reasons for voting against the raises were she felt some of the increases were too high, some too low, and she would have liked more clarification of what the Director of Instruction's duties will be if she decides to accept the dual position of Middle School Principal-Director of Instruction.

Accident Claims Life Of West Bend Youth

Trevor Gruenweller, 10, of 1606 Barton Avenue, West Bend, was killed Sunday afternoon as he rode his bicycle along Highway A, in the Town of Farmington.

The Washington County Sheriff's Department spokesperson said the accident occurred at 1:07 p.m., on Highway A, 2/10ths of a mile east of Indian Lore Road.

According to the report, a motorcyclist, Karl G. Kirmse, 23, of 1082 Highway A, Town of Farmington, was traveling west on Highway A, when Gruenweller, also westbound, turned

sharply left into the path of the motorcycle. The motorcycle hit and killed Gruenweller. In the collision Kirmse was thrown from his vehicle. He was taken to St. Joseph's Hospital, West Bend, where he was reported in satisfactory condition.

The Sheriff's Department said the accident was still under investigation, but at this time, no charges are contemplated against Kirmse.

Gruenweller was a fourth grade student at Barton Elementary School.

Gruenweller's death raises the number of fatalities to six, for Washington County in 1987.

Dear Diary,

Surely after last Saturday the trendiest bumper stickers will declare: Kewaskum OMERS Create It Better.

Both Kewaskum High School and Middle School Olympics of the Mind teams are state bound after a high-energy regional competition at Morse Middle School in Milwaukee. All five of our district schools sent teams that staged their creative solutions before judges and spectators. It was good to see parents and siblings, grandparents, teachers and one family just interested in OM in the Kewaskum cheering section...especially after one of those Wisconsin - famous "worst spring blizzard" scenarios the previous night.

Good grief, diary... here it is three weeks 'til state and this is the first chance I've had to jot down my thoughts on facilitating creative problem solving by high schoolers. Recycled OM coaches obviously move in low gear to conserve resources.

This is the third year Kewaskum schools have participated in this international competition and the second time the high school team is headed for state. The team consists of George Walz, Rebecca Morlen, Scott Kulas, Greg Weddig, Mitch Gebheim (2nd year member) and Leighton Peterson (3rd year member).

The long-range problem chosen by the team is called "OMER to the Rescue" which entails building a powered vehicle that can be contained in two suitcases. The vehicle must carry OMER and/or his sidekick on a quest to perform five tasks (two good deeds, stop a crime, relieve a distressed person and rescue a kitten), within a ten minute period within certain dimensions and without any body parts touching the floor. Simple enough.

Meanwhile the problem has a long list of limitations and clarifications attached to ensure a challenge, plus the solution must be creative and clever enough to garner lots of style points. It is a tough problem... so tough that Kewaskum was the only regional high school team to choose it. Obviously there was no competition to speak of at regionals...a shoo-in, maybe, but disappointing.

Note I used the word "facilitate" earlier, dear diary. My job description includes scheduling, purchasing, feeding and watering, and refereeing. My main goal is to present some basic skills in decision making, some practice in spontaneous thinking and an awareness of group process. It's the team's job to solve the problem. I still get to ride the glory train.

These students have been training for three months, practicing at least three days a week and working every night for two weeks prior to regionals. That is a lot of togetherness...add to that, high fatigue levels, creative temperaments, solutions that don't work. Survival depends on learning to work together...like the seven dwarfs or Santa's elves or something.

Well, dear diary, I've rambled on, but I still want to record my observations of this group's process in becoming a

team:

- Creativity Is Messy - coaches don't do floors, pick up tangerine peels or wash paint brushes. Endlessly hauling props is fun, fun, fun.

- OMERS Procrastinate Creatively - "later" is a neat code word for time-on-task, until time ran out. Hard lesson. Creative people spending time together does not a problem

solve. Hard lesson #2.

- BIARC - the method Noah used to move the animals - worked well as a decision-making model, when used: Brainstorming - Identify the best - Action plan and implementation - Review and revise - Conclusions. The other model frequently used was the gut level/shoot-from-the-hip style.

- Communication Skills We Know and Love: The helping

mode, when critiquing a team member, is more productive than the circling shark approach. "Should" is a fallacy of thought. Scapegoating doesn't get in. Mini-workshops on coping and assertiveness, as well as stress management and sensitivity training are being considered. Believe me, dear diary, this team has experienced it all...but there is definitely light at the end of the

tunnel...they are a team.

- Band directors who step in for ailing coaches are OMER angels.

RE: Kewaskum Teacher Salaries

I attended a public hearing March 19 at which Kewaskum teachers made an excellent presentation for better salary increases while the school board presented a short, relatively abysmal case in opposition, directed by an expensive attorney.

The teachers were represented by a young woman, Debra Schwock-Swoboda, Uniserve Director, Cedar Lake United Educators. She thoroughly explained the arbitration issue, the documents showing the relatively low rank of Kewaskum school salaries, and coalition efforts to take school financing off the property tax. This was all encompassed in a blue booklet distributed to the public. Teachers also spoke of their own personal experiences and concerns, in favor of the Education Association position.

Atty. Mike Spector, Quarles and Brady law firm, Milwaukee, spoke briefly and distributed a one page document showing only the current salary schedule, the board's offer, and the Kewaskum Education Association's offer. He questioned some of the comparison figures of the teachers, the rate of inflation, favored the property tax over other taxes to finance the schools because of the "home rule" benefit, and spoke of efforts to change the arbitration

law. He and some other speakers claimed the community could not afford more than the board offered. The teachers disagreed. No written figures on the economy were given to the audience.

Regardless of the outcome of this dispute, certain things appear clear:

1. High income people favor the property tax as a way to finance the schools, as their property tax is low relative to their income, and as for the "home rule" attraction of the property tax, high income people do most of the home ruling.

2. Lower income people with property pay a disproportionate share of their income on the property tax, particularly those who own farms, and to add to their burden, the value of these farms if sold has declined. As for home rule, they lack it, unless they organize and have trustworthy leaders.

3. Reform is needed in both the arbitration law, and in the means of financing the schools; there needs to be more flexibility and fairness.

4. The Kewaskum School Board needs new leadership, a board that is fair, strong, and representative of the community; a board that is not dominated by any special interest, and can speak for itself, not through a costly lawyer.

5. The Kewaskum School District needs new leadership to stimulate the right kind of economic development - in the right place.

Letter to the Electors of the Kewaskum School District:

Isn't it a shame how our past school board members are crying the blues. The truth is if you want to be a public official, you must serve the public or you are voted out. I believe it has been made very clear that the district isn't happy with our incumbent board members, and they justly deserve to be set down. Isn't this what Atty. Jeffrey A. Schmeckpeper told the court. The Plaintiffs may obtain RELIEF at the ballot box or before the legislature. Let's use the ballot box.

Doesn't it appear we only have 3 or 4 past board members that know how to run a school district. But just take the time out to realize that we have new candidates that have secure information from other districts, such as budgets, review their curriculum programs, and probably, have found they have better programs with less costs to the district and need less people to do the job. Also, I can't find where the board accepted his resignation by a 2/3 vote of the membership at an OPEN MEETING. This information is not in my copies of the minutes of the board meeting.

I believe we have some very qualified new candidates who want to serve the district and will take the time to review the problems that have arisen and

who will communicate with the public in trying to solve any problems that may come up.

By the way, what do you electors think of our last school paper we received in the mail? Does this reflect the complete minutes of the board meeting? State Statute requires the complete minutes be published within 45 days of the meeting. Is this being done?

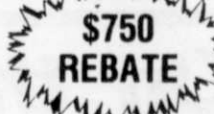

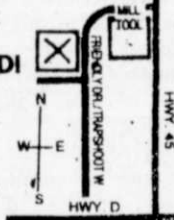

Minutes of Village Board Meeting

Mid-Monthly Meeting
March 16, 1987
8:00 P.M.

The Village Board of Kewaskum, Washington County, Wisconsin met in Mid-Monthly Session in the Council Room of the Municipal Building, 204 First Street.

President David E. Nigh presided. All Trustee Members were present. A quorum was present.

The meeting was opened with a Moment of Silence and Pledge of Allegiance.

On a motion by Trustee Richard Schmidt, seconded by Trustee Mary Krueger and unanimously carried by voice vote, the minutes of the March 2, 1987, meeting were approved as printed.

Five residents of the Kewaskum Mobile Home Park were present and asked the Village Board to consider an extension of sanitary sewer service to the Kewaskum Mobile Home Park without annexation. Mr. Norman Gruber was the group's spokesman. There were other citizens in attendance, but did not speak.

The Village Board asked questions of the Mobile Home people and expressed their concern for them. The primary concern is that the Village treat everyone the same and that the same policies, ordinances and precedents are maintained.

It was noted sewer service has never been extended to anyone outside of the Village limits and that annexation has always been a requirement for sewer or water hookup. Also that the annexed party meet all ordinances and zoning requirements.

On a motion by Trustee Howard Laubenstein, seconded by Trustee Paul Blumer and unanimously carried by voice vote, the Board approved the consideration of an extension of sanitary sewer mains and provide sewer service to the Kewaskum Mobile Home Park with annexation. Note this was only a motion to consider and that a meeting would be set up to review annexation, ordinance and zoning requirements.

After a brief discussion in reference to the possibility of retaining the 1985 squad car and using it as a general municipal vehicle, the Board reviewed what the car would

cost or save. After hearing the initial cost would equal an estimated \$914.00 and that the savings would equal an estimated \$904.00, plus it was noted the projected revenue from the sale of the vehicle would equal \$2,100, for 1987 and that would be lost as well as continued depreciation of the vehicle, it was determined to review the matter during the next budget process.

On a motion by Trustee Richard Schmidt, seconded by Trustee Thomas McElhatton and unanimously carried by voice vote, the Board approved the advertising for bids on the disposal of the 1985 Plymouth Gran Fury.

Administrator Daniel Schmidt reported that a letter was received from Ruckert & Mielke, Inc., the Village Engineers, in reference to the repair work to the Fire House. The plans, specs and bid documents are being processed. It was noted that options should be reviewed by the Fire Department Committee and the Protective and Tentative Safety Committee. The tentative date of March 24, 1987, at 7:00 p.m. has been set for this meeting with the engineer.

Administrator Daniel Schmidt reviewed some correspondence with the Board and some general information.

Trustee Mary Krueger informed the Board of the upcoming Incineration meeting on March 26, 1987, and offered information to those Board Members interested.

Trustee Thomas McElhatton, Chairman of the Park and Recreation Committee, reported to the Board on the committee meeting of March 16, 1987. The committee recommended the purchase of three (3) portable low band radios compatible with the DPW & WPC department's system to be used at the beach during the summer season. On a motion by Trustee Mary Krueger, seconded by Trustee Howard Laubenstein and unanimously carried by voice vote, the Board approved the purchase of the radios.

Lighting of the new ball diamond was discussed as well as the DNR canoe launch.

Insurance Agent Gene Bohn was present to review with the Board the Fireman's Errors and Omission Coverage. After a brief discussion the Board decided not to purchase the coverage.

Administrator Daniel Schmidt reviewed the letter

recently sent out to all those properties that are to have sidewalks installed. The response has been real good for after 3 days over 25% have already returned them signed.

On a motion by Trustee Mary Krueger, seconded by Trustee Richard Schlice and unanimously carried by voice vote, the Board authorized the advertising for bids for the two sidewalk projects for 1987. (The bids are due and are to be opened on April 2, 1987, 4:00 p.m.)

Administrator Daniel Schmidt informed the Board that the 1986 ordinances have been updated to be placed in the Municipal Code Book. All Trustees are asked to bring their code book in by April 6, 1987, so upon ratification of the update ordinance the code books may also be updated.

Board of the Village of Kewaskum supports and urges repealing of the aids-to-credits budget system;

RESOLUTION NO. 87-5 MODIFICATION TO 600 HOUR ELIGIBILITY FOR WISCONSIN RETIREMENT SYSTEM

WHEREAS, the State of Wisconsin has established and offered a state-wide Retirement System for all eligible full-time state, county and municipal employed personnel,

WHEREAS, this Retirement Program is administered through the Wisconsin Department of Employee Trust Funds, operating under specific rules and regulations,

WHEREAS, for the majority, individual employee contributions are being paid into the retirement system, in total as a fringe benefit by each governmental entity,

WHEREAS, the retirement system has established a compulsory employee minimum eligibility of 600 working hours each year to participate,

WHEREAS, a number of municipalities throughout the state have, and continue to hire part-time employees, in the interest of eliminating increasing costs of employee fringe benefits,

WHEREAS, there will always be specific seasonal and other part-time municipal jobs for students and those who supplement family income with part-time work,

WHEREAS, a number of part-time municipal jobs are exceeding the 600 hour working minimum, making it necessary for the municipality to pay contributions to the retirement system which defeats the original intent of no fringe benefits to part-time employees.

NOW, THEREFORE BE IT RESOLVED, that in the interest of budgetary control and cost containment, and to eliminate the excess administrative costs of monitoring part-time employment, that the 600 hours per year be modified to be more realistic.

FURTHER, BE IT RESOLVED, that a more realistic figure for eligibility of part-time hours worked be established at 1040 Hours per year being 1/2 of full-time employment.

FURTHER, BE IT RESOLVED, that a copy of this resolution be forwarded to the Governor, our members of the Wisconsin Legislature and to the League of Wisconsin Municipalities.

DNR Trout Stocking Now in Progress

The season's first rainbow trout stocking of municipal park ponds is scheduled from March 23 to April 3, according to the Department of Natural Resources.

The cold water sports fish will be released in 11 community-operated ponds and lakes in six counties of southeastern Wisconsin under the urban fishing program conducted by the DNR and local governments.

This will be the third year that trout have been stocked in public park waters for the special benefit of youngsters and oldsters who lack the mobility to travel to distant fishing holes.

About 300 trout per acre will be released in ponds in Kenosha, Ozaukee, Milwaukee, Racine, Washington and Waukesha counties in the first stocking, Piening said. Most trout should be between 10 and 12 inches long. The daily bag limit is five fish, and the size limit is nine inches.

Ponds to be stocked: Kenosha County - Anderson Park; Ozaukee County - Cedarburg Quarry; Milwaukee County - Miller Park; Racine County - Reservoir, Johnson, Quarry Lake and Green Ridge parks; Washington County - Hartford millpond; Waukesha County - Muskego, Minooka and Nixon parks.

A second trout stocking is planned April 7-9 to coincide with fishing clinics to be conducted April 11 by the Wisconsin Council of Sport Fishing Organizations in cooperation with Milwaukee County and the DNR. The fishing instruction sessions will be held at Brown Deer, Washington, McCarty, Humboldt, Sheridan, Greenfield, and Scout Lake parks in Milwaukee County and Lockwood (formerly Graceland) Park in Racine County.

Also to be stocked with trout the same days are McGovern, Jackson, Kosciuszko, Mitchell, Saveland and Wilson park ponds in Milwaukee County.

Once the ponds are stocked, they are open for fishing, Piening said. He reminded anglers that a fishing license and trout stamp are required for fishers between the ages of 16 and 65.

Campbellsport Attorney 'Surrounded' By KM State Forest

Wisconsin's eight state forests encompass nearly 500,000 acres that attract visitors intent on wilderness angling, family camping, weekend swimming or quiet relaxation.

John Zillmer, Brookfield, Lester and Patricia Lambries of Manitowoc, Sally Runge of Brule, Gus Christ of Campbellsport and Don Simonds of Brule have little in common - except a love of Wisconsin's state forests.

Gus Christ, an attorney at Campbellsport, lives on a farm "surrounded" by the Northern Unit of the Kettle Moraine State Forest.

It's a place for fishing and hunting for him and a place for walk into the forest. Lately I've been going out and scouting for some turkeys."

Christ is president of the Friends of Kettle Moraine, Inc., and is hoping that organization can supply educational materials for Ice Age Center visitors.

Each of the eight Wisconsin State Forests is a gateway to a special outdoor experience for visitors. The eight state forests are: Kettle Moraine, Southern Unit, Eagle, 18,000 acres; Kettle Moraine, Northern Unit, Campbellsport, 27,775 acres; Point Beach, Two Rivers, 2,900 acres; Black River, Black River Falls, 67,000 acres; Northern Highland - American Legion, Woodruff, 220,000 acres; Governor Knowles, Grantsburg, 30,000 acres; Flambeau, Winter, 87,000 acres; and the Brule River, Brule, 39,000 acres.

In addition, the Bong Recreational Area, 4,514 acres, and Havenwoods Recreational area, 235 acres, both near Milwaukee, and the Coulee Forest, 2,971 acres near La Crosse, are available for outdoor recreation.

Information about recreational opportunities is available from forest superintendents or by calling 608/267-7494.

At the Northern Unit of the Kettle Moraine State Forests, Superintendent Walt Adams sums up the importance of recreation in the forest, "Recreation and education are the two most important uses at this time, but forest products will become more important economically."

Cutting of pulpwood, hardwood veneer logs and trees for lumber produces income on all the state forests while providing forest products for Wisconsin industries. The forests and recreation are financed by a tax on equalized property equivalent to 20-cents on each \$1,000 of property value. The system was established in 1920 to finance reforestation, fire control and establishment of state forests throughout Wisconsin.


