Year 2,000 Sewer Service Plan Approved

While the year 2,000 seems in the distant future, the fact is that it is only twelve years away. On that basis, the Kewaskum Village Board, last week, approved a revised extended sanitary sewer service area which is taking into account the possible need for expanded service to the village and land bordering its boundaries during those next 12 years.

At the public hearing held last Monday night, Bruce Ruben, Chief Land Use Planner for the Southeast Wisconsin Regional Planning Commission, said the revision was drawn up in response to a request from the village.

While the service area maps had been intended to be used as a guide and tool for municipalities, SEWRPC and the various local governments soon found that the Department of

Natural Resources had been using those same maps in reviewing and approving requests for sewer extensions. If land seeking sewer service had been included in a sewer service area, noted Ruben, the DNR would approve the extension. If not, there was a good chance the request would be denied.

The village's new area is more than double in size than its original plan. The new map covers 3.8 square miles, which includes the original 1.5 square mile plan and it also designates primary and secondary corridors which would not normally be considered appropriate for development such as wildlife areas and marshes.

While there is no specific plan, request or mandate to extend sewer service in the area, requests for such service would be looked on more favorably by the DNR because

they have been included in the area.

SEWRPC estimates population growth for the area to range from 3,100 to 4,900 by the year 2,000. (The village's present population is approximately 2,400). George Allmann, chairman for the Town of Kewaskum, who was present at the hearing said he had no objections to the land being included in the new area since septic installations are being curtailed. He did question SEWRPC's growth estimates for the village. Allmann indicated he felt the low end of the projection seemed more logical. Ruben said it was better to over estimate than under estimate. On that basis the plan would remain in tact even longer.

Ted Meilahn of Kewaskum, and a surveyor, asked how long the plan would be in effect. Ruben replied, "Until the

The public is urged to attend this important meeting.

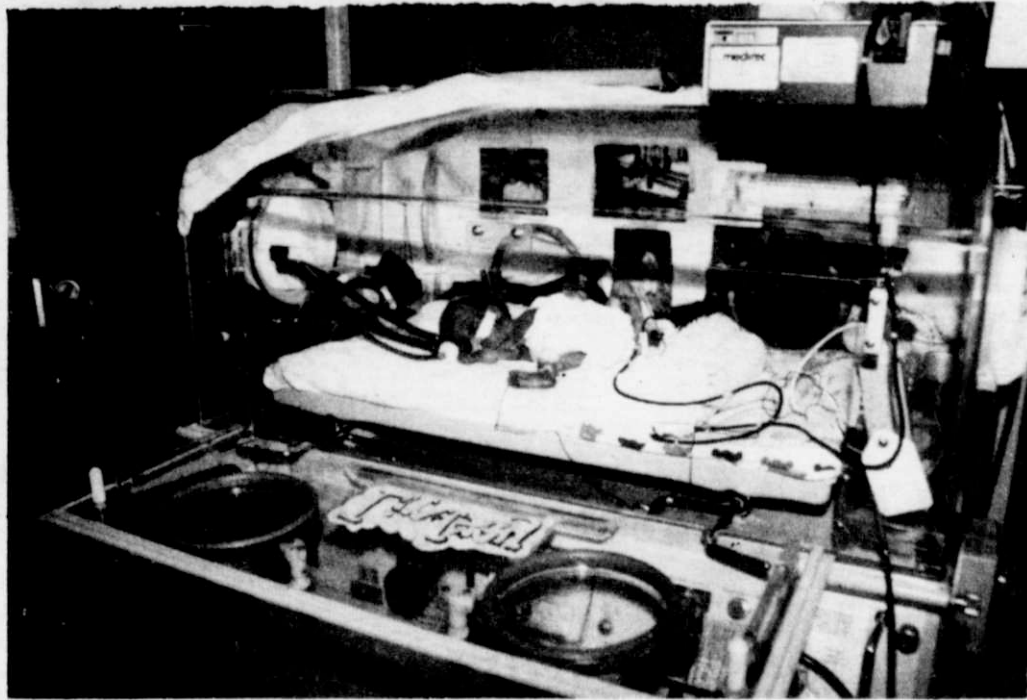
Dinner Concert At High School

Miracle Baby Lindsey Hackbarth

It was a fragile beginning for baby Lindsey Jean Hackbarth, daughter of Mark and Linda (Faber) Hackbarth, former residents of Kewaskum and West Bend. The Hackbarths now live in Bozmen, Montana the last 5½ years.

Linda is a member of Salem U.C.C. church of Wayne and Mark was a former member of St. Lucas Church of Kewaskum.

They would like to share their emotional experiences having a premature baby girl born July 23, 1987. She weighed one pound, 14 ounces. She was fourteen weeks early and was flown with Flight for Life to Salt Lake City, which was 800 miles

away. She then dropped to one pound, nine ounces, where she held on by a string.

Linda and Mark got to see their daughter for the first time on Tuesday, July 29, 1987. Her life was a miracle to them. A tiny body, red, wrinkled, and emaciated, lay in an incubator, a ventilator helping her breathe, with a maze of tubes and wires trailing from her body. Linda was able to hold her daughter for the first time after 2½ weeks, it was very scary. She was on the ventilator. It was like holding nothing, but a feather. "I cried when I held her and finally felt like she was really mine," Linda said. The

doctors and nurses were really supportive and kept saying everything will be O.K.

Lindsey was in Salt Lake City for two months. Several trips were made every week by their Pastor, family, friends and neighbors. Then she weighed three pounds 11 ounces. They flew her back to Bozmen Hospital for one month. She came home on October 17, 1987. Then she weighed four pounds, four ounces.

Lindsey was a Christmas miracle baby and was baptized on that day. Lindsey's grandparents, Mr. and Mrs. Eugene Faber of Wayne and

York Will Not Seek Re-Election Village To State Assembly in 1988

State Representative Dwight York, Republican of the 59th Assembly District, announced at the Washington County Realtor Association's meeting in West Bend on March 2nd that he would not be a candidate for re-election in November of this year.

York is the ranking member on the Education Committee and also serves on the Health, Housing and Securities Committees, as well as Forward Wisconsin. York who has served two terms in the Assembly stated, "I have enjoyed the experience very much, however, 'I wish to get back into an administrative position.'" York had been superintendent of Lomira schools previously.

"I have been happy to serve

in the Assembly, especially this term when we have been able to cut income taxes, inheritance taxes, and keep the capital gains tax credit. I look forward to passing the Governor's property tax plan after a few changes before I finish my term," York stated.

A primary election will be held on September 13, 1988 and the general election will be on November 8, 1988.

The 59th Assembly District includes the Washington County towns of Erin, Hartford, Addison, Wayne and Kewaskum; the city of Hartford and the villages of Slinger and Kewaskum, as well as Ashford Township and the Village of Campbellsport in Fond du Lac County and the eastern portion of Dodge County.

village decides to change it." He noted, however, that SEWRPC recommends the plan be reviewed every five years.

In order for developers with land within the plan, but outside the village limits, to request sewer service they must be annexed by the village and pay for all the necessary work required to provide that service.

Now that the village has approved the revised area, the plan will be presented to the SEWRPC Board of Commissioners for approval at their quarterly meeting this month. If it is approved by the commissioners, it will be forwarded to the DNR for its review and approval.

tion needs.

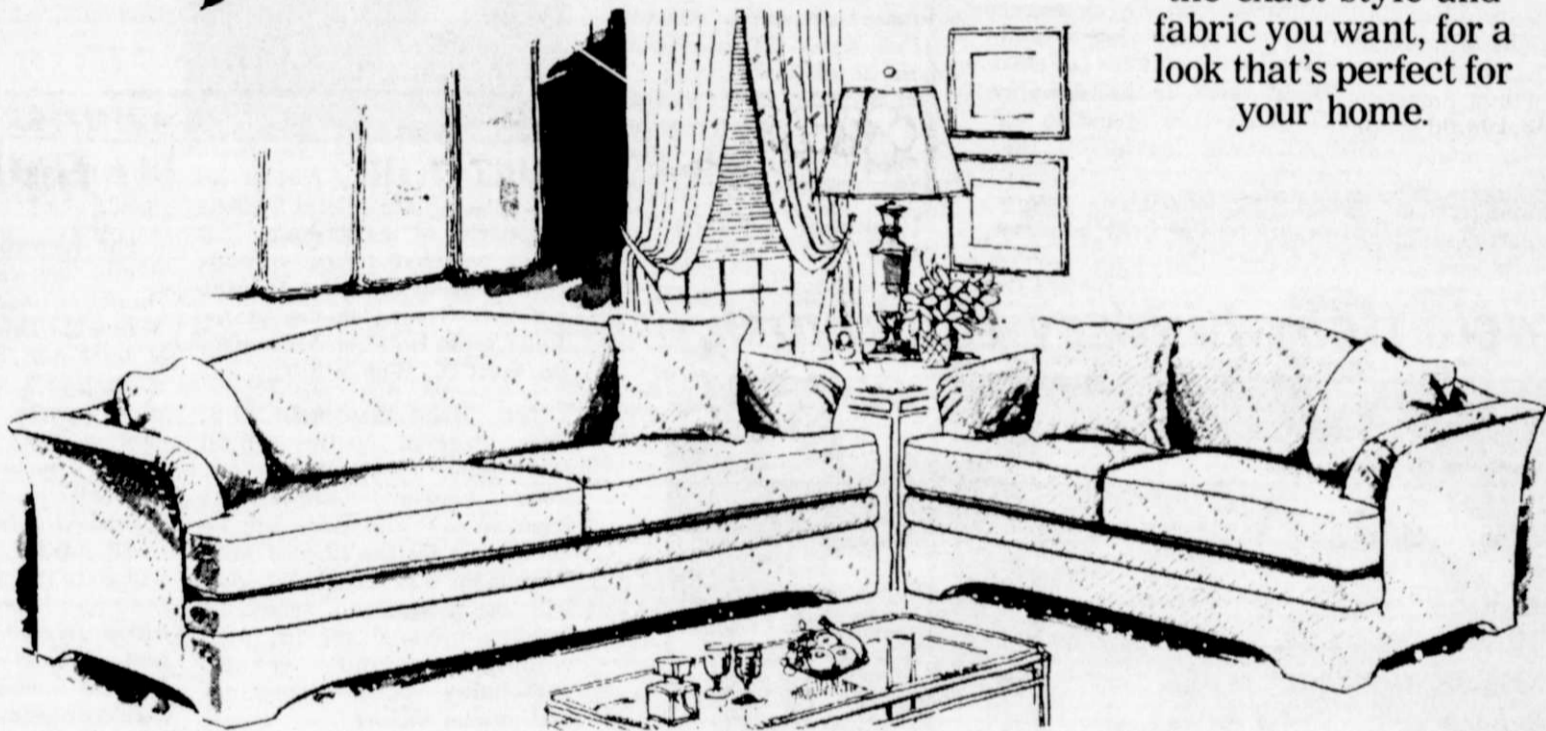
Besides Spradau, the village is served by two part time officers with backup from Fond du Lac county when the officers are off duty.

4-H to Celebrate 75th Anniversary

Get ready for a big anniversary celebration, 4-H enthusiasts!

Wisconsin 4-H will be 75 years old in 1989, and the celebration will be going all year long.

The kick-off will be held during State 4-H Week in October 1988. The celebration will include a state-wide poster contest and special events at the 1989 State 4-H Congress, the Wisconsin State Fair and Farm Progress Days.

Among the highlights will be a birthday celebration May 8, 1989, in Madison. This convocation of leaders will provide a time to present educational activities that look ahead to the future of 4-H as well as celebrate its past.

The birthday celebration coincides with the anniversary of the signing of the Smith-Lever Act, the legislation that paved the way for the federal Cooperative Extension Service. The first local 4-H club in Wisconsin was organized under the terms of this act by a representative of the Land Grant College in Walworth County in 1914.

It will be more than just an anniversary celebration. The anniversary theme, "Design for the Future," emphasizes the notion that 4-H is not just celebrating its past, but also its present and its future. The celebration aims to increase awareness of 4-H — its place within UW-Extension, its educational mission and its diversity, as well as recognizing past accomplishments and support.

Encouragement is focused on local 4-H clubs to participate in the celebration by becoming involved in the state-level activities and by coordinating their own local activities. The goal is for each local club in Wisconsin to celebrate the 75th

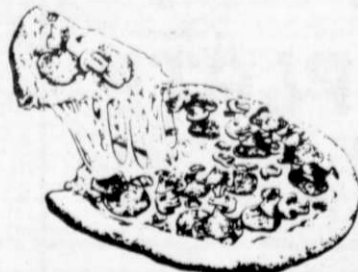

Kewaskum Native Dr. Chet Perschbacher Honored

The following news story about Chester Perschbacher, D.D.S., Appleton, a native of Kewaskum, was submitted by his sister-in-law, Mrs. Lazeda (Myron) Perschbacher, Kewaskum. The story was taken from the Outagamie County Dental Society, a component of the Wisconsin State Dental Society Newsletter. It follows:

"As we consider the status of both our present and future dental practices and participation as members of our local dental community, it is important to focus on our heritage and, in particular, the involvement of one of our members - Dr. Chet Perschbacher. Certainly, none other presently among us more highly represents the professional image of a master dentist. A dental career which represents excellence in both technical areas, as well as patient care, as represented by the bonded relationships he holds with four generations of patients is worthy of our review and admiration. While Chet's career has been highlighted by great achievements, the theme of his career has been that of mutual respect and thankfulness for the support he has received locally from his colleagues. His warmth, humility, optimism, and good humor are truly a great asset to the Outagamie Dental Society.

Chet was born in October, 1901, in Kewaskum, Wisconsin. He was raised there with three sisters and two brothers. His father had started a garage about ten years earlier in the building next to their house. This included a blacksmith shop, a carriage repository, and implements of the farming trade. With the advent of the automobile, Chet's father changed the business to that of selling and servicing automobiles about the time the Model T Ford became popular.

Shortly following graduation from Kewaskum High School in 1919, Chet built his own automobile. He entered Marquette University in the fall of 1919 in the School of Commerce. In 1921 Chet convinced the Dean

of the School of Dentistry to allow him to enroll in that program. There were 165 men and three women in his class. During that time, he developed a mentor relationship with Drs. Jim and Mort Mortenson, nationally renowned dentists and professors in the School of Dentistry. This relationship was to be strongly influential in the development of Chet's technical skills, as well as perceptions of dentistry. These men were also strongly influential in Chet's choice of the Fox Cities area for locating his practice. To this day, he remains grateful for their interest and influence in his career.

Chet established his practice in Appleton in the fall of 1925 setting up the first of his offices in what today is the AAL building. (He paid \$50 a month rent with a five year lease). The second office was later located in the same building. He moved his practice later to the Zuelke building, and finally to a location at what has been his residence at 1430 West Cedar Street. His location in these offices spanned 61 years in practice.

Chet joined the Fox Valley Dental Society in 1925, became Secretary in 1927, and was elected President in 1929.

That summer while double dating with a friend from Escanaba, Michigan, he met Louise Harder, who was home from Mills College in California. This was the beginning of many road trips between Appleton and Escanaba until the following winter when Chet spent an hour one day in sub-zero weather getting permission from Louise's father for her hand in marriage. They were married the following fall in September, 1931, and have been together for over 56 years. They have three children and seven grandchildren. Their daughter, Ann is married to

John Kloehn.

Chet's brother, Ray, graduated from the University of Minnesota School of Dentistry and joined him in dental practice. They practiced together for 14 years. Ray married Louise's twin sister and they later moved his practice to the Denver area following military service. Chet and his brother enjoyed putting on dental clinics, both nationally and locally over the years from 1928 to 1960. These clinics involved direct gold inlay and crown casting techniques, as well as reconstructive dentistry including the use of precision crown and bridge attachments.

In 1931 Chet became the youngest dentist to become a member of the American Academy of Restorative Dentistry. He would later serve on the Council of that organization in 1955.

Professionally, Chet is recognized as a member of several dental organizations. He is a member of the International College of Dentists, being elected a Fellow in 1938, President of the USA Section in 1956, serving on the Executive Council of the World's Section in 1956, and becoming President of the World's Section in 1963. (It was about this time that his hair turned white).

He has been a past member of the Milwaukee Dental Forum and served as their President in 1960. He has been an associate member of the Chicago Dental Society since 1926. He is a member of the Wisconsin State Dental Society 50 Year Club. He is a life member of the Psi Omega Dental Fraternity, as well as the Pierre Fauchard Dental Academy. He is a Fellow of the American College of Dentists.

During these years, Chet had become a leader and innovator in the development of veneer crowns, as well as the use of two or more precision attachment partial dentures. He developed innovational stress breakers for posterior teeth, as well as the

use of asbestos pads for dental castings. He devised a system of pre-measuring and packaging investment materials with proper water powder ratios. He was an innovator, as well, in the preventive use of antibiotics in dental treatment.

Chet's interests have included automobiles, hunting, fishing, and professional dental organizations. At one time, he held the U.S. record for the largest muskie. Chet continues to hunt and fish, and again bagged his duck limit this fall. Chet was disappointed not to down a goose on his goose hunt outing in the Rosendale area this year. He suggests he was even more disappointed at the difficulty he had moving for three days after kneeling in the goose blind on a cold autumn day.

Chet's community involvements have included being on the Board of Directors of the YMCA. He served as Secretary - Treasurer and later President, of the Appleton Memorial Hospital staff in 1960. He has served as a member of the Community Chest and the Outagamie County Hospital Commission. He has been a member of the Chamber of Commerce, as well as a 35 year member of the Kiwanis Club. He has served on the Commission for Underprivileged Children in this organization.

Chet, by invitation, is listed in the books America's Dental Leaders, Who's Who in

American Dentistry, Personalities of the West and Midwest and Who's Who in the Midwest.

Let us all take a moment to celebrate the professional career of Dr. Chet Perschbacher.

"He is a most remarkable individual whose life has reflected his commitments. His boundless energy, understanding and caring for people, as well as, his quick wit and delightful humor are a source of inspiration for so many who have known him. Here indeed is someone who has left an indelible mark."

'E' Stamps Provide Interim Solution for New Postage Rates

We've all been short a few stamps at one time or another. It is frustrating not to have the postage on-hand when you need to mail something. Now multiply this need several billion times — the number of stamps sold each month nationally — and you'll begin to see the Postal Service's problem when a First-Class rate change is announced every three or four years.

Postal rate setting is a long, complex process, that involves 10 months of consideration by the Postal Rate Commission, and a final decision by the Postal Service Governors. So how does the Postal Service make sure that stamps with the right amount of postage are available when you need them for correspondence?

Part of the answer is an interim nondenominated stamp — one that is good for whatever amount is decided. The new stamp features the letter "E" and a full-color picture of Earth from space. It is plainly marked for use as domestic postage and will be available in sheets of 100 stamps, booklets of 20 stamps and coils of 100, 500 and 3,000 stamps, says Norman L. Miller, Field Division General Manager/Postmaster of the Milwaukee Division of the U.S. Postal Service.

"Customers use several billion stamps nationally each month, so this situation could

create a big problem for us if we didn't have a two-month supply of 'E' stamps ready," Miller says. "Postage bearing the new First-Class denomination will begin arriving at Milwaukee Division post offices before the supply of 'E' stamps is exhausted."

In addition, Miller also says, post offices have ample supplies of low-denomination stamps to use with 22-cent stamps by customers still holding them when the rates change.

The selection of the letter "E" was easy, Miller explains, since this will be the fifth time the Postal Service gone through the drill of implementing a new First-Class rate that it couldn't predict in advance.

The first time was in 1978, when postal customers went through 4.9 billion "A" stamps before the new 15-cent stamps were ready.

The "B" stamps and "C" stamps went into service after 1981 rate changes. About 5.5 billion "B" stamps and 4.3 billion "C" stamps were used.

The "D" stamp was used following a February 1985 rate change. Customers used about 5.8 billion "D" stamps.

The new "E" stamps have been stored in a man-made cavern cut out of solid limestone near Kansas City, MO. The Postal Service leases 170,000 square feet of the 700-acre cave for its Philatelic Sales Division's fulfillment branch.

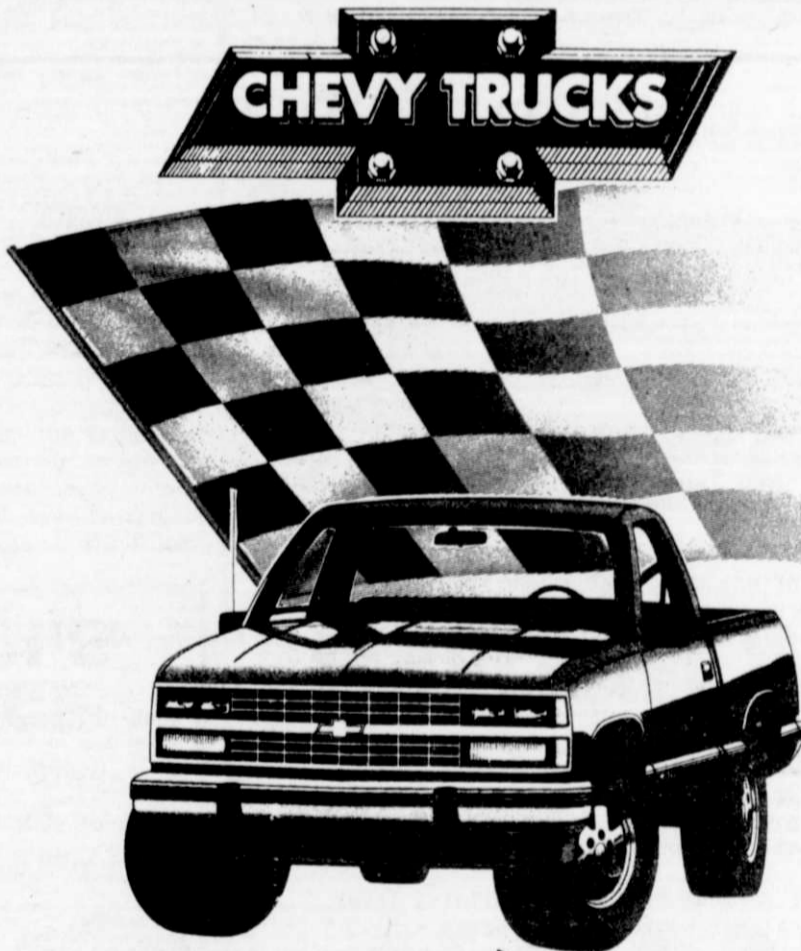

Mr. Meilahn asked how long the sewer service area would be in effect? (answer) Indefinitely, but it may be amended as needed and also should be reviewed on the average of every five years.

Mr. Allmann indicated he had no objections as to the area on the Town's behalf, but said he felt SEWRPC's projections as to population expectations for the year 2000 were high.

Mr. Zarling asked how much use of

topographical maps was used to establish the area? (answer) Those maps are used a lot especially for the significant environmental corridors.

The Village asked about an approximate 20 acre parcel bordered by CTH S and E. Moraine Drive as to why it wasn't included. (answer) It was overlooked more than likely and can be included as so noted by the Village Board in their Resolution.

In closing Mr. Rueben indicated this plan is a requirement of the DNR and is only a basic guide for future development.

Corn Marketing Order Referendum Scheduled

State corn growers will vote in a March 1-15 referendum, on proposed amendments to raise more revenue under the corn marketing order, says Secretary Howard C. Richards, Department of Agriculture, Trade and Consumer Protection (DATCP).

The grower-elected Wisconsin Corn Promotion Board, Inc. (WCPB) that administers the present marketing order requested the changes.

WCPB proposed the amendments to raise annual revenue from \$80,000 to \$350,000 to support international and domestic market development programs, and allocate more money for corn research. If approved, the assessment rate on corn will increase from one-tenth cent to one-half cent per bushel, and allow the Commodity Credit Corporation (CCC) to collect assessments on corn pledged as security for government loans.

Under the proposed amendments, producers would still be able to obtain refunds of assessments paid, and corn used for feed purposes would continue to be exempt from assessment.

Assessment revenues have been averaging \$80,000 annually, since the marketing order was instituted in 1983, much less than the

\$200,000 originally anticipated. Richards decision to schedule the referendum is based on testimony received from growers at DATCP hearings held around the state in December.

DATCP mailed ballots to individual corn growers before March 1. Any producer who either sold corn, placed corn under CCC loan, or forfeited corn to the CCC in 1987 or 1988, will be eligible to vote in the referendum. Ballots must be returned to DATCP before March 15 to be counted.

The amendments will be adopted if approved by more than 50 percent of the growers voting in the referendum. If growers do not approve of the amendments, the current marketing order will remain in effect.

Pesticide Training Is Scheduled for County

As part of the overall effort to have more Wisconsin farmers certified to apply agrichemicals, pesticide certification training will be held in Washington County on March 15.

"Extension offices have been providing certification training all winter," says JoAnn Vogel, president of Wisconsin Women for Agriculture. "But we think one final push before spring planting can really draw attention to the need for certification."

Farm women's groups throughout the Midwest have made a concerted effort to increase awareness among farmers of the benefits offered by certification. "This is our major educational program this spring," says Janis Fuerst, president of Wisconsin Women Involved in Farm Economics (WIFE). "The number of farmers certified to apply agrichemicals has risen sharply in the last two years, but many thousands of Wisconsin farmers still are not certified. Certification makes sense from both an economic and a safety standpoint. It's not difficult and it provides farmers with valuable information and updates on the use and handling of agricultural chemicals."

In Washington County, certification training and testing

will be held March 15 at 8:30 a.m. in the Courthouse. Farmers should contact the county Extension office at 338-4477 for more information.

YOUR TAXES

Elderly, Blind Taxpayers Need to Pay Special Attention To Tax Standard Deductions

Elderly and blind taxpayers seem to be making a common error on their 1987 tax returns - and it could cost them money. Internal Revenue Service centers around the United States are reporting that a higher than usual percentage of blind or elderly taxpayers are neglecting to claim the full amount of their standard deduction. As a result, they are reporting a tax liability that is too high, according to Milwaukee District Director L. M. Phillips.

On 1987 Federal income tax returns, taxpayers who are blind or who are age 65 or older are entitled to claim a larger standard deduction than other taxpayers. In the past, these taxpayers were able to claim extra exemptions on the front of their tax returns. But, due to changes made by the Tax Reform Act of 1986, those extra exemptions are no longer allowed. Instead, these taxpayers now receive the larger standard deduction which is claimed on line 33b of form 1040, line 14d of 1040A, or line 4 of form 1040EZ.

The IRS has alerted its taxpayer assistants to these errors and IRS cautions all taxpayers to read their tax form instructions carefully - to avoid paying either too much or too little tax.

WISCONSIN OUTDOORS AND CONSERVATION NEWS

BURN DEBRIS NOW WHILE WILDLIFE RISK IS LOW

Rural landowners and farmers should burn debris now while the ground is still snow covered, advises Earl Meyer, Wisconsin Department of Natural Resources' forest fire prevention specialist.

"Forest Fire Prevention Week is April 17 through 23," said Meyer, "but the time to begin taking fire precautions is now. Last Spring 798 wildfires burned over 3,000 acres in Wisconsin. And 90 percent of those fires were caused by people."

Now is the time to burn brush piles, debris and woodcuttings, suggests Meyer, as there is little danger of the fire spreading. That won't be the case in several weeks, however, when the ground is clear of snow and dry vegetation covers many areas.

But before you burn anything, check with your local fire department or forest ranger station to see if a burning permit is required. In many areas of the state, a burning permit is required when the ground is not snow covered.

"If you wait until the snow is all gone and it's too dry, you may not get a burning permit," added Meyer.

Ice anglers are reminded that the game fish season is now closed on most Wisconsin waters and ice fishing shelters must be removed soon, Department of Natural Resources' fisheries regulations specialist Hal Schwenn said.

* Ice fishing shelters had to be removed by March 5 from inland waters south of Highway 64 and from Lake Michigan waters (except Green Bay) south of Highway 64.

* Ice fishing shelters must be removed by March 15 from inland waters north of Highway 64, from Lake Michigan north of Highway 64, and from Green Bay and Lake Superior.

"Anglers can still use portable shelters after these dates," noted Schwenn, "as long as they are actually fishing in them. Portable shelters must be removed when they're not occupied."

Schwenn advises anglers to check the DNR 1988 Fishing Regulations pamphlet for a listing of state waters which offer year-round game fishing angling.

If ice conditions should deteriorate rapidly, resulting in unsafe conditions, the Department has authority to order that shelters be removed before March 15 on northern waters.

Overweight Trucking Will Be Suspended During Spring Thaw

Movement of overweight loads on Wisconsin highways is banned as of daylight Sunday, March 13.

The state Department of Transportation has temporarily suspended the overweight provisions of all trucking permits issued on an annual basis in order to protect roads during the spring thaw.

Thomas Cantwell, chief of motor carrier services in the Division of Motor Vehicles, said the suspension is due to unstable conditions of roadway subgrades in the springtime, when frost is melting and the ground is wet.

During the period of suspension, the DOT may consider requests to move loads which exceed statutory restrictions on a single-trip basis if investigation finds that the roads will not be damaged. Cantwell said single-trip permits will not be issued to loads that can be divided and hauled on more than one truck, such as pulpwood and raw forest products, garbage and refuse, recyclable scrap, grain or coal.

Cantwell said single-trip permits are valid only for state highways, and separate permits must be obtained from local authorities if county or town roads are involved.

The DOT will reinstate the overweight permit provision when the highway subgrade conditions stabilize.

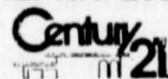
