## Bel-Ric Lots Re-zoned for Apartment Building

### Board Okays Sewer, Water Construction For Bonnie Lane and Fond du Lac Ave.

Following a public hearing Monday night, the Kewaskum Village Board voted to proceed with the construction of sewer and water mains and lateral stubs for twenty properties along Bonnie Lane and five properties on the north end of Fond du Lac Avenue.

The work will be done by Globe Construction at a cost of \$236,535. The cost of the project will be assessed in full to the affected property owners who will have up to ten years to pay for the assessments.

The residents along Bonnie Lane had petitioned and received permission to annex from the Town of Kewaskum so they could hook up to the village's services. Several properties in the area had been experiencing septic problems.

In other action the board approved the re-zoning and combining of three lots in the Bel-Ric Subdivision from a two-family (duplex) district, to multi-family district which will

allow Claude Johann to construct a six-family apartment building on the property.

Despite the fact that almost all of the neighbors adjacent to the property voiced their opposition to the request, the rezoning was approved. One woman noted that when they moved into the area the lots were zoned single-family, then they were re-zoned to duplex and now they were being re-zoned again for an apartment.

Some of the neighbors indicated they were opposed to the plan because the area is surrounded by single story one-family residents. It was also noted the building would be at the end of a dead-end street which is yet to be completed causing all its traffic to feed back into Bel-Ric Drive and Lazy Lane.

Some of the trustees indicated that while the homeowners had brought up some good points, they did not have a strong enough case to persuade the board to deny the

request.

In other business the board awarded a slurry seal contract to Struck and Irwin in the amount of \$14,180.

Public Works Superintendent Augie Bilgo advised the board that the village was "back to square one," with grass clippings. He said residents were bringing their clippings up to the municipal garage by the bags and boxes. Bilgo noted some of the bags were beginning to heat up and smoke. "It's not conducive to a good environment, its stinky and drawing bugs," he stated.

Bilgo told the trustees he did not know what the answer to the problem was. "I wish there was any easy solution," he said. It was said that farmers do not want to take the clippings because of the possibility of toxic chemical residue. Some farmers might consider taking them but they are leery in the event the DNR would decide to come in and test them.

Water Pollution Control Superintendent Pete Albers told the board, "there are no rules governing grass clippings now, but I can guarantee you that they are coming." He indicated that would probably mean the same kind of testing he is now required to do for the dumping of sludge on farm fields.

Trustee Larry Williams told fellow board members he felt it was time to look at the entire issue of the village's recycling program and make some decisions. "Well we've been 'thinking about this' for a couple of years," said Trustee Mary Krueger, "it's about time we do make a decision."

Bilgo noted one solution would be for residents to cut their lawns more often and leave the clippings on the lawn as he had suggested at past meetings. "They keep telling us the clippings are good for the lawns so why not leave them there." It was also suggested that people who want to bag their clippings should pay to have them taken away.

For the present the board decided to advertise for someone to present a proposal for the disposal of the clippings. If no other alternative is found, noted one of the trustees, we'll just have to refuse to pick up the clippings just like we had to do with old tires.

Trustee Gary Gavin advised the board there is a change in library hours. Effective immediately, the library will open at 10:00 a.m. on Fridays, instead of 12:00.

# New Wood Chipper Cuts Down On Storm Clean-Up Work

The Kewaskum Village Board knew it was going to need a wood chipper in the future when it gave Village Administrator Dan Schmidt and Public Works Superintendent Augie Bilgo permission to 'shop around' for the equipment. But no one knew how soon that need would arise.

Approximately a week and a half before that unforgettable May 10th snowstorm, village officials had a chipper in town for demonstration purposes. It

was agreed that the equipment could do the job, however, no one was in a hurry to make a purchase.

Things changed rapidly that memorable Thursday morning. "I got permission from a majority of the board members, called the company and bought the chipper over the phone," said Schmidt. "I even had to do it on a pay phone because our lines were out." It wasn't until the storm had passed and people began to clean up, that anyone really knew the extensive damage done to the

community's trees.

Anyone passing through town the past week has probably seen the \$16,000 chipper in action. Bilgo said the equipment is really reducing the size of the huge clean-up job. Village crews had already chipped up 15 truckloads of branches and brush from the storm. Bilgo stated those 15 loads of chips represented what would normally have been 45 to 50 truckloads of branches they would have had to haul away.

Another good thing, noted Bilgo, is the fact that people are

coming to us to get the wood chips. This is also helping reduce the problem of where to go with the end product.

Because the tree damage was so extensive, Bilgo estimates it will be another two to three weeks before all the brush in the village is cleaned up. He asks that the residents be patient and crews will get to everyone.

Bilgo also asks that the branches be stacked uniformly, with all the branches placed lying in the same direction. If not, the brush becomes knotted and tangled together making them almost impossible to feed into the chipper shoot. If that happens, the brush is left at the curb.

## Ignoring Hearing Loss Isn't Illegal, Just Illogical

Richard Dysart, star of the popular TV series "L.A. Law," is not afraid to admit he has a hearing loss. But he doesn't have a hearing problem any more, thanks to the hearing aids he wears.

As national chairman for the Better Hearing and Speech Month Campaign, Dysart launched the 1990 campaign on May 1 to bring a message of hope and help to those with hearing and speech problems.

"It is exciting to have Mr. Dysart lead our campaign this year," said Debra Hoops of the Beltone Hearing Aid Service Center, a local representative for Better Hearing and Speech activities in Kewaskum. "During May, we want people to learn more about hearing or speech difficulties, and where they can turn for professional help," she added.

"On an episode of 'L.A. Law' last season," explained Hoops, "Dysart's character Leland was reluctant to argue a legal case. When he realized his reluctance stemmed from an undiagnosed hearing loss, he was fitted with a tiny canal-size hearing aid and went on to win the case."

"I understand from Mr. Dysart," said Hoops, "that he has a hearing loss in real-life, and he wanted to be able to wear it on the set."

Public acceptance of hearing instruments is vital, industry officials say. More than 16 million Americans have aidable hearing loss, yet only 4 million currently wear hearing aids. "Too many people are letting hearing loss affect their school work, social life and careers," says Hoops. "Our mission this month is to test as many people as possible to uncover hearing problems, because in many cases, hearing problems can be cleared up quickly with medication or helped with hearing aids."

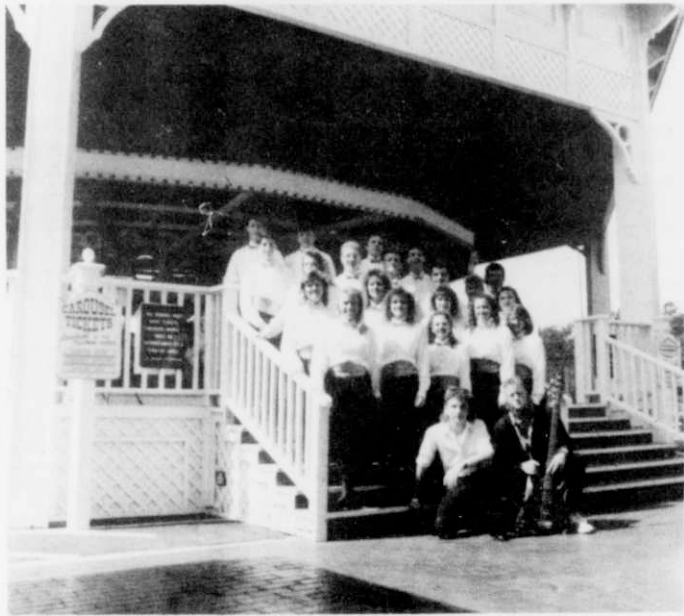

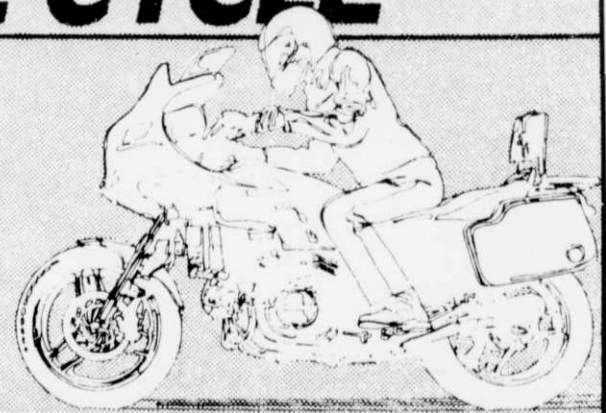

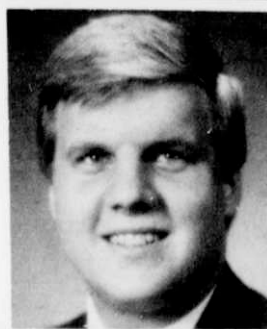

## Proper Planting Helps Ornamental Trees Help the Environment

MADISON, WI — Spring is a good time to plant trees, according to Department of Natural Resources foresters. And more than two million ornamental trees are planted in Wisconsin each year, providing benefits such as wildlife habitat, energy conservation and increased oxygen to the environment.

"Trees are helpful in combatting the greenhouse effect because they use carbon dioxide and release oxygen," said Trent Marty, nursery coordinator for the DNR's Bureau of Forestry.

In order to maximize the benefits of trees, however, they must be properly planted. The American Forestry Association (AFA) estimates that properly planted young trees grow twice as fast and will live twice as long as trees that are improperly set out.

Guidelines for planting trees have changed recently because of the heavy earthmoving equipment that is used nowadays to construct houses, according to the AFA. Soil in most yards is less fertile and more compacted than before; trees planted in dense soil often grow no farther than the shallow hole originally dug for

them.

When trees are trapped in a small hole without fertile surrounding soil, "They will grow around and around inside the hole until they eventually almost choke themselves to death," said Marty.

Instead, the association suggests digging a "planting area." A planting area should be marked out that is five times the diameter of the planting ball; then the topsoil should be mixed with a rototiller or shovel in the entire area to a depth of six to eight inches. If fertilizers are added, they must be distributed evenly throughout the whole area.

The balled tree should be placed in the center of the prepared area on solid ground. The tree should be positioned perpendicular to the ground, with the ball level with the existing soil.

After the tree is set in, the root area should be covered with backfill, but not overpacked. Water can help the soil settle in the area. Raking soil over the area and using a mulch of bark, wood chips, old sawdust, pine needles, or leaf compost will protect the newly planted tree.

Some trees may need to be

held by a stake and rope, although these securities should be attached lightly because some swaying in the wind is necessary to strengthen the trunk. After one year, the support rope should be removed.

Marty said the best season to plant trees is early spring and late fall when there is moisture in the ground. "As soon as the frost is out of the ground, no matter how chilly the weather is, trees can be planted."

Choosing a planting location is imperative to the health of a tree. When locating a planting site, make sure there's adequate space to accommodate the future size of the tree.

While trees benefit from proper site location, homeowners also can reap benefits from strategically located trees. Large evergreens (pine, spruce or fir) can block a house from cold winds when planted on the northeast section of the lot. Strategically located deciduous trees can block the sun during the summer and then, after shedding their leaves, allow sunlight to shine through during the winter.

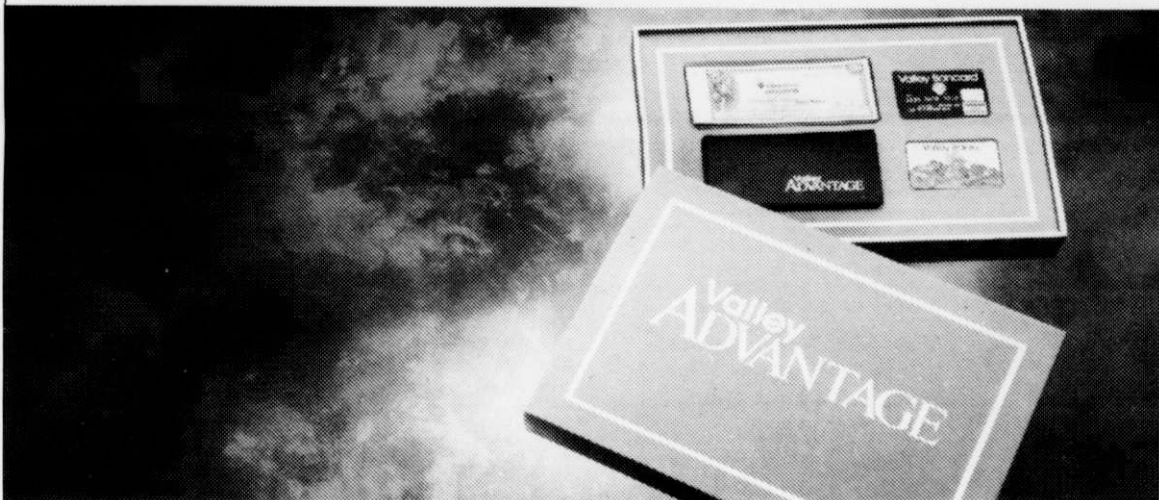

STATE TRUST FUND LOAN FOR THE PURPOSE OF VILLAGE PUBLIC IMPROVEMENTS

FORM OF RECORD

The following preamble and resolutions were presented by Trustee Gary Gavin and were read to the meeting.

By the provisions of Sec. 67.12(12) of the Wisconsin Statutes, all municipalities may borrow money for such purposes in the manner prescribed, and,

By the provisions of Chapter 24 of the Wisconsin Statutes, The Board of Commissioners of Public Lands of Wisconsin is authorized to make loans from the State Trust Funds to municipalities for such purposes. (Municipality as defined by Sec. 24.60(2), Wisconsin Statutes, means a town, village, city, county, public inland lake protection and rehabilitation district, town sanitary district created under s. 60.71 or 60.72, metropolitan sewerage district created under s. 66.22 or 66.882, joint sewerage system created under s. 144.07(4), school district or vocational, technical and adult education district.)

THEREFORE, BE IT RESOLVED, that the Village of Kewaskum in the County of Washington, Wisconsin, borrow from the Trust Funds of the State of Wisconsin, the sum of Two Hundred Sixteen Thousand Dollars (\$216,000.00) for the purpose of public improvements, such as water and sanitary sewer utility main and lateral extensions, and for no other purpose.

The loan is to be payable within ten (10) years from the 15th day of March preceding the date the loan is made. The loan will be repaid in annual principal installments with interest at the rate of 6.25 percent per annum from the date of making the loan to the 15th day of March next and thereafter annually as provided by law.

RESOLVED FURTHER, that there shall be raised and there is levied upon all taxable property, within the Village of Kewaskum, in the County of Washington Wisconsin, a direct annual tax for the purpose of paying interest and principal on the loan as they become due.

RESOLVED FURTHER, that no money obtained by the Village of Kewaskum by such loan from the state be applied or paid out for any purpose except the water and sanitary sewer utility main and lateral extensions without the consent of the Board of Commissioners of Public Lands.

RESOLVED FURTHER, that in case the Board of Commissioners of Public Lands agrees to make the loan, that the president and clerk of the Village of Kewaskum in the County of Washington, Wisconsin, are authorized and empowered, in the name of the village to execute and deliver to the Commission, certificates of indebtedness, in such form as required by the Commission, for any sum of money that may be loaned to the village pursuant to this resolution. The president and clerk of the village will perform all necessary actions to fully carry out the provisions of Chapter 24 and Sec. 67.12(12), Wisconsin Statutes, and these resolutions.

RESOLVED FURTHER, that this preamble and these resolutions and the aye and no vote by which they were adopted, be recorded, and that the clerk of this village forward this certified record, along with the application for the loan to the Board of Commissioners of Public Lands of Wisconsin.

## BUCKLE UP AMERICA WEEK

Governor Tommy Thompson has declared the week of May 21-28 as "Buckle Up America! Week," part of a national campaign to draw awareness to the need to use safety restraints in vehicles.

Sheriff Robert H. Schulte joins the governor in urging all residents to use safety belts. Wisconsin's seatbelt law is weak, so it is up to individuals to use common sense and use safety equipment.

"Our deputies have seen many accidents in which people were saved because they were wearing a seatbelt. They have also seen people who needlessly suffered injuries because they didn't," the sheriff stated.

It is especially important that parents keep their children buckled-up, and smaller children and infants in their safety seats. Vehicle crashes

are the leading cause of death of children over six months of age.

During "Buckle Up America! Week," deputies will take note of vehicles in which occupants are properly restrained, and submit the license plate numbers to Madison. The vehicle owners will receive a special award from the Department of Transportation, acknowledging their use of seatbelts.

The US Department of Transportation estimates that 15,500 lives have been saved by the use of safety belts since 1983. The use of the belt can reduce the risk of a fatal or serious injury by between 40 and 55%. It is clear that everyone benefits from the use of safety belts. The question is: why do so many people refuse to use them?

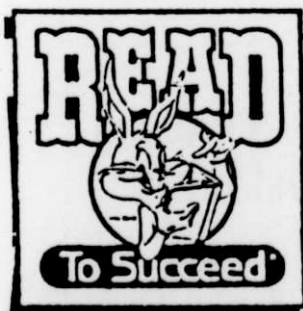

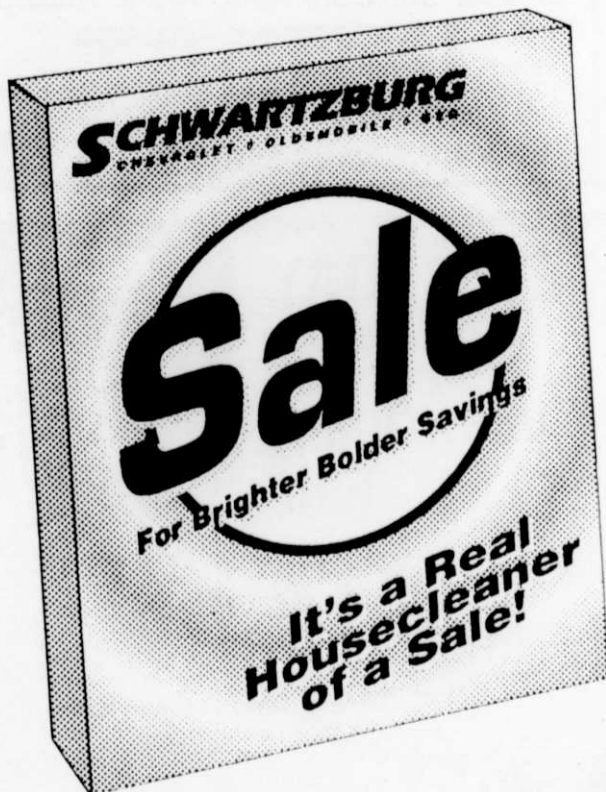

## State Supt. Grover Announces Chapter 2 Allocations

MADISON — Wisconsin school districts and other education providers will share approximately \$7 million in federal Chapter 2 grants, according to an announcement by State Superintendent Herbert J. Grover.

Kewaskum School District was allocated \$7,810; West Bend School District, \$30,952; Fond du Lac School District \$52,804, and Campbellsport School District \$7,456.

The state's allotment is down about 1.6 percent from last year's award of \$8,851,135. For 1990-91, Wisconsin will receive \$8,710,268 of which local education agencies will share \$6,968,214. Twenty percent of Chapter 2 funds remain with the Department of Public Instruction to provide state-level activities.

Develop other innovative projects that would enhance school educational programs and climate.

The DPI computed grants using a distribution formula approved by the Wisconsin Chapter 2 State Advisory Committee in March. The Formula, which is the same as this year's distributes funds based 50 percent on enrollment, 47 percent on the number of families receiving Aid to Families with Dependent Children, and 3 percent on a sparsity factor calculated from the number of students per square mile.

School districts must apply to the DPI for Chapter 2 funds. Private schools can receive Chapter 2 money by participating through public schools.

The DPI uses its Chapter 2 funds to support activities related to the six targeted assistance programs, to administer the Chapter 2 program, and to support educational improvement projects.

"The Chapter 2 program is one of the best offered by the federal government because it supports creative and innovative activities on the state and local levels," Grover said. "The Academic Decathlon, Arts World, Science World, Teacher World, several Families in Education activities, and other special activities would not be possible without Chapter 2 support."

The Chapter 2 law and regulations list six targeted assistance programs eligible for Chapter 2 funding. They include the following programs:

Meet the educational needs of children at risk of failing in school or dropping out and students for whom providing an education exceeds average costs.

Acquire instructional and educational materials.

Provide schoolwide improvements, including effective, schools programs.

Provide training and professional development for school staff members.

# Indian Girls Win Conference Championship

CHILTON — When the going gets tough, the tough get going, and when the Kewaskum girls track team got going at the Eastern Wisconsin Conference track meet here, last Thursday, they couldn't be denied the championship.

After finishing second to the New Holstein girls squad twice in two weeks, the Indians got their revenge against the Huskies in the conference meet, as they outran their rival to the North, and won the conference championship.

Kewaskum finished with 114 points, while the Huskies were second with 106. Plymouth was next with 93, followed by Two Rivers with 79, Kiel with 43, Sheboygan Falls with 27, and the hosts, Chilton, with 25.

"It feels pretty good," KHS head coach Perry Koth said of the victory. "I've seen a lot of teams in my ten years of coaching that had a chance to win it (conference championship), but eventually feel short. So this was like a real relief."

Due to the cold and windy conditions, Koth didn't expect to see any real good times rolling in from his girls, but Melissa Braun pleasantly surprised her coach in the trials for the first event of the meet, the 100 dash.

"Melissa Braun started it all," Koth was quick to point out. The junior sprinter set a new KHS record by running a 12.7 in the prelims, and eclipsed her own personal best this year by a half-second. "She

really worked hard towards that goal (setting the 100 record)," Koth said. "From that point on, it (the team successes) just kept coming. The girls really started believing that they could do it."

Braun went on to win the 100 in 12.8, and then went out and set another KHS record in winning the 200 dash, finishing in 26.6, almost a second and a half better than her previous best time. Braun capped off her day by helping the 800 relay team to a first-place finish. Braun, along with Tina Schwartz, Kelly Korth, and Kristi Lubahn, ran the race in 1:51.1.

Lubahn also had a key role in the Indians' success. The senior standout continued her dominance in the 300 hurdles, winning easily with a time of 49.1. But it was in the 1600 relay, the last event of the meet, where Lubahn showed what she was made of.

Just a week earlier, Lubahn came from about 30 yards behind to beat New Holstein's anchor runner in a triangular in Kewaskum. It was deja vu on Thursday, as Lubahn, down about 25 yards when she received the baton, did her thing.

"We were down about 30 yards after the first leg," Koth explained. "New Holstein's coach came up to me and said, 'Well coach, you gonna catch us again today?'. Then (Rachelle) Zuehlke really really cut into the lead on the third leg, and Lubahn took over and she would

not be denied."

Lubahn, along with Zuehlke, Laurie Vogt and Nicole Doherty finished the race in 4:17.8, the team's best mark of the year, to win going away. "It was a nice way to finish," said Koth. "It just proved that we deserved the championship... that it wasn't a fluke."

Lubahn and Braun weren't the only Indians turning in superb performances, though. Pam Osterbrink tied her own school record once again as she won the high jump competition, clearing the 5'2" mark. That event was rather profitable for the Indians as Ingrid Ankerson went over the 4'10" mark, good enough for a third place tie.

Ankerson, along with Tammy Michaels also picked up some valuable points in the triple jump. Ankerson leaped 32'2", and Michaels 32'0", both marks representing personal bests, as the two netted third and fourth place finishes in the event. Michaels also added a third in the long jump, going 15'1.5".

"That was one of many places where we did better than what we have all year," Koth said, discussing the triple jump finish. "I was real pleased to see that."

Tina Weddig also brought home a couple of places in the weights. The senior threw the shot put 33'6", good enough for sixth, but also added a second in the discus, coming up with a 110'1" toss.

The Indians' 400 meter relay team, consisting of Rachel

Gosa, Schwartz, Korth and Stacey Heberer finished second, coming in at 53.8, a full second behind Plymouth's winning effort. Gosa also managed a fifth in the 100 dash, crossing in 13.6.

Zuehlke and Doherty teamed up for a double place in the 400 dash, with Zuehlke taking third (1:04.8), and Doherty fifth (1:05.6).

Two other key runners for the Indians were Vogt and Christa Schmidt. Vogt came through with a big fourth place finish in the mile, coming in at 5:45.9, while Schmidt took fifth in the 100 hurdles with a 17.6 time.

"That was a big surprise," Koth said of Schmidt's performance. "Her times have been steadily dropping. She just learned the four-step method, and that usually takes a while to develop. But everything just started clicking for her, and she really surprised us."

There were no surprises for the Indian boys team unfortunately. The young, inexperienced team didn't fare well at the conference meet, only accumulating a total of seven points in the meet, and had to settle for last place. New Holstein ran away with the championship, winding up with a whopping 166 points.

The bright spots were few and far between for the Indians though. Kim Marx, however, did take a fourth for Kewaskum in the 300 hurdles, finishing with an excellent time of 42.7, a personal best, against some strong competition.

Randy Schlice had the other individual place for the Indians, clocking a 11.6 in the 100 dash, which placed him fifth.

Schlice and Marx teamed up with Aaron Miller and Rob Kertscher to come in with a sixth in the 400 relay. The foursome crossed the finish line in 49.9, a time somewhat deceiving because the team dropped the baton on one of its handoffs, causing for a valuable delay.

The Indian boys finished with 18.75 points in the meet, which was won by Eastern Wisconsin Conference member Sheboygan Falls, who had 126.75 points.

Hurdler Kim Marx ran a 42.5 in the 300 intermediates to finish second and earn a trip to Elkhorn. Marx's time was more than a second slower than the first-place finisher, and the sophomore just edged out Sheboygan Falls' Dan Schmitz by .1 of a second to place second.

Marx teamed up with Randy Schlice, Aaron Miller, and Rob Kertscher to place fourth in the 400 relay. The foursome's time of 46.5 however, was more than a second slower than the top two qualifiers.

## Indian Girls Capture Regional Championship

PEWAUKEE — The Kewaskum girls' track team continues to pile up an impressive list of championships this season. The last of which came here, Monday afternoon, when the Indians won the Pewaukee Regional.

The Indians finished with an impressive 142 total, beating out a tough Slinger squad, who finished with 124. Sheboygan Falls was a distant third with 66, followed by Brown Deer 53, Pewaukee (46), Campbellsport (29), Random Lake (16), St. Francis (12), and West Milwaukee (8). The top two finishers in each event automatically qualified for the Sectional meet, which is to be held Thursday, at Elkhorn.

Once again, the duo of Kristi Lubahn and Melissa Braun had a major role in the Indians' success. Lubahn set a new school record in the 300 hurdles when she crossed the line in 47.4, breaking the old record of 48.0. Lubahn finished almost two seconds ahead of the second-place finisher.

Lubahn, along with Rachelle Zuehlke, Laurie Vogt and Nicole Doherty, won the 1600 relay in 4:15.3, the unit's best time of the year by far. But KHS head coach Perry Koth feels that the group can lower its time even further.

"There's some things we can do to bring that time down even more," said Koth, noting that the unit's handoffs are as crisp as they could be. "We're going to work on that."

Lubahn and Braun teamed up with Tina Schwartz and Kelly Korth to set a new school record in the 800 relay as well. The foursome was pushed hard in the race by Brown Deer's team,

but came out on top with a time of 1:48.4, breaking the old record of 1:49.9. "That was some race," Koth noted.

Braun didn't stop there, however, as she accounted for three Indian firsts in all. The junior speedster also won the 100 and 200 meter dashes with times of 12.8 and 26.8, respectively. Her teammate, Rachel Gosa was right behind her, finishing second in 13.4 to also qualify for sectionals.

"She's really coming on," Koth said of Gosa, who has been right up there all year. Concerning Braun's efforts, he said "Melissa is really peaking right now. She's really got a good chance (to go to state)."

Koth got a pleasant surprise from his triple jumpers, Ingrid Ankerson and Tammy Michaels, who finished 1-2 in the event. Ankerson's leap of 30'9.5" and Michaels' effort of 30.7" weren't even their best of the season, and are considered pretty average, yet the two will be headed to Elkhorn.

Ankerson also qualified in the high jump, where she cleared a personal best 5'0", which was good enough for second place. While Koth was happy to have Ankerson qualify, at the same time he felt a bit sad that the Indians' top high jumper all year, Pam Osterbrink, did not qualify after she missed on one of her jumps.

Tina Weddig also took home a first, hers coming in the discus. Weddig threw a 116'0" in the preliminaries and automatically qualified for the sectionals. Weddig came up a bit short in the shot put, settling for a fourth place finish, but in the same event, Kewaskum's Marlene Wodsedalek tossed the shot 33'0", which was good

enough for second and a trip to the sectionals.

In addition to Osterbrink, the Indians had a couple of other disappointments, the biggest being Zuehlke's near miss in the 400 dash. Zuehlke ran an excellent time of 62.8, but she was just edged at the wire by Campbellsport's sensational freshman, Andrea Bertone, who crossed in 62.4.

"That was a real tough one," Koth said, dejected. "She's worked so hard at it, and to just fall short like that is just real disappointing."

Another race where the Indians just missed qualifying in was the 400 relay. The team of Stacey Heberer, Korth, Schwartz and Gosa "had a couple of bad handoffs," according to Koth, and were eventually nipped at the wire by Slinger, 53.3 to 53.7, therefore falling into third. Brown Deer won the event in 52.5.

Michaels and Vogt also came up just short in their bid to qualify, both coming in third. Neither Michaels' leap of 15'-2.25" in the long jump, and Vogt's 5:55.8 in the 1600 run were enough to grab a top two finish.

Christa Schmidt, who has come to strong in the final weeks of the season, finished fifth in the 100 hurdles, with a nice time of 17.8. Schmidt just recently switched to the four-step method in the event, and according to Koth, really picked it up well.

The Indians recorded two other fifths in the meet, one each from Doherty and Lora Delcore. Doherty ran a 65.5 in the 400, while Delcore had a throw of 86'1.5" in the discus.
