This year things will be a little different. The friendly people of Kewaskum are inviting fellow Wisconsinites to put down their rakes, "just say no" to window caulking, and join us for Kettle Kountry Kolors, our first of a kind, two-day fall festival being held Saturday and Sunday, October 13th and 14th from 10 a.m. to 6 p.m. in Riverhill Park. Kewaskum is located between Milwaukee and Fond du Lac, in the very heart of the beautiful Kettle Moraine area. Visions of past, present and future entwine along the banks of the Milwaukee River at Kewaskum's Riverhill Park. Mingle among the Civil War and Buckslanders encampments, and listen to the thunder of an original 1847 cannon being fired every hour. Wind your way through the sounds and smells of an open market of antique dealers, original artisans and crafters, along with various retail booths.

Hop on the free hayrides for a ride through breathtaking colorama or the pony rides or just sit back and watch hot air balloons (weather permitting) as they ornament autumn skies. Now pick up the pace and try the Hon-E-Kor Hole-In-One Golf Contest. Sink an ace and take home a prize of \$500. Every green shot qualifies you for the drawing for a free Hon-E-Kor membership. Move on to an old fashioned bingo game being played throughout the day. Then start your engines... and find out if you're a mouse or a rat as the Washington County Dairy Promotion Committee presents a Cheese Chase Car Rally-Poker Run on Saturday from 10 a.m. to 4 p.m. You will wind your way through some of the state's most brilliantly blazing scenery, through small towns tucked in kettles formed by the great glaciers an ice age ago. Your lucky poker hand could even net you \$100, \$75 or \$50, plus many cheese prizes donated by the cheese merchants scattered throughout the area. But hey, where did the kids go? They're in the "Great Pumpkin Patch" picking their favorite pumpkin decorated especially for the pumpkin painting contest and trying their luck at guessing just how many pumpkin seeds there could possibly be in that big pum-

kin. Maybe you'll find them working on Halloween wind-socks, or making an their own original design t-shirt in the Children's Creative Art Center. The kids might be sitting in front of Karen Hartman's booth spell-bound as she teaches them the ways of the Indian and their relationship with Mother Earth or helps them make a friendship bracelet. Perhaps they might even have entered the Pretzel Eating Contest or (heaven forbid) the Blindfold Pudding Eating Contest, both being held on Saturday. They won't want to miss the Big Wheel races on Sunday either. Of course, a country festival's not complete without some toe-tapping music provided by the Buchel-Klass Orchestra on Saturday with a live radio broadcast from WTKM. And Sunday, The Bear Creek Band, will keep everyone jumping with their 50s-60s and Country Western sound. There will be another live radio broadcast on Sunday from WBWI.

Local Coast-to-Coast Owners Buy KL Home and Hardware

Larry Williams confirmed Monday, that he and his partner Ken Weddig, have sold their business KL Home and Hardware to Dick and Loretta Schroeder, owners of the Coast-To-Coast Hardware stores in Kewaskum and Campbellsport. Williams said negotiations had been taking place on an on-off basis for several months. "Then last week everything seemed to fall into place in three days," stated Williams. "If all goes well and there are no last minute hitches, we should have a final closing on the sale in two to three weeks," he said. Williams said KL is holding a going-out-of business sale which is on right now and will run until October 20th. Dick Schroeder verified

Williams' statement. Schroeder said the need for more room was the reason he wanted to acquire KL. "It's basically an expansion move," said Schroeder, we wanted to expand especially our lawn equipment lines and for that we need more display area." Schroeder said he would also add items to his store line such as lumber and some building supplies similar to what KL handled. Dick said he was not sure exactly when Coast-To-Coast will move into its new quarters. "It depends on when the sale is finalized and then we will see how things go from there." Schroeder said he will also continue to operate the Campbellsport store. There will be no major changes he noted, just a relocation of our Kewaskum store to larger quarters.

School Board Approves Tax Levy

The Kewaskum Board of Education gave its stamp of approval to final figures for the 1990 tax levy. The total levy, including debt service, is \$4,509,850. District Administrator Dr. David Heather advised the board that two changes did affect the final figures somewhat. The first item was the district's need to increase the Debt Service Fund by \$14,436, to reflect 1991 interest payments on the new \$200,000 loan. The second item was the fact that the district's equalized valuation rose more than Heather's projected 2%. "The Kewaskum School District's equalized valuation rose 3.25% over last year," stated Heather. The end result is that the levy's mill rate will be slightly lower than the \$16.50 projected by Heather this summer. While the final 1990 mill rate will be \$16.36 per \$1,000 of assessed valuation, it is still 6.51%, or \$1.00 per \$1,000 higher than the 1989 levy rate. Based on the new levy figures, property owners of a \$50,000 home will see their school taxes go up \$50, from \$768 to \$818, on a \$70,000 home \$70, from \$1,075 to \$1,145 and on a \$90,000 home \$90, from \$1,382 to \$1,472. Board member Paul Seymour expressed his concern with the budget and its levy. "I honestly have not had anyone in my area

complain, but I feel guilty," he stated. "We bat around negotiations, insurance, funding, and we don't seem to get anywhere. A 6.51% levy increase seems palatable, but not a 12% increase in expenditures." The vote on the levy's approval was 5-2, with Seymour and fellow board member Perry Ankersen voting against it.

Board of Education Okays Expansion of Quest Program

The Kewaskum Board of Education approved Curriculum Coordinator Connie Strand's request to expand the elementary school 'Quest' program to include the first through fourth grades.

The district presently implements the BABES program for Kindergarten and the Quest program for fifth and sixth grade students. We would like to complete the program by adding the 1-4th grades "Skills for Growing" segment, noted Strand.

Board member John Schulte again, in a lengthy rationale, voiced his concern with the program, some of the things it teaches and the methods used to teach them. Schulte noted he had attended portions of the teacher in-service training program and, while he was not totally against the proposed segment, there were things that bothered him. "I would like to see the drug portion of the program set aside," said Schulte. He felt the youngsters were being "over informed at a young age." "The two things I have a problem with are one, the drug part of it and two, the socialist aspects."

Board member Ruth Schmitt told the meeting, "I too, attended the training sessions and I do not share Mr. Schulte's views." Schmitt stated, "I think

it is an outstanding program and our district will be enhanced because of it."

Two parents who serve on the district's Human Growth and Development Committee spoke strongly in favor of the program. "I'm probably one of the most conservative people in the world regarding this type of education," said Ann Enright, "but I feel this is a good program." "At the Human Growth and Development Committee's general meeting it was agreed to recommend this for board approval tonight."

Gayle Van Ess told the board, "I feel it is extremely positive and promotes family involvement."

Strand informed Schulte the state is mandating a K-12 drug and alcohol abuse program which must be in place by this school year. "If we remove the drug portion, we could be in danger of losing our federal funding." If some of the agencies came in to audit us, we could be in real trouble, she noted.

After hearing all the comments, the request was approved 6-1, with Schulte abstaining from the vote.

On behalf of the school district, Administrator David Heather and School Board president Neal Weare accepted a check for \$1,300 from the Kewaskum Lions Club as their contribution in supporting the

Quest program in the district. The money is used to purchase materials and defray teacher training costs. The check was presented at the meeting by club vice-president Clayton Stautz.

In other action the board approved several recommendations of the Finance-Transportation, Buildings and Grounds Committee. They included the purchasing of replacement intercoms for Farmington Elementary and Kewaskum Middle School at a cost of \$11,018, replacement of blinds, part of a three-year program, for KHS, KES and FES, at a cost of \$3,721, replacement of the KHS cafeteria folding door, \$3,814, and replacement of the Ag Shop north garage door \$1,690. All projects were budgeted items.

The committee also passed on the recommendation of its project engineering firm, Bray and Associates, to reject all the bids received on the KES ceiling repair project and to re-bid the work in November. Although one company had come in with a viable bid, its references appeared to be insufficient and since the firm was from out of state, it was felt rebidding was the best way to proceed.

The board also approved the re-hiring of three instructional aides who had worked for the district last year, hiring Mrs. Grace Wright as extended day kindergarten teacher, Fran Lider as FES intramural coach, O/M team coaches for 1990-91, a Gymnastics coach and

assistant coach.

In other business the board approved Heather's request to temporarily borrow \$1.4 million, short term, for cash flow purposes, the purchase of a replacement van at \$6,600 for the Maintenance Department and the sale of the old 1976 van.

KMS principal David Jones gave a report on this year's Summer School program. He stated the program was again a success with 195 students from both the public and parochial schools attending. He suggested that for next year, the board consider providing bus transportation which might help to get more students into the program. He recommended pick-up points rather than an extensive route system. He also noted consideration was being given to expanding the program from two to three periods.

Heather was questioned about the school district survey. He said 430 or 13% of the 3,200 questionnaires have been returned and the results will be published October 26th.

special demonstrations held both days, as Karen shares stories and explains the meaning of each part of the bracelet. Her wit and wisdom attract just as many adults, and kits will be available for everyone for just one dollar.

Her Native American display has traveled to several classrooms - items such as - basketry, birch bark, beadwork, bone carvings, horn, feather, furs, raw materials and quill work teach children to appreciate Indian culture and more importantly to understand the importance of preserving and respecting a heritage. Hartman brings each child closer to realizing the valuable role each one of them play as keepers of the earth. She

explains how raw material becomes a finished product without waste, using the buffalo as an example. Every part of the animal's body was eaten or used to make a functional item. Karen's husband Dave has made several pieces for her display.

For the past six years Karen has taught classes in beadwork - traveling to people's home or wherever the call arises. Her garage has been converted into a studio - with plans to someday teach classes there in beadwork, and hopefully silversmithing in the future.

Friendship bracelet demonstrations will take place Saturday at 1 p.m. and Sunday at 3 p.m. at Kettle Kountry Kolors. Karen Hartman's booth will be located on the south side of the bandstand, and is being sponsored by Sentry Foods of Kewaskum.



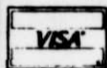

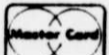

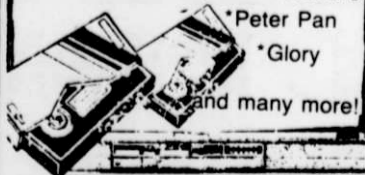

Bridge Closed

The "Young America Bridge" has been closed by the state after an inspection deemed it unsafe for automobile traffic, according to Barton Town Board Chairman Merlin Prost.

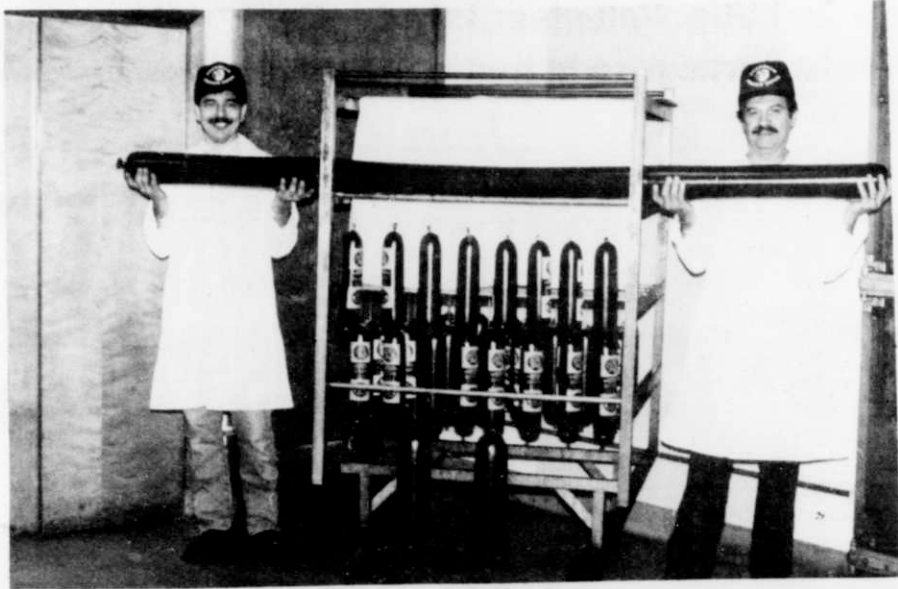

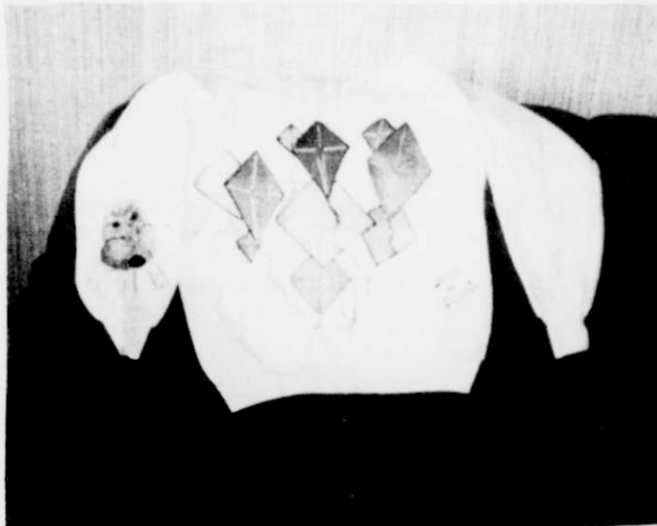

SOFT PRETZELS
Diane Shreves

1 pkg. active dry yeast
1/8 c. warm water (105° for yeast)
1 1/2 c. warm water
1/2 c. brown sugar
5 c. flour
coarse salt

Dissolve the yeast in 1/8 cup water. Stir in 1 1/2 cup warm water, brown sugar, and flour. Beat until smooth; then knead until the dough is smooth and elastic. In a saucepan, measure 2 tablespoons baking soda to each cup of water, until the pan is filled. Bring to a boil. Break off pieces of dough the size of a lemon. Roll dough into pencil shapes, and twist into pretzels. Place twists into boiling water for 15 seconds, until dough is golden yellow. Remove, and place on a salted cookie sheet: salt tops of pretzels. Bake in a preheated 475° oven for about 8 to 10 minutes, and serve.

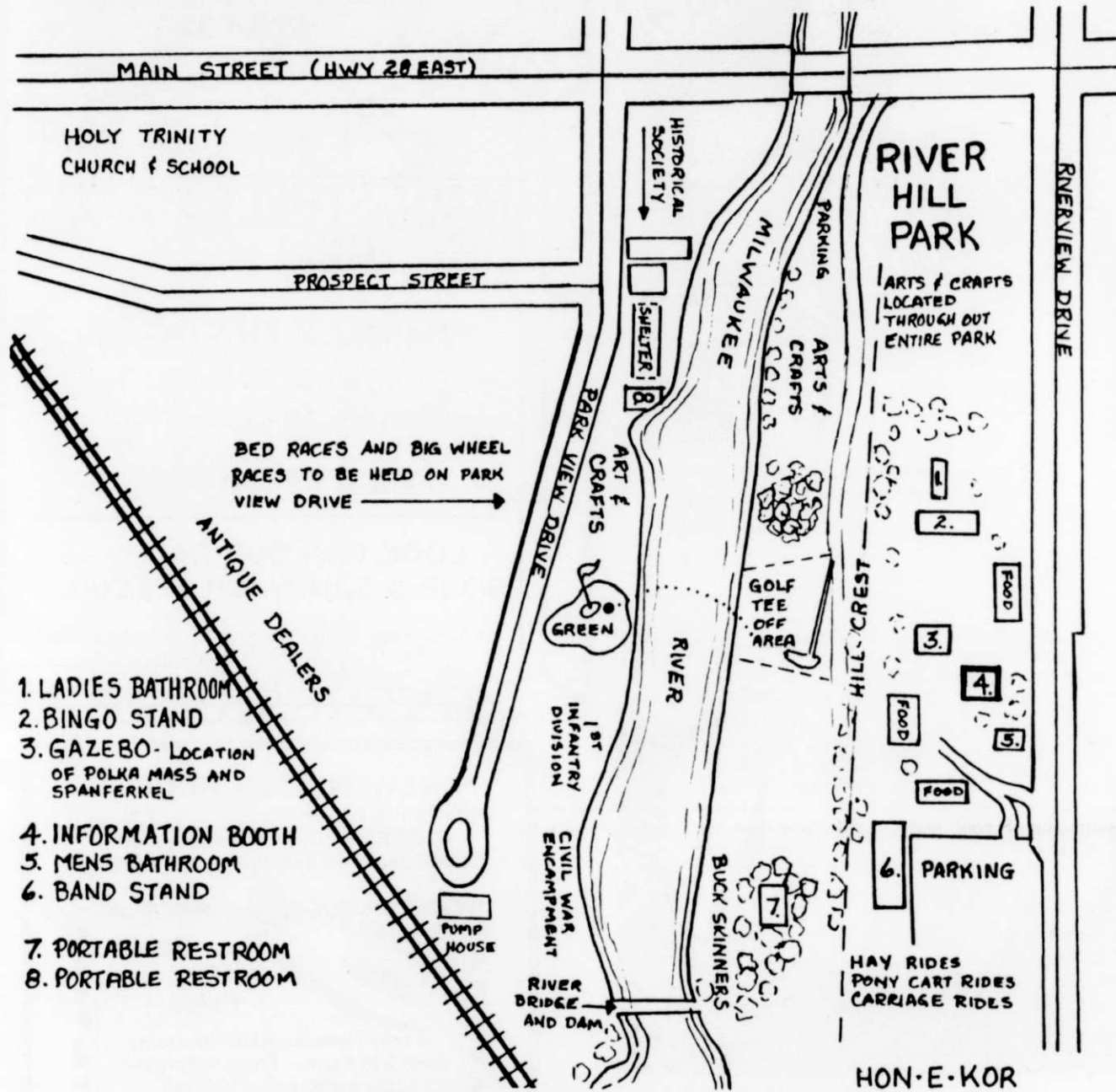

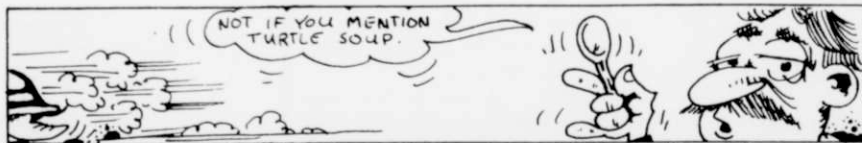

WHO SHOULD GET A FLU SHOT?

From November through April, symptoms that include fever, chills, headache, aching muscles and joints and sore throat may signal the onset of influenza or "flu." In Wisconsin, flu season usually peaks in January.

As in past years, flu shots are recommended for those who are at high risk, including: adults with chronic heart or lung disorders; residents of nursing homes or group homes for the elderly; people over age 65; anyone with chronic illnesses such as diabetes or kidney problems.

According to Delores P. Harder, Director of the Community Health Nursing Service, influenza can be fatal. Complications can include: pneumonia (the most

dangerous complication for the elderly), bronchitis, and sinus and lung infections. Dehydration is another flu danger.

To protect against flu, people at high risk should get a flu shot every year. Last year's shot won't provide protection this year because flu viruses can change every year.

This year's vaccine contains the strains A/Taiwan/1/86, A/Shanghai/16/89, and B/Yamagata/16/88. Each year the vaccine contains strains (usually two influenza A's and one influenza B) representing the viruses expected to circulate during the upcoming winter months.

For protection that lasts throughout the flu season, health care providers recommend that flu shots be

given in November. It takes the body about two weeks to build up protection following the shot. Protection begins to lessen after a few months.

"The flu shot will not cause flu because it's made from inactivated viruses. It provides protection to about 75 percent of persons who receive it," Delores Harder said.

Most people suffer no lasting side effects from the flu shot. However, a sore arm, fever, or aches may follow and last a day or two.

Influenza is a highly contagious respiratory disease, caught by coming in contact with a flu virus directly or indirectly. Direct contact occurs when viruses are breathed in. Indirect contact occurs following use of dishes, or other

personal articles contaminated with flu viruses.

A pneumococcal (bacterial) pneumonia shot is also available to protect those over age 65 and the chronically ill from this disease which may occur in those weakened from influenza. This shot is normally given only once in a lifetime and may be given at the same time as the flu shot in a different site.

Letter to the Editor:

We agree with Jeannie Goeden's letter that was in last week's STATESMAN, concerning the questionnaire sent out by the Kewaskum Board of Education. All taxpayers in the Kewaskum School District should take a few minutes and fill out this questionnaire and mail it back to the School District.

Basically, the message that we should be sending back to the Board of Education is that we as taxpayers are holding the Board and the District Administrator accountable for what happens in our school district. This means that the Board needs to establish measurable levels of performance for the District Administrator and his staff and then to monitor their progress toward attaining these goals. This whole process then results in a continuous improvement in the quality of education, and at the same time provides a vehicle to control the districts total costs.

This process of continuous improvement can be applied to the questionnaire as follows:

1.) If boundary lines were adjusted to provide maximum utilization of the three elementary facilities, then:

-wouldn't this eliminate overcrowding at Farmington?
-wouldn't this avoid the debate of reopening Beechwood, and associated costs?

-wouldn't this allow us to critically analyze the present criteria as to how students are assigned to schools?

2.) Any future building in the district should go through the above process, as well, and that is, that we should expand our core facilities here in Kewaskum which would maximize our support staff.

3.) The issues of moving the football field, auditorium, swimming pool, etc. are all mute points until the Board can get the District's total costs under control.

Finally, the Kewaskum Board of Education really needs to address the main issue that educators are struggling with throughout the nation, and that is, that our schools today are not providing our students with the skills that industry is requiring in the 1990's. That is, our students need to:

- think creatively
- write concisely
- communicate effectively
- have high problem solving skills
- desire self improvement

A recent survey done by an industry in a neighboring school district showed that 30% of those hired tested at only a sixth-grade reading level.

The critical issues facing the Kewaskum Board of Education in the 1990's are none of the issues that are in this survey. The critical issues that this Board should be addressing are:

1.) How are we going to challenge our students and create their desire to improve?

2.) How are we going to challenge our teachers to achieve excellence in the classroom?

3.) How are we going to measure this excellence in the classroom, and financially reward those that achieve it, and get rid of those that don't?

4.) How are we going to take

the gloves off of our teachers and let them have more control over what they teach?

5.) How are we going to get rid of the levels of bureaucratic administration that exist between the student and the taxpayer, so that we can begin to focus on our children and their performance in the classroom?

We challenge the Kewaskum Board of Education and our District Administrator to be futuristic in their planning, and to help our students acquire the skills necessary so that they can become **WORLD CLASS COMPETITORS.**

State's 2nd Fall Turkey Hunt Open

MADISON, WI — Wisconsin's second fall wild turkey hunting season begins Monday, Oct. 8. Department of Natural Resources Wildlife Biologist Ed Frank reminds hunters with turkey permits that a 1990-91 Wisconsin Turkey Stamp is also required to hunt.

Turkey stamps cost \$5.25 and are available at DNR and County Clerk offices. Senior Citizens Recreation Card holders, first year Wisconsin Hunter Education Course graduates and military licensees do not need a turkey stamp.

The fall hunt runs for three consecutive Monday - Sunday hunting periods: Oct. 8 - 14, Oct. 15-21, and Oct. 22-28. A total of 12,465 hunting permits were issued — 4,155 for each period — in 12 turkey hunting zones. Successful applicants were notified and the last permits were mailed Sept. 17. There were 23,466 applicants for the permits.

Frank estimates that about 2,500 wild turkeys will be taken this fall, compared to 1,570 taken last fall. Increases in permits available in most zones and the addition of zones 11, 12, 31 and 32 to the zones open last year account for the predicted increase.

Turkey hunters should keep an eye out for other hunters in the woods at this time of the year, reminds Frank.

"Identifying your target before you shoot is always good advice. This is especially true in the fall, when turkey hunters may encounter small game hunters and bow deer hunters dressed in camouflage."

DNR to Stock Rainbow Trout in Some Area Ponds

MILWAUKEE — Under the state's Urban Fishing Program, several ponds in southeastern Wisconsin soon will be stocked with legal-size rainbow trout, according to the Department of Natural Resources.

Approximately 20,000 trout will be stocked in 17 park ponds in Sheboygan, Washington, Ozaukee, Waukesha, Milwaukee, Racine, Kenosha and Walworth Counties. This is in addition to the over 80,000 trout stocked last spring.

"These are specially-fed trout that reach a larger size sooner than the more common trout stocked," said Ron Piening, a Southeast District Fisheries Biologist. "Fish will average ten inches in length and be ready to provide both fun and food for the frying pan."

The ponds are selected based on their size, location and the ability to provide for icefishing should there be any carryover into the winter.

Stocking will begin after October 15 when water temperatures are around 60 degrees Fahrenheit or colder. "Trout are cold-water fish and these colder water temperatures will help ensure that they will survive," added Piening.

Indians Manhandled by Two Rivers, 41-6

KEWASKUM — It really wasn't the way that the Kewaskum football team wanted to finish its annual Homecoming week. But unfortunately for the Indians, they didn't have much of a say in the matter.

After a successful week which saw both the Kewaskum freshman and junior varsity football team record wins over Two Rivers, the Indians were thoroughly dominated by a much bigger and powerful Raider varsity squad 41-6 here, last Friday night.

"They overpowered us at the line," Indian coach Clark Pearson said, repeating a comment he made just a week before when his team was beaten by a much bigger Kiel lineup. "They were just physically bigger than us at every position."

The Raiders used that muscle to roll up over 400 yards of total offense, compared to the Indians 143. Two Rivers outgained Kewaskum on the ground 278-64, thanks much in part to the efforts of running back Tony Stoeger, who accumulated 119 yards in 19 carries.

Stoeger got the Raiders on the board in the first quarter, breaking loose for a 39 yard touchdown run. Brian Miller's extra point gave the visitors a 7-0 lead, and it was just a hint of things to come for the Indians.

The Raiders extended their lead to 20-0 with a pair of second quarter scores. Quarterback Jim Smogoleski found Teuge Macksfield open for an 11 yard TD pass to make it 14-0 before Stoeger added an 11-yard scamper just before the half, making it 20-0 as the Raiders' attempt for two points came up short.

The Raiders continued to pour it on in the second half, as Smogoleski found Ryan Dodge for a pair of touchdown passes in the third quarter, one from seven yards and the other from 45. Smogoleski finished the night seven-of-16 for 153 yards and three touchdowns.

The Indians finally got on the board in the fourth quarter, as they used a Scott Heller interception to set up shop deep in Raider territory. Heller picked off a Stogoleski pass at the Raider 32 and returned it all the way down to the 13 before being tackled.

Three plays later, Indians quarterback Mark Felix found fullback Jamie Miller open for a seven yard touchdown pass to prevent the shutout. The try for the two-point conversion came up short, as Kim Marx was stopped after catching a Felix pass.

Two Rivers added a little salt in the Indians wounds with a 45 yard TD run by Brett Bero late in the game, giving the Raiders their fourth victory in as many tries in Eastern Wisconsin play.

"I was a little disappointed in our defensive play," Pearson went on to say. "I was hoping we could have held them down a bit. But they've manhandled every conference team so far except Kiel (which Two Rivers beat 18-13). They are definitely the best team we've played."

While maybe they are the best team his team has faced, the Raiders may also be the baddest. Two Rivers accumulated 125 yards in penalties in the game, many

coming from late hits. While he wouldn't go as far as saying the Raiders were a dirty team, Pearson did say that their tactics were "very aggressive."

Nonetheless, Pearson did find some bright spots in the defeat. Miller wound up with 45 yards in nine carries to go along with his TD catch. "He had a very nice game. He did a very decent job of running the ball," said Pearson. The Indians coach also pointed to both of the Heller brothers, Scott and Brian, as having good games, as well as Jason Steilow, who "did a nice job at defensive end."

Felix also played a decent game, according to Pearson. The senior returned to the starting lineup and completed 11 of 27 passes for 79 yards while leading the Indian offensive attack. "We moved the ball a little better," said Pearson. "We just couldn't sustain any of our drives."

The loss dropped the Indians record to 2-5 on the year, including 0-5 in conference. Kewaskum has one chance remaining to break its long losing streak in the Eastern Wisconsin, as it travels to New Holstein Friday to take on the struggling Huskies.
