## Veterans Remembered

### Kewaskum Area Observes Memorial Day

Despite windy, bone-chilling temperatures Monday, young and old alike took time out to remember those who made the ultimate sacrifice for their country. Memorial Day was marked by a parade, followed by a program at the Kewaskum American Legion Hall grounds.

Considering the inclement weather, a large crowd turned out for the Robert G. Romaine Post 384's annual observance honoring America's war dead from the Civil War, World Wars I and II, Korea and the Viet Nam Conflict.

Sgt. Major Michael Livingston was the guest speaker, giving the Memorial Day address. Livingston told the gathering he spoke to them as a soldier. During his years in the service he said he has served with individuals from every walk of life, men and women and even servicemen from other countries.

Livingston said he could always recognize a veteran, when they watch a parade they stand with their backs straight as if at attention, they salute the colors as they pass by and at special events they stand and sing the national anthem.

Livingston stated there is a misconception that the United States is no longer recruiting individuals for service. "We are recruiting right here in Wisconsin," said Livingston, "there is and always will be places for our bright young men and women in the armed services." Opportunities are always available as individuals fulfill their military service and return to civilian life.

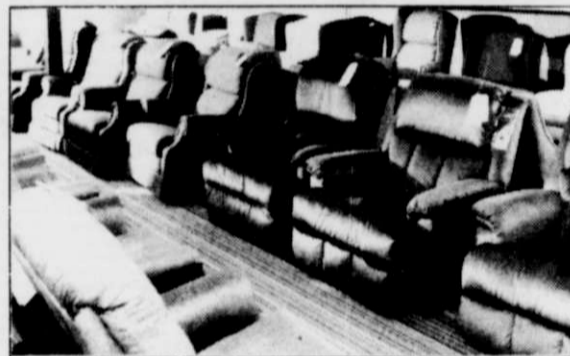
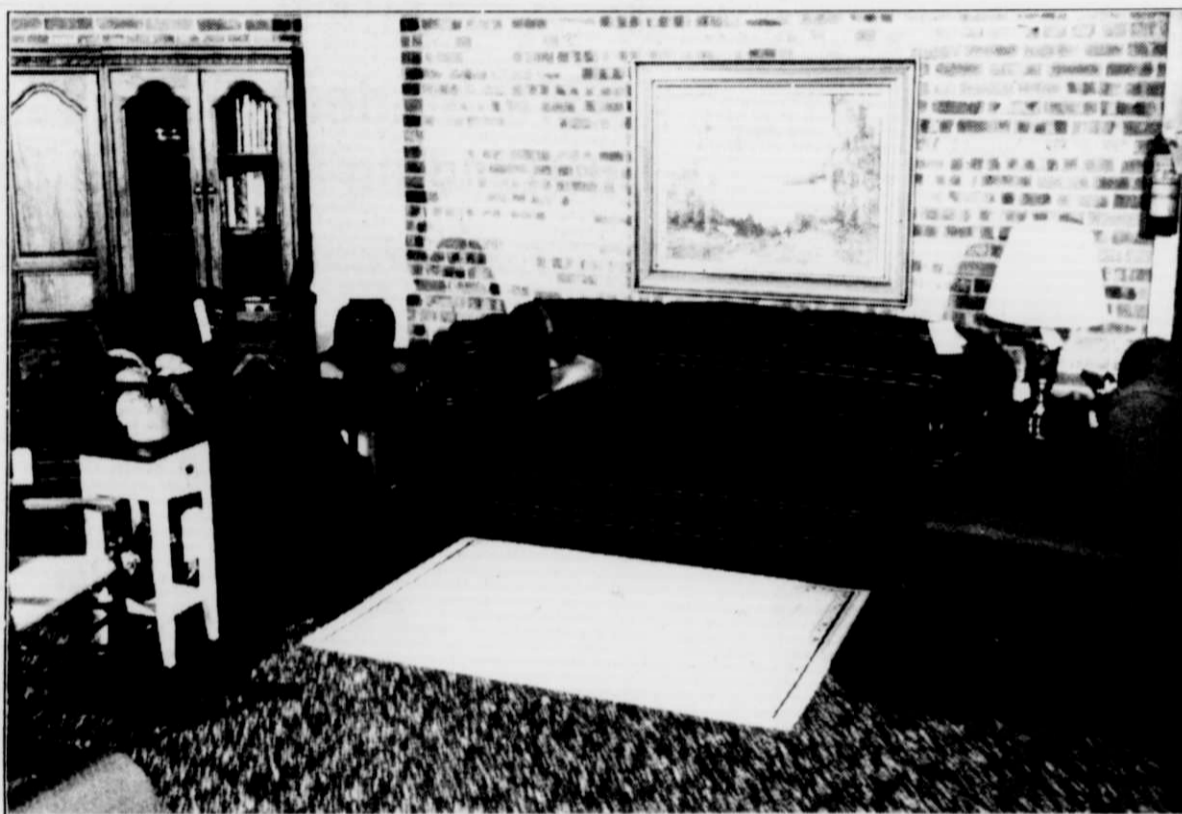
All are reminded that in order

LETTER TO THE EDITOR:

### Open Letter to the People of Kewaskum:

We would like to explain to you our reluctance to a sidewalk being placed in our cemetery.

First of all, let it be clear that NO ONE, not even Holy Trinity Catholic Church, may disturb a cemetery without authorization from the Director of the State Historical Society under the State Statute 157.70.

We are not sure why the Village Board decided not to call the State to find out the proper procedure in placing the sidewalk in the cemetery before deciding to do so. Since they did not, we notified the State of the Village Board's decision and have been following the State procedures as stated by the State Historical Society to make sure that burials would not be desecrated.

There is one particular burial that the engineer, hired by the Village Board, said a probability exists that a grave may be disturbed in order to construct the sidewalk. It is now the decision by the Village Board, in order to make the sidewalk go through, to hire an archaeological firm to come into our cemetery and scrape away the soil to see if a burial does exist. The cost of nearly \$2,500 charged by the archaeological firm will be assessed to Holy Trinity Catholic Church.

In conclusion, may we say we are baffled by the Village Board's decision to go the extent they are to put a sidewalk in this place of sacred ground for a reason we have yet to understand.

We encourage Kewaskum residents to call or write a Village Board trustee or write a letter to the newspaper editor stating your opinion regarding this sidewalk construction. It is important that the board knows your views.

Dear Editor:

I am writing to you as a parent who has just recently had two children graduate from our Kewaskum School District's "DARE" (Drug Abuse Resistance Education) program. I also have a child who is a member of the "Just Say No" club. My concern is over the school board seeing fit to grant a variance to the district policy banning the sale of alcoholic beverages on district property, namely the baseball diamond at the elementary school.

I fully realize that the party to whom the variance was given is a group of responsible adults and that sales do not take place while classes are in session. I also understand that group has made some efforts to compromise with the policy. However, I feel it is a hypocrisy to allow the sale of alcoholic beverages behind a fence clearly marked with a sign promoting it as a drug free zone. We have been instructed as parents to be consistent with our children to the best of our ability. How can the district sponsor the "DARE" program and the expenses it incurred, promote our district property with the large "Drug Free Zones" signs, and yet when it becomes an inconvenience make an exception? The policy committee and the school board need to be firm on their drug free policy as far as district properties are concerned. We need to set a special "zone" or atmosphere to the areas where our students spend so much of their time.

Ideally, the team concerned would come forward and state their support for the "DARE" program and their respect for a school district as a drug free area and phase out the sale of beer on district property on their own. What a statement that would be to my sons, who play baseball.

If anyone else feels as I do, please let your school board members know your support the drug free zone policies.

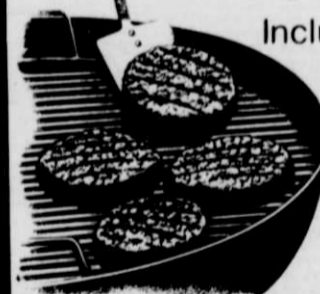

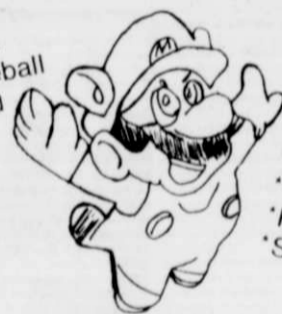

## Cedar Haven Offers Pool Therapy

Pool therapy is increasingly becoming an excellent rehabilitative tool for individuals of all ages recovering from neurological problems. Martha Stoffel, a Kewaskum resident, once barely able to stand, is now walking on her own.

Martha has been receiving physical therapy twice a week in the Cedar Ridge Retirement Campus swimming pool under the guidance of Anne Skalmoski, a Cedar Haven Rehabilitation Agency therapist.

Following knee surgery which resulted in complications and an inability to use her legs, Martha found the water to be a perfect environment for making quick rehabilitation progress. Anne Skalmoski also attributes Martha's progress to her biweekly therapy sessions in the swimming pool. "Working in the water has allowed Martha to work on balance and strength in a buoyant medium with less stress on her joints. Pool therapy has been

popularized by sports medicine because high paid athletes must be rehabilitated to return to activity as quickly as possible. It is also effective with patients of all ages with a variety of disabling conditions."

The Cedar Haven Rehabilitation Agency therapists receive referrals from doctors to utilize the pool with individuals due to its rehabilitative advantages. During therapy, floatation devices and life jackets can be used to give the patient a feeling of security. The pool's water allows the proper amount of resistance for the safe strengthening of muscles.

Furthermore, the whirlpool can be used to provide moist heat for relaxation or pain control. The entry ramp to the pool allows safe transfers for the elderly patients and special needs children who enjoy working in the water. As Anne and Martha attest, "Working in the pool makes therapy effective and enjoyable!"



For the past three years, Kewaskum Juniors have participated in an international program entitled At-Risk Babies Crib Quilts also known as ABC Quilts.

The program began in May 1988 by Ellen Ahlgren of New Hampshire, a caring compassionate woman, who wanted to help at-risk children. The idea is simple. Handmade quilts made by individuals, church groups,

homemakers, quilt guilds, school children, scouts and women's clubs are donated to hospitals, clinics, foster and private families.

The purpose of the quilt is to provide a special gift of comfort and unconditional love to any at-risk child under six years old. Most of the children who receive these quilts are drug affected, HIV positive or abandoned children living in foster homes. Many do

not survive their fourth birthday.

There are five volunteer area coordinators in Wisconsin. Each coordinator attempts to fill a monthly quota of 20 quilts each. These quilts are sent to Mt. Sinai Medical Center in Milwaukee for distribution. This year Kewaskum juniors donated 25 quilts to the program. 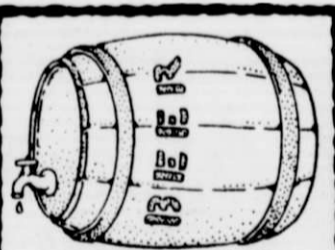

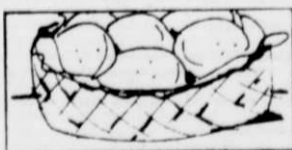

The Recycling Center, which is located adjacent to the Municipal Garage, 1002 Fond du Lac Avenue, will be open to receive recyclable materials EVERY Saturday, 8:00 a.m. to 2:00 p.m.

ITEMS SUBJECT TO RECYCLING. The following items of rubbish and garbage may be delivered to the Recycling Center on condition that the resident or property owner complies with the preparations hereinafter indicating recycling is not mandatory.

(a) PLASTIC MILK JUGS, SODA BOTTLES AND ICE CREAM CONTAINERS-- remove caps, rinse, flatten if possible.

(b) NEWSPAPERS - separate from magazines and colored advertising, bundle securely. (Please place at curb or take to the Recycling Center. Newspapers collected ONLY on the third (3rd) Saturday of each month.)

(c) CORRUGATED CARDBOARD - (Accepted only when flattened)

(d) ALUMINUM CANS - Separate from steel cans, flatten if possible, labels may be left on.

(e) STEEL CANS - Separate from aluminum cans, flatten if possible and rinse, labels may be left on.

(f) GLASS - Sort by color (clear, green or brown), labels may be left on, no window glass, light bulbs or ceramics. Please do not crush. Remove all neck bands.

ITEMS NOT PICKED UP DURING REGULAR WEEKLY GARBAGE COLLECTION. The following items will not be picked up by the Village in connection with its regular weekly garbage collection, but will be accepted for disposition by the Village Recycling Center on condition that the following preparations are made by the owner or resident generating such items of waste:

(a) MISCELLANEOUS METAL - Sort by content, if possible, remove all metal attached.

(b) MAJOR APPLIANCES - Place in the designated area at the center. (Exceptions: TV's, plastic type appliances, etc. NOT ACCEPTED)

(c) WASTE OIL - Pour into a tightly closed container and take to center.

(d) TIRES - Refer to Section 14.09(5)(c). (NOT ACCEPTED)

(e) GRASS CLIPPINGS AND LEAVES - Place in the designated area (compost pile). (There will be pickup by the DPW each Fall as noticed by the Village Board. At that time, the items are to be boxed or bagged and placed at curbside.)

(f) TREE BRANCHES AND BRUSH - Place in the designated area or cut and bundle, length not to exceed 4 feet, and place at curbside. Contact the DPW if pickup is not made within 3 working days.

(g) NON-RECYCLABLE MATERIALS - (furniture, carpeting, etc. - NOT ACCEPTED)

(h) BATTERIES - place in designated area at center.

(i) NEWSPAPERS - Separate from magazines and colored advertising, bundle securely. (Please place at curb or take to the Recycling Center. Newspapers collected ONLY on the third (3rd) Saturday of each month.)

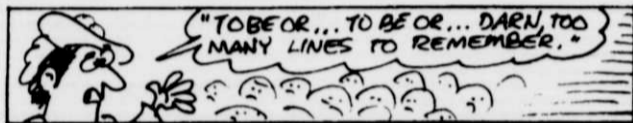

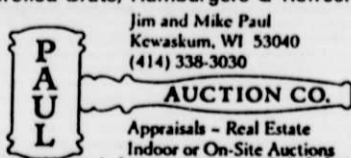

## UWWC's Tom Brigham Recipient of Rolf's Foundation Teaching Award

A former student from Alaska writes that he is fine and happily employed as a physician's assistant. It brings a smile to Tom Brigham's face. "My highest award is working with students and being able to touch their lives a little bit," cites the professor of Physical Education.

Brigham has touched many lives in the nearly 25 years he has been teaching and coaching at the University of Wisconsin Center - Washington County. His efforts earned him the prestigious Rolf's Foundation Teaching Award which was given to him at UWWC's Honors Convocation May 15.

The award was an "absolute surprise" to Brigham who says he is proud of being recognized by his peers. "It's a very good feeling to be in that fraternity of excellent teachers on campus."

The teaching award is especially gratifying for Brigham who now spends about 80 percent of his time in the classroom and 20 percent as athletic director and coach. Brigham is also the department chairman for physical education and athletics for the 13 UW Centers, and has held that title for the past six years. His responsibilities as chairman include curriculum planning, staffing and budgets. As a successful coach and athletic director,

Brigham, like others in physical education, is often defined by the old stereotype of "someone teaching calisthenics." Today he teaches health, first aid, wellness, sports injuries, along with life time sport activities. His students discuss living wills, alcohol, kinesiology and much more. Says Brigham, "People don't realize what teaching physical education is at the college level. It still comes down to the opportunity and ability to communicate, to transfer knowledge and to have an interchange of ideas."

Teaching and coaching at the university level was always Brigham's goal. He was raised in Two Rivers and went to UW-Madison on a four-year athletic scholarship. He played defensive cornerback for the Badgers from 1962-1965 and still holds the longest run from scrimmage record at 91 yards. When he was a senior he was voted the team's most valuable player and was selected to the Big Ten Conference's All Academic Team and the Chicago Tribune's All American Team.

He graduated with honors from Madison and was drafted by the Miami Dolphins and Detroit Lions. It was in Detroit that he suffered an eye injury that sent him back to Madison to get his Master's degree in Physiology and Exercise. "So I just got started on my teaching and coaching a little sooner than I planned," he grins.

In 1968 when the campus opened, he was hired by one of his mentors Carl Sanger, the Physical Education Department Chairperson of the Centers. "He had a tremendous influence on my life," remembers Brigham. He fell in love with the job and the students and has remained at UWWC because of them. "I've had tremendous help from the faculty and have enjoyed a fine relationship with the administration."

Many faculty have volunteered to coach teams over the years which has helped Brigham to build a successful athletic program. He now has two paid coaches but for many years relied

on faculty help to staff programs. He thanked these fellow professors and also the students who helped him to grow and mature. "Teaching is really a two way street," he explains. "I work hard because I enjoy working with students."

## DNR Recommends Nine-Day Deer Season to Natural Resources Board

MADISON... The Department of Natural Resources has recommended maintaining a nine-day gun deer season this year to the Natural Resources Board, but the department indicated the hunt could be extended in certain areas if the harvest falls short of checking a herd that has outstripped its habitat or is testing public tolerance.

Department Secretary C.D. Besadny also instructed DNR field staff to work with interested local groups to develop pilot, 16-day hunting seasons in 1993 to provide additional hunting and help tourism businesses.

The two recommendations are the most significant Besadny forwarded to the Natural Resources Board, which votes in Fond du Lac Thursday on proposed hunting and fishing rule changes.

Besadny decided against a statewide or a northern 16-day season for this year because "there just isn't the public support for it," although he added that recent surveys show a support for something other than the traditional nine-day season.

"Deer management policies must have the collective support of those affected and that support must be strong enough to convince conservation leaders to implement change," Besadny told the board in his recommendation. "Right now, the leaders don't support change and so major change won't happen."

"There is strong interest in establishing a longer gun deer season in Wisconsin. However, there is also equally strong sentiment for retaining the current nine-day framework," he continued.

Besadny said his highest 1992 priority would be to "creatively" use existing authority to keep the herd in check "to the best of our ability." He pointed to a possible season extension in the 58 management units where deer numbers are at least 20 percent over population goals.

"Most of the severe deer overpopulation problems are in the north," Besadny said. "These are areas where vegetation is being damaged and a harsh winter will risk significant starvation and serious habitat damage. So we will do our best to give ample opportunities to those who are really serious about hunting and harvesting."

Besadny listed this year's proposed actions to control deer numbers:

- Continuing - for the second year in a row - the two deer bag limit for bow hunters in several management units, generally in northern Wisconsin;

- Continuing a seven-day antlerless-only extended muzzle loader (gun) season immediately following the regular nine-day gun deer season for hunters who have valid Hunter's Choice or bonus antlerless permits;

- Establishing a special metropolitan deer management unit in the Milwaukee, Kenosha

and Racine areas, with two added weeks of antlerless deer hunting (by permit);

- Establishing special metropolitan deer management units in the Madison and LaCrosse areas within the traditional nine-day framework;

- Permitting bow hunters to bag up to four deer (three of which must be antlerless) in all metropolitan units and increasing the number of Hunter's Choice permits for gun hunters in those units. Some hunters may be eligible for up to four or more special permits, depending upon the unit and herd size;

- Allowing hunters to apply for Hunter's Choice and bonus antlerless permits in more than one unit with no limit on the number of permits they may receive.

In addition, the department recommended rejecting higher population goals in two deer units where damage to farm crops and natural vegetation exists and car-deer collisions are increasing. The units are 70B (in Columbia and Sauk counties in southern Wisconsin), and Unit 10 (in Burnett and Polk counties in northwest Wisconsin).

The department also said it would reject recommended higher deer numbers for Unit 70 in Sauk County, unless the local Land Conservation Committee, representing farmers, recommends the increase. The department is concerned about crop damage and car-deer crashes and will not recommend an increase in numbers without local support, said Bill Ishmael, DNR big game specialist.

"We want to communicate that the problem is serious in some areas and we are serious about it," Ishmael said. "Our 1992 strategy is focused on areas with problems and on the antlerless deer in these areas."

Ishmael said the department would review harvest progress in each problem unit once the hunt began and ask Besadny to use his emergency authority to extend the season if deer were not being adequately harvested. The authority was used in 1991 because of poor opening weekend weather.

While Besadny rejected a planned 16-day season for Wisconsin in 1992, he said the department was "very serious about exploring opportunities with local interests that want to break out of the nine-day tradition." He credited comments made to him during last week's Conservation Congress meeting in Eau Claire as "encouraging signs there are people in some parts of the state who see opportunities for more hunting."

Besadny said the department's district directors and field staff will work with land conservation committees, local officials, hunters, outdoor writers, tourist operators, other outdoor enthusiasts, law enforcement and landowners, "to logically explore the opportunities

and concerns."

He also said the department would review the recommendations of the Ad Hoc Deer Committee for possible implementation and continue its outreach effort to a variety of statewide groups, including the AFL-CIO Conservation Committee, the Conservation Congress and Wisconsin Wildlife Federation.

"We will walk the extra mile to work with local groups that will work with us," Besadny said. "This means the department and local interests may explore longer hunts, earlier hunts, different restrictions for antlerless and buck hunting, and other new ideas that meet the needs of local citizens."
