Board Names Vechart's Successor

Illegal Dumping Can Bring Hefty Fines

Because the area is bare and somewhat out of sight, individuals have taken to dumping their yard and construction refuse on land in the former industrial park land along Wildlife Drive. In questioning by some of the Kewaskum Village Board members, both Public Works Director Jerry Gilles and Village Administrator Dan Schmidt confirmed they were aware of the situation and agreed it should be halted.

Trustee Gary Gavin said he was concerned after seeing that some person or persons had dumped broken concrete in the area. "We're trying to sell lots for homes back there," said Gavin. He questioned whether there was any village ordinance against such dumping. Schmidt and Police Chief Richard Knoebel both indicated such dumping is illegal and under village ordinances, individuals doing it can be fined. "It can fall under the jurisdiction of either Public Works or my department," said Knoebel, "and fines can run anywhere from \$110 to \$600 plus costs.

Gilles told the board he planned to have the area in question leveled off and posted with 'no dumping' signs. The board agreed anyone found illegally dumping should be subject to fines.

In another somewhat related

issue, Gavin told fellow board members he felt the village should set up a dumpster for private citizens, not contractors, to dispose of items no longer picked up by the village crew in normal refuse collection. "We were providing a service and now you took it away without any explanation," stated Gavin. He noted many village residents were upset last week when they found some items put out with their garbage had not been picked up.

Former trustee Ken Bonlender, who was in the audience, told the board he was glad to hear Gavin's comments. "That's just why I'm here tonight," he said. "There are only a few reasons why people move to the village," stated Bonlender, "and that's services, sewer, water and garbage collection." He told the board, "you can't expect people, especially senior citizens, to drive all the way to West Bend with five or six boards or an old TV set." "Put a dumpster or five up at the (recycling) center and charge us per item. I would be willing to pay for it rather than have to go to West Bend. Some people, especially the elderly don't have a car or truck to haul stuff, but if we had a dumpster at the center I'm sure they could find someone willing to take it up there for them."

Trustee Bob Beisbier agreed in principle, "I think we should have

a policy and some guidelines though." Board president Mary Krueger stated, "I don't think it's a bad idea to have a nominal charge." "We're all agreed then, Krueger asked the board, we're going to put a dumpster up there." Schmidt told the board he would contact other communities to see if and what they charged for such services.

In other Recycling Center business, Trustee Tom McElhatton advised the board that response for the job of site manager had been poor. He received permission to continue advertising the position.

With the departure of Mark Vechart from the board this month, the trustees agreed Monday night, that they felt the position should not remain vacant. Since a year of the unexpired term remains, they felt a replacement should be selected. Schmidt said the village had received letters from three applicants, Warren Dums, David Goeden and Charles Waala.

On a secret written ballot, the board chose David Goeden to fill the unexpired term. President Krueger thanked all the applicants for their interest and encouraged them to consider running for office next year.

Chief Knoebel informed the board that his department had received a donation of \$300 from the New Fane Sportsmens Club to be used to offset its costs for the DARE program. He said a letter of appreciation would be sent to the club.

In other action the board approved the annual renewal of Class A and B liquor and operators licenses which expire June 31st.

In final action, the board approved moving the regular July monthly meeting to the 13th and the cancelling of the July mid-monthly meeting due to the July 4th holiday.

Gavin Encourages Development Of Wildlife Drive Land

Trustee Gary Gavin told fellow Kewaskum Village Board members he would like to see the village develop land along the east side of Wildlife Drive (in the former industrial park) into single family lots. "We need more single family lots in the village," said Gavin, "nice size lots for nice homes, not sixty-footers."

In making his concerns known Monday night, Gavin told the board, development of that area would help to bring in other individuals who are interested in building on other sections of the subdivision, behind that land.

Gavin said while he would like to see single family lots, he would have no objections to a duplex or two, but nothing bigger on any lots created adjacent to Wildlife.

Money from the sale of those lots would help to develop the rest of the land, he noted. Right now nothing is happening, we're not selling any more land and the situation is discouraging potential construction.

Presently the only construction going on in the subdivision is multi-family units west of Wildlife.

Village Administrator Dan Schmidt agreed with Gavin's remarks, noting interest had been shown in both areas addressed by Gavin's comments.

The board agreed the village should look into subdividing the land into single family lots.

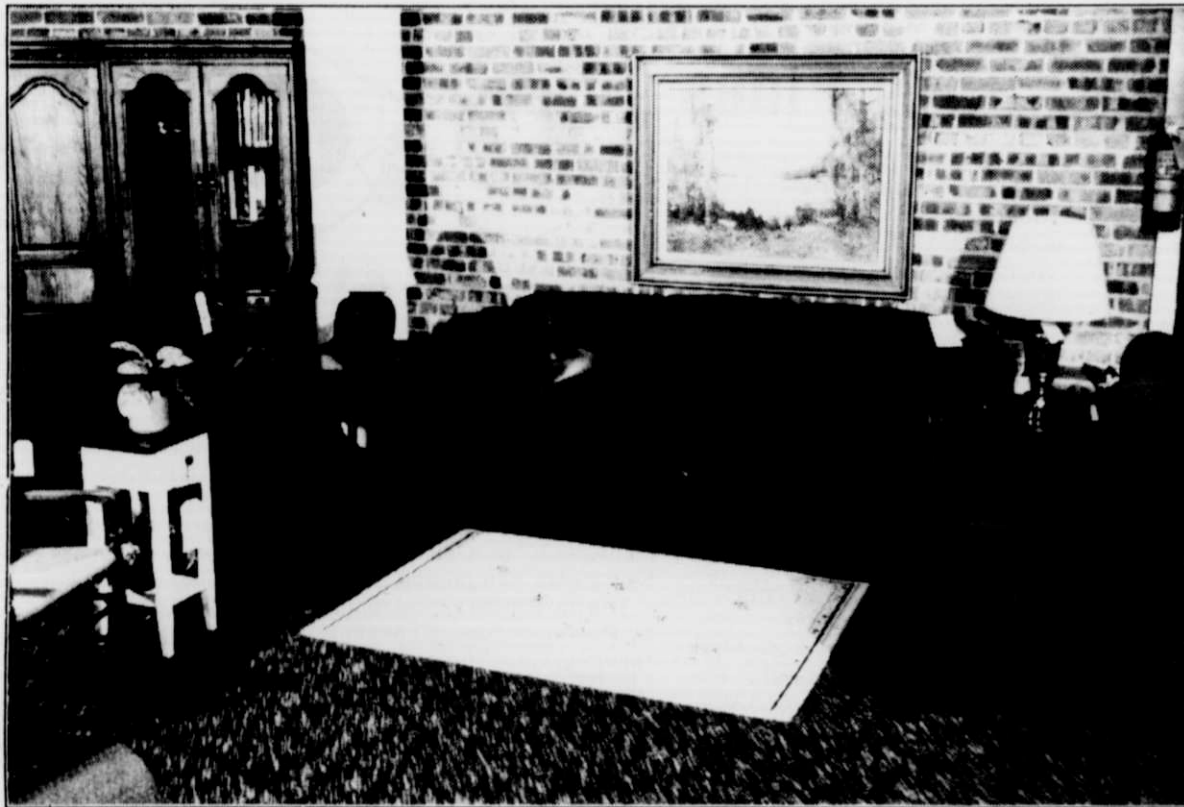

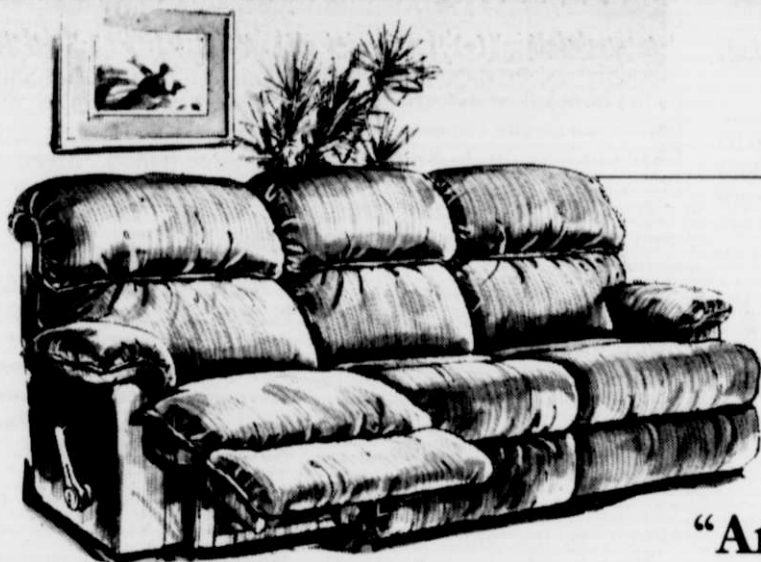

Jim Stern Competes At National Level In Geography Bee

Jim Stern, the eight grade geography whiz from St. Lucas Lutheran School in Kewaskum, took home a memorable placement from the National Geography Bee held May 20 and 21 in Washington D.C.

The son of David and Darlene Stern of Fredonia, Jim had participated in the contest for three years in a row, and captured the state title this year on March 27th in Oconomowoc. The Bee is sponsored by the National Geography Society. His parents, along with principal and teacher Rod Bollinger, were in the audience as he competed against 57 finalist from around the country.

The contestants were divided into five groups, and the top two from each group participated in the final round moderated by Alex Trebek of Jeopardy fame. A tiebreaker was necessary in Jim's group since Jim and two other students had each answered eight questions correctly.

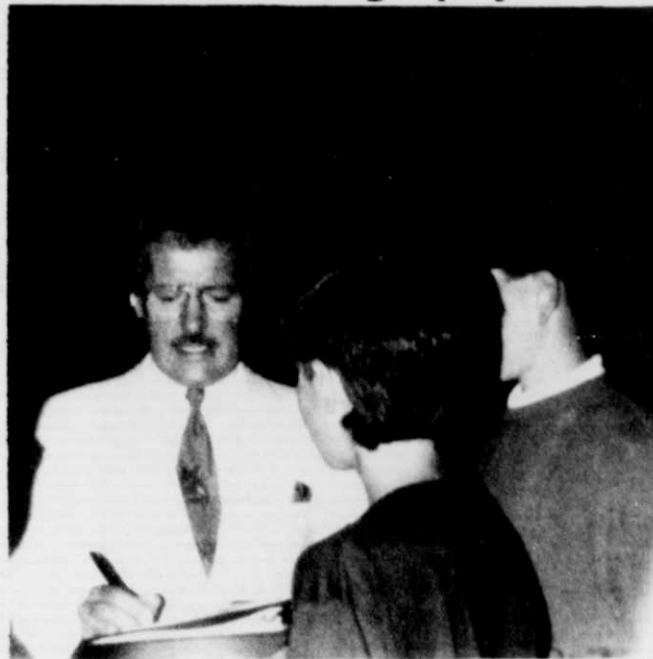
But in the next preliminary competition, Jim was eliminated during the three-way tie-breaker with the following questions: name the two countries in South America that do not border Brazil (Chile and Equador); give the term used to describe the movement of tectonic plates under the surface of the earth (subduction); and name the country where Punjabi is spoken, although the official language is Urdu (Pakistan). Jim guessed the first question correctly, but missed the last two.

"These contestants can put an audience of well-educated adults to shame with the depth and breadth of their knowledge of the world," said Gilbert M. Grosvenor, president of the National Geographic Society. "They provide vivid proof that when students are well taught, and are supported by their parents there is no limit to how much they can learn about a subject."

Nearly six million students have competed in the various levels of the 1992 National Geography Bee, sponsored by National Geographic World, the Society's magazine for children and Am-track, the nation's intercity passenger railroad.

College Scholarships were awarded in the amounts of \$25,000; \$15,000; and \$10,000; plus interest until the students enroll.

Jim enjoyed his trip to Washington D.C., and one of the highlights of the weekend was visiting the National Air Museum of the Smithsonian, and seeing the Wright brother's plane. Kewaskum is very proud of his accomplishments at the national level and looks forward to Jim's continued successes.

Thursday, May 28, 9:20 a.m. - The Kewaskum Rescue Squad responded to a call to Hwy. 144, 1/2 mile south of HH, following a vehicle rollover. The male driver suffered possible fractured ribs and lacerations to the head. He was transported to St. Joseph's Hospital in West Bend and later transported to Milwaukee by ambulance.

Thursday, May 28, 9:54 a.m. - While the first rescue squad was still on the accident scene, the second rescue unit was dispatched to Regal Ware in Kewaskum when a female worker had her right hand caught in a piece of machinery. She was transported to St. Agnes Hospital in Fond du Lac where she was later taken to Milwaukee by Flight for Life.

Sunday, May 31, 7:43 a.m. - The rescue was summoned to Maple Dale Manor in Kewaskum when a female resident suffered a possible stroke. She was transported to St. Joseph's Hospital in West Bend.

Accident Victim Remains Hospitalized

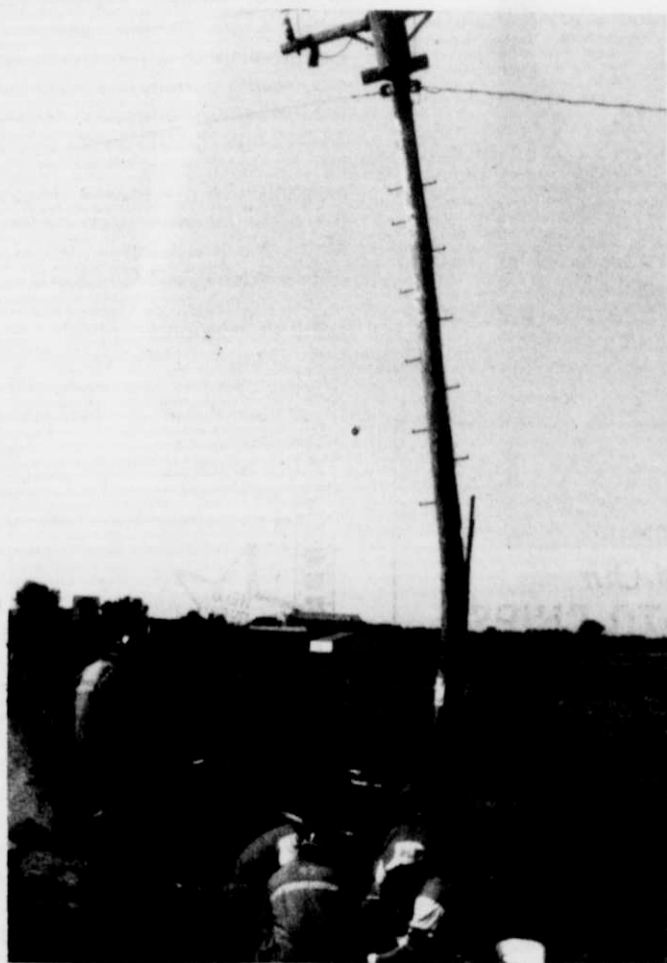
A 44 year old man, Gerald S. Mueller of Grafton, remains in the Intensive Care Unit of the Milwaukee County Medical Complex, listed in critical condition, with injuries sustained in a one-car accident which occurred last Thursday, May 28th at 9:21 a.m. The accident happened on Highway 144, between Shalom and Sunnybrook Drives, in the Town of Farmington.

According to a preliminary Washington County Sheriff's Department report, it appears Mueller, who was apparently traveling north on Hwy. 144, lost control of his vehicle when the right tire went off the pavement onto the gravel shoulder. The car traveled across the highway, rolling over and ending up on its roof in the ditch and against a utility pole on the west side of the road. The impact of the crash broke the pole about eight feet above the ground.

Complete details of the incident are not available because Sheriff's Department personnel have been unable to talk to Mueller.

The Boltonville Fire Department and Kewaskum Fire Department's Jaws of Life Unit responded to the call. It was not necessary to use the jaws to extricate the victim from the wreck.

Mueller, who was alone in his vehicle, was transported by the Kewaskum Rescue Squad to St. Joseph's Community Hospital, West Bend and later transferred by the Flight for Life, to the Medical Complex.

Grover Will Not Seek Re-Election As State Superintendent in 1993

MADISON — Herbert J. Grover has announced that he will not seek a fourth consecutive four-year term as state superintendent of public instruction. He made his announcement in Stevens Point at the convention of the Wisconsin Association of School District Administrators.

Grover, 55, has held Wisconsin's highest educational office for the past 11 years. His present term ends in July of 1993. He served as president of the Council of Chief State School Officers and has the third longest tenure among the nation's state superintendents. He holds numerous state and national education leadership positions and is widely respected as an educational innovator and leader.

A former five-term state legislator, Grover was president of the University of Wisconsin System Board of Regents and was a school district administrator in Niagara and Monona Grove prior to being elected state superintendent in 1981.

Grover said he was making the announcement now, 11 months before the election, to give others an opportunity to consider the office. "Twelve years is a long time in this office. It is time to pass the torch to others who have a dream and vision for Wisconsin's children. This office belongs to the public, not one individual," he said.

Pleased with the recently enacted education reform package - a result of hard work among educators, legislators and the governor - Grover said the new agenda is an ambitious one. "We have set the stage for monumental change in education." The new legislation deals with school-to-work transition; student assessment and accountability; school and social services collaboration; staff development; early childhood education; school management restructuring; educational goals; post secondary enrollment options, and Advanced Placement. Grover noted that the door has also been opened for further debate on lengthening the school year.

Grover thanked teachers, administrators, school board members, legislators, parents and citizens for their support. "Truly, we have seen many changes in education these last 11 years. Since 1981, Wisconsin has implemented new laws and regulations to establish safer school buildings, reform child labor laws and higher teacher education standards, implement school-to-work transition programs, make improvements in early childhood education, establish uniform admission policies to University of Wisconsin System institutions, and provide more assistance to children in danger of dropping out of school," he said.

During Grover's administration, minimum state educational standards for all school districts were established. Education programs were put in place with Japan and Germany. He also leads on initiatives in the areas of administrator training and leadership, alcohol and other drug abuse prevention, and family involvement in education. Through his leadership, the DPI has earned a national reputation in curriculum development and resource planning publications.

"I'm also very proud that through the efforts of many individuals and groups, we have recognized and honored excellence. Such programs as Academic Scholars, Kohl Fellows

and Scholars, Academic Decathlon, educators of the year, family friendly schools, and Science, Arts, Business, and Teacher awards all contribute to a greater sense of accomplishment for those in education," Grover said.

He emphasized that this is not an announcement from public service. He intends to continue to be active in education and child-related issues.

"I'm going to work hard with State Secretary of Administration James Klauser and the Cabinet for a Quality Work Force this next year to implement school-to-work transition, tech prep and youth apprenticeship, and the new student assessment program," he said.

Grover said he is proud to be associated with Wisconsin educators. "This state is fortunate to have the finest teachers in the

nation. Also, our school boards and administrators have shown vision and leadership in times of change."

He paid special tribute to the staff of the Department of Public Instruction. "They have worked hard and have absolutely focused on what needs to be done for students."

Athletes, Coaches Honored At UWWC Awards Banquet

The 23rd annual Athletic Awards Banquet at the University of Wisconsin Center - Washington County, was held Tuesday, May 12. More than 60 athletes and coaches were honored.

John Schuh of Jackson, who lettered in soccer was named the Scholar Athlete for 1992. "John epitomizes what this award is all about," explained Tom Brigham, Athletic Director at UWWC. "He is an excellent soccer player. He is very involved in the business club and in other organizations on campus. He is a tremendous talent and a very polished young man."

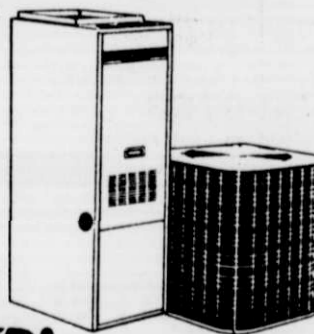

Special Meeting of Village Board

Special Meeting
May 18, 1992
7:00 P.M.

The Village Board of Kewaskum, Washington County, Wisconsin, met in Special Session in the Council Room of the Municipal Building, 204 First Street.

President Mary Krueger presided. All Trustee Members were present. A quorum was present.

Discussion was held regarding the proposed installation of sidewalk on the north side of Main Street adjacent to the cemeteries with the churches. It was noted by President Mary Krueger that this was an informational meeting and not a public hearing. The engineer from Ruekert and Mielke, Mr. Kenneth Ward was present. President Krueger asked that those in attendance give Mr. Ward the opportunity to explain the project and that once comments from the floor began people wishing to speak would identify themselves.

Those in attendance were Mr. Jerry Gilles the Director of Public Works, Mr. Robert Stoltzmann the Fire Chief, the news media, Larry Martin, Fred Miller, Mary Ellen McElhatton, Roy Esser, Dennis Bingen, John Schoofs, Andy Pesch, Linda Thorn, Gregg Krueger, Wally Hennig, Ronald Stange and Zachary Stoffel.

Also in attendance was Ms. Diane Holiday from the State Historical Society.

Mr. Ken Ward explained that the Village Board has adopted a policy of installing new and repairing existing sidewalk throughout the Village. The sidewalk program is for the general public's safety and is to be non-discriminatory. The general rule is to have sidewalk in front of all properties abutting a street whenever practical and possible.

It was noted that the sidewalk under consideration was actually to be installed in 1991 and was to follow the

contour of the land with a minimum greenway area. It was further noted that the proposed sidewalk was to be adjacent to one grave stone and another grave stone was to be within the sidewalk area by approximately 8 inches. The special assessment for the proposed sidewalk in 1991 was \$1,559.36.

Due to concerns expressed by Holy Trinity the project was tabled for further review, engineering and discussion. The State Historical Society was then brought in and has asked that no graves be disturbed prior to investigation and permission. Note: It was never the village's intention to disturb any graves and still isn't. The installation of a retaining wall then became apparent when it was no longer possible to follow the contour of the land, but to place it adjacent to the curb within road right-of-way. Two options were looked at regarding the retaining wall matter; the first was the installation of a timber retaining wall, but one with some inherent problems because of the timbers required to help support the wall, which would protrude into the cemetery. The second option was to install a Keystone concrete retaining wall, not requiring tie supports. The cost ranged from \$1,600 to \$3,000.

The preferable option, the keystone retaining wall, appears to be choice, given the amount of room within road right-of-way. In response to a question it was noted that 6" to 18" would be needed behind the retaining wall and that crushed stone would be used for backfill.

The State Historical Society had further contact with Holy Trinity and eventually had 185 signatures of people requesting to be placed on the list of those having an interest in the cemetery. This followed with the request of the State Historical Society to have an Archaeological Examination of the area within the cemeteries where the sidewalk and retaining wall are proposed. It was noted that the cost for such work ranged from \$2,516.20 to \$3,640.32.

Methods of such a study were

discussed. The excavation type study was recommended by Ms. Holiday as being more conclusive, because of the soil conditions.

For the Village Board to proceed, permission from the State Historical Society is required and the possibility of a public hearing. A special assessment public hearing is required whenever work is to be assessed against property. To proceed to the next step the archaeological examination is required. This would mean that the cost has grown from the estimated \$1,500 to the estimated \$7,000 not at the Village Board's request, but those of Holy Trinity's and the State Historical Society's.

Ms. Holiday indicated that the process is the same for all recorded and inventoried cemeteries. A letter dated April 15, 1992 officially notified St. Lucas Lutheran Church, Cemetery Board that their cemetery has not been recorded and inventoried as to add those special requirements. This now means the archaeological examination is also required to be completed on this cemetery even though no concerns or objections were filed.

A variety of questions and comments were made from those present with Mr. Larry Martin being the main spokesman. Mrs. Mary Ellen McElhatton, Finance Chairperson for Holy Trinity indicated the church would prefer the installation later rather than now because of current financial obligations.

It was noted that if the archaeological examination was not performed it would never be accomplished. It was further noted that the cost of the study would now be shared between the two cemeteries if the work was to proceed and if it did not proceed the Village would pick up the cost.

The time table for the study, permission process and proposed installation were discussed. Regarding the permission process it was noted a public

hearing may be ordered and also that the Village Board would need to first review the study and determine how and if to proceed.

On a motion by Trustee Gary Gavin, seconded by Trustee Harry Roecker and carried by the majority roll call vote, to adjourn. Roll call vote was 7 "Aye," 0 "Nay," 0 "Absent."

KHS Netters Scoreless at EW Meet

SHEBOYGAN FALLS — Things went pretty much as anticipated in the Eastern Wisconsin Conference tennis meet held here, last Saturday.

Campbellsport tied the game by scoring two runs in the fifth and then scored two more runs in the seventh to take an 8-6 lead.

Kewaskum sent the game to extra innings as they scored two runs in their half of the seventh. Donath scored on a passed ball and Mark Strohler scored on a wild pitch. Both runners scored after two outs. The inning ended when Kevin Klahn was tagged out at the plate on a very close play.

After the Indians held Campbellsport scoreless in the top of the eighth, they wasted little time putting the pressure on the Cougars in the bottom half of the inning. Mark Strohler walked to open the frame. Survis flew out, but Donath followed with a single. Strohler and Donath each advanced one base when the pitcher's attempted pick-off throw went into centerfield. Dane Dorn was intentionally walked to load the bases for Ryan Kurth. Kurth took a called first strike and then fowled off the second pitch. On a 0-2 pitch Kurth dropped down a perfect squeeze bunt to bring Strohler home with the winning run.

Dane Dorn worked the complete eight innings to get the win. He struck out five, walked five, hit one batter, yielded four earned runs, and gave up 10 hits. Jason Hull was the losing pitcher. Survis, Donath, and Cory Rammer each had two hits for the Indians.

In game two, Campbellsport jumped to a 2-0 lead then added single runs in the second, fifth, and sixth innings to push the lead to 5-0. Meanwhile, Kewaskum was struggling against Cougar hurler Bob Bothe. Through the first five innings, Bothe scattered five hits, and fanned 10 hitters. Kewaskum finally ended Bothe's shut-out bid as they scored twice

in the sixth inning.

Jason Gaffke doubled and scored on Donath's single. Donath's choice, to third on a passed ball, and scored on a wild pitch. At the end of six innings Kewaskum trailed 5-2.

Campbellsport did not score in the seventh inning and in the bottom of the seventh Jason Hall replaced Bothe on the mound for the Cougars. Hall struck out the first batter he faced. At this point Hall's control deserted him as Gaffke walked, Strobel, and Gaffke to load the bases. Donath grounded out to the second basemen but on the play Survis scored and Strobel and Gaffke advanced. Chad Muckerheide then delivered a clutch single to leftfield which brought in both Strobel and Gaffke. Kurth was the next batter for the Indians. While he was at the plate Muckerheide stole both second and third. Kurth eventually walked to put runners at the corners with two outs. With Brown at bat for the Indians, Kurth broke for second base hoping to entice a throw which might allow Muckerheide to score from third.

At first the Cougars seemed content to let Kurth go to second base uncontested, but when Kurth stopped halfway between first and second the pitcher began to run at Kurth. While this was happening Muckerheide broke for the plate and Kurth broke for second. Muckerheide crossed the plate just as Kurth knocked the ball out of the second baseman's mit giving Jason Gaffke a 6-5 victory.

Kewaskum pitched all seven innings to pick up the win. He struck out eight, walked five, hit two, gave up three earned runs, and yielded four hits. Jason Hall took the loss. Gaffke and Donath each had two hits for Kewaskum.

KHS to Send Four Boys to Sectionals

MAYVILLE - There were a lot of personal bests rung up by the Kewaskum boys track team in the WIAA Division II Track Regional here, last Tuesday, and for some it couldn't have come at a better time.

The Indians finished third as a team in the meet, qualifying four individuals for Sectional competition. Kewaskum racked up 70 points, behind only Sheboygan Falls (112) and Mayville (76).

"We had some good individual efforts," KHS coach Jerry Gosa said of the Regional meet. I think we did alright, considering we had just one (Kim Marx) qualify for Sectionals last year."

Marx was once again one of those headed to the Sectionals, as he came in a strong second in the 300 hurdles, losing to Slinger's Josh Nelson (40.19-40.64). "He ran well," Gosa said of Marx.

The Indians only first place in the meet came by way of a freshman, high jumper Travis Jacak. Jacak continued to peak in the event, clearing the 6-2 mark for the first time to win the event by four inches.

"For a freshman to be jumping that high is just fantastic," an enthusiastic Gosa said. "He has just done a super job."

Also qualifying for Sectionals was pole vaulter Brad Jackson, who cleared the 12-0 mark for second place. "He had fewer misses so he ended up second," Gosa said, referring to the fact that Jackson tied with three other vaulters.

The lone other Indian to make it to the next level was distance runner Jeff Dirmeier, who took second in the 1600 (4:40.7). "He ran a real super race," Gosa said.

"That's his best time of the season by three seconds."

Dirmeier also added a fifth in the 800 (2:06.1), leading several other Indians who had excellent efforts.

Junior Jim Wichtoski bettered his previous best long jump by a half a foot, in taking third with a leap of 20-3. "It'll be nice to have him back next year," Gosa said of Wichtoski, who joined the team mid-way through the season.

"We had some other good things happen," Gosa continued, noting Dan Schulteis' third in the discus (136-10) and Brian Harycki's third in the 100 dash (11.54). Gosa also pointed to Jim Rix's fourth in the shot put (45.0.5), which also was a personal best, "almost two feet longer than he ever threw before."

The Indians' 400 relay team was probably the biggest disappointment for Gosa, but not because of their effort. The unit, comprised of Marx, Beau Coulter, Schulteis and Harycki, ran a 45.11 clocking, which was just .01 off the pace needed to be an extra qualifier for Sectionals. The unit ended up finishing fourth.

Lady Indians Strong Second at EW Meet

NEW HOLSTEIN — While he was happy with his team's finish in the Eastern Wisconsin Conference track meet here, last Thursday Kewaskum girls track coach Perry Koth's comments suggested that he thought the team could have done even better.

"If you told me at the beginning of the year that we were going to finish second at conference, I would have been very happy," Koth said, noting that his team was edged by Plymouth for the title, 95-89.5. "It (the EW) is a very competitive conference. It's just a credit to all of our girls (to finish that high)."

But with the way the season has unfolded, the Indians winning four straight Invitationals at one point, Koth sounded like he wanted number five very badly. "If everyone would have had average times or better," Koth said, "we would have won the meet. But that sort of thing happens."

Despite being disappointed that his team didn't win the meet, Koth was quite pleased with some of the efforts turned in.

The 1600 relay team (Kelly Korth, Ginger Wiesner, Missy Rohrer and Tina Schwartz) took first with a best time of 4:14.2, which represented a five-second drop from their previous best. "Their time was really outstanding," Koth said.

Korth also added a first in the long jump with a leap of 15-6, which "is a little below average for her. But all the jumps were down a bit."

The Indians recorded a total of six seconds, led by Robyn Winninghoff's pair in the discus (112-7) and high jump (5-0). Wiesner added another in the 400 (61.2), while Wiesner, Korth, Schwartz and Greta Kuphal teamed up in the 800 relay (1:50.1) and Korth, Kuphal, Schwartz and Jenny Heisdorf added another second in the 400 relay (52.5). Wiesner also added a third in the long jump (14-11).

"The 400 relay ran real well," Koth said, adding the 800 relay had a bad handoff (We actually had to stop), and "we still ran a good time. That's just .1 off their best time."

Christa Schmidt also recorded

her best time in the 300 hurdles, taking second in 49.6, while adding a third in the 100 hurdles (17.9), and then chipped in a tie for sixth in the high jump with her personal best of 4-8.

That tie enabled the Indians to pick up a half point, allowing them to finish second, .5 ahead of Two Rivers. "Sometimes you don't think those points add up, but this shows that they do," Koth said.

Jacak Wins EW High Jump Title

NEW HOLSTEIN — While the Kewaskum boys track team has made great strides this season, the Eastern Wisconsin Conference Meet showed the Indians that they still have a lot of hard work ahead of them.

The Indians, led by freshman Travis Jacak's win in the high jump, finished with 37 team points, good enough to beat Kiel (19) and keep the Indians out of the cellar spot. Two Rivers, on the strength of nine second or thirds, won the meet with 120 points, barely edging Sheboygan Falls (114).

Marx also had a hand in the 400 relay team's second place showing. The unit, comprised of Marx, Beau Coulter, Dan Schulteis and Brian Harycki, lowered their school record time of 45.2 but had to settle for the runner-up spot to Chilton (44.9).

The 1600 relay (Harycki, David Gosa, Heath Heise and Jim Wichtoski) added a fifth with their 3:42.2 clocking, while Brian Bruendl finished fourth in the triple jump (38-2), and Brad Jackson added a sixth in the pole vault (11-0).

"Everyone who competed did as good as they possibly could," Gosa said, referring to the numerous personal bests the Indians had in the meet.

MAYVILLE — Usually, 115 points is enough to win just about any invitational. But when you're talking about Regional track competition, just about anything can happen.

Also advancing for the Indians was Tammy Schmidt, who took second in the shot put with a toss of 35-2. "She's been in the 32-33 foot range," Koth said, adding Schmidt's advance "was nice to see. She is a senior, so that was great."

The Indians' two other relay teams also qualified for Sectionals. The 400 unit (Korth, Schwartz, Kuphal and Missy Heisdorf) took second in 52.72, while the 1600 relay (Wiesner, Korth, Schwartz and Missy Rohrer) were runners-up in 4:13.45. "They (1600 relay) knocked another second off their best time."

Junior hurdler Christa Schmidt was barely edged out in both of her events. Schmidt finished third in both the 100 hurdles (17.34) and the 300 hurdles (49.53). Schmidt and Sheboygan Falls' Nicki Sexton crossed virtually the same time in the 300 race, but Sexton was awarded second by

the judges. "That was a little disappointing," Koth said.

Mary Yahr was also close to making it, as she took third in the high jump (4-10). "She started the year at 4-4, so that's really great to see her finish strong like that," the KHS boss said.

Jenny Heisdorf also put up a personal best, taking fourth in the 100 (13.28), "her personal best by a couple of tenths."

KHS Girls Send Four, Plus Relay to State Meet

ORFORDVILLE - The Kewaskum girls track team certainly had its share of things stacked against it in the WIAA Division II Track Sectional here, last Thursday.

First, the bus the team is traveling on gets lost en route to the meet, giving long jumper Kelly Korth, who finished third at the State Meet a year ago, all of about five minutes to get ready for her event.

Then, the format of the meet has the Indians' Ginger Wiesner running her leg of the 800 relay, and then having to go directly to her open 400 race and run that, all within about ten minutes.

Next, one relay team has a bad handoff, while another unit drops the baton completely, forcing them out of contention in that race.

Nevertheless, the Indians managed a third place finish as a team, and in the process qualified four girls in individual events, and another relay to the WIAA State Meet to be held this weekend in LaCrosse.

"You can't ask for much more than this," KHS coach Perry Koth said of the results.

East Troy won the meet with 69 points, followed by Elkhorn (48) and the Indians (45).

Korth joined fellow senior Tammy Schmidt in qualifying for the State Meet by virtue of having one of the top eight finishes in the state. Korth, despite having little time to prepare after getting off the bus, went 16-1.5, good enough for third.

"She had no time to warmup, and in the trials, her jumps were really short," Koth said of the misfortune. "I was really happy to hear that she made it, because that would have been really hard to swallow."

Schmidt's qualifying was equally as exciting, as her throws of 35-3.5 in the shot put placed her third. But compared to the other

throws in Division II, Schmidt's toss was good enough to make it to LaCrosse.

"I'm really happy for her because she's a senior," Koth said.

As for Wiesner's trials and tribulations, the sophomore helped the Indians 800 relay team run their fastest time of the season (1:48.36) in taking second. Korth, Tina Schwartz and Greta Kuphal joined Wiesner on the 800 team.

Immediately after that, Wiesner was thrust into the 400 run, and she gutted it out at the end to hold off a runner from Parkview, and take second in 61.92.

"That took a lot of heart," Koth said of Wiesner's effort. "There's only about seven or eight minutes between races, so she's not as fresh as you'd like her to be. But she just runs as hard as she can."

The 800 relay's time, meanwhile, tied the school record, which coincidentally, Korth and Schwartz are also a part of, back in 1990. "This is our fourth straight year the 800 relay has qualified for state," Koth said proudly. "They are really tough."

Lost in the shuffle was the fine performance of Robyn Winninghoff, who didn't bother with having to wait an extra day to see if her discus toss was good enough. The junior went out and won the event with a throw of 119-8, her second best toss of the year.

"I'm really pleased with Robyn," Koth went on. "She's really peaking right now. That was just an outstanding throw."

The Indians other entries were unable to post good enough marks for state, though. The 400 relay team suffered one bad exchange and had to settle for fourth (52.46), which according to Koth, "is still a very good time." Jenny Heisdorf joined Korth, Kuphal and Schwartz on the unit.

The 1600 unit, meanwhile, was on pace to break the school

athlete was originally given Marx's time and place. But after a few phone calls Friday, the mistake was corrected, but Marx still fell just short of a berth at State.

"He just missed the qualifying time," Gosa said. "It was not one of his better days. He has a run a 40.5, and I really felt he would do better than that. I guess it just wasn't meant to be."

Another Indian who barely missed going to state was high jumper Travis Jacak, who finished third because of more misses. "He had a couple of misses along the way, but he was right up there," Gosa said. Jacak cleared the 6-1 mark.

Jeff Dirmeier decided ahead of time to go all out in the bid to win the 1600 run, and in the end, Dirmeier ran out of steam, settling for sixth in 4:56.85, a slow time for him.

"He went out and tried to run with the leaders," Gosa said, noting he faded late in the race. "I told all of them after the meet that where they placed should take nothing away from the year that they have had."

Jackson will now get ready for the State Meet in LaCrosse on Friday and Saturday. Jackson, however will do all of his work on Friday, with the pole vault competition slated to begin at 1:00 p.m. at Memorial Stadium on the UW LaCrosse campus.
