Winter Parking Ban Lifted Board Votes to Rezone Land for Subdivision

A sizeable contingent of village residents were in attendance at Monday's village board meeting to ask questions during a public hearing on the proposed new subdivision which will be located west of Edgewood Drive in Kewaskum.

The public hearing at the request of developers Gary and Linda Gavin of Kewaskum, was however, for rezoning purposes only. The Gavins were asking to have the parcel of property located adjacent to Edgewood Drive rezoned from AG-2 Agricultural Land District to R-1 Single Family Residence District.

Although the public hearing was for rezoning purposes only some questions from the audience were addressed. Layout of the subdivision and other matters regarding the same, were to be brought out at Tuesday

evening's Plan Commission meeting and more will be published about that in next week's issue.

To clarify the rezoning, Village Administrator Dan Schmidt explained the rezoning being discussed was the land zoned Agricultural Land District to R-1 Single Family Residence District. There is also a portion of land in the area in question which is currently zoned Conservancy District. Schmidt said, "The Conservancy area

actually stays Conservancy with the determination of those boundaries being further decided by the Army Corps of Engineers and the DNR at a later date." Gavin said the Army Corps of Engineers would be returning sometime in May or June to do further study.

Answering questions brought forth by Trustee David Goeden, Schmidt further explained, "R-1 is the best single family zoning that we have. It calls for a mini-

Two Kewaskum middle school students will have the opportunity to visit Australia and New Zealand this summer as Student Ambassadors of the People to People International program.

Easter Egg Hunt at River Hill Park Apr. 2

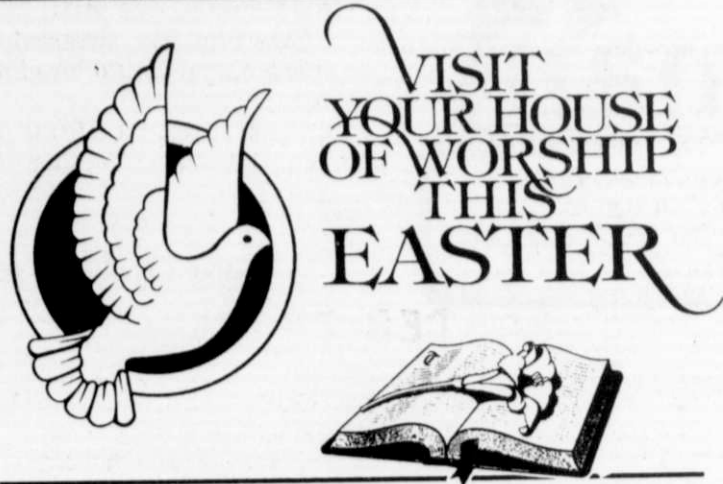

of 10,000 square feet per lot and the smallest width is 75 feet. If an area is in the Conservancy... a lot can have Conservancy area in it, you just cannot build on that Conservancy area. It can be used as square footage as part of that 10,000 square feet."

Trustee Tom McElhatton added the only time the village board has ever denied R-1 rezoning was when the lots did not measure up in square footage required.

After further discussion, the public hearing was closed with the understanding the voting would take place later on in the meeting.

In other matters brought before the board, the village's winter parking ban was lifted with the understanding if a snowstorm were to occur, a snow emergency would be declared.

It was also announced the date set for the Village's Spring Cleanup Day would be the first day of Earth Week, Saturday, April 23, from 9 a.m. to noon. All residents are encouraged to participate and more information on this will be forthcoming from future meetings.

Upon coming to the portion of "New Business" on the agenda, the Board took action regarding the request of the Gavins for rezoning. The motion was introduced by Trustee Harry Roecker and made by Trustee Tom McElhatton, seconded by Trustee David Goeden. The motion to rezone the parcel of property in question from Agricultural Land District to R-1 Single Family Residence District passed unanimously with Trustee Gary Gavin abstaining from voting.

Village Administrator Dan Schmidt commented that other than the Gavin subdivision, there are only 32 vacant lots in the Village with 18 of those already sold for housing. This leaves only 14 available lots in the Village.

Trustee David Goeden also addressed the board, saying how pleased he was to welcome new residents into the village through the single family housing development.

Town of Kewaskum Covers Light Agenda

The Town of Kewaskum Board quickly and efficiently covered agenda items at their monthly meeting on Mon., March 21st.

Myron Strobel of Strobel Propane Gas Company came before the board requesting a zoning change in one acre of land for possible future business expansion. This acre would add to an adjoining two acre parcel Strobel currently owns.

Dan Stoffel requested permission and presented plans from Gerald and Alan Stoffel to construct a manure pit for dairy steers at their farming operation on Highway 28.

On the recommendation of the Plan Commission, the board approved both requests.

Town Clerk Barbara Wenzlaff distributed to board members a revised Recycling Ordinance which is scheduled for approval at the April meeting. The ordinance has been updated to comply with the Department of Natural Resources requirements for recycling in municipalities.

Chairman, George Allmann read a letter received from Gehl Company of West Bend thanking the township for allowing the company to rent and use the community building and garage area for a four day training session for their mechanics from around the state. Many favorable compliments were received on the facility.

50 Years Ago

March 3, 1944

Mr. and Mrs. George Reindl of this village, received a letter from their son, Pvt. Roger Reindl, informing them that he is now recovering in a hospital from a bullet hole through the leg, suffered in action against the enemy on the fighting front in Italy. The bullet tore through one of his legs at the shin, breaking the leg. He writes that he was saved by a miracle. He was decorated for his action against the enemy by being awarded the coveted Purple Heart medal, which he says doesn't heal his leg any. Roger is the second known Kewaskum man to receive the Purple Heart. The other was Seaman Robert Romaine, who lost his life in action with the navy, and was awarded the decoration posthumously. Pvt. Reindl has been stationed overseas the past five months. He entered service on April 29, 1943 and after taking his basic training he attended a communications school. He was given a furlough and was later sent overseas. He first arrived in North Africa, where he was stationed for some time before being transferred to Italy. Roger was with a communications unit and it is believed that he may have been wounded while delivering a communication. He is a graduate of the Kewaskum High School and was employed at the L. Rosenheimer Store here, before entering service.

Ten Washington County men were accepted for military service over the weekend at the Milwaukee induction center, according to local draft board. Three of the men accepted are from Kewaskum, two of them being from the village. Those from the village are Gilbert Korth, son of Mr. and Mrs. David Korth, and Oliver Eichstedt, son of Mr. and Mrs. Art Eichstedt. Korth was employed by the Kewaskum Creamery company and was a

member of the village basketball team. Eichstedt was an employee of the Kewaskum Aluminum Company. Eichstedt was accepted for the marine corps Friday and left for the service immediately without a furlough. Korth was called back for another examination Monday and after being accepted for army service also left immediately. One Kewaskum selectee was rejected.

Lillies, white snapdragons and spring ferns massed on the altar of St. Bartholomew's Episcopal Church at White Plains, New York formed the setting for the candlelight wedding February 26 of Miss Dorothy Jean Higson, daughter of Mr. and Mrs. Francis Higson, of White Plains and Lt. Robert John Rosenheimer, army medical corps reserve, son of Mr. and Mrs. Lehman P. Rosenheimer of Kewaskum.

Mrs. Adelyne Kuehl of Route 2, Kewaskum, received a letter from her husband, Pfc. Wesley Kuehl, who is stationed somewhere in England, informing her that he had suffered a broken leg in a fall on some pavement. He is now confined at a general hospital out of camp. The accident occurred early in February. Pfc. Kuehl is the son of Mr. and Mrs. Albert Kuehl of Route 3, Kewaskum.

Cpl. Clyde Darmody, 25, son of Mr. and Mrs. Mike Darmody, Route 3, Kewaskum, is stationed in the Fiji Islands in the South Pacific. A graduate of the Kewaskum High School, he was inducted in April, 1941. He was stationed at Camp Livingston, La., for more than a year and was sent to New Zealand in May of 1942. He had furloughs before going overseas. Clyde is in the quartermaster corps.

50 Years Ago

March 10, 1944

Mrs. Edna Walters, Route 2, Kewaskum, Town of Farmington, who was advised in January of 1943, that her son, Tech. Sgt. Joseph H. Walters, was missing in air action in the western European area since January 3 of that year, received a letter from the adjutant general's office, Washington D.C. recently which terminated a year of uncertainty surrounding the fate of her son. He has now been presumed dead by the war department after a year's fruitless search for evidence of his possible survival. Tech. Sgt.

Walters is the third Kewaskum young man to lose his life in the war. The other two were Seaman Second Class Robert Romaine, son of the Elwyn Romaines of this village, who lost his life in action at sea with the navy and Machinist Mate Second Class Ray H. Buddenhagen, son of the Arthur Buddenhagens of Route 2, Kewaskum, who lost his life in action with the coast guard at sea.

In last week's issue we printed a story about Pvt. Roger Reindl of this village being shot through the leg in action in Italy. Since then another young man from this community has been reported wounded in the same theater of fighting against the Germans. He is S./Sgt. Joseph L. Weitzer, son of Mrs. Mary Weitzer of the Town of Auburn, who was hit by shell fragments in his left hip and right side. Mrs. Weitzer received word of her son being wounded from his wife, Mrs. Rhoda Weitzer, whom he married after entering service. She is residing at Grand Island, Nebraska, while her husband is serving his country. S./Sgt. Weitzer is a veteran of the Italian fighting. He accompanied the Allied troops in the initial landing at the start of the fighting in that country, after seeing previous action in Sicily. Sgt. Weitzer was in the field artillery and was a member of a five man gun crew. He attended the Holy Trinity Parochial School in Kewaskum and before enlisting in the army, was employed at Fond du Lac.

Twenty-two men were accepted for service from Local Board No. 3, Sheboygan County, and left for active service recently. Thirteen of the men left for service in the navy, among them being Lloyd J. Reysen, of Kewaskum route.

As the final semester of school gets underway at Kewaskum High School, the students attention is turned to plans for the annual Junior Prom. Leland Schaub, this year's king, announced Wednesday to the junior class that his queen will be Shirley Backus. This is the second time this school year that Shirley is serving as queen. She was Ralph Koth's queen at the homecoming. The prom will be held in April.

VILLAGE OF KEWASKUM NEW NOTES CORRUGATED CARDBOARD

Type of Corrugated Cardboard: The cardboard that peels apart with two outside layers is corrugated. The middle section not exposed is wavy corrugated.

Colors: Some waxed and pressed cardboard may also be recycled.

Preparation: Flatten boxes and cut into 3' x 3' pieces. Tie in bundles with twine or strong string. Bundles should be limited to 8" in height.

Place bundles at the curb next to the dark green recycling bin or blue recycling bag. Place the bin or bag, at the curb on the same day that your solid waste is to be collected. Pick up will be Wednesdays for both solid waste and recyclables. Multi-family dwellings of six or more remember your recycling pickup will be the 1st and 3rd Wednesday of each month.

NOTE: If raining on collection day, please hold cardboard until the following week.

Maple Tree Road Residents Must Specify Address Location

Town of Scott officials have received word from the Sheboygan County Sheriff's Department and the county planner that problems have arisen in the "911" system for residents of Maple Tree Road.

It is of utmost importance that residents living north of Hwy. S on Maple Tree Road designate their addresses as North Maple Tree Road. Those living south of Hwy. S should use Maple Tree Road as their address designation. Without these specific names, there is confusion when dispatching rescue and ambulance equipment.

Future reimbursement to Town of Scott officials who use their vehicles for town business will be paid 25 cents per mile. For nearly 10 years the rate has been 20 cents per mile.

Another topic was snow around the town hall's flag pole. Several voters complained that the American flag was not flown during the last election, and they would like to see it displayed on the outside of the building as well as inside (as it is now during winter elections).

Another suggestion was to shorten the flag pole and to install a light so it could be displayed around the clock. Final action was to direct the town's highway personnel to make sure that the area around the flagpole

be free of snow during all elections.

Gerhard Held has been appointed to a three-year term on the board of appeals, expiring in March 1997. Glyndon Zoehner was given a similar term on the board of appeals.

A number of changes in the recycling operation were suggested by the attendant, including the installation of a phone and a toilet.

Although a phone is located in the adjacent town hall, it was felt that the time needed to go to that building, unlock the door, and dial the phone could be a matter of life or death. Supervisor Clara Trapp suggested that a portable phone could solve the problem.

Regarding availability of a rest room there is one available in the adjacent town hall.

Another item is the ramp used to deposit garbage into the dumpsters. One side is guarded with an iron railing, but when the ramp is reversed there are only rope railings. A committee is looking into adding an iron railing on the rope side.

Users of the transfer site will be asked to "sign in" for the next six months. This list is required for obtaining grant money, and each user will be asked to "sign in" only once even though they may use the site a number of times during six months.

Several zoning changes were approved. Badger Beagle Club has gone out of existence, and has sold a 40-acre parcel at W9199 Brazelton Drive in the western part of the town. It has been split into two 20-acre parcels and the zoning changed from P-1 to A-5.

A zoning change from A-3 to B-3 was approved for property owned by Mark LaFever and others, allowing them to utilize several existing buildings as mini storage units located on Hwy. A, near Hwy. 28.

Reports from a special meeting held earlier in the month indicate that the transfer station attendant wage has been increased from \$6 to \$6.50 per hour, effective March 5, 1994.

Also effective on that date the wage for a "trained" part-

time and back-up employee for summer work will go to \$7.50 per hour. The "trained" part-

time back-up worker for winter road work will be paid \$11 per hour.

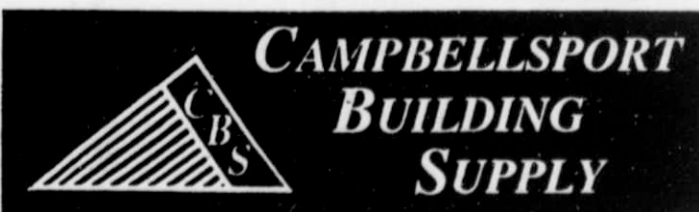

Ask the Village Board President...

ABOUT THE VILLAGE

EDITOR'S NOTE: This week *The Kewaskum Statesman* is premiering the first segment of what we hope will become a regular weekly feature column in the newspaper.

The column called, "Ask Your Board President," was initiated a few weeks ago, in hopes of opening the lines of communication between village and school district residents and the board officials we have elected to represent us.

The column is NOT designed to be used to lambast the presidents nor to carry out a personal vendetta disguised under anonymity. The column should be used to ask legitimate questions or give concerned opinions on our current issues being addressed by our local elected government officials.

We would have liked to have received more letters by this time to keep on file so the column can remain ongoing. Perhaps we are just experiencing a "slow start."

We ask that your letters be addressed to the "Ask Your Board President," column, c/o *The Kewaskum Statesman*, P.O. Box 98, Kewaskum, WI 53040. All letters must be signed, HOWEVER, the names are covered up before the copy is made to forward to the presidents.

So if you have a complaint or you do not understand the reasoning behind some of the decisions made by our local boards... please write them down and send it in to this column.

If you have concerns, it is a pretty safe bet to assume someone else does also. Your issue just might be the one we are all curious about. Hopefully, through this column we may all have a say in how our elected officials respond.

The first letter we received was directed to our village board president, Robert Wagner, and it stated:

"Now I finally see why West Bend is getting more of the small industry - they are developing their 3rd industrial park! What are we doing in the Village of Kewaskum - buying a building for future downtown parking. Who pays more of the taxes - small businesses and industry, or parking lots? Start looking south and maybe we can annex to West Bend."

ANSWER BY VILLAGE BOARD PRESIDENT ROBERT WAGNER:

I consider myself very pro business and industry. I would say as Village President the loss of business in the Village is one of my biggest concerns.

I haven't been very public about it up to this time, but you will hear more in the future. I've been doing many behind the scenes work on keeping the business and industry we already have and ways to attract more.

I have been meeting with the Chamber of Commerce and have had Village Administrator Dan Schmidt investigate some

new ideas. I have had meetings with Marcia Theusch, the Director of Washington County Economic Development and have been in contact with the Department of Development in Madison in regards to "The Main Street" program which is involved with downtown revitalization. I have also talked to people about Wisconsin's Ethnic Settlement Trail on a way to promote OUR heritage and increase our tourism.

The Village Board and Plan Commission is currently working on the SEWRPC study for our area which will help us plan our growth.

About the time I got on the Village Board as a trustee, the Village was trying very hard to develop an industrial park on the northeast side of the village, but to no avail. We even had our first tenant lined up which was Badger Packaging, who as we know later moved to West Bend.

One of the many reasons the industrial park didn't materialize was problems with the Town of Kewaskum. I was very frustrated when the industrial park died. I haven't given up on the idea of the park. I feel two possible areas for an industrial park would be the south end of the village, along Hwy. 45 or the northwest end of the village

somewhere around Hwy. 28 and 45. Right now they are only ideas.

I think right now a bigger concern of mine is the downtown business district of the village. As we all know, there has been an exodus of small business in the village. The downtown area is dying a slow, cancerous death and it's going unnoticed by many of us.

I feel we need to do something about the look and character of the downtown area. One big problem the business community is having is lack of parking and it's only going to get worse when Hwy. 45 is upgraded. This is one of the reasons why the village purchased the West Bend Savings Bank building... for the added parking... and also to guarantee the building would not be razed. Because as we all know, it's one of the nicer looking buildings in the village.

Right now the village doesn't have any definite plans for the building except the added parking. I must say the board is "all ears" on what to do with it, that is why the village board had a meeting with the Chamber of Commerce and invited surrounding businesses to comment about its future. We would even be interested in selling it to the right developer.

Long before I was on the

board the village also tried to develop a parking area downtown but to no avail, due to opposition, again.

Your comment about annexation to the City of West Bend upsets me very much. It's that kind of thinking and talk that will destroy the village and lose our identity. The day that would happen would be over my dead body.

There are way too many people in this village that are content to have Kewaskum be a "bedroom community" for Milwaukee, Fond du Lac and West Bend. I'm not a native of Kewaskum, but I consider myself an "adopted" native. I'm like a little kid, full of excitement over MY village and I'm very proud to live here. I am always talking up Kewaskum, no matter where I go.

As I mentioned earlier, we have an exodus of business from the village. Well, did you ever wonder why? Businesses are in business to make money and if they don't, they will leave the community or fold up.

So the next time you, or we, hop in the car to go to West Bend, Milwaukee or Fond du Lac to do our business... do a little soul-searching on the way there and ask yourself, "What about the business people in Kewaskum?" The best way to keep and attract business is by supporting them.

I hear complaints that a local resident is buying up the old business places and converting them into rental apartments. Well, if no businesses are willing to open up shop, then what should happen with the buildings? So let's get out and support OUR town and work on ways to improve things.

I would hope now that you know my concerns about our business and industry, but right now I need input and help from everyone in the village on ways to turn things around. I must thank you for a very good question, and I would hope others will do the same.



To the Editor:

I received a mailing from the School District of Kewaskum regarding the remodeling plan for which they want to pass a referendum to borrow \$5.3 million. I don't disagree that the remodeling is needed, but I do question the need to borrow the money.

I checked prices at two private schools, one of which was parochial. At the parochial school, the cost for one student was \$2,250 for one year. At the private school, the cost was \$3,120. These figures include transportation.

I called the School District office and was told that the

1993-94 budget was \$10,897,408 and the enrollment in the district was approximately 1,750 students. This works out to a cost of \$6,227 per student per year.

If it costs the district \$6,227 to do what a private school can do for \$3,120, I say that we don't need to borrow money, we just need to spend the money we have better. The administration may argue that they provide more services and activities than a private school, but I don't believe they provide \$3,100 more. All they have to do is cut the cost per student by \$1,000 per year, and in three years they will have the \$5.3 million we need.

On April 5th, I'm going to vote against the referendum.

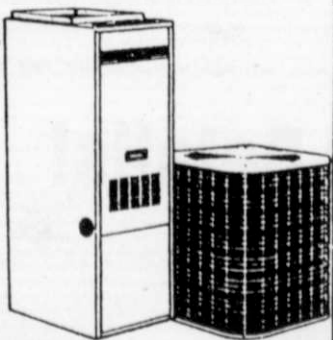

Mark your calendars!

The Spring Conservation Rules Hearings will be held in each Wisconsin County on Monday, April 11, 1994 at 7 p.m.

One of the Rule Proposals on the hearing agenda is:

To extend the pheasant season to December 31 and increase the bag limit to two per day for all of the season, except opening weekend when the bag limit would be one.

Wings Over Wisconsin's Executive Board of Directors opposes a longer pheasant hunting season!

Wings Over Wisconsin has 18 Chapters of which 8 have pheasant projects. Each project is at least 8,000 continuous acres.

These Chapters work with and pay private land owners for food plots, winter cover and nest cover. Pheasant numbers have increased but not enough to sustain additional hunting pressure. I believe hunting in December disturbs hens and roosters in their winter cover and makes them more accessible to predators.

With the future of the CRP program in doubt, now is not the time to increase hunting pressure.

If Wisconsin is going to be like South Dakota and Iowa, then our hours have to change: South Dakota - 1st week - 12 noon to sunset; after that 10 a.m.

to sunset; Iowa - 8 a.m. to 4:30 p.m. - this lets birds get out of their roosting cover and into the food plots.

DNR opinion as printed in Rule Change Listings. Pheasant Season and Bag Limit (1995)

Pheasant seasons currently ends about a week into December. This closing date is earlier than in most midwestern states and some of these states have recently extended their pheasant seasons even longer. Roosters-only hunting does not affect future pheasant populations. One rooster can breed 8 or more hens. Wisconsin's winter sex ratio surveys show relatively light hunting pressure; most areas have between 1.5 and 3 hens per rooster following the hunting season. Extending the December closing date would allow hunters more opportunity without harming existing populations. Most of the corn is harvested by December and there is a greater chance of a tracking snow. This can be particularly beneficial for those without a dog. The department proposes a December 31 closing date for the pheasant hunting season. The Conservation Congress Upland Game committee unanimously endorsed this proposal at its December, 1993 meeting.

The daily bag limit is currently one pheasant during the first two weeks and two per day thereafter. This rule's purpose was to spread the pheasant harvest among hunters during the first two weeks when most of the pheasant hunting pressure occurred. However, pheasant hunter numbers have dropped nearly two-thirds during the last 10 years and hunting pressure seems to be more evenly distributed through the season. Except for the opening weekend when hunting pressure is quite high, the daily bag limit could be raised to two pheasants per day without causing hunter crowding or affected pheasant populations. The department proposes a 1-pheasant-per-day bag limit for opening weekend followed by 2-pheasant-per-day bag limit thereafter.

Dear Editor:

Every election year since most of us can remember, the state legislature has come up with some scheme that is designed to win favor with property-tax-weary-voters. Last fall it was a referendum proposal that sounded so good that 60 percent of the voters told us in August they would be inclined to vote for it. In effect, the legislature asked us to TRUST THEM to reduce our property taxes by finding someone else to pay them. Three months later, when voters understood what a pig in a poke they had before them, 70 percent voted NO on amending the Constitution. Was anybody in the Capitol listening? Apparently not.

This year, Assembly Democrats are once again trying

to ensure success at the polls in November by proposing a bill that promises to take all school funding off the property tax next year. And, just like last time, they'll let us know AFTER the election how they are going to come up with alternative revenues. Actually, they have put the lightning rod in the Governor's pocket by proposing to name him as chair of a committee that is supposed to recommend what new taxes to raise. Clever ploy in an election year.

No one has made the case that taking schools off the property tax is good for taxpayers or good for education. There is strong evidence that there will be more tax losers than gainers if the Assembly proposal were to become law... renters, and property owners who itemize deductions to name two. And it can easily be demonstrated that a totally state funded school system produces inferior educational results to one that relies on some local funding and some local control.

Somehow voters have to send a message to the Legislature that we are not interested in election year gimmicks about property tax relief. We ARE interested in slowing the rate of

growth in local school spending so that it is more in line with our taxpayers' ability to pay. Absent some kind of control on local spending, all of these property tax shifting schemes are merely green lights for more local spending. Taxpayers get it. Voters get it. Why can't legislators?

To replace the \$2.9 billion property tax levy for schools with alternative revenue collected at the state level, Wisconsin would have to adopt the highest corporate tax rate in the nation, the highest sales tax rate in the nation, AND, the third highest personal income tax rate in the nation. That would generate \$2.9 billion. It would also raise havoc with our economy... which is much stronger than most. It is understandable why those in the legislature who support this irresponsible legislation want to wait until after the election to get into those details. That's why it is important for those of us who are justifiable nervous about the alternatives to speak up now.

State Senators and the Governor should be urged to stop this foolishness before we plunge Wisconsin into fiscal chaos.

A Message from the Postmaster

Hello Kewaskum Statesman readers and how are you all doing today? In this week's column, I am going to report on some areas that were requested by you --- our customers!!

Postal Exams and 1-800-numbers: A customer came in this week to inquire about an ad in a paper concerning Postal employment. She told me that there was a "90 day money-back guarantee for any dissatisfaction including not getting hired by the Postal Service during this time-frame."

This was a "new" one for me and I requested that she bring in the phone number and I would call it myself to get further information. Within moments, she came back with the phone number. I dialed the number and a pleasant voice answered the call.

She first of all asked me, "is this your first call to our service?" I responded that it was. She then went on to tell me what my cost of \$39.95 would give me: "A listing of all postal jobs available in my area, salary ranges for each of these positions, a "study guide" with answers that would assist me in the REAL Postal exam, and--best of all--a 90 day money-back guarantee if for any reason I was unhappy with their services.

She went on to say, "do not believe Postmasters who tell you that there is a "hiring freeze" and/or that they are not hiring as our company knows that they are!!" My first question to her was: "Are you telling me that within 90 days, I can get my money back for whatever reason." She said "Yes!" I then said "You mean to tell me that if I would not be hired by the Postal Service in the job that I want and the locale that I desire within 90 days, I could get my money back?"

She repeated, "for whatever reason you are unhappy with our services, there is a money-back guarantee." I then said to her, "I am going to level with you. I am a postmaster and just where do you "get off" telling people not to believe Postmasters if they say that they are not hiring?" (There was silence on the other end of the phone). I then went on to tell her that I felt it was illegal that her company could guarantee a position with the Postal Service within 90 days and that would enable a person that did not get hired to receive their money back.

I told her that I considered this a scam. She then said, "We are with the Better Business Bureau and have been for years." I then said to her, "I have this phone number brought in to me by a concerned customer. I have your name and am going to promptly notify the Postal Inspection service of this conversation." Well--guess what? She did not even say "goodbye" as the phone clicked in my ear!!!

Thank you to the customer that brought this information in to me and please do not get "caught up" in this, what I clearly see as a scam. First of all the study guide that she refers to is easily available at any library. It

is called the Clerk/Carrier Study guide and will give you sample questions and answers that are on the test. Your cost? Absolutely free to "checkout" of the library.

Secondly, the Kewaskum, Campbellsport, West Bend and other area offices are not hiring at this particular point and time. If and when our current hiring register gets "low" the test will be given. This will only establish a register for future employment. If and when the test is to be given in the area, you will find out about it in this Kewaskum Statesman and it will be posted in popular businesses in the area.

As your Postmaster, I advise you not to call 1-800 numbers and/or spend money concerning Postal exams. None of this is done by the Postal Service -- just private firms out to make a "fast buck".

Unwanted/unordered merchandise received in the mail: A number of customers have called or stopped in about this matter. Have covered it before but -- you may want to cut this out and save it for future reference okay? If you receive something in the mail that you did not order -- you have a right to keep it, that is the law!!! Many packages state "return postage guaranteed" or "address correction requested" or "forwarding/return postage guaranteed."

You can return these completely free of charge only if you open no part of the package and that includes the envelope on the outside of the package. Opening any part of the "above mentioned" means that if you want to return it you will have to pay the postage. So what can you do if you receive something like this? This is my suggestion: Like many of you I would open at least the envelope as I would not know what it was that I received.

After that, "remembering the law," I would keep it. Then the billings start. Ignore them.

The one that gets most people is the one that states "this matter is being submitted to a collection agency!" Upon receiving that most people are just going to either pay the postage and return the item or just pay for it and keep it, not good in either of these choices as you just become a prey to future unwanted/unordered merchandise!

Please do this, if there is an 800 number call it. If not the cheapest type of communication is a 19 cent postcard. State this on your card: "The Postal Service has advised me that unordered merchandise, by law, is mine to keep. Unless you can show me my signature that I did order this, I am keeping the merchandise. If however you wish

your goods returned, send me the amount for postage return (this can be known by bringing the item into the Post Office for weighing) and I will return it. Other than that I consider this matter completely closed. Future occurrences will be reported to the Postal Inspection Service."

This will stop it! Please, do not fall prey to unordered merchandise and remember if you do order something and do not like it you must pay return postage upon opening any part of the package (including the envelope).

That is about it for this week and a big thank you to the customers that assisted in the information for this week's column. I totally enjoy writing this column for you. Have a good day -- a happy everyday.

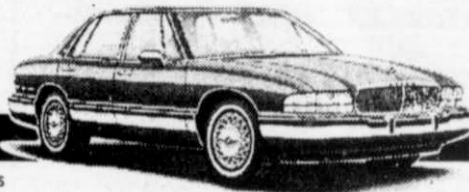

KEWASKUM - The accolades continue to pour in for Kewaskum senior Ginger Wiesner.

Named the Eastern Wisconsin Conference Co-Player of the Year just last week, Wiesner was named to the All-Washington County squad. The inaugural selection process was for players from county schools only.

Wiesner was a first team choice for the squad, was one of four seniors named to the first unit. Kewaskum senior Missy Radtke, a 67-2 center, was named to the second team.

Wiesner averaged 16.3 points per game in the EW this past season, and was a major force on defense as well. The 5-7 guard led the Indians with 47 steals, keying the Indian full-court press. She also led the team with 38 assists, and was tops in the conference in free throws made and attempted.

Radtke, meanwhile, led the conference in rebounding, collecting 125 caroms, including 58 on the offensive end. Radtke also added 6.1 points per game and led the league in blocked shots, averaging over

seven per game.

Other members of the all-county first team included Hartford's Jenny Thunin and Chris Fehring, West Bend East's Jane Kieckbusch, Slinger's Jamie Spiel, and Kettle Moraine Lutheran's Kate Lepein. All but Fehring and Kieckbusch were unanimous selections.

Joining Radtke on the second unit were West Bend East's Sara Smith and Jami Ritger, Slinger's Mary Wattenbach, Germantown's Jessica Olsen, and Kettle Moraine Lutheran's Chrissy Anderson.

Offensive Woes Eliminate Girls in Regional Opener

KEWASKUM - Never before in his coaching career had Kewaskum girls boss Glenn Eichstedt lost an opening round game in the WIAA Tournament series. Ironically, his first such loss may have been his last.

The Lady Indians never got things going on the offensive end of the court in their Regional opener with Mayville here, two weeks ago, on a Thursday night. The result was a 42-32 loss that ended the season for Kewaskum, which finished with a 10-11 record.

After the contest, Eichstedt reported that he had decided last month to step down as the Indian boss, handing in his resignation (see additional story).

"I was trying to avoid that (a first-round loss to the Cardinals) at all costs," Eichstedt said of the game. "It's kind of ironic, because my last loss in high school (as a player) was against Mayville."

The Lady Indians started slowly against the Cardinals, who entered the contest with a 17-game winning streak. Mayville jumped out to a 7-0 lead before KHS knew what had hit them.

"It took us a while to get going," Eichstedt said, explaining that a lack of practice may have hindered his club. After several regulars were unable to attend last Monday's practice, the team had a full workout Tuesday. An off day of school the following day left the team with just one full practice in nearly a week.

"I felt that turned out to be a factor," Eichstedt said.

Nevertheless, the Lady Indians battled back to tie things at 9-all late in the opening period. A basket and free throw enabled Mayville to regain the lead at 12-9 after one quarter.

The Cardinals extended the margin to 22-16 by halftime, and Eichstedt knew that his team wasn't executing offensively.

"We just weren't in the flow of the normal offense," he said. "The last couple of games (in the regular season), we were moving the ball around. This time, we didn't seem in sync."

The Cardinals backcourt duo of Heidi Bartlet and Jaime Milz helped to extend the lead to 31-18 midway through the third period. Milz led Mayville with 13 points, while Bartlet added 11.

"We didn't think they would be the ones to hurt us," Eichstedt said, explaining his defensive scheme was designed to stop Christy Keller inside. "We didn't want them to hurt us

inside. But they hit a lot of wing shots instead."

Mayville maintained a 35-22 lead into the final stanza. But the Lady Indians rallied, outscoring the guests 10-4 to pull to within seven, at 39-32 with just over two minutes remaining.

But that was the last of the KHS scoring, as Mayville hit their free throws down the stretch to hold on.

"I never really felt like we were being dominated," Eichstedt said of the loss. "I think that we were capable of playing better than we did. We left that night feeling like we didn't give it our best effort."

Much of that had to do with Mayville's defense, which limited KHS' leading scorer, Ginger Wiesner, to just eight points. After chalking up 81 points in her final three regular season games, Wiesner simply couldn't get untracked against the Cardinals.

"She seemed like she was hurrying things," Eichstedt said, pointing out that Mayville changed its defenses regularly. "We may have been trying too hard to get back in control of the ballgame."

"They (Mayville) are not the kind of team that beats themselves," Eichstedt said in praising the Cardinals. "I just really feel bad for our seniors."

The Indian seniors led the team offensively, as Wiesner and Missy Radtke each scored eight points, and Ali Bruendl added five. Eichstedt was even

more disappointed because he learned that KHS' lone other senior, Tricia Butschlick, may have been able to attend the Idnians' next game had they beaten Mayville.

Butschlick was hurt in an automobile accident in December, and has been recuperating from her injuries ever since.

"We had her on our minds," Eichstedt said of the team's desire to have Butschlick on hand. "We were looking forward to that possibility."

Instead, the Indians have to look to next season, and will do so knowing the returning players will play for a new coach.

"This may have been one of my best years here, because the chemistry of this team was so strong," Eichstedt said.

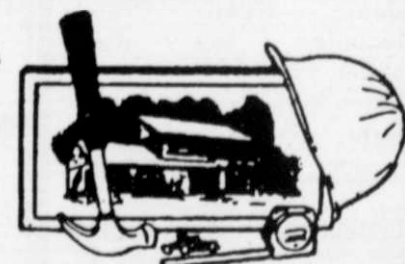

Eichstedt Resigns As Head Girls BB Coach

KEWASKUM - Kewaskum girls basketball coach Glenn Eichstedt's resignation was accepted by the Kewaskum School Board last week, after he notified officials that he was stepping down as the Lady Indians' boss.

Eichstedt said that he actually had decided to resign last month. His intentions became official after the Lady Indians were ousted from the WIAA Regionals by Mayville, 42-32.

"I just felt it was the right time to do that," Eichstedt said of leaving the post he has occupied the last five years. "I'm not leaving for any kind of negative or bad reason."

Eichstedt said he has even left the door open to return in the future.

"Nothing is forever," he said. "I'm leaving for awhile, at least. If they need some help down the line... (maybe he'll return). Right now, I want to commit more time to my professional studies."

Eichstedt said he is planning on finishing his masters studies at Cardinal Stritch University in Milwaukee. He is seeking a post-graduate degree in curriculum development, with an emphasis on study skills. He also expressed his desire to spend more time with his own family.

Eichstedt has been the Indians' head man since 1989, when he guided the team to a 14-11 record in his initial year. That year, he came within a game of taking KHS to the State Tournament in Madison. Last season, the Lady Indians finished one game back in the Eastern Wisconsin Conference race. All totalled, Eichstedt's five-year record with KHS was 50-61.

"I had the rare opportunity to return to my home town and enjoy the support of the community," Eichstedt said. "For that, I will be forever grateful."

Eichstedt sincerely wanted "to express my gratitude to all the young ladies that I have had the privilege of coaching." He added that while scores and sta-

tistics are quickly forgotten, "what stays with you over time is the quality of the people involved - their interesting personalities, and the intensity of their efforts."

"We always came close, but could never get over the hump,"

Eichstedt said of his team's near successes. "But I have nothing but appreciation and gratitude for the players and fans associated with my coaching years. You can't take away those memories."

Even though his coaching

days may be over, his philosophy regarding the game will stay the same.

"All you can ever do is to help get the players in position to be successful," he said. "What they do with that opportunity is largely up to them."
