## Volleyball Tournament Here To Benefit Muscular Dystrophy

For several years, area volleyball enthusiasts have had an opportunity to raise funds for an important cause while having fun by participating in the Muscular Dystrophy Volleyball Tournament on Labor Day weekend held in conjunction with the Jerry Lewis Muscular Dystrophy Association (MDA) telethon.

This year, organizers are joining forces with members of the Kewaskum Fire Department in hopes of sponsoring a bigger and better tournament. The tournament, scheduled for Saturday and Sunday, August 25th and 26th, will be a co-ed double elimination event held at the American Legion Hall in Kewaskum. Play will begin at 11 a.m. on both days. Food and refreshments will be available. Funds raised will be presented to MDA.

Kewaskum Fire Depart-

ment members have gotten involved in fund raising for MDA since the muscular dystrophy diagnosis of Jerry Zorn. Jerry is the nine-year-old son of Gene and Sandy Zorn. Gene has been a dedicated member of the department since 1988 serving the Kewaskum area as an Emergency Medical Technician and a firefighter.

Last year fire department members conducted a "Fill the Boot" campaign. The response received from Kewaskum and the area was heartwarming and overwhelming.

The past year has been difficult for the Zorn family. There have been good days and bad and at times, not easy to cope. Additional family members have been diagnosed with muscular dystrophy... Sandy, Brittany, age 4, and Matthew, age 3. Just recently, the Zorn's oldest son, Zach has experienced some symptoms that will require medical attention.

The Zorns take one day at a time as the progression of the disease varies from person to person.

The highlight of Jerry's summer was his attendance at Camp Wonderland, a camp designed for handicapped children in Kenosha County for one week. What a week it was! Jerry was one of 62 campers who enjoyed a delightful week of water games, cookouts, sports, campouts, arts and crafts, computers, swimming, boating, fishing, bowling, star gazing through a telescope, scuba diving and snorkeling.

The campers participated in various degrees depending on their physical capabilities but what impressed Sandy the most was the kids were laughing, feeling very normal and comfortable in this setting.

## Lions Kettle 20+2, Chicken BBQ Sunday

Get your running shoes ready because it's time once again to face on foot the rolling hills and scenic terrain of the Kettle Moraine State Forest, as competitors from across Wisconsin and neighboring states converge in Kewaskum for the Kettle 20 race.

The 20 kilometer event (12.4 miles) will be accompanied by three easier runs, 3.5 and 5 miles, and will include various mens' and womens' divisions. The foot races are sponsored by the Kewaskum Lions Club, and held in conjunction with their annual chicken barbecue at River Hill Park, scheduled for Sunday, August 13.

The race begins at 8:30 a.m. in the park, located along the Milwaukee River. Registration begins at 7:30 a.m. up until the time of the race, or they can also be

taken in advance.

Divisions for the Kettle 20 are as follows: six men's age groups: 1-17, 18-29, 30-39, 40-49, 50-59 and 60 and over. There are five women's age groups: 1-17, 18-29, 30-39, 40 and over, and 50 plus.

Top male and female runners will each receive a trophy, followed by medals for second and third place, and ribbons for fourth and fifth. The two smaller races will also offer awards to the top place winners.

The entry fee for all races is \$9 with a T-shirt, and \$7 without. Runners who register in advance will receive \$1 off the entry fee. "We're expecting about 200 runners to register," comments chairman Dale Squier of Kewaskum. As of Sunday, Squier had received about 45 advance entries, and was expecting about 50 more. "Usually on the day of the

The Toning Shoppe, Ltd. opened up at their new location this past Monday, at 240 Main Street in Kewaskum.

The new shop was formerly Frank and Helen Felix's Gamble Store and residence, and has since been remodeled by owner Gary Gavin. The old cream city brick building has people

turning their heads these days to get a second look at the beautifully remodeled exterior, complete with an old fashioned cedar front porch.

Proprietor Linda Thorn points out that the spacious interior gives her customer's more room to move, with a large front room for toning tables, a massage therapy room, a health and nutrition center, a bathroom with a tub

and shower, TV room, and an extensive 14 x 25 foot exercise/workout area located in the back.

The move allowed her to increase their collection of workout equipment, adding an 880 Hoist multi-station gym, and the Tuntori MT 360 Olympic weight gym, offering 700 pounds of workable weights between the two systems.

We ask that families take time to review the bus riding rules and safe boarding, riding, and unloading procedures. If this is your child's first experience at riding on a bus, why not take some time to accompany him/her or arrange for someone else to accompany him/her for their first pick-up and drop-off?

Also, please be aware of the times crossing guards are present on village street corners and utilize them accordingly. Please do not send or drop your children off at school before the school doors open because they will be unsupervised.

Information for those interested and eligible for the free and reduced hot lunch program is also published in the Statesman. During regis-

tration the forms were available to those interested. If you did not receive a form and now would like one sent to you, or wish to review the qualifying criteria, please call the business office at 626-8427.

Hot lunch prices for the 1995-96 school year are as follows: elementary schools \$1.25 per day or \$5.50 per week, middle school and high school \$1.40 per day or \$6.25 per week. School on Monday is a full day and hot lunch will be served. The calendar for the school year has been published and each family received one at registration. Extra calendars are available for purchase at the business office.

The school district does not carry accident insurance for students. We therefore urge parents/guardians to review their own policies to be certain coverage is adequate. Particularly in the case of athletics, this is a necessity. The schools do have insurance forms provided by Student Assurance Company of Stillwater, Minnesota available to parents who

At the Washington County Fair on Saturday, July 29, 1995 at 3:00 p.m. the Fairest of the Fair - Stephanie Hefter, with the assistance of Joyce Albrecht - The Washington County Home Living Agent and Mary Slauter - Senior Coordinator presented four plaques to the "Most Admired Senior Citizens of Washington County" for 1995. The recipients were chosen after applications were submitted by one or more persons admiring them. The applications were reviewed with the finalist receiving the award on their past and present accomplishments and achievements.

The four individuals selected were Sylvester Schmidt of Kewaskum, Evelyn Horst of Hartford, David Radermacher of Richfield, and Ione Stodola of West Bend. Sylvester Schmidt of Kewaskum was nominated by his granddaughter Jessica Trapp. It was noted Sylvester is admired for his caring and sharing of himself for his family, friends and associates, as well as being active in a number of local organizations.

### SYLVESTER SCHMIDT

When asked to answer the question, "Why are you nominating Sylvester Schmidt to be one of Washington County's Four Most Admired Senior Citizens?", Jessica Trapp responded by saying, "Sylvester is an active, concerned, and caring individual. He helps those in need, be it the tenants of the apartments he manages, his sons, his grandchildren, or his elderly aunts and uncles. Everyone respects him for his dedication and enthusiasm."

Sylvester manages three multi-family buildings in which there are forty-two different apartment units. A majority of the tenants are older men and women. Sylvester not only takes care for their rental units and needs, but also visits them and even will take them to the doctor, to a funeral, or to

the store to get groceries.

Several different community groups count Sylvester as one of their members. He is a past and present director of AAL, the financial secretary of St. Lucas Church, the treasurer of the Kewaskum Historical Society for nearly twenty years, treasurer for the Wayne Wranglers, and the St. Lucas Cemetery Board Chairman. In 1994, he was selected as the Modern Woodmen Man of the Year, and he has been a Those Who Care recipient.

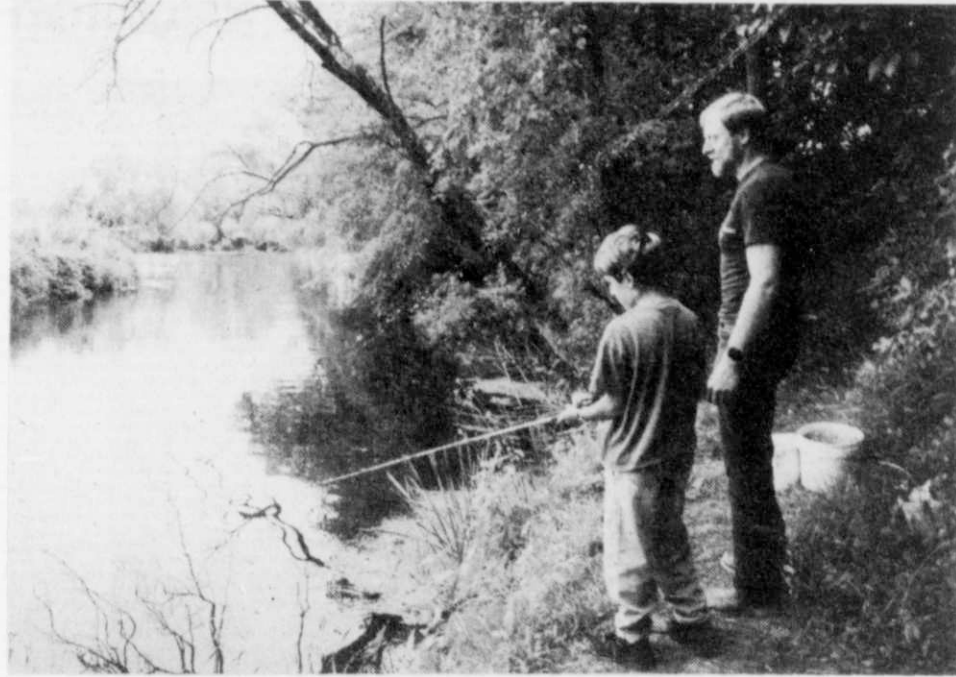

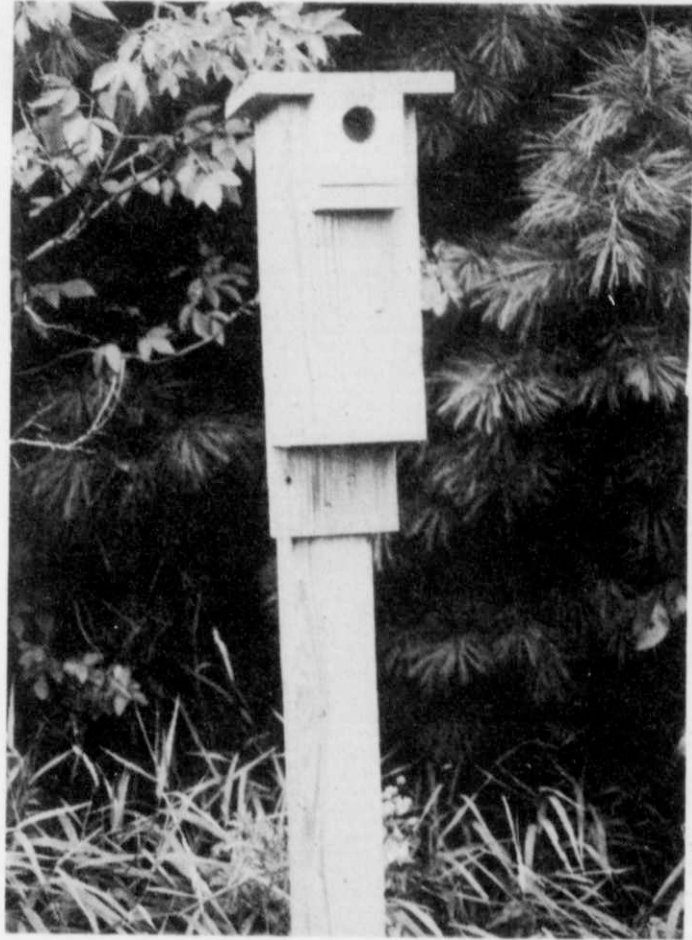

# Riverwalk Project Becoming a Reality

Some progress has been made on Kewaskum's Riverwalk Project, in an area located along the Milwaukee River, part of which is on school property.

The project initially began to reduce erosion that had been occurring along the banks of the river, and includes the prevention of water running across the road, cleanup of debris cluttered along the banks of the river, planting native vegetation in the vicinity, and developing a trail without damaging the stability of the site.

This will be the first

phase of the Riverwalk project, and according to high school biology teacher, Bill Lickel, part of the plan has already been completed, most of which took place during the last school year. "The Ag class planted a few hundred trees and began work on a trail through the wooded area behind the middle school," he reported. The FFA purchased the 300 trees and shrubs to extend the wooded area.

"The big thing we're stuck on is the digging of two ponds. That has to come first or it will mess up some of the work we have planned," he stated. Runge Excavating and Engineering had volunteered to dig the ponds while con-

struction at the schools was taking place this past summer, but at the time, the ground was too soft and they were unable to approach the area with their equipment.

Mr. Stradtman's Construction Skills class built wooden steps leading down to the river and a boardwalk section, near where the pathway begins. Once school starts, the Ag class will continue to clear the trail and level off the pathway, which

winds around the river to the end of the school property. "The village could add onto the trail in the future," Lickel points out, "and eventually it could continue through the entire village along the river."

Once the paths are leveled off and the inaccessible areas cleared, wood chips from the village will be brought in and laid down along the walkway. Wooden birdhouses for kestrels and bluebirds are located throughout the area, compliments of Mr. Stephani's fifth grade class, who constructed the birdhouses as a special project.

This fall the construction class will hopefully be able to continue the boardwalk, and in spring the area will be planted with native grasses and flowers. "We want both woodland and grass habitats," Bill explained. "The biology classes will get a

chance to observe the different organisms in the river, and how it changes from a free flowing body of water to almost a pond near the dam."

The two future ponds will be experimental ponds for the agricultural classes, and they will be able to view how a natural pond changes and evolves through the years. The Riverwalk project has the potential to create a variety of exceptional learning experiences for students at the Kewaskum schools. Other possibilities for future utilization of the site includes flower plots, learning stations along the trail, observation decks near the ponds, and a steam side park.

State funded money has already paid for the installation of curb and gutter along the road by the football field, which is intended to stop erosion. "We have enough money to do all of the trail

# Kuehl Accepts Newly Created Position Board Discusses Complaint On Parking Restrictions

A heated discussion on parking restrictions on Highway 45 was the main issue that closed Monday evening's Kewaskum Village Board meeting.

Trustee William Kulas brought the matter up under miscellaneous business, towards the end of the meeting, stating, "A business individual called me regarding parking in front of his establishment. They can't unload there. The area is right on Fond du Lac and Main Street."

Police Chief Richard Knoebel explained, "The biggest thing is you've got an intersection there and it's considered a traffic lane now. It had been going on for years, the delivering there. With the change of the road and the design of the road... it's a traffic lane now, and it's blocking an intersection, so you can't park there. We said that they could pull up farther in front of the next two businesses as long as they were ahead of that white line. And that's what the state had requested... to be ahead of that white line so there's enough room for the traffic to move through."

Knoebel further explained, "If you've got a situation where you got a truck parked in illegal parking and you've got a semi or several cars that want to go southbound, remember now, you only have a southbound lane there. You got a southbound lane and a left turn lane. If you have two vehicles that want to make a left hand turn, they're stopped in the middle of the intersection and all that traffic that's behind that truck is not going to be able to move. In the meantime, you could have another two cars pull up and do the same thing. You could have that traffic backed way up. It was a different situation before. It's now a traffic lane. State Statute No. 346.52 - Stopping Prohibited in Certain Specified Areas, lists no parking in an intersection and that is within an intersection."

Trustee Kulas reiterated, "So what you're saying is if they'd pull up in front of Prime Time..."

Knoebel stated, "Right and the drivers were told that and the owner of the business was told that."

President Wagner asked, "We couldn't put up like a temporary sign while that truck was there unloading?"

"Where's that traffic going to go, though, Bob?" Knoebel asked, adding, "The southbound cars can't cross that white line to go into the other lane because that is a left-turn lane. Then you're causing most people to violate the law by making them

go straight ahead in a left-hand turn lane."

A member of the audience, Roger "Butch" Schmitt, objected stating, "I think it's not right. It's 150 feet down to Prime Time and if you go to Millers, it's 180 feet. These guys ain't going to make 30 trips to carry stuff in. In other words, you're putting me out of business. Then rezone me for apartments cause that's what's gonna happen. I'm not going to stay in business this way. I can't stay in business. It already affected carryout sales. You want to lose business, that's what you're going to do. My neighbor next door, Nehrbass, is ready to do it the same way, (make apartments in front) and so is Beisbier. You're going to have three of them right in a row there."

Wagner stated, "It's not the intention of the board to put you out of business."

Trustee Kulas added, "I don't think we have any control of that highway out in front of there... I think the state has the control of that."

Knoebel reiterated, "It's an intersection. State highway... state highway right-of-way."

Schmitt said, "I only would need an hour-and-a-half in the morning and an hour-and-a-half in the afternoon, and they wouldn't even be there that long. Put a red cone behind their truck, there should be nothing wrong with it."

Knoebel declared, "The village will have to accept the liability. I won't accept the liability for it. State law says no parking in an intersection."

More discussion ensued on the possibility of being able to drive through in the rear of the building with Trustee Dave Goeden suggesting it might be an avenue to pursue.

Trustee John Borland reaffirmed, "They can't be blocking an intersection. That's a state law."

Schmitt stated, "They've been parking there for 18 years that I've been there."

Borland answered, "Right. But the road was a different situation at that time than it is now. I guess these drivers are going to have to do a little work. They'll have to park up by Prime Time and walk back there. I mean this is what they're getting paid for. We can't have a driver violating the law."

Discussion was also held on the problems that could be forthcoming when winter arrives. It was also suggested that Schmitt talk to his neighbor and perhaps he would be allowed to utilize his easement by the trucks parking in an alley located almost adjacent to his business.

President Wagner asked Schmitt to try a few of the

options suggested and assured him (Schmitt) he would get back to him in a month or two to see how things were working out.

Other pertinent business addressed by the board earlier in the meeting included discussion on the newly created position of General Maintenance Lead Worker in the Department of Public Works. This person would be "second in command" and take charge of business when DPW Superintendent Jerry Gilles was either out of town, on another job or unavailable.

It was decided a few months ago to promote from within to fill this position and the job was offered to twenty-year DPW employee Alan Kuehl. Kuehl accepted the position for a trial period of 60 days.

In other matters, the Board decided due to the Labor Day holiday falling on their next meeting date, the first September meeting was rescheduled for Wednesday, September 6.

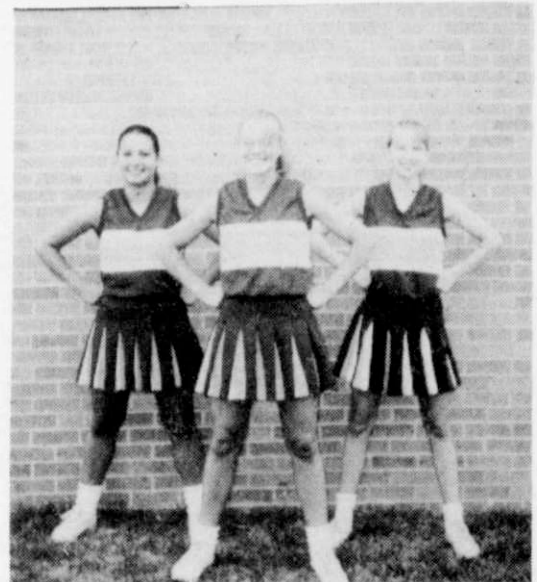

Our bid was then accepted by Wisconsin Farm Progress Days, Inc.

The Dan and Marge Neuburg family farm was selected as the site for the 1995 show. The people of Washington County are deeply indebted to this family for their cooperation, hospitality and generosity in working with our committee members to stage this very successful show.

The Neuburg's open air

farming arena is located not only in a productive agricultural area, but is settled in the midst of the rolling hills of the beautiful Kettle Moraine regions with the majestic spires of the Holy Hill Shrine rising above the surrounding, beautiful, green countryside.

We are also grateful and express our sincere thanks to the Dick Meyer family farm, adjacent to the Neuburg farm for allowing use of some crop acreage for field demonstration programs. We also thank all of the neighboring of Dan and Marge, for the use of land and above all, their willingness to cope with the increased activities and traffic before and during the show.

The hosting of an event of this magnitude, which is the largest in Wisconsin and one of the largest in our nation, was very exciting, challenging and overwhelming.

Our theme, "Agribusiness - On The Urban Edge," provided a unique opportunity to attract people from Milwaukee, as well as visitors from all around Wisconsin and other states, to be entertained and observe new trends in agriculture, family living and University Extension research projects.

Over all the years of my public service, I have never witnessed such an earnest commitment by a group of over 1,000 volunteers so eager and willing to assume chairmanship or serve on

assigned committees. All were determined to make this large undertaking a successful reality in Washington County. What I deem so remarkable and noteworthy is the fact that the original fourteen members of the Executive Committee and the 28 chairs or co-chairs assigned to work and oversee the many tasks, served over the entire three years of planning and final staging of the show. In my opinion, this truly is exemplary of the character of all of these fine individuals.

Following the first two years of planning, field preparation, program arrangement and fund raising were completed, the work load escalated. Starting in the spring of 1995, volunteers helped stake out the 70 acre tent city area for streets and exhibitor lots to prepare for electric installation and telephone service installation. The work of designing and painting of signs and booths, erecting miles of snow fence, food stands, etc., all completed by volunteers. During the last month, during and after the show, very many volunteers worked long hours daily to set up tent city and demonstration areas.

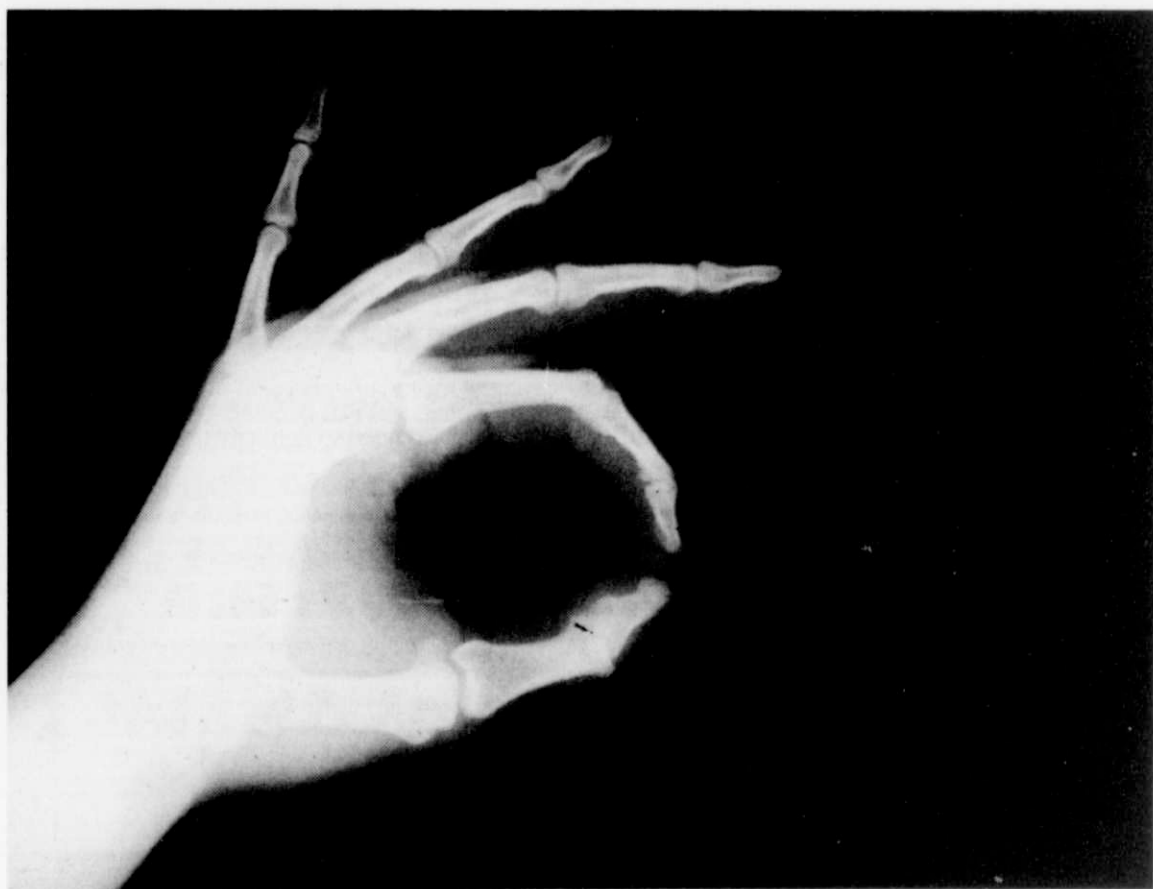

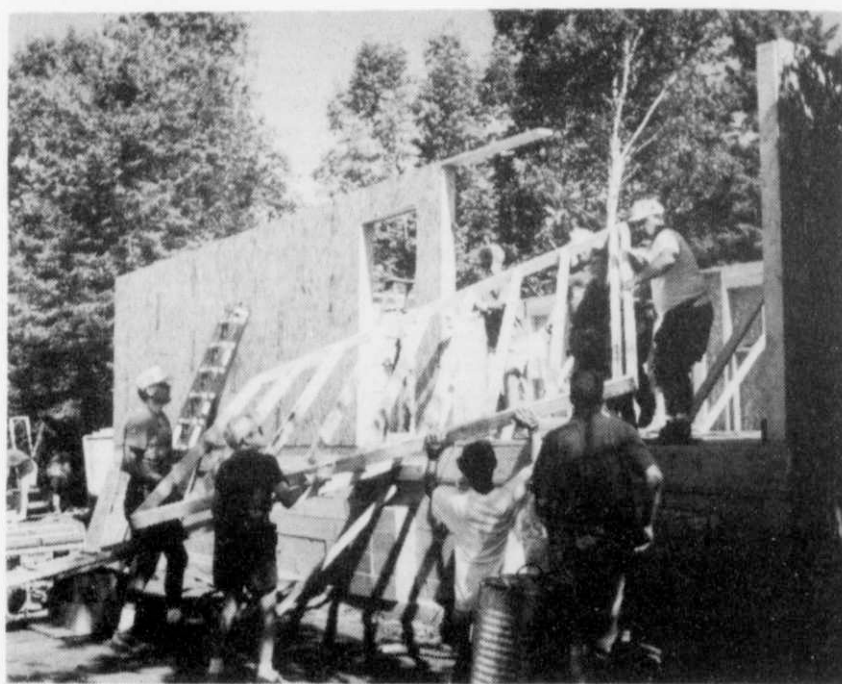

## Adell Officials Asked to Assist in Obtaining Community Block Grant Funding for CBRF

Village of Adell officials have been asked for assistance in obtaining funding for a Community-Based Residential Facility (CBRF) to be built in Adell if a suitable site can be found. Phillip and Penny Jones, along with Wayne and Connie Spring, have asked for assistance in applying for a Community Block Grant to build the facility.

A CBRF is a community living facility that provides room and board, supervision and supportive services to persons who are unable to live independently in the community or who choose to live in these facilities. It is intended that these facilities be as "home-like" as possible, and be located in or near the individual's community. The primary goal is to assist individuals in achieving the highest level of independent functioning of which they are capable. It is desirable that a CBRF provide services to a specialized target group in order to meet the unique needs of such individuals.

The Jones/Spring quartet has completed a survey for need of this type facility and have found Adell to be a favorable location. There are also a large number of Sherman residents who would qualify for this type of living arrangement.

A Community Block Grant would make favorable financing available to the developers. It offers lower than market finance rates, low loan initiation costs, and provides that as the loan is repaid, the money is placed into a revolving loan fund for the municipality to appropriate for other projects. The program is administered through the State of Wisconsin Department of Administration, Division of Housing.

This type of housing would provide each resident with a private bedroom. Residents share a common living, kitchen and dining area. Three meals per day are provided with residents being encouraged to participate with the cooking, cleaning, etc. There are daily organized activities scheduled and schedules are coordinated with family related outings.

Services include assistance with normal activities that many take for granted, such as: bathing, shaving, setting of hair, laundry and medication management. Regular checkups and appointments are scheduled with their physician, dentist or specialist as needed. Transportation is arranged or provided.

Facilities such as this have shown great success in Oostburg, Sheboygan Falls,

Plymouth and Port Washington. Most are at 100% capacity.

A seminar on Block Grant Applications will be attended by the village clerk later in the month.

Well closures ordered earlier this year are progressing slowly but steadily. An offer from Ed Filemyr to continue as the Village Assessor with a \$75 increase in salary was approved. Filemyr will receive \$575 for the 1996 assessment year.

Work has begun on a new Sewer Budget which is expected to provide a need for an increase in sewer rates.

Proposed pumping charges for Advent Environmental were tabled until more information can be gathered. Advent is monitoring the possible ground water contamination in the area of

the Adell Co-op. Representatives of Advent and the Co-op will be invited to the next meeting.

Issuance of a building permit for the Adell Co-op is being delayed until the placement of the proposed building and its possible interference with the storm sewer can be determined. The storm sewer in question was replaced last year.

Building permits for May and June were issued to Deems Pelishek, house; Dennis Witt, addition, Adell Co-op Electric Service; Dan Schueller, re-roof, (all with no value given); Thomas Payne, re-side, \$1,500; Andrew Schmitt, remodeling, \$10,000; Robert Knepprath, deck, \$500; George Klein, re-roof, \$900; Linda Orth, remodel kitchen, \$6,000.

## Town of Scott Board Ponders Zoning Request Changes

Town of Scott officials are asking common sense be used and are encouraging town residents to refrain from burning during the dry season. Several fires have spread and come close to destroying buildings. The town has no specific ordinance against burning and is hesitant to add another ordinance when common sense will do the job.

A number of zoning changes were approved at the August meeting and one was rejected. David Kurth's request for several zoning changes on his Brazelton Drive property which would have allowed him to make several changes in parcel sizes was turned down. He explained that most of the land was of class two soil and the rest a class four soil and is mainly a large slope and highly erodible.

He was advised to resubmit his request to the planning commission after finding out more information about the soil types and to make an effort to attend the planning commission meeting to better explain his plan. Due to a mixup in dates, he missed the previous planning meeting where his case had been decided.

Tom Hickenbotham, Cherry Hill Drive, displayed a diagram of his 30 acre parcel up for a rezoning. The parcel has been an orchard since the 1920s. It appeared that at the time of establishing the town zoning ordinance, all land within one-half mile of Batavia was zoned A-3, a land transition area available for development. This caused the split of

the 30 acres into 20 acres of A-3 and 10 of A-1. He had requested that the 10 acres zoned A-1 be changed to A-5, reasoning that it is non-conforming.

The planning commission on a vote of four against making the change, and only one for it, recommended that the petition be denied. The town board did not see it this way and voted to allow the change.

Terry Weber, County Road A in Section 16, was granted a zoning change from A-5 to B-1 for one-fifth of an acre of a 19.77 acre parcel, the area on which his woodworking and assembly shop is located. He was also issued a conditional use permit for the woodworking operation.

The town has been notified by the Department of Natural Resources that it has qualified for a property rebate for \$4,874 to be applied to recycling equipment already purchased. The town has undertaken a recycling marketing program.

A certified survey was approved for Lloyd Fellenz and Katherine Hughes for the former Evelyn Kauper property.

Operators licenses were granted to Richard Roesel, Mary Behnke, Lois Rohde and Steven R. Gross.

Building permits were issued to David Wheeler, house, \$106,000; Charles Tallmen, deck, \$1,100; A & N Pipeline, office building, \$120,000; Donald Depies, house, \$150,000; Robert Sargent, deck and pool, \$500; Paul Michaels, deck, \$3,000, and Thomas Benson, remodel kitchen, \$1,500.

## Four Indians Elected to EW All-Conference

The Kewaskum High School varsity baseball team reaped the rewards of a successful season recently, when four of the starting nine players were elected to the Eastern Wisconsin All-Conference Teams.

Senior centerfielder Kevin Klahn was named to the all EW First Team with a hefty .426 batting average, along with 15 RBIs.

Senior Dan Survis, left-fielder with a .353 batting average and 15 RBIs, and junior Tim Gundrum, catcher, with a .311 average and 14 RBIs, got the nod for the second team, as did senior pitcher Dave Dorn who finished the season at 4-2 with a 1.53 ERA.

The Indians were statistically sound as a team in the EWC as well, leading the conference with a .306 team batting average, as well as posting a minuscule 2.66 team ERA.

With the loss of six seniors, it may be looking a little tough for the Indians next year, but coach Mark Heise isn't worried.

"We've got a great, solid core of underclassmen who have performed well... most of them already have a year or two of varsity experience."

Pitching looks to be one of the strengths for the Kewaskum team next year, as an already strong Indian staff will be bolstered by some good JV talent.

Dan Jeserig and Erik Kopecky will be the anchors next year, after both sophomores had strong seasons for the varsity team this year. Jeserig finished the season at 5-2 with a 3.08 earned run average, while Kopecky was 2-1 with one win and a 3.94 ERA. Junior closer Tim Gundrum (2-0, 3sv., 0.95 ERA) will also be back for his final year.

Gundrum, the Indians homerun leader for the past two years, will also anchor a strong Kewaskum offensive attack next year. Andy Rix, outfielder, who batted .320 in conference and Luke Chesak, infielder, with a .294 average, will also lead the Indians hit parade next year.

Overseas four months, Herriges is in his first campaign with the Corregidor-famed 34th Infantry Regiment, a combat team in this Victory division.

## National School Lunch Program Letter to All Households

Dear Parent/Guardian:

All schools in the Kewaskum School District serve meals each school day. Lunch ticket prices are \$5.50 per 5-day ticket for students in grades 1-5 and \$6.25 for students in grades 6-12. Daily tickets are also available. The cost is \$1.25 for students in grades 1-5 and \$1.40 for students in grades 9-12. Children also may get meals free or at a reduced price.

If you now get food stamps or AFDC for your children, your children can get free meals. If your total household income is the

same or less than the amounts on the income Chart below, your children can get free meals or reduced price meals. A foster child may get free or reduced price meals regardless of your income. The reduced price is \$2.00 for a five-day ticket for all students.

**Fair Hearing:** You may talk to school officials if you do not agree with the school's decision on your application or the results of verification. You also may ask for a fair hearing. **Reporting Changes:** If your children get free or reduced price meals because of your income, you must tell the school if your household size decreases or your income increases by more than \$50 per month or \$600 per year. You may then fill out another application giving income information.

**Confidentiality:** School officials use the information on the application only to decide if your children should get free or reduced

The Kewaskum School District is committed and dedicated to the task of providing the best education possible for every child in the District for as long as the student can benefit from attendance and the student's conduct is compatible with the welfare of the entire student body.

The right of the student to be admitted to school and to participate fully in curricular, extracurricular, student services, recreational or other programs or activities shall not be abridged or impaired because of the student's sex, race, national origin, ancestry, creed, pregnancy, marital or parental status, sexual orientation or physical, mental, emotional or learning disability.

Complaints regarding the interpretation or application of this policy shall be referred to the District Administrator and processed in accordance with procedures established by the Discrimination Complaint Procedure.

### Discrimination Complaint Procedure

Any complaint regarding the interpretation or application of Kewaskum School District's student non-discrimination policies shall be processed in accordance with the following grievance procedure:

1) Any student, parent or resident of the School District complaining of discrimination on the basis of sex, race, national origin, ancestry, creed, pregnancy, marital or parental status, sexual orientation or physical, mental, emotional or learning disability in school programs or activities shall report the complaint in writing to the District Administrator.

2) The District Administrator, upon receiving a written complaint, shall immediately undertake an investigation of the suspected infraction. The District Administrator will review with the building principal, or other appropriate persons, the facts comprising the alleged discrimination. Within 30 days after receiving the complaint, the District Administrator shall decide the merits of the case, determine the action to be taken, if any, and report in writing the findings and the resolution of the case to the grievant.

3) If the grievant is dissatisfied with the decision of the District Administrator, he/she may within 15 days, appeal the decision in writing to the School Board. The Board shall hear the appeal at its next regular meeting, or a special meeting may be called for the purpose of hearing the appeal. In either case, the Board must hear the appeal within 45 days of its receipt. The Board shall make its decision in writing within 15 days after the hearing. Copies of the written decision shall be mailed or delivered to the grievant and the District Administrator.

4) If the grievant is dissatisfied with the Board's decision, he/she may within 30 days appeal the decision in writing to the State Superintendent of Public Instruction.

5) Discrimination complaints relating to the identification, evaluation, educational placement or the provision of a free appropriate public education of a child with exceptional needs shall be processed in accordance with Wis. Stat. Ch. 115, Subch. V and Wis. Admin. Code Ch. PI 11.

6) Discrimination complaints relating to programs specifically governed by federal law or regulation shall be deferred directly to the State Superintendent of Public Instruction.

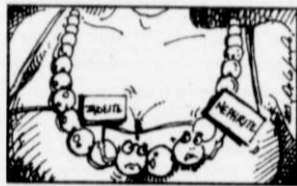

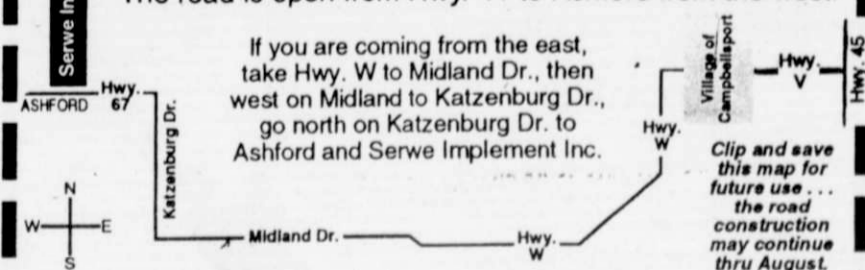

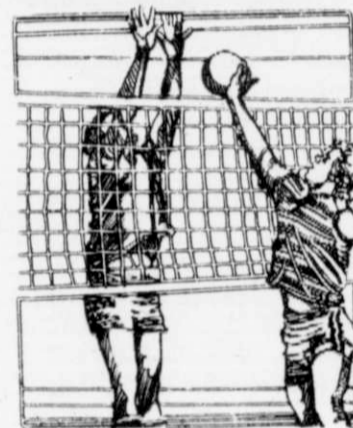
