Land Use and Rezoning are Concerns As Town of Wayne Grows

At the July meeting, the land use plan and rezoning in the town of Wayne continue to be major concerns for the town board, Plan Commission and landowners. The town board is currently accepting bids from land use planners and encourages input from town residents as the plan is being developed.

The town board appointed Donald Schulz to the Plan Commission to fill the vacancy created by the recent resignation of Fritz Roth. Prior to the appointment, Chairman Mark Strobel addressed questions regarding land rezoning and use plans. He shared in 1986 a county zoning guide was received containing county rules with a few modifications made as parcels have been rezoned. The board and Plan Commission began to receive a lot of requests for one acre lots to raise horses, steers, etc. which was becoming a problem. Board and Plan Commission members recognized that an updated land use plan was needed and would require the expertise of a land planner. Town supervisor, Leander Herriges stated that of the 13 townships in

Washington County, seven have plans, three are working on plans and three are not pursuing anything at this time. Herriges feels the town needs to preserve farmland. Town supervisor, Mark Pamperin supports the land use plan stating the town needs to grow in an orderly fashion. He would like to see a plan that is agreeable with landowners, residents and meets the town needs.

A visioning meeting open to the public will be held on Tuesday, September 10th at Wayne Elementary school beginning at 7:30 p.m. at which time town residents can provide input for a questionnaire that will be sent to all landowners regarding the land use plan.

Acting on the recommendation of the plan Commission, the board approved the rezoning request of 94.99 acres from agricultural to residential A-1 by Wesley Fickert for the Wilber Backhaus Living Trust. However, the request was not granted without opposition. A petition signed by 26 landowners opposing the rezoning was presented to the Plan Commission. A restriction, with the rezoning approval was no further land splits will be

allowed except the six parcels, as presented to Plan Commission, without board approval, soil borings must be done and driveways indicated on the certified survey maps.

Rosie Klemm, representing Art Terlinden's on a proposed land rezoning, challenged the town's recent established land division moratorium. Klemm stated minor land divisions do not fall under the moratorium and requested the rezoning of 40 acres from agricultural to residential be placed on the August agenda. The board will have legal counsel review the moratorium for compliance.

Surveyor, Ted Meilahn presented plans for the board to review on St. Kilian Drive. The board is anticipating work on the road to begin in 1997.

A special Plan Commission meeting will be held on Tuesday, August 6, 1996 beginning at 7:30 p.m. at the town hall when the board will open bids from prospective land planners. The next regular Plan Commission will meet on Tuesday, August 20th at 7:30 p.m. with the Town board meeting to follow on August 21, 1996, at 8:00 p.m. at the town hall.

Town of Wayne Holds Special Meeting

A special meeting was held at the town of Wayne hall on Monday, July 29th to confer with legal counsel to receive oral or written advice to consider strategy to be adopted by the town with respect to litigation in which it is or is likely to become involved.

After meeting in closed session, town board members, the town zoning administrator and legal counsel reconvened into open session at

which time the proposed changes to the town zoning ordinances and the town minor land division ordinance were explained. The purpose of the changes is to give the town protection during the interim period while the land use and zoning plan are being developed.

A public hearing on the proposed changes will be held on Tuesday, August 20, 1996, at 7:30 p.m., prior to the Plan Commission meeting at the Town of Wayne hall.

MADISON -- Emu meat, cranberry catsup, and chocolate flavored kringles are all products you can taste test at the Wisconsin State Fair, August 1-11.

The Department of Agriculture, Trade and Consumer Protection (DATCP) sponsors the consumer preference survey each year in the Agricultural Products Building.

Wisconsin food companies can enter up to four different products, each that will be tested by an estimated 30,000 hungry fairgoers.

Pickles, bratwurst, cream cheese, and ice cream are just a few of the other Wisconsin food products being sampled at the State Fair. The event allows consumers to test their taste buds, while Wisconsin companies obtain feedback on their products.

"The survey gives valuable consumer feedback at a very low cost," said Heidi Kafura, DATCP Agriculture Marketing Consultant. As well as the lower expense, the diversity of the sample group assures unbiased results. "Fairgoers who will test and rate the products come from rural Wisconsin, Milwaukee and the Chicago area and make up a broad sample group," says Kafura.

Each product will be tested for a two to three day period in order to collect a minimum of 350 completed surveys.

"An additional benefit for companies that qualify is the opportunity to receive the distinguished 'Wisconsin State Fair Seal of Excellence' award," says Kafura. "Products rated very good or excellent by 80 percent or more of the testers receive this seal."

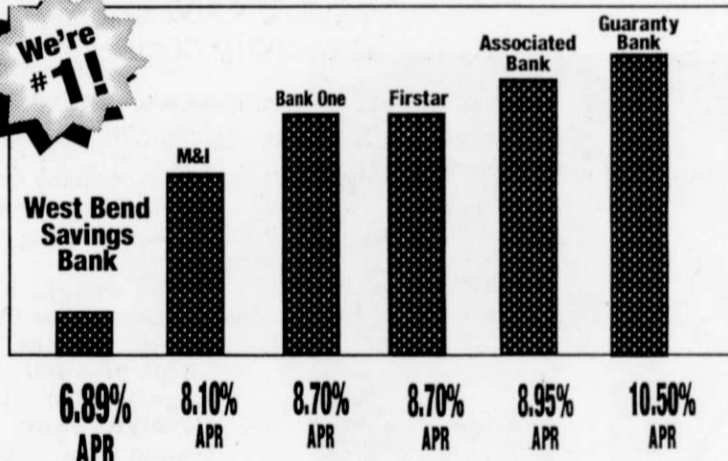

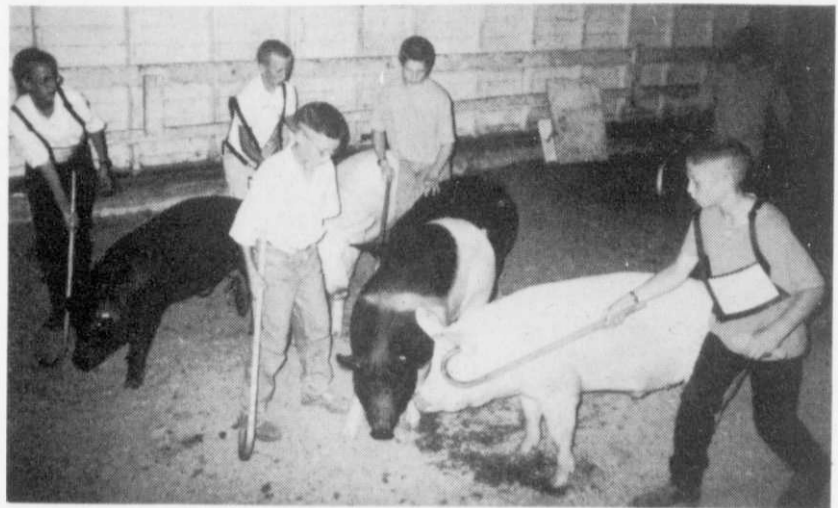

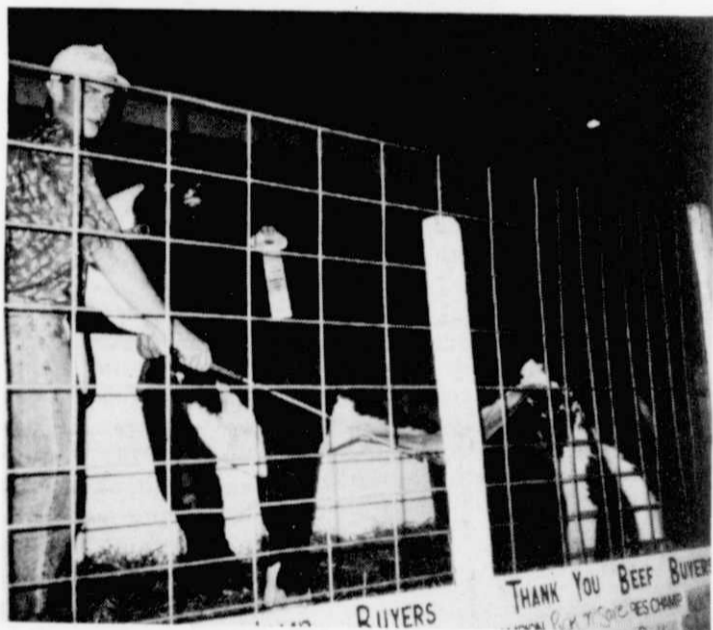

The well depth was verified at 400 feet in comparison to the drilling recorded depth of 405 feet. Also one section of pipe needs replacement because it has a bad spot.

2) The hydrants were tested and the flow testing as requested by the DNR was also accomplished but that process did add 3 to 4 hours per day to the job.

3) It was noted that during the process, two new hydrants experienced failure but will be covered under warranty.

4) The Board was informed of the status of the sludge storage facility and the warranty work now being done on it.

ORDINANCE NO. 96-6

AN ORDINANCE TO AMEND CHAPTER 1 GENERAL GOVERNMENT

THE VILLAGE BOARD OF THE VILLAGE OF KEWASKUM, WISCONSIN WISH TO AMEND 1.31(5) AND ORDAIN AS FOLLOWS:

1.31 POLICE AND FIRE COMMISSION.

(5) MEETINGS. One regular/annual meeting of the Commission shall be held in April of each year. Special meetings of the Commission may be called by the Chairman or any two members upon reasonable notice to all other members.

This Ordinance shall take effect upon passage and publication as provided by law.

Five KHS Players Selected to EW All-Conference Teams

The Kewaskum High School varsity baseball team was rewarded for their 11-7 record and fourth place finish in the Eastern Wisconsin Conference by having five players selected to this year's All-Conference Teams.

Senior Tim Gundrum was nominated to the first team that included such names as Dave Doyle and Gary Goebel of Campbellsport and Chris Korff of Sheboygan Falls. Gundrum led the Indians offensive attack with a .367 batting average, collecting 22 hits and driving in 19 runs.

Joe Rettler and Erik Kopecky represented Kewaskum on the second team, Rettler batted .322 with 23 RBI's, while Kopecky, a junior, batted .340 and scored 24 runs. Both players had fine seasons on the mound as well, with Kopecky earning a 4-0 record and netting a 1.88 ERA. Rettler was the Indians closer, collecting three saves with a 2.02 ERA.

Dan Jeserig (3-3, 2.18 ERA, one save), and Josh Christopherson (.345 BA) received honorable mentions.

The Indians had very strong bats this season, outscoring their conference opponents 121-54, with eight team homers

and a .282 team batting average.

Kewaskum's season was full of streaky play, as they started the season just 1-6, but then got hot, winning five in a row and nine of their next eleven, to pull to 10-8. During the stretch they picked up victories over Sheboygan Falls and New Holstein, who both finished 10-8, one game behind the Indians.

Kewaskum also had a thrilling 4-2 victory over EWC Champion and WIAA State runner-up, Campbellsport.

The Indians had picked up exciting wins over Cedarburg and Slinger in the WIAA tournament before their season was cut short by West Bend West.

Fall Turkey Season Application Deadline

MADISON -- Hunters are reminded that the August 10 deadline for fall turkey hunting permits is only a short time away.

The season runs 28 consecutive days from October 7 through November 3, during normal small game hunting hours. Hunters are limited to one turkey of either sex, which may be harvested only in the zone in which their carcass tag is valid. Additionally, hunters are reminded that they must wear blaze orange clothing if hunting in a zone T Deer Management Unit October 24-27.

There will be 32 zones open for the fall season, up from 28 zones in 1995. DNR biologists and wildlife managers are currently determining the number of permits that will be available, according to Tom

Howard, wildlife ecologist and turkey specialist with the Department of Natural Resources.

There were 48,453 applicants for 29,850 permits available for the 1995 fall turkey season, and successful hunters registered 6,241 turkeys.

Up to 30 percent of permits in each zone are available first to qualifying landowner applicants within that zone. Applications cost \$3 and are available at DNR offices and area sporting goods outlets.

Resident hunters who apply for, but do not receive a permit are given a preference for the next year's drawing.

Turkey hunters set a spring harvest record of the 13th consecutive year in 1996, with hunters taking 18,000 turkeys with the 75,596 permits that were issued for 40 turkey hunting zones.

Westphal, along with partner Jim Korth were golfing in the annual Michelob Alternate Shot Tournament, attended by over 100 players.

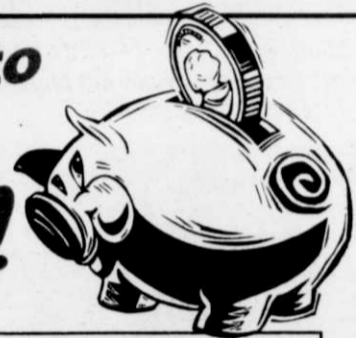
The hole in one earned Westphal a \$5,000 prize.
