School Board Votes for Taxpayer Input by Putting Land Purchase Decision On a Referendum

The Kewaskum School Board voted to allow taxpayers a say in purchasing land for future district building projects by approving a resolution for a referendum election, at Monday night's school board meeting.

The referendum will be placed on the ballot for the April 1st Spring Election, asking residents to approve authorizing the issuance of general obligation school building bonds in an amount not to exceed \$600,000, for the sole purpose of purchasing land. This is the beginning step toward initiating the district's 15 year capital improvement plan developed to meet future facility needs.

After listening to the results of work sessions, committee evaluations, survey results, and school assessments, the board, who is ultimately responsi-

ble for the capital improvement plan, unanimously agreed that the purchase of land was essential to begin taking action on the impact of rising district growth.

Monday night's decision came after school board members met on Saturday to approve allowing the superintendent to make an offer to purchase land, which will now be contingent on the results of the referendum. The board also toured various potential land sites, but official word on where or what will be built upon them has not been released for public knowledge. Questions remain as to what kind of school needs to be built -- a grade school, middle school or new high school.

A news release received from the district office explains the referendum in detail, as follows:

"The Kewaskum School Board, at its February 10th meeting, approved a resolution to place a referendum

question on the April 1 election that would authorize the board to borrow \$600,000 for the purpose of purchasing land for future school construction. The referendum question will be voted on April 1, 1997 in all Townships and the Village of Kewaskum.

If the land referendum is approved, the Board would have authority to borrow not more than \$600,000. The \$600,000 figure was deliberately chosen by the board because it approximates the revenue increase of a \$1.00 per thousand tax levy for the 1997 equalized valuation for the district.

Last year, the district levied an additional \$1.00/1,000 equalized to reduce its long term debt. According to school officials, if this referendum passes on April 1st, local property taxes would not increase since the same \$1.00 it levied last year for debt reduction would be applied to the land

New Postmaster For Kewaskum

As of January 4th, the Kewaskum Post Office operation has been under the supervision of new Postmaster, Ed Wanta.

Wanta, who resides in Richfield, was transferred to Kewaskum from the Cedarburg Post Office, where he served as supervisor for four years. "I've always liked this area, and years ago lived in West Bend," he said of his job relocation. "I used to hunt up here, and I also worked at Sunburst Ski Hill."

Since beginning his new position, Ed has been kept busy rearranging and redesigning the workroom for maximum efficiency, and eliminating some of the older equipment no longer needed. "I don't see any personnel changes," he points out. "The workforce here does quality work, and I'm very happy with the desire of the employees to serve the community so well." This includes insuring the rural routes continue to run as efficiently as possible.

He relates that this is actually a very exciting time to be a part of the postal service, with the new automated sources of mail sorting. Back in the 60's, mechanized means of handling mail was considered state of the art.

Presently, post offices around the country are striving to become fully automated, like Wanta's

former office in Cedarburg. "That's part of the reason I was hired here," he explains. "We need to encourage businesses to start using bar codes, which saves money on larger mailings. Everyone's goal is to keep the prices of postal service down."

The only other change he foresees for the time being is to put in a wall, or screen line between customers and the back workroom, to neaten up appearances and display postal information. Kewaskum's post office once again received a district award for the best Christmas decorations in the area, and Postmaster Wanta will be proudly presenting awards to the various schools that participated.

Wanta also announced that there are openings for two part-time rural carrier positions at the Kewaskum Post Office. Applications can be picked up at their location on Main Street, and applicants will be contacted by mail concerning examination scheduling.

"New for 1997, is the Statue of Liberty stamp, which was issued Feb. 3," he adds. "We offer a number of different stamp designs, and the office displays posters showing the variety of choices."

Ed Wanta's family includes his wife, Arlene, son Eric, and two daughters, Melissa and Angie.

Gavins Purchase Glacier Inn

The Glacier Inn, one of Kewaskum's most historic landmarks, will be under new ownership as of February 21st.

Owners Marlene and Bob Nagel, who took over the restaurant in August, 1994, announced the building has been purchased by Kewaskum native Gary Gavin.

The decision to retire from the successful business known for its tradition of fine dining and sociable atmosphere was based on health reasons, according to Marlene. It was too many hours for me at this point in my life, she relates, and plans to take life easy for a while, traveling with her husband and anticipating the birth of another grandchild. We're going to take a trip down south, and spend some time enjoying our family. The couple is in the process of purchasing a home in Germantown.

The Nagels are extremely thankful to all the people in the community and beyond for their support, having found the town friendly enough to call home. I know my husband plans on still coming up and playing

cards at Schmitt's Never Inn, and now I can join him, she stated. We will definitely miss it, and continue to keep in touch with all the friends we've made.

New owner Gary Gavin plans to completely remodel both levels of the building's interior, which is estimated to take about 2 1/2 months. The new restaurant will be handicapped accessible from the south side, with a handicapped elevator to reach the second floor. Ceilings will be opened up to their original height of 10 feet.

The upper level will offer room for banquets, meetings and overflow dining, including restroom facilities, with a seating capacity from 125 to 150 people.

The downstairs will house a formal dining room capable of serving 60, with an expanded bar room seating 35. Two separate menus will be offered, one for casual dining in the bar area, and another for formal dining with reservations, Gavin explained, pointing out that he will continue to carry on the established Supper Club tradition the Glacier has always been reputed for.

Scott and Annette Erickson of West Bend will be managing the new business, with Scott bringing with him 28 years of experience in the restaurant industry, as former manager of Dick's Pizzeria. The Ericksons have two children.

Gavin said the restaurant will be closed during remodeling, and is slated to reopen before Memorial Day, with a brand new name.

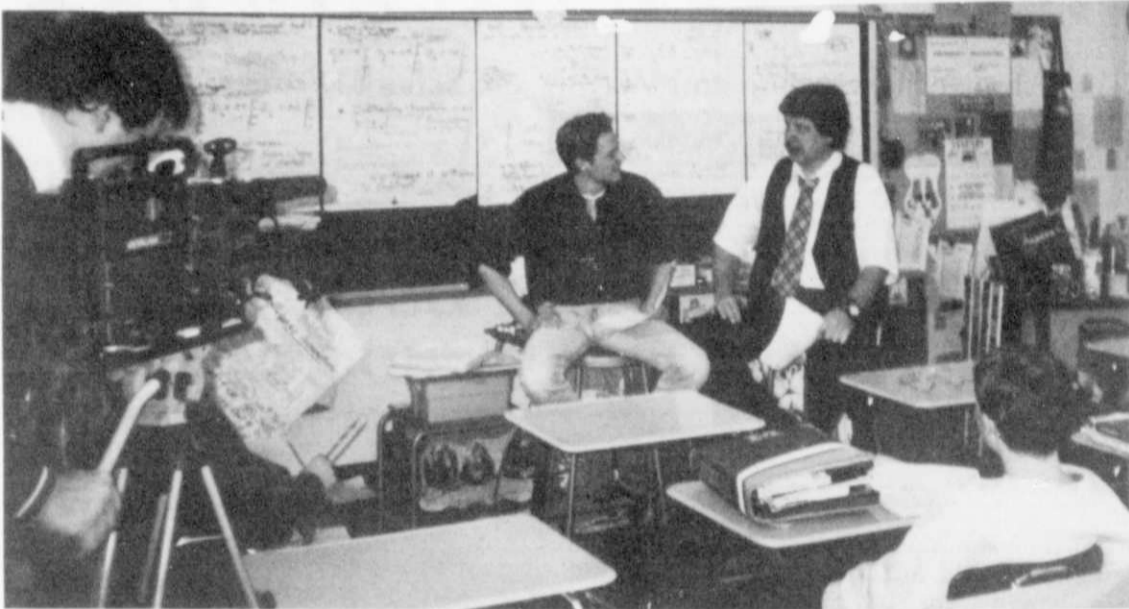
Primary Election Set for Tuesday

KMS's Bill Heckel Named UPN Channel 24 'Teacher of the Month'

Kewaskum Middle School Math/Algebra teacher Bill Heckel is February's "Teacher of the Month," as selected by Milwaukee TV's UPN 23 (WCGV) for Southeast Wisconsin. As a result, Mr. Heckel will be featured throughout the month, in 30-second spots during childrens' programming on Channels 18 and 24.

As part of the TV station's "Teachers are Tops" program, student viewers throughout the Channel 24 viewing area are asked to nominate teachers for the award, describing in 50 words or less what makes them a top teacher.

From there, according to program producer Stephan Roselin, staff members use a variety of criteria to make the final selection.

Mr. Roselin (who also acts as "Andy" the host of UPN 24's childrens' programming), came to KMS recently, accompanied by a camera operator to interview Mr. Heckel for the featured spots.

Mr. Heckel has taught eighth grade mathematics in the Kewaskum Schools for thirty years, since his graduation from UW-Oshkosh in 1967. Although the location of his classroom has changed from the third floor at KES, to what is now the library at KHS, and finally to KMS, some things have not changed.

"Our kids at Kewaskum have always been, and still are, the best," Mr. Heckel stated. "The majority of them do give it their all and take advantage of their chances (to learn.)"

Working with the students has always been his favorite thing about teaching. "Watching them grow, improve, learn, change. Where else can you be involved with so many personalities, attitudes, emotions, etc." he marvelled. "(All students) are great in their own way and have a great deal to offer society."

"And," he added, "they are all special to me."

Mr. Heckel has found teaching in Kewaskum special for other reasons, as

well. "The parents are supportive of education. The

School Board, administrative staff and support staff are all very helpful and fun

to work with. The teaching staff is a great staff to work with and all care about our kids very much."

To emphasize an earlier point, Mr. Heckel repeated, "And the kids are the BEST."

For this month, UPN 24 has recognized what community members and students have known all along, Bill Heckel is "tops" as well.

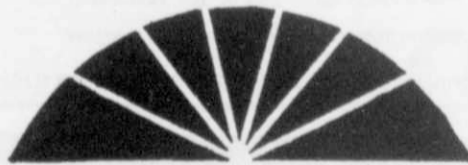

Early Morning Fire Destroys Campbellsport Business



Only a smoldering door frame remained late Friday where the ADD Auto business once stood in Campbellsport. Fire that began around 3 a.m. totally gutted the building.

An early morning fire completely gutted a Campbellsport business at 239 Railroad Street last Friday, February 7.

The ADD Industrial Supply Building, owned and operated by Alan Defatte of Campbellsport, once housed the Stella Cheese warehouse.

A neighbor, Ray Crego, happened to be looking out his window around 3 a.m. and noticed the fire. He immediately called the Fond du Lac County Sheriff's Department, who in turn, dispatched the Campbellsport Fire Department to the scene.

Campbellsport then requested mutual aid from four neighboring fire departments. Men and equipment from the Kewaskum, Eden, Lomira and Kohlsville departments assisted in fighting the blaze.

Despite the intense efforts of firefighters, an

attached home was the only part of the building that could be saved. Campbellsport fire personnel were on the scene nearly ten hours.

Residents, at one point, were advised to evacuate the area due to concerns that toxic fumes might possibly be emitted by the conflagration.

The fire totally destroyed the building that housed ADD Auto Supply and

Repair, a vehicle storage area and an adjacent apartment. All were declared a total loss along with numerous vehicles and motorcycles. The exact dollar loss has not yet been estimated, but it is expected to be in excess of \$200,000. The cause of the fire has not yet been determined as of this writing.

No one received injuries.

Board Votes Against Full Day Kindergarten... For Now

The Kewaskum school board gave itself and parents of the community more time to review the impact of full day Kindergarten at their Monday night meeting by voting 5-2 against the proposal, until administration could provide more detailed information regarding future facility planning.

A large audience attended the meeting, with some parents opposing the full day program aimed at preparing young children for the academic pace of the future. Shawn Roberts, owner of My Little Friends Daycare, stated that after 14 years of experience, she felt a number of children would not be ready for full days, five days a week, at that age. "Kids by me will come back those first three months of school and nap the whole afternoon, because they're just worn out from that morning Kindergarten session," she related.

"They don't have research

saying it's better for a five year old to be there all day, in a structured setting," said parent Julane Luedtke. "Research says it's good because it's more convenient, it's better for adults, we'll get more money, bussing will be less, but I want to know what you have that tells me it's better for my child."


Mary Dallmann, Kindergarten teacher who has taught within the district for 26 years, recommended the board adopt a full day Kindergarten program. "I feel the children are extremely rushed (in a half day program). There is very little time for the children to play, many days they just don't get any time, and I think that is really doing them a disservice. There is not enough time for socialization. We go through lessons so quickly, we're jumping from one thing to another. The children don't have enough time to absorb, and think, and practice, to experiment," she

pointed out.

Administrators reported on their experience visiting different school districts with a team of Kewaskum Kindergarten teachers, to observe a variety of full day programs, some of which had been in place for several years. "We found out from other districts, you have to provide a choice, a separate half day program," Director of Elementary Education, Kieth Kriewaldt stated, reinforcing the district's plan to offer parents both full and half day options for their child. Providing adequate prep time for teachers, transportation, age appropriate curriculum, and keeping parents informed, are all keys to a successful program, he maintained.

According to Kriewaldt, full day Kindergarten would help close the gap between the different knowledge children bring with them their first days of school. Some are just learning their ABC's and others have the capabilities to run a computer.

Curriculum/business manager George Allmann reviewed the surveys sent out to 160 district parents, and the concerns brought out at that time. Out of the 82 surveys returned, 50 favored full day Kindergarten, 14 favored half day, and 18 indicated parents that were sending their children to parochial school. "We ask you give us the opportunity to provide this option," he told the board.

"I had thought to take this out of the facility issue," Superintendent Charles Johnson stated. "We wouldn't bring this to you if we didn't think we could do a good job for those parents who chose it." He stated that after two different surveys, the strongest indicator was the parents, who supported the full day option 4 to 1.

After listening to both sides of the issue, the majority of board members could not get past the facility concern, and wanted the program spelled out in more detail. Board member Tom Timblin asked for some state statistics, and was told out of 426 Wisconsin school districts, 49 offer full and half day

Kindergarten, 119 full day only, and 247 half day only. Timblin, who voted in favor of the proposal, along with member Jon Downs, said he was in favor of it because, "in the long run the bottom line is it will help our kids compete better in an ever increasingly competitive world. I think there's a lot of kids that want to learn and I think our job at the school board level is to give the kids the tools to compete better."

"I tend to agree with our administration," board member Larry Fechter maintained, "but I just feel this needs a little more time to get it down to what I feel comfortable with. We've got to address our facilities to accommodate such a thing." He indicated he received phone calls two to one against the full day option.

Board member Neal Weare asked for more space clarification and documentation of opposing view points. "Why is it we have no numbers, as to how many additional teachers if any, what the cost is in its totality, if possible, and we don't have that?"

Addressing state funding presently offered to districts who increase enrollment through additional Kindergarten options, board member Mary Andera stated the money issue was enticing schools to participate, but what happens when the money runs out?

"I did find pro and con in the information we had," supporter Jon Downs remarked. "If the information I'm getting is correct, over 50% of children that would be in half day, go to another group setting of some type afterwards. The more we take the child from one setting to another setting the more detrimental it is to that child, I'm hearing. I think if we have the options, we can keep them in that same group setting."

Although the proposal was defeated in a 5-2 vote, board member Jean Goeden said it doesn't mean that the board won't take another look at in the future, and considered the meeting informative.

On January 19th, the New Fane Kettle Riders Snowmobile Club dedicated one of its trails in memory of a founding and charter member of the club.

The Martin Haack Memorial Trail runs from Highway DD north of New Fane approximately six miles south to Highway 28, just east of St. Michaels.

Martin, a rural Kewaskum dairy farmer, passed away last July. Although he lost his battle with cancer, he was always willing to fight for a cause he believed in. A pioneer in the sport of snowmobiling, Martin and his family were avid snowmobilers back when machines had names like Evinrude, Skiroule, Mercury, Sno Prince and John Deere.

Those were the years when there were no mark-

ers, no trail system and only a few hardy (or foolhardy) souls ventured out into the biting cold. On a beautiful crisp winter night, you traveled the cow lanes of neighboring farms, over fluffy fields, down the bridge trails in the Kettle Moraine, guided only by the moon, stars and a man like Martin who knew the land.

As the popularity of the sport grew, however, so did the problems. In those early years, with no organized trails systems marked with orange blazers and informational signs, trespassing and property damage on private and public lands increased.

The Department of Natural Resources threatened to close the state forest to snowmobiling. It was then that Martin, along with his neighbors and friends decided something

had to be done.

The first thing the group did was to create the New Fane Kettle Riders Snowmobile Club, and the second was to meet with DNR officials to work out a system of trails in, and around the state forest. From those early meetings with the DNR, an excellent cooperative and working relationship developed which continues today.

Martin continued to give his free time to help the sport of snowmobiling. Over the years he served in a variety of capacities from director to vice president and president, not only for his club, but the Fond du Lac County Snowmobile Association, as well.

It is because of dedicated snowmobilers like Martin across the state that Wisconsin is number one in snowmobiling fun today.

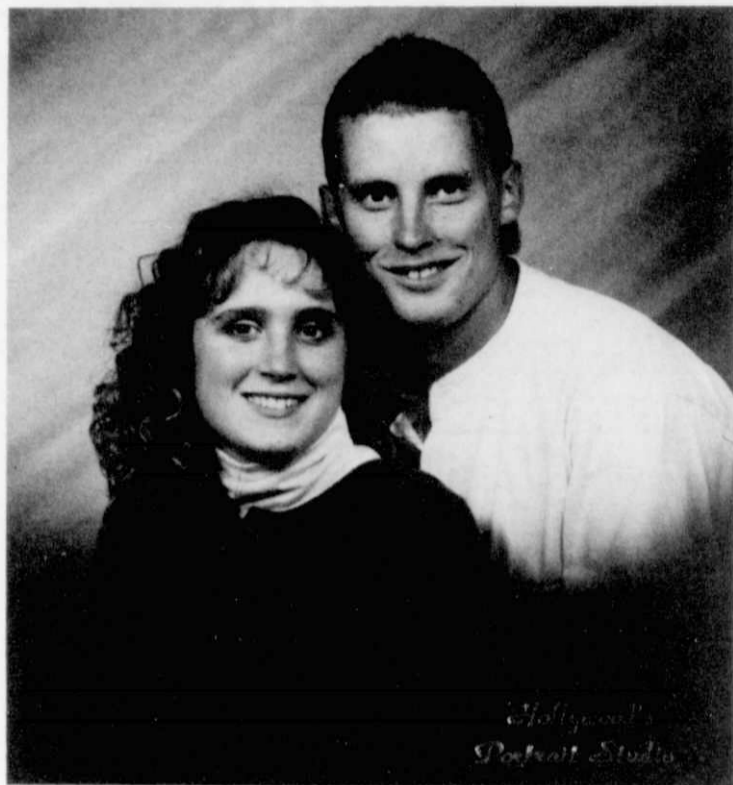

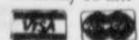

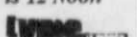

Regal Ware Opens Career Center

KEWASKUM -- Regal Ware, Inc. this week opened its on-site Career Development Center. The center was developed as a resource for Regal employees who are interested in furthering their education or job skills.

With this new center, participants will have the opportunity to work at their own pace on goals of their own choosing. Regal employees can sign up for computer classes, finish their GED at their pace or advance their math skills, for instance.

Through the program, participants can come to the center on their own time, to obtain confidential advice and instruction from an impartial instructor who works within the Moraine Park Technical College. To accommodate various skills, the center is scheduled to be open Tuesdays through Thursdays from 1 to 7 p.m.

The new program was a collaborative effort between Regal's management and union representatives, along with the help of Moraine Park Technical College. Through the college, Regal was able to obtain a state grant to help pay for a portion of the initial setup cost in equipment for the center.

The Moraine Park staff also directed the setup and served as advisors in purchasing equipment and setting up the curriculum. The planning and implementing of the program has taken a year and a half to complete.

Currently, the center has nine computer systems with numerous software

programs including Windows, Microsoft Word, Excel, Lotus for Windows, Power Point, E-Mail and others.

The center also has an adjoining conference room which holds 54 people. Some of the classes that will be offered include Introduction to Computers, Math Basics, Basic Electricity and AD/DC Circuits, Introduction to Spanish, Team Building Workshops and Plato -- a revolutionary self-paced computer program that teaches reading, parenting skills, writing, communications, math and more.

Class offerings may be revised and expanded based on demand and in-put from participants. The center, its classes and programs are also open to retirees of Regal Ware.

To help answer initial questions about the center and encourage employees to use it, organizers of the center asked for volunteers to serve as peer advisors. In this capacity, peer advisors participate in regular meetings and are given first hand information to pass along to those interested. There are currently 19 peer advisors from various manufacturing and office areas.

An in-house grand opening ceremony took place on Tuesday, February 11. (Photo will be published in next week's Statesman). Regal employees were able to view the center for the first time and sign up for advising sessions and computer time.

purchase.

Local officials also stated that they expect the state aid revenue for the 1997-98 fiscal year will remain constant since the state budget passed last year covers school costs and was approved for the two year period.

Currently the school district has an equalized value of 522 million dollars. This value is expected to increase by 8-10% this year totaling nearly 600 million dollars. By using \$1.00 of the tax levy for land purchase instead of additional long term debt reduction, the local property tax should not change if the \$600,000 referendum is approved."

Village President Robert Wagner attended Monday's meeting and told the board he was encouraged to see the school board taking initiative to plan ahead down the road, through a land purchase. "It would help us a lot, with our land use plan, knowing what the district has planned for a land purchase," he stated. "As we all know in the village, development has really taken off right now, and I feel that if you don't seize the opportunity now, you're going to miss out on some parcels of land in the area around the village that would lend itself very useful to the school district, along with making it easy for us to provide sewer and water."

Board member Tom Timblin said that it would not

be wise or prudent right now for the board to discuss the land publicly when they are in negotiating stages. "We might put in a bid in for two different pieces of land, or one, and we're not sure right now, and don't think now is the time to talk."

"This is an opportunity for the taxpayers also to have a great influence in the direction of this district," board member Larry Fechter added. "We're saying to the taxpayers, here's your chance, let us know the direction this district is going. We need to invest in the future. I can't see it any other way but that, and I know I'll support it 100%."

A public hearing is planned for the future, to inform the public about the land purchase and building proposals, before the April election.

We can't find land overnight for the DNR to approve. It takes the DNR months to decide where to allow the sludge to be spread. So the villages won't have any where to go with it while waiting for the DNR to make their decision. Something has to be done fast for the sake of the small villages as well as the farmer.

5) Review of correspondence.

Chairman of the Park and Recreation Committee, Gary Gavin reviewed the results of the Committee meeting held earlier this evening and recommendations to the following.

On a motion by Trustee Robert Stoltzmann, seconded by Trustee Harry Roecker and unanimously carried by voice vote, the Board approved the contract for portable toilets with Arnold's, the apparent low quote of \$60.00 per month per unit.

On a motion by Trustee John Kenworthy, seconded by Trustee Robert Stoltzmann and unanimously carried by voice vote, the Board approved the donation of \$500.00 from the Recreation account to the Grid Iron Club for youth football.

On a motion by Trustee Warren Dums, seconded by Trustee John Kenworthy and unanimously carried by voice vote, the Board approved the sharing of costs, not to exceed \$250.00 with the Fire Department for live music for the July 3rd Fire Works.

Board Representative for the Plan Commission, Trustee David Goeden announced a meeting for January 28, 1997 at 7:00 p.m. It was also noted the Public Informational and Public Hearing Meeting regarding the proposed Land Use Plan have been postponed for February because of some clarification work needed to refine the proposed Flood Boundary Districts.

Board Representative for the Mid-Moraine Municipal Association, Legislative Committee, Trustee Robert Stoltzmann reported that the Committee met on January 8, 1997 with Kathy Bull as the speaker. It was noted the meeting was very informative.

The names of the candidates for each office, whose nominations have been certified to or filed in this office, are given under the title of the office, each in its proper column, together with the questions submitted to a vote, for a referendum, if any, in the sample ballot below.

INFORMATION TO ELECTORS

Upon entering the polling place, an elector shall give his or her name and address before being permitted to vote. Where ballots are distributed to electors, the initials of two inspectors must appear on the ballot. Upon being permitted to vote, the elector shall retire alone to a voting booth and cast his or her ballot except that an elector who is a parent or guardian may be accompanied by the elector's minor child or minor ward. An election official may inform the elector of the proper manner for casting a vote, but the official may not in any manner advise or indicate a particular voting choice.

At the spring primary election, where lever machines are used, the elector shall depress the lever at the right of the name of the candidate for whom he or she intends to vote. To vote for a person whose name does not appear on the ballot, the elector shall write in the name of the candidate of his or her choice in the space provided for a write-in vote. On the referendum question, the elector shall depress the lever at the right of "yes" if in favor of the question, or the elector shall depress the lever at the right of "no" if opposed to the question.

Where marksense voting is used, the elector shall darken the oval next to the name of the candidate of his or her choice for each office for whom he or she intends to vote. To vote for a person whose name does not appear on the ballot, the elector shall write in the name of the candidate of his or her choice in the space provided and darken the oval at the left of the write-in line. On referendum question, the elector shall darken the oval next to "yes" if in favor of the question, or the elector shall darken the oval next to "no" if opposed to the question.

The vote should not be cast in any other manner. If the elector spoils a ballot, he or she shall return it to an election official who shall issue another ballot in its place, but not more than three ballots shall be issued to any one elector. If the ballot has not been initialed by two inspectors or is defective in any other way, the elector shall return it to the election official, who shall issue a proper ballot in its place. Not more than five minutes' time shall be allowed inside a voting booth. Unofficial ballots or a memorandum to assist the elector in casting his or her vote may be taken into the booth and copied. The sample ballot shall not be shown to anyone so as to reveal how the ballot is marked.

After an official marksense ballot is marked, it shall be inserted in the ballot sleeve provided so the marks do not show. After casting his or her vote, the elector shall leave the booth, insert the ballot in the voting device, and shall leave the polling place promptly.

An elector may select an individual to assist in casting his or her vote if the elector declares to the presiding official that he or she is unable to read, has difficulty reading, writing or understanding English or that due to disability is unable to cast his or her ballot. The selected individual rendering assistance may not be the elector's employer or an agent of that employer or an officer or agent of a labor organization which represents the elector.

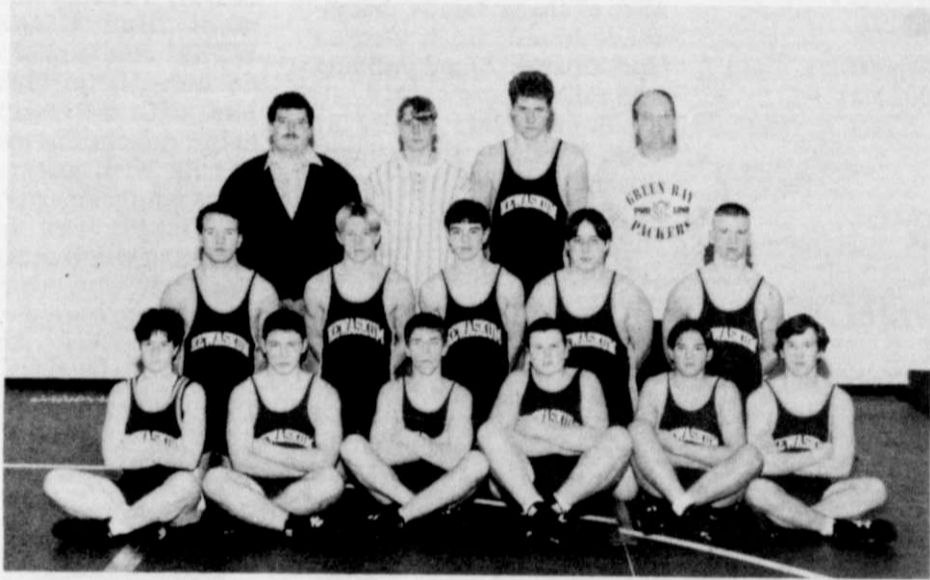

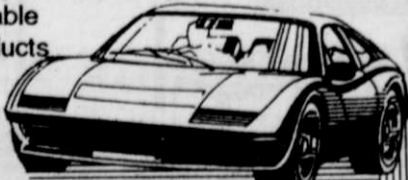
