Open Forum on Land Purchase Referendum

Residents of the Kewaskum School District will have the chance to ask questions concerning the upcoming land purchase referendum by attending the Open Forum hosted by the district on Monday, March 17, at 7 p.m. in the high school commons.

This informational meeting is designed to relay facts to the public regarding the proposed purchase of land as part of the school district's long range facilities planning. The intent is to open up lines of communication between the community and the school board to increase involvement in decisions that affect the future of our children's education.

School board members and administrators will discuss the purchase of land and how it will be used, the affect of the dollar amount on the taxpayer, projected growth figures for the dis-

trict, and taxpayers input on what direction the district should be taking to alleviate overcrowding in the schools and address a growing population.

A twelve member citizens committee for the referendum met Tuesday evening to propose additional means to educate the public on the land purchase referendum appearing on the ballot for the April 1 general election. The advocate group will focus on getting accurate information to the public, and considers the land purchase an affirmative vote for the future.

Besides the issuance of informational flyers, the committee chairperson, Marilyn Terlinden, along with school board member Larry Fechter and district business manager George Allmann, are scheduled to appear on WBKV's morning radio talk show Monday, March 24 at 8 a.m. to discuss the upcoming referendum.

Sue Daggett Earns All-American Title

On March 7, in the RCA Dome in Indianapolis, Indiana, Sue Daggett earned the title "All-American" in indoor track at the NCAA Nationals, finishing sixth in the 5,000 meters (3.1 miles), 25 laps in her best personal time of 16 minutes, 23.59 seconds.

Sue competed against 13 other top 5000 M. qualifiers from the United States and Canada.

She is a senior at Illinois State University, Normal, Illinois, a Division One college in the Missouri Valley Conference.

Of the 14 participants only ten would be able to capture the prestigious title of ALL-AMERICAN.

Sue earned the title of All-American in Cross Country in 1996. She is the daughter of Wallace and Joan Daggett of Kewaskum.

Jagielski, daughter of David

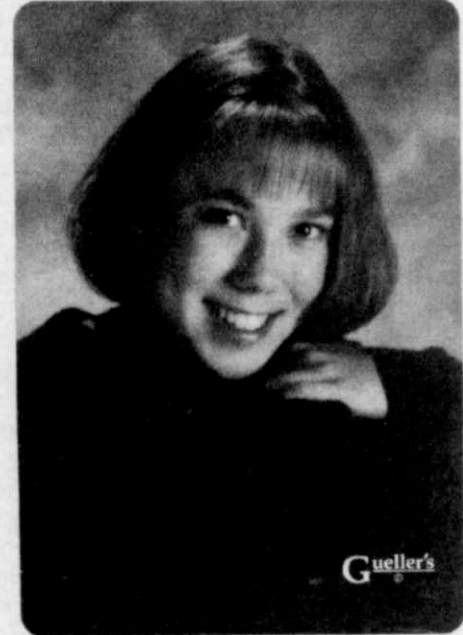

Welsh Froncysyllte Choir to Perform May 2

The Froncysyllte Male Voice Choir of 55 men will appear in concert on May 2, at 7:30 p.m. at the Cedar Theater, Cedar Lake Health Care Center, Hwy. Z, in West Bend.

A group of 90 Welshmen, with wives, accompanist and director, are paying their own air fare to Chicago and Wisconsin from April 28 to May 8 to join in the celebration of 150 years of the Welsh pioneer settlement in Wisconsin. Other concerts will be given in Chicago, Oshkosh, Milwaukee, and Madison, with "home base" being in Oshkosh at the Ramada Inn and private homes from May 1 through 7.

Rev. James Bettin of Peace United Church of Christ, Kewaskum, and his wife Betty (Williams) Bettin are coordinating the Wisconsin concerts and other arrangements for the group. This choir was founded in 1947 and became hosts for the International Eisteddfod (song and music competition) at Llangollen, North Wales. The formation was a gesture of peace to heal the wounds between countries in World War II. It was most successful, with German and Italian choirs soon competing, and a great 1953 Eisteddfod welcomed Queen Elizabeth and Prince Philip to honor the event. The

Froncysyllte Choir has three times won the International Eisteddfod at Llangollen for male choir, the last time being 1994. Bettins, on their third visit to Wales, attended the 1995 event, and it was then the idea of choir participation in the 1997 Wisconsin celebration was born. Betty Bettin has several cousins in the choir, one of whom, Dennis Williams of Froncysyllte, is coordinating plans in Wales.

During its 50 years, the choir has had only three directors, all very able and prestigious. Their present one since 1991 is the first woman to direct, and under leadership, the choir has grown even larger and won numerous additional awards.

Val Jones, this distinguished musician, has led the choir in tours of Spain, Holland, and Germany as well as directing the group to first place awards in many Welsh competitions, as well as in the Malta International Choral Festival, where a choir of 300 professional Russian singers took second place to their first in 1995. Val, whose roots lie in Wales, was a student of Dr. W.S. Lloyd Webber at the Royal College of Music. Later, as Junior Professor, she taught both Andrew Lloyd Webber and his brother Julian in

London, sons of her former teacher!

In 1962, Val was invited to perform at the White House by President John F. Kennedy. She and her husband Eric moved back to Wales, where he was County Music Advisor of Powys until his death in 1975. Val has always encouraged young talent and teaches privately from her home in Powys as well as having directed other Welsh choirs before beginning at Froncysyllte.

The accompanist for the May tour will be Rona Jones of Chester, with roots in Wales. She has acted as pianist for singers and instrumentalists in both Welsh radio and T.V. programs and will appear at Royal Albert Hall, London, in early April, during the Massed Male Voice Choir Concert. She also teaches in Manchester and has been accompanist for the Froncysyllte Choir for tape cassette and C.D. recordings.

These musical souvenir

memories of Welsh folk tunes, Welsh hymns, and songs of many lands, including U.S. songs, in several languages, will be available only at the concerts of the choir. Another accompanist, Owen Roberts, will also be with the choir at his own wish.

A surprise bonus for the tour concerts in May will be the addition of Trebor Edwards, the 57 year old "singing farmer" of Wales, a grandfather and a sheep and cattle farmer with his two sons on 850 acres of Welsh soil. He is the most popular lyric tenor in Wales today, outselling other artists with his eleven recordings. He and his wife wanted to come along and see the midwest U.S.A. He will be hosted on the dairy farm of State Representative Carol Owens near Oshkosh. A favorite requested song of his is "Hen Shep," about sheepdog - the man is rural to his

Welsh roots!

The choir itself is composed of volunteer area singers, gathering in joy to sing together at least twice a week under Val's direction. Their occupations and ages vary - song is their common denominator. Many are Welsh as well as English speaking. They toured Canada in 1979, 1983, and 1984 - as well as Ireland in 1985.

Tickets at the West Bend Concert are limited to 500, and the proceeds are used for bussing and concert-centered needs of the choir. The \$10.00 tickets are available from Rev. James and Betty Bettin, phone 626-2911 in Kewaskum - or by sending Rev. Bettin a check payable to the Froncysyllte Male Voice Choir for the number of tickets desired, plus a self-addressed, stamped envelope. The local address is 1036 Hillside Drive, Kewaskum, WI, 53040. This is a once-in-a-lifetime musical adventure.

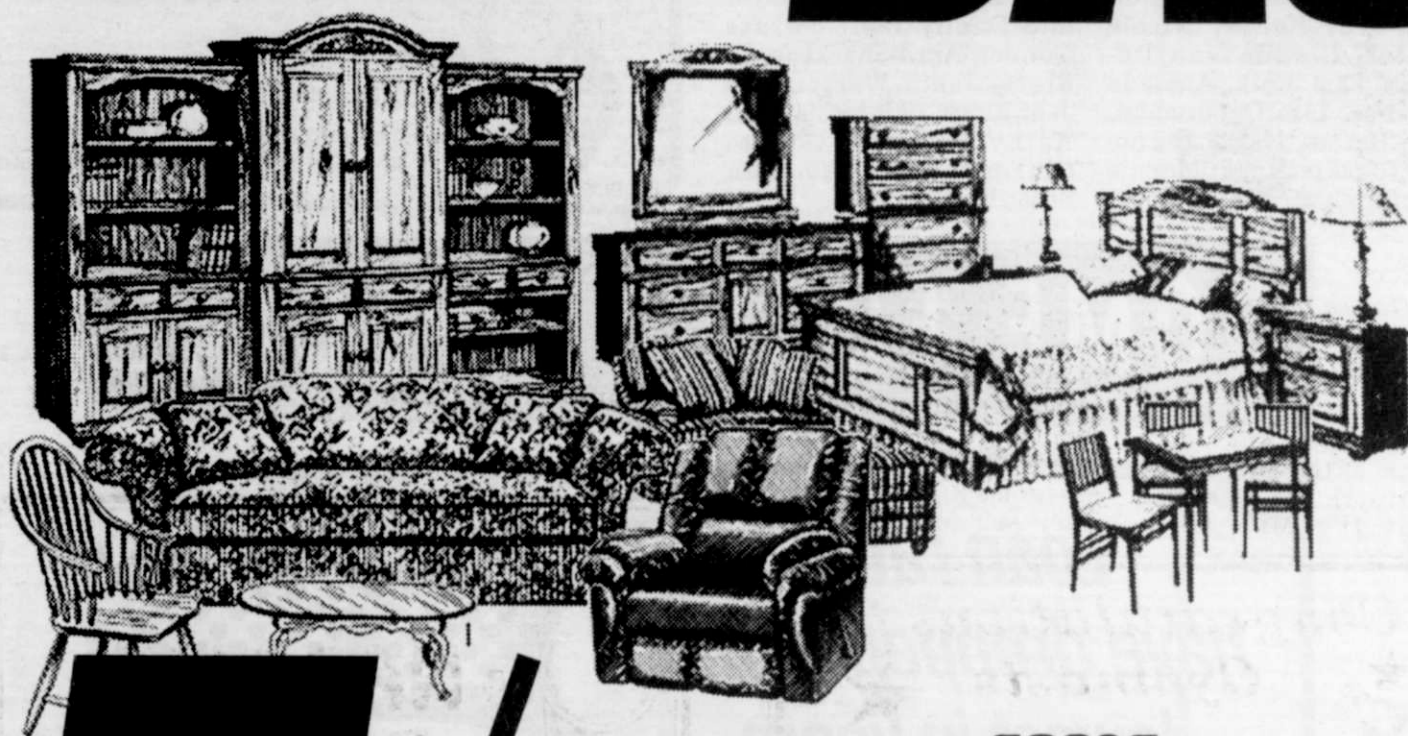

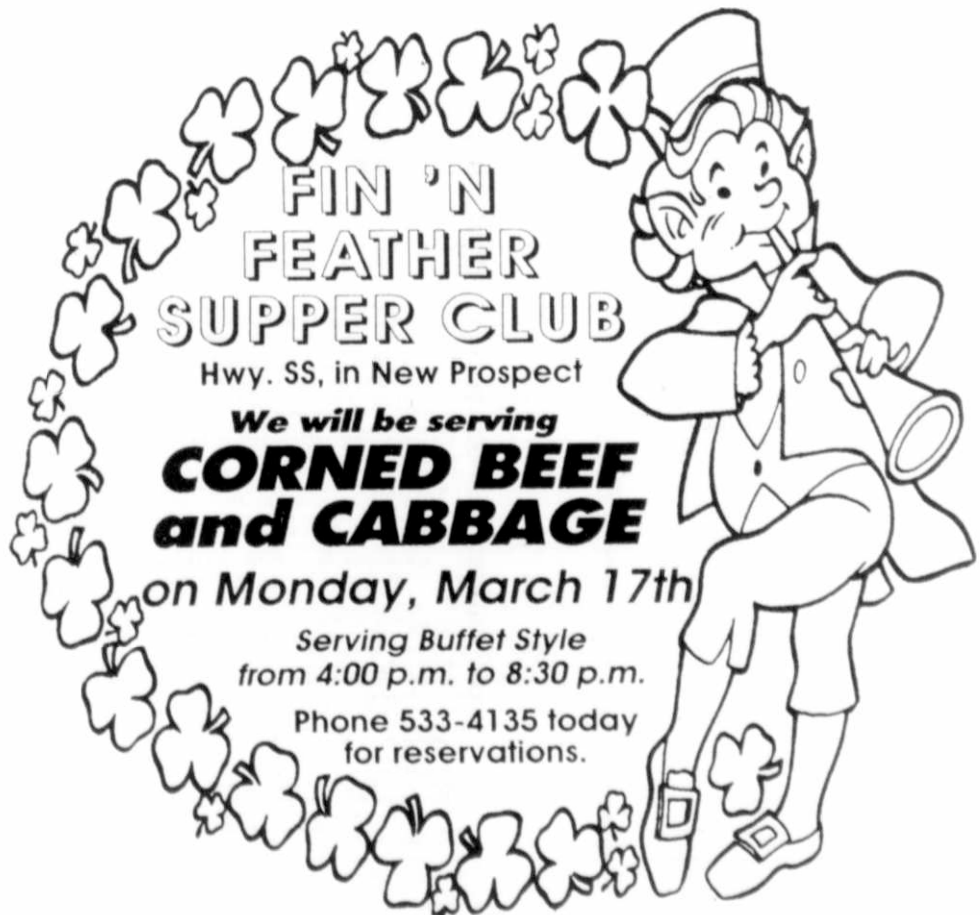

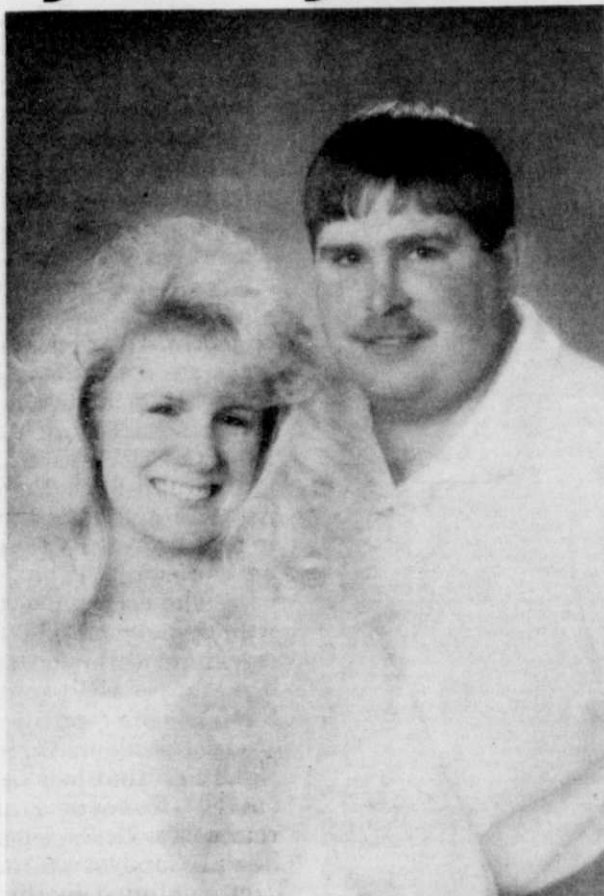

Two of Four District OM Teams Going to State

"Look out State... here comes Kewaskum!"

Four teams from the School District of Kewaskum-- one each from Kewaskum High School, Kewaskum Middle School and Kewaskum and Farmington Elementary Schools -- participated in the Odyssey of the Mind (OM) Regional Competition in New Holstein this past weekend, and two teams, KHS and FES, won their divisions and the right to go to the State competition on April 19.

KMS finished seventh and KES finished 16th in their divisions out of all teams competing in the Regional.

OM requires students to create a solution to a specific "long-term" problem using their own brainpower and limited outside resources, from which they are scored on various aspects of their work and performance. Students had worked on this portion for several months.

KHS and FES each created a skit with an "OMerdroid," a human-looking robot that could perform specific human functions. KMS and KES were required to create a skit including a hero that had a difficulty.

Each team is also scored on a "Spontaneous" problem in which team members must give responses -- to a never-rehearsed question -- off the top of their heads.

KHS was also awarded the prestigious "Ranatra Fusca Award," considered to be the most important award given because it recognizes outstanding achievement in creativity and effort. The engineering aspects of the KHS OMer-droid, which helped secure the award, included numerous ingenious devices to help the robot walk, turn its head, blink its eyes and even smile.

Members of the KHS team, many of whom are making a return trip to the state competition, are: Dan Zuehlke, Brad Oelhafen, Heather Maas, Jessica Schulist, David Kletti, and Exchange Student Henrik Lorenz. The team is coached by KES teacher aide, Con-

nie Schulist.

They are coached by FES fourth grade teacher Marlene Domasky.

Teams from KHS and FES will compete at the state competition in Stevens Point on Saturday, April 19.

To the Editor:

Now is the time to act if we are to save the farming way of life that we know and love here in Wisconsin.

You may have read about proposed federal action on milk pricing, but it also is a state issue. Wisconsin state statutes and Ag Department administrative rules can prohibit unfair trading practices conducted in Wisconsin.

Gov. Thompson wants Congress to fix the problem and does not support state action. Congressional action is needed as a long-term solution, but decisive action at the state level will help to spur national change.

The Fair Milk Price Bill, Senate Bill 2, prohibits trading against interest on the National Cheese Exchange (NCE) with the intent of manipulating cheese prices. SB2 allows state regulation of the NCE and provides the State Department of Agriculture with the tools to ensure fair trade practices.

Milk prices are unfairly tied to the price of cheese on the NCE, which is located in Green Bay. The NCE has been widely criticized for providing a forum for price manipulation. Many farmers blame the NCE for the 25% drop in their income. Is it just a coincidence that the income of farmers crashed last fall, while operating income for Kraft's North American food business hit \$2.6 billion, an increase of 8.5%?

Clearly, the state needs to do what it can to help farmers. The Fair Milk Price Bill has experienced broad bipartisan support in the Senate. Unfortunately, the bill is now hung up in the Assembly, where the leadership cares more about protecting the governor's special interests than farmers.

The recent "Cheese Summit" in Washington D.C., expressed the need for cooperative efforts at the state and federal levels to resolve the milk pricing dilemma. The federal government is considering "de-linking" the price of milk from the price of cheese on the NCE, but Congress moves slowly. U.S. Ag Secretary Glickman encouraged us to continue efforts to regulate the NCE at the state level.

Why has Governor Thompson not been proactive at the state level to help farmers, like he was with the Brewers Stadium? A year ago the governor blocked State Ag Secretary Alan Tracy's administrative rule to prohibit unfair trading practices on the NCE, precisely what the Fair Milk Price Bill does.

Tracy's action was in response to a March 1996 UW-Madison study, which revealed trading practices by large cheese corporations on the NCE directly affected milk pricing.

Thompson's response was to set up a Cheese Task Force to study that UW report. The initial membership of the task force was heavily represented by the cheese industry, clearly not in the best interest of farmers. Dairy farmers were added later, but many criticized the task force because it did not take decisive action.

How can our governor, who preaches bringing federal control back to the states, ask Congress to solve unfair trade practices in Wisconsin when we clearly have the authority to deal with this problem? Wisconsin's "Little FTC Act" (ss.100.20) gives the state the authority to ensure fair trading practices.

In fact, State Ag Secretary Alan Tracy proposed a rule to strengthen our fair trading standards by prohibiting "trading against interest on the NCE." He did his work and did it well until the governor came in with his quarterback sneak to try to circumvent the authority of the state. His Cheese Task Force effectively took the ball out of Tracy's hands.

How much did the Governor influence Secretary Tracy's actions? When Tracy proposed his administrative rule to prohibit trading against interest, the program was estimated to cost \$2,700. A little less than a year later, the Ag Department attached a price tag of over \$411,000 to the bill. How can the cost to implement the same plan increase by 15,000 per cent?

Only after the State Senate requested a supplemental fiscal estimate from the non-partisan Legislative Fiscal Bureau did the Fair Milk Price Bill proceed. In

spite of the lack of leadership by the Department of Agriculture and the governor, the bill passed 28-5.

Is there a connection between Phillip Morris buying out Kraft Cheese in 1988 and the volatility in the market? Is there a connection between the governor's lack of action and the fact that Phillip Morris contributed \$51,000 to his campaign? (11-28-96 *Milwaukee Journal-Sentinel* article). You be the judge. Whatever decision you make, it is clear that the state needs to take action.

Congressman Obey commented that "the 1996 Farm Bill to get government out of dairy has eliminated its ability to moderate price swings." What is left is a deregulated market, where the income of farmers is almost totally dependent on the uncertainties of trading at the NCE and the business decisions of large corporations, like Kraft.

We can let this issue languish at the federal level or we can provide the federal government with a hammer like the Fair Milk Price Bill to force action. It is in the hands of the Assembly and the governor to bring about this change. Wisconsin's No. 1 industry -- the \$3 billion dairy industry -- is in jeopardy, and solutions for fair milk pricing must be found, now.

Now is the time for you to act! Tell them that you want immediate state action, not further political posturing and pandering. (Both have the same mail address of P.O. Box 8952, Madison, WI 53765).

Locally, please call Rep.

Glenn Grothman (R-West Bend) 608-264-8486 or his district office at 338-8061. So far he only has heard from people who oppose the bill. Also call Rep. Michael Lehman (R-Hartford) 608-267-2367 and Rep. Carol Owens (R-Oshkosh) 608-267-7990. We need everyone's help to save our Wisconsin dairy farms.

Wisconsin Electric Adds New Facilities Here and Area

MILWAUKEE -- The Kewaskum area continues to grow, and Wisconsin Electric is ready to fuel the area's growing energy needs.

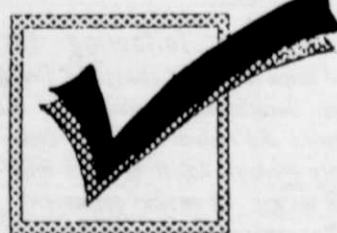

NOTICE TO ALL WASHINGTON COUNTY DOG OWNERS

Pursuant to Section 174.052, Wisconsin Statutes, notice is hereby given to all owners of dogs in Washington County that dog licenses and rabies vaccinations are required.

Vaccination by a licensed veterinarian against rabies is required of all dogs (Section 95.21 (2)) within 30 days after the dog reaches 4 months of age and revaccinated within one year after the initial vaccination. The owner of a dog shall have the dog revaccinated against rabies by a veterinarian when the certificate expires or within three (3) years of previous vaccination. The certificate of rabies vaccination must be presented to the collecting official before a dog license may be issued.

All dogs five (5) months of age or older require a license. The minimum license fee for neutered males or spayed females is \$3.00, upon presentation of evidence attesting to the same, and \$8.00 for the unneutered male or unspayed female dog or one-half of these amounts if the dog became five (5) months of age after July 1 of the license year. The governing body of any town, village or city may raise the minimum dog license tax. Any person who keeps or operates a kennel may apply for a kennel license. The fee is \$35.00 for twelve (12) dogs or less and an additional \$3.00 for each dog in excess of twelve (12).

Dog licenses can be obtained from your local town, village or city treasurer or designee during the course of any given year. Dog owners should notify their treasurer if their dog is given away or has died, so that you will not be considered delinquent. An affidavit of death is available.

PENALTY
Every owner of a dog 5 months of age or older who fails to obtain a license by April 1 will be assessed a late fee of \$5.00.

Pursuant to Section 174.052, Wisconsin Statutes, notice is hereby given to all owners of dogs in the Village of Kewaskum that rabies vaccinations and dog licenses are required. The same applies to cat owners under chapter 12.04 of the Kewaskum Municipal Code.

Certificates of current vaccination must be presented when obtaining licenses.

All dogs/cats, 5 months of age or older, require a license. The minimum dog license of neutered males or spayed females is \$6.00, upon presentation of evidence attesting to the same and \$11.00 for the un-neutered male or un-spayed female dog. The minimum cat license for neutered males or spayed females is \$3.00, upon presentation of evidence attesting to the same and \$5.00 for the un-neutered male or un-spayed female cat.

PENALTIES

A late fee of \$5.00 shall be assessed the owner of each dog 5 months of age or over, who fails to obtain a dog license by April 1st.

An owner who fails to have a dog vaccinated against rabies as required by Statute may be required to forfeit no less than \$50.00 nor more than \$100.00.

1997 Dog and Cat licenses can be obtained from the Village Treasurer's office at 204 First Street from 7:30 AM to 4:00 PM, Monday through Friday.

Village Board Meeting Minutes

Mid-Monthly Meeting
February 17, 1997
8:00 p.m.

The Village Board of Kewaskum, Washington County, Wisconsin, met in Mid-Monthly Session in the Council Room of the Municipal Building, 204 First Street.

President Robert Wagner presided. Trustee Harry Roecker asked to be excused and was absent. All other Trustee Members were present. A quorum was present.

The meeting was opened with a Moment of Silence and Pledge of Allegiance.

On a motion by Trustee Robert Stoltzmann, seconded by Trustee John Kenworthy, and unanimously carried by voice vote, the minutes of the February 3, 1997 meeting were approved as printed.

Assistant Fire Chief Mark Herriges presented the January 1997 monthly report:

Fire calls 2, Year to date 2; Jaws calls 2, Year to date 2; Rescue calls 14, Year to date 14.

Discussion took place regarding the manpower needs of the rescue squad and possible ways to help the situation. The matter will be monitored and further information gathered. It was noted that the non-resident fee was increased for the Village to \$45.00 per call.

It was also reported that the Fire Department used the money donated by Shefond to buy new helmets for the department at a cost of \$7,400.00.

Chief of Police Richard L. Knoebel presented the January 1997 monthly report:

Criminal arrests 24, Criminal investigations 38; Traffic warnings 85, Traffic citations 30; Adult arrest 19, Juvenile arrest 15; Property stolen \$1,022, Property recovered \$1,022; Parking warnings 25, Parking tags 93.

On a motion by Trustee Gary Gavin, seconded by Trustee Warren Dums and unanimously carried by voice vote, the Board authorized advertising for part-time summer employees for the DPW & WPC.

Administrator Daniel S. Schmidt reviewed the following with the Board:

1) Reported on the tax collection and settlement with the other taxing entities. The percentage collected was 72.45%.

2) The Balance sheet for the period ending December 31, 1996 was reviewed. The designated fund balance was also reviewed. It was noted that these numbers are subject to final audit.

3) Review of Taxpayer and League Bulletins.

Chairman of the Administrative Committee, Robert Stoltzmann reported that the Committee and Board had reviewed the proposed changes to the Salary and Benefit Program for the Non-Represented Employees and recommend the same changes as used on the AFSCME Agreement. On a motion by Trustee Gary Gavin, seconded by Trustee John Kenworthy and unanimously carried by voice vote, the Board approved the amendments as proposed.

Chairman of the Protection and Public Safety Committee, Trustee Harry Roecker was absent, but Chief of Police Richard L. Knoebel brought up for discussion the possibility of adopting an ordinance to issue licenses for gaming devices. This would be a small fee and provide a record as to what type of gaming machines an establishment has. Trustee Gary Gavin felt this would be just more government and he thinks we should promote less. President Robert Wagner asked the Chief to check into the matter further and report back to the Board.

Chairman of the Park and Recreation Committee, Gary Gavin reported on the Committee meeting held earlier February 17, 1997. It was noted that Dennis Butz was

present to ask for permission to again use the NE lighted diamond for the softball association on Thursday evenings. There has been enough interest to try and set up one additional evening possibly Tuesday or Monday. Details need to be worked out to avoid any conflicts.

It was reported a thank you was received from the Gridiron Club for the Village's donation.

On a motion by Trustee John Kenworthy, seconded by Trustee Robert Stoltzmann and unanimously carried by voice vote, the Board authorized the advertising for summer part-time employees for the park/beach employees.

The Park Committee also asked Administrator Schmidt to survey other communities regarding park facility fees and to prepare a policy on keeping the Village of Kewaskum's fees current.

Board Representative for the Library Board, Trustee John Kenworthy reported that the advertising for a new Library Director has begun and that the Library Board will be working on the matter during the month of March and hopefully bring a recommendation back to the Board.

Board Representative for the Mid-Moraine Municipal Association, Legislative Committee, Trustee Robert Stoltzmann reported that David Meiser from the Public Policy Forum spoke. The next meeting is scheduled for March 12, 1997 and will have both County Planners present.

Administrator Daniel S. Schmidt brought up for discussion the request for placement of street lights on Edgewood Road and Forest Avenue. It was noted that two existing lights on the east side of Edgewood Road are to be moved across to the west side and that two additional street lights would be installed mid-block on the east side as reflected on the sketch. The cost for the work is \$148.75 per light or \$595.00. Trustee Gavin asked that the property owners be asked what they think of the proposal prior to authorization for installation. Trustee David Goeden indicated he felt the lights should be installed. The matter was tabled for owner verification.

The street light request for Forest Avenue was discussed and it was determined that if the funeral

home was not in favor of moving the existing light, the lights should remain as placed.

Action was taken on Ordinance No. 97-1 an Ordinance to Amend Chapter 10, Public Nuisance Affecting Peace and Safety - regarding construction time designation as attached hereto:

On a motion by Trustee Gary Gavin, seconded by Trustee Robert Stoltzmann and unanimously carried by voice vote, the Board authorized the signing of the Fire Service Contract with the Town of Auburn as returned for execution.

On a motion by Trustee Warren Dums, seconded by Trustee Robert Stoltzmann and unanimously carried by voice vote, the Board authorized the Village Engineers, Ruekert & Mielkie, to perform survey work on an estimated 40 plus properties to define their flood zoning status and to have SEWRPC do some flood flow modeling on an estimated 6 properties. The estimated cost per parcel is \$63.00 with the overall cost projected to be less than \$2,700.00.

Discussion regarding Whispering Willow Plat re-submission as requested by the State, County and developer was held. The Wisconsin Department of Commerce, Wisconsin Department of Transportation and other regulatory agencies requested minor changes in reference to bearings and/or distance changes. The developer asked for some adjustments to footages on lots 1 to 7 to provide for a double faced duplex lot. It was noted all lots are sufficient according to the Village of Kewaskum Zoning Ordinance. The county asked for an offset line in reference to lot 21 due to the creek adjacent to said property. The County also asked for a restriction regarding the access to U.S.H. 45 for lot 14 only. All of the noted changes, after having been reviewed, met with no objection and were not contrary with the initial approval.

Administrator Daniel S. Schmidt reviewed and answered questions regarding the DRAFT of Ordinance No. 97-2, an Ordinance to Amend Chapter 1 General Government, regarding the establishment of an Economic Development/Advisory Committee. Some adjustments and clarifications are to be made and then the ordinance brought back to the Board on March

17, 1997.

Mr. Kenneth Bonlender was in attendance and wished to address the Board. Mr. Bonlender informed the Board that he and several other residents wanted the Board to limit and monitor more closely the number of multi-family units being constructed in the Village. The information as proposed in the Land Use Plan was shared with Mr. Bonlender and several of the Board Members as well as President Wagner told him they support his concerns as that efforts will be made to achieve those goals.

On a motion by Trustee Gary Gavin, seconded by Trustee Warren Dums and carried by the majority roll call vote, to adjourn. Roll call vote was 6 "Aye" 0 "Nay" 1 "Absent."

Type: Plastic Bottles - normally used in 2 liter soda bottles

Hint: P.E.T. bottles will carry the 1 emblem stamped or molded on the bottom.

Preparation: Remove caps and rings. RINSE CLEAN. This is the most important aspect of a successful recycling program. Bottle that contain liquid residue cannot be recycled. Place #1 plastic bottles in your dark green recycling bin or blue recycling bag along with the other recyclable items. Place bin or bag at the curb on the same day that your solid waste is to be collected. Pick up will be Wednesdays for both solid waste and recyclables. Multi-family dwellings of six or more, remember, your recycling pickup will be the first and third Wednesday of each month.

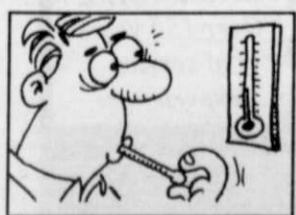
