New Businesses on Main Street

Jim Symicek says it was Kewaskum's Chamber of Commerce that prompted him to open a branch office here of his Hartford based Kettle Moraine Graphics.

Located along Main Street, the printing business opened its doors in Kewaskum on March 2. Specializing in offset printing, graphic design, full color copies, and high speed production, KMG has taken opportunities success has offered through expansion and major investments in equipment. "Now we can better serve Washington County through two locations," Symicek confirms.

Busy keeping pace with his latest endeavor, he has done much in a little over a year, starting off with buying back a business he once began out of his own home, Hartford Print Shops. He promptly changed the name to Kettle Moraine Graphics and added Kettle Moraine Marketing, offering promotional items, screen printing and embroidering. "With a fully computerized product sourcing system, we have access to over 3,000 items," Symicek points out.

Sales and marketing is Jim's forte; it helped put him through Carroll College by selling printing jobs for a local printer. "That's how I

got started."

Majoring in business and computers, he continued to dabble on and off in printing sales, and eventually built up a list of contacts that enabled him to work as a print broker out of his home, the beginning of KMG.

He later sold his business to Marty Knuth of Hartford Print Shop, and worked for him for a number of years before purchasing the business on January 1, 1997. "After being in the industry for nine years, I felt it was time to own the business again, and expand our services," Jim explains.

Since the change in ownership, KMG has made major investments in large equipment purchases. A state of the art, two color press improved the quality and speed of job printing. "That's been a big factor in the success of our business," Symicek relates.

A new Canon 62-85 high speed copier with finishing unit can produce 90 copies per minute, is fully programmable, and puts KMG in the same league with companies that own a Xerox Docutech. Other improvements include and Itek platemaker camera, a full color copier, one of the best in Washington County, and new IBM and Mac computers.

Since Randy and Tim Heberer purchased and remodeled the former Village Bootery building on Main Street in Kewaskum, two new businesses have taken up residence at the location.

Last October, Dennis Butz opened his own branch office of Smith Insurance, specializing in home and automobile coverage.

Smith Insurance, headquartered in Eden, was founded by Bea Smith in 1976. "Their main territory serves an area from Campbellsport to Fond du Lac.

With ten employees between the two businesses, Jim credits the first year's success to their hard work and dedication. Al MacDougal manages the Hartford shop and Carrie Kuehl is executive assistant and manager of the new Kewaskum office. Kathy Tuttle is co-owner of KMG and production manager.

Standing behind their quality of work and high level of professionalism, KMG also stands behind a 100% guarantee. Currently they are putting together a customer education program to help people get the best value for their dollar, including free printing audits.

"The Chamber of Commerce said there was a need (for a print shop) in Kewaskum. The people have been very open, welcomed us with open arms," Jim affirms.

Business hours are 9 a.m. to 5 p.m. Monday through Friday.

The Kewaskum office gives us the opportunity to

expand," Dennis points out.

As an independent agent, Butz has access to service from over 20 different companies, allowing him to find the right coverage at the right price for customers from all walks of life.

Butz previously worked as an agent for another company in West Bend, but decided last August to team up with Smith Insurance after he met up with some of their "key players" as a member of a Campbellsport baseball team. "I grew up here. I've been here all my life," Dennis said. "It's basically my own business, and that's what I wanted to do. You're much more motivated if it's your own."

A former construction worker for ten years, and RV mechanic for eight, Theisen was forced to reevaluate his life after knee surgery left him unable to return to his pre-

vious occupation. With help from the Department of Vocational Rehabilitation, Theisen found he excelled in mechanical aptitude, and enrolled in a 45 week program in Office Equipment Repair at Waukesha County Technical College.

He made the honor roll, graduating in 1996, and went to work for two Milwaukee firms, earning experience along the way. After two years of traveling around southeastern Wisconsin repairing a variety of printers, copiers, fax machines, typewriters and the like, Don felt he had enough first hand knowledge to go

"There is a big price savings in bringing it here versus calling the company and getting socked with a huge service charge," Theisen points out. Don also does maintenance and cleaning of equipment, and orders parts for most makes and models.

Another of the store's features is a full line of new and used office furniture, from chairs and desks to large conference tables, file cabinets and accessories. "I just finished a job supplying the new New Fane Church Hall," Don adds, hoping people from the community will stop by and let him know what they may need, how much they want to

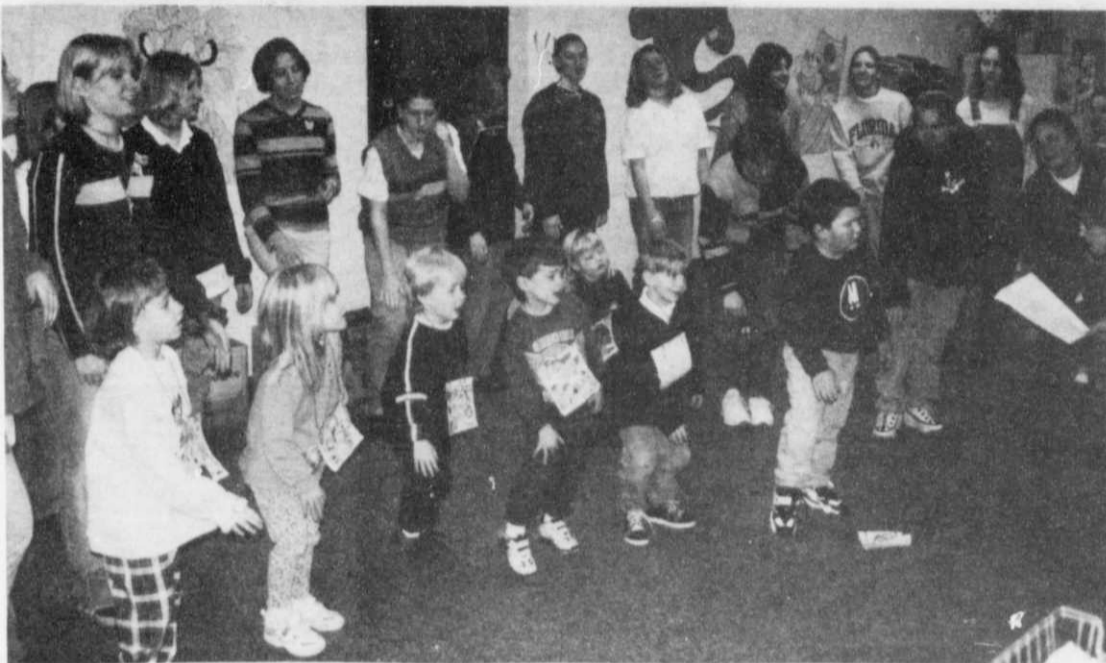

A Stroll Up Main Street



Our last stop on our Stroll Up Main Street shows us another of Kewaskum's landmark buildings. The business, located on the northeast corner of Main Street and Fond du Lac Avenue, was originally known as The American House and early owners included Louis Guth, Ed Guth, George Petri, John Guth, Nic Guth, Sr. and Nick Guth, Jr. According to "Kewaskum Then and Now" the last owner was John Van Blarcom Sr. before the building became the Corner Drug Store. When Isabelle Mucker-

heide came to Kewaskum in the late 40's, the Corner Drug Store was operated by Otto Graf and his wife Ann. Isabelle said they had a soda fountain, sets of ice cream chairs and Rose McLaughlin worked there at the time. Children used to tease him, calling him Grandpa Graf (after the Creamy Top Root Beer). After the death of Mr. Graf, the drug store business was sold to Ray and Ann Skrentny and Mrs. Graf moved to Milwaukee. Following the death of Ray Skrentny, Sr., an auction was held

there and later Kennelly Pharmacy opened a drug store in the building. Dennis Butz stated in 1975-76, Eric Torkelson of the Green Bay Packers came to the store and signed autographs on a Friday night. Black and white photos were available for sale, but he did not charge for his autograph. The drug store portion of the building has remained vacant since Kennelly Pharmacy relocated to the Kewaskum Mall years ago.

Mountain Bike, Bridle Trails in Northern Kettle Moraine Closed

All mountain bike and bridle trails in the Kettle Moraine State Forest - Northern Unit are closed. To protect the trails from damage during ice thaws and spring rains, the trails will be routinely inspected and will open when conditions on the trails improve.

Forest Superintendent Jerry Leiterman, said that because of fluctuating temperatures in late winter and early spring, trail surfaces

are extremely susceptible to erosion damage. "Closing trails during this time is the best preventive maintenance we can do," said Leiterman.

Traditionally, Northern Unit's biking and bridle trails are open for the season in mid-spring. Those interested in using the trails should first call (414) 626-2116 for information on trails.

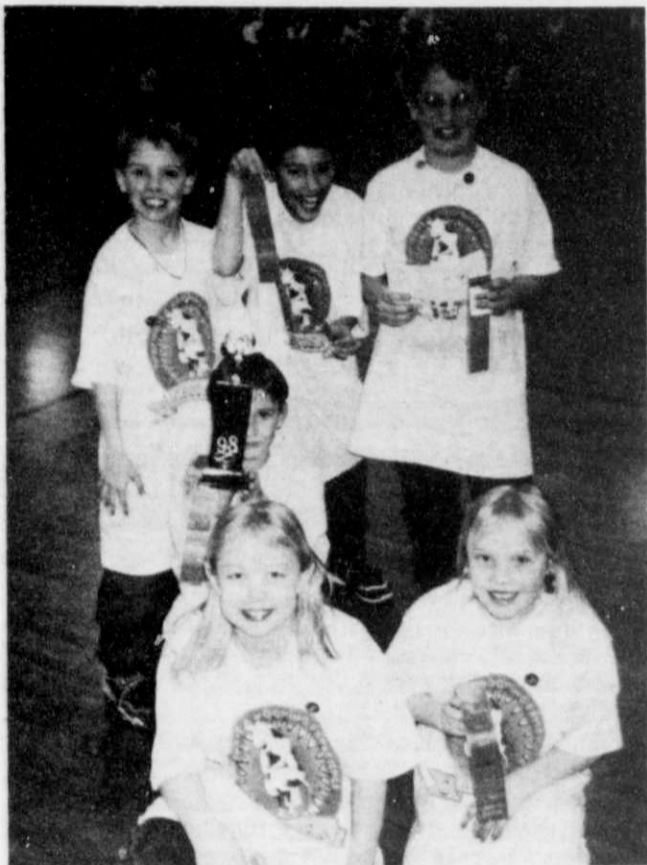

Kewaskum Schools came home from the recent Odyssey of the Mind (OM) New Holstein Regional competition chock-full of impressive scores -- so impressive, in fact, that the team from Kewaskum Elementary will advance to April's State competition in Stevens Point.

Odyssey of the Mind is an extracurricular activity designed to promote creative problem solving and spontaneous thinking. The New Holstein Regional hosts teams from dozens of schools annually.

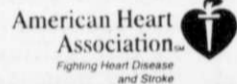

Letter to the Editor:

This letter is directed in large to the residents of the Town of Wayne.

About 15 months ago, Town of Wayne residents were asked to fill out a survey for a new land use plan. A plan designed for controlling the future development of our rural community. Results of that survey showed that 74% of the residents want to preserve the rural atmosphere. 70% of residents want to regulate development through zoning and land division ordinances. 67% of the residents want to discontinue all residential development on all prime farmland. 70% want to protect woodland, and 65% want to protect wetlands and floodland. 45% of the residents want slower growth or no growth at all. Only 4% want faster growth than we have at the present, which is 10% from 1990 to 1996. 78% of the residents agree that farmland should be preserved and 74% would be in favor of tax credits to farmers who keep their land in farm use.

In short, an overwhelming majority of people want to preserve the "rural community."

The land use plan is in the development stages right now. The Plan Commission is looking at a five acre rural density (an average of one lot per every five acres - actual lot sizes could be larger or smaller). That means that every 40 acre field in the Town could have eight homes built on it. If the farm field you drive by on your way to town is 80 acres, as many tracts of land are, you could have 16 homes, every 1/4 mile of country road. How is this preserving the rural "setting?" What this does is open farm lands up to the development of what could be considered small subdivisions. Is this what the majority of the people want?

It would not be right to expect residents or farmers who want to get out of farming, to not sell their land. And it's not right to expect the residents or farmers of a rural community to accept a subdivision lifestyle because

the 80 acre field is now being developed. Somewhere there has to be a balance.

About a year ago, the Plan Commission talked about having a plan that would coincide with the surrounding townships. The Town of Barton has a 35 acre minimum with one bonus lot for parcels over 35 acres and two bonus lots for parcels over 70 acres. The Town of Kewaskum has a 35 acre minimum west of Kewaskum. The Town of Addison has a 35 acre minimum lot size. How does a five acre density for Wayne fit in with the surrounding areas?

Some of the Plan Commission members have stated, "Where are the people when we hold our meetings?" Others say, "If people don't show up, they just don't care." A lot of people thought the survey that they filled out was enough to develop the Land Use Plan. But that is not the case. People need to voice opinions at meetings, write letters, or call your Town Board officials. They were elected to represent YOU. The Plan Commission members are appointed by the Town Board. To get your point across, come to meetings and let them know how you feel about the development of "your town." The people who want to develop land are getting their views across loud and clear. One board member said, "I wish more people would attend and let me know how they feel on these matters, so I could do a better job." It's not always easy to make time to attend meetings, make phone calls, or sit down to write a letter these days, but that may be necessary to get your views heard.

If you think that life will always be the same out here in Wayne, just drive around areas like Jackson, Hartford, Germantown or Richfield.

One board member stated that he'd like to finish the Land Use Plan by the end of the year. Time is running out. Or maybe like some board members stated, no one cares. We truly

hope that's not the case.

The next Land Use Plan meeting is on March 31, at 7:30 p.m. The Annual Town Meeting is on April 14 at 7:30 p.m. at the Wayne Town Hall. This meeting has an open agenda. People can bring up anything for discussion.

Dear Residents of the Kewaskum School District,

Last week I addressed my views on academic expectations/standards. This week I'd like to explain my views on the upcoming building referendum and a term you may be hearing -- a recurring referendum.

First, the educational models. I support the K-5 model for two main reasons: a) it's working -- our test scores are improving and, b) the middle school teachers are firm supporters of the 6-8 middle school system and they defended this system based on good solid evidence. The teachers came to a Board meeting, presented many good points, and backed them up with facts. Bravo!

I am in favor of building a new KES but I'm torn between where it should be built. Common sense tells me that KES should be located on its present site in the village so that our children can walk to school. But the traffic issue concerns me. We will need to clarify some of the safety considerations as we formulate the plan.

Second, a recurring referendum. Let me state here that I am opposed to all referenda on the basis that they seek to exceed the state-imposed spending limits. I am against spending more than these limits allow. The reason I voted in favor of the recent land referendum is because, in addition to the land being needed for future growth, the purchase would not have raised our taxes at all! I have always believed that a person would have to be crazy to vote to have his taxes raised but sometimes

even a fiscal conservative as myself can see the need to do so. It took a lot of convincing, but I finally had to admit that, yes, KES is not even close to what it should be and the outlying schools will soon fall short in handling the growth occurring in Farmington and Wayne. So I am willing to "bite the bullet" and okay a referendum. (Oooo, that hurt!).

However, a recurring referendum is a totally different matter. An ordinary referendum asks the district taxpayers for permission to exceed the spending limit for a set amount of money. Once the loan is paid, the added tax is over. A recurring referendum asks the taxpayers once to allow the district to exceed the spending limits by a certain amount year after year after year in order to pay for something it can't afford. Sometimes a time limit is imposed, sometimes not. If the funds are needed on an ongoing basis to support the item in question and the district cannot find the money in its existing budget to pay for it, then there will be virtually no end to exceeding the spending limits every year forever.

Spending limits were mercifully imposed by the state legislature in order to curb the past outrageous spending habits of school districts around the state. It's true that the referendum process was installed by the state as a means to allow districts to exceed these limits if they wish. I agree with the local control philosophy. However, school districts spent money as though there was a bottomless pocket out there (the taxpayer) and with little accountability. This practice has had a devastating effect on homeowners and especially those homeowners on fixed incomes. Many were on the verge of being taxed out of their homes. So the legislature stepped in and basically said, "Enough! Live within your fiscal limits." (I wish our legislature would take a dose of its own medicine.)

Spending limits have forced districts to determine what is a need and what is a want. I try to look at our district's fiscal needs as a homeowner. As a homeown-

er, I can't always undertake all the home projects that I'd like. I have to prioritize and budget for each. If an emergency arises, such as needing a new roof, it may be necessary to forego our family vacation in order to afford that roof. I must determine what is a need and what is a want. School districts (and all governmental bodies, for that matter) need to remember that there is a bottom to the taxpayer pocket.

According to the information provided to the Board, the only realistic way Beechwood School can be operated is through a recurring referendum. I like Beechwood. I like the concept and opportunities offered by small schools. However, I cannot support a recurring referendum as the way to meet its operational expenses. The estimated costs and future district enrollment projections vary at this time. In addition, the Town of Scott zoning does little to support growth in Beechwood. I believe we need to live within our means. If Beechwood is truly essential, we must find another way to pay for its operation. I will not support what amounts to giving the school board an open checkbook. I believe it could spell financial disaster for the taxpayer and it sets a dangerous precedent. A recurring referendum negates the very reason spending limits were imposed in the first place and it places a heavy and precarious burden on folks living on marginal or fixed incomes. Have we helped "the kids" if we have virtually taxed their parents or grandparents out of their homes or chipped away at a family's disposable income in order to pay for something that has not been proven as a need? We should find another way and I'm open to suggestions.

Canine Fun Match Raises Funds For State 4-H Dog Show

Although the weather outside was awful, the atmosphere inside the Hartford Armory on Sunday, March 8, was one of anticipation, patience, preparedness and excitement.

It was the first indoor winter Fun Match sponsored by the Washington County 4-H Canine Company for the dogs and their owners and friends, and drew 117 entries with 28 different breeds of dogs shown in conformation and obedience. Some contestants came from as far away as Portage,

Sheboygan and Kenosha.

Anna Kodet, along with her papillon Chantel, won Best Junior Handler in the competition. Kodet, a member of the Kirchhayn Trotters 4-H Club trains with her dogs on a weekly basis with the Washington County 4-H Canine Company at the Hartford Armory. She has been training and showing dogs since the age of four. Kodet is now 11 years old and also enters American Kennel Club Shows on a regular basis.

The dog project is open to

4-H members from the county, but Sunday's show was also open to the general public, in order to raise funds for the sponsorship of the statewide 4-H dog show in Waupun this coming August.

Dogs were judged in obedience, where dogs are judged on how well they listen to their handlers and perform for them, and conformation, where attention is paid to the overall structure of the dogs and the way they gait around the ring. Junior showmanship judging had a large entry where young adults show just how well they can handle their pets.

Dustin Ostberg, also a

member of the 4-H Canine Company, along with his dog Shadow, an Australian Shepherd, took the High Score Pre-Novice Title. This Class was open to the public and Dustin won over many adult contestants. Although Dustin admits he sometimes get a little nervous before a competition, once he steps in the show ring with his friend, he is all business and his performance as well as his dog's performance proves it. Dustin also took 1st Place in the Novice Junior Showmanship class.

Other winners in the Junior Showmanship classes included Zara Gercz who took 1st place

in the 8-10 Year Old Division and Linda Lueder, who took 1st Place in the Open Senior Class.

Dear Residents of the Kewaskum School District,

I bring to your attention a meeting (actually, what we call a worksession) on March 30, 1998 at 7 p.m. in the high school library. We don't vote in a worksession but do come to a consensus for a decision that will be voted on in a future meeting. Members can change their mind before the vote but after the vote it is a done deal. One of the issues regarding facilities that affects all members of the district will be whether to re-open Beechwood Elementary School (BES). Since the board already, by consensus, has decided to keep the 6th grade in the middle school (I didn't agree -- educational value and cost) we would be deciding based on a K-5 arrangement. This is the "life or death" decision. This is the ninth inning. Bases loaded. Two outs. It is the 11th hour.

There is the possibility that the decision will be put off till later, however, at the last worksession, we agreed to come to a consensus on March 30th.

So far, we have had the current administration and previous administration recommend that we re-open. We have had two separate facilities committees over the last two years recommend that we re-open. We surveyed the most recent committee to see if they were unduly influenced or afraid to speak out on their position regarding re-opening BES and did it

in a fashion so they could remain anonymous. The results? Of the 11 surveys returned, nine say re-open, one undecided and one sell. These recommendations are based on educational value and fiscal responsibility. To this date, I am very unsure as to where the four needed votes will come from, if at all.

I recommend that anyone coming to the meeting or in talking to others, to keep this in mind: The decision for re-opening BES stands on its own for today and the future. None of us needs to dwell on the past, what happened and what coulda shoulda been. Nor should we become overjoyous. Save that for what I hope will be the re-dedication ceremony.

Two of the many important considerations for a board member to keep their focus on are educational value and the cost for that value. In other words, in a given situation does this decision improve or damage the end results of our educational program, what are my options and is the change worth the expense or savings? Within these parameters are numerous complications. Use your imaginations.

Election time is approaching. I am one of the candidates for the two open seats on the school board. Your choice is not an easy one. All three of us bring experience and have had various successes beneficial to the educational program and the fiscal management of the district. It should be a difficult choice for you. If not, then you probably don't know enough about what each of us stands for and what we've accomplished. You can learn a lot by com-

ing to just this one meeting on March 30th. I hope to see you there.

Village Board Meeting Minutes

Regular Meeting
March 2, 1998
8:00 p.m.

The Village Board of Kewaskum, Washington County, Wisconsin, met in Regular Session in the Council Room of the Municipal Building, 204 First Street.

President Robert Wagner presided. All other Trustee Members were present. A quorum was present.

The meeting was opened with a Moment of Silence and Pledge of Allegiance.

On a motion by Trustee Robert Stoltzmann, seconded by Trustee Harry Roecker and unanimously carried by voice vote, the minutes of the February 16, 1998 meeting were approved as printed.

The bids received for the construction of the proposed park and ride lot, which were opened on February 17, 1998 were as follows:

Runge Excavating & Engineering, Campbellsport, WI - \$62,411.55

Town & Country, Mayville, WI - \$72,178.40

Scott Construction, Lake Delton, WI - \$76,643.25

Musson Brothers, Inc., Waukesha, WI - \$82,029.07

It was noted the project was proposed to cost \$44,500.00 plus a few additional thousand dollars for the driveway and sidewalk lowering. This would mean that when adding in the final engineering the Village would have to spend \$25,000.00 in addition to the grant money. A total of six options as to how to handle the project were discussed. On a motion by Trustee John Kenworthy, seconded by Trustee Gary Gavin and unanimously carried by voice vote, the Board rejected all bids received for the Kewaskum Park and Ride and directed the Administrator to notify the Department of Transportation that said project is being discontinued because costs exceed budgeted funds. It was further noted that the DOT may wish to consider placement of a park and ride in conjunction with the USH 45 project work scheduled for the year 2001.

Chief of Police Richard L. Knoebel informed the Board that the 1998 squad car has arrived.

On a motion by Trustee Robert Stoltzmann, seconded by Trustee Gary Gavin and unanimously carried by voice vote, the Board authorized lifting the winter parking ban immediately. It was noted that if a snowfall occurs a snow emergency may be declared by the Village President or Administrator. Director of Public Works, Jerry Gilles informed the Board of the following:

1) Reported that a seedling tree program is being offered through the County and that the Village may participate and resell said trees to the citizens of the Village of Kewaskum. On a motion by Trustee Gary Gavin, seconded by Trustee Warren Dums and carried unanimously by voice vote, the Board authorized the expenditure of \$400.00 for said purchase and authorized the sale of said trees at a cost of an estimated \$1.00 per tree.

Administrator Daniel S. Schmidt reviewed the following with the Board:

1) Review of Mid-Moraine, League and Taxpayer Bulletins.

2) It was noted that the tax collection process went well and that the dollar amount of collection is ahead of last year.

3) The year end balance sheets for 1997 and departmental year end sheets subject to audit and adjustments were reviewed.

4) Reported that the EDAC survey has been mailed out and that the opening and tabulation is being conducted by UW Extension. The Extension office noted they were running behind and that the next meeting is proposed for the last

week in March. It was further noted over 500 surveys were returned which would indicate a rate of return in excess of 55%.

5) The Board was advised that the certification of legal description of total boundaries was complete and that the Village would be submitting that certification later this week.

On a motion by Trustee Robert Stoltzmann, seconded by Trustee Harry Roecker and unanimously carried by voice vote, the Board approved the issuance of an Operator's License upon proper payment of fee and documentation for the following:

Trustee Robert Stoltzmann, Chairman of the Administrative Committee announced a Special Meeting of the Village Board for Thursday, March 5, 1998 at 6:00 p.m. to go into closed session to perform non-represented employee evaluations.

Trustee John Kenworthy, Chairman of the Park & Recreation Committee reported that the Women's Club and Mr. and Mrs. Larry Ammel both donated \$100 to go towards the concrete flower pots. It was also noted that the Kewaskum Kiwanis will be donating \$1,000 for the water apparatus and money for two street benches.

Board Representative for the Plan Commission, Trustee Warren Dums informed the Board that the Commission reviewed Sections 8 and 9 of the Zoning Ordinance. Mr. Rick Kania of SEWRPC was present to inform the Commission of the status of the Zoning Ordinance update.

A number of related items in reference to the project were reviewed. Several points were agreed to by consensus of the Board which will be transmitted to the engineers for incorporation with the project. Points discussed were as follows:

1) Storm sewer area to be drained.

2) Work on the easement and permits.

3) Storm sewer design for ten year flood period.

4) All phases of the asphalt type repair.

5) Extension of water mains on Brooklane and Roseland Drives

6) Future installation of water main adjacent to Roseland relief sewer. (8" to 12" difference in cost to be picked up by water utility)

7) Roseland relief sewer over-sizing to be picked up by sewer utility. (8" to 15" difference to be picked up)

8) The USH 45 east side creek crossing to be tabled in reference to

this project.

9) East-west railroad crossing to be installed for existing use, not future.

10) Placement of hydrant at Second Street and Regal Ware. This is to provide for a valve and common hydrant.

11) Review of proposed tentative schedule.

It was noted that if all goes well authorization to advertise for Old Fond du Lac Road project will take place on March 16, 1998 with the public hearing and possible award of contract on April 20, 1998.

The asphalt work as budgeted for 1998 will be brought to the Board for authorization to advertise on March 16, 1998 also.

On a motion by Trustee Gary Gavin, seconded by Trustee Robert Stoltzmann and unanimously carried by voice vote, the Board authorized the signing of the Local Road Improvement Project for 98/99 for Old Fond du Lac Road.

ORDINANCE NO. 98-3

AN ORDINANCE TO AMENDING CHAPTER 18 BUSINESSES

THE VILLAGE BOARD OF THE VILLAGE OF KEWASKUM, DO ORDAIN AS FOLLOWS:
THE VILLAGE BOARD OF THE VILLAGE OF KEWASKUM, WISCONSIN WISH TO CREATE/AMEND CHAPTER 18 - BUSINESSES AND ORDAIN AS FOLLOWS:

Section 18-57. Licenses and permit fees.

(11) Pawnbrokers and secondhand and jewelry dealers. As set from time to time by the Village Board. (Unrelated to this ordinance the fee is set at \$30.00 per each license.)

ARTICLE VII. PAWNBROKERS AND SECONDHAND AND JEWELRY DEALERS.

Section 18-301. License required.

No person shall conduct or manage for gain within the village any pawn, secondhand and jewelry shop without obtaining a license therefor.

Section 18-302. Application for license.

Every application for a license required by section 18-301 shall be made upon a blank furnished by the village clerk/treasurer and verified and shall contain all noted and required information. The village clerk/treasurer shall issue a license to the applicant upon his compliance with all the provisions of this Code and state law, upon payment of the proper fees and law enforcement recommendation.

Section 18-303. Condition of premises.

Premises licensed under this article and all structures on the premises shall be so situated and constructed that the business may be carried on in a sanitary manner; shall contain no fire hazards; and shall be arranged so that thorough inspection may be made at any time by the proper health, fire, building and police authorities.

* State law adopted by reference - Pawnbrokers and secondhand and jewelry dealers as per Wisc. Stats: 134.71.

This Ordinance shall take effect upon passage and publication as provided by law.
