Students to Return to District Schools Aug. 19

Wednesday, Aug. 19th is the first day of school for new and returning students of the Kewaskum School District.

Johnson Bus Company will soon be sending out information on bus rules and pick-up times. If you have not received this information by August 14th please call them at 626-4414 to complete arrangements.

We ask that families take time to review the bus riding rules and safe boarding, riding, and unloading procedures. If this is your child's first experience at riding on a bus, why not take some time to accompany him/her or arrange for someone else to accompany him/her for their first pick-up and drop-off?

Also please be aware of the times crossing guards are present on village street corners and utilize them accordingly. Please do not send or drop your children off at school before the school doors open because they will be unsupervised.

Information for those interested and eligible for the free and reduced hot lunch program is also published in the Kewaskum Statesman. During registration the forms were available to those interested. If you did not receive a form and would like one sent to you, or wish to review the qualifying criteria, please call the business office at 626-8427, extension 8001.

Hot lunch prices for the 1998-99 school year are as follows: elementary schools \$1.30 per day or \$6.50 per week, middle school and high school \$1.55 per day or \$7.75 per week. School on Wednesday is a full day and hot lunch will be served. The calendar for the school year has been published and each family received one at registra-

tion.

The school district does not carry accident insurance for students. We therefore urge parents/guardians to review their own policies to be certain coverage is adequate. Particularly in the case of athletics, this is a necessity.

The buildings and grounds are in good shape and the classrooms are clean and ready for students. All is in readiness and we are anxious to greet the children and begin another year.

Many teachers have attended various courses, workshops and seminars over the summer to improve their skills. Administrative staff worked to hire new staff and arrange schedules, discuss goals and refine the vision of the district.

Most important to us will be the continued support and involvement of parents, grandparents, guardians and community members at large. Please take the time to review school handbooks and rules with your children, help them with their homework, call their teachers or principals, and visit their schools. You are important and we need your assistance.

Hints for a successful start to the 1998-99 school year include the following: Be positive about the teacher(s) your child(ren) has/have and the programs available; be interested in what is happening on a daily basis; encourage participation in extra-curricular activities; set goals that are high enough yet realistic; and set aside some time to talk to your child/children each day.

School Board Breezes Through Light Agenda

The Kewaskum School Board sailed through a light pre-school agenda at Monday night's meeting.

The board OK'd charges for the use of school facilities by two local daycare centers. Little Folks Schoolhouse in Wayne and Tuttle Creek Learning Center in Kewaskum will be providing before and after school programs at Wayne and

Kewaskum Elementary schools for the upcoming school year.

Both businesses will be charged one dollar per student as a monthly fee, until the success of the program is evaluated after the first year. Currently, six students are signed up at WES, 18 at KES. Children up to age 12 are accepted into the program.

New KES is Focus of \$12 Million Referendum Sept. 8

Architects Drawings on Page Two

A new elementary school within the village is the focus of the September 8, 1998 school referendum asking district taxpayers to approve a \$12 million dollar building plan.

Kewaskum Elementary School - originally built in the 1920's (with additions constructed in the 1950's, 1960's and 1970's) does not meet the ADA handicap requirements because of the three stories. Structural problems are beginning to occur because the way in which the buildings were tied together during construction additions. Special education classes require updated facilities to meet student needs.

Wayne and Farmington Elementary Schools - are near capacity and require updating to meet computer and library needs. Facilities are limited for speech and reading specialists to work with children. Farmington gymnasium and cafeteria are not handicap accessible.

Kewaskum High School - original section built in the 1950's - needs updating for lighting, asbestos tile removal, locker replacement and revamping of the heating and air handling equipment, and gymnasium floor replacement.

Administrative Office - originally purchased in the 1970's - as two portable classrooms - does not provide adequate space for the business and administrative staff. The two units are costly to heat and operate.

The Kewaskum School Board approved a one question referendum, and is requesting approval for new construction, remodeling, and improvement to address these problems: "Authorizes General Obligation Bonds, not to exceed \$12,000,000, for the purpose of paying the cost of constructing a new Kewaskum Elementary School; constructing a permanent Administration building; remodeling, constructing additions, and equipping Wayne and Farmington Elementary Schools; modernizing interior portion of the high school; and demolition of the old Kewaskum Elementary School."

The new KES will be situated on the seven acre parcel bordered by Reigle Drive, Third Street, Bilgo Lane and First Street. The old elemen-

tary school will be torn down, making way for a new 76 car parking lot, a hard surface playground area, kindergarten play area, and athletic fields.

The current building does not meet the ADA requirements for handicap accessibility. It is highly inefficient to operate in terms of heating and air handling. Asbestos tile and incapacitated piping runs throughout the building. Plans include demolition of the existing KES and asbestos removal.

The new two-story elementary building will house approximately 78,750 sq. ft. of space for pre-school through fifth grade students. Along with classrooms and special education space, plans indicate music and art areas, an IMC gymnasium, administrative and student services, auxiliary areas, and a flexible, two-stage, gym that allows for a cafeteria, media center, and community usage.

Total costs to the district, including demolition and site development, will be \$7,400,000.

A \$2,250,000 addition to Farmington Elementary School will enlarge space for offices, guidance, restrooms, classrooms, storage, gym, air conditioning and remodel existing space, including the cafeteria.

Wayne Elementary School will receive \$1,050,000 of referendum monies to remodel the school and add on a conference/workroom, air conditioning, and a gym entrance feature. Renovations include classrooms, the gym, bathrooms and corridors, and adding blacktop paving.

A \$1 million dollar project at Kewaskum High School will accomplish remodeling corridors in existing building, new floors, ceiling, lights, wall finish; air condition central portion of building - cafeteria, FACE, Special Education classrooms, and teachers lounge, 700 building, kitchen locker rooms and Rose Hall; add central chiller and chilled water piping system to those areas served by unit ventilators. At areas served by air handling units, add a central chilled water system or separate compressor condensing units.

Remodel 700 building, replace rusted metal sill on exterior siding, paint metal siding, insulate and add interior wall finish, new acoustical ceiling and lights, new carpet. Remodel Field House: resur-

face floor, paint walls inside and out, repair bleachers. Rose Hall: develop stage and seating.

Based on the Kewaskum School District's amortizing general obligation bonds over twenty (20) years, the increase in the mill rate will be .35 cents per thousand dollars of equalized valuation.

This means that if a taxpayer has a \$100,000 home, the real estate taxes will increase \$35.00 because of the bonding issue. For a \$150,000 home the cost would be \$52.50 per year. A home valued at \$200,000 would see the property taxes increase by \$70.00.

Once the referendum passes, the time line for construction and remodeling is scheduled as follows:

1) Farmington & Wayne - new construction and remodeling to begin in the spring of 1999 and be completed by August 1999.

2) Kewaskum Elementary - new construction to begin in the spring of 1999 and be completed by August 2000.

3) Kewaskum High School - remodeling to begin in the spring of 1999 and be completed by August 1999.

4) Administrative Office - new construction to begin in the spring of 1999 and be completed by fall of 2000.

5) Demolition of old Kewaskum Elementary by spring of 2001.

Voting will be at the primary election on Tuesday, September 8, 1998. The ballots will be cast at the normal polling places (at normal polling hours). All people 18 years of age and older who have lived in the district at least ten (10) days prior to election day are eligible to vote. Pre-registration is not necessary. Voters new to the district may register on the day of the election. Absentee bal-

Pregame will begin at 2:40 p.m. with the game being broadcast at 3 p.m.

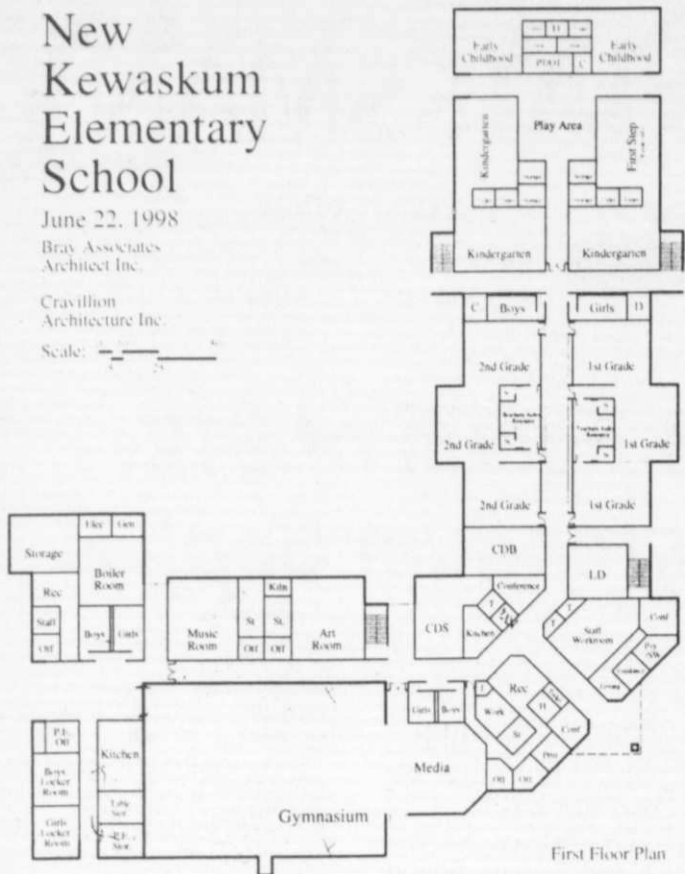

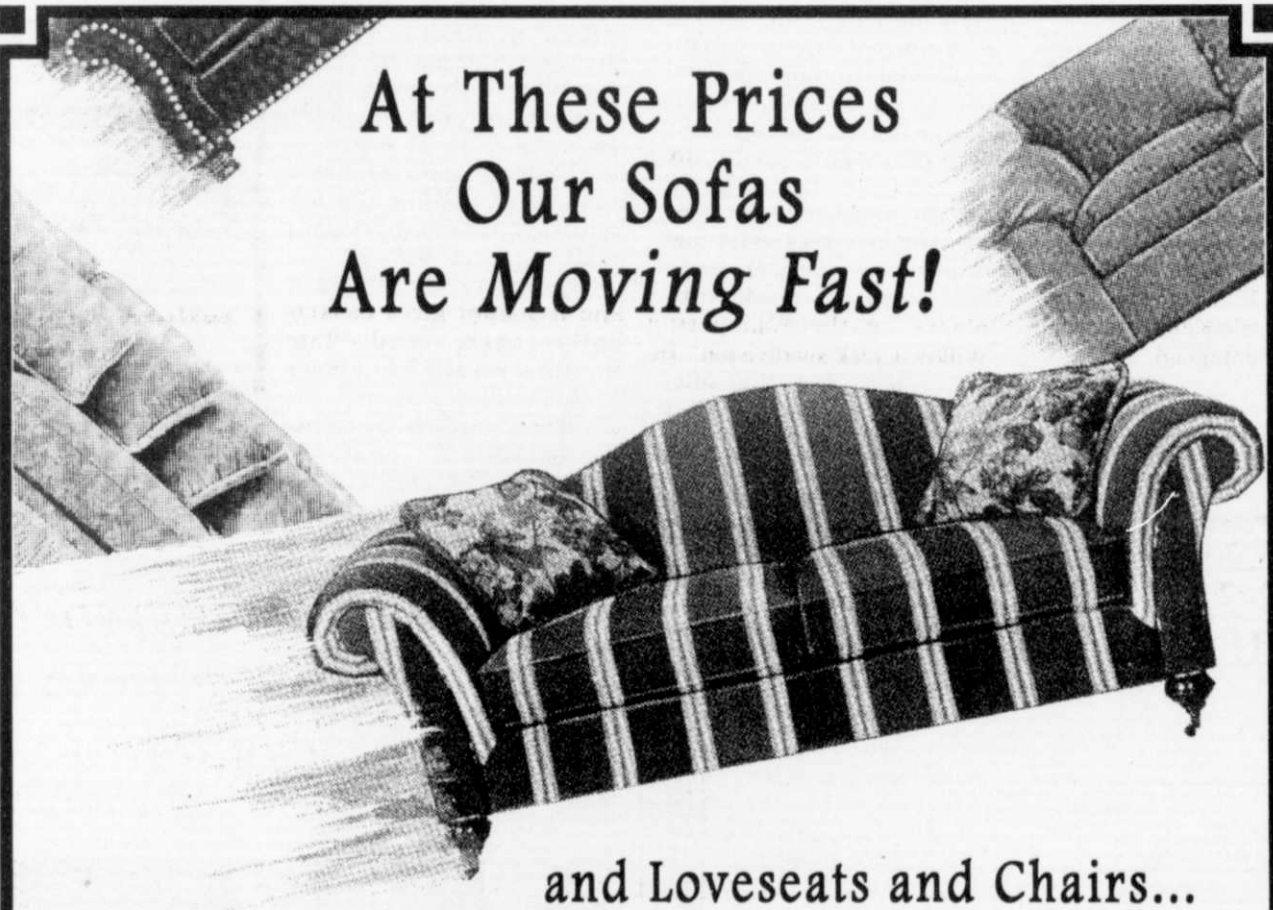
A registration Carnival will offer games and crafts, available for a 35¢ to 50¢ fee.

Village Board Presents Beautification Awards

The Kewaskum Village Board met Monday and honored three homeowners in the village for their outstanding efforts to beautify the village.

Gwen Dreher, President of the Kewaskum Women's Club, along with Village President, Robert Wager congratulated the citizens on a job well done and presented them with a plaque and a yard sign announcing their achievement.

The winners were: The Dennis and Kathy Giese residence for creative use of landscape materials; the James and Susan Wessing residence for floral, shrubbery and tree arrangement, and the Harvey and Margie Janssen residence for good selection of color and lawn ornaments.

The program is sponsored annually by the Kewaskum Women's Club.

David Schwengel was in attendance to try to convince the board to support two railroad resolutions. One was to preserve the Kewaskum rail line, which runs from Jackson to Eden. This line is a candidate for abandonment sometime in the next three years. The reason for abandonment is so the railroad company could come in and tear up the track and use it in a different location. The resolution passed with Trustee's Kenworthy and Stolzmann voting no.

The other resolution was in support of Green Bay Train Service. This resolution deals with getting rail passenger ser-

vice back in the village. The village has been deprived of this service since May of 1971. The resolution passed with Trustee's Stolzmann and Kenworthy voting no.

Police Chief Richard Knoebel reported theft in the village was low with zero property stolen. He also brought up a concern with use of roller blades. He would like to see an ordinance restricting skating in the roadway on Fond du Lac Avenue, Main, Railroad, First, Second and Third Streets, Reigle, Riverview and Parkview Drive, Bilgo Lane and municipal parking lots.

This ordinance, would allow usage of the skates on the sidewalk and the crossing of the roadway from curb to curb.

Quin Mueller and Al Bohn Memorial Drive residents addressed the board with concerns of the traffic flow and speed of traffic on Memorial Drive. Juveniles racing vehicles side by side was also a concern.

Police Chief Knoebel stated that he would have officers watch the area more closely.

Administrator Daniel Schmidt informed the board that the sewer project is now underway. He also stated that there is about a five-hundred foot piece of Milan Drive that was put in about 30 years ago, that has been patched numerous times. In October the surface course of asphalt will be placed in the Whispering Willow Creek subdivision. He suggested that the board approve this project and postpone the siding project on a storage area.

George Allmann gave board members a list of principal requests compiled from each building, prioritizing needs to apply an excess fund balance to. Allmann indicated funds in the amount of \$197,550 were left over from last year's budget due to major savings in certain budget areas and interest increases. The list of the major approved items included social studies books (\$27,000), architectural fees (\$25,000), cafeteria tables, and a water wheel for the football field.

All schools have been preparing for opening day on August 19th, with maintenance projects nearing completion. At the high school level, principal Larry Wilson stated that all staff has been hired with the exception of one academic position. Expected student enrollment is between 718 and 722.

Several coaches positions are still open at the middle and high schools, including soccer. Athletic Director John Wolfenberg commented that late resignations put everyone in a difficult position, and asked the board to look into policy regarding fines imposed on resignations after a specific date.

Instructional contracts were approved for the following positions: Holly King - CDB teacher at KES; Dan Ross - KHS history teacher and assistant girl's basketball coach, and Tim Rohlinger - KHS business education.

Resignations were accepted from Dale Schatz and David Reiner.

WHITE LILY "LIGHT" BISCUITS

2 cups White Lily Self-rising soft wheat flour

1/4 cup shortening

2/3 to 3/4 cup milk

Preheat oven to 500°. Place flour in mixing bowl. With pastry blender or fork, cut in shortening until mixture resembles coarse crumbs. Blend in just enough milk with fork until dough leaves sides of bowl. Turn dough onto lightly floured surface. Knead gently 10 to 12 strokes. Roll out dough 1/2-inch thick. Cut with 2-inch biscuit cutter, dipping cutter into flour between cuts. Press cutter straight down without twisting for straight-sided, evenly shaped biscuits. Place biscuits on ungreased baking sheet 1-inch apart for crusty biscuits or with sides almost touching for soft-sided biscuits. Bake for 8 to 10 minutes. Makes 12 biscuits.

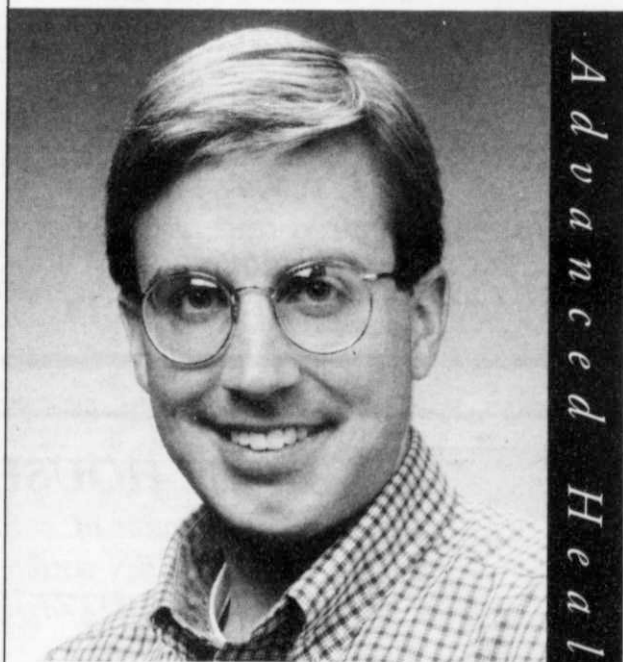

St. Matthias Parish Merges With Holy Trinity

The Archdiocese of Milwaukee, at the end of August, 1997, announced that they would be closing and/or merging approximately 40 Catholic parishes due to lack of clergy. St. Matthias-Auburn and St. Bridget-Wayne, were to be merged with Holy Trinity Church in Kewaskum, beginning on July 1, 1998.

St. Matthias held a parish "Farewell" dinner on May 17, at the Boltonville Fire Hall. In addition to over 100 parishioners and friends, several former pastors and help-out priests were in attendance.

Sunday, June 28, was the closing Mass for the parish. It was a morning of sadness for the people who worked for and loved their parish, and as Father Elroy Pesch so aptly put it, it was like a funeral to them. Like many other "wakes," though, it was also a time of remembrance, a time of gathering with old and new friends, and sometimes, even laughter.

The celebrants at the Mass were Father Pesch, (priest-son of the parish), assisted by Father Mark Jones. The liturgical ministers included many "retired" parishioners, and all of the current altar servers.

The music was not somber, but hopeful, and the Homily brought a lump to the throat at times, and smiles just as often. Coffee and cookies were available

after the service, and many seemed reluctant to leave.

Many of the St. Matthias parishioners are joining Holy Trinity in Kewaskum, but others are relocating to neighboring parishes that may be closer to them.

St. Matthias is now designated as a Chapel, available for weddings, funerals and other celebrations. This year, a Christmas Eve Mass will be celebrated there. The traditional Halloween dance will also continue to be held, this year on October 30, and the funds raised will be earmarked for Chapel upkeep. St. Matthias, as a parish, may be a thing of the past, but the devotion of its "family" continues on!

allow them to function in modern society while at the same time taking pride in their culture and traditions.

July 31, 1998

To Kewaskum Residents,

Americans live in the wealthiest country in the world, and remarkably live in the ugliest of cities. We have never escaped the cabin mentality of erecting quick shelters which last perhaps one hundred years. Our fast paced life continues to grow even faster, and thus caters more and more to automation, convenience, and the automobile. As a result, our sense of community and neighborly etiquette is as endangered as peace and quiet.

Kewaskum is taking a hard look into the future of the community through the Economic Development and Advisory Committee. Also, Kewaskum and the surrounding area is also trying to woo tourism through the Northern Kettle Moraine Tourism Council. Washington County had an intensive Future Search workshop last fall. I am hoping with all this effort into looking into the future that a long term idea is established involving people, environment, and economy.

I will be bold and say that more strip malls, fast food, and super stores will

do more to destroy a community than to act as cohesive elements. The "Wal-Mart" mentality is not only visually ugly, but it guts the community of cottage industry and leaves Main Street a ghost town. I have heard the "You can't stop progress" statement far too many times. It is a copout to believe in that vein if progress means destroying a community by adding yet another strip mall.

An impossible dream? Not at all. How do I know? We have done it before.

Why are Carmel, California and Aspen, Colorado so successful as vacation spots? They stopped chain style businesses from cluttering the community, and thus maintained a sense of balance in providing service, recreation and housing. If you don't ever get to either of those two quaint villages, then go to Door County or Cedarburg. These two Wisconsin communities have survived brilliantly without mega-malls, restaurant chains, and hotel chains. The merchants and the village residents take great pride in their respective communities, and it shows.

The shops and stores in these villages are brimming with smiling merchants and villagers. Their businesses are healthy, and their streets are charming.

People recognize each other, and stop long enough to chat with one another. The barbershop, the shoe store, the sport shop, the tailor, butcher and grocery and more can be under separate roofs and prosper. We've done it before.

"But you can't turn back the clock!" That statement is another copout. Oddly enough, the "new" look of communities is getting back what we have lost. The "good old days" were good for a reason... simplicity in life, a rich community and harmony with the environment. Smart developers have realized this and are creating the neighborhoods we recently might only have seen on vintage television.

One way in which the State of Wisconsin helps communities willing to restore their Main Streets through a program set up by the state several years ago. Many cities and villages around the state have taken advantage of this "Main Street" program and have been quite successful. The key to their success was

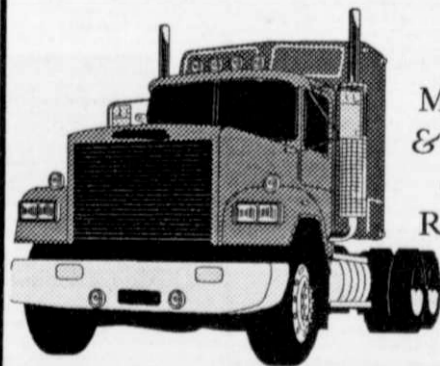
strong community support, as well as strong back up from the area merchants. This involves not only a facelift for the street itself, but also for facades of the buildings lining the street. Experts are assigned to the "Main Street" project to help promote existing shops and businesses, and to attract new shops and businesses. The kicker is, it creates a cohesive community by the simple fact that it

gets people to work together towards a common goal.

Instead of another fast food chain, consider attracting a unique restaurant. Instead of a chain motel, consider more Bed and Breakfast or resort style businesses. Instead of a strip mall, consider your friends on Main Street by adding new shops and businesses in a like manner. Instead of mere progress,

NATIONAL SCHOOL LUNCH PROGRAM
Letter to All Households

Dear Parent/Guardian:

All schools in the Kewaskum School District serve meals each school day. Lunch ticket prices are \$1.30 per day for students in grades 1-5 and \$1.55 per day for students in grades 6-12. Children also may get meals free or at a reduced price of \$.40 per day. All meals served must meet standards established by the U.S. Department of Agriculture. However, if a child has been determined by a doctor to have a disability and the disability would prevent the child from eating the regular school meal, this school will make any substitutions prescribed by the doctor, if a substitution is needed, there will be no extra charge for the meal. If you believe your child needs substitutions

because of a disability, get in touch with us for further information.

If you now get food stamps or AFDC for your children, your children can get free meals. If your total household income is the same or less than the amounts on the income Chart below, your children can get free meals or reduced price meals. A foster child may get free or reduced price meals regardless of your income.

TO GET FREE OR REDUCED PRICE MEALS FOR YOUR CHILDREN, YOU MUST COMPLETE AN APPLICATION AND RETURN IT TO THE SCHOOL. WE CANNOT APPROVE AN APPLICATION THAT IS NOT COMPLETE.

Verification: Your eligibility may be checked at any time during the school year. School officials may ask you to send papers showing that your children should get free or reduced price meals.

Fair Hearing: You may talk to school officials if you do not agree with the school's decision on your application or the results of verification. You also may ask for a fair hearing. You may do this by calling or writing: Mrs. Jean Goeden, Board President, 2478 Hwy. 28 East, Kewaskum, WI 53040, Phone: 334-9549.

Reporting Changes: If your children get free or reduced price meals because of your income, you must tell the school if your household size decreases or your income increases by more than \$50 per month or \$600 per year. If your children get meals because they get food stamps or AFDC, you must tell the school when you are not getting AFDC or food stamps for them. You may then fill out another application giving income information.

Confidentiality: The information provided by the household on the application is confidential. Public Law 103-448

does authorize the release of student free and reduced price school meal eligibility status to persons directly connected with the administration and enforcement of federal or state educational program. With your written consent, they may also use the information for other programs if you sign a statement waiving confidentiality for those specific uses.

Reapplication: You may apply for meals anytime during the school year. If you are not eligible now but have a change, like a decrease in household income, an increase in household size, become unemployed or get food stamps or AFDC for your children, complete an application then.

In the operation of the child feeding programs, no child will be discriminated against because of race, sex, color, national origin, age or handicap. If you believe you have been discriminated against, write immediately to the secretary of agriculture, Washington, D.C. 20250.

We will let you know when your application is approved or denied.

Eligibility Requirements for Free, Reduced Price Meals Announced by School District

The School District of Kewaskum, announced its policy for children unable to pay the full price of meals served under the National School Lunch Program. Each school

office and the central office has a copy of the policy, which may be reviewed by any interested party.

The following household size and income criteria will

be used for determining eligibility. Children from families whose annual income is at or below the levels shown are eligible for free or reduced price meals.

Application forms were given to each family on registration day. To apply for free or reduced price meals households must fill out the application and return it to the school. Additional copies are available at the principals office in each school. The information provided on the application will be used for the purpose of determining eligibility and may be verified at any time during the school year by school or other program officials. Applications may be submitted at any time during the year.

To obtain free or reduced price meals for children for whom households receive Food Stamps or Aid to Families with Dependent Children (AFDC), an adult member needs only to list the names of the school children, give Food Stamp or AFDC case number for each child, sign his/her name and return the application to the school office. Households must inform the school authorities when they no longer receive Food Stamps or AFDC.

For the school officials to determine eligibility for free or reduced price meals of households not receiving Food Stamps or AFDC, the household must provide the follow-

ing information requested on the application: names of all household members, and the social security number, of the adult household member who signs the application. In lieu of a social security number, the household may indicate that the signer does not possess a social security number. Also, the income received by each household member must be provided by amount and source (wages, welfare, child support, etc.). Households are required to report increases in income of over \$50 per month or \$600 per year and decreases in household size.

Under the provisions of the free and reduced price meal policy, the District Administrator will review applications and determine eligibility. If a parent or guardian is dissatisfied with the ruling of the official, he/she may wish to discuss the decision with the determining official on an informal basis. If the parent/guardian wishes to make a formal appeal, he/she may make a request either orally, or in writing to: Mrs. Jean Goeden, School Board President, 2478 Hwy. 28 East, Kewaskum, WI 53040, Phone 334-9549. If a hearing is needed to appeal the decision, the policy contains an outline of the hearing procedure.

If a household member becomes unemployed, or if the household size changes, the family should contact the school. Such changes may make the household eligible for reduced price meals or free meals if the household income falls at or below the level shown above, and they may reapply at that time.

In certain cases foster children are also eligible for these benefits. If a household has foster children living with them and wishes to apply for free or reduced price meals, the household should complete an application for a family of one or contact the school for more information.

The information provided by the household on the application is confidential and will be used only for purposes of determining eligibility and verifying data.

In the operation of the child feeding programs, no child will be discriminated against because of race, color, sex, national origin, age, or handicap. If any member of a household believes they have been discriminated against, they should write immediately to the Security of Agriculture, Washington D.C. 20250.

Any questions regarding the application should be directed to the determining official.

1) Any student, parent or resident of the School District complaining of discrimination on the basis of sex, race, national origin, ancestry, creed, pregnancy, marital or parental status, sexual orientation or physical, mental, emotional or learning disability in school programs or activities shall report the complaint in writing to the District Administrator.

2) The District Administrator, upon receiving a written complaint, shall immediately undertake an investigation of the suspected infraction. The District Administrator will review with the building principal, or other appropriate persons, the facts comprising the alleged discrimination. Within 30 days after receiving the complaint, the District Administrator shall decide the merits of the case, determine the action to be taken, if any, and report in writing the findings and the resolution of the case to the grievant.

3) If the grievant is dissatisfied with the decision of the District Administrator, he/she may within 15 days, appeal the decision in writing to the School Board. The Board shall hear the appeal at its next regular meeting, or a special meeting may be called for the purpose of hearing the appeal. In either case, the Board must hear the appeal within 45 days of its receipt. The Board shall make its decision in writing within 15 days after the hearing. Copies of the written decision shall be mailed or delivered to the grievant and the District Administrator.

4) If the grievant is dissatisfied with the Board's decision, he/she may within 30 days appeal the decision in writing to the State Superintendent of Public Instruction.

5) Discrimination complaints relating to the identification, evaluation, educational placement or the provision of a free appropriate public education of a child with exceptional needs shall be processed in accordance with Wis. Stat. Ch. 115, Subch. V and Wis. Admin. Code Ch. PI 11.

6) Discrimination complaints relating to programs specifically governed by federal law or regulation shall be referred directly to the State Superintendent of Public Instruction.

held off a late charge from Plymouth's Brian Gilles to capture his second feature victory of the year in the 20 lap Super Stock main event.

In other action, Pete Ostrowski won the 15 lap Winged Super Modified B semi-feature. Scott Haugstad of Plymouth was victorious in the 15 lap limited Late Model

semi-feature and Elkhart Lake's Brad Ruh won the 15 lap Super Stock semi-feature.

This Saturday night EWSC will hold its second autograph night of the 1998 season.

WHEREAS, a specific neighborhood of the Village has been targeted by census data as low income and has been designated for comprehensive homeowner and rental property housing rehabilitation,

NOW, THEREFORE, BE IT RESOLVED, the Village Board of the Village of Kewaskum, Washington County, Wisconsin supports the application for State Community Development Block Grant funds and approves the survey of a target neighborhood in the Village of Kewaskum for comprehensive housing rehabilitation funding, and

BE IT FURTHER RESOLVED that the Village encourages citizen input in the development of the application process including the establishment of a Citizens Plan is hereby adopted by the Village.

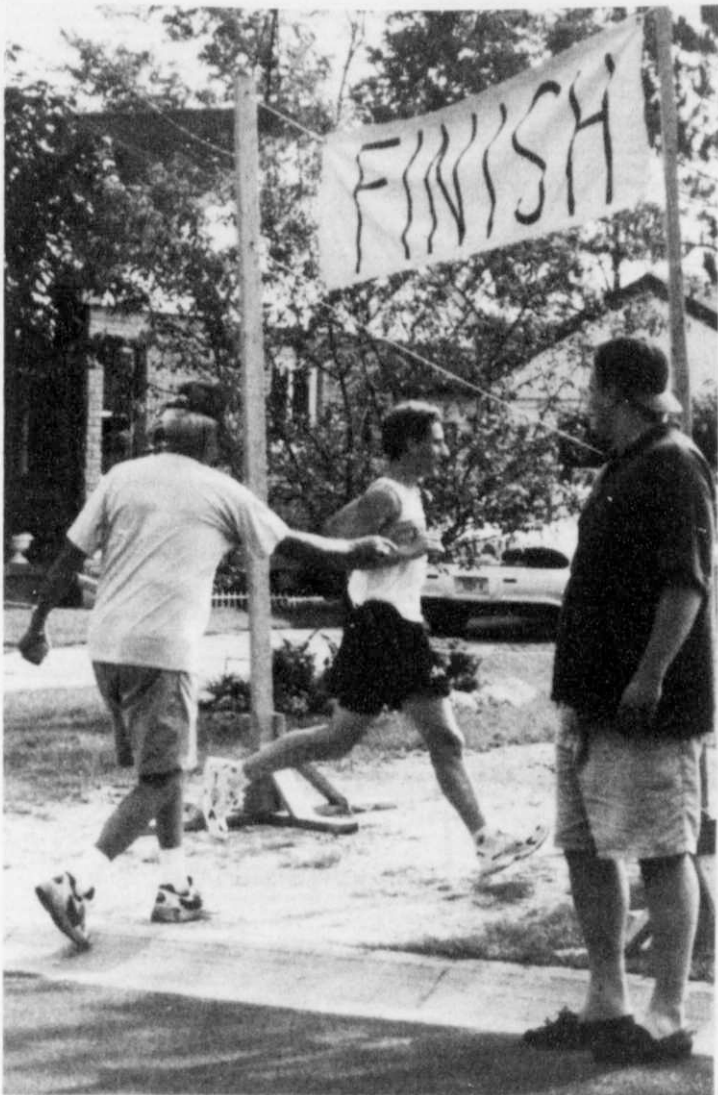

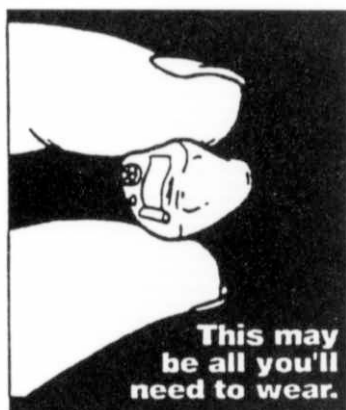
