KEYS to Administer Michael Strelka Memorial Scholarship

Kewaskum Youth Scholarships in conjunction with Delores E. Baasch have recently announced that KEYS will administer a \$1,000 memorial scholarship annually in the name of her son, Michael H. Strelka. The Michael H. Strelka Memorial Scholarship was presented 1985 through 1990 and has been reestablished and will be awarded in May of 1999 to a graduate of Kewaskum High School.

Michael H. Strelka graduated from West Bend High School in 1971. He was active in debate, National Honor Society, German Club, and was in several plays. His mother, Delores

E. Baasch, a graduate of Kewaskum High School, hopes that this scholarship will provide the recipient the inspiration that her terrific son displayed and financial help that is needed to pursue their college education.

Michael Strelka graduated from Marquette University in 1976 with a bachelor of arts degree magna cum laude in political science and interpersonal communications. His honors were Phi Beta Kappa, Alpha Sigma Nu, National Jesuit Honor Society. His activities included Pre-Law Society treasurer, 1975-76, Pi Alpha Sigma and Faculty-Student Freshman Advising program.

He graduated from Marquette University Law School with a Juris Doctor Degree in May 1982. He was a member of the Phi Alpha Delta Law Fraternity International, and a member of the Phi Delta Phi International Legal Fraternity.

He was born July 22, 1952 in West Bend, and was a West Bend resident all his life. He died January 14, 1984.

Don Kosterman was a good friend and he summed up Michael's personality in the following editorial that appeared January 24, 1984 in the *West Bend News*:

Mike's will to live, to learn

A scholarship fund is being created in memory of a West Bend native who epitomized what the word "scholarship" should mean.

A memorial scholarship has been established in memory of Atty. Michael H. Strelka to honor the memory of an avid student who overcame tremendous adversity in his thirst for learning.

West Bend News readers will remember Mike as a young man who fought the odds in the early and middle '70's as he went through a number of kidney transplants.

What people who didn't know Mike personally couldn't know was the other battles Mike fought to do things that for the rest of us

come all too easy.

Mike was driven by a desire to learn. In 1976 he graduated from Marquette University magna cum laude and a member of a number of honor societies. He followed that with his 1982 graduation from Marquette Law School, again with honors.

But his accomplishments came only through struggle.

He had to have two sets of law books, one at home and one at school because of his weakened condition; and cataracts, resulting from one failed kidney transplant, forced Mike to use a lighted magnifying glass to read. His education was constantly interrupted, as he spent some eight years of his life in the hospital. (He once remarked to friends that he was both a "professional student" and a "professional patient.")

Learning from those who showed care for him throughout his trying time, Mike had a great capacity to be a caring person to his fellow man. He showed that care through personalized

gifts he gave to his close friends and this constant looking to help people in some way less fortunate than himself. He tutored inner city students for a time and regularly sought out opportunities to help others.

Mike was not a big person physically, but his stature came from what was inside of him. His mother hopes the scholarship being established in his name will help keep his spirit of both learning and caring alive for others, who may, like Mike, have a special outward needs but exceptional inward abilities.

WCSD Squad Car Collides With Vehicle on STH 28



A Washington County Sheriff's Department squad car was involved in an accident, along with another vehicle, after the deputy attempted to maneuver a U-turn on STH 28, just .2 miles west of Woodlawn Drive in the Town of Wayne on Friday, March 25, at approximately 2:45 pm. The driver of the squad car was William M. Niehus of West Bend. The driver of the other vehicle, a 1985 Chevrolet Caprice, was Linda A. Schaub of Kewaskum. Along with her, was Terry L. Schaub, also of Kewaskum. The accident occurred when the deputy was attempting to apprehend a suspected speeding vehicle not involved in the collision. The deputy pulled to the gravel shoulder to make a u-turn on the highway while the Schaub vehicle was directly in back of him. Schaub saw the deputy pulling over and started to merge over to the left of the shoulder and give him more room. The deputy suddenly made a left turn into traffic lane and pulled in front of Schaub. Schaub tried to avoid him by pulling into the westbound lane but was unable to avoid the oncoming squad car.

Town of Wayne Candidates Look to Serve a Growing 21st Century

The Town of Wayne is currently in the process of working on enacting zoning ordinances to coincide with their new land use plan. The town has grown by leaps and bounds the past two years since the last election.

Residents now need to make a decision if a change is needed for the next two years or if they are satisfied with the role their current officials are playing.

TOWN CHAIRMAN

Incumbent Leander Herriges, 63, resides at 5677 CTH H in Allenton. He is married and has three children. He has served as town chairman for two years and was supervisor the two years before that.

His opposition, **David Scharf, 40,** resides at 9564 CTH BB. He is single. He has never held public office.

TOWN CHAIRMAN

Incumbent Don Kurer, 72 of 9519 Mullen Drive is married with four grown children. Kurer has served on the board for two years. Kurer has been very involved in trying to implement the land use plan for the town.

Incumbent Leonard Peter did not seek re-election.

Carl Klemme, 46, 4932 CTH H. He is married with three children. He has served on the Board of Appeals for the town for one year. A well

driller sharing part interest in Klemme Bros. Well Drilling, he has lived in the Town of Wayne for 43 years.

Christian Kuehn, 47 of 5874 Beaver Dam Road in West Bend is married with two children. Kuehn has not served in office previously.

TOWN CHAIRMAN

Incumbent Orville Kern, 75 has served as town clerk for the past 26 years. He is married with four grown children.

Marilyn Filber, 64 is married and has five children and has made the Town of Wayne her home for over 40 years. She is a retired legal secretary, working in the Washington County District Attorney's office. She has never held a public office.

Incumbent Treasurer Gerald Schulz is running unopposed. Schulz has been serving continuously for 15 years.

RECYCLING TIPS

CORRUGATED CARDBOARD

6 of 7

TYPE OF CORRUGATED CARDBOARD: The cardboard that peels apart with two outside layers is corrugated. The middle section not exposed is wavy or corrugated.

COLORS: Some waxed and pressed cardboard may also be recycled.

PREPARATION: Flatten boxes and cut into 2'x2' pieces. Tie in bundles with twine or strong string. Bundles should be limited to 8" in height. Place bundles at the curb next to the dark green recycling bin or blue recycling bag. Place the bin or bag at the curb on the same day that your solid waste is to be collected. Pick up will be Wednesdays for both solid waste and recyclables. Multi-family dwellings of six or more, remember, your recycling pick up will be the 1st and 3rd Wednesday of each month.

NOTE: If raining on collection day, please hold cardboard until the following week.

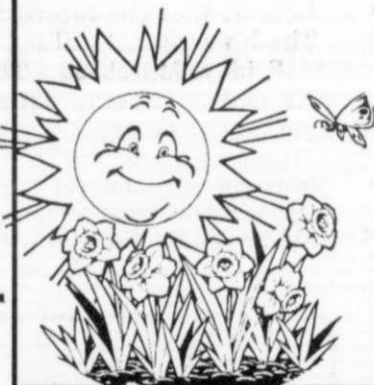

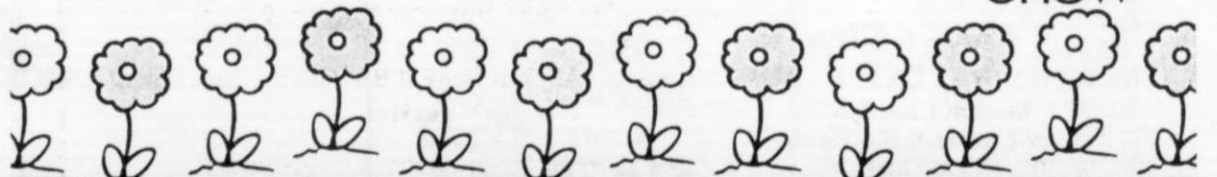

NOTICE WOOD CHIPPING

Wood Chipping will resume on the 1st and 3rd Mondays of the month, beginning with the 1st and 3rd Mondays in April. (Weather permitting)

1. Place large (butt) end toward the street, at the curb.
2. Pile branches no more than 2 feet high; a long low pile is best for feeding the chipper.
3. For small brush, TIE IN BUNDLES with string or twine. NO boxes, bags or cans of branches will be chipped. The reason for this is if a stone, gravel, wire, metal or other material is in a bag, can etc. and gets into the chipper it will destroy the knife edges on the chipper, delaying our chipping until the knife is replaced and resharpened.
4. No roots of any kind, or material with any dirt on it.
5. Corn Stalks and Sun Flower stalks will NOT be chipped.

Note: Yard waste, garden plant waste, corn stalks, Sun Flower stalk, leaves, grass and materials that will rot down in a compost pile can be brought to the DPW yard and placed in the yard compost bin. Hours are 7:00 AM to 3:30 PM Monday - Friday. The wood chipper can take up to about a 3" diameter tree branch. It is recommended larger pieces be cut up for fire wood, or given to someone with a wood burning fireplace etc.

as others. Financially it is crucial for you to express your opinion on the plans in the voting booth. The Board has agreed to abide by the majority outcome of the referendum results.

Regarding the possibility of a new high school, please keep in mind the cost to the taxpayer. A plan that includes a \$18-22 million

high school building also requires \$1 million for land, \$200K revamping of the old middle school, and the still needed improvements at the outlying elementary schools for at least another \$4 million. Add a gymnasium and/or swimming pool, and necessary recurring referendum to maintain these facilities, this total bill of about \$28-30 million would increase your taxes \$300 per year on a \$100,000 home. A new high school sounds wonderful! But quite frankly, I don't think most of our taxpayers can justify it. If they could, they might have approved the \$17 million referendum in November. So don't vote for a new high school unless you can put your money where your mouth is later. I'd hate to see you mislead the Board and have them sink more money into architectural fees, only to have a future referendum fail again. We've wasted too much time and money already.

On the Beechwood school issue, the fact sheet states that for \$200-250K, Beechwood could be renovated for reopening. For this small amount of money, our district would be adding essentially six more classrooms and a gymnasium. If we do not utilize these facilities, we would likely add six classrooms at Farmington at a cost of \$75K each for a total of \$450K (excluding extra gym facilities). Sounds to me like the district could save \$200-250K by utilizing the Beechwood facility with the added bonus of additional gym space and educational benefits of a community school. Are the taxpayers of this district so rich that we can afford to scrap BES? The proceeds of selling the building (about \$150K) would not put a dent in the cost of any new facilities. Meanwhile, as we procrastinate on the building plan, Farmington school is scrambling to find space for next year's student base. We should not pass up the simple and affordable option of reopening Beechwood. If we abandon the community school concept now, the next option that could be considered is to build a new KES on the west side of the village and close Wayne -- at this point anything's still possible.

A swimming pool would be nice, but again I think we could get more bang for our buck using the money on educational and other athletic facilities like a gymnasium. I'm not sure we can afford both, not to mention a recurring referendum just for a pool!?

Let's give the Board some accurate and realistic results on April 6th!

Letter to the Editor:

On Tuesday, April 6th, you the taxpayer, parent and grandparent will be able to "voice" your opinion on an advisory referendum. Here is your chance to make your "plan" known to the school board.

I have talked with a few constituents and received some calls concerning some of the issues that are not on the fact sheet. I would like to share those concerns of others and offer some information on some laws.

1. The school board CANNOT sell any property or buildings. The sellings of any land or building must be done by the electors at an annual meeting or a called special meeting. The board must receive permission from you, the taxpayer, to sell any property or buildings. The next annual

meeting will be held at the Kewaskum High School on Monday, September 27, 1999.

2. There is a space problem in the schools. Today, the students with special needs need their space too. The law tells the school district how many square feet per student is allotted. For the special needs children, there may be a different amount of square footage depending on the needs of the student. The Kewaskum School District has a very sound Special Education Dept. This school district needs a new elementary school in Kewaskum. Whether a new one is built on the same site, or the elementary students would move to the newly remodeled Middle School the needs will stay the same. The idea of moving them to the middle school, would require the movement of the middle school students to the present high school and build a new Kewaskum High School on a parcel of land just outside of the village. **WHATEVER YOUR IDEA IS, PLEASE GO TO VOTE NEXT TUESDAY.**

3. What is open enrollment? This is where a Kewaskum student may request a transfer to another school district, such as Random Lake, Campbellsport or West Bend. The request to leave cannot be denied. So any student requesting to leave a district may do so, as long as there is room for them in the other district. The parents may feel the other district offers a better gymnastic program or a modern facility for the plays and for graduation. This means YOUR TAX DOLLARS goes with them. The other district may have a better computer program or an advanced college curriculum in the high school. YOUR TAX DOLLAR will go with that student. So when this school district starts to lose students to other schools, we are not just losing students, we are losing monies.

4. Concerns about buying land. Yes, a few years ago the school board asked the voters to vote for the purchase of a 74 acre parcel, just south of the village on Hwy. H. The cost was

within the monies \$10.56 per hundred thousand, allowed to pay off the district debts. Dear Editor,

I would like to clear up some misinformation that appeared recently in the "letters to the editor" as well as some previous false information that appeared as news or in former letters.

I would first like to say that in order to keep the information that I have contributed accurate, it was only prudent for me to have members of our administration review the facts I presented before publication so

as not to make any errors. This is why I have always been able to stand behind everything that I wrote with complete confidence.

Although this referendum does not have immediate financial consequences, it does and will have an impact on future decisions, by the board, on what is presented to you in the form of referendums.

A recurring referendum is provided for by state law so as to give the control of spending/taxing to the people of a community on an as needed basis to meet their needs. Not all school districts are alike, so, this vehicle makes it possible for educational needs to be met without the state dictating in a blanket fashion how the people will be taxed for the purposes of educating the students. This is not a Pandora's Box. It is democracy at its best.

It was recently said, three issues ago in this paper, that a recurring referendum for the operation of Beechwood Elementary would cost \$250,000 per year. This is totally false. The correct figure is estimated, on the high side, at \$120,000 and expected to be about \$100,000 in actuality. Also, that bussing costs would go up. This again is incorrect as it is obvious and easily calculated to decrease by several thousand dollars. It was just last week that the same person said the school would require a new gym. This is also incorrect as this school has the nicest gym in the district and would function beautifully. It is correct to say that a cafeteria is needed because if we are going to have separate gyms from our cafeterias in all elementary schools (none of which is the case presently) then it would only make sense to

provide for the same at this location. So it is a moot point and should not have been mentioned without this supporting information (Just trying to keep this in perspective for you so you aren't misled).

Let me clarify the mentioning of the need for two heating systems. If the school were to open as is, it would require the replacement of the existing inefficient system. If we were to add on to the school, a bona fide approach if you ask me, it would be more efficient to add a separate system that would include air conditioning. A roof mounted system. This would be a sensible approach.

Unfortunately we will not have fresh numbers to tell you just how many children are in the Beechwood area. The census figures will not be in and deciphered for a couple of months. However, it is known that there are about 120 to 125 students in the area that currently use our schools. In other words, real numbers. These students are within about a 5 mile radius.

During the last referendum you were told by a letter to the editor that there were only two students in the area for kindergarten. This was incorrect also as it was based on the number of children who, at that time, were attending pre-kindergarten. That does not represent the number of children who would attend kindergarten only the number of parents who needed or desired that their children attend the prekindergarten program.

Notice is hereby given of a spring primary election to be held in the County of Washington on April 6th, 1999, at which the officers named below shall be chosen. The names of the candidates for each office to be voted for, whose nominations have been certified to or filed in this office, are given under the title of the office, each in its proper column, together with the questions submitted to a vote, for a referendum, in the sample ballot below.

INFORMATION TO ELECTORS

Upon entering the polling place, an elector shall give his or her name and address before being permitted to vote. Where ballots are distributed to electors, the initials of two inspectors must appear on the ballot. Upon being permitted to vote, the elector shall retire alone to a voting booth and cast his or her ballot except that an elector who is a parent or guardian may be accompanied by the elector's minor child or minor ward. An election official may inform the elector of the proper manner for casting a vote, but the official may not in any manner advise or indicate a particular voting choice.

At the spring election, where paper ballots or lever machines are used, the elector shall make a cross (X) in the square or depress the lever at the right of the name of the candidate for whom he or she intends to vote. To vote for a person whose name does not appear on the ballot, the elector shall write in the name of the person of his or her choice in the space provided for a write-in vote. On referendum questions, the elector shall make a cross (X) in the square or depress the lever at the right of "yes" if in favor of the question, or the elector shall make a cross (X) in the square or depress the lever at the right of "no" if opposed to the question.

Where marksense voting is used, the elector shall darken the oval next to the name of the candidate of his or her choice for each office for whom he or she intends to vote. To vote for a person whose name does not appear on the ballot, the elector shall write in the name of the person of his or her choice in the space provided and darken the oval at the left of the write-in line provided. On referendum questions, the elector shall darken the oval next to "yes" if in favor of the question, or the elector shall darken the oval next to "no" if opposed to the question.

The vote should not be cast in any other manner. If the elector spoils a ballot, he or she shall return it to an election official who shall issue another ballot in its place, but not more than three ballots shall be issued to any one elector. If the ballot has not been initialed by two inspectors or is defective in any other way, the elector shall return it to the election official, who shall issue a proper ballot in its place. Not more than five minutes' time shall be allowed inside a voting booth. Unofficial ballots or a memorandum to assist the elector in casting his or her vote may be taken into the booth and copied. The sample ballot shall not be shown to anyone so as to reveal how the ballot is marked.

After an official marksense ballot is marked, it shall be inserted in the ballot sleeve provided so the marks do not show. After casting his or her vote, the elector shall leave the booth, insert the ballot in the voting device, and shall leave the polling place promptly.

An elector may select an individual to assist in casting his or her vote if the elector declares to the presiding official that he or she is unable to read, has difficulty reading, writing or understanding English or that due to disability is unable to cast his or her ballot. The selected individual rendering assistance may not be the elector's employer or an agent of that employer or an officer or agent of a labor organization which represents the elector.

Do you realize that with Open Enrollment, now law, parents can send their children to another district and the state tax dollars follow the child to the other district? It is to our advantage to attract children from other districts to our schools not just by superior educating but also convenience. Elementary education, as compared to high school, is the least expensive and should be where we would try hardest to retain students and attract them from other districts. Do you know that BES is a prime candidate for doing a Charter School? Do you know that not only could we have the opportunity to make significant educational improvements but that the Federal and State grant moneys are on the increase and currently we would receive about \$60,000 per year for that school? Also, there is considerable growth in the BES area. Not that all new housing means more children but it has been known to occur.

When all is said and done. After this argument and that is made. After the pros and cons are presented. When the real picture is illuminated-which is so hard to do because of the personal feelings or vendettas at work. It still comes down to: What is the right thing to do for educating our children? What are the costs of not opening this school? Do we get results for what we spend our money on? Should we build on to another school when we have one located right where the parents and children live? What about our philosophy of having and maintaining small outlying schools? What about the increased parental involvement that normally occurs which the smaller schools and the positive effect such involvement brings with it? What about the effect it will also have on FES as a smaller school that could now receive these same advantages? Do you also realize that opening BES not only alleviates the overcrowding at FES but can and probably will also effect the size of KES (reduced building costs).

I hope you can see that BES should be included in future building plans and referendum proposals. Overall the committees have recommended it to the board. The last two administrations (the third actually also supported it and that goes back several years now.) have recommended it and a majority of board members have been in support of it-it just becomes a sticking point over which way to fund it. (The board can vote to open it at any time. Allocate the money for it. And begin making use of it as soon as it is remodeled if it wants to.)

NOTICE OF REFERENDUM ELECTION

APRIL 6, 1999

NOTICE IS HEREBY GIVEN, that an election to be held in the several towns, villages, wards, and election districts of the State of Wisconsin, on Tuesday, April 6, 1999, the following proposed amendment to the Constitution of the State of Wisconsin, having been approved by two successive legislatures, will be submitted to a vote of the people pursuant to law:

1999 Assembly Joint Resolution 2

Date of Publication: February 26, 1999

1999 ENROLLED JOINT RESOLUTION 2

To amend section 24 (3), (5) and (6) (a) of article IV of the constitution; Relating to: the distribution of the net proceeds of the state lottery and certain moneys received by the state that are attributable to pari-mutuel on-track betting and bingo (2nd consideration).

Whereas, the 1997 legislature in regular session considered a proposed amendment to the constitution (1997 Assembly Joint Resolution 80, which became 1997 Enrolled Joint Resolution 19) and agreed to it by a majority of the members elected to each of the 2 houses, which proposed amendment reads as follows:

SECTION 1. Section 24 (3) of article IV of the constitution is amended to read:

[Article IV] Section 24 (3) The legislature may authorize the following bingo games licensed by the state, but all profits shall accrue to the licensed organization and no salaries, fees or profits may be paid to any other organization or person: bingo games operated by religious, charitable, service, fraternal or veterans' organizations or those to which contributions are deductible for federal or state income tax purposes. All moneys received by the state that are attributable to bingo games shall be used for property tax relief for residents of this state as provided by law. The distribution of moneys that are attributable to bingo games may not vary based on the income or age of the person provided the property tax relief. The distribution of moneys that are attributable to bingo games shall not be subject to the uniformity requirement of section 1 or article VIII. In this subsection, the distribution of all moneys attributable to bingo games shall include any earnings on the moneys received by the state that are attributable to bingo games, but shall not include any moneys used for the regulation of, and enforcement of law relating to, bingo games.

SECTION 2. Section 24 (5) of article IV of the constitution is amended to read:

[Article IV] Section 24 (5) This section shall not prohibit pari-mutuel on-track betting as provided by law. The state may not own or operate any facility or enterprise for pari-mutuel betting, or lease any state-owned land to any other owner or operator for such purposes. All moneys received by the state that are attributable to pari-mutuel on-track betting, shall be used for property tax relief for residents of this state as provided by law. The distribution of moneys that are attributable to pari-mutuel on-track betting may not vary based on the income or age of the person provided the property tax relief. The distribution of moneys that are attributable to pari-mutuel on-track betting shall not be subject to the uniformity requirement of section 1 of article VIII. In this subsection, the distribution of all moneys attributable to pari-mutuel on-track betting shall include any earnings on the money received by the state that are attributable to pari-mutuel on-track betting, but shall not include any moneys used for the regulation of, and enforcement of law relating to, pari-mutuel on-track betting.

SECTION 3. Section 24 (6) (a) of article IV of the constitution is amended to read:

Article IV] Section 24 (6) (a) The legislature may authorize the creation of a lottery to be operated by the state as provided by law. The expenditure of public funds or of revenues derived from lottery operations to engage in promotional advertising of the Wisconsin state lottery is prohibited. Any advertising of the state lottery shall indicate the odds of a specific lottery ticket to be selected as the winning ticket for each prize amount offered. The net proceeds of the state lottery shall be deposited in the treasury of the state, to be used for property tax relief for residents of this state as provided by law. The distribution of the net proceeds of the state lottery may not vary based on the income or age of the person provided the property tax relief. The distribution of the net proceeds of the state lottery shall not be subject to the uniformity requirement of section 1 of article VIII. In this paragraph, the distribution of the net proceeds of the state lottery shall include any earnings on the net proceeds of the state lottery.

Now, therefore, be it resolved by the assembly, the senate concurring, That the foregoing proposed amendment to the constitution is agreed to by the 1999 legislature; and, be it further

Resolved, That the foregoing proposed amendment to the constitution be submitted to a vote of the people at the election to be held on the first Tuesday of April, 1999; and, be it further

Resolved, That the question concerning ratification of the foregoing proposed amendment to the constitution be stated on the ballot as follows:

QUESTION 1: "Distribution of gambling proceeds. Shall section 24 (3), (5) and (6) (a) of article IV of the constitution be amended to require that the net proceeds of the state lottery and of moneys received by the state from bingo games and pari-mutuel on-track betting be used for property tax relief for residents of this state as provided by law, but subject to the condition that the distribution not vary based on the income or age of the person provided property tax relief?"

EXPLANATION

Article IV, section 24 (3) and (5) of the Wisconsin Constitution concerning bingo games and pari-mutuel on-track betting do not presently make provisions for use of the moneys received by the state. Article IV, section 24 (6) (a) of the Wisconsin Constitution concerning the lottery presently provides that the net proceeds of the state lottery shall be deposited in the treasury of the state to be used for property tax relief.

The proposed amendment provides that all moneys received by the state attributable to bingo games and pari-mutuel on-track betting, except for moneys used for the regulation of, and enforcement of laws relating to bingo games and pari-mutuel on-track betting, and the net proceeds of the state lottery must be used for property tax relief for residents of this state. The proposed amendment also provides that the distribution of these moneys may not vary based on the income or age of the person provided the property tax relief and exempts the distribution of these moneys from the uniformity requirement of article VIII, section 1 of the Wisconsin Constitution.

A "yes" vote on this constitutional amendment would mean that the moneys received by the state that are attributable to bingo games and pari-mutuel on-track betting, other than moneys used for the regulation of and enforcement of laws relating to bingo games and pari-mutuel on-track betting, and the net proceeds of the state lottery would be used for property tax relief for residents of this state and that the distribution of those moneys would not vary based on the income or age of the person provided the property tax relief. A "yes" vote would also mean that the distribution of these moneys would not be subject to the uniformity requirement of article VIII, section 1 of the Wisconsin Constitution which makes no provision for moneys received by the state attributable to bingo games or pari-mutuel on-track betting and which provides that the net proceeds of the state lottery must be used for property tax relief but does not limit that relief to residents of this state.

On the referendum question, where paper ballots or lever machines are used, the elector shall make a cross (X) in the square or depress the lever or button at the right of or depress the button or lever next to "yes" if in favor of the question, or the elector shall make a cross (X) in the square or depress the lever or button at the right of or next to "no" if opposed to the question.

Where punch card voting is used, on referenda questions, the elector shall make a punch or a hole in the space designated "yes" if in favor of the question, or make a punch or a hole in the space designated "no" if opposed to the question.

Where marksense voting is used, on referenda questions, the elector shall connect the arrow or fill in the oval next to "yes" if in favor of the question, or connect the arrow or fill in the oval next to "no" if opposed to the question.

If the elector spoils a ballot, he or she shall return it to an election official who shall issue another ballot in its place, but not more than three ballots shall be issued to any one elector. If the ballot has not been initialed by two inspectors or is defective in any other way, the elector shall return it to the election official, who shall issue a proper ballot in its place. Not more than five minutes' time shall be allowed inside a voting booth. Unofficial ballots or a memorandum to assist the elector in marking or punching his or her ballot may be taken into the booth and copied. The sample ballot shall not be shown to anyone so as to reveal how the ballot is marked.

After an official paper ballot is marked, it shall be folded so the inside marks do not show, but so the printed endorsements and inspectors' initials on the outside do show. The elector shall leave the booth, deposit his or her folded ballot in the proper ballot box, or deliver the ballot to an inspector for deposit, and shall leave the polling place promptly.

After an official punch card ballot is marked, it shall be inserted in the envelope provided so the holes or punches do not show. The elector shall leave the booth, deposit the envelope containing his or her ballot in the proper ballot box, or deliver the envelope to an inspector for deposit, and shall leave the polling place promptly.

After an official marksense ballot is marked, it shall be inserted in the envelope provided so the marks do not show. The elector shall leave the booth, insert the ballot in the voting device and discard the envelope, and shall leave the polling place promptly.

An elector may select an individual to assist in casting his or her vote if the elector declares to the presiding official that he or she is unable to read, has difficulty reading, writing or understanding English or that due to disability is unable to cast his or her ballot. The selected individual rendering assistance may not be the elector's employer or an agent of that employer or an officer or agent of a labor organization which represents the elector.

Chamber Music Evening Set For UWWC

WEST BEND -- Even though the typical chamber music ensemble is small, UWWC music professor Peter Gibeau says the genre still can weave a rich tapestry of music.

"It can have a big, rich sound," Gibeau said. "The effects can be fully orchestral."

Gibeau and a small group of friends and professional acquaintances will demonstrate that, as the University of Wisconsin-Washington County presents, "Another Evening of Chamber Music and Song with the Gibeaus and Friends." The chamber music concert is set for 7:30 p.m., April 3, in the college theater. The college is located at 400 University Drive, West Bend.

Tickets are \$7 for adults, \$5 for seniors and those

under 18.

Featured in the concert will be renowned area musicians and singers: Kewaskum music teacher David Bertelsen, tenor; Krista Christy, alto recorder; Junko Fujiwara, cello; Deanna Gibeau, soprano; Peter Gibeau, piano and harpsichord; Joanne Hendersen, violin; Mary Hughes, flute; Jane Maley, alto recorder and Kelly Nelson, viola.

Gibeau said that chamber music stems from intimate, informal entertainment in the early 1700s and 1800s, when European families would gather in a small salon to play the music of the masters. The small salon size dictated a smaller instrumentation, he explained.

"This was a sort of family entertainment," Gibeau said. "Many composers reserved their most intimate musical thoughts for chamber music."

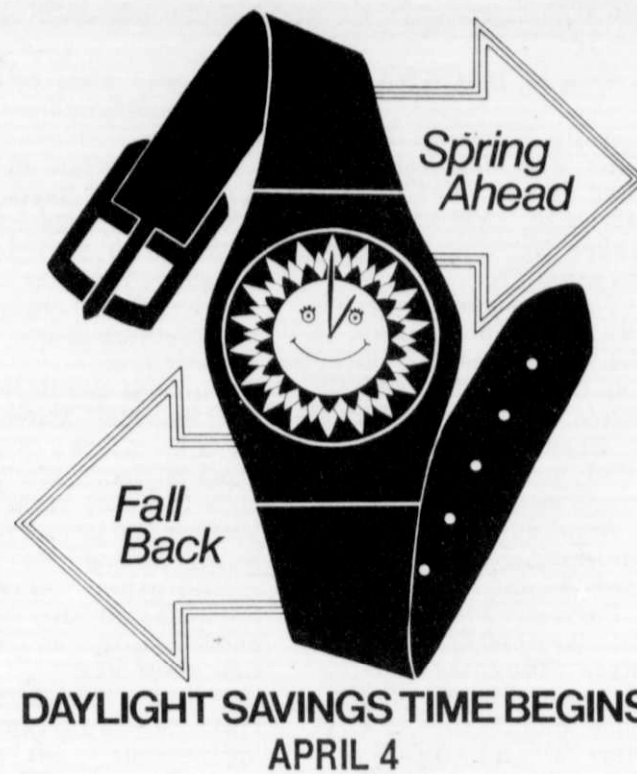
The UWWC concert will feature the classical masters, such as J.S. Bach, Henry Purcell and Brahms.

Gibeau explained that, even with a smaller instrumental group, some of the concert pieces -- such as Brahms' Piano Quartet in C-minor, which features piano, violin, viola and cello -- still will fill the hall. "It's very intense music," he said.

Gibeau said that, as a professional musician, he much preferred chamber music to full orchestral music. He explained that, in the absence of an orchestra conductor, musicians in smaller ensembles had to rely more upon each other for decisions and directions. "In chamber music, we all make decisions," he said. "We all look to each other and communicate with each other while we're playing."

As for question #2 that you will be voting on: (New KES, New High School or no Construction) You can only choose one as that will dictate to us (the board) which way to go in future referendum proposals. Let me clarify how this works because I have sensed a bit of confusion on this question. If you choose a new high school we automatically will move KES into the middle school and the MS into the high school. If you choose a new elementary school it means we will not build a new high school but we will be, I assume, asking for the much needed improvements to the HS and additions to the MS along with (see #5) a gymnasium and probably a consolidated library facility as in the previous proposal.

What is not included in the "fact sheet" which you should have received a copy of in the mail, is what a total District Long Range Facility Plan will cost - particularly with a new high school included. It's the main reason I voted against the fact sheet. By reading it, can you tell me what it will cost? You cannot think of a new HS as being 18 to 22 million and there that will do it. Even if you add in the land and infrastructure costs and the cost to move KES to the MS and to move the MS to the old HS we still won't be done as far as a long range plan goes. There are still the very necessary needs at the outlying schools. And it is not like whether to open BES is the focal point. Like I said in the past: It is the board that is making an issue out of something that shouldn't even be an issue. That aside, whatever you decide to support, you must keep in mind that when a new referendum is proposed, if it is comprehensive, will be in the neighborhood of 25 to 28 million depending on whether you add a pool or not.

Based on a K-5 system which is what the board has agreed on so far, in round numbers, it adds up like this:

New high school 20 million (includes a gymnasium)
 Land, infrastructure 1 million
 Move KES and MS 250,000 thousand
 Remodel old HS 750,000
 Remodel FES 1,800,000
 Remodel WES 1,000,000
 Remodel BES 800,000
 Total 25,600,000

I hope this helps you see the big picture. Please do vote. The board has committed itself to honoring the results of this election.

World War II Speakers at KMS

During the third quarter, the Kewaskum Middle School eighth graders have learned about World War II and the events surrounding the Holocaust. We were very lucky to have some speakers in our school to tell us about life during the war. We had visitors from all sides of the war including an American soldier, German citizen and a concentration camp survivor.

Our first speaker came on Tuesday, February 14. Roger Reindl, grandfather of eighth grader Tricia Brath, was a soldier during the war. Mr. Reindl was stationed overseas in Italy while the war was going on. He told stories of the army, both good and bad.

He spoke of night patrol, army food rations and the various pins and medals he was awarded, including his Purple Heart, which he received after being wounded in the leg during action.

Our second speakers were Mr. and Mrs. Yanke, grandparents of Allison Yanke, also an eighth grader. They came on Monday, February 8th. Mrs. Yanke was a German citizen during World War II. She told stories about the many hardships she and her family faced at that time. She would never comply to salute Hitler or his Nazis, and as a result was taken from her school. Eventually she lived with a family and helped with their children.

She never saw her family members again until after the war. Mr. Yanke was a United States soldier during the time. He spoke of

the black market, a system for buying and selling scarce materials after a war. He paid for their whole wedding with cigarettes. He also mentioned life as an Allied soldier and how he met Mrs. Yanke.

Our third speaker was Mrs. Fela Warchau of Sheboygan. Fela is a survivor of Auschwitz, a Nazi concentration camp in Poland. She spoke to us on Thursday, February 11th. At the age of 13, Fela and her family were taken from their home and placed in a ghetto in Lodz, Poland.

Fela and her sister were the only members of their family to survive Auschwitz. From there they were taken to Bergen - Belsen where they were soon after freed by the Allied soldiers.

On behalf of the eighth grade of Kewaskum Middle School, I would like to extend my thanks to our wonderful speakers. It is always fun to learn through the eyes of someone who lived it. Thank you!

Wisconsin's Frogs, Toads and Salamanders

The Evening with Nature Series at the Northern Kettle Moraine State Forest continues with the program, "Wisconsin's Frogs, Toads and Salamanders."

The program will be held on Thursday, April 8, from 7 to 8:30 p.m. at the Henry S. Reuss Ice Age Visitor Center. The Ice Age Visitor Center is located off of Highway 67, 1/2 mile west

of Dundee. The program is free, but donations are always gratefully accepted.

Wisconsin is home to 21 species of amphibians: twelve frogs, one toad and eight salamanders. Amphibians are a truly remarkable group of animals starting their lives as tadpoles in the water and then metamorphosing to adults, many of which spend their adult

lives on the land.

Because of their unique life cycles, amphibians are very sensitive to physical changes in their environment and to pollution. Throughout the world scientists are seeing reductions in many amphibian populations and they are not quite sure what is causing this wide-scale decline.

Rebecca Christoffel, formerly with the Bureau of Endangered Resources, will share her intimate knowledge of amphibians. She will introduce participants to the amphibians of Wis-

consin and their fascinating life histories. She will also cover some of the global threats to amphibian populations and what is being done to help ensure their survival. Rebecca will be bringing several live animals for folks to meet up close.

Bluebird Nest Box Workshop

Lac Lawrann Conservancy's annual Bluebird Nest Box Workshop will be held Saturday, April 3, from 9 to 11 a.m. at West Bend City Hall, 1115 S. Main Street, in the Conservancy Niche on the first floor.

Workshop leader Mary Holleback is a Riveredge Nature Center Naturalist and Washington County Coordinator for BRAW (Bluebird Restoration Association of Wisconsin).

Bluebirds will arrive any day now. If you haven't cleaned out your boxes or need new boxes to install, this is the time to make your checklist. BRAW is a volunteer organization which promotes the monitoring of nest boxes.

Many times people put up nest boxes and forget them. During the nesting season the survival of birds nesting in man-made boxes depends upon a monitoring program. Cats, raccoons, wasps, ants, snakes and non-native species such as the European house sparrow, can kill or discourage the fledgling of native birds such as bluebirds, house wrens, chickadees and tree swallows. A few simple steps can prevent disasters.

BRAW's spring workshop gives the backyard enthusiast effective ways to attract bluebirds and other native cavity nesters and methods to handle predator problems. The workshop includes a 30 minute slide program on monitoring nest boxes, hands-on identification of bird nests, nest box types and time for questions and answers.
