Kewaskum Awarded \$150,000 COPS Grant

Regal Ware, Inc., Kewaskum, is pleased to announce that Diane Broske and Lauren Steinhardt are the winners of this year's J.O. Reigle Scholarship. The college scholarship program was created in 1963 and is named for the late founder of Regal Ware. It awards each winner \$4,500 each year for four years for a total of \$18,000. Recipients are judged

according to their academic and extra-curricular achievement. Both women are ranked number one in their class with a 4.0 grade point average. Broske, daughter of Richard and Debra Broske of Kewaskum, is a member of the National Honor Society, Yearbook and Key Club. Her hobbies include playing basketball and pool, reading, dancing, bowling,

listening to music and writing. She plans to attend Ripon College with a major in secondary English education. WASHINGTON, D.C. -- U.S. Senator Russ Feingold announced Wednesday that Kewaskum is one of five Wisconsin communities that are receiving grants through the Community Oriented Policing Services (COPS) program. The COPS program, through the Department of Justice, provides funding for the deployment of additional officers to help keep neighborhoods and communities safe. These communities will receive their grants as part of the COPS Universal Hiring Program. When contacted about the \$150,000 grant, Kewaskum Police Chief Richard Knoebel stated, "We are very pleased to have been given the grant for the addition of two officers. The next move will be to discuss the grant with the Village Board and to see what our next steps will be." Knoebel went on to say, "One of the goals of the grant is to add a full-time liaison officer to work between the Kewaskum High School and the Kewaskum Middle School. With the increase of violence and other problems in our schools, the addition of a liaison officer is a proactive move to try and stem problems before they happen. The addition of the officers would be the first increase in department size

since January, 1992."

The following are the recipients of the COPS grants:

Village of Kewaskum - two full-time officers, \$150,000;

City of Verona - one full-time officer, \$75,000;

Forest County Sheriff's Department - one full-time officer, \$75,000;

Jefferson County Sheriff's Department - five full-time officers, \$306,150;

City of Shawano - one full-time officer, \$75,000.

"COPS grants are intended to enhance local law enforcement efforts with new officers and equipment. They are a great example of federal assistance without federal interference," said Feingold. "These funds will support the public safety efforts of these five communities by allowing them to expand the essential and effective crime fighting

partnership between the community and the police department."

COPS funding goes to counties, towns and cities to increase police presence in communities. The COPS program was passed by Congress in 1994 after it was proposed by President Clinton in his State of the Union Address.

Since 1994, the COPS Office has awarded \$6 billion in grants to more than 11,300 state and local law enforcement agencies across the nation. More than 300 Wisconsin communities have benefitted from nearly \$70 million in COPS grants.

Grant programs include; matching funds for the hiring of new officers; assistance for purchasing new technologies and equipment that result in officers spending more time on the streets, and financing the training of former military personnel for local law enforcement.

On April 10, 2000, a special person will be leaving the School Board here in Kewaskum. Nineteen years of service! Nineteen years of dedication! Nineteen years of meetings! Nineteen years of change!

April 10 will be Jean Goeden's last school board meeting. On April 10 beginning at 6 p.m. in the High School Commons, there will be a Farewell Social held in her honor. YOU are invited to say "thank you," "good-bye," "farewell," or simply to be there. At 7 p.m. the board will move to the library and begin what will be Jean's final school board meeting, representing Kewaskum, representing children, representing people.

There are three kinds of people in our society. There are rowboat people, sailboat people, and there are steamboat people. We all know rowboat people. These are people who need to be pushed or shoved along. They just never seem to get going on their own. They usually need someone else to motivate them and tend to be procrastinators. Jean is not a rowboat person.

Then there are sailboat people. Sailboat people move when a favorable wind is blowing, doing things when the feeling hits them. They do things when there is little chance of failure or being wrong. They definitely are not risk-takers but are usually willing to go along with the crowd, always doing the popular thing. If you know Jean, she is not a sailboat person either.

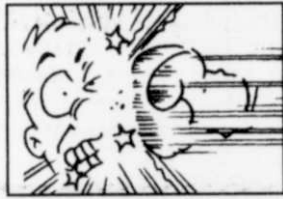

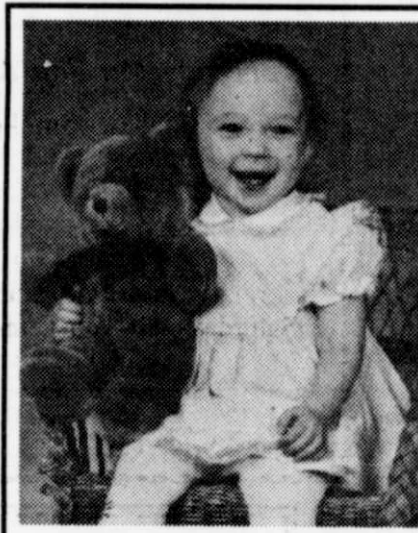

Second Wave of Campaign Promotes Seatbelt Safety

There are a million and one excuses for not wearing seatbelts and some of those excuses can be lethal. As a result, Wisconsin's safety-minded agencies, employers, health care providers, educators, law enforcement, community and civic groups will unite in urging motorists to buckle up.

Beginning March 19, as part of the second wave of a statewide campaign, "Click It - Why Risk It" will increase seatbelt safety initiative in Wisconsin with the help of public-private partnerships, high visibility enforcement and extensive public education and outreach.

Seatbelts save lives. "The Click It - Why Risk It cam-

paign reinforces the fact that seatbelts are the most effective safety device in automobiles today. The West Bend Police Department supports this effort to reduce motor vehicle injuries and fatalities on Wisconsin roads particularly among our youth."

Wisconsin Department of Transportation's (WisDOT) 1999 data shows that belt use is lowest among occupants ages 16 to 25 years. Although this represents only 14.7% of licensed drivers, this group accounts for 27% of Wisconsin drivers involved in crashes. In 1998, one driver age 19 years or less, was injured or killed in a motor vehicle-related crash every 42.4 minutes in Wisconsin.

Young drivers aren't the only motorists at risk. Any unbuckled driver or passenger is likely to be seriously injured or killed in a motor vehicle crash if not wearing seatbelts.

WisDOT 1998 statistics show 60% of persons killed in passenger cars (for whom seat belt use was reported) were not using seatbelts. The National Highway Traffic Safety Administration (NHTSA) shows Wisconsin's seatbelt use (65.1%) trails other Midwest states including Iowa (77%), Minnesota (71.5%) and Michigan (69.9%).

"Click It - Why Risk It" includes a partnership of 40 law enforcement agencies at state, county and local levels aimed at increasing seatbelt use among all Wisconsin motorists. NHTSA research shows that high visibility enforcement works because, with many part-time and non-belt users, the fear of a citation and significant fine influences driving behavior and safety practices.

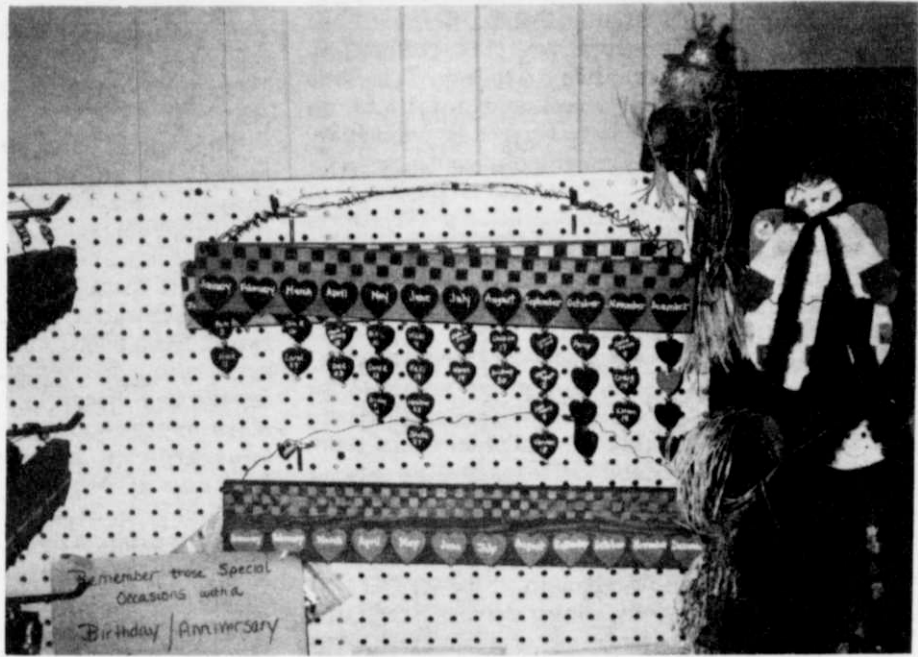

Dear Editor,

AN OPEN LETTER TO AREA SPORTSMEN

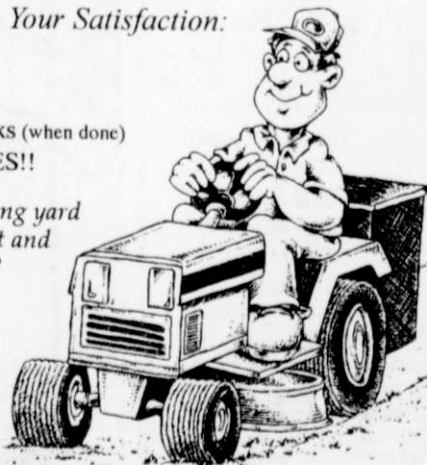

Time to End Racial Preferences

The press reported with great fanfare that the State Assembly last week approved a plan to allow Brown County voters to vote on a sales tax for an expanded Lambeau Field. What wasn't as publicized was a disturbing amendment requiring 15% of all labor on the project to be from racial minorities -- this despite the fact that only about 5% of Brown County's population would be classified as minority.

Leadership insisted on a voice vote so that no one would be on record voting for or against this odious provision. We were informed that over 20 legislators would not vote for the Packer package without this amendment added. A similar amendment was added years ago with regard to the new Brewers' Stadium, requiring 25% minority labor.

Not only will this cost taxpayers more, as the lowest bidder or more efficient worker does not get the job, but also it is an insult to any of the white taxpayers in Brown County who will not be able to work on the job for this reason.

Preferences began in this country in the mid-sixties when President Lyndon Johnson ordered all major United States' businesses that sold products to the government to institute quotas. Of course, federal, state and local units of government frequently followed suit. Due to the liberal bias of the mainstream press, these are not scrutinized often.

Universities and professional schools also give strong preference to minorities and sometimes women. Recently, a white applicant to the Wisconsin law school was outright told that it would be difficult to get in

since he was a white male.

This practice continues due to fear of politicians of being called racist and a lack of public understanding of how widespread it is. The University of Wisconsin-Madison will not release figures in this regard -- apparently because they want to avoid controversy. It is time this practice ends.

America is built on the premise that all men are created equal. This principle underlies the unity, which causes us to all work for the public good. One reason foreign countries have not advanced to the degree our country has is that they get bogged down in factions favoring one ethnic group over another. This was true of Yugoslavia, India, and most African nations. Sadly, I see African American legislators in Madison not asking "Is this bill good for Wisconsin?" but, "Is this bill good for black Wisconsinites?"

I have drafted a constitutional amendment to end racial preferences in the State of Wisconsin once and for all. This amendment would apply to all governmental units as well as our university and tech school systems.

Conduct Safety Check Before Putting Boat in the Water

Boaters can help ensure that their first outing of the season is safe, enjoyable, and environmentally friendly by checking out their boat and trailer before getting to the launch site, Department of Natural Resources Warden Doug Bilgo says.

Anything that sits for a while may develop some problems that may be difficult to see -- mice may have chewed through wiring, parts may have rusted or water rotted a support, Bilgo says. Make sure all the equipment works well on the boat and trailer before you go out -- the boat launch or the middle of the lake is not the place to find something wrong.

A well-maintained boat, especially one with a well-maintained motor, also helps minimize pollution from boating by improving fuel efficiency and preventing fuel and lubricant leaks into the water. Individual boats and marinas usually release only small amounts of pollutants, but, when multiplied by the more than 570,000 motorized boats registered in the state and the 500,000 boats from other states, they can cause water quality problems in lakes, rivers and along the Great Lakes coastal areas.

Bilgo recommends people check out their boat, starting at the bow and working their way back. Inspect the hull, pulleys, carpeting and fittings, and lubricating

those items that need it. Check out the electrical conduits, live well, compartments, benches, transom, the motor, fuel lines, fittings, and put in a fresh fuel filter.

Charge up the batteries, hook up the systems, and check navigation lights, bilge pumps, tilt controls and accessories such as the horn and interior lighting.

Also check over the trailer to make sure the lights work, the tires are inflated to the proper pressure, and that the trailer hitches, safety chains, rollers and pads are all in good condition.

Bilgo also recommends doing the work -- checking, cleaning and maintaining boats before the season begins and after their use -- away from the water, to prevent any oil, toxic cleaners or other pollution from entering lakes and rivers. Also, carefully fueling boat engines, recycling used oil and discarding worn motor parts into proper receptacles, will prevent needless oil spills into the water.

At the spring election, where paper ballots or lever machines are used, the elector shall make a cross (X) in the square or depress the lever at the right of the name of the candidate for whom he or she intends to vote. To vote for a person whose name does not appear on the ballot, the elector shall write in the name of the person of his or her choice in the space provided for a write-in vote. On referendum questions, the elector shall make a cross (X) in the square or depress the lever at the right of "yes" if in favor of the question, or the elector shall make a cross (X) in the square or depress the lever at the right of "no" if opposed to the question.

Where marksense voting is used, the elector shall darken the arrow next to the name of the candidate of his or her choice for each office for whom he or she intends to vote. To vote for a person whose name does not appear on the ballot, the elector shall write in the name of the person of his or her choice in the space provided and darken the arrow at the right of the write-in line provided. On referendum questions, the elector shall darken the arrow next to "yes" if in favor of the question, or the elector shall darken the arrow next to "no" if opposed to the question.

The vote should not be cast in any other manner. If the elector spoils a ballot, he or she shall return it to an election official who shall issue another ballot in its place, but not more than three ballots shall be issued to any one elector. If the ballot has not been initialed by two inspectors or is defective in any other way, the elector shall return it to the election official, who shall issue a proper ballot in its place. Not more than five minutes' time shall be allowed inside a voting booth. Unofficial ballots or a memorandum to assist the elector in casting his or her vote may be taken into the booth and copied. The sample ballot shall not be shown to anyone so as to reveal how the ballot is marked.

After an official marksense ballot is marked, it shall be inserted in the ballot sleeve provided so the marks do not show. After casting his or her vote, the elector shall leave the booth, insert the ballot in the voting device, and shall leave the polling place promptly.

An elector may select an individual to assist in casting his or her vote if the elector declares to the presiding official that he or she is unable to read, has difficulty reading, writing or understanding English or that due to disability is unable to cast his or her ballot. The selected individual rendering assistance may not be the elector's employer or an agent of that employer or an officer or agent of a labor organization which represents the elector.

KHS Girls Track Team Seventh At Washington County Indoor

WEST BEND -- The Kewaskum High School girls' track and field team had a chance to see just how powerful the teams from West Bend East, Hartford, and West Bend West were Tuesday night, March 21, at the annual Bob Buel Washington County Invitational.

West Bend East dominated the competition as they totaled 138 points to win the title, 38 points ahead of second place Hartford. East scored points in all 15 events when they won four events, took second in eight events and two individuals placed in five events.

Their hurdlers took first and second place in both the high and low hurdles using four different hurdlers. West Bend West placed third with 93 points, Slinger was fourth with 53 points, Kettle Moraine was fifth with 36 points, Kettle Moraine Lutheran was sixth with 26 points and Kewaskum finished seventh with 19 points.

The highlights for Kewaskum included the second place finish for Nicole "Coco" Herrmann in the shot put. Herrmann, a sophomore, threw the shot a career best of 34'5". Wenzel of West Bend East won the event with a throw of 35'6-1/2". The next best place for Kewaskum was the fourth place finish of junior Emmy Foerster in the 50 yard high

hurdles with a time of 8.0 seconds. Lemke of West Bend East won the high hurdles with a time of 7.5 seconds.

Sophomore Jolene Clark placed fourth in the high jump with a jump of 4'8". Three individuals all cleared 4'10" and thus first, second and third place were determined by misses. Likewise, four jumpers all cleared 4'8" and again places were determined by misses.

Junior Colleen Gosa finished fifth in the mile with a time of 6:22.6 and sixth in the 880 yard run with a time of 2:48.1.

Both the four-lap relay team and the 10-lap relay teams finished sixth. The four-lap relay team of Becky Herriges, Stacy Muckerheide, Kristin Schiller and Tina Lindgren ran a time of 1:30.7, while West Bend East's quartet ran a time of 1:25.3. The Kewaskum 10-lap relay team of Lauren Schultz, Michelle Zingsheim, Amber Averill and Emmy Foerster ran a time of 4:38.3. West Bend West won the relay with a time of 4:06.9.

The Kewaskum six-lap relay team was disqualified when an opponent cut in front of one of the Kewaskum runners and the Kewaskum runner then hit the back of the opponents foot causing her to fall. The

six-lap relay team consisted of Kristin Schiller, Jody Wichtoski, Beth Degner and Stacy Muckerheide.

The 20-lap relay team of Kelly Darmody, Heather Hackbarth, Mandi Will and Heather Meyer should have placed but an officiating error caused Heather Meyer to run one additional lap. Both junior Tina Lindgren and freshman Becky Herriges ran well in the 213 yard dash, but missed placing by a couple of a tenths of a second.

The next track meet for the Kewaskum girls' track team will be on Tuesday, April 4, at UW-Oshkosh.

New Holstein Boys Track Team Topples Kiel and Kewaskum

NEW HOLSTEIN -- The New Holstein Huskies boys' track team won eight of the 14 events and also took seven second places at the annual triangular indoor track meet at New Holstein to easily defeat both the Kiel and Kewaskum boys' teams on Monday, March 30.

New Holstein scored 71 points compared to 34 points for Kiel and 30 points for Kewaskum. This was the first regular track meet of the season for all three schools.

Highlights for the Kewaskum boys' team included the 1-2 finish by Josh Parrent and Chris Koth in the pole vault. Junior Josh Parrent cleared 11'6" to record the only first place finish for Kewaskum. Senior Chris Koth, who cleared 11'6" last Saturday at the Kewaskum Invitational, had more than enough height to clear 11'6" or 12' kept hitting the bar on the way down on each of his three misses.

Even though Kiel does not pole vault, New Holstein maximized their "home vaulting box advantage" and provided good competition for Kewaskum pole vaulters. Senior Joel Hermann also cleared 11' for Kewaskum, but only two vaulters per school compete on the varsity in each event.

Junior Charlie Sparks placed second in the shot put with a throw of 44'7-3/4". Woelfel of New Holstein won the shot put with a put of 46'9-1/2". Spark's teammate Nathan Fechter placed fourth with a distance of 35'4-1/4".

The Kewaskum 400m (4x100m) relay team of Jim Thelen, Chris Canter, Tony Fitts and Sparks fought Kiel, New Holstein and the tight turns to place second behind Kiel with a time of 52.0 seconds, just 0.3 seconds behind Kiel. The Kewaskum 4x100m relay team is looking forward to running on the larger track at West Bend for the Washington County Indoor.

The lone other second place finish was freshman Mike McKee in the 60 yard high hurdles. McKee finished with a time of 10.6 seconds, while Wasmir of New Holstein won with a time of 8.2 seconds.

Jim Thelen finished third in the 60 yard dash with a time of 7.08 seconds just behind two New Holstein runners who finished first and second in other heats with time of 7.03 seconds and 7.06 seconds. It is interesting to point out that all three times would actually be recorded as 7.1 seconds according to WIAA rules, but when multiple heats are hand-timed in the hallways of New Holstein during indoor season run somehow

Accessory structures in the A-1 Agricultural/Open Space District and in any Residential District where the residence is the principal use on parcels greater than five (5) acres shall not exceed a total of 1,500 square feet in area or 20 feet in height. Accessory structures 120 square feet or less in area shall be permitted up to five (5) feet from a side or rear property line.

Section 3: Section 6.01 (G) is created to read: (G) Accessory structures with a maximum sidewall of ten (10) feet may exceed the height limitations of this Ordinance to allow architectural simulation of the principal residence.

KHS Boys' Track Team Sixth at Washington County Indoor Meet

WEST BEND -- The Kewaskum High School boys' track and field team had the opportunity to find out just how good teams like West Bend East and Slinger are going to be this season on Tuesday, March 21.

West Bend East dominated the area competition in the annual Bob Buel Washington County Invitational. West Bend East amassed a total of 134 points to easily outscore Slinger by 26 points. West Bend West finished third with 76-1/3 points, followed by Hartford with 41 points. Germantown placed fifth with 40-1/3 points, Kewaskum was sixth with 25 points and Kettle Moraine Lutheran finished with 4-1/3 points.

The Kewaskum boys each year have a difficult challenge when they compete against the well-established track programs of the West Bend West, West Bend East and Slinger. West, East, Germantown, and Hartford are Division I, but Slinger, a Division II school, also annually fields a good track team.

The highlights for Kewaskum included two second place finishes, one in Six Lap Relay and the other in the long jump.

The Kewaskum Six Lap Relay team provided the most exciting relay race and an electrifying photo finish for the crowd Tuesday night. The Kewaskum foursome of Jim Thelen, Chris Canter, Tony Fitts, and Charlie Sparks were paired against West Bend West in the fastest heat.

Kewaskum took the early lead, but the crowd saw the lead exchange hands several times as Kewaskum's handoffs definitely showed they needed more practice. West built a 10-15 foot lead, but Sparks, running the last leg, cut the lead and threatened to take the lead on the back stretch and then almost succeeded in completely overtaking the West Bend West anchor at the wire.

West won with a time of 1:57.0, Kewaskum finished second with a time of 1:57.1, and West Bend East placed third with a time of 1:57.2. Thelen, Canter and Sparks are returning members of the 400m relay team from

last year. Sophomore Tony Fitts, filling in for senior Jason Strobel, ran very well.

All of them ran very well. Better handoffs might have tipped the scales in Kewaskum's favor. Fitts has matured as a runner since last season and has a lot of untapped potential. He should help the sprinter corp even more as the season progresses.

Sophomore Chris Canter placed second in the long jump with a distance of 18'10-3/4". Schmitz of Slinger won the long jump with a leap of 20'1-3/4". Canter also placed fourth in the 440 yard dash with a time of 58.8 seconds. Brzeski of West Bend West won with a time of 57.1 seconds.

Sparks threw 43'7-1/2" in the preliminaries of the shot put to put himself into

the finals. After anchoring the Six Lap Relay to their second place, Sparks went back to take his final three throws in the finals, but, did not improve his distance and had to settle for sixth place in the shot put competition.

Mueller of Slinger won the shot put with a throw of 49'6". Sparks also placed fifth in the 213 yard dash with a time of 24.89 seconds. Czerniak of West Bend East won the event with a time of 24.52 seconds.

Kewaskum's 20 Lap Relay team of Darrell Woebeking, Curtis Cochran, Joe Rinzel and Justin Weninger placed fifth in 9:24.8. West Bend East won with a time of 8:15.5.

The pole vault event was not held due to problems with not having legal vaulting conditions in the West

Bend Field House. Pole vaulting should be a strong event for the Kewaskum team this year. Both senior Chris Koth and junior Josh Parrent were disappointed,

but will just have to wait until the Washington County Outdoor on April 26 at Germantown to compete against the other county vaulters.

Parrent, Koth Clear 12'6" Pole Vault at Oshkosh Invite

UW OSHKOSH - The Kewaskum High School boys' track and field team traveled to the University of Wisconsin to compete in the 28th Annual Oshkosh Invitational on Friday, March 24.

The night was especially rewarding for two of Kewaskum's varsity vaulters, junior Josh Parrent and senior Chris Koth, who hadn't had a chance to vault at the Washington County Indoor the previous Tuesday because the event was not held.

As the field of 27 vaulters narrowed, three vaulters succeeded in clearing the 12 foot barrier. Dan Murrary of

Grafton then cleared 12'6" easily. Chris Koth also cleared 12'6", on his second attempt, while his teammate, Josh Parrent, cleared the bar on his first attempt.

The bar was then raised to 12'9" and Murrary cleared it on his first attempt. Kewaskum coach Rick Robinson asked that the bar be raised to 12'9-1/4" so that both Kewaskum vaulters would have an

attempt to break the Kewaskum indoor school record of 12'9". (The record was set back in 1993 at this same meet by Brad Jackson.)

Koth and Parrent each took three attempts at the bar and were unable to break the school record. Murrary thus won the event and then cleared 13'3" before he missed three times at 13'6". Parrent placed second and Koth placed third based on the fact that Parrent cleared 12'6" on his first attempt. Their cleared height of 12'6" was a career best for both athletes.

After the completion of the event, Parrent remarked to Koth, "I really wanted you to break the school record. I have another year to come back and give it another shot."

"Both came to this meet expecting really good competition. The best vaulters in our sectional were here tonight vaulting. Chris and Josh vaulted their best ever and both came very close to breaking the school record. They did an excellent job," concluded Coach Rick

Robinson.

Kewaskum is presently loaded with good pole vaulters. Senior Joel Hermann vaulted 12' and Brian Wall 11'6" just two days earlier on Wednesday at the JV track meet at Hartford. At last year's sectional meet, Wall also cleared 12'. Thus, Kewaskum presently has four athletes at or over 12 feet. There will be some tough decisions ahead for the pole vaulting coach when it is time to decide on which athletes compete for the two varsity spots for meet competition.

Junior Charlie Sparks was a pleasant surprise in the shot put as he qualified for the finals with a season best throw of 44'8-1/2" in the shot put. Before Sparks could take his throws in the finals, he was needed to run with his teammates in the 800m relay. Sparks was not able to improve his effort in shot put after anchoring the relay and had to settle for eighth place.

Charlie will have to get used to running and then throwing again during the season. This same thing happened at the Washing-

ton County Indoor and will probably repeat itself all season.

The surprises were not over for the Kewaskum coaching staff. Senior Jesse Boegel, who had run the 880 yard run with a time of 2:19 on Monday at the track meet in New Holstein, but missed the Washington County Indoor meet, was preparing for running the 800m run for only the second time of his varsity career.

Boegel had run track as a freshman, but missed both his sophomore and junior track seasons. What happened next, might have not been a surprise for Boegel, but sure surprised Coach Randy Backhaus and Coach Gosa.

Boegel ran with his large graceful stride and worked his way up to second place in his heat behind the New Holstein runner that beat him on Monday. Then, with one lap (200m) to go, Boegel sprinted past the New Holstein runner on the backstretch to win his heat going away with a time of 2:10.2 (two minutes, 10 seconds.)

The Kewaskum school indoor record is 2:08.4.

Boegel kept getting faster as the race went along as he ran 200m splits of 34.1, 33.9, 31.5 and 30.6 seconds. It didn't seem like Boegel was really excited with his performance, but the rest of the athletes and coaches were sure happy and excited for him.

The Kewaskum 800m relay team of Jim Thelen, Chris Canter, Tony Fitts and Charlie Sparks knew they would be facing extremely difficult competition at Oshkosh. Their goal

was to break the school record of 1:39.65 and also place among the top six and win a medal in this event. (The school record is held by Andy Rix, Aaron Kurth, Matt Tonn and Ryan Herman.)

Neither goal was attainable Friday night as Kewaskum ran a time of 1:42.13. The group ran fairly well, but not as well as they will have to run in their conference meets. Both New Holstein and Campbellsport beat Kewaskum. Official results were not available at press time.

Jim Thelen and Chris Canter ran the 55m dash with a time of 7.24 and 7.21 respectively, but did not make the finals. Canter ran a time of 57.71 seconds in the 400m dash, but did not place in the top eight. Canter also competed in the long jump and recorded a jump of 18'10" but did not make the finals. It was a busy night for Canter as he competed in four events -- 55m dash, long jump, 800m relay and 400m dash.

Other Kewaskum athletes competing and their events and times are as follows: Luke Kehres - 400m dash, 61.27 seconds; Darrell Woebeking - 800m run, 2:28.2; Chris Baker - 1600m run, 5:23.57; Paul Mertz - high jump, 5'6", and Mike McKee - 55m high hurdles, 8.9 seconds. The 1600m relay team of Darrell Woebeking, Luke Kehres, Andy Lickel and Jesse Boegel ran a time of 4:02 (four minutes and two seconds).

Head Coach Jerry Gosa commented, "I am very happy for both Chris and Josh. They both have put a

OFFICE OF THE WASHINGTON COUNTY CLERK TO THE ELECTORS OF WASHINGTON COUNTY:

Notice is hereby given of a nonpartisan spring election and a Presidential Preference Vote to be held in the several wards in the County of Washington on April 4, 2000, at which the officers named below shall be chosen. The names of the candidates for each office to be voted for, whose nominations have been certified to or filed in this office, are given under the title of the office, each in its proper column, together with the question submitted to a vote, for a referendum, if any, in the sample ballot below.

INFORMATION TO ELECTORS

Upon entering the polling place, an elector shall give his or her name and address before being permitted to vote. Where ballots are distributed to electors, the initials of two inspectors must appear on the ballot. Upon being permitted to vote, the elector shall retire alone to a voting booth or machine and cast his or her ballot, except that an elector who is a parent or guardian may be accompanied by the elector's minor child or minor ward. An election official may inform the elector of the proper manner for casting a vote, but the official may not in any manner advise or indicate a particular voting choice.

At the Spring Election, where lever machines are used, depress the lever over the candidate's name. Where a marksense system is used, darken the oval next to the candidate's name.

To vote for a person whose name does not appear on the ballot, the elector shall write the name of the person of his or her choice in the space provided for a write-in vote and darken the oval next to the name written in.

On referenda questions, where a marksense system is used, the elector shall darken the oval in the space next to "yes" if in favor of the question, or darken the oval next to "no" if opposed to the question.

At the Presidential Preference Vote, where lever machines are used, the elector shall select the party of his or her choice and depress the lever over the name of the candidate of his or her choice or shall, in the alternative, depress the lever over the words "Uninstructed delegation," or write in the name of his or her choice for a candidate in the space provided.

Where marksense system is used, the elector shall select the party of his or her choice and darken the oval next to the name of the candidate of his or her choice or shall, in the alternative, darken the oval next to the words "Uninstructed delegation," or write in the name of his or her choice for a candidate in the space provided and darken the oval next to the name written in.

If an elector spoils a ballot, he or she shall return it to an election official who shall issue another ballot in its place, but not more than three ballots shall be issued to any one elector. If the ballot has not been initialed by two inspectors or is defective in any other way, the elector shall return it to the election official who shall issue a proper ballot in its place. Not more than five minutes' time shall be allowed inside a voting booth. Unofficial ballots or a memorandum to assist the elector in marking his or her ballot may be taken into the booth and copied. The sample ballot shall not be shown to anyone so as to reveal how the ballot is marked.

After an official marksense ballot is marked, it shall be inserted in the envelope (if one is provided) so the marks do not show. After casting his or her vote, the elector shall insert the ballot in the voting device and discard the envelope. The elector shall leave the polling place promptly.

An elector may select an individual to assist in casting his or her vote if the elector declares to the presiding official that he or she is unable to read, has difficulty reading, writing, or understanding English, or that due to disability is unable to cast his or her ballot. The selected individual rendering assistance may not be the elector's employer or an agent of that employer or an officer or agent of a labor organization which represents the elector.
