Kewaskum Celebrates Fire Engine 'Wet Down'

Kewaskum Fire Department members, along with over 300 area residents, proudly experienced a historic event on Thursday, April 27, at the Kiwanis Park.

They gathered to officially install two fire engines into service in a "wet down" ceremony. Following the presentation of colors, the engines slowly made their way into the park. The first engine, #1862, is a 2000 all aluminum-manufactured truck from Pierce and the second engine, #1864, is a 1984 refurbished truck with an all-new aluminum body.

Many dignitaries attended and addressed those assembled. In addition, sixteen area fire departments were represented.

Joe Enright, Boltonville Volunteer Fire Department chief and acting Master of Ceremonies for the wet down, began by welcoming all attending and explained that the spotlight shines on the Kewaskum Fire Department as the department installs their two trucks. He further explained that the addition of the Kewaskum trucks would not only meet present needs but future fire fighting needs as well. He recognized and expressed appreciation to all

the departments who were represented at the event.

Neighboring departments who participated included Beechwood, Boltonville, Hartford, Batavia, Kohlsville, Jackson, Theresa, Fillmore, St. Lawrence, Waubeka, Silver Creek, Campbellsport, Allenton, Slinger, Newburg, and of course, Kewaskum.

Kewaskum Village President Robert Wagner expressed his gratitude to not only the Kewaskum Fire Department firefighters but to all firefighters who are dedicated to the communities they serve.

Washington County Sheriff Jack Theusch congratulated the Kewaskum Fire Department on their acquisition and commended all the fire departments in Washington County. He stated that he is proud of the fire departments and pleased with the excellent working relationship that exists between the sheriff's department and county fire departments.

Kewaskum Fire Chief Mark Groeschel followed, introducing the equipment committee members, recognizing the numerous hours and preparation that went into the trucks, and finally, gave a brief description of the new trucks. The trucks

Open House Planned for New Cancer Care Center May 21

A grand opening and community open house is planned for the new \$7 million Cancer Care Center at St. Joseph's Community Hospital of West Bend on Sunday, May 21, starting with a ribbon cutting ceremony at 1 p.m.

Special guest speaker will be well-known former Milwaukee TV anchor and reporter, Melodie Wilson. A cancer survivor, she has been active in cancer-focused efforts, and in 1999, founded an organization that offers mentoring and resources for people diagnosed with breast cancer.

The open house will include guided tours of the Kettle Moraine Oncology clinic, the Vince Lombardi Cancer Clinic-Aurora Health Care, and St. Joseph's radiation oncology department.

The 1 p.m. ribbon cutting ceremony at the Cancer Care Center, 1110 Oak Street, will be followed by the dedication of a ceramic tile sculpture commissioned to recognize donors to the Cancer Care Center.

Tours and refreshments will be offered until 4 p.m. for the public, and Cancer Care Center staff will be on hand to talk about the facility and answer questions. Information will also be

available on cancer prevention and cancer-related services.

The Cancer Care Center is a unique three-in-one collaborative effort among Kettle Moraine Oncology, St. Joseph's Community Hospital of West Bend, and the Vince Lombardi Cancer Clinic-Aurora Health Care. Together, they offer a range of treatment and support services to benefit cancer patients and their families in Washington County and surrounding communities.

The two full-service medical oncology clinics provide consultation appointments and chemotherapy treatments. A state-of-the-art linear accelerator in the radiation oncology department at the Center means that, for the first time, area cancer patients have convenient access to locally delivered radiation therapy treatments.

Studies have estimated that the equipment at the Cancer Care Center will be able to meet the needs of 90% of the cancer patients in the area who require radiation therapy.

Some of the highlights of the Cancer Care Center which visitors will see on May 21 include:

- * "Non-institutional" design and decor that uses

soft lighting, rich colors and finished woods to create a comforting and comfortable environment.

- * The \$1.6 million linear accelerator, a machine that delivers radiation therapy. The linear accelerator is a dual high-energy radiation therapy treatment machine that uses high doses of radiation to damage or destroy cancer cells in specific parts of the body. The linear accelerator is housed in a specially constructed 1,578-square-foot suite with walls that are nearly seven-feet thick in some locations.

- * Two backlit transparent photographic murals of colorful nature scenes placed on the ceiling above the simulator and linear accelerator in the radiation oncology department. These dramatic murals promote "visual therapy" and relaxation to patients during their treatments.

- * Wide-windowed rooms called infusion areas where patients receive chemotherapy treatments. Weather permitting, patients can also choose to receive their treatments in one of two sheltered outdoor patios.

- * Resource areas with Internet access, videos, and printed information to assist cancer patients and

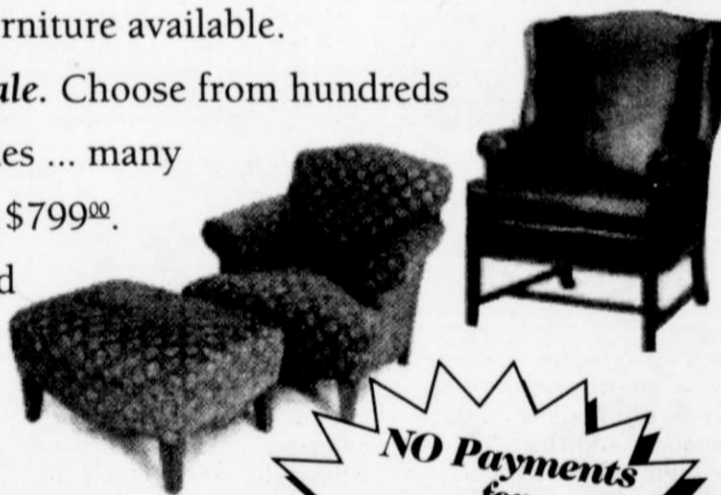

The highlight of the evening, however, was when the semi-circle of pumper trucks from all 16 fire departments readied their hoses, lights and sirens. As emcee Joe Enright gave the signal, sirens screamed, horns blared and emergency lights flashed as water sprayed from the hoses in the air over the trucks and showered down on the trucks and equipment committee members. It was indeed a sight to behold!

Following the wet down at Kiwanis Park, a reception was held at the Kewaskum Fire Station where the two engines were on display and a traveling

trophy was presented to the department by Lieutenant Lamm of the Jackson Fire Department. The large trophy, originated in 1994, now has 11 engine engravings including two for Kewaskum.

Joe Enright offered congratulations and presented a display plaque to the equipment committee from his host department, the Boltonville Volunteer Firefighters.

Kewaskum Fire Chief Mark Groeschel, followed by cutting two decorated cakes with a fire ax as many gathered around to watch. A light lunch, refreshments, conversation and truck inspection rounded out this historic event for the Kewaskum Fire Department.

HELPFUL HINTS FROM EXPERTS

Prevent Spoiled Foods From Spoiling Your Fun

(NAPS)—Following a few simple tips can make it less likely for bacteria to get an invitation to your next barbecue or party.

According to recent studies, the U.S. and other industrialized countries are experiencing a rapid increase in food-borne illnesses.

Up to 24 million cases are reported in the U.S. each year—a figure that swells to more than 80 million by including unreported, untreated or misdiagnosed cases. Nearly 9,000 deaths occur.

Despite this alarming trend, food-borne illnesses can be avoided, according to weight management expert and award-winning author Jenny Craig.

"At least 25 percent of food-borne illnesses over the past 17 years could have been avoided by handling food safely," said Craig. "You can still enjoy popular party foods like mayonnaise-based salads, chicken, pork and dairy products, which also are the most common vehicles for salmonellosis, trichinosis and other forms of food poisoning. The key is to handle, prepare and store foods properly to minimize exposure to bacteria and maximize freshness, quality and shelf-life."

Craig offers the following tips for keeping your parties safe and sanitary:

- Refrigerate or freeze groceries immediately upon returning home. Don't leave perishable items sitting on the counter.

- Wash hands with soap and water thoroughly when handling leftovers, and

before, during and after food preparation.

- Wash vegetables under the tap, using a vegetable brush for potatoes and celery.

- Keep raw meats separate from other foods, both on the kitchen counter and in the refrigerator. Wash marble or acrylic cutting boards, knives and counters often. Avoid wooden cutting boards as they more readily harbor bacteria.

- Thaw food in the refrigerator or microwave or in a sink filled with cold water that is changed every half hour. Do not refreeze thawed food.

- Avoid using the same spoon for stirring and tasting.

- Divide cooked leftovers, cool separately in small containers in a well-ventilated room for no longer than one hour, then refrigerate or freeze. If stored in the refrigerator, use within three or four days and reheat thoroughly.

- If in doubt, throw it out. For more information on healthy cooking tips or weight management, call toll-free 1-800-93-JENNY.

Ozaukee/Washington Land Trust Requests Grant for Acquisition

MILWAUKEE -- The Ozaukee Washington Land Trust has requested a grant of \$143,250 from the Department of Natural Resources' Stewardship Habitat Areas Program. If awarded, the grant will be used to purchase a 12-acre parcel of land in Washington County.

"The property is located on Lake Twelve in the Town of Farmington in Washington County and is owned by Roger A. Johnson and Michael G. Pflughoeft," says Daniel Kaemmerer, DNR community services specialist. According to Kaemmerer, the property contains significant wildlife habitat, including seven acres of wetlands. The Department will also work with the land trust in developing a public boat access site to the lake. Washington

County and the Cedar Lake Conservation Foundation are also providing financial support for the land acquisition.

The type of project typically does not have the potential to cause significant adverse environmental impacts, therefore, the Department has made a preliminary determination that an environmental analysis will not be required for this potential grant project.

Information regarding the Department's grant determination can be reviewed at the DNR Southeast Region Headquarters, 2300 N. Martin Luther King Jr. Drive in Milwaukee. 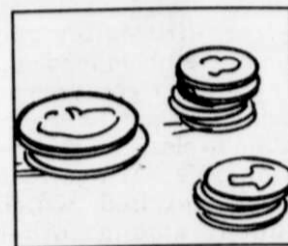

CORRUGATED CARDBOARD

6 of 7

TYPE OF CORRUGATED CARDBOARD: The cardboard that peels apart with two outside layers is corrugated. The middle section not exposed is wavy or corrugated.

PREPARATION: Flatten boxes and cut into 2'x2' pieces. Tie in bundles with twine or strong string. Bundles should be limited to 8" in height. Place bundles at the curb next to the dark green recycling bin or blue recycling bag. Place the bin or bag at the curb on the same day that your solid waste is to be collected. Pick up will be Wednesdays for both solid waste and recyclables. Multi-family dwellings of six or more, remember, your recycling pick up will be the 1st and 3rd Wednesday of each month.

NOTE: If raining on collection day, please hold cardboard until the following week.

their families.

* Specially commissioned donor recognition artwork on the wall in the main corridor. Madison-born artist Karen Singer created these five ceramic tile pieces depicting the Kettle Moraine landscape and four familiar flowers of the region. The artwork is a gift of West Bend Mutual Insurance Company in memory of the late Ron Lauret, a vice-president of the company who was very involved in promoting art appreciation and accessibility.

The costs of the Cancer Care Center were supported in part by generous donations from the community, including a \$2 million gift from an anonymous donor. In addition, a fund drive has also raised more than \$1.6 million. The donor recognition wall honors donors to the Cancer Care Center and lists donors of \$1,000 and more.

Construction of the 23,718-square-foot facility began in April 1999 and was completed this spring. The Center saw its first patients on Monday, March 27, 2000 when Kettle

Village Board Meeting Minutes

Village of Kewaskum
Regular Meeting
April 17, 2000
8:00 p.m.

The Village Board of Kewaskum, Washington County, Wisconsin, met in Regular Session in the Council Room of the Municipal Building, 204 First Street.

President Robert Wagner presided. Trustee Elect Mathew Heiser was present. All other Trustee Members were present. A quorum was present. Trustee John Kenworthy asked to be excused at 8:12 p.m.

The meeting was opened with a Moment of Silence and Pledge of Allegiance.

On a motion by Trustee Robert Stoltzmann, seconded by Trustee Larry Ammel and unanimously carried by voice vote, the minutes of the April 3, 2000 meeting were approved as printed.

President Robert Wagner and the entire Village Board recognized Trustee Warren Dums for his 4 years of service to the Village of Kewaskum and presented him with the Certification of Appreciation from the Mid-Moraine Municipal Association upon his retiring from office.

Mr. John Knepel of the accounting firm of Virchow, Krause & Company, LLP, was present to review and answer questions on the latest audit prepared for the Village of Kewaskum for the year ending December 31, 1999. Mr. Knepel explained the entire audit process and financial statements regarding the General and Utility Funds portion of the audit and associated financial statements. The audit revealed the Village to be in a healthy position.

It was further noted the General Fund ended with a positive balance. The Water Utility reflected a balanced rate of return; this rate of return being 5.63%. It was noted that the PSC has authorized the Village Water Utility to have a rate of return of 8.25%. The Auditors suggested possibly looking into the short form PSC rate adjustment process to account for inflation, that being the routine 3.0% type increase. The Sewer Utility also ended the year with a positive balance. It was noted that a rate increase was implemented following 1996 to help cover the cost as well as the relief sewer projects of 1998. The sewer utility rate of return dropped to .62% and it was recommended to follow that closely with the possibility of a rate adjustment. The Village's overall debt is at an estimated 22% of what the law provides, a very good position to be in.

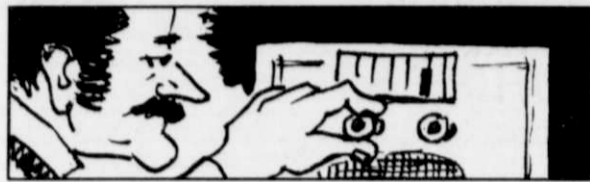

Ordinance No. 2000-02

AN ORDINANCE TO AMENDING CHAPTER 90 TRAFFIC AND VEHICLES

THE VILLAGE BOARD OF THE VILLAGE OF KEWASKUM DO ORDAIN AS FOLLOWS:

THE VILLAGE BOARD OF THE VILLAGE OF KEWASKUM, WISCONSIN WISH TO AMEND SECTION 90-97 OFF-STREET PARKING LOTS AND ORDAIN AS FOLLOWS: 90-97 OFF-STREET PARKING LOTS.

(a) Off-street parking shall be permitted in properly designated off-street lots in the village.

Those lots are designated as follows:

- (1) Municipal Building parking lot, Railroad Street parking lot between 1st & 2nd Street.
- (2) River Hill Park parking lot, Riverview Drive west side curbed area adjacent to 1155 Riverview Drive.
- (3) Fire House north parking lot, 1106 Fond du Lac Avenue.
- (4) Downtown parking lot, adjacent to the Municipal Building Annex, 1308 Fond du Lac Avenue.
- (5) Kewaskum Kiwanis Community Park, 1601 Brooklane Drive. (Seasonal with specific permission.)

(b) The village reserves the right to limit the number of vehicles allowed in any lot, to designate specific area allowed for parking and to restrict vehicles by weight and size, so as to not interfere with the routine business of the village.

(c) All vehicles are to be moved once every 24-hour period and are to be currently licensed, registered vehicles.

(d) The fee for such overnight winter, spring, summer and fall parking shall be \$10.00 per month, and permits therefor shall be obtained at the office of the Chief of Police. The permit received must be displayed in the front window of the vehicle, left lower/driver's side of the dash.

This Ordinance shall take effect upon passage and publication as provided by law.

KHS Golfers Finish 12th In Brown Port Invitational

On Friday, May 5, the Kewaskum High School varsity boys' golf team participated in the 20th Annual Golf Invitational Tournament conducted at Hawthorne Hills hosted by Port Washington and Brown Deer High Schools.

Eighteen area high school teams competed on a glorious spring day on the 6,246 yard, par 72, 18-hole trac north of Saukville.

The tournament began with a shotgun start of all 90 competitors dispersed throughout the back nine (nos. 10 through 18), therefore the pace of play was slowed due to starting with either three or four groups assigned to each hole.

The pace and scoring gradually improved as did the weather and playing conditions. The invite concluded with the awarding of team trophies to the top two teams and medals to the top ten individual scorers as well.

With 12 division one teams and many ranked among the state's best in the tournament, Kewaskum looked forward to battling the five other division two teams, most of which will be in the WIAA Sectional (State Qualifying) Tournament conducted in Kewaskum later this month.

After nine holes, the Indians were tied for sixth overall with senior Curt Koth leading the local linksters with an even par 36 on the back nine.

However, the Indians remained true to form lately by recording a significantly higher score on their second nine. The KHS varsity managed to add 15 more strokes to their first round total, thereby ending up in 12th place overall with a 437 team score.

Koth finished with an 83, followed by Bill Koch's 84 and Jon Boedeker's 86. And, with all five scores counting toward the final team score, Kevin Miller's 89 and Josh Stangl's 95 rounded out the Indian's scoring.

Since two division two teams, Grafton (403) and Pewaukee (410), finished fourth and fifth place, it would appear that Kewaskum needs to become more consistent and still make some much needed improvement, in order for the Indians to take advantage of hosting the Sectional Meet.

KHS will also be hosting the Eastern Wisconsin Conference Tournament on Thursday, May 18, which will provide the Indians with another opportunity to prove their collective abilities.

The KHS varsity boys golf team has posted some very solid nine hole totals this spring and even won a nine-hole tournament. Yet, the Indians have had difficulty in putting together

two good nine-hole scores in the five (18-hole) tournaments they have competed in this season.

Thus, the emphasis for the next several weeks of practice and play will be on consistency and the mental toughness it takes to successfully compete no matter what the level of competition, the weather conditions or even what course they are competing on.

This week the Indians are not scheduled to play in any tournaments, therefore they can focus on improving their status within the conference. The varsity and junior varsity will each play three EWC opponents prior to going into next week's conference tournament.

These matches should solidify the lineup and the Indians position in the league, where they are currently 1-2 at the varsity level and 2-1 for the junior varsity. KHS hosted Kiel on Wednesday (5-10), travel to Manitowoc Roncalli on Thursday (5-11) and to Campbellsport on Friday (5-12) to determine their league record and develop some level on consistent performance.

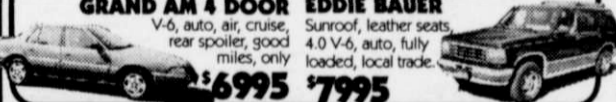

Boys 4x200m Relay Team Wins at Vanderpan Invite

SHEBOYGAN FALLS -- The Kewaskum High School boys' track and field team won an impressive four events as they placed fifth at the 30th Annual Vanderpan Co-ed Track and Field Invitational held Friday, May 5, at Sheboygan Falls High School.

Kewaskum's pole vaulters Josh Parrent and Brian Wall, each returned to championship form as they easily went 1-2 in the pole vault competition. Parrent and Wall cleared 12'6" and 12' respectively to score 18 points for the team.

Diedrich of New Holstein cleared 11' for third place. Parrent came within six inches of clearing his career best and Wall equaled his career best. "They both vaulted extremely well tonight," commented pole vault coach Rick Robinson.

Charlie Sparks continued to dominate in the discus competition. Sparks, who on Tuesday broke the KHS discus record for the fourth time this season with a toss of 163'5", easily won the competition on Friday with a throw of 158'6". Second place was a toss of 136'5" from a thrower from Plymouth.

Sparks also anchored the winning 4x200m relay team and the 4x100m relay team that finished fourth. In the shot put competition, Sparks placed seventh with a put of 42'7-1/2".

Chris Canter has regained last season's form and won the long jump competition in a major invite for the second time in two weeks with a leap of 19'10". Canter also finished third in the 400m dash with a time of 52.8 seconds.

Otte of Plymouth won the 400m competition with a time of 51.6 seconds and later placed second in the 800m run. Teammate Tony

Fitts placed fourth in the long jump with a jump of 18'3-1/4" and also placed eighth in the 100m dash with a time of 11.6 seconds.

The 4x200m relay team of Jim Thelen, Tony Fitts, Jason Strobel and Charlie Sparks won and set the meet record with a very good time of 1:35.7 (one minute and 35.7 seconds). The 4x200m relay is a new event for the boys competition this year. Southern Door finished two seconds behind for second place with a time of 1:37.6 and conference foes Sheboygan Falls and Plymouth finished third and fifth with a time of 1:38.5 and 1:39.0 respectively.

Powerhouse Eastern Wisconsin Conference foe Plymouth easily won the team title by scoring 131 points. Host Sheboygan Falls finished second with 112 points and Oostburg finished third with 97 points.

Southern Door finished fourth with 94 points, followed by Kewaskum with 90 points for fifth place. New Holstein finished sixth with 82 points, Howards Grove finished seventh with 81 points and Elkhart Lake finished eighth with 13 points.

Senior Jesse Boegel finished third in the 800m run with a time of 2:05.0. Amel and Otte of Plymouth finished 1-2 in the 800m run with times of 2:01.8 and 2:03.3 respectively. The competition in the 800m run is probably the toughest it has been in years. Erickson of Two Rivers ran a time of 2:01.3 seconds on Tuesday, May 2, against Boegel and Otte and Amel,

both of Plymouth.

Tom Ogi placed fourth in the high jump competition with a career best jump of 5'10". Ogi's previous best had been 5'6". Teammate Paul Mertz placed sixth in the high jump competition with a height of 5'8". The winning height in the high jump was 6'0".

Four jumpers, including Ogi, cleared 5'10" and there fore places 2-5 were determined by number of misses. Ogi also surprised his coaches when he almost won his preliminary heat in the 200m dash. Ogi later finished sixth in the finals of the 200m dash with a time of 25.1 seconds.

The Kewaskum 4x400m relay team ran their fastest time of the season by over 10 seconds Friday night. All the athletes from the different schools line up around the perimeter of the last turn of the track and form what they call "the wall" and loudly cheered for their respective team members of the 4x400m relay teams as they rounded the track heading towards the finish line.

The Kewaskum relay team of Darrell Woebeking, Chris Canter, Luke Kehres, and Jesse Boegel each ran their fastest 400m splits of the season as they finished fourth with a season best time of 3:40.6. The effort by each of these four athletes was great.

Friday night was the first time Canter ran on the 4x400m relay team and the other three relay members responded by running great. Each of them dropped 1-2 seconds per 400m split. The coaches were very proud of their efforts. The only way

an athlete will get better is by a lot of hard work and giving that kind of effort every time they run. Boegel recorded the fastest 400m split of the group with a time of 53.5 seconds.

The 4x100m relay team of Jim Thelen, Chris Canter, Tony Fitts, and Charlie Sparks finished fourth with a 46.6 seconds, just 0.1 seconds behind third place conference foe Sheboygan Falls. Southern Door won the 400m relay with a time of 45.5 seconds.

The 4x800m relay team of Darrell Woebeking, Troy Kedroske, Kurtis Cochran and Chris Baker placed eighth with a time of 9:48.8.

"We definitely had a lot of good efforts and results. Their progress and success

is the result of their hard work," stated the coach.

Kewaskum next competes Thursday, May 11, at Plymouth High School at the Eastern Wisconsin Conference Track and Field Championships. Field events and the 4x800m relay start at 3:45 p.m. (girls first, then boys). The boys throw the shot put and the girls throw the discus first. Girls high jump first and the boys pole vault first. Open pits will be used in both the long and triple jumps. Trial in the high hurdles, 100m dash and 200m dash will be held immediately following the boys 4x800m relay. Finals start 15 minutes after the trials.
