Tighter Security at KHS Due to 2nd Bomb Threat

A second threat of a bomb at Kewaskum High School had administrators prompting for tighter security in the school Friday morning.

Officials say that the threat was again found in a bathroom by a custodian. This time on a roll of toilet paper that said "There is a bomb." Police were notified at around 7:20 a.m. The threat was written on the middle of the roll with what appeared to be a black marker type pen as it bled through several layers of the roll.

The bathroom was searched but nothing was found. It is uncertain there was no date of the message so it is uncertain when it was written.

Teachers were contacted individually and told to look for anything suspicious. Custodians looked in waste receptacles. After nothing was found it was decided to continue with school for the day as usual.

A letter has been sent to all parents regarding the issues and the tighter security measures.

■ Students will not be

allowed to enter the building until 7:30 a.m.. School starts at 7:45 a.m.. Students could previously enter the building at 6:30 a.m..

■ The school will be locked at 3:30 p.m.

■ A hall monitoring system is being set up so a record of student movement will be on hand.

■ The walking program for the community is being discontinued until further notice.

■ Restrooms will be checked more frequently and regularly between classes.

"Be assured that we will do whatever is necessary to assure the safety of our students and staff," said KHS principal Bob Ganka in a letter to parents.

No leads have been found as of this printing. Anyone with any information can contact the Washington County Chief's Tip Line at 1-800-232-0594. All information is confidential and informants can receive up to a \$1,000 reward.

On Tuesday the Fond du Lac Reporter reported on an incident that took place Monday at Laconia High School in Rosendale where students were evacuated

due to a bomb scare. A bomb threat was discovered in a girls bathroom.

Ironically the threat was similar to Kewaskum's first threat. The note in Laconia's bathroom scrawled on a stall in the bathroom, read, "There is a bomb."

In response, all 365 Laconia students and 30 or more staff members were taken to the nearest school - Rosendale Primary School.

The official Laconia High School emergency plan calls for students to go there first but to transfer to Rosendale Intermediate School a few blocks south if they expect to be there more than one hour.

Due to the lunch-hour timing of the incident and Monday's severe weather, which included high winds, pea-sized hail in western Fond du Lac County and a tornado watch, school administrators decided not to shuffle students to the Rosendale Intermediate School.

Students stayed in the hallways of the Rosendale Primary School rather than the gym.

The Rosendale Fire Department, Rosendale police and the Fond du Lac

County Sheriff's Department cooperated in the effort to search the building. Monday's bomb threat

was Laconia's third in two years. A threat was found in 1999 just before graduation and a second last spring.

Two Injured Sunday As Pickups Collide

TOWN OF KEWASKUM- Two members of a Menomonee Falls family were injured Sunday afternoon when they were broadsided by an on-coming pickup truck.

The accident occurred on Sandy Ridge Road at the County Road H intersection, just outside the village.

Authorities say Steven J. Czerniak, 56, of Kewaskum was proceeding north on Sandy Ridge Road, approaching a stop sign. According to the

Washington County Sheriff's department, Czerniak collided with a vehicle driven by Thomas M. Snuggs, 46, of Menomonee Falls, in the intersection. Snuggs and his two children were proceeding westbound when they collided with Czerniak's vehicle.

Snuggs' vehicle went off the roadway striking a stop sign and coming to rest in a plowed field.

Snuggs and his 11-year-old son were transported to St. Joseph's Community Hospital with non-life threatening injuries. They were treated and released.

We Apologize...

The Kewaskum High School student (whom we chose not to identify) shown in last week's Kewaskum Statesman having his backpack checked following the first bomb threat at the school, was chosen **AT RANDOM** and was in **NO** way, shape or form, guilty of any misconduct.

The photo (the lightest and most clear of three other shots) was used only to show that police officers and school personnel were, as a precautionary measure, checking the backpacks and purses of **ALL** students at the doors.

The student shown in the photo just happened to be the one checked at the time. Please **DO NOT ASSUME** he was guilty of any wrongdoing, just because that photo was the most printable. We sincerely apologize to the student and his family for any distress this may have caused them.

This newspaper was specifically invited to the high school at the time of the bomb scare to assure parents and taxpayers that a **NO-NON-SENSE** approach was taken during this difficult situation and it was handled efficiently and diligently. The entire school district received the brunt of some "media notoriety" and we felt they deserved some positive reinforcement.

This newspaper constantly seems to be between the proverbial "rock and a hard place." Subscribers voice outrage when we do not put

School Start Date Survey Deadline is April 30

When should a school start school? Current state law prohibits any school in Wisconsin from starting school before September 1 unless there is a public hearing and a vote by the School Board to start prior to September 1. The difficulty with this is the public hearing and final decision cannot be made until **AFTER** July 1. If you have children, or if vacation or summer plans are contingent on school calendars, the July 1 final decision date causes many problems in the construction of the calendar, particularly if a district wanted to begin before September 1.

On Friday, April 20, approximately 4000 surveys were mailed to every home and business in the Kewaskum School District. The survey seeks input from

the community at large regarding the start of school in Kewaskum. The basic question is "Should it begin before September 1, or after September 1?" While the survey is non-binding, the larger the number of responses, the more direction will given the Board of Education in making a decision on this issue.

A letter explaining the need for the survey accompanied the survey and an envelope the recipient could use to return the completed questionnaire. If you don't remember receiving it please recheck your incoming mail of the past week and then take the time to complete the survey. Please mail it back not later than April 30. Your involvement is critical in this most important matter.

Construction Begins on School Administration Building



Construction on the school district's new administration building has begun. The plans call for a board room/community meeting room on the south end which will hold about 100 people. Kitchen and bathrooms will be available for use by those on the administrative side and individuals using the community room. The administration offices will be able to be locked off by those using the community room/board room. There will be a foyer entry way that a person can enter and move either to the meeting room side or turn right to the receptionist's office. The building will have actual offices rather than the current partitions in the trailer office that now houses the district office. The offices will be wrapped around a work-room in the center of the building. The exterior will be brick and there will be a smaller version of a front overhang like the new KES entrance. The current administration building parking lot, will later be the very west end of the KES parking lot. Exit will be to the west on 2nd street, which will be one way. The side drive on the south end of KES will be one-way west leading into the parking lot. When the old KES is torn down that will become green space and a softball diamond will be built on the northwest corner of that space. Superintendent of Schools Wayne Graczyk stated "We are figuring to be in the new building in mid to late August. In the meantime we'll be in the new KES building."

Youth Options Students Enjoying Technical College Experience

Students involved in the Youth Options program at Moraine Park Technical College are not only working toward a degree but are also receiving high school credits at the same time.

Since Moraine Parks Youth Options program started in August 1998, it has been greeted with great success. There are Youth Options students in several programs on each of the college's three campuses. Currently there are students enrolled in the Culinary Arts, Barber/Cosmetology, Tool and Die Making and Administrative Assistance programs.

"The instructors are easy to get along with and there are many things to do with-

in the Culinary Arts program and club. You could never get bored with the program and you can go at your own pace," said Katie Jastrab, a senior at Slinger High School, and a student in the Youth Options Culinary Arts program. According to Josh Gellings, a Campbellsport High School senior, "I chose Youth Options because I wanted to see if being a chef would be a good job to be in. I enjoy the lab time to create."

Students in the Youth Options program are given the opportunity to earn both high school and college credits while they are still attending high school. The school district allows students to enroll in college courses if the high school is unable to offer comparable classes. Students can earn college credits while on the track to their high school graduation. These students are given the opportunity to acclimate themselves to the college environment and prepare themselves for a career.

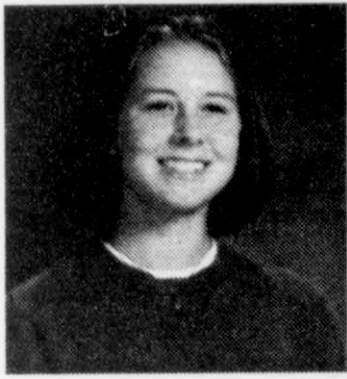

TYPE OF PLASTIC: Plastic Bottles - Normally used in 2 liter soda bottles.

HINT: P.E.T. bottles will carry the #1 emblem stamped or molded on the bottom.

PREPARATION: REMOVE CAPS AND RINGS AND RINSE CLEAN. This is the most important aspect of a successful recycling program. Bottles that contain liquid residue cannot be recycled. Place #1 plastic bottles in your dark green recycling bin or blue recycling bag along with the other recyclable items. Place bin or bag at the curb on the same day that your solid waste is to be collected. Pick up will be Wednesdays for both solid waste and recyclables. Multi-family dwellings of six or more, remember, your recycling pick up will be the 1st and 3rd Wednesday of each month.

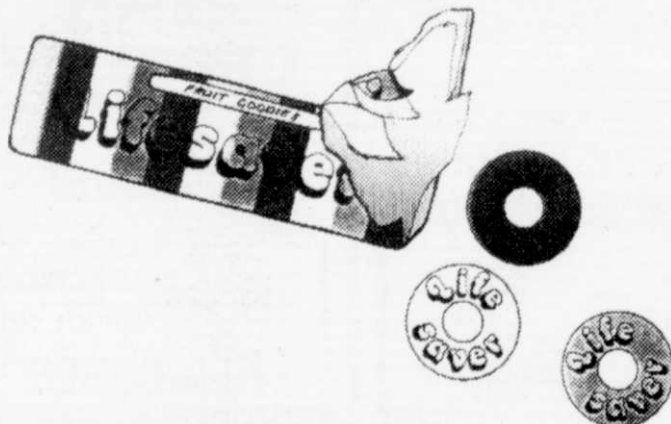

News From The Capitol

Not Time to Get Rid of the First Amendment

As a state legislator, normally I use this space to discuss state issues. But a shocking development in Washington a few weeks ago demands attention.

Congress was debating the McCain-Feingold campaign finance reform bill. Personally, I find it amusing that Senator John McCain, one of the Keating five involved in the Savings and Loan scandal and Senator Russ Feingold who in his last election was fined a whopping \$9,000 for failing to report campaign contributions would have the nerve to get out in front on this issue. It would seem they should establish a track record of obeying current laws before they try to pass new ones.

When the law was first proposed, Minority Leader Gephardt from Missouri boldly stated that we may have to change the First Amendment. I realize that some campaign television ads are too negative. While they are not as irritating as ads for psychics, 900 chat lines, or ads for embarrassing health problems, there are an awful lot on television. But the idea that the First Amendment would have to be changed to prevent NAACP, AFL CIO, National Right to Life or the National Rifle Association from running ads related to political campaigns is so absurd I assumed Representative Gephardt just had a bad day and made a foolish off-the-cuff comment.

However, during the debate on this issue, Senator Fritz Hollings from South Carolina actually tried to push through an amendment to the United States Constitution restrict-

ing the right to free speech!!!

The amendment would allow "reasonable limits" in expenditures made in support to political candidates. This amendment was clearly designed to allow passage of laws restricting the ability of groups like labor organizations, farm groups, or pro-life groups to present their side in political campaigns. In the past, their rights to buy radio time, newspaper space, etc. was always considered protected by the Bill of Rights. The right to free speech was not designed to protect X-rated bookstores, obscene language or nudity in public parks. It was designed to protect an individuals' or groups' ability to speak openly about political races.

Even more shocking was that forty U.S. Senators apparently felt the Bill of Rights was outdated and voted for this outrageous amendment. To their credit, even though the purpose of the amendment was to support the McCain-Feingold bill, neither Russ Feingold nor Herb Kohl was among the thirty-seven Democrats or three Republicans who voted "yes."

Fortunately the amendment failed 40 to 56. But what has become of our country when forty U.S. Senators in essence vote against the First Amendment to the Constitution. And, where are our newspapers that either didn't cover this attack on the Constitution or buried it deep in their newspaper? These forty senators shouldn't have even been given a passing grade in high school civics much less serve in the United States Senate.

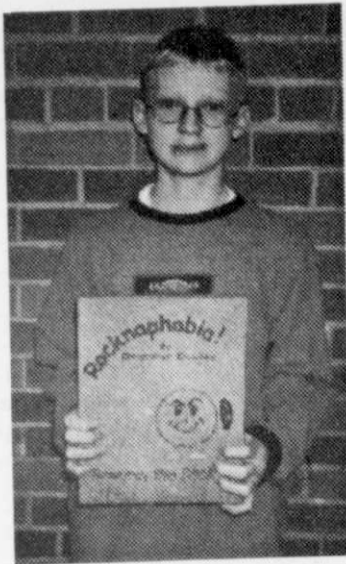

FES Authors Capture Awards

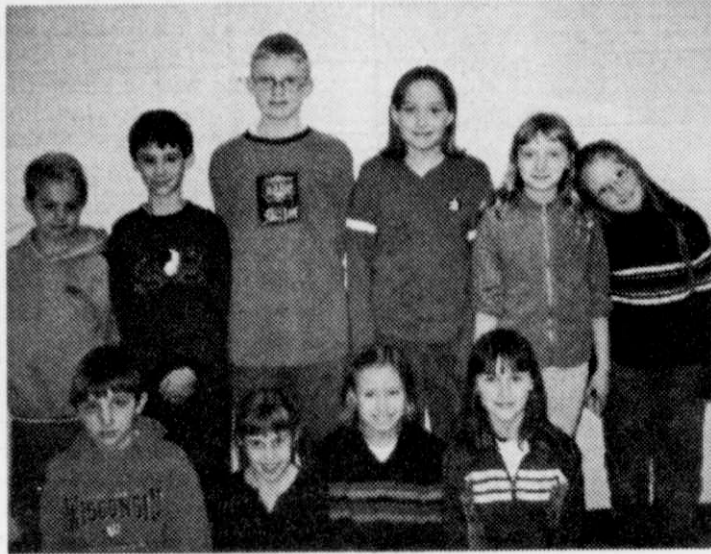

Dear Editor:

The Village Board received a summary of the village financial situation on Monday, April 16, and while your paper will also print the minutes of that meeting I would like to highlight some of the positive features for you and your readership.

Every year the village finances are audited by an independent firm as mandated by law. The auditor reports on two general topics: the way the village keeps its financial records and the monetary strength of the village. Audits in the past complimented Kewaskum on its finances and this year was no different.

Kewaskum received the auditor's highest rating for the state of its financial records. Beyond the strict record-keeping guidelines Wisconsin demands of its municipalities a strong rating of this kind requires special effort and scrutiny. It also ensures to the people of Kewaskum that public funds are received and spent exactly as reported.

The auditor also gave Kewaskum a very favorable review of its financial health and stated a number of specific examples. The auditor reported that Kewaskum spends its money typically for a Wisconsin municipality with over one-third of the village budget devoted to public safety. The auditor described how they have worked with other municipalities that were forced to implement massive water/sewer rate increases because of an inability to manage rising costs while Kewaskum has been able to avoid that. The auditor also reported that Kewaskum has a very low public debt in comparison to other municipalities in Wisconsin and in the United States.

The positive review calls for some recognition. The auditor's findings reflect that the people we have charged with managing the various village budgets are doing a good job. Congratulations to Village Administrator Dan Schmidt, Fire Chief Mark Groeschel, Police Chief Richard Knoebel, Director of Public Works Jerry

Gilles, Head Librarian Steev Baker, Deputy Clerk/Treasurer Janet Knops and Water Treatment Manager Bob Manthei for a job well done. The auditor's report also reflects the value and contribution of all who serve Kewaskum. All village employees should get an extra-special "thank you" for always giving the village their best efforts. Kewaskum could not be as financially strong without the dedication and sense of service by everyone involved.

The people of Kewaskum deserve to know how their money is being spent and it is good to hear it is being spent carefully and wisely.

To date I am still 100% disabled, unable to be hired any place that could provide family health insurance benefits. This is not like a layoff, where you are able to seek other employment the next day. I did get hurt on this job, of which I can no longer return to.

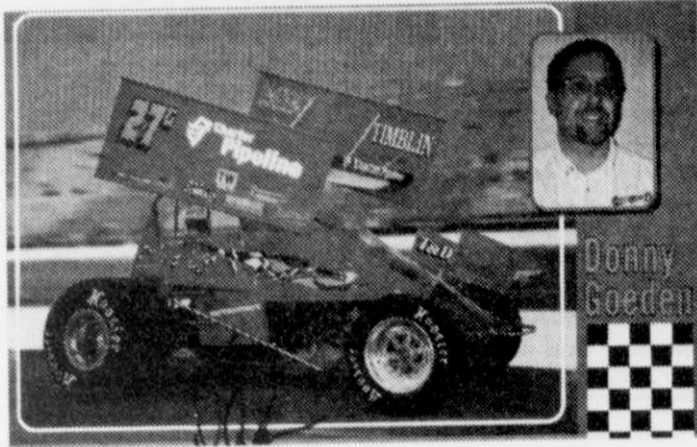

Goeden Wins IRA Feature at Hales



The Charter Pipeline/T&D Jewelry #27g sprint went to the winner's circle on Saturday evening at the third mile dirt oval track at Hales Corners, Wisconsin. Don Goeden, the 1999 Interstate Racing Association (IRA) Champ, was the chauffeur with a last lap daring maneuver in the outside groove with lapped traffic, Goeden won by a half a car length!

Goeden has the Hales track down to a science. (So did his Dad, Willie!) In hot laps, the #27g sprint car had mechanical difficulties. Having to come out ninth in a field of 48 sprints in the timing order, proved to be the right thing to do. As the qualifying continued, the track conditions changed and became slick. Goeden took the fourth qualifying spot, with the top position going to Wilmot's Dave Molis, champion of the Wilmot Fair Grounds Speedway.

With 24 cars starting the main event, Goeden had to start in the second row outside, as they invert the top six qualifiers, if they finished in the top four positions in the 10 lap heat races. (Goeden finished third in his heat.)

On the first lap of the 30 lap feature, going into the first turn, outside pole sitter Todd Hoepner drove his #28 to the inside and left the outside groove wide open for Goeden to get a run in the second turn and take the lead on the first lap. "I couldn't believe it!" said Goeden. "All I saw was clear track and I took advantage of it."

By the fourth lap, with Todd Hoepner and Molis about a quarter of a lap behind, Goeden started lapping the slower sprints cars. This helped the other fast competitors such as Al Winker, Kim Mock, Hoepner, Molis and Joe Roe to catch up and make it a race with-in a race.

With four caution flags and lapped traffic, Goeden took the high groove on the track and was able to hold on to the lead until the 2000 IRA Champion Joe Roe of Kenosha found "bit" on the inside groove of the track. (Roe had lined up in seventh position.)

Goeden was held up with the slower traffic using the outside groove. With three laps to go, Roe took the lead. The battle was tight, as the lapped traffic continued to play a big part in the race.

Roe took the white flag lap with Goeden in hot pursuit! In turn two Goeden took the outside groove and Roe stayed on the inside. With the slower cars in the thick of it, Roe again took the lead in the third and fourth turn, only to see Goeden "fly-by" on the front straight-away to take the checkered! It went so quick, even the scorers had problems scoring the "hold-your-breath" finish.

Talking with the crew later, they said, "We needed this one. And so did Donny. He still has what it takes! He inherited that Goeden blood." Said Brian Stern of Fond du Lac, "We worked hard in between every event tonight. It feels good to see Donny out there again." Said Dean Wetzel of Green Bay, "yes, man. It was great!!! We put in so many hours to get this car ready." Cheered Julio Hammes of Kewaskum, "Donny worked hard on the track and did what he had to do, and we did what we had to do. "Yes!" Terry "Web" Weber, the driver of the four-wheeler push-vehicle stated, adding, "it's good to be racing again. Don did a great job. I couldn't go to the first IRA race in Attica, Ohio. I'm glad I could be here to see this win." Goeden had taken a year off for family and to regroup.

Crew chief and brother, Dave Goeden was very mellow about the win. "Yes, it was a team effort. Don loves this track and he never gave up. Other drivers might have given up after getting into the slower traffic, but he just stayed focused...all 30 laps! We all worked hard

the last few months and the win was for all of us. But Don is the one with his life on the line when he gets behind the wheel of that sprint car."

This will be the last year for the most popular dirt track in the Milwaukee area. It would be only fitting to have Goeden win. On the side of his wing panel on the sprint car, Goeden had printed a note to the owner/promoter of the track, John Kaischen. "John K. Thanks for the memories."

After the races, John went to the Goeden pits to get some pictures with the sprint car and sign. "Yea, that was very nice of Donny. He probably remembers when his dad Billy, raced here every Saturday night for many years. The sign was a good gesture."

Later Don Goeden said, "I felt it was only right to do something for John. we do so well here and I will miss this track."

Don commenting on the race said, "I guess it was exciting!!! I wish I could have a tape of the race...or just the last three laps!! We have had our share of problems, so this win was great. The IRA schedule is tough. We have to thank the sponsors. To be competitive in this division takes equipment and the monies to continue to go to the next event. Tires and motor are two big factors."

The sponsors on the T&D Motorsports #27g of Eldorado, Wisconsin are: Charter Pipeline; Tom Hutter of T&D Jewelry; Interstate Welding Supply; Orv's Pizza; Electro-Plating; Service Motors; Pro-Motorsports and the Parts Centre, all from the Fond du Lac area; Eldorado Trailer Sales of Eldorado; Trev Timblin Trucking and Grand Larsony of Kewaskum; Bero Motors of Escanaba, Michigan and Klein Engines of Tempe, Arizona.

Next week the IRA will compete on the half mile clay track at the Dodge County Fair Grounds on Hwy. 33, about two miles east of Beaver Dam.

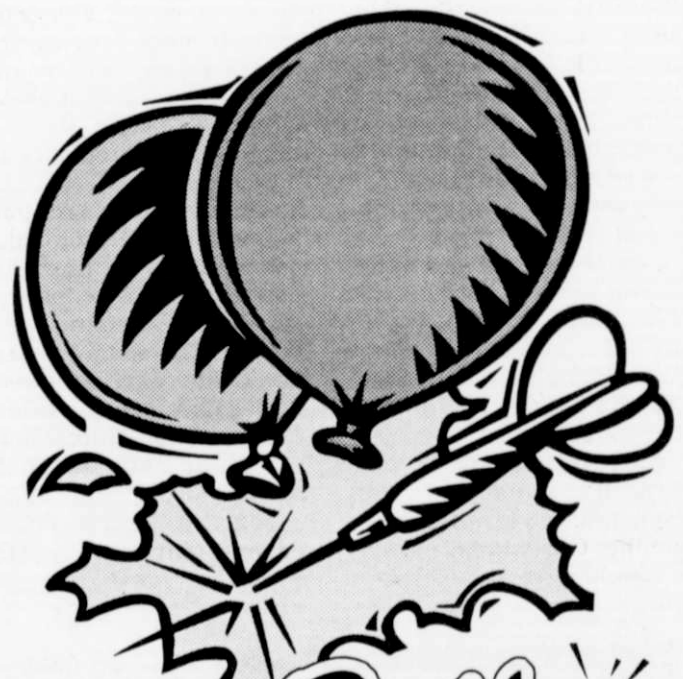

Boys Varsity Golf Team Taps Into New Season With Fourth, Fifth Place Finishes

Members of the Kewaskum High School varsity boys golf team opened their season by participating in three team tournaments during this past week.

All three invitational tournaments featured some of the state's best W.I.A.A. Division One and Two teams. Therefore, the Indians found out early if they are currently capable of competing against some of the traditional powers in Wisconsin high school golf.

Six Indians traveled to Horicon to play in the Marshland Invitational at Rock River Hills on Wednesday, April 18. Nine area teams from seven different conferences participated in the annual 18 hole medal play tournament.

The weather and playing conditions were excellent as the golfers enjoyed a warm (50's), fairly dry, sunny and calm day with well manicured greens and bunkers.

The overall team scores and the weather improved dramatically from the previous two years as Kewaskum and Pewaukee attempted to regain or defend their respective titles in 1999 and 2000.

The Indians recorded the second best nine hole total, but the Pirates overcame the Indians by tallying three of the top four individual scores to win the tournament. The local linksters improved their team score by 20 strokes over last season. Unfortunately the competition did likewise as Pewaukee's winning score was nearly a 30 shot improvement from their previous championship team total.

Individually, senior Jon Boedecker and junior Ty Wietor recorded rounds of 81 and 85 to finish with two of the top ten tallies to help the Indians to their second

consecutive fourth place finish at Horicon.

This solid start gave Kewaskum confidence going into Thursday's Grafton Invite conducted at the Country Club of Wisconsin, where the Indians won the 2000 title.

The eight team field includes six Division One powers, including five that qualified for last year's WIAA State Tournament and host Grafton who finished second in Division Two in 1999. Thus, Kewaskum failed to defend their title on a cool and windy day on the front nine (par 36) of the natural prairie layout.

Congratulations to Hartford Union High School as the Orioles nipped the Blackhawks of Grafton by one, 165-166.

Needless to say, this annual tournament and golf course proved to be very challenging, as none of the Indians were able to break 45, resulting in a fifth place finish. Both Kewaskum and Hartford were headed to Saturday's Washington County Invitational Golf Tournament at the County Golf Course.

Kewaskum and Hartford have won the county title in the first two years of its existence. After nine holes, the Orioles and Indians recorded the top two team totals, but Hartford ended up blowing away the field on a very blustery day at the Washington County Golf Course near Hartford.

West Bend East and Germantown overcame the Indians early nine-hole lead as the local linksters concluded their play in fourth place.

Each high school team within the county brings eight competitors with the top seven scores counting

toward the team title. Hartford easily outdistanced the rest of the field by registering the top five individual scores to win going away. Unfortunately the Indians could not maintain their first round position as the winds consistently blew between 40 and 45 miles per hour with gusts over 50 miles per hour.

Kewaskum was led by seniors Jon Boedecker, Dustin Melzark, Luke Reindl and junior Ty Wietor recorded similar scores. Junior Andy Bauer and sophomores Brian Mertz and Josh Timblin gained valuable varsity experience heading into Eastern Wisconsin Conference play next week.

The wind and talent of Hartford turned out to be too much to overcome. Yet, Kewaskum now knows what the level of golf the Indians must strive for to achieve late season success.

Prior to starting their EWC season, the Kewaskum Indians were to contend for the Oak/Lion Invitational at the Golf Club at Camelot on Wednesday, April 25. This tournament was to include 24 teams, of which eight were scheduled within the Division Two Regionals at Quit-Quit-Oc and Sectionals at Camelot.

Therefore this annual competition was beneficial to determine area schools that the Indians must be capable of beating in order to advance through the W.I.A.A. Tournament Series in late May and early June.

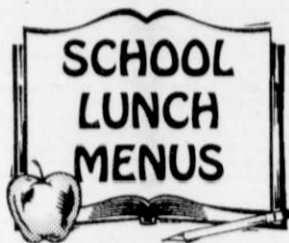

No person may appear before the Board of Review, testify to the Board by telephone or contest the amount of assessment unless, at least 48 hours before the first meeting of the Board or at least 48 hours before the objection is heard if the objection is allowed because the person has been granted a waiver of the 48 hour notice of an intent to file a written objection by appearing before the Board during the first two hours of the meeting and showing good cause for failure to meet the 48-hour notice requirement and files a written objection, that the person provides to the Clerk of the Board of Review notice as to whether the person will ask for removal of any Board members and, if so, which member will be removed and the persons reasonable estimate of the length of time that the hearing will take.

When appearing before the Board, the person shall specify, in writing, the persons estimate of the value of the land and of the improvements that are the subject of the persons objection and specify the information that the person used to arrive at that estimate.

No person may appear before the Board of Review, testify to the Board by telephone or subject or object to a valuation; if that valuation was made by the Assessor or the Objector using income method; unless the person supplies the Assessor all of the information about income and expenses, as specified in the manual under Sec. 73.03(2a), that the Assessor requests. The Village of Kewaskum has an ordinance for the confidentiality of information about income and expenses that is provided to the Assessor under this paragraph which provides exemptions for persons using information in the discharge of duties imposed by law or of the duties of their office or by order of a court. The information that is provided under this paragraph, unless a court determined that it is inaccurate, is not subject to the right of inspection and copying under Section 19.35 (1) of Wis. Statutes.

The Board shall hear upon oath, by telephone, all ill or disabled persons who present to the Board a letter from a physician, surgeon or osteopath that confirms their illness or disability. No other person may testify by telephone.

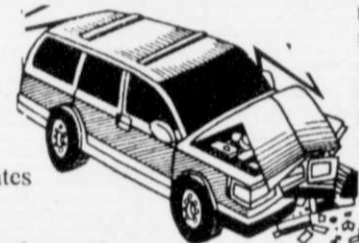

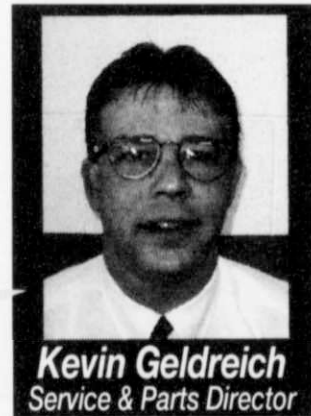

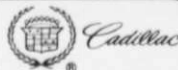
