Dead Man Found in Vehicle at New Fane Trail Entrance

A 41 year old male was found dead in his car that was parked in the parking lot of the New Fane hiking trail late Tuesday morning. He was found by two hikers who noticed him in the vehicle.

The man, who's name could not yet be released is from out of the county according to the chief investigator for the Fond du Lac County Medical Examiner's office.

Foul play is not suspected. An autopsy is being performed but the results are not yet available.

As another school year begins, I would like to begin with a big "Thank You" to the supporters of our schools here in Kewaskum. When school begins, students in Kewaskum will be housed in our new elementary school. In addition, our new administration/community building will be open for administrative offices, School Board meetings and will serve as a community meeting area.

Whether you cast your vote for or against the referendum in April of 2000, our new buildings are there for all to see and be proud of. Community members might want to mark down Sunday, October 7, 2001, from 12:30 - 3:30 p.m. as the date for the dedication ceremony for the new KES and Administration/Community Building.

With the start of the 2001-02 school year, our theme and emphasis will be "Planning for Achievement." I would like to remind everyone that most school information can be obtained by going to our school website at www.ksd.k12.wi.us. Schedules, athletic events, calendars, etc., is all there so visit us at your convenience.

Transportation: Johnson Bus Company will be sending out information soon on bus rules and pick-up times. If you haven't received information by August 24, please call them at 626-4414 to make or verify transportation arrangements.

Families are encouraged to review the bus riding rules and safe boarding, riding and unloading procedures together. If this is your child's first experience riding a bus, parents may want to take a little extra time and accompany their child or arrange for someone else to accompany them for their first pick-up and drop-off.

Crossing guards will be present on village street corners. Parents and students are urged to use them accordingly. It is extremely important for parents to cooperate with the schools by not sending or dropping their children off at school before school doors open since they will be unsupervised. Also, while parents may be curious about the new KES, please wait to see the building after school or during the scheduled Open House or at the Dedication Ceremony. This will go a long way in eliminating confusion on the first day of classes.

Free and Reduced Hot Lunch Program information will be published in the Statesman. Registration

forms were available during registration for those interested. This program is critical to our school district's finance system. Federal and State Grant programs such as Title 1, SAGE, etc., as based on the percentage of students enrolled in the Free and Reduced Hot Lunch Program. If you think you are eligible, or aren't sure, please request that a form be sent to you by calling your child's school office.

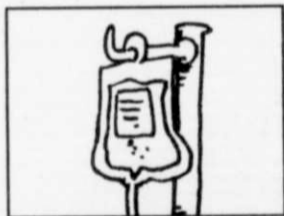
Hot Lunch prices for the 2001-02 school year are as follows: Elementary schools, \$1.30 per day or \$6.50 per week. Middle School and High School students pay \$1.50 per day or \$7.75 per week. School begins with a full day on Tuesday, September 4, is a full day and hot lunch will be served. The calendar for the school year will be distributed, one per family, on the first day of school.

The school district DOES NOT carry accident insurance for students. We encourage parents/guardians to review their own insurance policies to be certain that coverage is adequate, especially in the case of athletics.

Kewaskum School District Official Notice Non-Discrimination Statement and Discrimination Complaint Procedure

The Kewaskum School District is committed and dedicated to the task of providing the best education possible for every child in the District for as long as the student can benefit from attendance and the student's conduct is compatible with the welfare of the entire student body.

The right of the student to be admitted to school and to participate fully in curricular, extracurricular, student services, recreational or other programs or activities shall not be abridged or impaired because of a student's sex, race, national origin, ancestry, creed, pregnancy, marital or parental status, sexual orientation or physical, mental, emotional or learning disability.

Complaints regarding the interpretation or application of this policy shall be referred to the District Administrator and processed in accordance with procedures established by the Discrimination Complaint Procedure.

Discrimination Complaint Procedure

Any complaint regarding the interpretation or application of Kewaskum School District's student non-discrimination policies shall be processed in accordance with the following grievance procedure:

1) Any student, parent or resident of the School District complaining of discrimination on the basis of sex, race, national origin, ancestry, creed, pregnancy, marital or parental status, sexual orientation or physical, mental, emotional or learning disability in school programs or activities shall report the complaint in writing to the District Administrator.

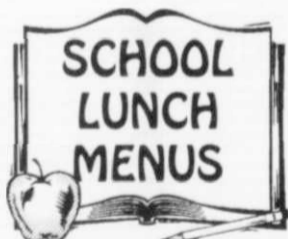
2) The District Administrator, upon receiving a written complaint, shall immediately undertake an investigation of the suspected infraction. The District Administrator will review with the building principal, or other appropriate persons, the facts comprising the alleged discrimination. Within 30 days after receiving the complaint, the District Administrator shall decide the merits of the case, determine the action to be taken, if any, and report in writing the findings and the resolution of the case to the grievant.

3) If the grievant is dissatisfied with the decision of the District Administrator, he/she may within 15 days, appeal the decision in writing to the School Board. The Board shall hear the appeal at its next regular meeting, or a special meeting may be called for the purpose of hearing the appeal. In either case, the Board must hear the appeal within 45 days of its receipt. The Board shall make its decision in writing within 15 days after the hearing. Copies of the written decision shall be mailed or delivered to the grievant and the District Administrator.

4) If the grievant is dissatisfied with the Board's decision, he/she may within 30 days appeal the decision in writing to the State Superintendent of Public Instruction.

5) Discrimination complaints relating to the identification, evaluation, educational placement or the provision of a free appropriate public education of a child with exceptional needs shall be processed in accordance with Wis. Stat. Ch. 115, Subch. V and Wis. Admin. Code Ch. PI 11.

6) Discrimination complaints relating to programs specifically governed by federal law or regulation shall be referred directly to the State Superintendent of Public Instruction.

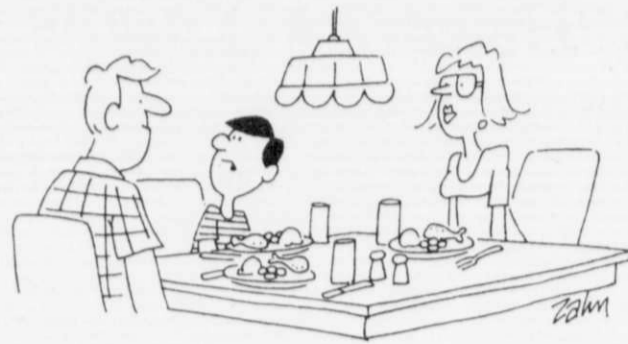

Food Package Dates Can Be Confusing

MADISON - If you are baffled by "sell-by" and "use-by" dates stamped on food products, don't feel alone. These statements are confusing to many consumers.

Food safety expert Mike Barnett says manufacturers date food packages to tell consumers how long food items remain at their highest quality and by what dates consumers should purchase products. Products purchased at the peak of quality are less likely to harbor significant amounts of food-borne, disease-causing bacteria and spoilage.

Here is a run-down of what those statements

mean:

Sell-by - Try to purchase products before the "sell by" date expires and use as soon as possible. Products that carry this date are often perishable foods that require refrigeration like fresh meat, poultry, seafood, dairy products, eggs and fresh vegetables. Hamburger, for example, must be used within one - two days after purchase. Ground meat should be thrown out after two days because it spoils rapidly and bacterial levels rise to harmful levels after 48 hours. You can store fresh meats for several months if you freeze them before the "sell-by" date.

Use-by - Manufacturers set dates for each product based on scientific testing results. Barnett says that most dry and canned foods will remain safe to eat after the "use-by" date, although quality will decline slowly. Refrigerated fresh foods deteriorate rapidly and must be used by the "use-by" date.

Best if used by (or before) - Try to use products before this date, or freeze if possible before the date expires. Many foods remain safe after the "best if used by" date, though quality declines over time. For example, milk stored in the refrigerator at 40 degrees F or less should remain safe to

drink even after the "best if used by" date, as long as it has no off flavors or odors.

Barnett says that with proper handling and storage, food products will remain fresh and wholesome at least until the date stamped on the product. Many foods will remain safe to eat beyond the package date if frozen or refrigerated.

"Again though, just as a word of caution, consumers should use highly perishable products like fresh meat, poultry and seafood before any date on the package," Barnett says. "If you have any concerns about the safety, quality or freshness of food, either do not purchase it or discard it."

Application are available at all five school offices. To apply for free or reduced price meals households must fill out the application and return it to the school. Additional copies are available at the principal's office in each school. The information provided on the application will be used for the purpose of determining eligibility and may be verified at any time during the school year by school or other program officials. Applications may be submitted at any time during the year.

To obtain free or reduced price meals for children for whom households receive Food Stamps or Wisconsin Works (W-2) benefits, an adult member needs only to list the names of the school children, give Food Stamp or W-2 case number for each child, sign his/her name and return the application to the school office. Households must inform the school authorities when they no longer receive food stamps or W-2.

For the school officials to determine eligibility for free or reduced price meals or free milk of households not receiving food stamps or W-2, the household must provide the following information requested on the application: names of all household members, and the social security number of the adult household member who signs the application. In lieu of a social security number, the household may indicate that the signer does not possess a social security number. Also, the income received by each household member must be provided by amount and source (wages, welfare, child support, etc.). Households are required to report increases in income of over \$50 per month or \$600 per year and decreases in household size.

Under the provisions of the free and reduced price meal policy, the Food Service Director, Kathy Robinson, 262-626-8427, ext. 4118 will

The incoming freshmen girls recently wrapped up their basketball season. The girls have been playing together since December, after their eighth grade season ended.

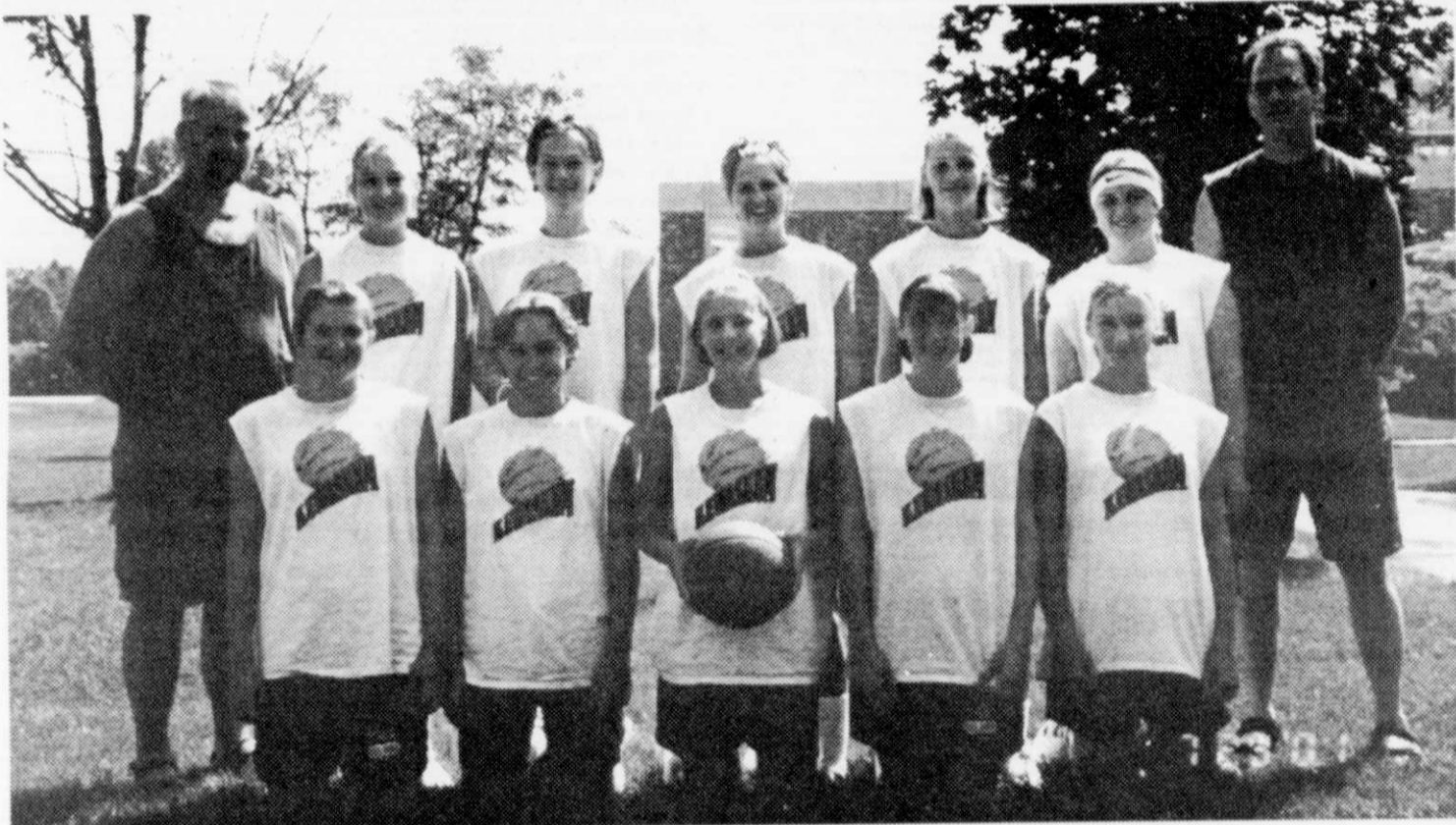
They have competed in various tournaments, scrimmages, the Badger State Games and a summer league. They have made tremendous progress as individuals and as a team.

News From The Capitol

Living Off Credit

We are told that Americans have some of the lowest savings rates in the world and that in some recent quarters we actually had a negative savings rate.

Some individuals who persist on going deeper and deeper in debt cause this. Rather than change their spending habits, they use a fourth credit card, take out a third mortgage, or go to a check-cashing agency. Eventually, of course, their crash will be all the greater for their refusal to stop spending.

One would assume that the type of people who run our state government would be more responsible. In fact, in this budget they have dealt with the downturn in state revenues with more spending than ever and reckless financial maneuvers one would expect only from a spendthrift on the verge of bankruptcy.

The state was to receive approximately \$140 million per year from tobacco companies who were sued for health problems related to smoking cigarettes. In order to balance this budget a future stream of this revenue was sold to get a one-time \$450 million fix. This \$450 million not only will be unable to be repeated in the

next budget but results in a \$100 million less in revenue next time.

Much of your income and sales tax dollar is returned to local school districts with one payment being made before the fiscal year end in June of 2003. The state will delay paying \$115 million, which the school district should have gotten in June until July in the following fiscal year. The state will also restructure their debt in the next two years delaying \$100 million in principal payments which were scheduled to make.

The state by law should have approximately \$160 million in reserve at the end of the biennium to guard against future revenue shortfalls. In the budget just passed, this amount was reduced to \$90 million. The state also took advantage of a the controversial federal intergovernmental transfer program to fund \$220 million in this budget which will almost certainly not be available next time. The above results in the state balancing this budget with over a billion dollars which will not be available to it two years from now. If a private company engaged in such financially irresponsible activity, the bank

would have shut off their credit a long time ago. Instead, legislators used this money to authorize over \$2 billion of new debt, a massive expansion of a school program to hire more teachers, and the second most generous prescription drug plan of its kind in the country.

The state faces a fiscal disaster in two years but the irresponsible spenders have sowed the seeds in the last two budgets.
