Budget Cuts Not Popular With District Residents

There was standing room only as parents, students, staff and administrators filled the Kewaskum High School cafeteria for Monday night's Special Board Meeting.

Residents gathered to hear the proposed \$1,004,478 in cuts the district needs to make in order to have a balanced budget for the 2002-2003 school year.

Residents were able to voice their opinions to the board and administrators for the first 45 minutes of the meeting. The general consensus from parents, staff and students was that it would hurt students to make these cuts.

KHS student Rebecca Mayan asked the board to respect their welfare and not just the budget. Many students worried that colleges would overlook their applications if they did not have extra-curricular activities, seeing as how that's a big thing college's look for. As another student pointed out, for all of her high school career she's been told to join as many activities as she can, and now with cutting them, how is she and students following behind supposed to?

Andy Breese, a junior at the high school also noted that in order to participate in sports students need to maintain a certain grade point average and if some athletes don't need to maintain their averages for sports they would have no reason to do well.

Gym teacher and high school athletic coordinator Jason Piittmann reminded the board to remember the district's motto "Where children come first." He pointed out that there are many benefits to activities and students are less likely to participate in illegal activities.

Kathleen Flaherty, reading specialist for the district, is concerned that with a half-time reading specialist

cut, 88 at-risk readers will not receive the services they need and may not be able to meet reading guidelines that the federal government is going to be issuing.

Pat Alvarado, KHS Spanish teacher and National Honor Society advisor pointed out all of the money and good things the NHS has done this year. The club raised \$600 for a NHS scholarship and \$900 for a general fund. The money they raised for the general fund is \$439 more dollars than budgeted for the year.

German teacher Therese Rosenthal stated that even if they eliminate German from the schools, students who have already started German are required to be allowed to finish at another school or through a college correspondence course, at the district's expense. She also pointed out the Kewaskum School District would be the only district to offer only one language in Washington County. She also wanted to clear up the fact that even with the elimination of the German program, she still would be an English teacher at the high school.

Middle school teacher Nikki Airaudi stated that the major bonds with students is after school and by taking away these activities there would not be that bond. She stated that she loves her job because she is able to make this bond with students and it would be a bad thing to lose this.

District parents and taxpayers also voiced very strong opinions. A few even suggested possibly raising taxes due to the fact that they have either been decreasing or staying the same from year to year.

Deb Strigenz stated, "I am very impressed with the education both my children and I have received in this district. However, this behavior is unacceptable," and would like the board to consider not making these cuts.

Sue Survis, another parent stated she was very embarrassed to read the article in the paper. "Your

This leads to another issue that was repeated many times throughout the night. If all of these cuts are made, how many students will leave the district with the open enrollment option? When students choose to take advantage of open enrollment, the district the student lives in pays a fee to the district the student enrolls in.

District resident Chris Cane advised the board to not be afraid to raise taxes "it takes good money to hire good teachers."

Farmington Elementary school parent Janet Luedtke was very emotional about this issue. She stated "The children are our future.

They are not dumb. This would be a great loss to take away these things. What we give them now, they will return." She further stated that she does not want the children to go off to college and never return to Kewaskum. She fears that if they are treated poorly now, this will happen.

Village President John Kenworthy pointed out how important these activities are. "I don't know where I'd be without extra-curricular activities. I learned to parse a sentence in English class, but I learned the love of writing working on the newspaper. My love of words came from the rhythm of hearing Shakespeare in drama and I learned hard work from sports. I wouldn't have gone to college without NHS."

Kenworthy further pointed out that this "may be a school issue today, but it will be a village issue tomorrow." He stated that he would have to find more funding for more police officers, find more places for parks and find other community activities for students to partici-

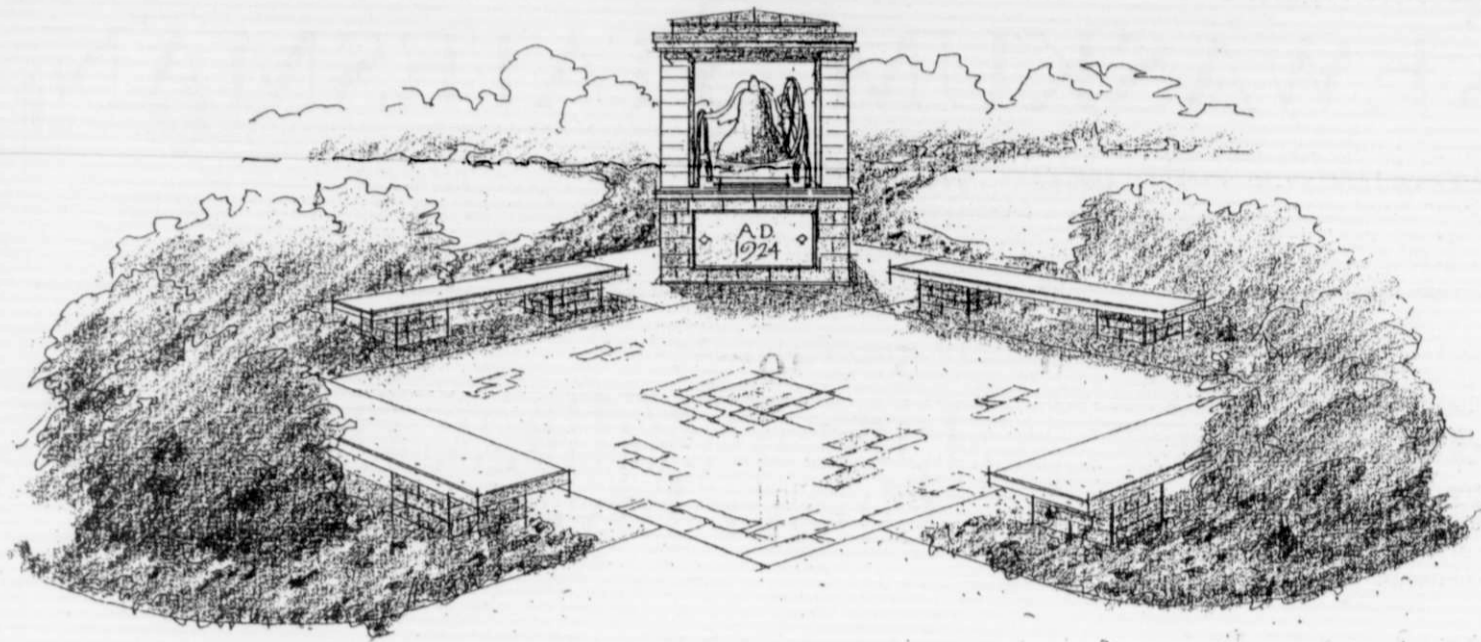

The Kewaskum Elementary School Parent / Teacher Organization is in the process of building a multi-functional space at the new elementary school. The area is to be to the southeast side of the school. The area will be called the "Richard Zarling Bell Tower."

The purposes of the space are:

- To remember Richard Zarling, past principal of KES. He was employed with the district for 36 years. He was also involved with the Kewaskum Auxiliary Police, was the Kewaskum Village Zoning Administrator and a member of the Kiwanis Club. In 1996, Mr. Zarling presented the children of the Kewaskum Elementary School with a bell that was removed in 1924 from the first village elementary school. The bell will be incorporated into this space.

- To remember the first Kewaskum High School,

which was constructed and finished in 1924. The old elementary school was the first high school in this community and graduated many area students. Last year the building was torn down to make room for the new elementary school. The original date stone, from the old high school, will be incorporated into this space.

- To create a space for the community to reflect and classrooms to learn. As you can see in the drawing above, the space will have four benches and a bell tower. A paved area will have bricks with the names of past graduates, friends and current students.

Bricks are 4x8 and are available for \$40 each. They can include up to three lines with 14 characters per line including spaces.

This space will enhance the new elementary school and provide students, parents, grandparents, alumni, school clubs, sports teams

and the general public an opportunity to pay tribute to and memorialize someone special. Don't delay!

The bricks may be purchased for a limited time only. Construction of the space is scheduled for this summer. Don't miss the fun and don't be left out. The deadline to order is JUNE 1, 2002.

Ashford Couple Charged After Drug Raid

A Town of Ashford man remains in the custody of the Fond du Lac County Sheriff's Department for charges of marijuana possession with the intent to deliver. His bail has been set at \$100,000 cash.

Vince Berry, 40 turned himself into authorities Wednesday night after his home on Highway 67 was raided Tuesday morning by a SWAT team that found approximately 20 pounds of marijuana.

That Tuesday afternoon Washington County Sheriff's deputies arrested Berry's 33 year-old girlfriend, Pamela Polakowski after she was pulled over while driving through Allenton. Deputies found another two pounds of marijuana in her vehicle. She was a resident of the home.

According to Captain Bill Gau of the Fond du Lac County Sheriff's Department the SWAT

Team executed a search warrant at the residence. The warrant was the result of a joint drug investigation conducted by the Lake Winnebago Multi-Jurisdictional Enforcement Group, the Fond du Lac County Sheriff's Department and the Washington County Multi-Jurisdictional Drug Enforcement Group.

Barry and Polakowski each face one count of being party to possessing marijuana with the intent to deliver.

Barry will have his preliminary hearing in Fond du Lac County Circuit Court May 24.

Polakowski was charged with one count of possession with intent to deliver in Washington County Circuit Court Wednesday, April 17, She faces a pretrial hearing today. She was released on \$75,000 bail from Fond du Lac County Jail earlier this week. She will be in Fond du Lac County Circuit Court Friday and May 24 for her preliminary hearing.

To those who first are kind. Let that thought and this one

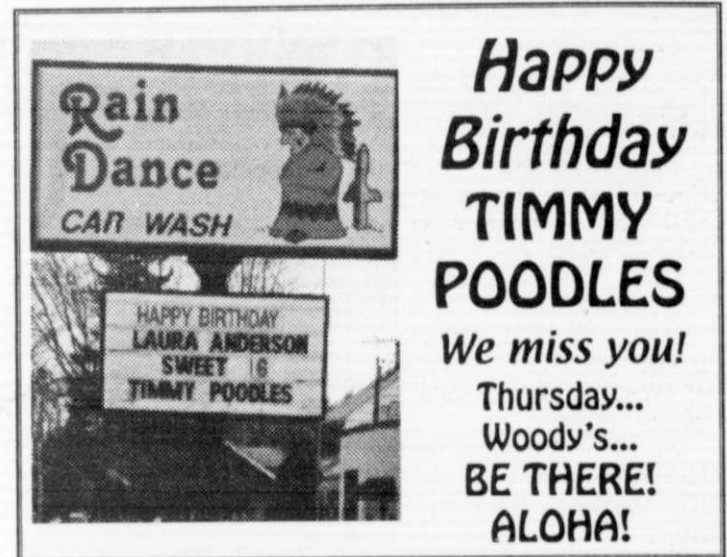
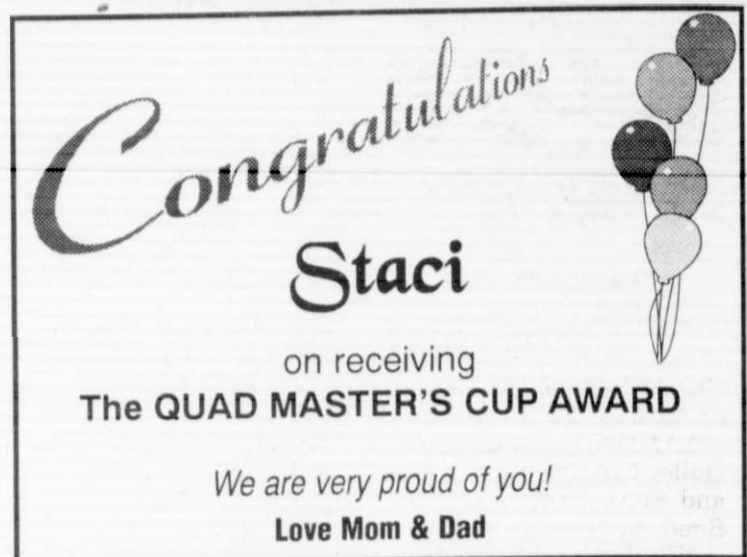

To The Members of the Kewaskum School District Finance/Transportation and Grounds Committee, Kewaskum School Board Members, concerned students and parents:

I am very distressed by the articles printed in the Kewaskum Statesman and the West Bend Daily News, concerning the cuts of athletics/co-curriculars.

My first question is how did the school district get into this situation to begin with? Why were parents, students, and tax payers not informed before reading it in the paper? But, now that we are in this situation how do we fix it?

According to the articles, some cuts have already been made, which is good. But, has every expense the district has been analyzed? For example; has the insurance policy for district employees been requested? Is there a need for the employees to pay a larger portion of the premium, as has been done in most other businesses across the country?

Is continuing education required to hold licenses being paid by the district or the individual?

Is the district paying for cell phones, pagers, cars, etc. for any employees?

How has the cost of benefits to district employees been reduced?

What is the annual payroll for district employees? Could say, a 1% to a 1.5% pay cut retain jobs but yet have a major impact on balancing the budget. Many companies across the state have cut pay by 5 to 10% and the employees are able to keep their jobs.

What if parents had to pay for busing services or

drive their children to school?

What about cutting or reducing advisor, coaches, and referee pay? Committee members and Board Members?

Personally, I am part of a nonprofit organization that consists of 12 Board Members, 14 Board Planning and Operations Teams (consisting of 2-7 members per team). We are all unpaid and volunteer our time and talents (5-20 hrs a week, maybe more, depending on your position). Why do we do this?? We all would give you the same answer: For the sake of the kids being able to participate!! I also spend approximately 3-5 hours a week in volunteering in religious education, why do I do this? For the sake of the kids!!

I'm sure there are other people out there willing to volunteer for the sake of the kids!!

What if the students are charged more to participate? Uniform and equipment fees? What is the cost of the specific sports, clubs, plays, activities, programs, field trips, etc? What if the spectators were charged? Example; season pass, family pass, each event attended, etc. fund raisers? donations from area businesses, with advertising showing their sponsorship?

Will the cuts that are being now proposed by the district, have a large impact on even more students leaving the Kewaskum School District? Athletics/co-curricular activities keep our kids busy and out of trouble. They are a great asset to our children both mentally and physically.

The treasurer must follow the same rules as the Town of Auburn residents, to sit in the audience, to address the board on town matters. In consideration of the fact that I am secretary of the Board of Appeals in the Town of Auburn, I have a set of strict rules and regulations and a code of ethics to follow. Hello friends,

This past week, my golden retriever Pearl gave birth to a litter of five pups. A tough delivery has kept me on the home front, so I decided to put down in writing the role four golden retrievers I've owned have played in my adult life.

February 1982

Ranger

The past year of my life had gone three distinct changes. In the late spring of 1981, I quit my job as a deckhand on a river boat which pushed fuel from New Orleans to Louisville, Ky.

I joined the Wisconsin Air National Guard and became a munitions loader on a A10 aircraft. That August, I became a full time student at Madison Area Technical College. I never fit into the college scene and had one goal each day. That was to get outside.

By November, my visions were elsewhere. I had a life-long dream of becoming a farmer. With about \$5,000 in my savings, I rented a farm. I also took a job on the farm across the road. I had just enough cash left to buy my first golden retriever. It was a female pup, which I named Ranger.

I enjoyed farming, but I felt too tied down. After two years, I took a job as a welder at a company in Mauston.

September 1984

Ben

I had been welding for one year when Ranger gave birth to a litter of eight pups. I kept the last one, which I named Ben. To this day, Ben was the best dog I have ever owned.

Ben, Ranger and I were weekend nomads. On Friday mornings, I would punch the clock with Ben and Roger chained to the truck and a boat load of fishing or hunting gear. We didn't return until Monday mornings, when I would drive directly from wherever we had camped to work.

In 1991, Ben was my companion on a 1,244-mile trek of the Appalachian Trail. It was on this trip that his trail name became Golden Bear and mine, Sunset.

Ben's two best qualities were loyalty and the incredible ability to hunt whatever game we were after. At nine years of age, he was rock hard muscle and weighed 119 pounds.

September 1991

Star

Ben and I had recently returned from our AT hike. The \$25 per week salary I received from writing this column was my sole income. I knew I needed a pup from Ben. I did my homework and purchased Star from a Field Trial judge, Mickey

Strandberg.

Star was 8 weeks old when she began a 16-day canoe trip on the Wisconsin River with me. She will be 11 this July and has been on the go ever since the day I bought her. She can pull as sled, carry a pack and fetch a duck. She has all the requirements of a dog earning its chow in my life.

December 1993

Pearl

Star gave birth to a litter of six pups. Ben was an incredibly proud father.

My pal Ben, who was absolutely the greatest, was run over by a car when the pups were 4 weeks old. At that time, I was writing for 15 papers and received over 100 letters of condolences. The loss of Ben completely wiped me out emotionally for a couple of months.

I chose Pearl out of Star's litter and gave her the registered name of Pearl Ben's Baby. There are times that I feel that Ben's soul jumped out of his body and into Pearl's the day he died. Pearl has the same mannerisms and looks and loves to hunt.

At 8 weeks, Pearl went on a 180-mile ice trek of Lake Superior with Star and me. Star pulled Pearl on most of the journey. This was a trip that all three of us should have died on a hundred

times over.

Two years ago, at the age of six, I knew it was time to get a pup from Pearl if I was going to keep this line going. Unfortunately, she did not come into heat. This past February, Pearl did come into heat, and we matched her up with an excellent stud. With eager anticipation, our family of six watched Pearl's belly swell.

I would like to report a happy ending to this story. Unfortunately, none of the litter of five pups survived. Four were born dead. One pup lived three days, just long enough to win our hearts.

We will regroup and come up with another plan.

Everything happens for a reason.

Lickel, who wasn't able to complete the third leg of the race, could be out a couple of weeks. Hopefully, it will heal and he will be able to return to the line-up at 100 percent.

Matt Hartmann replaced Lickel in the 4x100m relay and teamed up with Josh Uelmen, Tom Ogi and Tony Fitts to win with a time of 46.3 seconds on a cold and windy night.

"After the 4x200m relay team wasn't able to finish because of Lickel's injury the team needed a lift and the 4x100m relay win did just that," commented Coach Gosa.

Kewaskum's throwers won both the shot put and the discus. Troy Koefler won the shot put with a throw of 48'10" and David Cibulka won the discus with a throw of 133'4". Koefler made it a 1-2 sweep with his second place throw of 122'2" in the discus.

Kurtis Cochran and Mike McKee also gave Kewaskum a 1-2 placing in the pole vault. Cochran won with a jump of 10'6" and McKee cleared 10' even for second place.

While Canter was the sprinting star for Kewaskum, Josh Meyer, a freshman, had an outstanding meet as a distance runner. After running a 2:11.6 split in the 800m on the winning 4x800m relay, Meyer finished second in the 1600m run with a season best time of 4:47.8 (four minutes and 47.8 seconds).

Meyer, who wasn't done for the night, demonstrated that he had also learned how to race his next event, the 800m run. "Before he

stepped on the track to run the 800, I told him that the fastest 800m time listed on the program was 2:12," commented Coach Gosa.

Meyer went out strong and stayed with the leaders. Meyer was in third place going down the backstretch on the second lap when he made the big push. He moved into second around the far curve and then out-sprinted the leader down the homestretch to win the race in a personal best time of 2:08.8. What a great night for a freshman.

Matt Hartmann finished second in the 300m intermediate hurdles with a time of 42.7 seconds and placed third in the triple jump with a distance of 37'9".

Bryan Kraft dropped 30 seconds off his season best time in the 3200m run and finished fourth with a time of 11:01.

Mike Wagner finished sixth in the 300m hurdles with a time of 47.2 seconds and sixth in the 100m high hurdles with a time of 18.5 seconds.

Tom Ogi tied for third and Brian Cotter placed

sixth in the high jump with heights of 5'6" and 5'2" respectively. Josh Uelmen finished fourth in the 100m dash with a time of 12.0 seconds.

Meyer's distance teammate, Chris Baker, finished sixth in the 1600m run with a time of 5:03.5 and fifth in the 800m run with a time of 2:17.4.

The Kewaskum 4x400m relay team of Mike Wagner, Tom Ramthun, Josh Uelmen and Adam Woebeking finished sixth in 3:54.9.

Uelmen, Woebeking, and Wagner were last minute replacements due to injuries to Lickel and Mike McKee. Matt Hartmann ran in his maximum of three events when he filled in for Lickel on the winning 4x100m relay team so he couldn't run on the 4x400m relay.

The 4x100m throwers relay of Troy Koefler, Bill Thelen, David Cibulka and Kurtis Cochran won handily, but this year the points didn't count in the final standings.

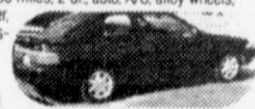

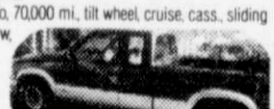

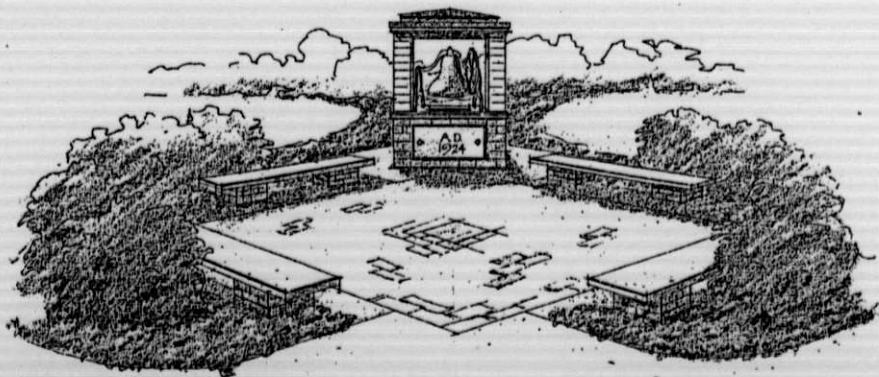


Buy a Brick, Build a Memory
