Ad-Hoc Committee Recommendation Says New High School to Board of Education

Monday night's School Board meeting started off with the reorganization of the board and quickly moved on to a very full agenda.

Gordie Dickmann became the new president; Mark Steinhardt, the new vice president; Mary Meisser, the Board Clerk, and John Schulte the Board Treasurer.

Laurie Beimborn presented a report on the volunteer program she was the coordinator for at KES. She and building principal Kieth Kriewaldt pointed out the success of the program and tossed out the idea of starting similar programs at FES and WES. Laurie stated that teachers were happy with the results because it saved them the time of looking for volunteers for things.

Co-chairs of the committee, Greg Ogi and Anne Wicklund were on hand to present the Ad Hoc Referendum Planning Committee Recommendation.

The consensus of the group at the meeting on May 1st was to present the idea of remodeling the high

school to be a middle school and building a new high school on a new site.

The new high school would also include an auditorium that the committee feels the district needs.

"We need to provide an environment that exceeds what we have now for performing arts," stated Ogi. He further advised that the auditorium is a NEED and not a want.

The proposal to build a new high school, remodel the existing high school and an auditorium would be approximately \$32 million plus the cost of the land.

Also pointed out was the fact that the football and track facilities would stay at the existing site and new facilities would not be built, however the committee did suggest building better soccer fields and softball or baseball diamonds.

The issue of the cost to taxpayers was raised. Ogi stated that he has talked to numerous dairy farmers, who he pointed out have "lots of land," and asked them how they felt about this. He stated that he had "yet to have a single dairy

farmer say 'we don't need this'."

When asked about land for the new school, Wicklund stated that there were three possibilities and that two of the three landowners had already been contacted.

Overall Ogi stated, "We are realistic but cautiously optimistic that this will pass."

There will be a meeting on Tuesday, May 21 at 6:30 p.m. to further discuss the issue of the changes to the high school and middle school. Any and all topics will be covered. Representatives from Bray Associates and the accounting firm of Griffin, Kubik, Stephens and Thompson Inc. will be there to answer questions about the building plans and taxes.

Also at the meeting the 2002-2003 school calendar was approved. School will be starting on Wednesday, September 4th and end on Thursday, June 12, depending on snow days. The last day before Christmas will be December 20 with classes resuming on January 2. The last day before Easter Break will be April 11 and school will resume on April 21.

Sheriff Thuesch to Seek Re-Election



Washington County Sheriff John "Jack" Thuesch has announced he will seek another term as sheriff. Thuesch indicated in a brief interview Tuesday he is in his 31st year with the department and in his sixth year as sheriff. Thuesch won the 1996 election over Jim Grover and has been sheriff since that time. The fall election will take place on Tuesday, November 5. To date Thuesch runs un-opposed.

Local American Legion Post to Hold Annual Memorial Day Service Here

On Monday, May 27, the Robert G. Romaine Post No. 384 of the American Legion will hold their annual Memorial Day Parade and ceremonial program.

The parade to honor those who gave their lives will be held at 9 a.m. beginning at the Kewaskum High School and proceeding to the American Legion on Fond du Lac Avenue in Kewaskum. A short memorial service will be held there.

All Legionnaires, fire department members, Boy Scouts, Girl Scouts, 4-H and youth groups, civic organizations, etc. are invited to march in the parade honoring our war dead. Participants are asked to meet in front of the high school at 8:45 p.m.

The parade route is from the high school to Third Street, south along Parkview, to Main Street, west on Main Street to Fond du Lac Avenue and north to the Legion grounds where

the ceremony will then be held.

In case of rain, the program will be held in the high school auditorium at 9:30 a.m. Marching groups will assemble in the halls and march into the auditorium.

The Memorial Day address will be delivered by Meggan M. Gronbeck, SPC, US Army.

Meggan joined the Army at the end of her junior year in 1997. She spent her senior year in the Delayed Entry Program while attending West Bend West High School. Thirteen days after graduation, she left for Basic Training at Fort Jackson, South Carolina.

After Basic she spent 13 weeks in Advanced Individual Training at Fort Jackson. During these weeks she was a platoon leader and squad leader.

Following AIT Meggan went on to Airborne School at Fort Benning, Georgia. During her four weeks there

she became one of the few females to graduate from that school. When jump school was over she was stationed at Fort Bragg, North Carolina.

She served in the 82nd Airborne Division, was assigned to a tough unit, the First Squadron 17th Cavalry Regiment, part of the 82nd Airborne Brigade.

Meggan accomplished her dream to be a part of history and stated, "I served in the greatest Division in history."

She also accomplished 20 successful jumps out of C-130's, C-141's, a Blackhawk helicopter, and a tailgate C-130. While she was at Ft. Bragg, her unit was called to serve overseas. Her unit was all set to go over to Kosovo and support the Infantry units that were there. When they were told to stand down, and that they didn't need them she was disappointed. She was

KHS Student to be Charged in Juvenile Court for Bomb Threats

The Kewaskum School District held an expulsion hearing Monday for a high school student who was arrested on charges of leaving bomb threats in the school's 300 hall bathroom. Kewaskum Police Chief Dick Knoebel said the 16 year old boy admitted to writing six of eight threats found at the school between April 2001 and March 2002.

"School Liaison Officer Troy Ellis initially questioned the student after reviewing several video tapes," said Knoebel who had cameras installed at the school. "Initially the student denied making the threats, but later admitted it because he said he wanted to get out of class."

Aside from setting up cameras, school administrators also instructed teachers to check the bathrooms on a regular basis in hopes of finding who was responsible for making the threats. Kewaskum Police took the student into custody last

Thursday and charges were sent to the Washington County District Attorney. Knoebel said it would be up to the D.A. to decide if the boy should be pushed into adult court.

Knoebel said he is glad they finally found the person responsible for some of the threats. "You can never assume that these things are pranks. You always have to take each threat seriously," he said. While Kewaskum Police investigated the threats they eventually held fire drills rather than evacuate the school each time a threat was found. Knoebel said the drills helped keep the students safe and get them back to class, rather than have them sent home each time a threat was discovered.

Kewaskum Police are still looking for another person who may be responsible for other threats. An expulsion hearing was held

How Old is Too Old?

Did you know that the world famous pianist Arthur Rubinstein gave one of his greatest recitals at age 89? Or that Tintoretto, the great 16th century Renaissance artist, painted "Paradise" when he was 74? It was a canvas measuring 74 feet by 30 feet!!!

Did you know that another great Renaissance artist, Titian, painted his historic picture of the "Battle of Lepanto" when he was 98? Or that the celebrated American artist, Grandma Moses, didn't even begin painting until she was 78 - and never even had an art lesson? She continued her career until she was 100.

Then there's the German writer, Goethe, who completed his masterpiece "Faust," when he was 80; and Tennyson, the 19th century English writer, who made profound contributions to world literature throughout his lifetime,

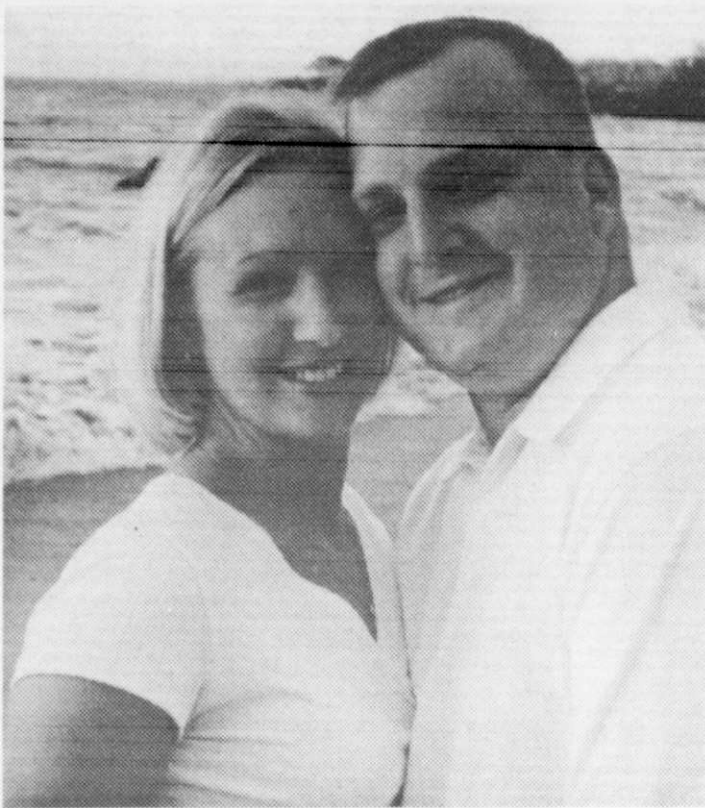

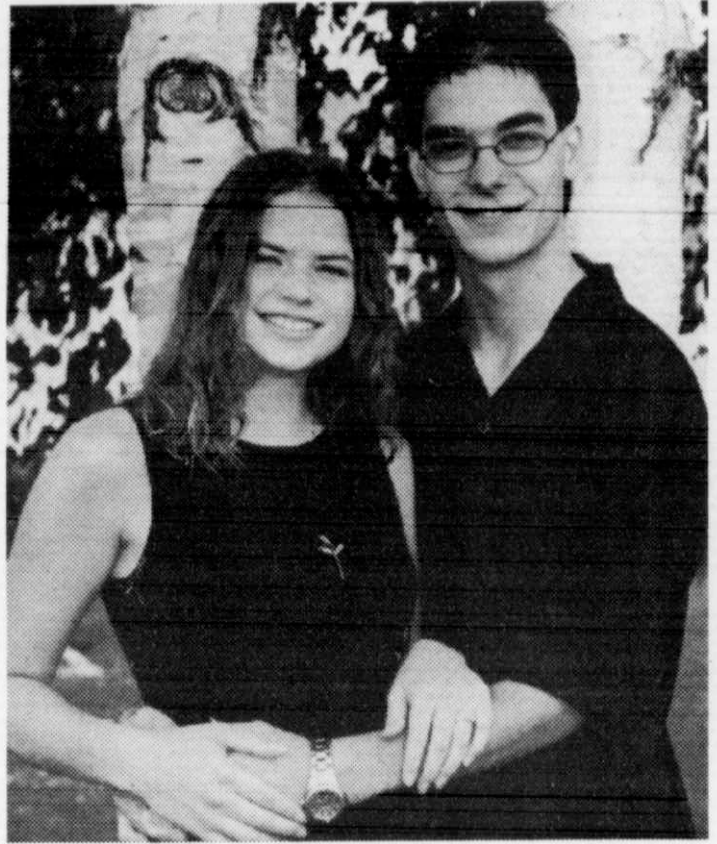

West Bend Surgery Center Celebrates Third Anniversary, Continued Growth

The West Bend Surgery Center (WBSC), a member of SynergyHealth, marks its third year of service this month. Since the WBSC began serving the community on May 10, 1999, the WBSC team has grown from a staff of 16 to the current staff of 33.

In the first year, the WBSC cared for 2,235 patients, performing 2,881 procedures. To date the WBSC has served over 7,500 patients, performing almost 9,300 cases.

Examples of surgeries performed include arthroscopy of the knee and shoulder, carpal tunnel, colon-

oscopy, gastroscopy, hernia repair, laparoscopy, epidural and cervical injections, tonsillectomies, and many more. This summer a new team of orthopedic surgeons will join the WBSC and West Bend Clinic, and a plastic surgeon is being recruited, to expand the services that are currently available.

The vision behind the development of the WBSC was to create a facility designed to meet unique patient needs, with an emphasis on utilizing state of the art medical equipment. The doctors of the West Bend Clinic worked to develop the best place to have surgery, whether you are a patient, a surgeon, or a staff person.

"It has been my privilege to work with the excellent caliber of physicians and staff who are working so hard to provide excellent patient care," says Sue Roemer, Director of Surgical Services since the inception of the WBSC. "It is the philosophy, that in working together individuals can achieve a level of excellence that cannot be achieved independently. This same philosophy brought SynergyHealth into existence."

The WBSC is governed by a medical board consisting of Roxanna Aldstadt, D.O., Robert Bodensteiner, M.D., William Owens, M.D.,

Bhupinder Saini, M.D., Jim Browne, West Bend Clinic Administrator and Sue Roemer, Director of Surgical Services. Dr. Saini is also the Medical Director of the WBSC. Saini is also a member of Wisconsin's

State Medical Board, receiving his appointment from former Governor Tommy Thompson.

The WBSC is located at 1710 Vogt Drive in West Bend, inside the West Bend Clinic.

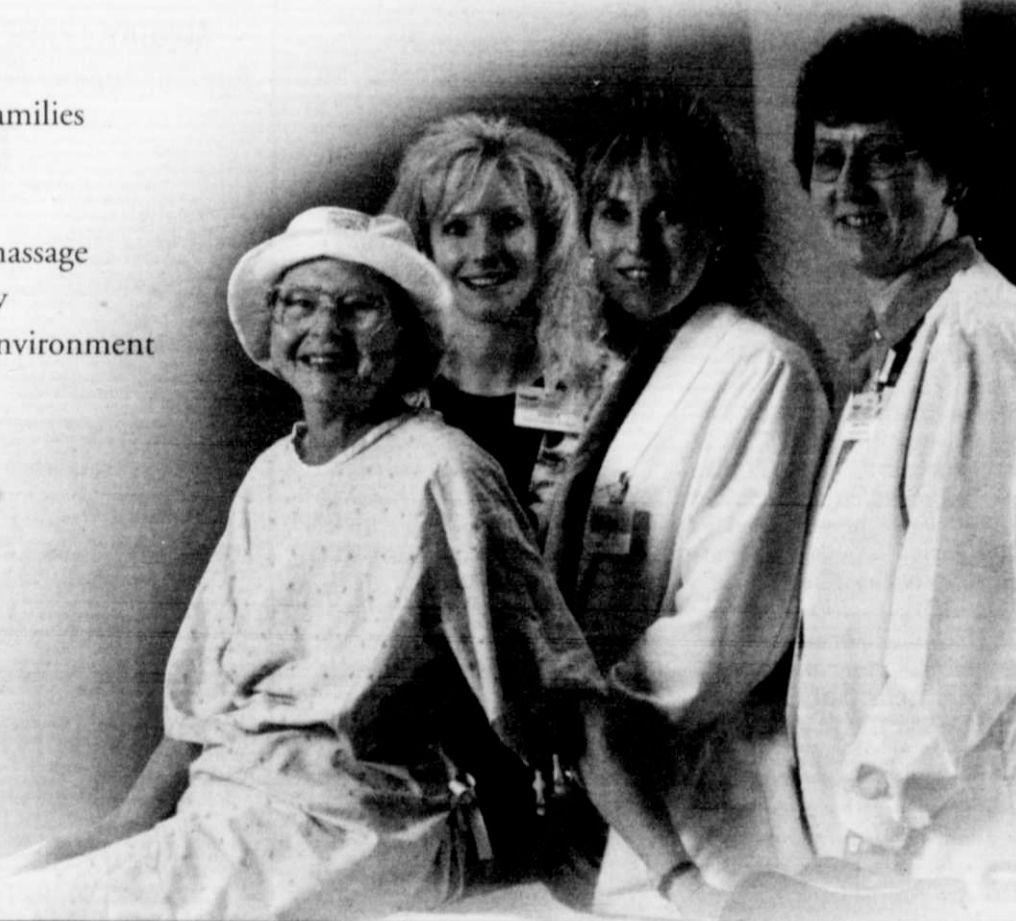

Bring up sides of foil and double fold. Double fold ends to form a packet, leaving room for heat circulation inside of packet. Repeat to make four packets.

Grill 13 to 16 minutes in covered grill.

Makes four servings. Rainy day variation: Prepare as directed, but bake on a cookie sheet in a 450° pre-heated oven for 20 to 25 minutes.

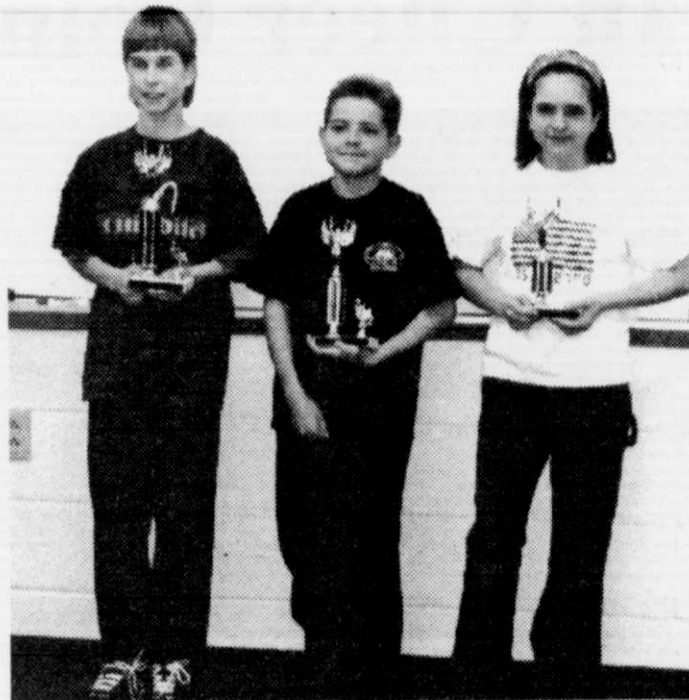

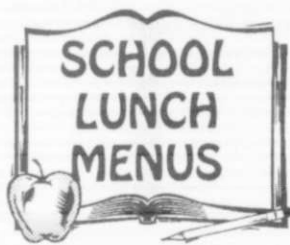

CHOCOLATE CHUNK COOKIE MIX IN A JAR

- 1 1/4 cups all-purpose flour
- 1/2 tsp. baking soda
- 1/2 tsp. salt
- 1/2 cup firmly packed light brown sugar
- 1/3 cup granulated sugar
- 1 cup (6 oz.) pkg. semi-sweet chocolate chunks or chocolate chips
- 1/2 cup chopped pecans or walnuts

Combine flour, baking soda and salt in a small bowl. Spoon into 1-qt. wide mouth canning jar. Layer remaining ingredients in order give, making sure to pack down each layer firmly and clean inside of jar with paper towel after each layer. Decorate lid as desired.

Attach these instructions to the jar: In large mixing bowl, cream together 2/3 cup softened butter or margarine, 1 egg, 1 tsp. water and 1/2 tsp. vanilla until light and fluffy. Add contents of jar and mix well. Drop by rounded teaspoons onto ungreased cookie sheet.

Bake at 375° for 8 to 10 minutes or until lightly browned. Makes about 3 dozen cookies.

New FCC Rules to Help 911 Response

WASHINGTON - Federal telecommunications regulators hope new requirements announced recently will help emergency personnel better respond to calls from 911-only cell phones or mobile phones without service.

Several private programs allow cell phones to be donated to needy users such as domestic violence victims, the elderly and the disabled. Those phones typically do not have service, but federal rules require wireless carriers to pass on 911 calls to dispatchers regardless of the phone's service status.

Carriers also manufacture cell phones that can only dial 911.

Both types of phones cannot receive calls, which can pose a problem if the caller gets cut off from the emergency dispatcher.

At the request of public safety groups, the Federal Communications Commission studied the issue and determined that it is not yet technically possible to require carriers and phone manufacturers to provide callback numbers on the so-called non-initialized phones.

Instead, the FCC voted to require such phones to be programmed so that 123-456-7890 would show on dispatchers' screen as the telephone number. That would alert the dispatcher to quickly get information, knowing the call cannot be returned.

Non-initialized phones now also must carry labels advising the user that 911 operators cannot call back, and carriers must issue to each user a more detailed notice of the phone's limitations.

The action comes as the FCC's Enhanced 911 initiative continues to roll out, to be completed over the next several years. The system requires carriers to make sure emergency service can pinpoint the location of distressed callers on cell phones to within 300 yards, using either global positioning or networking.



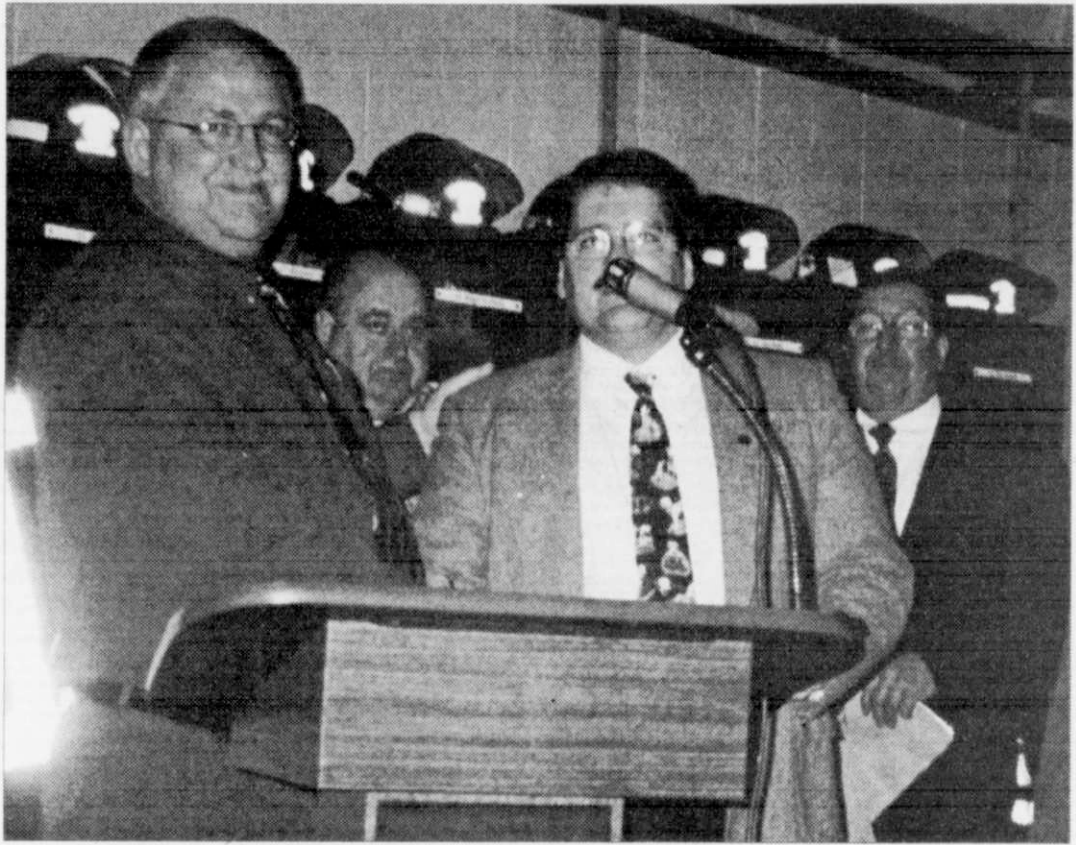

Leisch assisted others in his party taking care of those seriously injured to sustain life until ambulances and rescue crews arrived on scene.

Badger Firemen Association also recognized John Breuer of the Allenton Fire Department with their award for Meritorious Service Award for his contributions of time, skills, knowledge and experience along with his dedication to the Allenton Volunteer Fire Department and the Allenton Community. Breuer is the first Assistant Chief of the Allenton Fire Department. He has served on the building committee from January 1999, which included a \$450,000.00 addition recently.

Breuer was further recognized John for his quick, life-saving actions at the scene of an EMS call on

August 12, 2001. His skills, training and knowledge were used to save a life of a gentleman that was injured was playing softball and was hit by another adult male. His correct assessment, in not moving the patient's neck or head, resulted in not being paralyzed according to doctors at Froedert Hospital.

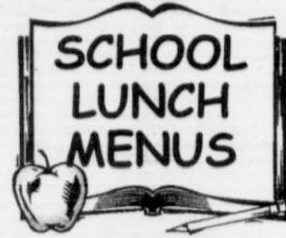

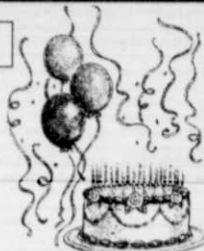

Raiding One Time Fund Spells Trouble

During the current state budget crisis, Governor McCallum, Assembly leadership, and Senate leadership have all claimed they have solved the budget crisis without raising taxes. A closer review of both Republican and Democrat proposals show they are delaying the crisis not by reducing spending but instead, using one time accounting tricks which will make things worse in the long run.

The state spends about \$23 billion in our General Purpose budget every two years. Almost all of this comes from our income and sales taxes. Both sides plan this year on spending about \$23 billion but taking in about \$2 billion less in taxes than what they spend. The difference will be made up through a variety of gimmicks.

The Assembly Republicans take \$1.1 billion by selling the rights to future payments from tobacco companies and the Senate Democrats get about \$1.25 billion this way. Both sides get \$270 million of federal money intended for nursing homes through a technical loophole, which the federal government will shortly close. Both sides save \$150 million by restructuring a debt and not making principal payments. This will not be repeated.

Both sides suspend making \$72 million in payments, which are actuarially required to be made to cover a liability for health insurance to retired state employees. Both sides make a \$25

million payment for health care for the poor in the next fiscal year rather than this fiscal year. Both sides take advantage of a \$48 million one-time savings related to a pension increase passed two years ago. The Democrats tried to save \$60 million through a one-time early retirement proposal, which will cost over \$400 million in the long run.

Since we cannot repeat this, two years from now either the state will have to spend \$2 billion less or have a major tax hike to make up the difference. Incredibly, both sides are bragging about new spending to hire new teachers to further reduce class size, encouraging districts to go to four year old kindergarten and start the second most expensive prescription drug program in the country.

While this so called structural deficit may be boring, it is the greatest scandal I've seen since being in Madison.

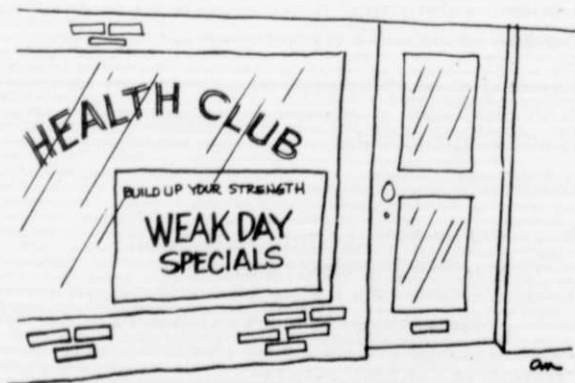

** P.E.T. #1 PLASTIC**

TYPE: Plastic Bottles - Normally used in 2 liter soda bottles.

HINT: P.E.T. bottles will carry the #1 emblem stamped or molded on the bottom.

PREPARATION: Remove caps & rings. RINSE CLEAN. This is the most important aspect of a successful recycling program. Bottles that contain liquid residue cannot be recycled. Place #1 plastic bottles in your dark green recycling bin or blue recycling bag along with the other recyclable items. Place bin or bag at the curb on the same day that your solid waste is to be collected. Pick up will be Wednesdays for both solid waste and recyclables. Multi-family dwellings of six or more, remember, your recycling pick up will be the 1st and 3rd Wednesday of each month.



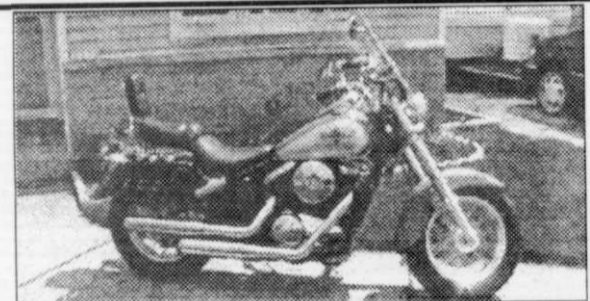

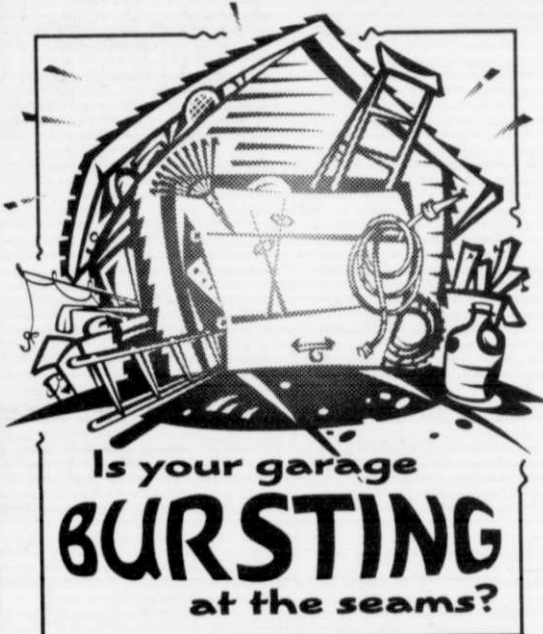

Outdoor Adventures

with

Mark Walters



Trouble in paradise



Southwestern Dane county is made up of hilly, forested farmland.

Hello Friends,

This week, I am going to try to cram as much information into this column as I can on what I feel is the most important outdoor related subject to hit the state of Wisconsin in the history of the state.

Last week, I spent three days camped on Knobby Knoll, which is the third highest point in Dane County. I attended a very important meeting and talked with 75 people on the issue of Chronic Wasting Disease, which in the end will mean certain death for the entire deer herd in at least a 280 square mile area covering the hill country of southern Dane and Iowa counties.

Wednesday, May 1
High 58, Low 45

Myself, along with about 1,600 other concerned citizens, attended a meeting put on by the DNR announcing the total eradication of the whitetail herd in the area.

But Vander Zouwen, a biologist in charge of attempting to stop the CWD disaster, along with Julie Langenberg, a DNR Wildlife veterinarian with the Colorado Division of Wildlife, were each given about 15 minutes to let the highly emotional, well behaved crowd know what type of disaster we're looking at.

Miller has been working with the CWD problem in Colorado which covers 1,600 square miles and part of three states.

All three speakers did their best to make it obvious that the only solution is total eradication. Anything less means an inevitable end to the whitetail herd in the area and spread of the disease to the outlying areas.

Fourteen deer management have been chosen to have their deer herds culled to half the management goals to curtail the spread of disease.

Year-and-a-half old bucks on occasion relocate from 10 to 50 miles, which is why so many management units outside of the hot zone will be affected.

Thursday, May 2
High 51, Low 40

Last night, on two separate occasions, I had deer wake me up as they came within 10 yards of my tent and gave me their warning snort.

My camp is in the hot zone. Either a bullet or CWD has doomed these deer.

Last night, Mike Miller told us Colorado has basically thrown in the towel in stopping CWD and was now concentrating on trying to stop the spread.

Bill Vander Zouwen and the meeting monitor, Scott

Craven, showed pictures from a successful hunt and made it clear that the CWD is not just a job for them.

Their camp, which they have both belonged to for over 20 years, is in the hot zone, and they will be taking part in the job that needs to be done.

Questions were asked concerning the disposal of deer carcasses, and landowners who wouldn't allow hunting.

The answers seemed to be landfills, and the hope that private landowners who are against hunters on their land would find shooters they could trust, even if they have to go to their church or some organization they believe in to find them. Chronic Wasting Disease has not been found anywhere else in Wisconsin, and has never been known to directly affect a human who has eaten venison or elk.

The paranoia that has hit this state needs to slow down. A huge sacrifice is taking place by the people in Dane and Iowa counties, which will last for at least the next six years.

To hopefully stop and definitely slow down the spread of CWD, they have been given the sacrifices of their entire deer herd and deserve the respect given to people who are going

through a very long term and emotional situation.

The eradication will be extremely ugly, at times disorganized, and unfortunately, there will be flaws. Before complaining, think of the other option.

Stick together on this one!

Evening Events Begin at Ice Age Center

The 2002 Friends of the Kettle Moraine Saturday Evening Events begins with "Kolterman Mounds of Horicon Revisited." The program will be held on Saturday, May 25, from 7:30 to 9 p.m. at the Henry S. Reuss Ice Age Visitor Center.

The Ice Age Visitor Center is located off of Highway 67, 1/2 mile west of Dundee. The program is free, but donations are always gratefully accepted.

After further intensive field surveys, mapping, and on site observation of astronomical events, more petroforms were found among the mounds at the Kolterman site. The petroforms discovered so far at the site include rock bison effigies, associated stones oriented to solstice events, a giant human-like effigy petroform, and stone rows that intersect and overlap each other.

Collectively, all the dis-

coveries may indicate that many of these mound groups are far more complex than anyone has ever suspected.

Join Herman Bender, a geologist, amateur astronomer and historian, as he provides some insights into these new discoveries and their significance to understanding ancient cultures.

Mr. Bender has been internationally published in the fields of archeoastronomy and applied geophysics. He is currently a member of the Mid-America Geographic Foundation, Inc., a not-for-profit preservation and educational organization.

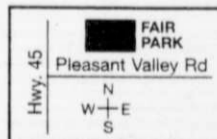

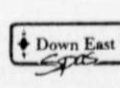

KHS Boys Win First EWC Track Title

KEWASKUM- The Kewaskum High School boys' track team won their first ever Eastern Wisconsin Conference track and field Championship on Thursday. Chris Canter lead the team by winning four individual events: the 100m, 200m, 400m dashes plus the long jump. "Chris had the type of meet that track athletes dream of having. His goal was to win all four events and he went out and did just that. He had a sensational meet," commented head coach Jerry Gosa.

Canter won the 100m dash in 11.2 seconds, then the 400m dash in a school record time of 50.8 seconds, then the 200m dash in 23.2 seconds, and in between the running events won the long jump with a jump of 20' 7". Bryan Buechel of New Holstein placed second in the long jump just one inch behind at 20' 6". Canter's win in the long jump gave him three consecutive conference titles in the long jump as he won the long jump at the conference meet both his sophomore and junior year.

Kewaskum surprised everyone including themselves by upsetting favorite Two Rivers 122-118.5 to win the team title. It was definitely a team victory. The final score shows that every point and every place is very important.

The final score hardly does justice to the suspense that the Kewaskum athletes, parents, fans and coaches had to endure during the pole vault competition.

At the conclusion of 4 x 400m relay, 17 out of 18 events had been scored and Kewaskum and Two Rivers were tied at 112 with the pole vault still in progress. Kewaskum, Two Rivers, and Plymouth each still had two vaulters competing and

Sheboygan Falls and Roncalli each had one vaulter left in the competition.

Kewaskum needed to beat the Two Rivers vaulters to earn Kewaskum's first EWC Track and Field Championship. Fitzgerald of Two Rivers was out of the competition earlier as he failed to clear 11' and placed eighth at 10' 6". Kurtis Cochran of Kewaskum missed 11' 6" on all three attempts and placed seventh at 11'. Six vaulters cleared 11' 6" including Kewaskum's Mike McKee and Erich Parizek of Two Rivers. Four of the six vaulters cleared 11' 6" on their first attempt, but McKee cleared the bar on his second attempt and Parizek cleared the bar on his third and last attempt to remain in the competition. With six vaulters remaining, both Peter Ulrickson of Sheboygan Falls and Mike Blau of Plymouth missed three times at 12' and ended up placing 5th and 6th respectively.

Jake Krueger of Plymouth, Jake Peters of Roncalli, Parizek of Two Rivers, and McKee all cleared 12' on their first attempt. At 12' 6" Parizek went first and missed three times and then Peters missed three times. Peters and Parizek tied for third at 12 feet. Then with the field-house full of anxious spectators, Mike McKee sprinted down the runway, went high into the air and cleared 12' 6" to clinch the victory for Kewaskum. Jake Krueger went on to win the pole vault at 13' 6" and McKee placed second at 12' 6" and scored 8 big points for Kewaskum.

"Mike really put everything together at the right time and kept his cool under pressure," commented pole vault coach Nate Wesemen on Mike McKee's performance.

Every point the Kewaskum team scored up to the pole vault competition made the pole vault competition the deciding factor for Kewaskum to win the conference title.

The Kewaskum 4 x 100m relay team surprised both New Holstein and Sheboygan Falls by winning the conference title in the sprint relay Thursday night. Just six days earlier New Holstein and Falls both convincingly beat Kewaskum at the Vanderpan Invitational. The Kewaskum 4 x 100m relay team of Josh Uelmen, Tom Ogi, Matt Hartmann, and Tony Fitts won with a time of 45.4 seconds beating New Holstein who finished second. Two Rivers finished third and New Holstein fourth. "It was great seeing them run the way they are capable of running. We worked a lot on hand offs this last Monday and it paid off in the 4 x 100m relay," reported coach Gosa.

The same foursome of Hartmann, Ogi, Uelmen, and Fitts finished second to New Holstein in the 4 x 200m relay team with a times of 1:36.6 and 1:35.8 respectively.

Kewaskum had a total of four second place finishes - McKee in the pole vault and the 4 x 100m relay and the other two came in the shot put and the 300m intermediate hurdles.

Troy Koefler placed second in the shot put with a throw of 48' 1". Derek Paulitzke of Two Rivers won with a throw of 48' 8 3/4". Matt Hartmann finished second in the 300m intermediate hurdles to Jon Fenrick of Campbellsport. Fenrick finished in 42.07 and Hartmann in 42.10 seconds.

Tony Fitts combined for two 1-3 finishes for Kewaskum. Fitts finished third in the 200m dash to Canter with a time of 23.5 seconds and third in the long jump at 19' 11". Fitts

almost didn't get a chance to jump in the finals of the long jump. Time had expired for the finals in the long jump while he was competing in the relays. The games committee ruled that he should be allowed to jump. All the other jumpers had already finished when Fitts, who was in eighth place at 19' 2", took his three final jumps. A Two Rivers coached witnesses the jumps as Fitts jumped 19' 11" to place third. Third place meant six points instead of one point for eighth place in the team scoring.

David Cibulka placed fourth in the discus under the extremely windy conditions with a throw of 126' 8". The 4 x 800m relay team of Josh Meyer, Tom Ramthun, Bryan Kraft, and Chris Baker finished fourth with a


time of 9:01.2. Meyer also finished fifth in the 1600m run and seventh in the 800m run with times of 4:54.9 and 2:13.06.

Kraft also scored big points for Kewaskum finishing sixth in the 3200m run with a time of 11:07. Brian Cotter and Tom Ogi finished in a three way tie for sixth place in the high jump at 5' 4".

Final team scores: Kewaskum 122, Two Rivers 118.5, Plymouth 108.5, New Holstein 105.5, Sheboygan Falls 98, Campbellsport 54, Kiel 51, and Roncalli 43.5.

"Mike McKee really came through. It was great how well he and the team performed tonight," commented Chris Canter on his thoughts about the team's performance that resulted in the conference title.



