Number of Complaints Handled Down Almost 400

Crime in Village Up 11.1% in 2001

The 2001 annual police report was released to village trustees at an earlier Village Board meeting. Police chief Richard Knoebel went through the summary with the trustees.

Knoebel started off the report by saying, "During the year 2001 we all saw how emergency services have to react to very diverse situations. The September 11 tragedy showed how emergency services have to be ready to take action on a variety of situations on a moments notice. It is with this in mind that we have continued to train our officers to do the best job possible in whatever circumstances they face."

Highlights of the report are as follows:

■ Total crime, as reported to the state on a monthly basis increased 11.1% in 2001. This compares to it increasing 5.9% in 2000.

■ During 2001, all crime rates in Kewaskum were considerably lower than those of the entire state and lower than those of comparable cities.

■ During 2001, 25% of the total crimes were cleared by arrest. This is comparable to the statewide rate of 24.59%

■ Total adult arrests increased by 16.8% from 273 in 2000 to 319 in 2001.

■ Total juvenile arrests decreased by 20% from 230 during 2000 to 184 in 2001.

■ The stolen property recovery rate was 18% for 2001. 2000 saw 37.5%, which was slightly less than 1999's

rate of 42.8%. However, the amount of property stolen was about 62.7% higher than in 2000.

■ Total amount of theft was \$24,050. Eighty-eight thefts from various locations took place in 2001.

■ A total of 370 traffic citations were issued, while a total of 1,115 traffic warnings were issued during that same period. That is one citation issued for approximately every four vehicles stopped.

■ A total of 1,725 complaints were handled by the department in 2001. This compares to 2,115 complaints in 2000 and 2,274 in 1999.

■ A total of 67,541 miles were patrolled in 2001 while 64,211 were patrolled in 2000.

The top five complaints handled by the Kewaskum Police Department:

1. Issue of Worthless Checks- 117
2. Disorderly Conduct- 75
3. Criminal Damage to Property- 42
4. Report for Record- 34
5. Underage Tobacco Violations- 27

Of the total 370 traffic citations, 93 were for driver's license violations.

The department issued 759 parking tickets in 2001 compared to 513 in 2000 and 528 in 1999.

The department investigated 73 traffic accidents in 2001, compared to 88 in 2000 and 71 in 1999.

Freshmen Sports Reinstated

Farmington Elementary Still Remains Without Full Time Principal

Monday night's Board of Education meeting started off on a slightly rough note. Farmington parents addressed the board with their concerns of not having a full time principal at the school. The school currently has a half-time principal and that is all that is budgeted for the next school year.

The parents stated that they did not understand how the school can be dealing with such a deficit and didn't feel that the board was detailed enough in their costs and deficits. She stated that she would like to see the books the district kept and threatened to go through an attorney if needed. The board reassured her that it wouldn't be necessary because they are public record.

Another parent stated that she didn't think other districts were having budget problems. Board and other audience members assured her that there were many other schools with the same problem.

On a more positive note, HOPE School teacher Gail Dehnel stated that she was very happy that the HOPE school stayed in the budget. She was however concerned about the proposed cut of Jason Olsen's position. He is a part time physical education teacher at Farmington and then teaches the other half of the day at KHS's HOPE school. She was concerned that cutting the position would hurt the one-on-one time she and Jason spend with the students. She also stated the kids like him because he's a younger teacher.

The board also made decisions on what to do with the proceeds from selling Beechwood school. The board voted to use the \$65,190 for different building/maintenance items at the high school. \$33,800 will be used for security cameras at the high school. The remaining \$31,390 will be used to repair some of the roof at the

high school. The repairs to the roof are desperately needed as Paul Reichert, business manager, pointed out, the roof is actually leaking.

John Schulte, who ended up voting against the motion to use the money for the high school, thought the money should be used for a principal at Farmington. Mary Meisser didn't think it was a good idea due to the fact that this is one-time money and it won't be there next year. "It's important to be fiscally prudent. I would like to see a full time principal, but I don't think we should do it with money that ends. It's (money) from a building for a building."

The board also approved the 2001-2002 budget transfers.

With this year's budget out of the way, the board moved on to the 2002-2003 budget. Paul Reichert presented the budget complete with possible tax rates. The tax rate won't be finalized until October of 2002 once the district knows exactly how much state aid they will receive among other variables. With an estimated equalized value of 3%, which Reichert states is a conservative number, the mill rate could increase by 10¢, bringing it up to \$9.21.

The budget the board tentatively approved does include freshman sports but still does not include middle school second teams and intramurals and cheerleading.

The budget the board approved is not set in stone and can be changed at any time before the annual meeting in September.

The board also discussed possible building sites for a new middle or high school. Board President Gordie Dickman stated that he had been approached by a landowner, but this person did not want to go public yet.

The board approved four resignations. James Westphal resigned from girls golf, Mary Holfeltz from volleyball, Mollie Flood from a 70% CD specialist and Mark Cloutier from math.

The board also asked the school principals to come up

with a realistic "wish list" for their building with the help of the teachers. Board members were presented with the preliminary list at the meeting. Dickman assigned board members to pursue different areas of the lists to see what and why some of these things are wanted. The board will hold a workshop on Tuesday, June 25 at 6:30 in the Administration/Community Building.

Kohn and Becker Reunion To Be Held June 15 in Kewaskum



A family reunion is being held on Saturday, June 15th at the old park pavilion next to the Kewaskum Historical Society Museum on Park View Drive in the village of Kewaskum. The reunion will mark the 150th anniversary of the Kohn family coming to America and it will be 150+ years for the Becker family as well. This event will run from 10 a.m. to 5 p.m.

All descendants and kin of the Kohns who settled in Kewaskum and the Beckers who settled in Campbellsport are welcome to attend. In addition to all direct relations invitations are also extended to families such as Hess, Bonescho, Matheau, Thill and Bach which have an affiliation with the Kohns and Beckers in the Loraine region of France.

The all day event gives time for people to gather and get acquainted before lunch and then many other activities will follow in the afternoon.

Activities will include a raffle, a car tour of the old Kohn farmsteads and St. Bridget church, where they attended church, in rural Kewaskum among other things.

Everyone who attends is expected to bring their own foods, desserts, refreshments and of course utensils for an outdoor potluck or picnic setting. This picnic will begin at noon. It is also advised to bring extra seating in case it is needed.

Some who may want to start a game or other sports activity should bring the necessary items with them.

There will be charts, photos and other family memorabilia present and others are encouraged to bring theirs to share with all who will be in attendance.

These two families which originally settled in rural Kewaskum and Campbellsport areas united by a common origin and ancestry centered around the tiny village of Berig, France.

The first to come was Christopher Becker and his wife Katherine (Kieffer) who, in 1849, settled on a farmstead which now adjoins the south end of the village of Campbellsport. They had two children when

they arrived and had 5 more in America. Their descendants are found throughout the area and abroad today.

Christopher Becker had a sister named Maria Becker living back in what is now the Moselle region of France. Maria Becker was married to Francois Kohn who was the oldest of three brothers who decided to come to America in June 1852. All three Kohn brothers bought farmland near each other. Franz Kohn bought a farm straight south of Christopher Becker's in the extreme southwest corner of Auburn township which borders Kewaskum township. This allowed his wife Maria to be reunited with her brother and his family in Campbellsport.

The other two Kohn brothers, Theobald and Peter, bought farmsteads in the northwest corner of Kewaskum township within a short walking distance from one another and which was also near that of their older brother Francois or Franz as he was later known.

The Kohns all attended St. Bridget church in those early days.

In 1858, Peter Kohn was united in marriage with Maria Noll and in 1860 her sister Victoria was united with Theobald Kohn.

Between these two couples were born 30 children (15 kids each).

Maria and Victoria Noll were the daughters of Franz Anton Noll who was quite active in early Kewaskum and West Bend area Politics. Franz Noll served as Postmaster and Register of Deeds for many years. By his hand the very first civil birth records were recorded in the county.

Ironically the first birth

records in the Washington County Courthouse are those of his daughters Maria and Victoria. Even more interesting these birth records note that the two Noll girls were in fact born in Ohio in the early 1840's before the family settled here in Wisconsin.

When it comes to the need to start recording civil birth records for the county it appears that family came first even if they were not born there. The subsequent three birth records were of his three sons by his second marriage. This time they were born in Wisconsin but still many years earlier than when their births were officially written down at the county courthouse in West Bend.

When the Civil War broke out all three Kohn brothers decided to enlist and they all served with distinction throughout that conflict. After the war they quickly returned to their farmsteads to resume their work and family life.

Franz Kohn remarried to Lucia Schoenhafer in 1870 after the death of his wife Maria. Between Franz and his two wives there were a total of eleven children and when added to the children of his two brothers Peter and Theobald this makes a total of 41 Kohn children within the first American born generation.

By now there are many more descendants and it is hoped as many as possible will be able to attend this event.

Peter and Maria Kohn observed their 50th wedding anniversary in 1907 and Theobald and Victoria Kohn were able to do the same in 1910. They were all sturdy hardworking people and were able to make many great contributions to their families and communities.

Many Kohn and Becker descendants are expected to arrive for this one day event including Kathleen Oberley of Iowa City, Iowa. She is a descendant of Theobald Kohn and has done a remarkable job in tracing the Kohn and Becker ancestries back centuries. She is also preparing genealogies of the three Kohn families.

There has been no sizable Kohn reunion for about 40 years and this will be an occasion to be remembered for all involved.

Still not seeing them, she paused, then directed, "I would like my father and mother to please stand up at this time."

Two people, looking quite sheepish and confused, stood up. It was at this point that their daughter, beaming, said, "Audience, I would like to introduce you to my parents. I have asked them to stand along with me because I would not be up here today had it not been for them. And now I would like everyone to give them a big round of applause because they are the ones who deserve it more than me."

And applaud they did - with such vivacity that it seemed the noble efforts of parents everywhere were being honored.

Parenting. This most sacred duty cannot be understated. Of this I am convinced: the firm foundation from which a parent's deep running roots of commitment establish and uphold their children, is also the springboard which can launch them to new heights. The fruit of efforts made to teach our young all that is good and true and worthy will see its season of blossoms as surely as New England cherry trees opening beneath May sunlight. RECYCLING TIPS

Newsprint and Magazine

TYPE OF NEWSPRINT AND MAGAZINES: Basically all types of newsprint and magazines can be recycled. Waxed paper and other waxy paper goods are not accepted. Office paper and computer paper may also be recycled.

PREPARATION: Tie in bundles with twine or strong string. Bundles should be limited to 8" in height. Office and computer paper may be bundled or shredded and stored in plastic see through bags.

Place bundles at the curb next to the dark green recycling bin or blue recycling bag. Place the bin or bag, at the curb on the same day that your solid waste is to be collected. Pick up will be Wednesdays for both solid waste and recyclables. Multi-family dwellings of six or more, remember, your recycling pick up will be the 1st and 3rd Wednesdays of each month.

NOTE: If raining on collection day, please hold cardboard until the following week.

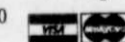

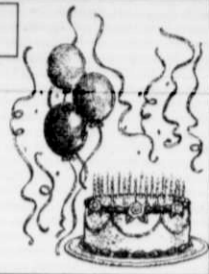

Mid Monthly Meeting
May 20, 2002
8:00 p.m.

The Village Board of the Village of Kewaskum, Washington County, Wisconsin, met in Regular Session in the Council room of the Municipal Building, 204 First Street.

President John D. Kenworthy presided. All Trustee Members were present. A quorum was present.

The meeting was opened with a Moment of Silence and the Pledge of Allegiance.

On a motion by Trustee Thomas Piwoni, seconded by Trustee Robert Stoltzmann and unanimously carried by voice vote, the minutes of the May 6, 2002 were approved as printed.

Fire Chief Mark Groeschel was absent and did not have anything for the Board.

Police Chief Richard Knoebel presented the Annual report of the Kewaskum Police Department for 2001:

1. Total index crimes, those reported to the State on a monthly basis, increased 11.1% in 2001.

2. During 2001, all crime rates in Kewaskum were considerably lower than those of the entire state and slightly higher than comparable communities.

3. During 2001, 25 of 100 or 25% of reported index crimes were cleared by arrest. The 2001 clearance rate is lower than the 2000 clearance rate of 28.9%. It is comparable to the statewide clearance rate of 24.9%.

4. Total adult arrests increased by 16.8% from 273 in 2000 to 319 in 2001.

5. Total juvenile arrests decreased by 20%, from 230 in 2000 to 184 in 2001.

6. The property recovery rate for Kewaskum of 18% is less than its 2000 recovery rate of 37.5%. However, the amount of property stolen was 62.7% higher than 2000.

7. There was a total of 370 traffic citations issued in 2001, while there were a total of 1,115 traffic warnings given during the same period. That is one citation issued for approximately every four vehicles stopped by the Kewaskum Police Department.

8. The Kewaskum Police Department handled 1,725 complaints in 2001 compared to 2,115 in 2000.

9. The Kewaskum Police Department patrolled a total of 67,541 miles in 2001.

The Board asked several questions of the Police Chief and discussed the school liaison officer program. The Board also expressed their thanks to the Police Clerk for a job well done on the Annual Report.

Director of Public Works Jerry Gilles reviewed the following:

1. The Board was informed that the concrete work at the KKCP bathroom was in the process of being replaced.

2. The storm sewer/catch basin work previously discussed is also being fixed and the new curb and gutter concrete work is being completed.

Administrator Daniel S. Schmidt reviewed the following with the Board:

1) Review League and Taxpayer bulletins.

2) Reported on the Board of Review meeting of May 13, 2002. It was noted that no one appeared before the Board and that the assessed value of the Village has increased \$4,472,700 or 3.6% and that the total assessed value without manufacturing is at \$128,057,300.

3) Review building permit report

for April 2002, noting that permits are ahead of 2001.

4) Review of correspondence. Trustee Mathew Heiser, Chairman of the Park & Recreation Committee report on the request for closing the RHP the day prior to the area youth fishing day. On a motion by Trustee Larry Ammel, seconded by Trustee Thomas Piwoni and unanimously carried by voice vote, the Board authorized the closing of River Hill Park to fishing from May 31, 2002 noon to Saturday June 1, 2002 9:00 a.m.

Board representative for the Plan Commission, Trustee Andy Pesch announced a scheduled meeting for Tuesday, May 28, 2002 at 7:00 p.m.

Board Representative of the Library Board, Trustee Mathew Heiser indicated that the May report will be given at a future meeting.

Mid Moraine Municipal Association Legislative Committee Board Representative, Trustee Robert Stoltzmann reported that the committee met on Wednesday, May 8, 2002 at 7:00 p.m. The topic was again the States budget problems.

Discussion was held on the recommendation from the Board of Review regarding the approval of a contract to complete the Revaluation and Assessors Contract for 2003 as mandated by the state. It was noted the current village assessor, Bowmar Appraisal, prepared a proposal and that the funds for said work have been budgeted. On a motion by Trustee Robert Stoltzmann, seconded by Trustee Larry Ammel and unanimously carried by voice vote the Board authorized signing the contract for said revaluation and contract work for 2003 at a cost of \$43,600.

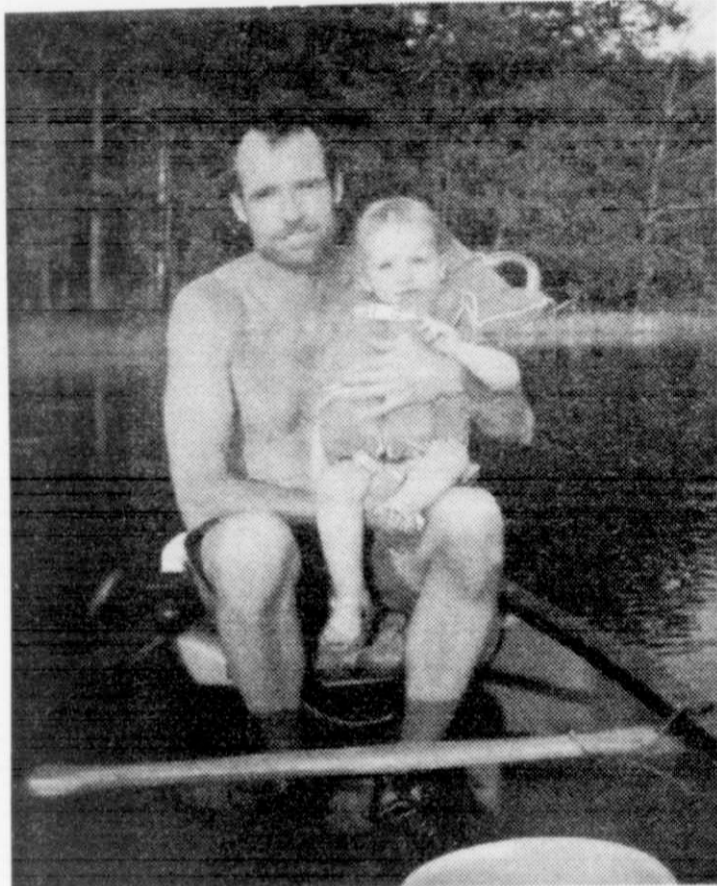

Hello friends,

We found what looked like a hot spot, but they weren't for big fish, just small. We were fishing about 3/12 hours and Selina was very good. We tried about five different places on the lake but had poor luck."

My concern for Laurie and the boys was for no rea-

son. They caught several perch and kept 10 dandies.

Selina, who I was testing for a more serious trip, was a riot. She had a blast in the canoe, even though she didn't take a nap.

Tonight, at 11 p.m., she still had more energy than anyone else in camp.

Kevin, who hopes to be a defensive end on the Necedah seventh-grade football team, had this to say: "The start of Sunday was when we started to good quality and quantity of perch. I used a blue spoon off the dock and caught one after another. Then it was Mark's turn. We all stayed on the dock and tried jigging, catching about 100 perch and keeping 25."

We played cards and talked about being good sports, feeling like we have gone back in time, with only AM radio, heating water to wash dishes and clean ourselves. No motor boat - just manual labor. It's fun to be thinking in the past."
