## C-Sport Man To Run For 59th District Assembly Seat

A well known local politician has decided to try his luck at winning a seat on the state assembly in the newly created 59th district.

Much hype has stirred up since federal courts redrew the boundaries weeks earlier.

Thomas "Tommy" Thompson of rural Campbellsport announced officially he is running for the 59th Assembly District.

Thompson, 54, is married with two grown children. He is a life-long resident of the Town of Osceola.

No stranger to politics, Thompson has previously served six years as a Town of Osceola supervisor, served on the town's persons and property protection committee and is presently serving as chairman of the zoning board.

Active in his church, Trinity Lutheran he serves as council member, treasurer, secretary and financial secretary. He is also a member of the Waucousta Lutheran Grade School and their secretary-treasurer.

A self-made business owner Thompson says, "I have farm land and rental properties and know first hand about unnecessary government regulations, and being suffocated by paper." In addition to the rental properties he was the sole proprietor of Tom's Gun Repair for 25 years from which he has since retired.

He also operated with employees, Thompson Electric.

Sheboygan County Board Chairman Daniel LeMahieu, 55, also announced recently that he was entering the race with Thompson on the Republican ticket. He resides in the Village of Oostburg.

LeMahieu, has been serving for 14 years on the Sheboygan County Board, presently serving as Chairman. Previously he chaired the Finance Committee and the Personnel Committee.

He has owned his own business, the Lakeshore Weekly, in Oostburg since 1983. LeMahieu says being a small business owner has given him an understanding of the challenges that state government imposes on businesses, both in paperwork and high taxes.

LeMahieu has also been a lifelong resident of southern Sheboygan County, stating that he is familiar with the problems facing the farming areas of the district and the villages and towns.

"My campaign will focus on my leadership abilities, my business experience and my conservative approach not only to fiscal issues but also social issues," said LeMahieu.

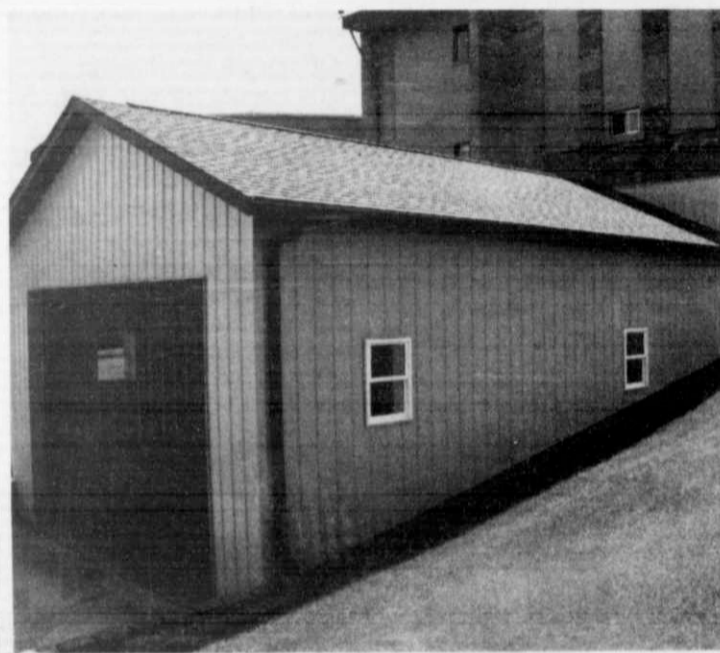
Another emerging candidate, Sheboygan alderman Anthony Bonnett has announced his Republican candidacy.

Bonnett says his top priorities are reducing taxes, controlling spending, promoting jobs, and a responsible approach to solving the state's budget crisis. "We need to get serious about getting the state's finances back in order without tax increases that hurt families and cost jobs," said Bonnett. Bonnett has taken a firm stance, as a representative of the people, that "less government in better government."

Bonnett and his wife, Jill, are active in the community and church.

The concerns of 15 village residents fell upon deaf ears at Monday's Kewaskum Village Board meeting.

The hot topic at the board meeting was for RAMKO's Brian Kober to get a rezoning request passed. The request asked for a lot in RAMKO's R-1 subdivision to be changed to R-2 because the lot with the R-1 zoning would not allow a home to be built on it. Changing the zoning would allow that and then the lot could be sold.

The idea of using the property as a neighborhood park was discussed in length by the village's economic development advisory committee and planning commission. Kober at no time seemed to be conducive to the plan of a park citing the size of the lot being small and he did not like the idea of the financial burden the

park would be on the village at a time when the village is clamping down on its expenditures.

Residents of the neighborhood didn't like Kober's rezoning idea from the start.

The planning commission met in late May and could not give the village board a yes or no answer on what they thought of the plan. When voting came around, a tie was had and it was decided to send the request on to the board without any recommendation.

That didn't seem to have any effect on the board members, all of who voted in favor of the rezoning that village engineers gave a thumbs up to.

RAMKO partner, Peggy Kober, stated that they (RAMKO) already had people looking to buy the lot that would give them a seven foot backyard.

Plan commission liaison to the village board Andy Pesch stated, "If the village engineers say it's ok, I think we have to ok it."

"It's frustrating because I would have much preferred to see lot 17 as a small neigh-

borhood park. A lot of people did. It is the strong feeling of the Village Board on recommendation from the Economic Development Committee that all new developments explore the concept of incorporating parks into their designs. Because there are no parks currently in that area of the Village, this seemed to be a particularly appropriate request. Unfortunately, that was not the nature of the matter before the Board. In my opinion, the Village can not zone lots in a way that can't be used. The whole point of zoning is to control the use, not create unusable lands," stated village president John Kenworthy after the meeting.

At a previous meeting the board approved the purchase of a 1987 Ford LNT 8000 dump truck, including plow, wing and tailgate sander from Cooley's, in West Bend for \$33,120 the DPW traded in a 24 year old

## Campbellsport Building Supply Acquires Precision Metal Building

Campbellsport Building Supply (CBS), a building material retailer focusing on home designs and building supplies, has acquired the land and building formerly owned by Precision Metals, Inc. located at 100 W. Precision Drive, Campbellsport.

The new acquisition may serve many purposes. The main reason for the purchase was to protect the current jobs and the current business leasing the 37,000 sq. foot building. There are currently 13 full time people, most from within the village limits, that work in approximately 1/3 of the available space. "Our number one concern is the people and businesses of Campbellsport. Without them we are all in trouble. So, making sure jobs and businesses stay here has always been important to us," stated Albert Fleischman, president of CBS.

Campbellsport Building Supply has no immediate plans for the remaining space. They are looking into

many possibilities. The additional space and five acres of land that adjoins CBS may be used for future growth of CBS, leased to an interested business, or used in some undetermined way. Lumber suppliers of Campbellsport Building Supply has also shown interest in using the facility temporarily for large scale storage.

Joel Fleischman, vice president of CBS remarked, "With the support of our local builders and remodelers we do not want to limit our service to them. We are always looking to stay a step ahead of our industry. When you stop in our showroom or yard we are constantly remodeling and tweaking to make us better. This purchase is just another step in that direction."

Located at 227 West Main Street in Campbellsport, CBS serves builders, remodelers, and homeowners in Campbellsport and the surrounding communities. The 17 year old company now operates on seven acres of

land in downtown Campbellsport. Campbellsport Building Supply and its sister company, Berlin Building Supply, employs over 30 full time employees.

## YMCA Partners With Health Dept. To Help Community 'Walk to Wellness'

The Kettle Moraine YMCA recently announced that it will begin a new program in partnership with the Washington County Health Department. The program is designed to last 12 weeks since it takes about that long to establish a new health habit, but, as Lange points out, "People will feel the benefits of increased activity much sooner."

Once registered, participants will attend an orientation session at the YMCA on Tuesday or Thursday, June 18 or 20. Walkers can stop by any time between the hours of 9 to 11 a.m. or 5:30 to 7:30 p.m. on those days. Staff will be available to help set up pedometers, give demonstrations and answer questions.

The mission of the Kettle Moraine YMCA is to put Christian values into practice through programs that build a healthy spirit, mind and body for all. 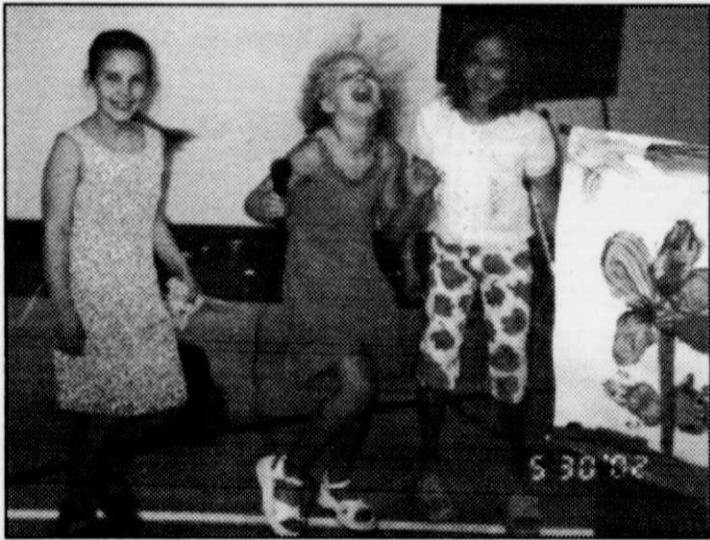

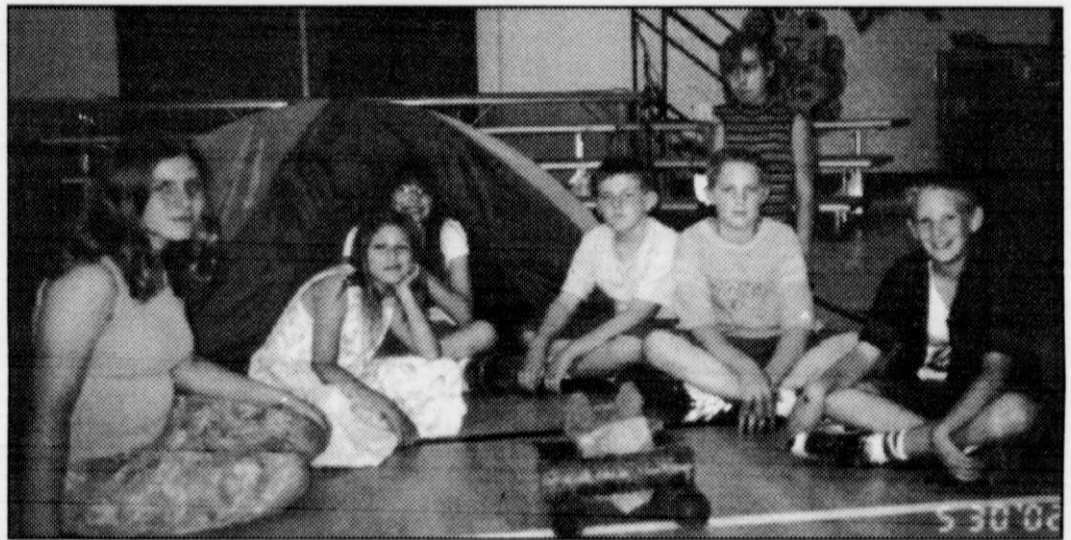

The Kewaskum Water Utility routinely monitors for constituents in your drinking water according to Federal and State laws. The following tables show the results of our monitoring for the period of January 1st, to December 31st, 2001.

**Health Information**

Drinking water, including bottled water, may reasonably be expected to contain at least small amounts of some contaminants. The presence of contaminants does not necessarily indicate that the water poses a health risk. More information about contaminants and potential health effects can be obtained by calling the Environmental Protection Agency's Safe Drinking Water Hotline at (800-426-4791).

Some people may be more vulnerable to contaminants in drinking water than the general population. Immuno-compromised persons such as persons with cancer undergoing chemotherapy, persons who have undergone organ transplants, people with HIV/AIDS or other immune system disorders, some elderly, and infants can be particularly at risk from infections. These people should seek advice about drinking

public water systems by May 6, 2003. The assessment will identify land areas that contribute water to each system, significant potential contaminant sources within those areas, and the susceptibility of the drinking water systems to contamination. **Educational  
Information**

The sources of drinking water, both tap water and bottled water, include rivers, lakes, streams, ponds, reservoirs, springs and wells. As water travels over the surface of the land or through the ground, it dissolves naturally occurring minerals and, in some cases, radioactive material, and can pick up substances resulting from the presence of animals or from human activity.

Inorganic contaminants, such as salts and metals, which can be naturally-occurring or result from urban stormwater runoff, industrial oil and gas production, mining or farming. Pesticides and herbicides, which may come from a variety of sources such as agriculture, urban stormwater runoff and residential uses. Organic chemical contaminants, including synthetic and volatile organic chemicals, which are by-products of industrial

The zoning that would be requested would be R-1 Single Family Residential District and R-4 Multi-Family Residential District. President John Kenworthy informed the Board that at an EDAC meeting some committee members raised the need for additional greenspace. On a motion by Andrew Kuehl, seconded by Andy Pesch and unanimously carried by voice vote, the Commission approved the preliminary plat noting the need to indicate the right-of way (easements) for the villages future trail system sending it for discussion to the Village Board, review by the Village Attorney and Village Engineer.

A review of the preliminary plat for Homestead Hollow a proposed development in the northeast corner of the village. Mr. Brian Kober one of the developers is proposing to develop 23 single family lots. The developers are requesting a minor deviation from the Villages Land Use plan regarding the street layout and larger lots. There were four points raised by the developer 1) One lot is a little smaller than the R-1 zoning, but would meet the R-2 zoning, identical to the adjacent already developed land. It was noted that if this was to occur a rezoning request would need to be received by the Village and the process followed. 2) The proposed street layout which varies from the land use plan, was warmly received by the Commission. 3) A request to alter the village street width standard from 66 feet to 60 feet. The developers informed the Commission that all four ingress and egress points had 60 feet of ROW and was asking to continue with that same ROW. The street width would remain identical the same as in a normal 66 foot ROW with the only difference being an 8.5 foot greenway instead of a 5.5 foot greenway. The Commission was split on this point with the majority in support of the 60 foot ROW. 4) The standard for curb/gutter using the vertical face curb to be waived to use what is known as

mountable curb. The pros and cons regarding this type of curb was discussed. Several neighbors were present and in general were support of the development of all the points with the exception of possibly using lot 18 the smaller lot for a playground area. The Commission supported the discussion regarding a neighborhood park. In the discussion with the Village Board the item of a neighborhood park will be discussed as sent to it from the Commission in reference to land verses the open space fee. After considerable discussion on a motion by Leeann Butschlick, seconded by Frank Beesten and carried by the majority by voice vote, the Commission approved the preliminary plat acknowledging the use of mountable curb, discussion on the location ROW for trails, street layout, and ROW reduction to meet existing access points at 60 feet, with proposed discussion for greenspace (neighborhood playground). The vote was 4 Aye 3Nay 0 Absent.

The Commission reviewed the Certified Survey Map as submitted by Steve and Jill Ebert at 1336 Stark Street. This CSM is for the creation of a single family lot, which is already zoned R-2 Single Family Residential District. On a motion by Richard Schmidt, seconded by Leeann Butschlick and unanimously carried by voice vote, the Commission authorized signing said CSM and recommended it to the Village Board with a favorable recommendation.

The Commission reviewed a concept plan for a proposed development from Thomas Timblin for a parcel located in the southwestern corner of the village. The plan was similar to the land use plan, but it was noted the main street as well as all street should be using the village standard of 66 feet of ROW. Also a street stub is needed to the west at or near lot 24 and that a street dedication or reservation is needed to access Bonnie Lane and the proposed north south street on the east side of the creek. No action was taken, but the Administrator will notify the owner of the discussion.

Mr. Rick Kania was not present for discussion on the Zoning Ordinance.

On a motion by Frank Beesten, seconded by Richard Schmidt and carried by the majority roll call vote, the Commission adjourned the

meeting. Roll call vote was 7 "Aye" 0 "Nay" 0 "Absent".

## Requiem For a Junior Firefighter

**BROOKHAVEN, PA** - Christopher Kangas, an eighth-grader at Northley Junior High School and a junior fireman in Brookhaven, died at Children's Hospital from multiple head traumas as a result of being struck by a 16-year-old driver while answering a fire call on his bicycle.

"We're just devastated," said Jon Grant, President of the Brookhaven Fire Company. "He was just a great kid. I can't believe it happened. It's worse than a nightmare."

Kangas, who would have turned 15 in the days following the accident, was responding to an alarm that he heard while sitting in the home of Brookhaven Policeman Mark Messner when the accident occurred.

"We were just sitting there getting ready to have a barbecue and we heard the sirens," said Messner, who has only been on the Brookhaven police force for one of his 12 years in the field. "He was asking me, 'Is that us, is that us?' Then he got on his bike. I told him to be careful, and that I'd put the hamburgers on."

Kangas proceeded to pedal to the Brookhaven Police Station where he checked in with Officer Adam Brown who was on patrol.

"He asked me if I knew the nature of the alarm," said Brown, who has been on the Brookhaven Police force for nearly three years. "When I told him I didn't know he just left. The accident happened about two minutes later."

"When I got the call that it was him I was stunned and shocked. I had just seen him. In my three years on the force, Saturday was one of the hardest and longest shifts that I've had to (endure)."

Although the accident is still under investigation there is no indication of wrongdoing on the part of the driver according to Brookhaven Accident Investigator Richard Fuller.

"Basically it's a tragic situation involving two inexperienced kids. One on a bike and one behind the wheel of a car," Fuller said.

The driver of the car had only had his driver's license for two weeks prior to the accident.

As it turns out, the fire call was not in Brookhaven at all. "We got a call to be on stand-by for a house fire in Concordville," said Grant. "We hadn't even left yet, when we got the call on Christopher's accident. We sent a truck over there right away, and our EMTs were doubly devastated to find out who it was when they arrived at the scene."

Pennsylvania law does not allow junior firefighters to actually be involved with the fighting of a fire. They are not allowed in a burning building or near a car fire. Yet, the time they spend in the firehouse gives them valuable experience.

"He was learning the job," Grant said. "He was training at the fire house, and learning what it took to be a fireman. Mostly, when we would get a call, he would help us get ready to go, or stay back at the house to help out whoever was still around. Every free moment he had he was in the firehouse. All he wanted to do was be a fireman. It's what he enjoyed the most."

Kangas had been a junior firefighter in Brookhaven for one year.

Aside from spending a good amount of time in the firehouse, another of Kangas' hobbies was collecting trading cards. Most teenage boys collect trading cards of their favorite sports heroes, but Kangas wasn't interested in getting Barry Bonds, Shaquille O'Neal, or Donovan McNabb.

"He was a real big collector of police officer trading cards," said Brown. "He would stop in the station pretty often, or stop us when we were out on patrol. Most of the time it was just to say hi, but he was really into those trading cards and was always asking us about them."

Many of the Brookhaven

police officers befriended Kangas, but none more than Messner. "He was my neighbor," said Messner. "He used to spend a lot of time at my house with me, my wife, and my two-year-old daughter."

"He always wanted to help out. If my wife was busy with something, Chris would be like a babysitter for my daughter and keep her occupied. If my wife came home from grocery shopping, Chris was right there to help her bring the bags in the house."

"I told my wife if she absolutely had to go out of the house at night to ask Chris to go with her. He wouldn't even pause. He was willing to tag along with her anywhere she went. He was just a tremendous kid."

As a tribute to Kangas, every Brookhaven fire truck and emergency response vehicle gathered at the accident site where a number of fireman spoke to honor their fallen comrade.

"We have a lot of young guys in the company," Grant said. "It hit them especially hard. They needed to say some things as part of the mourning process, and it was something nice for Christopher too."

Despite the fact that Kangas did not die in an actual fire, Brookhaven Fire Company provided him with full honors at his funeral. "(We brought) out all the trucks and everything for the kid," Grant said. "He died responding to a fire call as if he was on duty."

A tragedy of this kind won't go away easily, especially for Messner and his family.

"My daughter walked out on our lawn this morning and pointed to his house and said 'Chris, Chris,'" Messner said. "She's only two years old. How do you explain to her that he's gone? There's no way. There's just no way."

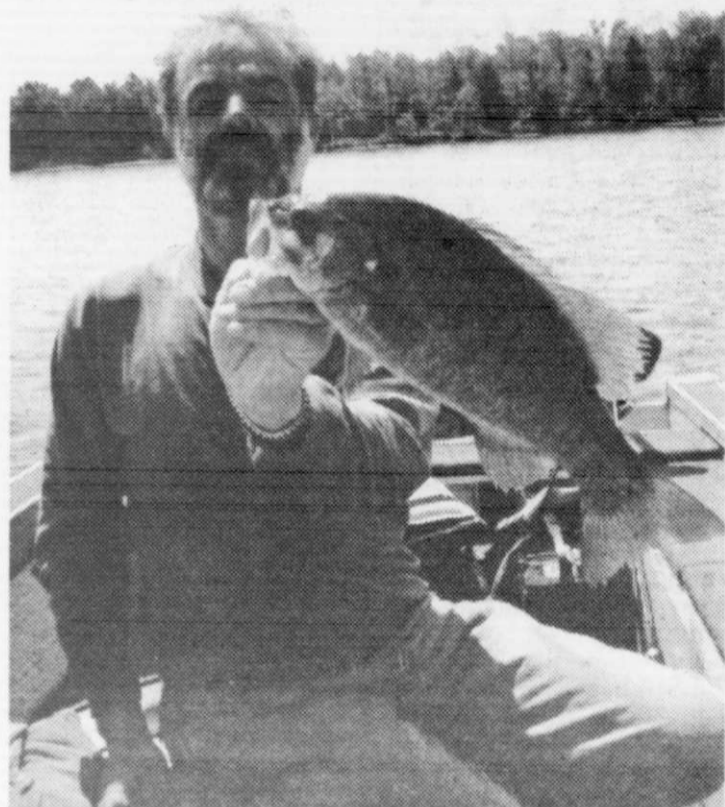

## Football on the Bay

Hello friends,

This week's column is once again about great fishing and good friends. I met J. Bird Kornfehl last July when I spent a day on his boat fishing on the Fence Lake near Minoqua.

J Bird, who lives on Trude Lake, which is part of the Flambeau Flowage, is a fishing and bear hunting guide. He comes closer to living the daily life of any outdoorsman than anyone else I know.

Since last July, we have become pretty good buddies, and this week, I had a blast fishing for smallmouth bass on Chequamegon Bay near Ashland on Lake Superior.

**Thursday, June 6**  
**High 81, Low 56**

J Bird and I were short on sleep as we made the 75-mile journey from Trude Lake to Ashland this morning. We went out to eat and made the mistake of drinking lots of ice tea.

The caffeine in our systems had us both staring at the log walls in his cabin until the birds were chirping to greet the new day.

My fatigue vanished

this morning as we were launching J Bird's 16-foot Alumacraft Deluxe.

I had a conversation with a fisherman and his son who were from Iowa. They had caught 83 smallmouth a week earlier, including a 24-incher.

With very little wind to blow us off the water, clear skies and the report we just heard, we hit the big lake with fishing on our minds. J Bird does the vast majority of his guiding on the Flambeau and Trude Lake. Today was more or less for exploration. It has been two years since he's fished on Chequamegon Bay.

After roughly a three-mile boat ride, we reached the shallow waters of Chequamegon Point.

Beautiful is the perfect word to describe this area. Other than an occasional duck blind, there is no sign of man's presence.

During the last mile of our voyage, the water was 3-4 feet deep and crystal clear with a sandy bottom.

J Bird was looking for small pockets of water 6-8 feet deep with either weeds or wood structure.

When he found about a two-acre area such as I described, he dropped anchor, tied on a No. 10 hook and attached a bobber. Before my knot was tied I heard J Bird say he already had one on.

The football with fins and a tail gave a valiant effort, was boated and released.

The first fish of the day was 19 inches long. Had the season been open (it opens June 15), it still would have been released.

Smallmouth on Chequamegon Bay have to be 22 inches long to be kept. The 22-inch limit is what has created a truly world class fishery. As I witnessed today, fishermen from throughout the Midwest trailer their boats and head up to Ashland.

Today would be one of excellent fishing and lots of laughter. J Bird landed three smallmouth before a hungry fish gobbled up my three-inch sucker minnow.

When I set the hook, my line broke. Fifteen minutes later, my pal had caught five footballs and was starting to feel sorry for me.

A good fish submerged my bobber, and I thought my comeback had begun. But once again, my line broke. I was actually becoming embarrassed.

I was using a quality 8-pound mono and decided to put on 10-pound Fireline. Five minutes later, my bobber vanished. I set the hook and my line snapped.

Meanwhile, J Bird was becoming worn out from landing 17- to 20-inch smallies. I kept telling him that when I rebound, he will be in for quite a show.

An hour after we hit the water, my rebound began. Whatever was attached to the other end of my line was big and stayed on the bottom.

The first time she came up to the net, we saw it was a big northern pike. Unfortunately, she tore a hole in J Bird's net. I was then faced with the predicament of fighting my gator through his net.

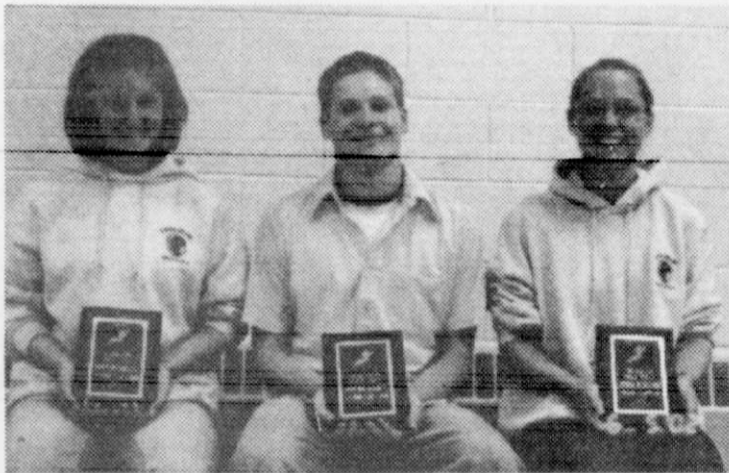

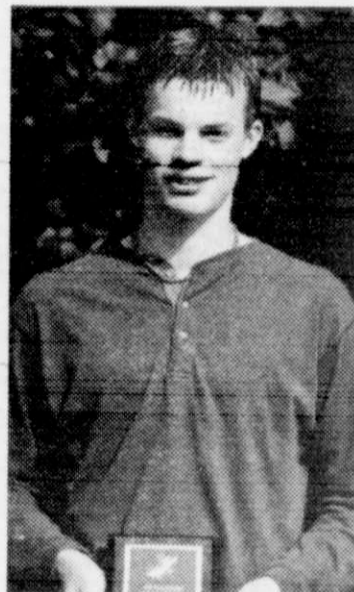

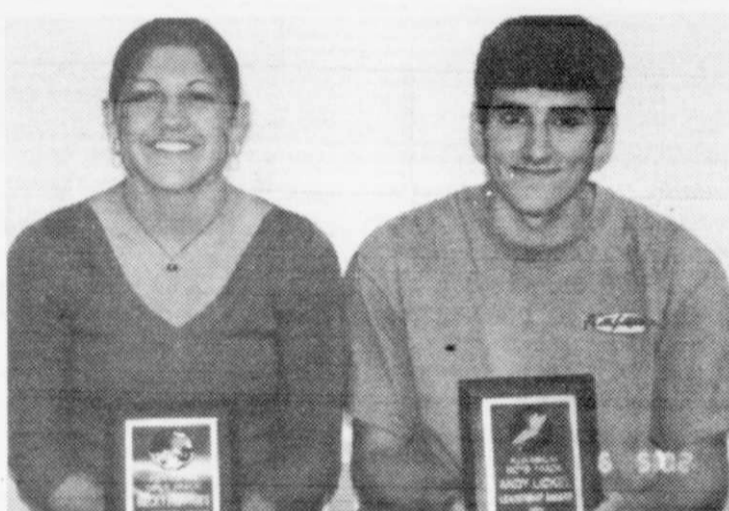

Coach Gosa also recognized the Kewaskum girls 4 x 400m relay team of Becky Herriges, Jessi Graham, Jenna Roecker, and Breyan Donath for finishing eighth at state last year and then finishing third this year.

Coach Gosa wished all the seniors good luck next year and encouraged them to return next spring to see some of the track meets. Coach Gosa also reminded the athletes of the importance of off season weight training, running, spinning classes, cross training, and participation in fall and winter sports, so that they can achieve even more success next track season.

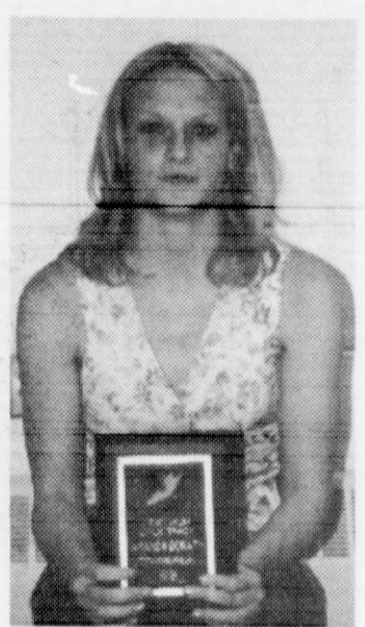

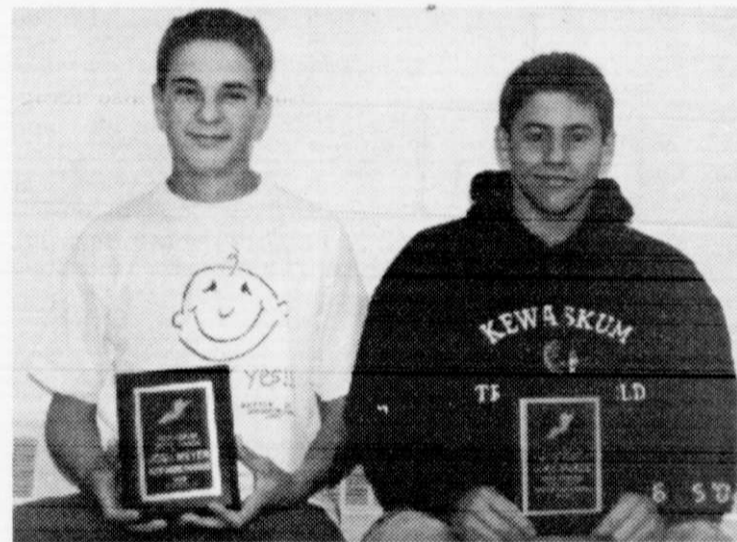

Hundreds of motorcyclists roared into Kewaskum on Saturday as part of the fourth annual John Schmitt Memorial Ride. The event, which started at Bob's Harley in Fond du Lac, wound its way around several establishments in Washington County before wrapping up in West Bend.

In Kewaskum the ride stopped at the Grand Larsony. Motorcyclists began pulling into town around noon. Bar owner Richard Kissinger said he likes being part of the event because Spike, frequented the tavern and a lot of people respected him. "It's only right that we have a memorial for him," said Kissinger who has seen the ride grow tremendously over the years. "I remember the first year there were about 500 people and now there are about 750 who take part."

One of the participants this year was Stacy Anderson of Kewaskum. She was riding with her husband Eric on their pearl white 2000 Harley Fat Boy. "This ride is too cool, seeing all the other bikes up in front of you cranking around, you just have to see it," she said. This was the first year Anderson was actually able to ride in the event and she said it was a good time to catch up with friends and enjoy the benefits of the Kettle Moraine. "Riding out here today we were with a pack of about 20 bikes. You look up and down the back roads and there's another group of bikes. It looks so cool."

This year the Kewaskum American Legion Post 384 set up a brat and hamburger stand for the riders. Al Barutha said the proceeds from the sale would benefit

the John Schmitt Scholarship at Kewaskum High School and a police survivors group. "I think the ride has always been good for the community," said Barutha. "A lot of the businesses benefit from the motorcyclists coming through town and it shows the bikers that they're welcome in Kewaskum."

Jeremy Van Assche of Kewaskum has been participating in the Schmitt Ride for the past three years. On Saturday he was riding his blue and silver 1999 Dyna Wide Glide. "It's for a good cause," he said. "Plus I have some friends that are Washington County deputies and I ride to support them and the whole force."

Over the years the Schmitt ride has grown. The idea to honor Schmitt, after his death in September 1998, came from his friend Mike Geldreich. During the event, Geldreich was busy tying up loose ends and trying to keep things moving along. "The event has really taken off over the years," he said. "We tend to see a lot of the same people, but that's good because it shows they're having a good time and support the cause."

This year the Schmitt Ride began in Fond du Lac just after 11:30 a.m. Riders had to make five stops to complete a poker hand, visiting participating taverns such as Guerdnt's in St. Lawrence, The Grand Larsony in Kewaskum, The Mousetrapp in Boltonville, West Bend Harley, and Our Place Tavern in West Bend. Around 2 o'clock some riders got caught in a brief down-pour and others were hit with hail, however no accidents were reported.

Tim Thompson from Campbellsport was riding an all chrome, 2000 Harley

Deuce. "I like participating because I'm able to get together with friends and it's for a good cause," he said. "Plus, riding with a pack of 700 motorcyclists is beyond cool. When you look as far forward as possible there's two lanes of bikes and as far back there are two lanes of bikes. It's like giant squeal marks and looks very cool," he said.

Dan Becker of Kewaskum has been riding in the Schmitt Memorial for the past four years. "John was a friend of mine in high school and I worked with him at Sunburst Ski Hill," said Becker. "John was such a good guy and the ride does his memory justice with money raised going to a scholarship and a police memorial fund."

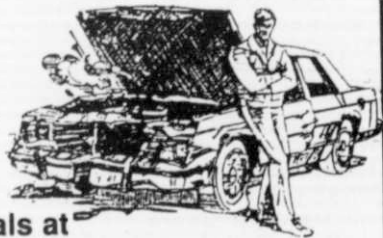
