Town of Scott Holds August Meeting

How do you define junk? That was the question asked of the Scott Town Board during the public input portion of its August meeting.

David Stommel, Walnut Lane asked for help in correcting a situation occurring in his neighborhood. He is attempting to sell his home and is experiencing problems that are related to the condition of the neighboring property. Garbage strewn about, car motors hidden by tall grass, a former peacock pen, too close to the property line, junk everywhere.

Town residents asked, what do you consider junk, relating to the old saying, "one man's treasure is another man's junk."

To make the problem worse, there has been an invasion of rats in the area and they are eating into Stommel's home. He assumes that the neighbor may have been putting out rat poison because in the past few weeks he has discovered dead rats in his

basement. "If they are coming in now, what will happen in winter?" he asked. Potential buyers turn away when they see the neighbor's property.

Although the board members were sympathetic to his problem, the town does not have a specific ordinance regarding these nuisances. Chairman Steve Jung suggested contacting the County Health Department to assist with alleviating the rat problem. He further stated that in the meantime the town will be looking into obtaining sample ordinances from neighboring towns and will take up the subject at the next month's meeting.

Members of the Batavia Athletic Association requested permission for use of a portion of the Scott Community Center grounds as a campground on August 30. The association is sponsoring a kick ball tournament on August 30 and 31.

They stated that some of the participants come from a long distance and wish to put up tents so they can stay overnight. They said that having them there overnight

provides protection for the area, discouraging vandalism. The board saw no problem with the campers for only one night and because it was done last year without incident, permission was granted.

A lengthy discussion concerning rental of the community center relating to comments received from former users regarding its' condition. Renters of the facility pay a fee for use of the building along with a deposit that is returned if the building is left in satisfactory condition.

Recently a complaint was received that prior to holding a wedding reception, they found the rug in a dirty condition and so the family took it upon themselves to rent a rug shampooer and spent five hours working on the rug prior to the reception.

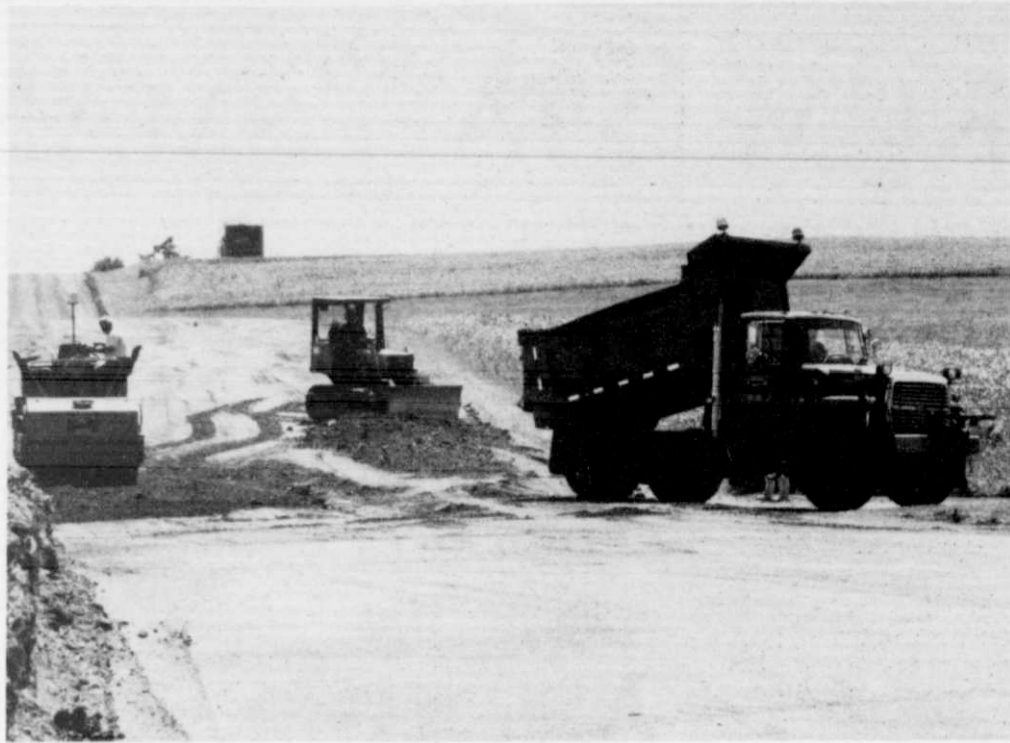

Due to need of additional space at the towns transfer station, and due to the fact that the market for recyclables is almost nil, it was Decided to sell the crusher and baler that had been used as part of the Town's recycle marketing program.

The board is also taking steps which will discourage people from filling the dumpster which is stored outside during times when the site is not open. Anyone observed depositing garbage, leaving appliances, tires etc when the site is not open, will be reported to the Sheriff's department.

Penalty for littering can cost as much as \$200.00 and court costs. The site is open on Saturdays and that is the time to bring your disposable materials.

Supervisor Ivan Kumrow reported activity in the town's highway department. Two large up-rooted trees, one on Crooked Lake Drive and another on North Maple Tree Road have been removed along with eight trees suffering from the July 8th storm have been cut up and removed.

Scott Construction has been contacted to complete the contracted road projects and a new quote is forthcoming from American Salt Company. Contact with that company indicates that the quote of \$35.46 which was to have been sent last May, never arrived. The new quote is expected to be \$39.17 per ton.

Kumrow explained that there was a third round of grass cutting on the right of way along Cranberry Road


between County Road D and County Line road was done because of the Noxious weeds in that area and to comply with state statute 66.96 which requires that all noxious and nuisance-weeds must be cut. Kumrow explained that he took a tour of that stretch of roadway and observed 62 thistles and other noxious weeds.

Schools to Open; Motorists Urged to Drive Carefully

The end of summer marks the beginning of the 2002-2003 school year and AAA Wisconsin urges motorists to keep their eyes open and their minds alert. "The motorists should take extra precaution when driving in areas with school age children," says AAA Wisconsin spokesman Michael Bie. "Some of these kids have very little experience in dealing with traffic situations."

Motor vehicle crashes are the leading cause of death for children 14 years of age and under with 2,343 deaths in 2000. One-fourth of all children who die in these crashes are pedestrians. Overall, one pedestrian is killed every two hours in the

U.S.

"Everyone needs to take extra precaution during this hectic time of year," Bie said. "This may cause some drivers not to be focused on basic traffic safety practices."

AAA's annual *School's Open - Drive Carefully* campaign reminds us all to use extra caution on the roadways on a regular schedule. Adjusting your schedule by just five or ten minutes can help you avoid busy pedestrian zones and frequent bus stops.

During the campaign AAA is noting that drivers should recognize that it is more difficult to judge traffic situations because their peripheral vision is one-

third narrower than adults. "When driving in school zones, near playground, or in neighborhoods where children play, be prepared for a child to dart into the roadway," Bie says. "That way, you'll never be taken by surprise and will be able to stop in time."

To protect children, AAA urges motorists to follow these safety tips:

- Slow down in or near school and residential areas.
- Drive with your headlights on - even during the day - so children and other drivers can see you.

- Look for clues such as School Safety Patrollers, bicycles, and playgrounds that indicate children could

be in the area.

- Scan between parked cars and other objects for signs that children could dart into the road.

- Practice extra caution in bad weather.

- Always stop for school buses that are loading or unloading students.

"Remember, back to school means back to basic driver safety," Bie said.

responsibility. We live lovingly when we don't tell the cashier at the movie theater our son is nine and should be charged the discounted price when he's really twelve and a half. We live lovingly when we return our shopping basket to the designated area in the parking lot instead of leaving it stand out in the open where it can roll into someone else's car. We live lovingly when we don't bring eighteen items into the express line marked "up to ten." We live lovingly when we refuse to "help ourselves" to supplies at work that belong to our employer, not to us. We live lovingly when we don't pull into the handicapped parking stall at the mall unless we are.

Livingly lovingly is nothing more, and nothing less, than doing unto others as we wish to be done by. It is simply about taking others into consideration and caring about how our actions will affect them. It is the willingness to ask ourselves how we would feel if we were the owner of the movie theater, or if we were a handicapped person without a place to park, or if we were in the express line with two or three items and were on our way to an appointment behind a fellow with eighteen, or if ours was the car that the shopping basket rolled into.

Living lovingly is about choices. Choices, choices, choices. And when love is the dominating choice of our life, our souls take flight like a little sparrow on a mountaintop did a long, long time ago. Set free.

August 1, 1952

The first poliomyelitis of the year in this area was reported on Tuesday when an eight-year-old village boy was stricken with the disease.

A warning was issued to all parents from R. G. Edwards, M.D., Village Health Officer, stating: The polio season is here. There are no preventive medicines nor injections as yet but it is known that all children should receive 8-10 hours rest each night, that they must not overdo it at play and they must avoid contacts with any polluted streams or rivers in which human body wastes are to be found (for example, our river). Keep all garbage cans covered and always wrap the garbage. All actual contacts to acute polio cases must remain on home premises for two weeks.

The number of new homes in Kewaskum is being increased by two more being built in Roseland Heights. Work is well along on one being erected by Mr. and Mrs. "Buddy" Holzmann of the village and the foundation

work is completed for another being constructed by Alfred Zuehlke of Lomira.

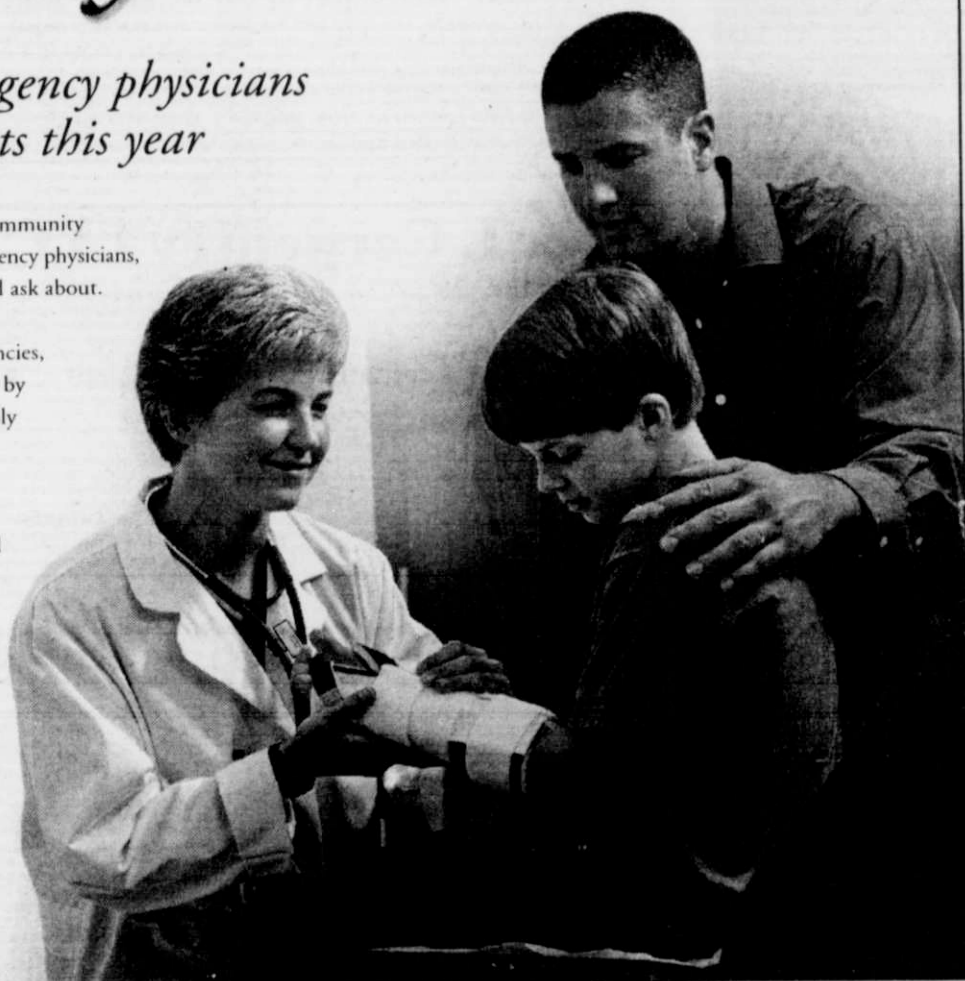

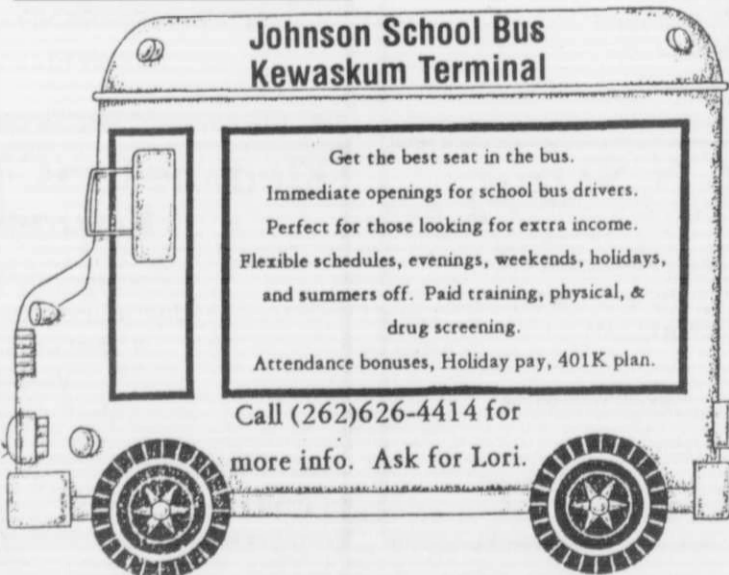

- 2) The District Administrator, upon receiving a written complaint, shall immediately undertake an investigation of the suspected infraction. The District Administrator will review facts comprising the alleged discrimination. Within 30 days after receiving the complaint, the District Administrator shall decide the merits of the case, determine the action to be taken, if any, and report in writing the findings and the resolution of the case to the grievant.
- 3) If the grievant is dissatisfied with the decision of the District Administrator, he/she may within 15 days, appeal the decision in writing to the School Board. The Board shall hear the appeal at its next regular meeting, or a special meeting may be called for the purpose of hearing the appeal. In either case, the Board must hear the appeal within 45 days of its receipt. The Board shall make its decision in writing within 15 days after the hearing. Copies of the written decision shall be mailed or delivered to the grievant and the District Administrator.
- 4) If the grievant is dissatisfied with the Board's decision, he/she may within 30 days appeal the decision in writing to the State Superintendent of Public Instruction.
- 5) Discrimination complaints relating to the identification, evaluation, educational placement or the provision of a free appropriate public education of a child with exceptional needs shall be processed in accordance with Wis. Stat. Ch. 115, Subch. V and Wis. Admin. Code Ch. PI 11.
- 6) Discrimination complaints relating to programs specifically governed by federal law or regulation shall be referred directly to the State Superintendent of Public Instruction.

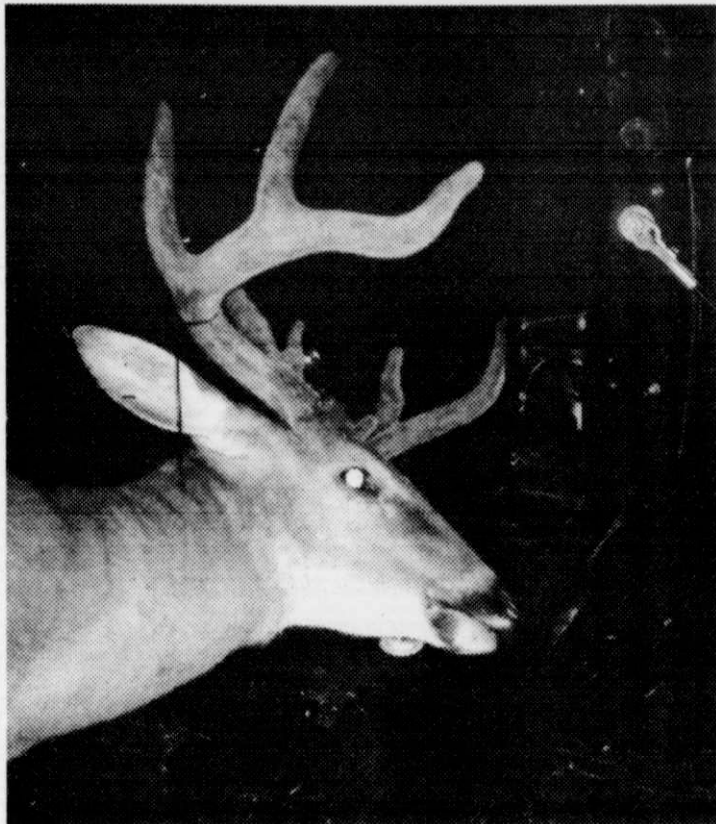

August Deer Hunt



Hunting, prayers and luck will hopefully stop CWD.

Hello friends,

This week's column may not increase my popularity, but I strongly feel there is an important war taking place in Wisconsin's southwest corner. That is the war against Chronic Wasting Disease (CWD).

Last fall, there were nearly 700,000 licenses issued to hunt whitetail deer in Wisconsin. I am beginning to realize that far too many of my fellow hunters are ready to hang up their guns and let the invader win.

What I did this past week should pretty much explain that this hunter will not lay down and give up! Five hundred deer were shot last spring and an additional 600 this June and July. Roughly two percent of those deer showed signs of CWD.

If nothing is done, CWD will continue to spread across Wisconsin. This would mean the certain end to whitetail deer hunting in this state and possibly in bordering states.

Wednesday, Aug. 14
High 82, Low 59

It's day five of the seven-day August CWD hunt covering a 374-square-mile

area in parts of Dane, Iowa and Sauk counties.

Today was one of the worst days of my life. After I was shown the lay-out of a 200-acre farm, I built a quick camp and headed out to a ladder stand for an evening hunt with my 30:06. My goal was to shoot straight and harvest as many deer as possible.

I had been in my stand for a half an hour when an adult deer ran across the field a hundred yards to my left. I could tell my first shot was a miss. I knew the second was a hit even though she vanished in the woods.

A terrible feeling came over me as I searched the dense brush. Everything was so unnatural about what I was doing - shooting a doe in August. She probably had fawns. What had happened to me to cross the line?

When I found her, I planned on dressing the doe and then waiting to see if she tested positive or not. This takes six to eight weeks.

My afternoon hunt became a gut wrencher when three more deer entered the field. All three innocent victims would fall to a war that I pray was not

caused by my fellow hunters.

After the shooting began, the work began. I started to feel like I was going to have a nervous breakdown. Absolutely everything I had done in the last hour went completely against what I had been taught as a hunter and as a human.

Each deer had to be tagged and loaded. I frequently washed my hands and knife with bleach water. I was getting a nervous rush, probably like that of a man living his last days on death row. When I took the deer to one of two DNR registration and handling stations, I realized I was not alone.

During the hour I was at the Mazomanie station, I witnessed at least 15 deer shot by about 10 hunters. Everyone was quiet. No one was bragging. There were no parties. These were local hunters eliminating their herd so someday they can have a real hunt again.

I am going to ask everyone that loves the whitetail to, in some way, help support the job at hand. Hunting clubs with ambitious members could raise money and perhaps set up hunts. I heard nothing from our major sporting goods stores who will be severely and permanently injured by loss of revenue.

So if you're reading this in Florence or maybe Park Falls and think it's too far away to be a problem, please think again. By doing the math, you can almost predict when it will affect your herd.

Hunters are tough, by and large, probably the toughest citizens in the United States. We are also smart and need to join in this battle.

Everything cannot be left up to the DNR. They have neither the money nor the manpower to win the CWD battle without the full support of hunters and non-hunters.

Our lives have changed drastically since February. There are people reading this column who are great organizers, fund raisers and members of sportsmen's clubs. Please don't just read the latest bad news on CWD. Hunt deer in the CWD zone. You can keep the

horns if you shoot a buck. Local butchers (in the Black Earth area) will process your venison at no charge until you receive the results of your test.

Read between the lines. President Bush cut CWD funding on Aug. 14. Become

creative, whether with your rifle, your pocket book or imagination. There's a bad guy in town and I fully intend on kicking his butt back to Hades.

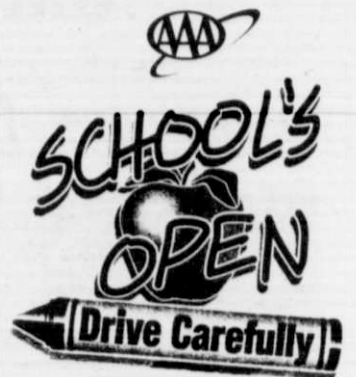

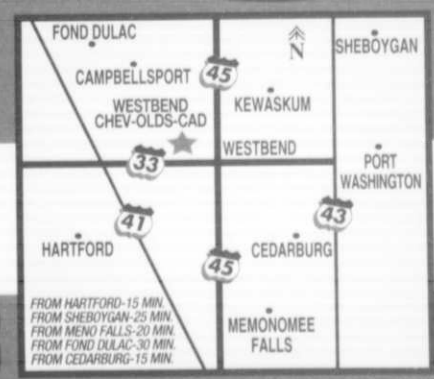
