LeMahieu Wins Assembly Primary

Oostburg native Daniel LeMahieu came away from Tuesday's primary election with 2,279 votes. This gives him a guaranteed place on the November ballot where he will face off against Independent candidate Cathy Lawton and Libertarian candidate Rick Levandowski.

LeMahieu, who with his son operates the *Lakeshore Weekly*, an advertising publication in Oostburg and is also Sheboygan County Board Chairman. He could not be reached for comment at press time.

SB Sets Interviews For Vacant Seat

KEA President John Breese started off Monday night's school board meeting by presenting the board with a petition signed by more than 100 teachers stating: "We believe the top priority for the School District of Kewaskum is to increase salaries to levels that are commensurate with surrounding school districts." They are asking for a raise to be included with any referendums the district may have. Approximately 110 of the 140 KEA teachers signed the petition.

Superintendent Wayne Graczyk announced that on Wednesday in honor of September 11, the schools were taking a low key approach to things by

observing a moment of silence and they were promoting wearing red, white and blue.

High school principal Donn Woolweber presented the board with a new idea for high school graduation. The teachers, counselors and the printing teacher who prints the program voiced concerns that they were very rushed in trying to get everything situated in one day and would like to see the graduation ceremony moved to the following week, either Friday or Sunday. The seniors would still get out of school on the same day, just the ceremony itself would be moved. The board tabled the issue until the October meeting.

Five applications were turned in for the vacant school board seat left by the resignation of Andy Degnitz. All five applicants will be interviewed during an open session on Wednesday, September 18, starting at 6:30 p.m. Each applicant will have 25 minutes for their interview. The applicants, in the order they will be interviewed are: Andrew Kuehl, Beth Steiner, Carrie Kuehl, Jeanne Goeden and Neal Weare.

The board once again tabled the issue of naming the athletic field after discussing that a policy or guidelines should be in place for naming things. The board discussed at a previous meeting possibly naming the field after Ernie Mitchell. Mr. Mitchell served the Kewaskum School District for 40 years as a teacher, guidance counselor, interim principal, coach and athletic director. However, no decisions were made either way.

The board accepted instruction applications for Jason Meinen, physical education at FES, Scott Jornlin, limited term contact for 02-03 school year as a high school English teacher and David Schultz, 62.5% computer teacher at KMS, limited term contract.

In a four to one roll call vote, the board approved the launch of a middle school

breakfast program. Kathy Robinson, Food Service Director, presented the idea at the August school board meeting where the issue was tabled. The board approved this only after being promised by middle school principal Ken Soerens that no instruction time would be used for the distributing and eating of the breakfasts. 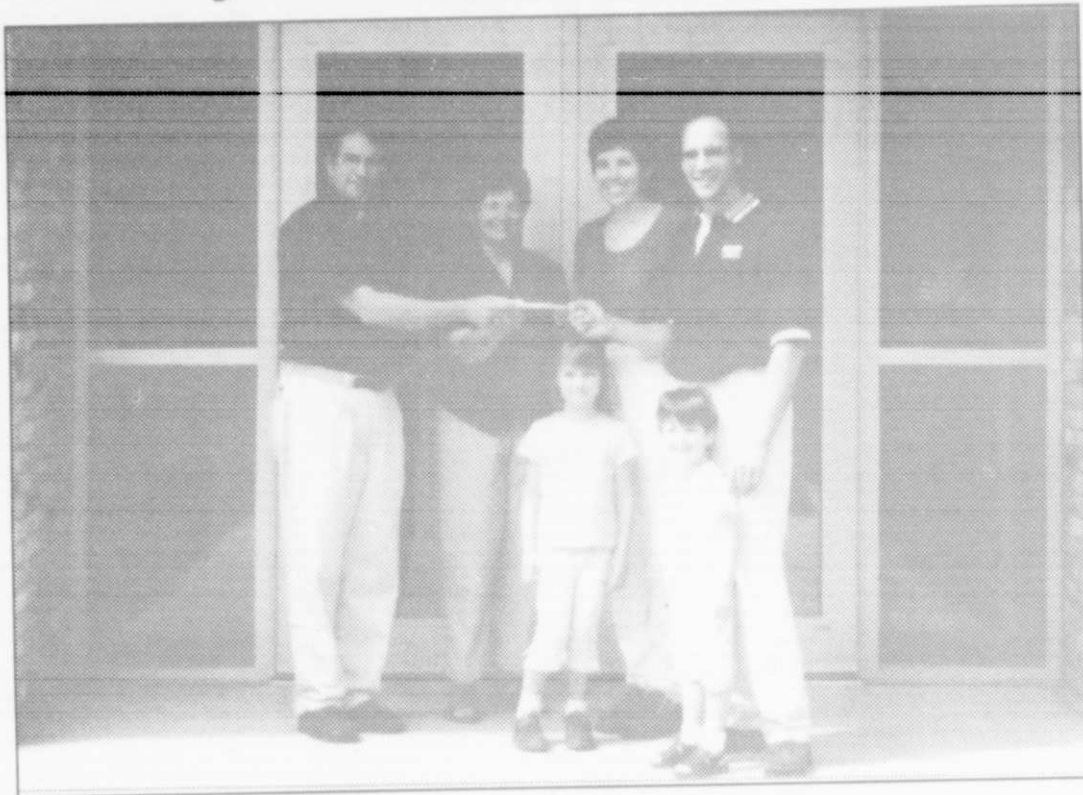
● **Man Arrested in Village with Cocaine**

The First Responders have been actively training with the personnel from the Kewaskum Fire Department in improving their skills by practicing auto extrication of victims from car accidents.

Kewaskum P.D. To Give Out Packer Cards

The Kewaskum Police Department has again joined in the Green Bay Packers Card Program, which has police officers carrying Green Bay Packer football card with them for distribution to those who ask.

The cards not only have a picture of the individual player, but also contain a public service message. There are a total of 20 cards and five new cards will be given out every Monday, beginning Monday, September 9. Each set of cards will be given out for a week.

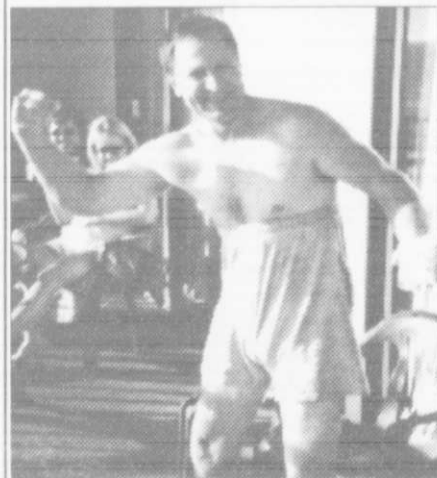

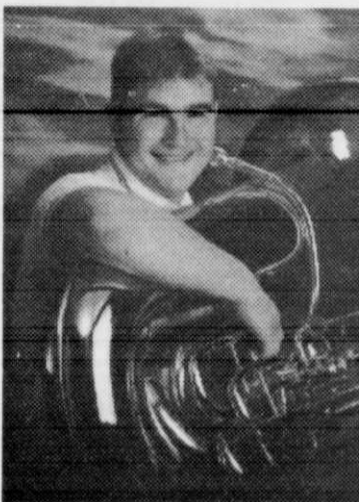

Sheriff Issues Reminder

It is that time of year when we have to remind everyone travelling our highways about the dangers involved with the transportation of children to and from school on school buses. With school having just started, traffic patterns change and everyone must be aware of school bus stops on the route that they normally drive during these periods of time.

Remember that when a school bus is stopped with flashing red lights and many times with a stop sign out, you must stop at least 20 feet or more in front of our 20 feet or more behind the bus, depending on your direction of travel. You may not pass the bus when the red lights are on and the stop sign is extended. On a two-lane highway, regardless of where the children are that are to be picked up, you must stop, travelling in either direction, when the school bus turns on its red lights and is stopped.

It is always important to remember to slow down when you see children present waiting for buses in the rural area, and to slow down to 15 miles per hour in the school zones when children are present.

Violations of the law regarding school buses are

very dangerous and many times will result in the issuance of tickets based on information received from school bus operators.

Please use caution when approaching or passing a school bus and make it a safe year for our kids.

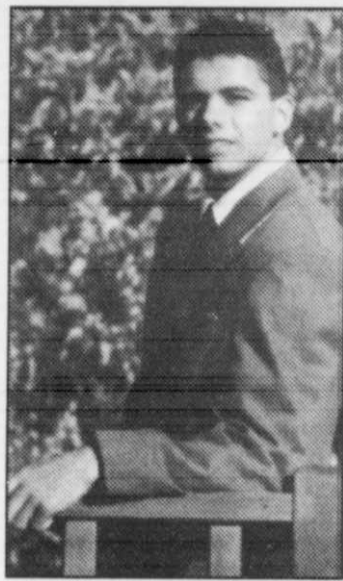

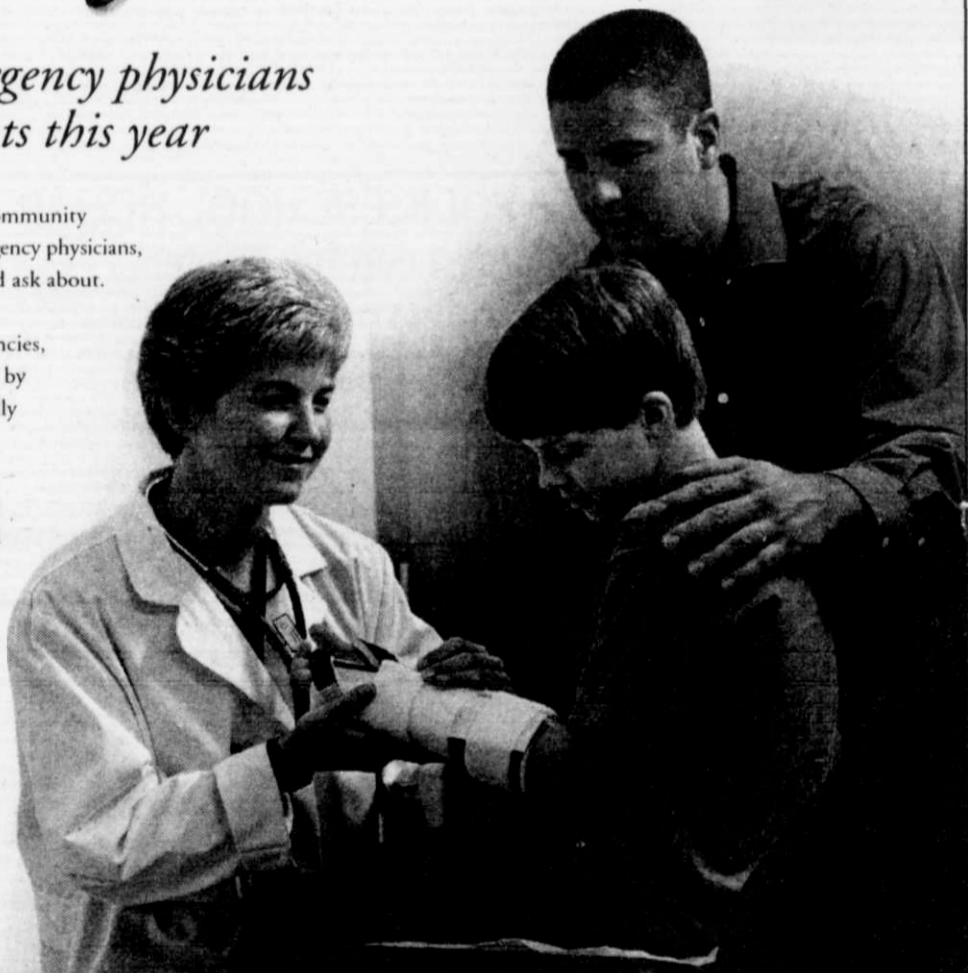

Booster seats are donated by Ford Boost America Program. An unlimited number of low back seats are available and a limited number of high back seats are available. Screening will be done on site.

If your child is between 40 and 80 pounds, and is using a lap and shoulder

belt only while riding in your car, he or she is at risk.

Current recommendations are that children under 4'9" tall and weighing between 40 and 80 pounds should be riding in a booster seat. They are too small to safely ride without one.

To qualify for a free booster seat you must:

Have a child that weighs between 40 and 80 pounds and is no taller than 4'9".

Have a vehicle with lap and shoulder belts in the back seat.

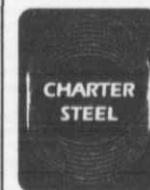

First Annual Pentenwell Flowage Catfish Classic

Hello friends,

Last year about this time, I spent a stormy night in my 14-foot boat fishing on the Petenwell Flowage which borders Adams and Juneau counties. By the time daylight arrived, the thunderous concussions from the storm had rattled me twice, I had a boat full of water, and most importantly, I had a stringer of seven catfish, each weighing 3-10 pounds.

My brother, Mike, has been after me for the past year to return with some friends to my honey hole for an all-night catfish tournament. Thus, the first annual Petenwell Flowage Catfish Classic was born.

The six of us, representing five different graduating classes from Poynette High School, divided into two teams.

Bob and Linda Brodeur along with Jerry Absher would fish aboard Sassy Sally, a 20-foot pontoon boat.

My boat, the Kingfisher, is a 14-footer and would be home to Mike, my old pal Roger Frank and myself.

The contest rules are pretty simple. The longest catfish wins five bucks per

person. The best stringer gets three bucks and the longest "exotic," any other species, gets two bucks.

Our contest would end at 8 a.m. the next day. It was centered around old friends having a good time.

We fished the Devils Elbow area of the Petenwell where everyone was counting on me to find last year's honey hole. This section of the Petenwell consists of islands, channels and some cattail marshes.

Linda, who was a classmate of mine, had a goal of catching her first walleye tonight. Everyone wanted bragging rights in the first of many Petenwell Flowage contests.

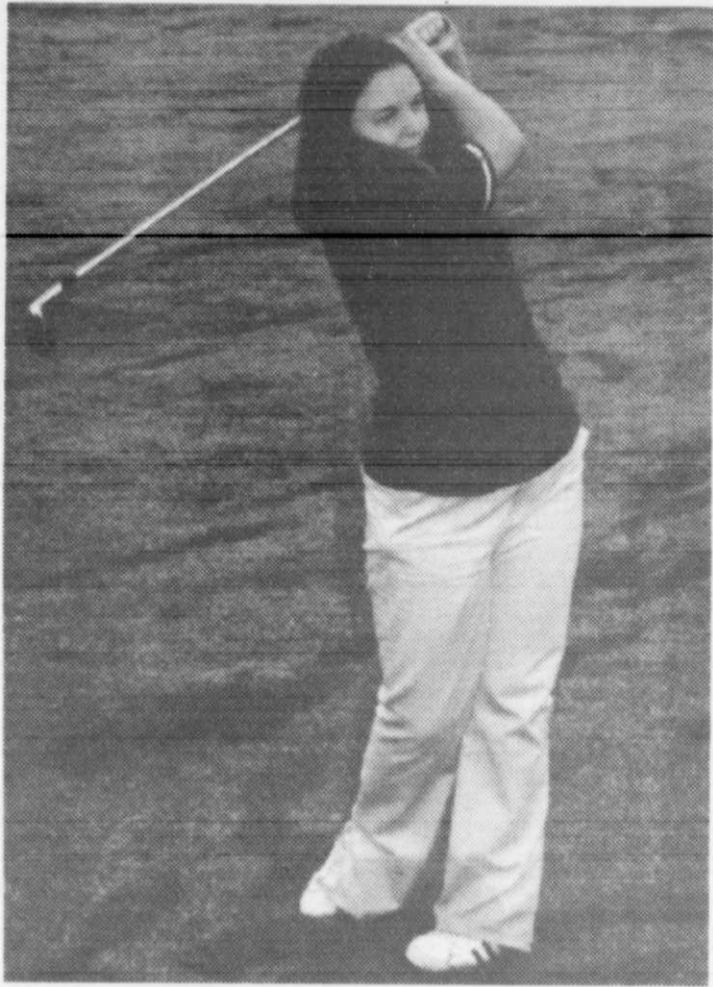
