Regal Ware Takes 250 Jobs to West Bend Facility

Kewaskum residents were stunned to learn that their only major employer is closing down shop and moving production to their neighbor to the south.

Media and other officials were alerted to the fact that a decision would be made on Thursday during a meeting held last Tuesday, February 4 at Regal Ware corporate headquarters in Kewaskum.

At Tuesday's meeting Regal's top officials stated that they would be announcing to employees and the media their plan Thursday afternoon. On Thursday they stated they will leave their Kewaskum manufacturing plant of 57 years empty.

All corporate functions will be consolidated into Regal Ware's headquarters in Kewaskum. This includes Administration, Sales,

Marketing, Customer Service, Accounting, Finance, and Information Systems. The relocation of employees will begin in March and be completed by mid-year. Currently the headquarters employ 81 individuals. Once a move is complete they will employ 126 combined from West Bend and Kewaskum.

After an evaluation process, the decision has been made to locate all production and warehousing activities in the former West Bend Company manufacturing facility on Schmidt Road in West Bend. This transition will begin in April and leave about 105 without jobs. That transition is anticipated to be completed within a year.

Regal has offered an attractive early retirement package and severance package but Senior Vice President James Moran feels it is unlikely that all 105

people needed to be eliminated will voluntarily give up their job. Moran figured maybe between the two plants 50 might choose the early retirement option.

Regal Ware, Inc. acquired The West Bend Company on October 31, 2002. Since that time, Kewaskum residents thought they might have a chance at having Wisconsin's ONLY major cookware manufacturer in their own hometown to continue the tradition set by Regal Ware founder J.O. Reigle in 1945.

The West Bend and the Kewaskum manufacturing facilities are of similar size. Both were operating at less than 50% capacity.

Jeff Reigle, President and CEO, stated: "This has been a very difficult decision to make. We are confident that this is the right decision to put us in the best position to compete long-term with for-

Benefit Set For Holly Parsons

A Benefit Dance is set to be held Saturday, Feb. 22 to help raise money for Holly Parsons and her family. Entertainment, raffles, food, door prizes, beverages and auctions will all combine into one beneficial evening intended to help cut the accumulating costs of her hospital bills.

A one car rollover on Jan. 13 left Parsons with a collapsed lung, fractured ribs, pelvis hairline fractures, as well as a large injury on her arm. Parsons was in a car with two other Kewaskum teenagers that evening when the driver lost control and the car overturned. Parsons was taken to St. Joseph's in West Bend, but after a couple of hours was transferred to Children's Hospital in Milwaukee. Parsons has gone through five surgeries so far, with the possibility of more plastic surgery after the wound on her arm

Highway 45 Project Underway

The long-awaited USH 45 project has finally gotten underway as construction began Monday morning. Their first order of business - was reintroducing a stream bed that will replace a drainage ditch on the highway's west side.

A meeting held last Wednesday at the Kewaskum Municipal Annex Building hosted an array of people curious about the project's future.

D.O.T. Engineer, Jeanne Marchant, of Kewaskum began the meeting and the first concern addressed was the location of mailboxes.

During construction, mail delivered to those living on USH 45 will have to be done so at a different location. For most people, mailboxes will be moved to the Kewaskum Veterinary Clinic parking lot and on Timblin Dr.

Another concern addressed at the meeting pertained to driveway access. There will be time

during construction that people will not be able to get to their driveways.

During storm sewer and placement of concrete pavement, residents will not have access to their property. Arrangements should be made by the property owner to try and find off street parking during that time. Residents will be notified as early as possible before workers begin construction in front of their homes.

Business owners along the construction site will be allowed to erect signs that show consumers how to get to their business.

Brian Aebly of Hoffman Construction gave a basic timeline. He said the dates were just estimations, and it would depend on weather conditions and other factors to see how smoothly the time frame actually goes.

Beginning in April, a temporary roadway will be put in from Sandy Ridge Road to the end of the project. The project has seven stages, keeping one lane open in each direction at all times. CTH H, Timblin and

pavement. Traveled lanes will be 12 foot wide, and a shoulder consisting of two foot concrete and six foot asphalt in the rural area. The urban area has a 14 foot center turn lane with curb and gutter and new concrete sidewalk.

Sandy Ridge Road, both north and south, will be closed during concrete pavement replacement. Traffic volumes are low, and CTH H East will be a suitable detour for a couple of weeks. Residents, county officials, bus services and emergency vehicles will be alerted to the above time frame.

Not only will Kewaskum be acquiring an expanded, newly-paved Hwy. 45, but the community will also receive new lights that will start at Badger Road and go north. New lighting is scheduled from CTH H East to CTH H West. In the rural areas, the lighting will be located in the terrace, and in the urban section, from Sandy Ridge Road south to CTH H East, the lighting will be placed in the center median. The completion date for the project is set for Sept. 3, 2004.

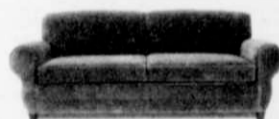

Parsons occupied her time with her job at Dairy Queen as well. Close friends of the family approached Holly's father, Mike, on Superbowl Sunday and asked if they could plan a benefit dance in order to raise money to help with the costs the Parsons' have endured during this trying time. The family was overcome with emotions and plans got underway.

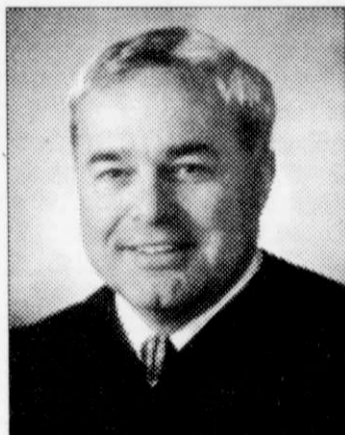

Three Running For Supreme Court Justice Seats

Voters will go to the polls Tuesday to pick who they would like to see on the April 1 ballot for the 2003 Spring Election.

Three candidates are running for the position of Justice of the Wisconsin Supreme Court which carries a 10-year term. The pending retirement of Justice William Bablitch leaves an open seat on the state's highest court.

First on the ballot is Chief Judge Ed Brunner who currently is serving his third term as Circuit Court Judge for Barron County.

Ed Brunner

Born in Akron, Ohio, in February of 1948, Judge Brunner first came to Wisconsin to earn his Bachelor of Arts at Marquette University in Political Science. While working he realized that learning the law was a way for him to continue improving juvenile justice. Judge Brunner attended law school at night and earned his Juris Doctorate from the University of Akron School of Law in 1974.

In 1979 Judge Brunner moved to Rice Lake with his wife and their two children. There he went into private practice and was Rice Lake City Attorney for seven years.

Judge Brunner is a past president of the Rice Lake Optimists Club, the founder and incorporator of the Rice Lake Area Men's Club, and past board member and president of the St. Joseph School, Rice Lake.

For three years he was the Organizer Chairman for Indianhead Special Olympics and for two years was a member of the Wisconsin Special Olympics Board of Directors. Currently, he is a member of the Barron Association for Retarded Citizens, Board of Directors for the Barron County Chapter of the Red Cross, the Elks Club, Moose Club, and the Knights of Columbus.

Referendum Questions On April 1 Ballot

After nearly two years of study and planning, the School Board approved five questions for an April 1, 2003 referendum. These five questions are on our web site (listed above). If you do not have computer access you can probably use one at most libraries. The five questions are printed exactly as they will appear on the ballot for your convenience and understanding. There is also an e-mail address that residents can contact me personally with questions, comments, concerns, etc. This would be an excellent opportunity for you to gather even more information to make an informed decision. I will respond to every e-mail contact as honestly and openly as possible, so please won't you take the time to write?

The attractive part of the proposed referendum is that residents will have a chance to vote and decide on each question, individually. There are three primary questions:

1) Renovation and a two story addition to the current high school on its current site;

2) A five-year, non-recurring question for the purchase of textbooks and for upgrading our technology programs in and out of the classrooms throughout the district;

3) A 650 seat proposed auditorium to be constructed between the high school and middle school, and connected to both. The other two questions pertain to the future upkeep and maintenance of the remodeled high school and the new auditorium.

Informational meetings, flyers, posters and articles and Letters to the Editor will be forthcoming over the

next six weeks so people can have the information they'll need to make a final decision. Presentations to local clubs and organizations will be scheduled in the months of February and March. If you would like a presentation for your group, please contact the District Office and ask for Debbie Goodsell, (626-8427 Ext. 8001). If you have questions or need more information, you are again encouraged to go to our web site at www.kewaskumschools.org. We will be updating it over the next six weeks to provide residents with additional information and will add a Frequently Asked Questions link.

I ask you to please respond while visiting our web site and ask questions. Feel free to add your thoughts and insights on the referendum. Please take the time and write. While you may choose to write anonymously, I would appreciate your name because it is more personal. Your opinion does count, and will continue to count. Pertinent information will be shared with the Board and others involved in the referendum but I want to assure you that your name, if given, will not be shared with anyone. That's my promise to you.

eign produced products."

"Tax dollars are really not affected by the move because the property is still here. Sewer and water on the other hand will be," stated Schmidt.

Whether you simply use the petals as potpourri, or you use the full blooms to create an elegant arrangement, your Valentine's Day roses will last for the remainder of the year. For an elegant look, place your roses, along with some floral accents, between two panes of clear glass and frame them. Flowers such as statice, strawflowers, larkspur, delphinium, saf-

flower, baby's breath and mimosa are also ideal for drying and will make beautiful accents to your dried roses.

AAA Safety Tips for Snowbound Motorists

Wintertime in Wisconsin can be a source of fun and amusement for an outdoor enthusiast with the proper gear. However, for an unprepared motorist trapped inside a disabled vehicle, winter can turn downright deadly, according to AAA Wisconsin.

AAA Wisconsin recommends that drivers always carry an emergency survival kit in the vehicle, containing a flashlight, flares or reflective triangle, distress sign, telephone change, first aid supplies, jumper cables, shovel and some basic tools. And don't forget warm clothing and a fully charged cell phone.

During severe winter weather, law enforcement agencies may recommend that motorists stay at home, and if they must venture out, to tell someone where they are going, route of travel and estimated time of arrival.

In the event that you do become stranded this winter, AAA Wisconsin advises:

• **Note your vehicle's location** - Wireless technologies don't always work in remote areas, and in-car systems may be useless if your vehicle experiences electrical failure or it becomes necessary to move to a place of greater safety. Be aware of landmarks, street names, including cross streets, specific addresses and highway numbers and exits. This information is important when summoning assistance, or confirming your location to an operator.

• **Pull Off the Road** - Immediately activate the safety/emergency flashers. On most roads, pull on to the far right shoulder as far as possible. If your vehicle has lost power in the roadway, set the emergency brake, turn your wheels toward the shoulder and place flares or warning triangles well behind the vehicle -- while being extremely careful of other traffic. If you or your vehicle could be struck by traffic, leave your vehicle for a place of safety. Do not risk injury by pushing your vehicle to a safe location, unless competently assisted by others.

• **Alert Other Motorists** - In addition to using emergency flashers or flares, raise your vehicle's hood and tie a brightly colored hand-

kerchief or scarf to the antenna or door handle to signal the need for assistance.

After a stranded motorist has made every effort to ensure personal, passenger and fellow motorist safety, he or she would:

• **Communicate the Situation** - Call a trusted friend, family member or motor club for help. Make the call from inside your vehicle, if this is the safest place and a cellular telephone is available.

• **Remain With the Vehicle** - Generally, it is safest to remain with the vehicle until a law enforcement officer or tow truck operator arrives. If a cellular telephone is not available - or it is not operable - do not accept a ride from a stranger. Get the attention of a law enforcement officer or ask another motorist to make a call for you.

• **What to Expect from Emergency Road Service** - Road service providers can usually provide gasoline, attempt to change a tire or boost a battery. If the problem is more serious, the vehicle will need to be towed. An extra charge - paid in advance - often applies for longer distance tows.

• **Determine When Service Should Arrive** - The operator should be able to give you an estimated time of arrival. Depending on circumstances, including

weather, time of day and location, service could take as few as 30 minutes, or as long as several hours. Check your watch and confirm the estimated time of arrival with the operator.

• **What To Do When Help Arrives** - Remain calm and cooperative. Verify that the driver offering assistance is the one your motor club sent to help you. Most firms have trained personnel that know what to do. Do not attempt assistance unless asked. If you need alternative transportation, ask to ride with the tow truck driver to the towing destination, or ask that alternative transportation be arranged. Do not accept a ride from a stranger.

Having fun, seeing my 13-year-old stepson Kevin shoot his first rabbit, and making some meat for the frying pan were all goals this past weekend. Kevin and I, along with three of our golden retrievers, took a ride down to Columbia County to chase some bunnies and have some fun.

**Saturday, February 1
High 37, Low 30**

Generally, fresh snow makes for premium rabbit hunting conditions, and today would be no exception. For our two-day hunt near my home town of Poynette, I had planned two totally different styles of hunting rabbits. Day one would include hunting with my high school buddies, Doug and Todd Cibulka, and their three beagles, Sassy, Champ and Smokey.

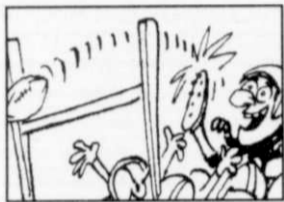
My family and I have lived here for 21 years, while my husband has been a life long resident of the township. I have worked in



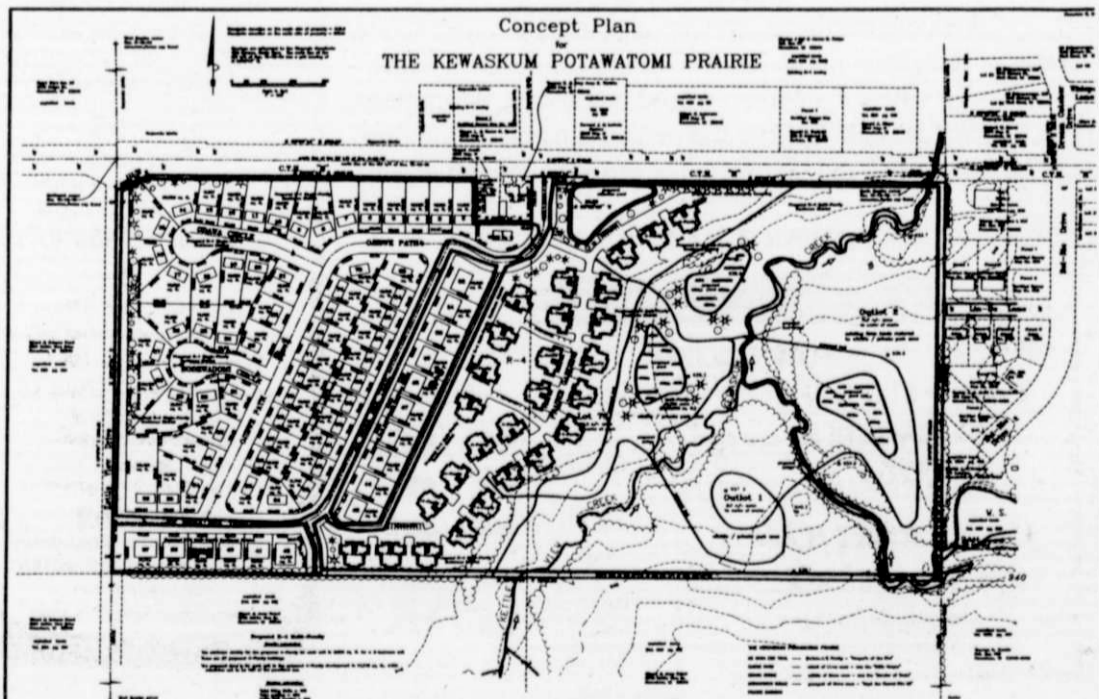

Upon entering the polling place, an elector shall give his or her name and address before being permitted to vote. Where ballots are distributed to electors, the initials of two inspectors must appear on the ballot. Upon being permitted to vote, the elector shall retire alone to a voting booth and cast his or her ballot except that an elector who is a parent or guardian may be accompanied by the elector's minor child or minor ward. An election official may inform the elector of the proper manner for casting a vote, but the official may not in any manner advise or indicate a particular voting choice.

Where marksense voting is used, the elector shall fill in the oval next to the name of the candidate of his or her choice for whom he or she intends to vote. To vote for a person whose name does not appear on the ballot, the elector shall write in the name of the person of his or her choice in the space provided and fill in the oval on the write-in line.

The vote should not be cast in any other manner. If the elector spoils a ballot, he or she shall return it to an election official who shall issue another ballot in its place, but not more than three ballots shall be issued to any one elector. If the ballot has not been initialed by two inspectors or is defective in any other way, the elector shall return it to the election official, who shall issue a proper ballot in its place. Not more than five minutes' time shall be allowed inside a voting booth. Unofficial ballots or a memorandum to assist the elector in casting his or her vote may be taken into the booth and copied. The sample ballot shall not be shown to anyone so as to reveal how the ballot is marked.

After an official marksense ballot is marked, it shall be inserted in the security sleeve (if one is provided) so the marks do not show. After casting his or her vote, the elector shall leave the booth, insert the ballot in the voting device and discard the sleeve. The elector shall leave the polling place promptly.

An elector may select an individual to assist in casting his or her vote if the elector declares to the presiding official that he or she is unable to read, has difficulty reading, writing, or understanding English, or that due to disability is unable to cast his or her ballot. The selected individual rendering assistance may not be the elector's employer or an agent of that employer or an officer or agent of a labor organization which represents the elector. 2. The public improvements shall be the installation of storm sewer, catch basins, street/road way, street lighting, curb/gutter, sidewalk and other related improvements deemed necessary by the Village of Kewaskum, Village Engineers of the Village of Kewaskum and Wisconsin Department of Transportation and other related specifications contained in Section 8 of the Municipal Code of the Village of Kewaskum and under the Village Engineers specification for utility and street improvements. The improvements will basically take place on Fond du Lac Avenue (USH "45").

3. The total amount assessed against the properties in the defined assessment district shall not exceed 100% of the total cost of the improvements. The Village Board determines that the improvement constitutes an exercise of police power and the amount assessed against each parcel shall be based on the lineal footage of said parcel on Fond du Lac Avenue.

- c. Schedule of proposed assessments against each parcel.

6. When the report is completed, the Village Department of Public Works and Village Engineer shall file a copy of the report with the Village Clerk for public inspection.

7. Upon receiving the report of the Village of Public Works, Village Engineer, the Clerk shall cause a notice to be given stating the nature of the proposed improvements, the general boundary lines of the proposed assessment district, the time and place at which the report may be inspected, and the time and place of the public hearing on the matters contained in the preliminary resolution and the report.
