A 17 year-old Campbellsport youth has been charged with four counts of sexual assault.

Kevin M. Carey Jr. has been charged with one count of attempted sexual assault of a child under age 16, one count of sexual assault of a child under 16 years of age, one count of fourth degree sexual assault and sexual assault of a child under age 13.

The three victims in the case are females from the surrounding area.

A 15-year-old victim told authorities the first alleged assault took place at a birthday party at a friend's home in the Village of Campbellsport in May of 2003 where the 17-year-old attempted to engage in sexual contact.

The 15 year-old again was assaulted by Carey in June of 2003.

A 16-year-old victim also stated between June 1 and July 4, 2003 she was assault-

ed by Carey.

A nine-year-old town of Eden girl alleges that in December of 2002 Carey sexually molested her while the two watched a movie at her home.

On all counts, Carey could face a maximum of 120 years in prison and fines not to exceed \$160,000.

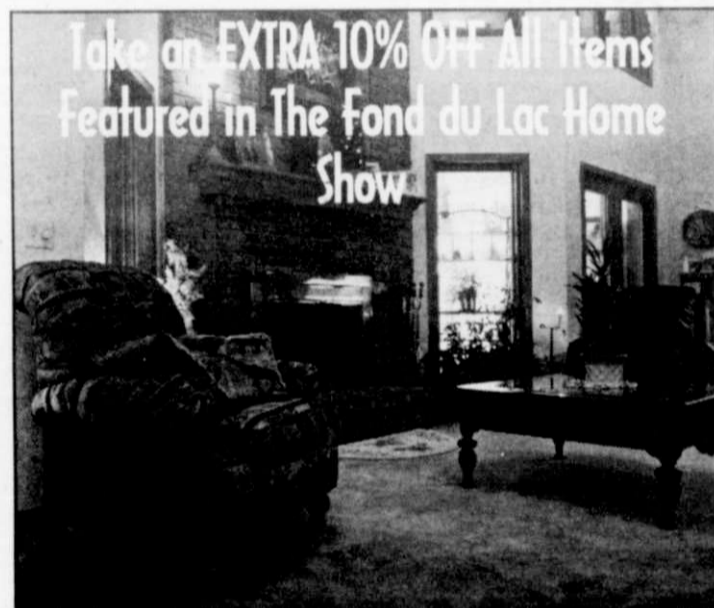

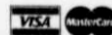

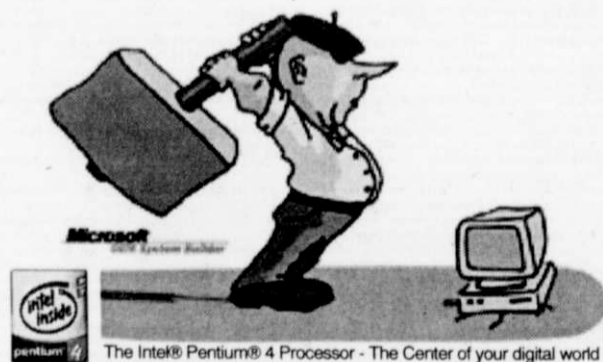

School-Based Mentoring Comes to Kewaskum

Big Brothers / Big Sisters of Washington County will offer their School-Based Mentoring Program to children attending Kewaskum Elementary School beginning this fall. Volunteer mentors meet with a child over the child's lunch hour, one day each week for the length of the school year. Match activities include eating lunch together, playing games, working on school work, talking and having fun.

Children benefit by receiving individual attention and guidance during the school day, providing the child with additional support to build a variety of skills. Volunteers

receive the satisfaction they have made a difference in the life of a child who may not have the chance to be matched in the traditional BBBS program.

A national study of children involved in the School-Based Mentoring Program showed improvements in attitude toward school, higher grades and improved relationships with adults and peers.

Volunteers are local professionals, retirees, students, homemakers and other community members that have agreed to volunteer one hour each week. between 700 and 1,500 birds. The species' breeding range spread throughout the central plains, from the grasslands of north central Canada to the prairie states of the US.

By 1890, whooping cranes had disappeared from the heart of their breeding range, and by the 1940's only a single migratory flock of 15 whooping cranes remained.

Rebecca Hansen, Assistant Naturalist with the Northern Kettle Moraine State Forest, will share insights into the incredible lives of these beautiful birds. She will explain how people have helped save this species from extinction and what critical role Wisconsin is playing in the recovery effort. Rebecca will compare the plight of the whooping cranes to that of the other 14 species of cranes throughout the world.

Wayne Elementary PTO Officer Dawn Weiss kept busy during the 2002-2003 school year accepting proposals and

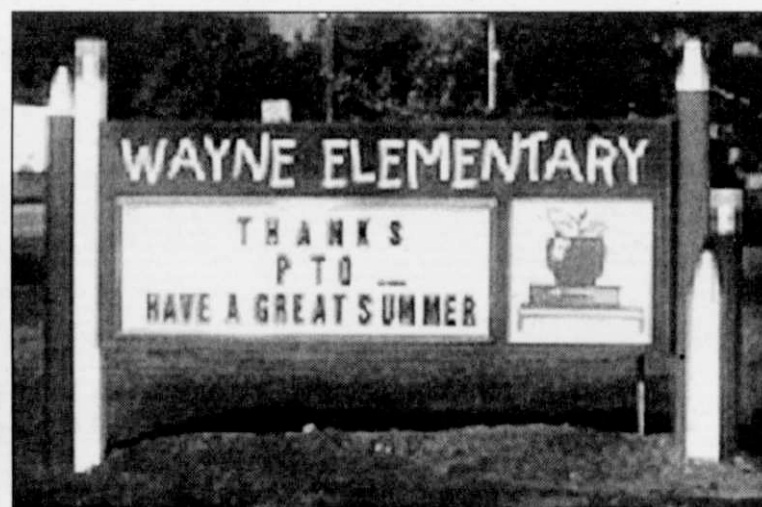

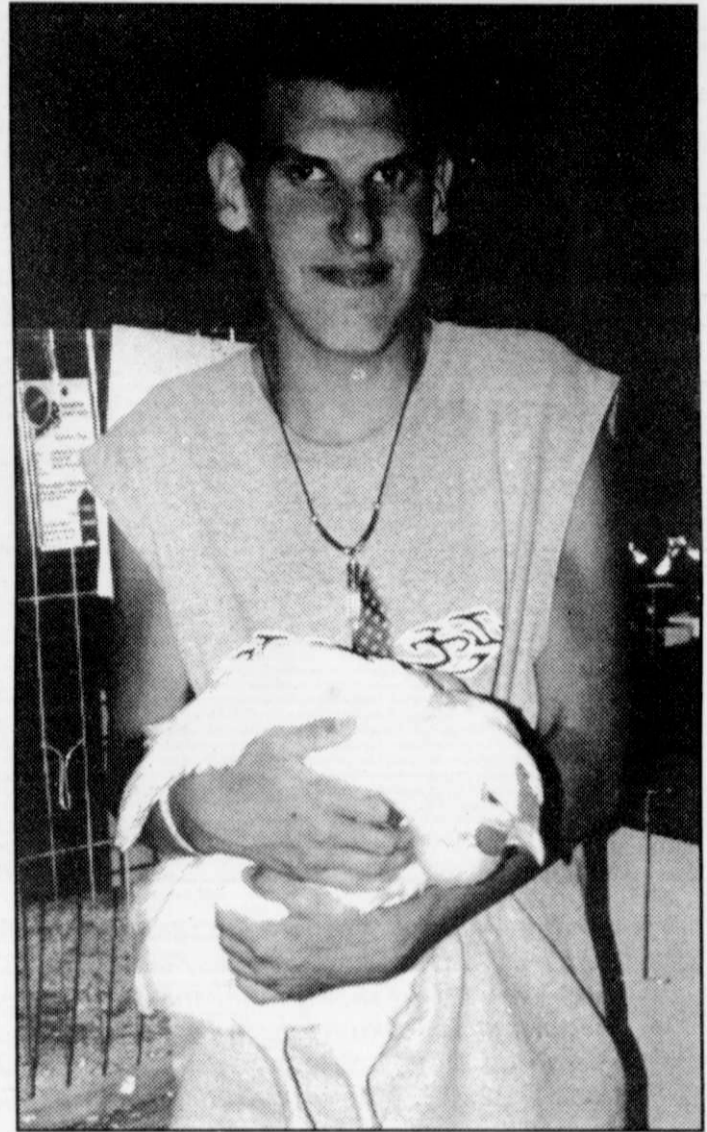

Give Driving Your Undevided Attention

Because of hectic schedules, a normal part of everyday life is juggling several tasks at the same time. But no matter how busy you are, each time you're behind the wheel you need to concentrate exclusively on your driving and eliminate all distractions.

Distracted drivers are everywhere, and so is the focus of their attention. They often are unaware of traffic conditions and road hazards.

"Using a cell phone while driving is often mentioned as a big distraction. But there are many others, too," says Captain David Pichette of State Patrol District 3 in Fond du Lac. "We see drivers putting on cosmetics or combing their hair while looking in the rear view mirror rather than watching the road. They read and fold maps, eat and drink, or search for items on the dashboard or in the glove compartment. Even switching

radio stations can be distracting. Because distracted drivers are not ready to react, they are dangerous in to themselves, their passengers and other drivers."

Aside from watching television while driving, no single type of distraction is specifically outlawed. But state law prohibits drivers from being "so engaged or occupied as to interfere with the safe driving of that vehicle." Violating the inattentive driving law can cost up to

\$150.60 and drivers may be assessed four demerit points.

"Safe driving requires your undivided attention. If you absolutely need to use a cell phone for a non-emergency call, read a map or find something in the glove compartment, please exit the highway into a rest stop or other safe area," says Captain Pichette. "The next time you're in the drivers seat, ask yourself if that phone call or other potential

distraction is really so important that you're willing to endanger yourself or someone else on the road."

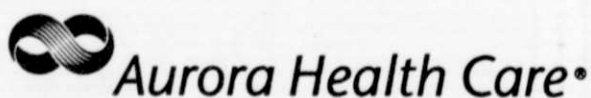

was used for shouldering in various locations, Bolton-ville Road was pulverized and blacktopped, one stop sign was replaced and damaged building permit signs have been disposed of.

A resolution passed in April, 2001, now has been converted to an ordinance. The new ordinance deals with specifications for the required road right of way and road surfaces. The ordinance deals with private drives or roadways which are constructed to serve two or more lots for residences and commercial establishments.

These roads must have a 66 foot wide right of way, with a cleared road surface being no less than 14 feet wide and 14 feet high, for one residence or commercial establishment. In the event of two or more residences or commercial establishments, there must be a cleared road surface of no less than 20 feet wide.

For long driveways, at least one 50 foot in length and 18 feet in width segment of road surface shall be provided for each 300 feet of driveway length to provide for the safe passage of meeting emergency vehicles. An adequate road bed base of suitable material to support the projected traffic and requirement of culverts shall be determined by the Town Board. Minimum cul-

Fishing Report

Last week while I was fishing near the launch on Wolf Lake two senior citizens were launching their boat. Being so close it was an opportune time to watch this process. It was something that you would not believe. The boat was not loaded and it took ten minutes, yes ten minutes for them to get the boat ready. It was quite an operation. Rods and reels, tackle boxes, life preservers, and whatever else. Then a long pole of some sort was pulled out from somewhere and the launch was on. Well, the boat got stuck on the trailer and the pole, which had a hook on it, was used to pull it into the water. Wow, I was just sweating watching them. Now it was time to park the truck, get into the boat and start the motor. Well I thought the launch was the starting line for a drag race. The engine was racing at almost wide open throttle. He put it in gear, the boat jumped up and luckily backed off the throttle. They proceeded to go out about a 150 yards and threw in the anchor. Out came the rods. They put on bobbers and started to fish. Ok, everything seemed fine now until I see him stand up to scratch his behind, not once, but a couple of times. That's it! I'm going home to write about this.

Usually after coming back from fishing I put a flyer on everybody's windshield. It's about how you can stop the spread of Eurasian Milfoil. When doing this I noticed that every car had a receipt in their windshield for boat launching except this older couple. So I also put one of the fee slips on the windshield. (It's only two dollars). Hey, he also parked in a handi-cap parking zone with no sticker. While riding home a thought occurred to me this could be what I'll be doing in a few years. OH NO FISHING WITH MY WIFE.

Wow, Monday started off great! Went directly to Tittle Lake and used my bb3 all along the west shore line. One small bass hit and I lost it at the boat. A few northern did follow my bb3 up to the boat and jump out of the water. On the way back I began to use a black plastic worm and had a bass. She weighed 3 lbs 12 ozs. and was 20" long. Then the second bass was 18" and the third 16". Ok, so a plastic worm works at times. These bass just took the worm on the drop and swam away with it in there mouth. I had to watch my line a lot that morning because there was no pick up just the line moving.

Tuesday morning I made a trip to Crystal Lake. The boat hasn't touched this water since last year. The lake produced some nice 3 lbbers last fall but it was tough this time. One quarter pounder hit a bb3 and I had one bass on a plastic worm but lost it. Had some other hits but never got them to the boat. The south

side of the small island was where I had the hit with the worm and bb3. The other bass came from the weed bed near the launch. Besides the bb3, Bill Dance's suspending bait and a red oz. Rat L Trap got some use but no hits with them either. About the same thing happened that night, a bunch of hits and nothing else.

Wednesday morning it was northern fishing on Long Lake. Most were small and hitting the gold Bagley bb3. One northern was in the 30" range. She nipped at the lure and then said goodbye.

A lesson was learned Wednesday afternoon that I will share with you. My wife, I and others were at a pond helping people fish. I found out, this pond has some huge bass. We were baiting the hooks to catch pan fish or bass. Someone hooked a small blue gill and as he was reeling it in a big bass took a swipe at it. The bass was in the 5 lb plus category and I mean plus! My heart was pounding. We continued to catch bluegills and the bass would keep hitting them. She would not bother the other bluegills but as soon as one looked distressed or was having a hard time swimming, BANG, she would hit it. This bass was on at lease a half a dozen times during the afternoon. Other bass were doing the same thing. I've seen this happen with northern, but not with bass. It was an unbelievable experience! (A lesson to remember.)

Can you believe that Wednesday night "The Big A" was not on my schedule to fish? Musky fever set in Wednesday afternoon and a long night of rest was needed to fish Big Elkhart. Early and I mean early (3:30 am) Thursday I was up and ready to go. Left the house by 4:00 am and started to see the lighting in the sky. Ok, I should have checked the weather report. The morning turned nice and it rained very little. The musky didn't cooperate and not even one followed my lures. There is always a positive side of not catching any fish on a strange lake if you keep an eye on your fish locator. You can learn a lot about the lake - the location of the isolated weed beds, drop offs and structure. Thursday night was the same as the morning, no action just a sore arm from casting.

Friday morning, with my arm aching from fishing Big Elkhart and musky fever still in my blood, it was off to Random Lake. After launching and pulling the trailer out of the water the rope got hooked on the trailer again and broke. As usual the boat floated away but luckily the wind pushed the boat back to me. I have determined to try a rope that floats and may be it won't get caught on the trailer. Will let you know if that does the trick.

The musky fever needed to be reckoned with, but it was a disappointing morning with

only one follow. To rest my arm, bass fishing was done, and some were found in the lily pads. Most of the thick pads had some bass in them, but I never hooked up with any. They struck at the Tournament frog or just pushed at it.

A new fishing adventure is in the works - will tell you all about it in the next Fishing Report.

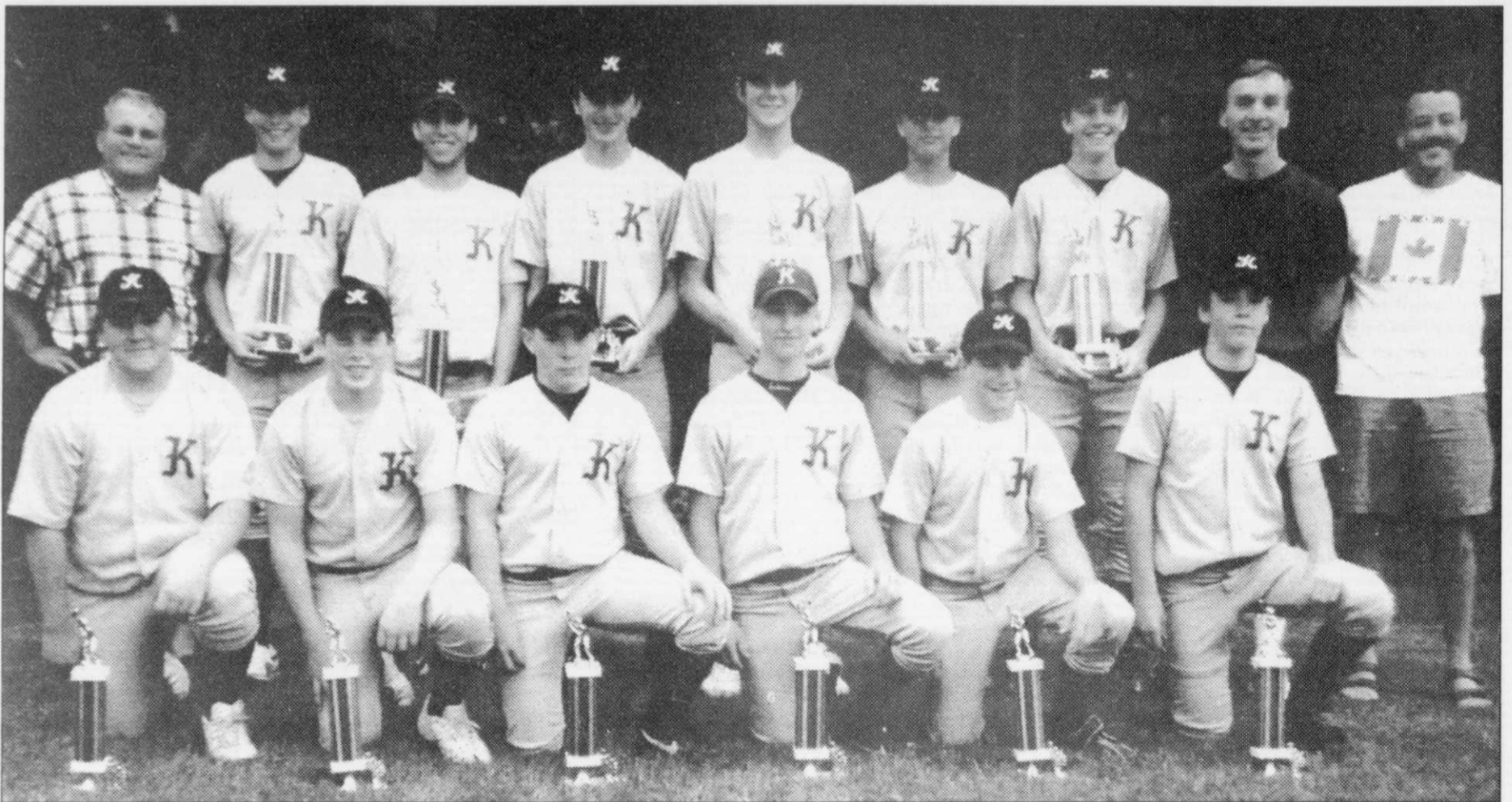
