## Village Lakes Center not completely dead in the water



Village Lakes Center has been the topic of much discussion around Kewaskum. Owners of United Construction Group, who plan to build the shopping center say they wish to build in Kewaskum. Property owner Gary Gavin says he is moving on.

**KEWASKUM-** United Construction Group, rumored to be pulling the plug on their Village Lakes Center retail complex planned for south Kewaskum, says the rumors are untrue. Greg Chmielewski, owner of United Construction Group, stated portions of an article appearing in the

Saturday, January 14 edition of The West Bend Daily News is false. That article stated that his company "has pulled its offer to purchase the property." "United Construction wants to move forward with the project," stated Chmielewski Wednesday morning while vacationing in the Virgin Islands. Gary Gavin, who owns the property and is the primary developer, says he "doesn't know what happened."

"Deadlines were missed, we were supposed to close in July and then in October," said Gavin. He also stated that other companies were very interested in the land and he felt he needed to explore other options. "I don't think the deal is 100% off," Gavin concluded. Chmielewski stated that for the time being his company would continue working from their Kewaskum office, but he was unsure for how long.

## Cousins Subs to open store in Kewaskum

Store will be part of new retail complex at Hwys 45 & H

**KEWASKUM-** Get ready Kewaskum, the company who says their better bread, makes better subs, is planning on opening a sub shop in June of this year. Jill Bohn confirmed Wednesday morning that her and her husband, Tom, along with business partner Keith Novotny, will open their Kewaskum store in a proposed retail development at the intersection of Fond du Lac Avenue and County Road

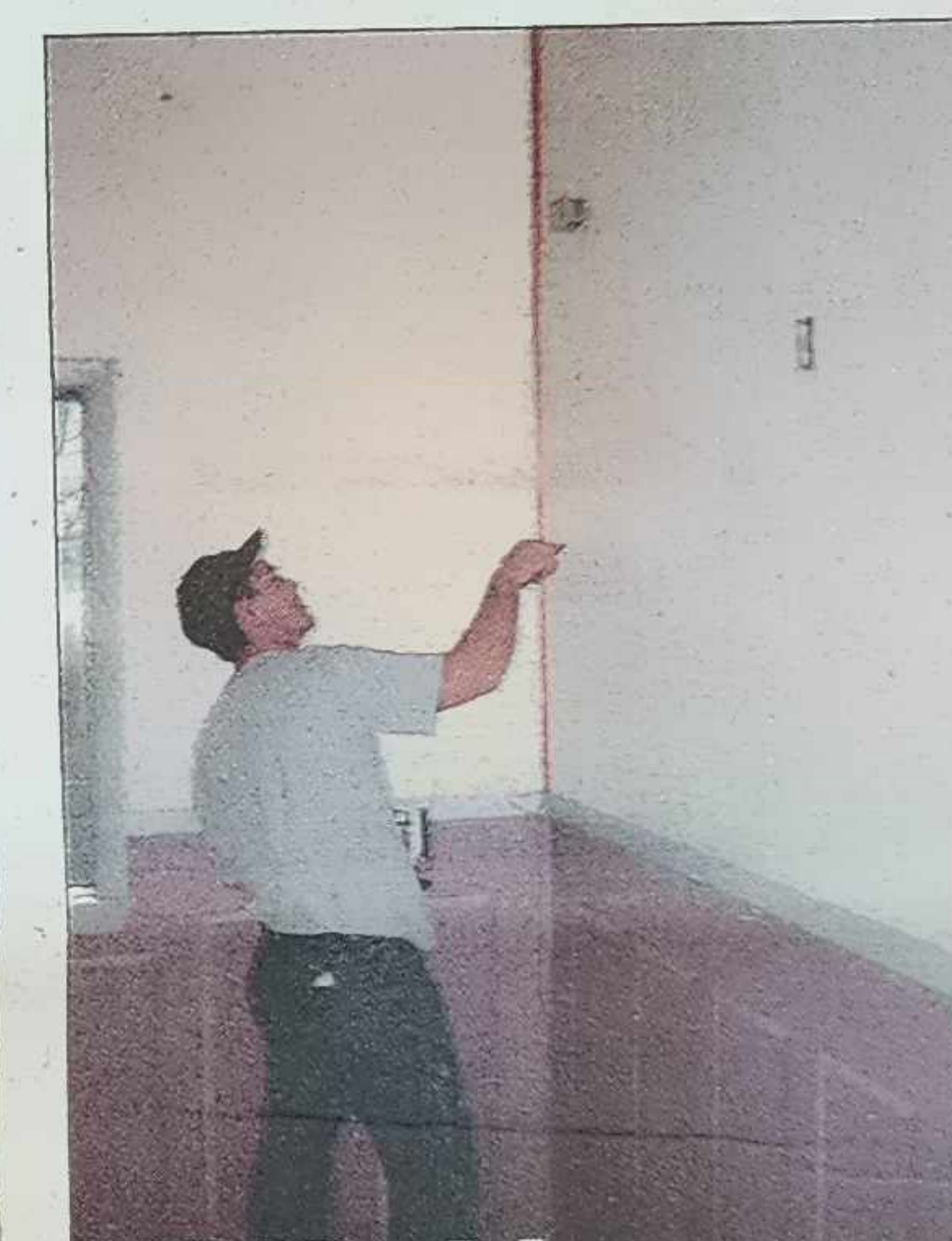
H in the village. In December, Kewaskum Green and Gold LLC announced their plans to develop a "first class retail and professional space" on the site of the locally known Carl Johnson property that was once home to his company, Hydraulic Gear and locally tagged, "the Packer building". Cousins Subs is the first business to publicly announce plans to open shop in the building. Bohn says the trio is very excited to open a store in Kewaskum because her husband Tom has ties to Kewaskum, as does Novotny. Both are graduates of Kewaskum High School.

The Bohns and Novotny own both West Bend Cousins stores. "Kewaskum needed one (Cousins store), if we didn't open one, someone else would have," said Bohn. Cousins' website states two cousins opened their first restaurant on the North-West side of Milwaukee in 1972. The two transplanted cousins from Atlantic City saw the need for an Eastern-style sub shop in their new hometown of Milwaukee. Today, Cousins Subs restaurants around the country carry on the tradition begun in Milwaukee over 30 years ago. Kewaskum Green and Gold LLC meets with the Village of Kewaskum Planning Commission Tuesday, January 24 at 7 pm to discuss their plans for the Fond du Lac Avenue property.

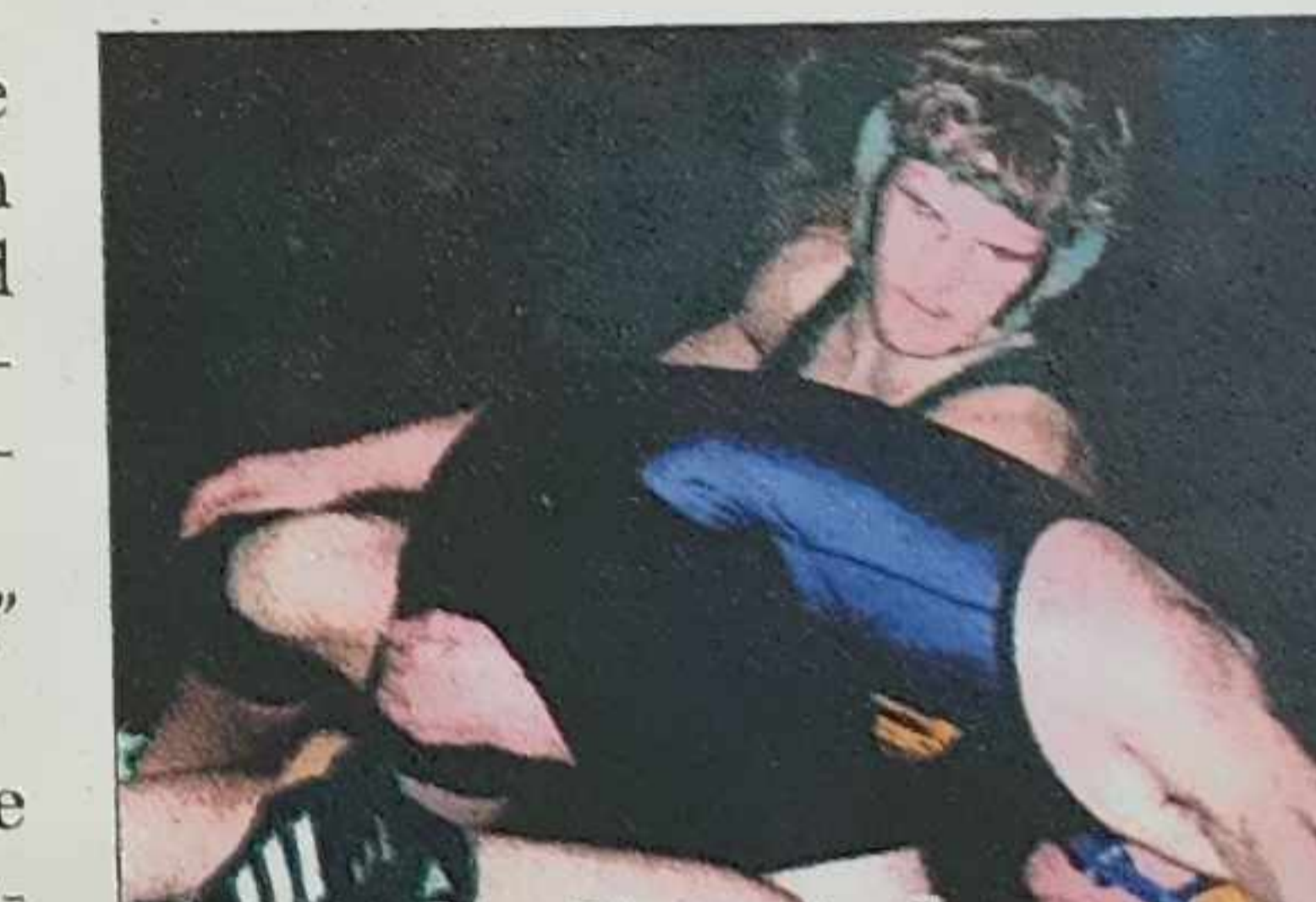

## Sandra Stern resigns as Town of Kewaskum clerk

*Resignation letter states further communication to be directed to her attorney*

**KEWASKUM**- Just short of a year in to her second term as the Town of Kewaskum's clerk and zoning secretary, Sandra Stern submitted an abrupt resignation Saturday, January 14. Town treasurer, Dan Stofel has been appointed interim clerk to handle the town's business until a decision is made about what to do with the position.

Town of Kewaskum chairman, Ellis Kahn, announced Stern's resignation at the town board and planning commission meeting Monday, January 16. "I am hurt this has turned out this way. When I got elected, she bent over backwards to help me," stated Kahn.

In her resignation letter Stern says, "Any further com-

Kahn's predecessor, former chairman, Michael Lettow, had his own opinion for Kahn on Stern's resignation. "That was the best thing that could have happened to you Ellis," he stated during the meeting.

Stern started her career in town government after finishing the term of Barbara Wen-

zloff who served the town over 20 years. Stern served one complete term and in April 2005 she ran for a second term against Yvonne Boettcher and was successful in retaining her seat. Her term was to expire in April of 2007.

Stern could not be reached for comment.

The town board will meet Friday, January 20 in the town hall at 9 am to discuss their options for moving forward.

## Farmington Board discusses road, driveway ordinance

**T. FARMINGTON**- Routine business and discussion on a proposed road and driveway ordinance was on the agenda for the Farmington Town Board at their January meeting. The board also decided to retain Ken Ramthun as their treasurer.

Fire department contracts were also awarded to Boltonville and Fillmore Fire Departments. Both departments will receive \$70,000 and fire dues for each member.

The board held a lengthy discussion on enacting a road and driveway ordinance. Supervisors reviewed a draft ordinance that outlined design standards for roads and driveways in the township. The supervisors thought that the town's engineering firm should inspect driveways. Costs for those inspections would run around \$320 per

driveway. Copies of the proposed ordinances are available at the town hall during normal business hours.

Members in the audience didn't like the sound of the price tag and asked the board to consider holding a public hearing before making any decision. The supervisors set Tuesday, February 14 at 7 pm for the public hearing. At that meeting the supervisors will also consider removing the development moratorium.

Town Chairman Gary Schreiber made his decision on the vacant treasurer position in the township. Currently, former treasurer Ken Ramthun was handling business since the death of Eugene Fay. The township accepted resumes for the position in the fall of 2005. At that time Ramthun stated he was uninterested in keeping the job. This prompted the town to accept resumes. Ramthun said he later decided that he would enjoy keeping the job.

Schreiber said because of Ramthun's dedicated work in the past and because he knew the town's finances inside and out, he would like to keep Ramthun as treasurer permanently. The supervisors agreed and motioned to that effect. Residents of the town complimented Ramthun on the job he had done since taking over the position.

Chairman Schreiber informed the audience of a letter he received from Washington County Highway Commissioner Ken Pesch in regards to work being done on County Road A this spring. In his letter, Pesch stated that Highway A would be widened six feet on both sides. Work would begin this spring and end in fall.

Clerk Joanne Oneska requested the board raise the prices for copies made from 15 cents to 25 cents, which she thought, seemed to be the going rate at other townships in the area. The board approved her request.

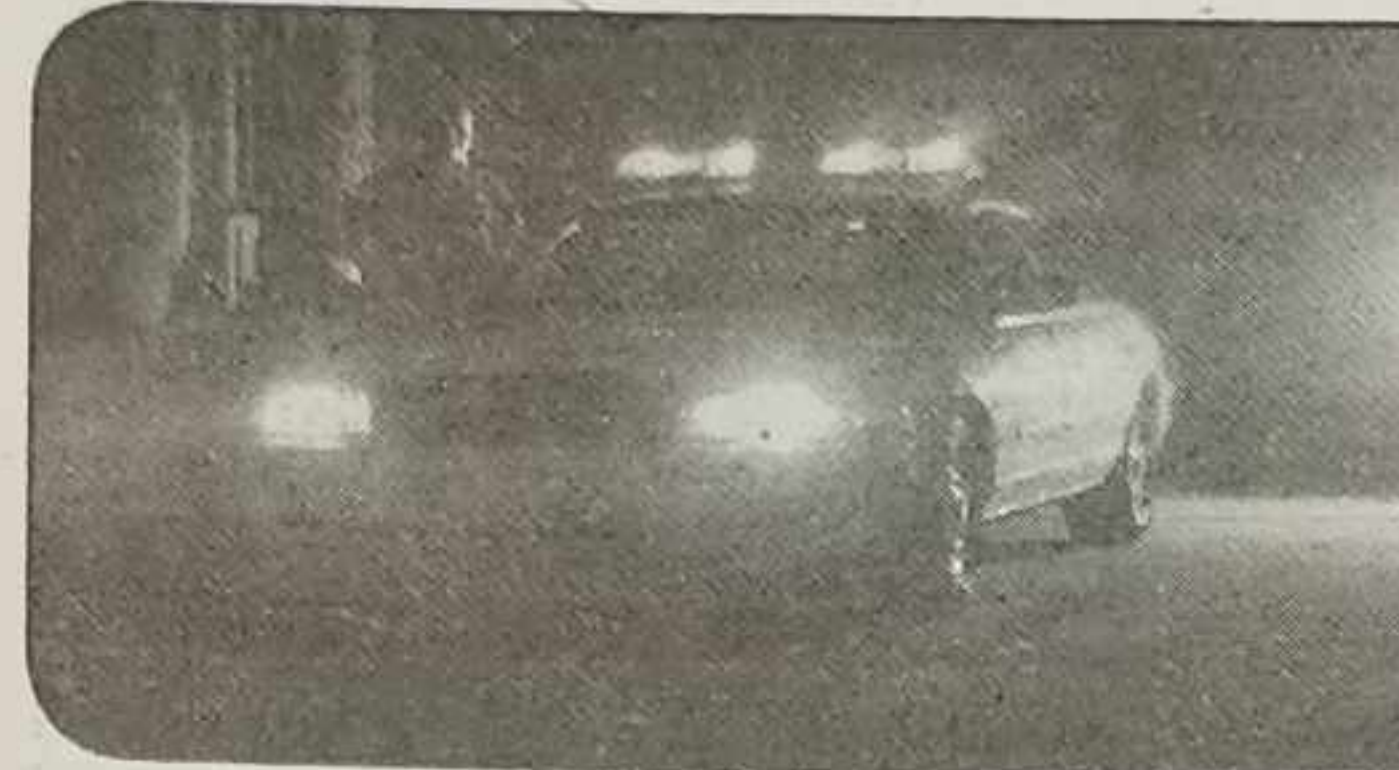

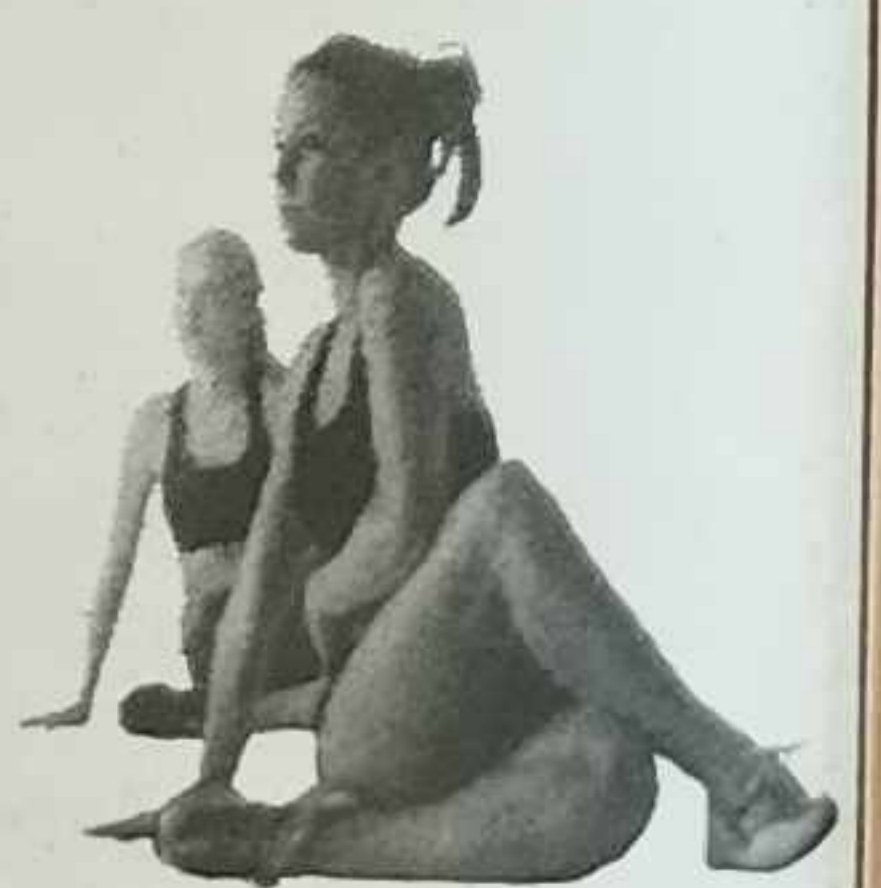

## Kewaskum School District will feel pinch of rising fuel costs in bussing

*School Board approves fuel escalator clause in bus contract*

**KEWASKUM-** Feel the pinch at the pump? Think of paying the tab on fueling a school bus. The dramatic rise in the cost of fuel has prompted The Kewaskum School District's bus company, Johnson Bus, to add a Fuel Escalator clause to their contract with the district.

Johnson Bus Company has been under contract with the Kewaskum School District to provide student transporta-

tion since 1993. Their contract with the district automatically renews each July 1. In May 2005 Johnson Bus met with district officials to inform the district they would be adding a fuel escalator clause to the contract.

The clause establishes a base amount for fuel and provides for reimbursement to the bus company for fuel prices that exceed this cost. The proposed base amount for the 2005-06 school year is \$1.33 per gallon of fuel. Based on using 60,000 gallons per

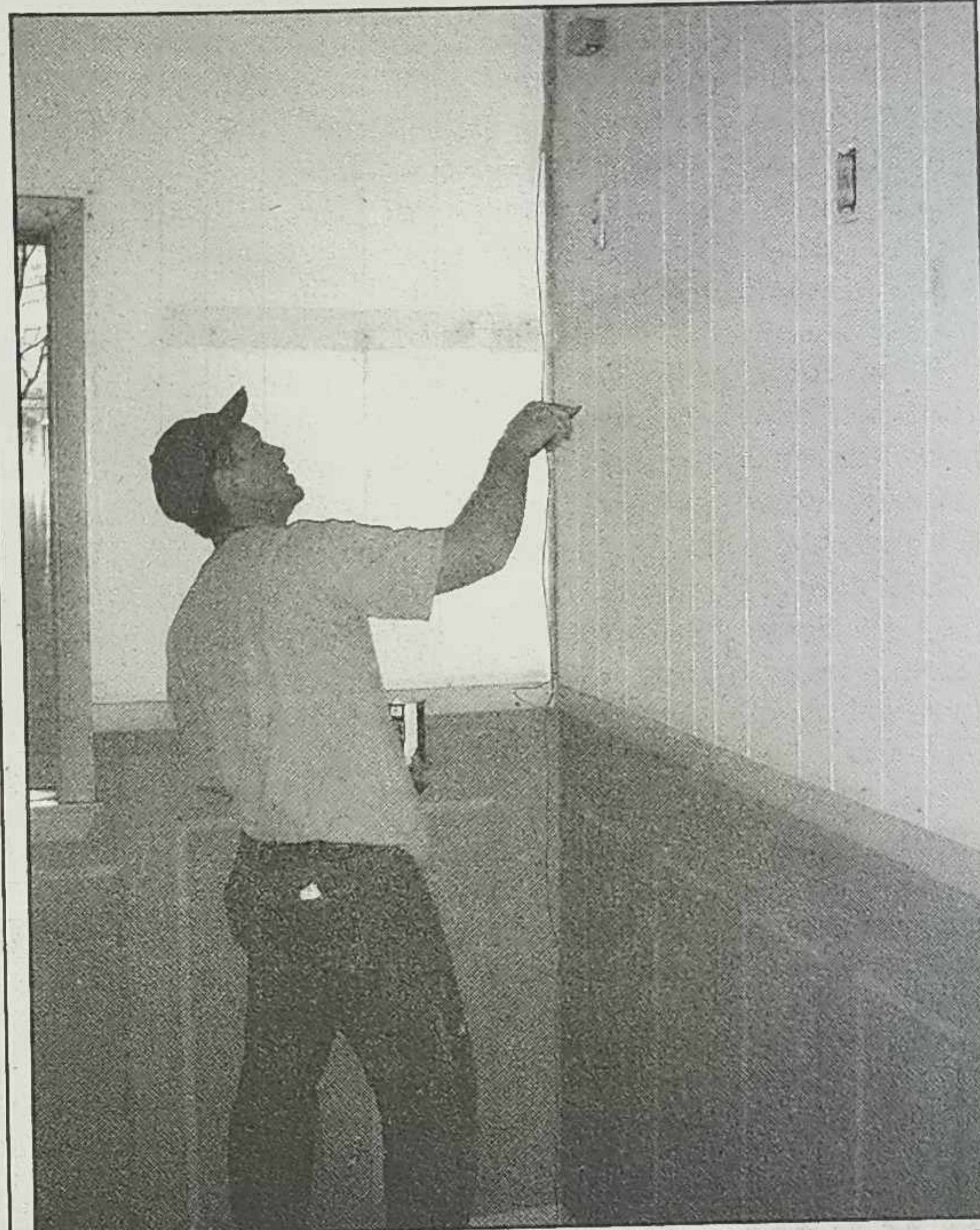
year and a net fuel price (gross price minus federal fuel tax) of \$1.86 per gallon, the estimated annual reimbursement required by the fuel escalator will be \$31,800.

The school district was informed that if they did not agree to the clause the bus company would not enter into the contract in July. The bus company asked the district to make the clause retroactive to 2004 and to split \$15,739 for that school year. They stated that if the district agreed to the clause for the 2005-2006 school year they would waive making the clause retroactive. Johnson Bus also agreed that if fuel drops below the base price they would credit the district.

The school board approved the clause early in the school year and according to the district's business manager Paul Reichert, taxpayers have paid \$25,632 for fuel surcharges from August until the end of December 2005.

"It looks like we will end up paying about \$45,000 in fuel surcharges for the entire school year. We are on track as to the number of gallons used. However, the average fuel cost per gallon from August until December is \$2.428," he said.

## Gateway Cafe prepares to open



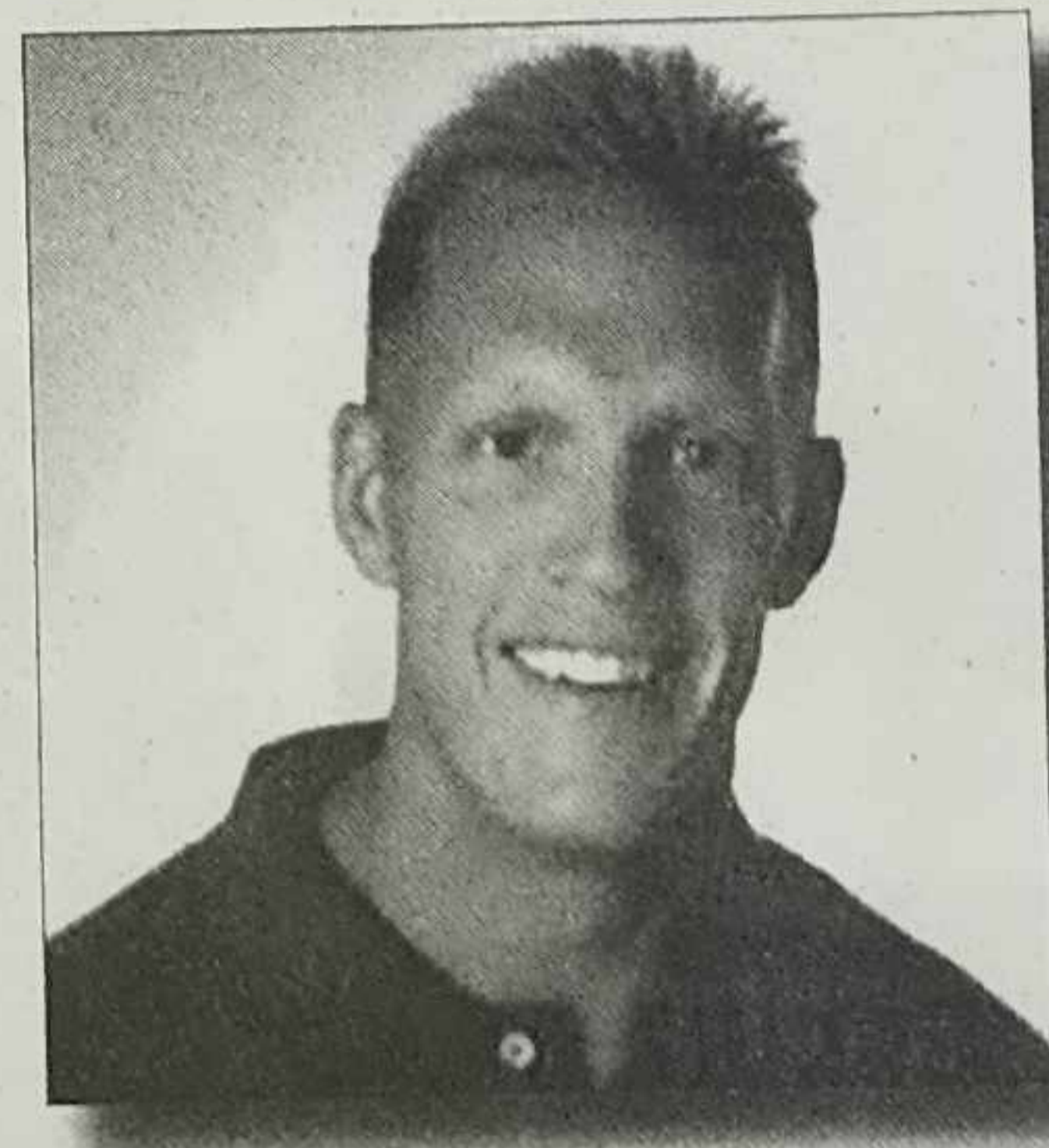

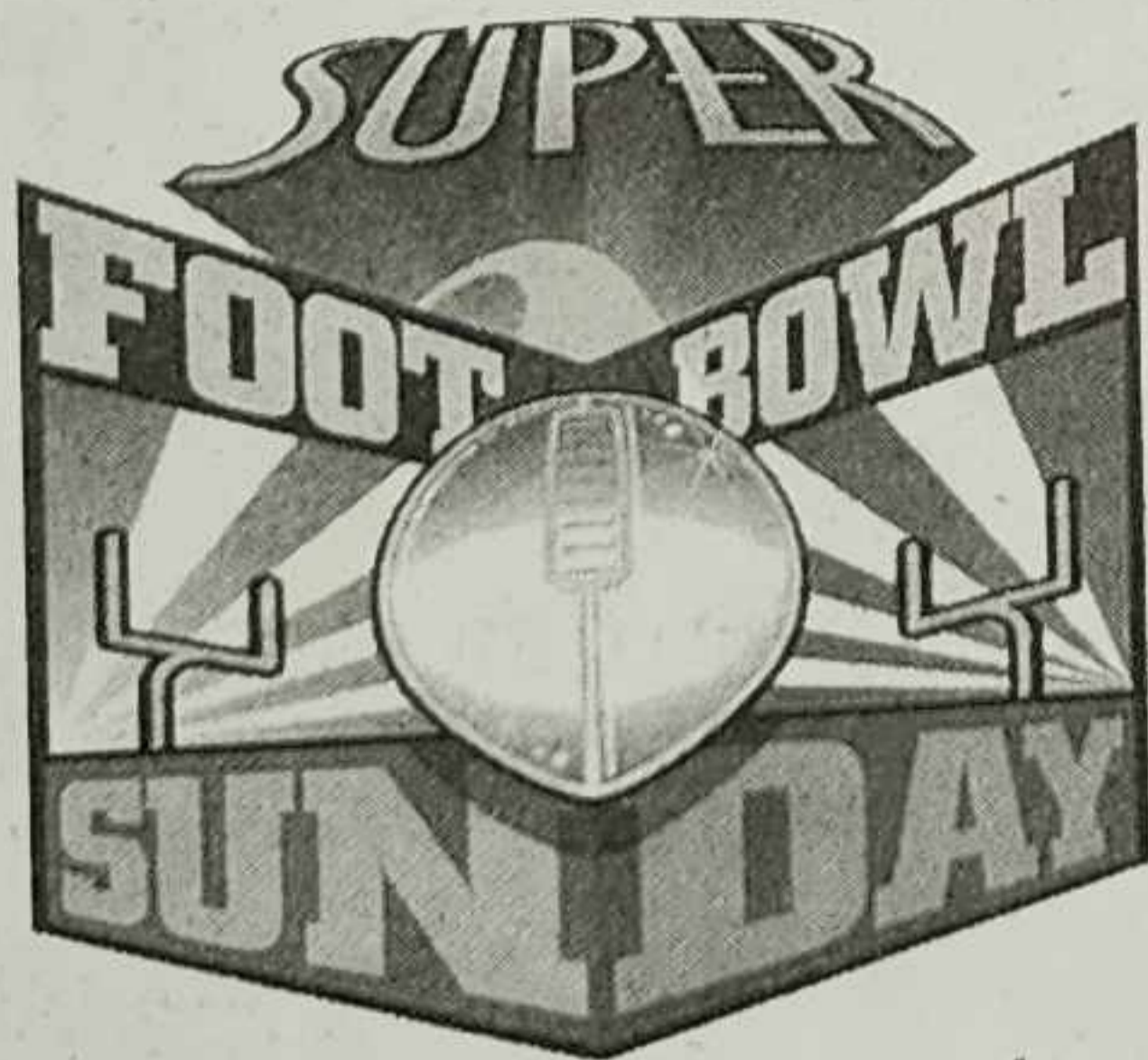

## Hide n seek, just got technical

Hide and Seek just got more complicated. Now you need a GPS unit, a journal, a compass, a map, Internet access and possibly a Jeep! It isn't just for kids anymore, now it's for caches.

Geocaching, pronounced geo-caching, has become a trendy adventure sport that is found in 50 states and over 100 countries. Using a Global Positioning Satellite Unit (GPS) participants find objects, known as caches. Once found, the caches can either be left alone for someone else to find, add to it, or helped along to their final destination.

A GPS unit is an electronic unit that pinpoints your location using longitude and latitude within 6 - 20 feet on the planet. Some GPS units have their own compasses, voice navigation and other bells and whistles.

Geocaching became a sport shortly after May 1, 2000, when the Clinton Administration removed the GPS signal degradation called Select Availability (SA).

To celebrate, on May 3 in Portland, Oregon, someone hid a container filled with objects - later known as a cache. By May 6, two people located the cache. Mike Teague was the first person to find the cache and started his own web page to track its history that was also posted to the sci.satellite-nav newsgroup.

Jeremy Irish found Teague's web site and his first cache in Seattle, Washington in July 2000. Together, the two sportsmen named the game Geocaching and developed an official Geocaching web

site, Geocaching.com that contributed to the growth of the unique game. Irish, who maintains the website, along with worldwide Geocachers have made the game a popular sport.

As of today, there are 225,373 active caches in 219 countries.

Geocaching comes from the word GEO for geography, and CACHING - both a computer term and also in hiking and camping - for hiding.

According to Russell Gross of Kewaskum, Geocaching is easy to play. When you find the cache, take something out, leave something else and write about it in the logbook. The first item in the cache

should be the logbook, which contains notes from the creator of the cache and all of its visitors. A small cache might only contain a logbook.

Larger caches may consist of a waterproof plastic containers or bags with a logbook, maps, money, books, CD's, tickets, jewelry, tools, etc. More challenging locations for caches can be placed under water, a rocky cliff or below ground.

Geocaching is a game that is constantly changing, so the rules are fairly flexible, except for one that requires caches not be moved to another location, unless there are instructions with the cache to do so, which is called a hitchhiker.

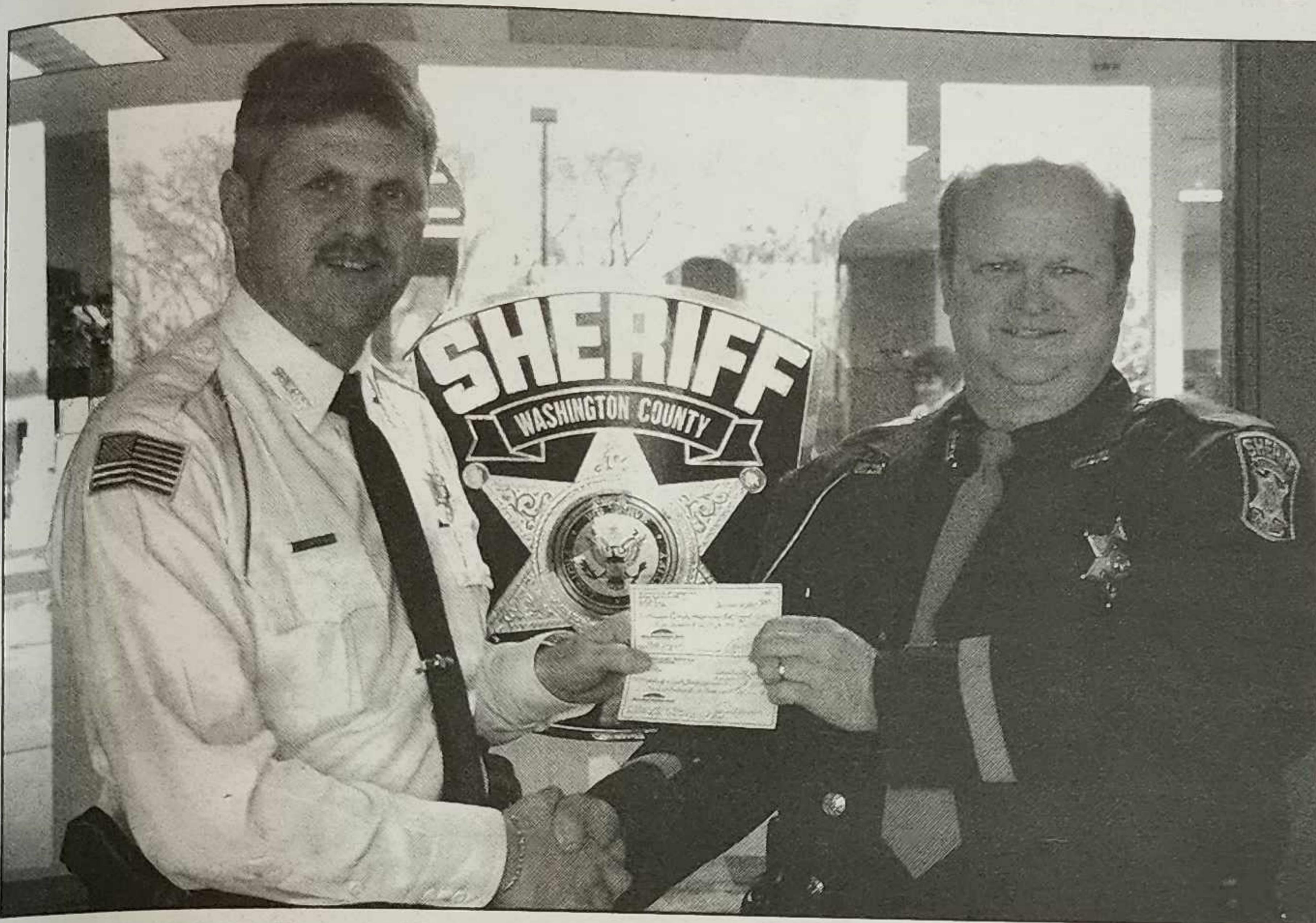

## Sheriff Rahn releases 2005 fatal crash data for county

**WEST BEND-** Washington County Sheriff Brian Rahn released the 2005 fatal crash data for the county last week. Interestingly, of the 17 total fatalities, 15 were male.

Rahn states that 17 people died in 11 fatal crashes in 2005. In the year prior, 13 crashes resulted in 13 deaths for motorists driving in Washington County.

"The goal of the Washington County Law Enforcement agencies is to reduce the number of fatalities throughout the county. That goal should be accomplished when we reduce the total number of fatal crashes," said Rahn.

Rahn stated that the deadly crash on STH 33 where five people were killed in the town of Trenton had a drastic impact on the numbers, as well as the three teens killed in a one vehicle crash in the town of West Bend in late November.

"Alcohol, excessive speed and inattentive driving were present in the majority of the 2005 crashes. This again is consistent with years past," said Rahn.

The sheriff stated his biggest concern with the fatalities in 2005 was that seven or 41 percent of the victims were under 18 years of age. "That is a staggering number," he concluded.

Of all the 17 victims, eight of them were the operator, six of them were passengers and three were motorcycle operators.

### Seat Belt Usage

Five of the victims could be confirmed as wearing their seat belts, six could not. Three people were unknown and two of the three motorcyclists were not wearing helmets.

### Food-shelter program funding received

Washington County has been chosen to receive \$29,972 to supplement emergency food and shelter programs in the County.

The amount awarded annually is determined by a national board chaired by the Federal Emergency Management Agency (FEMA), with representatives from the Salvation Army, American Red Cross, United Jewish Communities, Catholic Charities USA, National Council of Churches of Christ in the USA, and the United Way of America.

A local board coordinated by the United Way of Washington County and made up of representatives from American Red Cross, Catholic Charities, Department of Social Services, Friends of Abused Families, St. Vincent DePaul

Society, Salvation Army, United Church of Christ, Youth & Family Project, and other agencies and individuals, recommend how the funds are to be distributed to Washington County agencies.

Under the terms of this grant, local agencies chosen to receive funds must 1) be private voluntary non-profits or units of government, 2) have an accounting system, 3) practice nondiscrimination, 4) have demonstrated the capacity to deliver emergency food and/or shelter programs, and 5) if they are a private voluntary organization, they must have a voluntary board.

The local United Way Executive Director is in charge of distributing funds appropriated by Congress to help expand the capacity of food and shelter programs in high-need areas around the County.

Agencies interested in applying for these funds should contact Joe Calabrese, at the United Way of Washington County office, (262) 338-3821, by January 23th.

### Woman killed after being hit by train

**ALLENTON-** A 39-year-old Allenton woman was killed after a train hit her shortly before 1 a.m. on Monday, January 16 in the Town of Addison. Washington County Sheriff's Department Lieutenant Robert Martin stated she was traveling on foot at the time of the accident.

Arlene Deleon was killed

near the intersection of Main and Weis Street in Allenton after walking in the path of a northbound Canadian National Freight Train. The Sheriff's Department was notified of the collision at 12:52 a.m. Deleon was pronounced dead at the scene by the Washington County Medical Examiner's office.

It was estimated that the speed of the train at the time of the accident was between 40 and 50 miles per hour. This is within the normal range of speed for locomotives traveling through this area. The fatality remains under investigation.

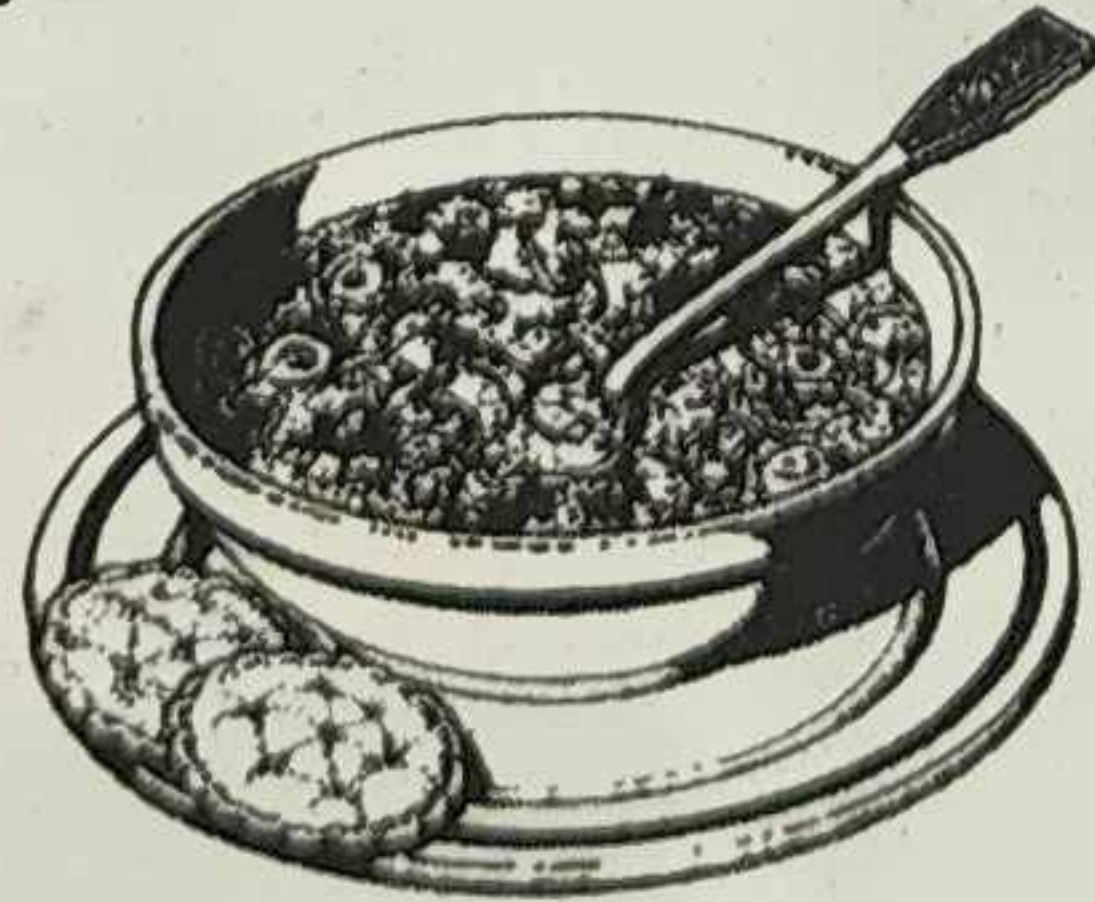

## - In Your Opinion -

There are times when a decision made by public authorities is questionable, debatable, even arguable. There are other occasions when one wonders what those officials may have been drinking to have come up with something that inane. And finally at times one of those decisions constitutes somewhat of a monument to aberration.

A beautiful instance of the last kind is the 25mph speed limit that was recently installed on the stretch of Prospect Road from Badger Road north to where it joins with State Highway 45. It is understandable that the previous 45mph limit might soon become higher than acceptable when the new subdivision opens to more homes. However, the 25mph limit in that section is at present almost laughable, laughable that is except for all those who have recently been pulled over and ticketed.

Almost without exception when traveling from the east on Badger Road I noticed some motorists pulled to the side with the flashing lights of a squad behind. I am sure there are some who might argue that these are all examples of very dangerous irresponsible speeders who should be kept off our roads to keep

them safe.

If the real purpose of this 25mph limit was to collect revenue to fill the town coffers, then it is definitely working. A few years back Kewaskum's reputation as a "speed trap" used to be rather notorious. That reputation has waned a bit of late. I would expect that this latest bit of brilliance will measurably help to again bring it back to its former claim to fame. In the meantime, as long as new signs are being posted, perhaps a few "speed trap ahead" signs would do wonders both to slow traffic and to help warn the motorists. Or if such signs are deemed too unsightly, perhaps a few speed bumps, one would guess, would also do the trick.

In the meantime Kewaskum's reputation is assuredly again on the rise.

## Local governments receive share of fuel tax, registration fees

As part of his ongoing "Grow Wisconsin" initiative to support economic development and encourage job growth, Governor Jim Doyle has announced that quarterly checks totaling nearly \$98.7 million for General Transportation Aids, Connecting Highway Aids, and Expressway Policing Aids have been conveyed to Wisconsin units of local government.

The Governor said that the January payments from the Wisconsin Department of Transportation (WisDOT) included \$95.2 million in General Transportation Aids to 1,923 units of government; \$3.2 million to 122 municipalities for Connecting Highway Aids; and \$272,700 to Milwaukee County for Expressway Policing Aids.

This year, local governments will share an estimated \$394.7 million from the state transportation fund to build and maintain local roads and bridges, and in Expressway Policing Aids that support the Milwaukee County Sheriff Department's patrol of Milwaukee expressways. Quarterly payments are sent the first Monday in January, April, July, and October.

"Wisconsin's quality system of federal, state and local

roadways serve as the backbone of our economy," Governor Doyle said. "These local transportation aids represent a vital investment in supporting the safe, efficient movement of both people and commerce."

General Transportation Aids help defray the costs of constructing, maintaining, and operating roads and streets under local jurisdiction. Connecting Highway

Aids reimburse municipalities for maintenance and traffic control of certain state highways within municipalities.

Communities also receive state transportation fund revenues for public transit, elderly and disabled transportation, and airport and harbor development from WisDOT. State and federal funds will also be allocated for specific highway and bridge construction projects.

## RESOLUTION 2006-02

### A RESOLUTION OF THE VILLAGE OF KEWASKUM, WASHINGTON COUNTY, WISCONSIN DECLARING THE INTENT OF THE VILLAGE BOARD TO ESTABLISH A STORM WATER UTILITY DISTRICT IN THE VILLAGE OF KEWASKUM

WHEREAS, the Village Board of the Village of Kewaskum, Washington County, Wisconsin, has approved the storm water management plans for the Woodland Creek Subdivision, Woodland Creek Addition No. 1 and related outlots ("Woodland Creek"); and

WHEREAS, the storm water management plans for Woodland Creek include the use of "Stormceptor" type traps for the control of pollutants in storm water runoff; and

WHEREAS, the Wisconsin Department of Natural Resources has approved the storm water management plans for Woodland Creek, subject to the Village agreeing to take responsibility for the long-term maintenance of the "Stormceptor" type structures; and

WHEREAS, the Developer of Woodland Creek has installed, at his own cost, the storm water management facilities as required by the approved storm water management plans; and

WHEREAS, said structures are not used elsewhere in the Village and are more costly to maintain than storm water management facilities located

elsewhere in the Village; and

WHEREAS, it is the intent of the Village that the cost of providing and maintaining said structures should be charged to properties within Woodland Creek in the form of annual service charges.

NOW THEREFORE BE IT RESOLVED, by the Village Board of the Village of Kewaskum, Washington County, Wisconsin, that:

**Section 1.** Pursuant to Wisconsin Statutes Sections 66.0827 and 66.0821 and in accordance with § 66.0703, the Village Board hereby declares its intention to establish a utility district in the Village of Kewaskum, Washington County, Wisconsin, and to charge storm water service charges to properties in the utility district for a public purpose to wit: to provide storm water management service to said utility district.

**Section 2.** The limits and boundaries of said proposed utility district are set forth on the map and legal description attached hereto and incorporated herein and made part hereof by reference as Exhibit A.

**Section 3.** The properties to be included in the proposed district are benefited by the maintenance of storm water management facilities within the proposed district, and said actions by the Village Board constitute an exercise of the police power of the governing body of the Village of Kewaskum, Washington County, Wisconsin.

**Section 4.** The method of charging for costs of providing the storm water management services within the district will be determined at the hearing required under Wisconsin Statutes Section 66.0703(4) and the engineering firm employed by the Village shall make a report thereon.

**Section 5.** Said report shall comply with the requirements of Wisconsin Law and shall include:

A. Preliminary plans and specifications;

B. An estimate of the annual cost of maintaining the planned improvements.

C. An estimate as to the approximate annual cost per unit for properties affected and a schedule of the proposed annual charges for each property affected.

D. A statement that the properties against which the assessments are proposed are benefited.

**Section 6.** The Village Clerk shall give public notice of said public hearing.

**Section 7.** Each paragraph of the Preamble of this Resolution shall be and is hereby incorporated in its entirety into the substance of this Resolution and made a part of this Resolution by reference as though fully restated.

**Section 8.** If any provision of this Resolution is determined to be invalid or unconstitutional, or if the application of this Resolution to any person or circumstance is invalid or unconstitutional, such invalidity or unconstitutionality will not affect other provision of applications of this Resolution that can be given effect aside from the invalid or unconstitutional provision or application.

# Daggett shares story of remarkable crash landing

1/LT. FRED A. TREYZ  
(Part One)

In my review of the book "B-29 Units of the Korean War," and a short story written by me and titled, "The Unexpected," my aircraft commander, 1/Lt. Fred A. Treyz, is mentioned frequently.

"B-29 Units of the Korean War," sparked my curiosity to Treyz's whereabouts. The last time I saw Treyz, and for that matter the rest of our crew, was in my hospital room in California. We said our final goodbyes after they were assured I was going to be okay.

My appendix had ruptured on the way back from Korea. We all then lost contact with each other. Now over 50 years later, I hoped I could find Treyz. I wanted to tell him about this book first published in 2003 in Great Britain that covered our crew and aircraft.

I decided to check with the Air Force and was advised that the Worldwide Locator System at Randolph Air Force Base, Texas, could possibly help me locate him. From my military records I had his AO number and year of birth, 1923.

The information I received back, was not what I had expected. Treyz has been deceased since April 9, 1984. He would have been only in his early sixties. It is hard for me to accept the fact that he is gone. All the while I knew him, which began amazingly enough when we were in training at Randolph Air Force Base, Texas, he was always the picture of good health. We were together for over a year. He had hand-picked us for his crew and as my aircraft commander, I held him in high esteem as an exceptional pilot.

The Air Force advised me that if I sent a letter in a stamped envelope, they would forward my letter to the Treyz family. Because of the Privacy Act of 1974, the Air Force could not release the address of the Treyz family to me. I did write a letter and enclosed it in a stamped envelope for the Air Force to forward to a family member. I really hope someone does respond, as I want them to know what Treyz meant to me.

I have always felt that I owed this man a debt of gratitude for saving my life, as well as the rest of the crew, when he landed our B-29 on a fighter strip near the 38th Parallel in Korea. This fighter strip was located on a large plateau with a steep droppoff at the end of the runway. We had lost #4 engine and #3 engine was running at slightly less than half power.

By using max. military power (this is something that can only be done in an extreme emergency and then only for a couple of minutes) on the other two engines, we had just enough power to keep our aircraft in the air. Thanks to Fred Treyz's remarkable skill and ability to stay cool, he crash landed our B-29 at the end of the runway on that fighter strip and we all walked away from it.

I had heard that Fred Treyz had received the Distinguished

Flying Cross and the book "B-29 Units of the Korean War," proved it. It doesn't tell why, but, I know the Military Brass were in awe of his landing that day. He also held a record for no aborts of missions flown in the Korean War so he could have received the Distinguished Flying Cross for either accomplishment.

After we crash landed and were all walking away from our B-29 that day, a panther jet that had escorted us to the target and back to where we crash landed, also was forced to make a crash landing. He would come along side our wing tip while making a pass, check our engines, dip his wings and then make a wide circle and repeat coming back alongside of us, again and again.

In doing this, he was using up a lot of fuel. He escorted us until we landed on the fighter strip. That pilot was Ted Williams of baseball fame. He had a job to do and he did it! I will always be grateful to Williams and I'll never forget his role this eventful day in my life. His jet was running low on fuel and he couldn't get his gear down or open his canopy.

The runway was foamed down and his jet caught on fire as he skidded to a stop near our B-29. Apparently from the impact of the crash his canopy popped off and he escaped from his burning plane.

Both Treyz and Williams were reservists called up by Uncle Sam to fight for Freedom for the Korean people. Being debriefed at that forward fighter strip by military intelligence that day was quite an experience for all of us. We all were quite hyped up and meeting a celebrity like Williams was really something else. The Korean War was referred to as a "police action" and these men never received the recognition they were due from their countrymen. What a day that was! I also ran into a West Bend High School buddy of mine, Mike Gonring. Mike was a supply sergeant at this forward fighter strip. I find it hard to accept the fact that Fred Treyz is gone and question what happened to this remarkable man, who was my friend. A man with his abilities and intellect should still be around. I hope some day I will find out what happened. I regret I didn't seek this information years ago and keep in contact with my crew and Treyz. You always think you have plenty of time.

POST SCRIPT: 1/Lt. Fred Treyz died April 9, 1984 after a courageous battle of nearly two years, with cancer. He had a long and distinguished career in the Air Force. He retired a Brig. General. He had only been retired a couple of years when he learned he had cancer.

I am filled with immense pride to have had the privilege to know and serve our country with Fred Treyz, when we both

were younger men.

I am very grateful that the Air Force Locator System out of San Antonio, Texas did forward my letter to the Treyz family. Fred's widow, Caroline Treyz, responded with a handwritten letter in April, 2005.

It has been 53 years since Fred Treyz and I last saw each other. During this period of time I had no idea what had become of him, but I always felt that he would become a career officer in the USAF. GOD BLESS OUR MEN AND WOMEN SERVING IN THE MILITARY SERVICES.

## Vanilla-Chai Icebox Shortbread Cookies

2 -1/3 cups. all purpose flour  
2 tsp. pumpkin pie spice  
2 tsp. ground ginger  
1/2 tsp. ground allspice  
1/2 tsp. ground cardamom  
1 cups (2 sticks) unsalted butter, softened  
1 cup granulated sugar  
3 Tbsp. honey  
1/4 tsp. salt  
2 large egg yolks  
1 medium vanilla bean  
Icing:  
1 cup confectioners' sugar sifted  
2 tsp. pure vanilla extract  
more vanilla bean scraping, if desired  
1 Tbsp. water

In large bowl, sift or whisk together flour, pumpkin pie spice, ginger, allspice and cardamom. Set aside.

Combine butter, sugar, honey and salt in a bowl. Using an electric mixer or wooden spoon, beat until light and fluffy. Add the egg yolks, one at a time, and beat until smooth.

Using a small knife, split the vanilla bean lengthwise in half. Scrape the seeds from both sides of the pod with the tip of the knife and add them to the butter-sugar mixture. Beat to combine.

Add in flour-spice mixture, 1 cup at a time, blending until fully incorporated.

Divide the dough in half and transfer each half to a sheet of wax paper. Using the wax paper, shape into a 12-inch log, rectangle, or square. Chill logs at least two hours or overnight.

Preheat oven to 350° with an oven rack in the middle. Line two baking sheets with parchment paper.

With a sharp knife, cut logs into 1/8 inch thick slices and arrange 1/2 inch apart on baking sheets. Bake until lightly browned around edges, about 10 to 12 minutes. Transfer to racks to cool.

In a small bowl, whisk together icing ingredients until smooth and transfer to sealable plastic bag. Cut a 1/8 inch opening in one corner of bag. Arrange cookies as close together as possible on sheets of wax paper and drizzle icing decoratively across the tops.

It's winter and you've got a nasty cough. Your eyes are scratchy. You're hacking so hard you feel like your ribs might break. Overall, you feel pretty rotten.

You have a cold, but read "The Worst Hard Time" by Timothy Egan and look on the bright side. You're clean and dry and not choking on dirt.

In the latter nineteenth century, some 21 percent of the U.S. and Canada was covered by vast wild and natural grasslands. In the state of Texas alone, over 450 species of native grasses flourished.

Corporations, which bought up much of the land once it was cleared of bison and Native Americans, began to entice people to come to the area to farm, even though cowboys who were familiar with the grassland said that plowing up the ground was the wrong thing to do. The best side is up, the cowboys told settlers. Besides, the Plains were arid, desolate, and just plain not good for farming.

When Germans from Russia immigrated to the Plains states, they brought with them talent for eking a living out of nothing, and a few seeds of hardy winter wheat. Within a short time, the entire southern Plains area was immersed in a wheat boom. Farmers plowed up record amounts of grassland to plant wheat, and they were making more money than they ever dreamed possible.

Every now and then, though, the weather brought a hint of what was coming. Occasional dust storms hammered small towns on the Plains, but me-

teorologists considered them anomalies.

And then the drought came, and it lasted for years. The area became a Dust Bowl, and temperatures shot up in the three-digit range. Brutally high winds stripped topsoil off the land and deposited it thousands of miles away; scientists believed that during the storms of March and April 1935, nearly five tons of dust per acre fell on Kansas settling in Boston and on ships at the harbor. New Englanders reportedly were surprised by it.

So what about those people who stayed on their land because they had no choice or no money to escape? Therein is the most fascinating part of this story.

"The Worst Hard Time" is one of those books you'll want to pick up and read slowly, so you don't miss a thing. Author Timothy Egan interviewed several survivors from the Dust Bowl years because he says that their memories will be irretrievable when those people are gone.

Egan is alternately a story recorder and a historian. He skillfully pulls you in to his book until you feel the choking horror of drowning in dirt, the misery of relentless heat, and the despair of watching your family sicken and your livestock die. Not many authors can make history so vivid, but Egan does.

If you're in the mood for a fact-filled and fascinating book on American History, this is the one to read. "The Worst Hard Time" is a book you'll have a hard time forgetting.

## Lady Indians have no chance against two EWC powers

It wasn't a case of not trying. The Kewaskum girls varsity basketball teams were simply overwhelmed by bigger and better teams in their recent outings against Campbellsport and Two Rivers.

The Lady Indians lost to their arch rival Cougars, 78-29 last Tuesday, and the score of the home game against Two Rivers on Friday night was 83-26.

With the defeats, Kewaskum's record in the Eastern Wisconsin Conference dropped to 0-7. Overall the Indians are 0-13.

"Campbellsport is undefeated in conference for a reason," KHS coach Dave Kraft said Monday. "They have a good basketball team."

Kraft said once again his young players had problems against a swarming defense.

"Their defensive pressure got to us ... we had a hard time dealing with it ... a lot of turnovers," he said.

Campbellsport, behind the offensive firepower the two Benike sisters, Kelsie and Kallie, who combined for 31 points, blazed out to a 25-4 lead after one quarter and never looked back.

Junior guard Sam Droese and Taylor Long, the only senior on the team, paced Kewaskum with 11 points apiece. Freshman Jennie Wicklund chipped in with seven points. No other player scored for the Indians.

"The two games were carbon copies of each other," Kraft went on. "They've got some big girls in the middle. Their inside players just ate us alive."

Two Rivers has a 6-foot-3 freshman who weighs about 190 pounds, according to Kraft, who said the Raiders also have two others who stand 6-0 and 5-10.

"Their big kids combined for 40 points," Kraft said. "Kelsey Goetsch (Kewaskum's 5-11 freshman center) found out what it's like to be short.

In that game, Droese had nine points and Long had eight.

Despite the struggles the

team has been through, only one player has quit the team. "We've been going with seven," Kraft said, indicating taking another young player from the JV team would not really help the situation. "I think it's better this way."

Kewaskum has no easy task this week, entertaining Roncalli on Friday night.

### Monster Whole Wheat Cookies

- 1 1/4 cups all-purpose flour
- 1 cup whole wheat flour
- 1 tsp. baking soda
- Large pinch salt
- 3/4 cup granulated sugar
- 3/4 cup packed light brown sugar
- 3/4 cup (1 1/2 sticks) unsalted butter, softened
- 1 1/2 tsp. vanilla extract
- 2 eggs
- 2 cups toasted walnut pieces
- Maple Glaze:
  - 1/2 cup confectioners sugar
  - 2 tsp. milk
  - 1 tsp. maple flavoring

Preheat oven to 350° with oven racks in upper and lower thirds.

Combine flour, baking soda, and salt; reserve.

Combine sugars and butter in a bowl. Using an electric mixer or wooden spoon, beat until fluffy. Add vanilla, then add one egg at a time. Mix dry ingredients into butter mixture and thoroughly blend. Fold in walnut pieces.

Using 1/4 cup dough for each cookie, roll into a ball; place 4 inches apart on buttered baking sheets. With fingers, flatten each to about 3 inches indiameter.

Bake until lightly browned around edges, about 12 min. Remove from oven; cool about 2 min. on the baking sheets, then transfer to a wire rack to cool completely.

Thoroughly mix confectioners' sugar, milk and maple flavorings until smooth. Add a drop or two of more milk, if necessary to achieve drizzling consistency.

Using spoon, drizzle each cookie with glaze. Let glaze set.

## Parrent hits 2 late FTs to clinch OT effort Guards Scheel and Cain propel Indians to 1st EWC victory

Following the darkness, last week's loss to previously winless Kiel, came the light for the Kewaskum High basketball team in its Eastern Wisconsin Conference contest at Two Rivers last Friday.

Using 38 points from its two starting guards, Casey Scheel and Eric Cain, Kewaskum edged the host Raiders 69-67 in a thrilling overtime game.

With the win, Kewaskum, which has had its share of close losses, finally got the monkey off its back in the EWC and is now 1-5 in conference play and 2-9 overall.

"Anytime you come back from Two Rivers with a win, you're in a good spot," coach Glenn Eichstedt said, explaining in recent years Two Rivers has not been timid about announcing the fact since Kewaskum has come into the EWC, they haven't beaten the Raiders many times. "We've played something like 46 games, and prior to last night, we had won three."

Eichstedt urged his charges not to look at those figures but instead to just concentrate on this one game. And they did.

Scheel led the way with 21 points, spreading them out in all quarters but the second and coming up with two key free throws in the extra period.

"Casey was solid all the way through," Eichstedt said about Scheel's offensive performance. Especially impressive were the two clutch 3-pointers in the fourth quarter when the Indians outscored the hosts 17-11 to knot the score at 63 all. Scheel also was credited with a whopping 10 assists, showing he also was looking for his teammates who were in position to score.

Cain also put on quite a show from the outside, hitting three rainbow jumpers for nine of his 17 points.

Eichstedt said both Scheel and Cain connected for three pointers in the first quarter, "We shot real well, but the big thing was Mitch Paulus came in and gave us a tremendous lift."

With Paul Gaynor again slipping into foul trouble — he had two early — Paulus came alive to help out with 10 points, including seven in the first quarter. "He kept us in the game that quarter," the coach said, indicating his team was playing poor defense, which continued in the second quarter, resulting in a 42-32 deficit. "We give up 42 points in the second half and we have no chance."

That's what half times are about, and during the break, the

Indians made some changes in an effort to slow Jon Coogle down a bit after he scorched the nets for 15 of his 23 points in the first half.

"He's (Coogle) a tough one to guard," Eichstedt said, indicating a zone helped to stop him from penetrating in the second half, and 6-foot-5 post player Jon Mueller didn't get as many easy chances inside as he did early.

Steadily the Indians drew closer to the Raiders, and it was Scheel's three with :25 left that knotted the score at 63-all.

Two Rivers got off a shot, but Noah Timm was off balance when he took it, and it never had a chance.

In the OT, Gaynor, who was able to come back and contribute nine points and a team-high 10 rebounds toward the victory, scored a bank shot from the free throw line with 3:30 left. This gave the Indians a 65-63 lead.

Coogle got one back with a free throw (65-64), then the clock ticked down to :52 before anyone scored again.

It was Scheel making a pair of free throws for a 67-64 advantage, then Timm canned a three from the corner with just under a half of a minute to go to tie the score at 67-all.

KHS called a time out and set up a "high-low play" which was to go from Gaynor to Matt Parrent who was double and even triple-teamed most of the way and didn't make a field goal the entire game.

"He (Gaynor) ended up making a nice bounce pass to Matt. His first shot was blocked, but he got the rebound and was fouled on the second try," Eichstedt said. Parrent made the winning free throws with :03 left.

Two Rivers did get off a long shot but it missed, and the Indians had their first win in the EWC.

The balance in the scoring and fewer turnovers — the statistician had just 11 for the Indians — were just what Eichstedt has been looking for from his team.

Plus, another reserve helped out. "Austin Flanders gave us a big boost with a three in the fourth quarter," Eichstedt said.

The effort comes just in time, because Campbellsport, which has just one loss in the EWC thus far, was scheduled to come to Kewaskum on Tuesday (Jan. 17th) night.

"Our kids are really looking forward to that one, just because it's Campbellsport," Eichstedt said.

Tomorrow night (Friday), Kewaskum travels to Manitowoc to face unbeaten Roncalli.

## Kewaskum, others will welcome Waupun to EWC in 2007

Waupun High School is in. Roncalli is leaving.

Those changes will be made in the makeup of the Eastern Wisconsin Conference beginning with the 2007-'08 school year after the WIAA's (Wisconsin Interscholastic Athletic Association) Board of Controls voted unanimously on Jan. 13 to approve realignments affecting eight athletic conferences in northeast Wisconsin.

Tentative approval had been given by the board in December, but there was a 40-day window for schools to file appeals to the proposed changes.

In an e-mail announcement that went out last Friday, the WIAA said there were no appeals filed and a final vote had been taken favoring the plan.

"We got the notice late Friday evening," Kewaskum High Athletic Director Jason Piittmann said Sunday. Piittmann had figured if anyone currently in the EWC would appeal, it would be Two Rivers, but they chose not to.

"Even though the superintendent wanted to, he figured what would be the use since the board had voted unanimously to make the move.

The entire process of the realignment took about a year, according to Piittmann, who said about this time in 2005 there was a letter from Deb Hauser, an associate director with the WIAA, on the possibility of changes. "Last spring she met with the Eastern Wisconsin Conference schools and Waupun in Plymouth," he said about initial discussions, which may have been prompted by Roncalli's desire to leave the conference because its enrollment (about 290) was no longer in line with the other schools.

Schools in the Green Bay area, the Fox Valley and Fox Valley Association schools, along with the Olympian, Packerland, Valley 8 and the Wisconsin Flyway Conferences were also involved in realignment propos-

als and ultimately in the final decision.

As far as Piittmann is concerned, Waupun "will fit very well in our conference," because it offers the same sports as the current EWC, its enrollment is very close to the three largest schools and it will mean shorter trips than going to Roncalli, which is located in Manitowoc.

When asked what strengths Waupun will bring to the EWC, Piittmann said, "Obviously volleyball." He said at first he waited to see what the reaction of some coaches might be to having a state power come into the league. It now appears the coaches feel Waupun will "raise the level of play" in the sport and help get some of the other schools prepared for the quality of play exhibited in the sectional tournaments.

"Their football program is solid," Piittmann went on. "Their wrestling is OK, and baseball ... they had been playing spring ball, but their coach is anxious to play summer ball."

Track appears to be a little weak, according to Piittmann, who noted the new school still does not have a track but there is some fund raising going on in the community to try to get one and a football field at the new school. (Currently Waupun's football games are played at the old school.)

Waupun will be the second largest school in the EWC, behind Plymouth, but there might be some shuffling in the order because of enrollment predictions.

"Two Rivers is projecting significant drops in the next years," Piittmann said, and as far as Kewaskum, he added, "it's hard to say what will happen" since there are more homes in the community but smaller families.

Whatever the case, Piittmann is happy the decision to bring in Waupun and let Roncalli go to the Olympian Conference has been made. "If it hadn't passed, we would have been pushed back another year."

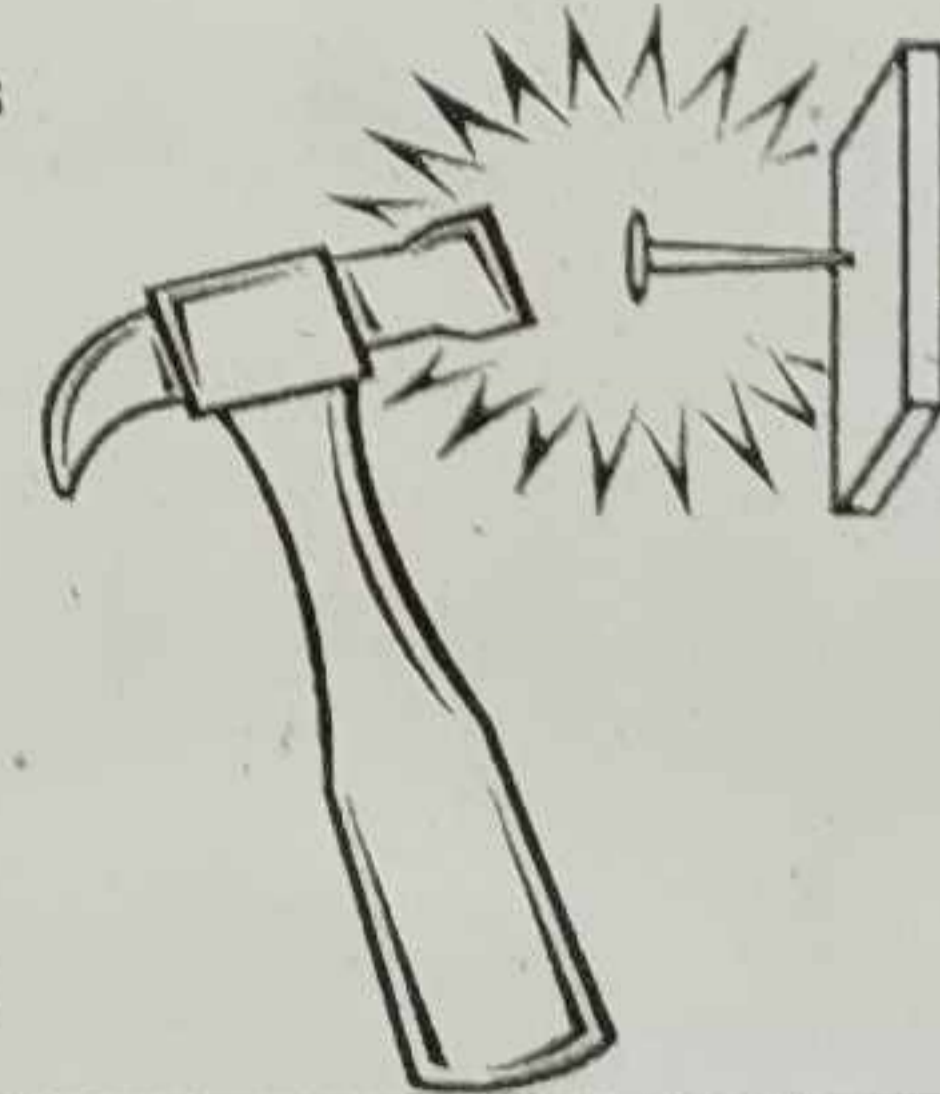

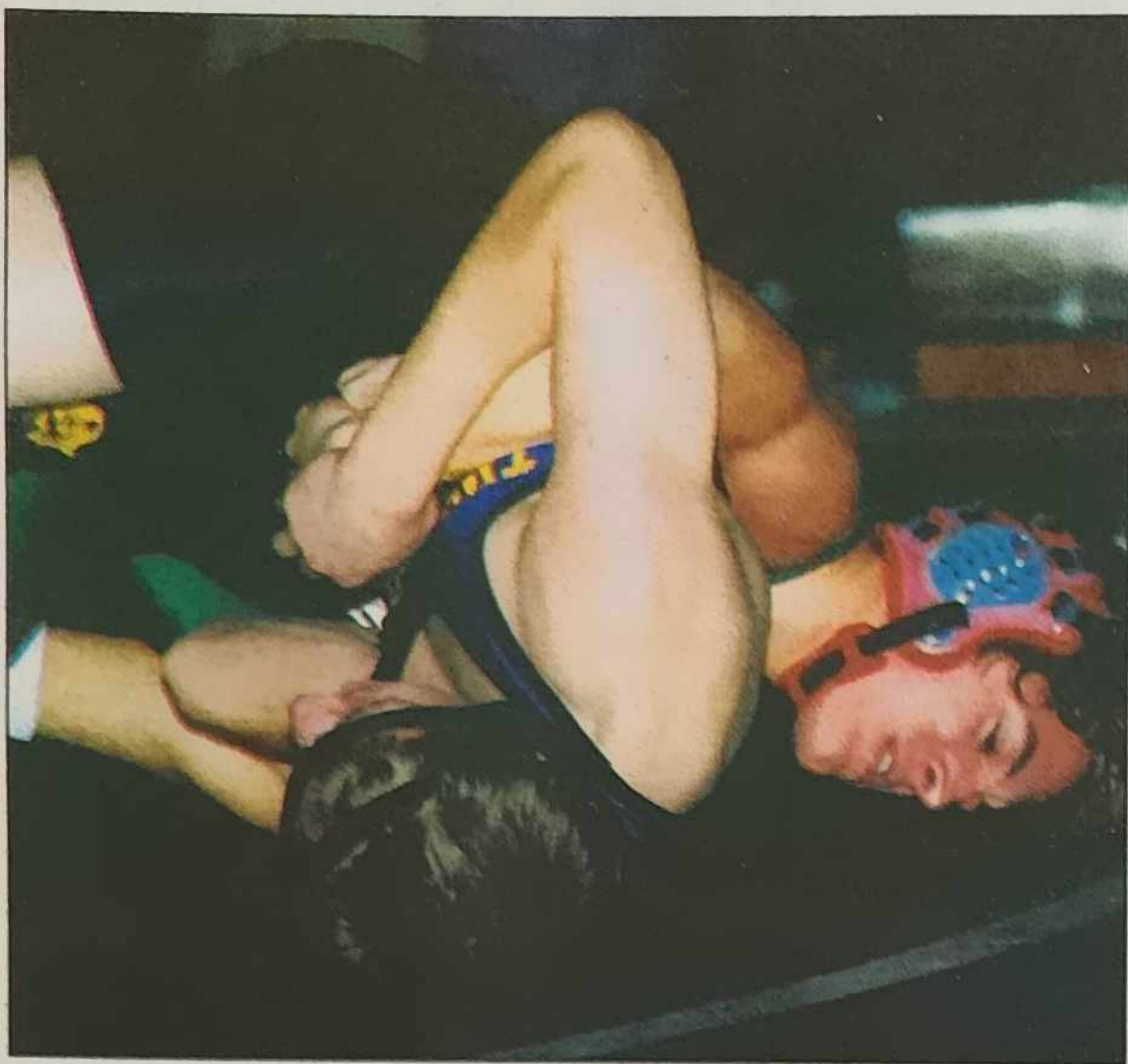

How the tide has turned in the Eastern Wisconsin Conference wrestling circle.

Once a power in the EWC, Two Rivers is now lucky to field seven or eight varsity wrestlers and to see the light of the upper division of the league.

Kewaskum, on the other hand, has climbed to the upper echelon, and even with a couple injuries, continues to win conference matches. The Indians used seven pins and four forfeits last Tuesday to manhandle the Raiders 66-18. Kewaskum is now 5-0 against EWC foes and 11-3 overall.

Not a single bout went the full six minutes, and the match was over in 35 minutes.

"Yeah, that was quick," KHS coach Dennis Aupperle said afterward. When asked if he knew the Raiders were this weak, the coach said, "No, I haven't really followed them ... I think they are young and low in numbers."

Two of the Indians' aces, Scott Rhoads and Eric Ogi, were relatively unchallenged. Ogi needed just 2:32 to pin Rob Wandrie, while Rhoads used a variety of moves to get a little workout against Travis DeBauche before pinning him in 3:30.

With this win, Rhoads improved to 23-1 overall, while Ogi, who missed a few early matches to get to his right weight, is 17-3.

Rhoads is "looking good" Aupperle said. "He works hard and everybody knows that. They knew what they're getting into (going against him)."

Aupperle is also pleased with the way Mason Smith and Jon Hawig wrestled in the

match. Both notched pins.

"Mason and Jon are both doing a lot better, and we'll need that for what's coming up," Aupperle said.

The one "downer" in the match came at 152 where Eric Turowski had to injury default.

"He was just trying to tie up with him and throw him and he dislocated his elbow," Aupperle said about the injury which comes at the same weight where two other Indians are currently out with injuries.

Nick Bartley, a two-time state place winner for Kewaskum, is still out with a knee injury, but Aupperle expects he may be back soon. "He's been going to therapy three times a week," the coach said, indicating putting him in the recent premier On the Waters and Marty Loy Tournaments would not have been smart, because it might have meant losing a chance to compete in the upcoming EWC Tournament (Feb. 4 in Kewaskum) and the state series.

Jake Sabel had been doing a good job substituting for Bartley, going 14-6, but then after winning his first three matches in the On the Waters test, he also suffered an injury.

"Jake's going to see the doctor on Thursday," Aupperle said, hoping he will be back next week.

The big showdown in the EWC is tonight (Thursday) with Campbellsport, which is also unbeaten, coming to Kewaskum. Last year's battle between the two long-time rivals was a dandy, with Kewaskum winning 38-36 on Jake Turowski's victory at 189

pounds.

"The lower weights are going to be big," the coach said, then pointing to matches at 103, 112, 119, along with the two on the upper end, 215 and heavyweight, and saying, "Whoever wins three of the five will probably win (the match)." Jake Turowski's match against Billy Mayer is also expected to go a long way toward determining the team winner ... and ultimately the EWC dual meet championship.
