T. Wayne Plan Commission tables concept plan recommendation

Residents still unhappy about rezoning of parcel

TOWN OF WAYNE- Almost 100 residents and three Washington County Sheriff's Deputies packed the Wayne Elementary School gymnasium for the Town of Wayne's Plan Commission meeting Tuesday, March 14 to express their thoughts about a 31 lot subdivision proposed for the township. Recently, numerous town residents have been angered at what they say is a disregard of the Land Use Plan that was adopted in 1998.

Steve Kearns pitched his idea of a 31 lot residential subdivision in February on what is known as the Jankowski farm located on West Bend Road to the plan commission. Kearns asked the Plan Commission to make a favorable recommendation to the town board to rezone a portion of the land to R-1. Town residents in attendance were not pleased with the idea.

Commissioners were informed by the town engineer that recommending the rezoning request would allow for a cluster development with 30% open space. If they did not recommend rezoning, the subdivision could still be created, but would require 60% open space. At that meeting commissioner Tony Bailey motioned not to recommend the rezoning to the town board. Mike Samann seconded the motion. The vote was unanimous.

The commissioners stated they felt the parcel was not helping to preserve farmland or protect public interest. Neighboring property owners raised legitimate concerns about the environmental impact and following the land use plan.

Later the next evening, the town board saw things differently and voted against the recommendation of the plan commission and approved the rezoning request. They voted to rezone a portion of the property from A-2 to R-1. A portion of the property was already zoned R-1.

Before the plan commission Tuesday, was the approval of a concept plan for Kearns's subdivision.

Scott Weiss opened Tuesday's plan commission meeting and made a presentation to the board speaking about the importance of the Land Use Plan and the following of it when dealing with land use issues. Weiss stated his confusion over why the town board voted against the plan commission's recommendation at the February meeting concerning the Jankowski farm rezoning.

After Weiss's presentation, a

number of town residents spoke again about the proposed subdivision. Temporary chair of the meeting, Gordon Hoffmann, who serves as the township's zoning administrator, kept the meeting on track, only allowing citizens to speak on the agenda items.

Residents re-stated items they brought up at the February meeting such as traffic concerns, and school overcrowding. A few residents were upset at what they thought was town officials not listening to what they want for the township.

Clem Jacak, whose home is adjacent to the proposed subdivision, stated he was concerned about soil erosion and the fact that in his opinion, bridges on both West Bend and Nenno Road need replacement. He also reminded the plan commission that the land use plan called for only 12 homes to be built per year.

Keith Bartelt had an opinion quite different than his neighbors. "I want

to commend the town board on what they did, some farmer could have bought it (the Jankowski farm). I think the town looked at the rights of the Jankowski family. I personally don't want a subdivision by my house, so I bought the (adjacent) land. Allowing the subdivision to go forward is a right they cannot deny," he stated.

After over an hour of discussion on the matter, Don Thoma, of Accurate Surveying, who represented Kearns at the meeting, presented the plan commission with three concept plans to review.

Because it was already late, Town Supervisor Carl Klemme motioned to table making a decision on the plans until the next plan commission meeting that will be held in April.

Ken Schlager of SEWRPC gave a presentation on a Broadband WiFi Wireless telecommunications plan for the town. The township will move forward with investigating a plan. A meeting will be held at a later date to further discuss the benefits to town residents.

Suspected burglar from Legion Clubhouse captured

KEWASKUM- Chief of Police, Richard Knoebel says "good police work" was the reason for the capture of the man they believe is responsible for a break-in at the American Legion Clubhouse and theft of a car in the village that took place very early Monday, March 13, after a Kewaskum Police Officer on routine patrol, noticed a door ajar at the clubhouse located on Fond du Lac Avenue.

The 25-year-old man from Hartford is currently be-

ing held in the Fond du Lac County Jail where he has been charged with obstructing a law enforcement officer and OWI. He also faces charges from Kewaskum Police in Washington County.

While on routine patrol the Kewaskum officer checked a door at the clubhouse and then also found a broken window. Police here believe the man went inside, made himself something to eat and had a few drinks. They suspect, after breaking into the clubhouse, the man took a car from the Engelhardt & Sons truck yard and left the village.

Police were alerted to the

stolen car while investigating the clubhouse break-in, so Washington County Sheriff's Department Deputies took the stolen vehicle complaint. The car was later found being driven southbound on USH 45, south of Waucosta by a Fond du Lac County Sheriff's deputy.

The Deputy stopped the vehicle and the driver then fled on foot. He was later captured and taken into custody. According to Knoebel, the man will later be taken to Washington County Jail and will await charges there from Kewaskum Police.

First large residential development in town history Town will hear proposal from Timblin for 120 acre subdivision

TOWN OF KEWASKUM- For the first time ever the Town of Kewaskum may get the opportunity to keep land poised for large scale residential development in the township. A local developer has his eye on 120 acres in the township and said he hopes to offer large, single family lots on the parcel. The town's planning commission will meet Monday, March 20 at 7 pm to hear plans for the proposed development.

Tom Timblin stated he is

looking at both options, keeping the land in the town, or annexing the parcel located along Old Fond du Lac Road to the village of Kewaskum. No matter where the subdivision goes, his intent is the same, to offer large single-family homes.

He says that the land is too beautiful to make it a "cookie cutter" subdivision. Although he did not give a time frame for the development, Timblin says that soil testing will play a role in which municipality the land is sub-divided.

Timblin is currently working on a condominium community in the Village of Kewaskum called Cherokee Lakes. He stated at this time he has no intention of developing anything but single family homes on the new parcel he is

proposing.

The last subdivision to develop in the town was on Kara Court which is located off Moraine Drive in the most northern section of the town. Before that, a large estate type development took many years to flourish on Shagbark Road off Highway 28.

On Saturday, Tim Vetter reported seeing a robin "sleeping" on the side of Hwy. 28. Not sure if this sighting

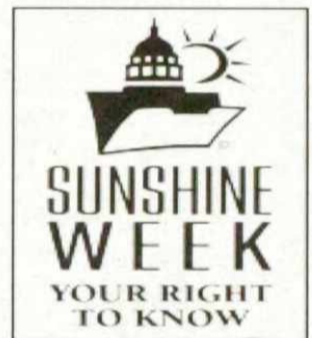
counts either.

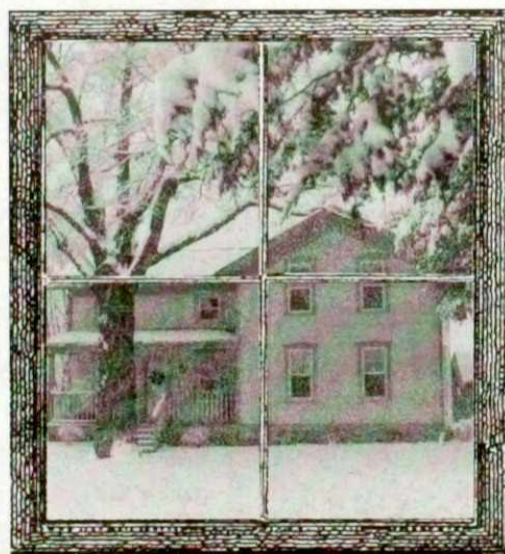

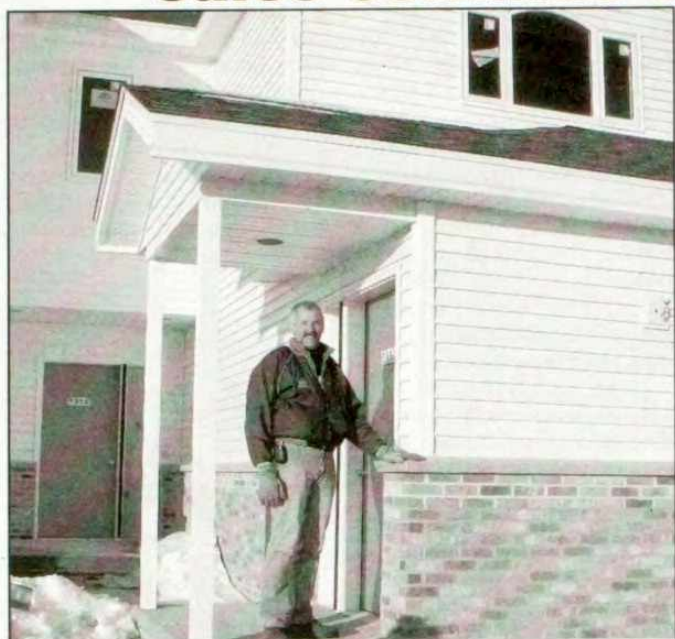

Soaring Eagle Condominiums sales continue to soar

CAMPBELLSPORT- If all continues on schedule, the public will have their first look at a Soaring Eagles Condominium unit in April - just two years from the time the former Huspen farm was proposed for annexation to the Village of Campbellsport.

The just-over-148-acre WLM Development, LLC annexation became Valley View Estates, and is divided into four quadrants, with Soaring Eagles Condominium Association occupying the northwest quadrant. The remaining quadrants are zoned for commercial, duplex, and single family use, with the duplex lots set for development this summer.

Steve Lentz of Lentz Custom Homes, Inc. and LESSCO, Inc (Low Energy System Supply Company) is developing the Soaring Eagles project with the first four-unit building enclosed and interior work continuing.

This past weekend, Lentz, provided a private tour of the first building, and said the condos will be ready for occupancy by June 1.

One lower level condo will be completed for a planned April Open House. He said Mary Jo Greene of Mueller Development will be hosting the open house and marketing the condos. Lentz said, "The others will have drywall and paint, but no trim." He said the completed unit would be ADA (American Disability Act) compliant, complete with a roll-in shower and wider doorways. He said the unit would give prospective buyers an idea of an ADA-compliant unit. The unit will have pine doors and trim, and maple cupboards.

"If someone comes in and says, 'Oh, but I really like oak trim,' we can give them that," Lentz said. He added that with the remaining units unfinished, "That way it leaves the customer with more choices." They cannot only choose wall and carpet colors, they can choose hardwood floors if they wish. Lentz said some choices may add to the final cost, but that, also, is up to the customer. All units have gas fireplaces and individual air conditioning units.

With the remaining three units unfinished, Lentz said prospective buyers could check out the views; select an upper 1700-square-foot unit with cathedral ceilings and three bedrooms, or, a 1450-square-foot unit with two bedrooms. All have a combined mechanical/utility room, and floor plans with kitchens open to dining rooms, allowing for flexibility of use. Condo prices start at \$142,000, he said. All units have attached two-car garages and brick trim, as well as patio doors opening onto upper decks and lower patios.

Lentz said he wanted the condos to be "upscale, not cheap." He said one of the biggest complaints of adjoining living quarters is noise. To avoid this, Lentz said the dividing walls are double, filled with insulation, and dry walled on both sides. The floors of the upper levels have additional soundproofing with a layer of concrete. He said that a bowling ball dropped on the floor of an upper unit wouldn't cause the lower level neighbors to duck for cover, but maybe just notice a slight bumping sound.

"It costs a little more, but I'm doing as much as I can possibly do for sound proofing," Lentz said.

Currently, Lentz is plan-

ning ten four-unit condos and six side-by-side four-unit, two-story townhouses. He said the townhouse plans would be available for viewing at the spring open house. So is a townhouse next in Lentz's building plans?

"Maybe. If the interest is there for townhouses," he said. He will wait to see what generates more interest; condos or townhouses. Then he will proceed depending on the market. The mix of condos and townhouses on the property can also change, depending on the market, he said.

Soaring Eagles owns a total of 48 acres, including marshland that will remain undeveloped green space. Lentz said a private trail would connect with the public Eisenbahn Trail that is taking shape on the eastern edge of the Soaring Eagle development.

The Eisenbahn Trail, along old railroad bed, is part of the Rails to Trails program, and runs from Eden to the south Fond du Lac County line, then into Washington County to West Bend.

Lentz said utilities have been installed in berms that serve as a buffer between the development and Campbellsport Drive, and the berms will be graded, shaped, and landscaped in spring.

A unique aspect of the development will be a tribute to Vietnam veterans. Lentz was near the top of the draft list during the Vietnam War, and said he decided that, instead of waiting to be drafted; he would "join the Navy and see the world." Instead, he ended up in Vietnam as a member of the Army. So the street in Soaring Eagles development is being named Veterans Circle and will feature an area with a flagpole and plaque dedicated to Vietnam veterans.

With reams of paperwork signed and filed, tons of ground graded and moved, and miles of underground utilities installed, the commercial areas and 20 duplex lots will soon be ready for development, followed later by about 150 single-family lots in the southwest quadrant.

Village Lakes Center plans still afloat according to developer

KEWASKUM- United Construction Group spokesperson Rick Kozak says his company still plans to build their commercial park in Kewaskum. Kozak says purchasing the land continues to be under negotiation with developer Gary Gavin.

United Construction is scheduled to appear before the Village Board on April 17 when they will give the board an update on what is happening with the development. Kozak says ironing out the parking problem will be part of his discussion.

Kozak first made plans known about his company's

intentions to build a commercial park in the village's Tax Incremental District in May of 2005. The commercial park being proposed is said to have numerous professional buildings, a hotel, and retail shopping center along with a number of restaurants.

The project has hit a few bumps since the beginning of the year. United Construction Group continues to operate their office out of Kewaskum, but is based in Sacramento, California. More information, along with conceptual drawings for the project, can be seen at www.gokewaskum.com.

New voter registration procedures in effect

Voters who plan to participate in Wisconsin's April 4 non-partisan elections should make sure they are correctly registered, County Clerk Brenda Jaszewski said this week.

"As of the first of January, every voter in Wisconsin has to be registered," Jaszewski said.

Fourteen of the 20 municipalities in Washington County have started to implement voter registration for the first time this year. The six municipalities that had voter registration prior to January 1 are, the Towns of Trenton and Richfield, the Villages of Germantown and Jackon and the cities of Hartford and West Bend. For every other Town and village in Washington County, voter registration is completely new.

"People who have lived in the 14 municipalities where voter registration is new, probably believe they are registered because their name was always on the poll list when they entered their polling place and voted. Those poll lists no longer exist," Jaszewski explained. "Unless they have voluntarily completed a new voter registration form, they are not registered."

"It's still easy to register to vote, and people can register on Election Day," Jaszewski said. "But municipal clerks and poll workers would prefer people register before April 4 so they don't have to wait in line to vote."

When registering on election day, the voter needs to bring proof of residence. To complete the registration process, a voter needs to provide a Wisconsin driver's license or state ID number, as well as personal information such as a name, address and date of birth. If a voter has never been issued a Wisconsin driver's license or state ID card, they are allowed to use the last four digits of their Social Security number.

The driver's license, state ID, or last four digits of the Social Security number are used to identify voters specifically in the new Statewide Voter Registration System so that one resident is not mixed up with another, helping to prevent voter fraud.

Voters who wish to register by mail must send a photocopy of their Wisconsin driver's license or state ID card to their municipal clerk's office. Once registered, voters will have a permanent voter registration number in the Statewide Voter Registration System, and will only be required to fill out a new form when they move to a new address.

"If you are not registered and have been issued a Wis-

consin driver's license or state ID card and do not provide that number, you will not be able to vote. I would strongly urge everyone to bring their driver's license or state ID card with them on April 4, even if they believe they may already be registered," Jaszewski said.

To find if you are currently registered, you need to contact your Municipal Clerk's office.

Kohl. She also will receive a \$1,000 stipend for both herself and KES.

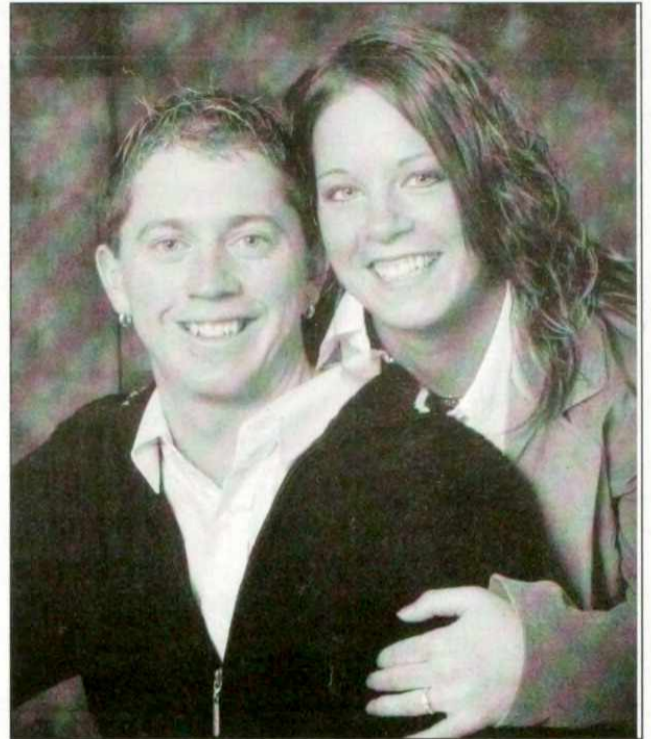
Kasten says she will use a portion of her funds to add flowers and a wrought iron fence to the Zarling Bell Tower located at KES.

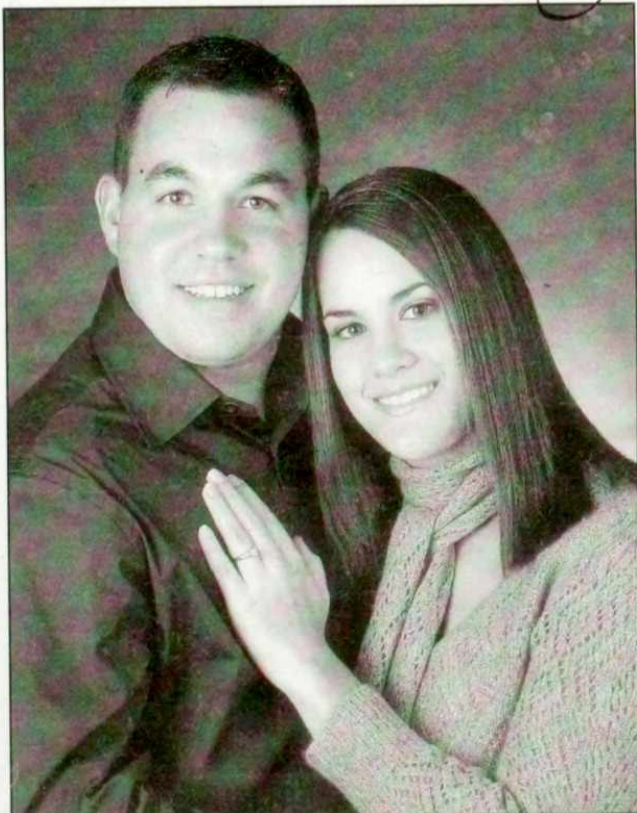

Pushing Back Against Big Brother

In 1958, at the height of the Cold War, I was stationed at the Second Marine Division as a Communications Watch Officer with top secret clearance. That meant I regularly locked myself in a crypto vault and broke coded messages from around the world. The Lebanese incursion was underway, a Marine expedition, and so there was heavy encrypted radio traffic flowing into division headquarters.

What I encountered was instructive. Much of the material traveling under high classification was, for the most part, information I could obtain from reading the newspapers. That did not mean big secrets were being made public. It meant that innocuous information was being classified for unfathomable reasons.

Twenty years later, I was Assistant Secretary of State and State Department spokesman in the Carter administration. In that job I regularly received and reviewed a large stream of highly classified material. I was also responsible for the department's Freedom of Information activities.

Again, much of what I saw behind closed doors was a puzzlement. Some of it was potentially embarrassing to the administration, much of it was boilerplate and only bits and pieces were of enough significance to be kept under classified lock and key.

With that as background, plus a couple of decades as a reporter covering foreign policy issues at home and abroad I have come to a firm conclusion: The vast majority of all classified material could be released to the public without harming national security one iota.

And that is where Sunshine Week comes in. It means to push back against the coordinated campaign to wall off the American people from the information they need to function effectively as citizens. It builds on some of the oldest propositions in this democratic republic.

Of course, the thought-controller's arguments are even older, dating back to the divine right of kings. They are "Father knows best" gone amuck.

We're classifying tens of millions of documents to protect you—to guard national security—says Washington.

We're closing police records to guarantee a fair trial or preserve privacy interests, says City Hall.

We need closed-door

meetings so to ensure frank exchanges and uninhibited debate, they say just about everywhere

And when all else fails, the debate-ending clincher in Washington always comes back to "national security." When that is invoked, we're supposed to shut up, salute and go back to watching American Idol.

We shouldn't, despite the fact that there is a core of truth beneath what is otherwise a vast load of self-serving manure. There are secrets whose exposure would damage national security. They must be safeguarded. That much is true.

But the burden of proof in this society is on government. It is contemptible to hide behind national security to justify covering up failed policies and faked evidence. Telling the world when and where we intend to strike at an enemy force would obviously be a despicable act. Refusing to give Americans an honest accounting on the continued inability to provide enough armor-plating for our troop carriers is also despicable.

"Trust me" won't do. Ronald Reagan went to the heart of the matter two decades ago. "Trust, but verify," he memorably said. He was talking about dealing with the Soviet Union, but those should be the watchwords for free men and women everywhere when dealing with government.

Unfortunately, the climate in Washington—and in too many state capitals and county seats—is hostile to what the brave Russian reformers of the 1980s called "glasnost," openness. Citing the necessities of war—a war undeclared by Congress and made open-ended by presidential declaration—federal agencies are classifying information at record rates. They are also simultaneously subverting the nation's hard-won Freedom of Information law, making it increasingly difficult to extract information from the packed warehouses where the federal bureaucracy hides the record of its activities behind locked doors.

Luckily, Americans have never been fond of Big Brother. When we stop to think about it, we can sort out the legitimate demands of national security from the limitless claims of big government.

The people should not have to prove a right to access. Our Revolution and our Constitution long ago settled

that official information does not belong to the king—to the state. It belongs to the people, who are sovereign.

Democracy sickens without accountability. Accountability is impossible without the free flow of news and information, a point we make repeatedly when lecturing repressive regimes abroad. Sunshine Week is the time to say it here at home, loud, clear and all together.

I see that the Kewaskum School Board has posted a closed session dealing with Administrative salaries. Why now, since this is normally done at the June meeting after the NEW Board is seated? Last June, the Administrative Team, received raises. After an agreement was reached with the Teachers Union and a change in the insurance plan was made, there was a savings of about \$7,000 dollars. Where did that savings go? To benefit the students? NO. That money was divided up among the Administrative Team and each received an additional \$540 plus, added onto their salaries. This money could have and should have gone for things the students need.

I was the ONLY Board member that voted NO at the December meeting, for what I felt was an additional raise. It is time to control the constant increase in salaries and start using any savings to benefit the students. This money could have gone towards books, technology or other items that are needed.

Another cost savings could be realized by making the Administrative Team pay an additional 5% towards their health insurance. They currently pay about \$850 per year

(5%) for the family plan. How many of YOU pay that small amount and have what I call a "Cadillac" plan. Perhaps it is time for YOU, the residents to call and find out how much each of the Administrative Team makes in salaries and fringe benefits. Then demand that the Board take proper action to hold down the cost. If they get what the teachers got, 4.2%, the increase will be \$2,000 minimum, while some will exceed \$3,000. Did ALL of you see raises that high this past year?





ORDINANCE NO. 2006-03

AN ORDINANCE TO ANNEXING TERRITORY TO THE VILLAGE OF KEWASKUM, WISCONSIN

The Village Board of the Village of Kewaskum, Wisconsin, do ordain as follows:

SECTION 1. Pursuant to the provision of Section 66.0217(2), of the Wisconsin Statutes, and the petition for annexation filed with the Village Clerk on the 19th day of January 2006, the following parcels of land, lying adjacent to the Village of Kewaskum, is hereby detached from the Town of Kewaskum, Washington County, and attached to the Village of Kewaskum described as follows:

Being a part of the Southeast 1/4 of the Southeast 1/4 of Section 9, Township 12 North, Range 19 East, Township of Kewaskum, Washington County, Wisconsin, which is bounded and described as follows:

Commencing at the southeast corner of said Section 9; thence South 88°35'00" West, along the south line of said SE 1/4, 645.00 feet to a point in the centerline of Fond du Lac Avenue (USH "45") (Project F027-1(14)); thence North 32°35'00" West, along said centerline, 35.02 feet to the point of beginning of lands herein described; thence continuing North 32°35'00" West along said centerline, 18.38 feet; thence continuing along said centerline, North 30°31'00" West, 386.18 feet; thence North 66°23'00" East, 222.75 feet; thence South 30°31'00" East, 180.00 feet; thence North 66°23'00" East, 52.48 feet; thence South 29°55'00" East, 341.22 feet to a point 30.00 feet North of said south line of said SE 1/4; thence South 88°35'00" West, parallel with said south line, 307.86 feet to the point of beginning.

SECTION 4. Temporary Zoning Classification. (a) Upon recommendation of the plan commission, the territory annexed to the Village of Kewaskum by this ordinance is temporarily zoned as follows, pursuant to sec. 66.0217(a) of the Wisconsin Statutes:

B-2 Community Business District zoning.

(b) The Plan Commission on January 31, 2006 recommended the permanent zoning classification of B-2 Community Business District.

SECTION 5. Ward Designation. (a) The territory described in section 1 of this ordinance that is located in Section 9 is hereby made a part of the 4th Ward of the Village of Kewaskum and is subject to the ordinances, rules and regulations of the Village governing wards.

(b) Be it further noted as per the petition submitted by Kewaskum Green and Gold, LLC indicated the population of the noted area in the 4th Ward is (0) zero and the number of electors is (0) zero.

SECTION 5. Severability. If any provision of this ordinance is invalid or unconstitutional, or if the application of this ordinance to any person or circumstance is invalid or unconstitutional, such invalidity or unconstitutionality shall not affect the other provisions or applications of this ordinance which can be given effect without the invalid or unconstitutional provision or application.

SECTION 6. Effective Date. This ordinance shall take effect upon passage the 6th day of March 2006 and publication as provided by law.

NOTICE TO ALL WASHINGTON COUNTY DOG OWNERS

Pursuant to Section 174.052, Wisconsin Statutes, notice is hereby given to all owners of dogs in Washington County that dog licenses and rabies vaccinations are required.

Vaccination by a licensed veterinarian against rabies is required of all dogs (Section 95.21(2)) within 30 days after the dog reaches 4 months of age and revaccinated within one year after the initial vaccination. The owner of a dog shall have the dog revaccinated against rabies by a veterinarian when the certificate expires or within three (3) years of previous vaccination. The certificate of rabies vaccination must be presented to the collecting official before a dog license may be issued.

All dogs five (5) months of age or older require a license. The minimum license fee for neutered males or spayed females is \$3.00, upon presentation of evidence attesting to the same, and \$8.00 for the unneutered male or unspayed female dog or one-half of these amounts if the dog became five (5) months of age after July 1, of the license year. The governing body of any town, village, or city may raise the minimum dog license tax. Any person who keeps multiple dogs or operates a kennel may apply for a multiple dog license. The fee is \$35.00 for twelve (12) dogs or less and additional \$3.00 for each dog in excess of twelve (12).

Dog licenses may be obtained from your local town, village or city treasurer or designee during the course of any given year. Dog owners should notify their treasurer if their dog is given away or has died, so that you will not be considered delinquent. An affidavit of death is available.

PENALTY

Every owner of a dog 5 months of age or older who fails to obtain a license by April 1, will be assessed a late fee of \$5.00.

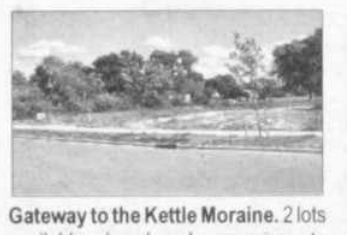

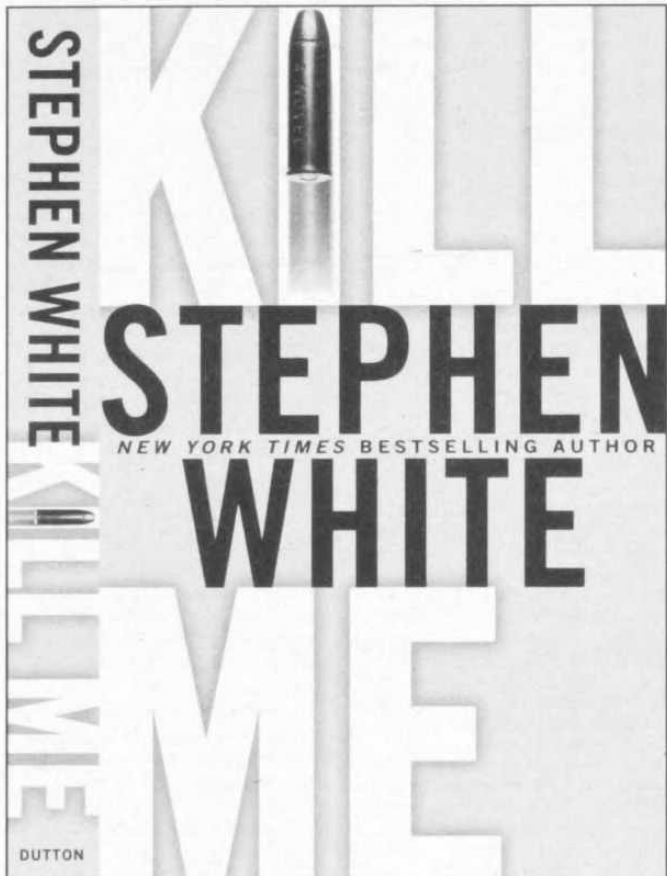

Kill Me
By Stephen White
Dutton \$25.95 352 pages



They say that nothing is "for sure" except death and taxes.

"They" are close, but not quite right on that statement. If you're dead, you're not paying any taxes at all.

So what if you could choose the time of your death? And what if - once you've made that choice - you can never change your mind? In the new novel, "Kill Me" by Stephen White, a wealthy Colorado entrepreneur makes a brash decision that haunts him for the rest of his life.

Dr. Alan Gregory has a new patient in his office. The man is obviously very rich, and he makes some unusual demands. Counseling sessions are on the patient's terms and he wants two appointments, both always the same day. It seems that the man has a lot on his mind and he needs someone to bear witness.

The patient always loved risk. He's surfed Big Waves. He skied back trails and mountains that few men would tackle.

On the day that he was heli-skiing with friends in the Bugaboos, he was standing on a shelf of snow, pondering his next move when the snow gave way and he tumbled down the mountain. Hurt and out of breath, he picked himself up on the bottom of the hill. Shaken but alive, he made his friends vow that if he was ever incapacitated, that they would end his life for him.

He was thinking of his brother, Conrad, who lived in New Haven, Connecticut, and who had ALS.

He was thinking of his friend, Antonio, who'd been in an underwater cave without

oxygen and was now lying in a hospital bed.

When the entrepreneur's skiing-buddy, Jimmy Lee, heard the vow, he mentioned a secret group who could help the entrepreneur if the worst ever happened. Jimmy Lee knew who to call, but the matter could never be spoken aloud again.

When contacted, the group - a business, really - made one offer. For a million dollars, they would monitor the entrepreneur's life. The moment his health crossed a pre-determined line, they would step in and end it for him. It would look accidental or natural, and his family need never know.

He paid the money. He agreed to the terms.

He didn't know then about a son who was conceived one drunken night, fourteen years ago.

He never thought he'd have a dangerous aneurysm at age thirty-something.

And now someone wants to kill Dr. Gregory's patient.

No, someone has to kill him.

It's been a long time since I've been as captured by a book as I was with "Kill Me". Author Stephen White takes you for a thrilling ride in speeding cars, on cross-country flights, up high mountains and deep into cities. The narrator of the story - we're never told his name - is a likeable guy; sarcastic and witty but scared witless by what he's done and what is to come.

If you love a good story, one that is entirely, chillingly possible, then be sure to look for this book. "Kill Me" will thrill you to death.

Donath, Lady Titans are outstanding again

According to the dictionary, a Titan is a powerful or impressive person.

The UW-Oshkosh Lady Titans were every bit that on Friday and Saturday at the NCAA 3 Indoor Track and Field Championships held at the Tostrud Center on the campus of St. Olaf College in Northfield, Minn. They were powerful and impressive in piling up 44 points and bringing home the championship for the third year in a row.

Once again, one of the cogs in the UW-Oshkosh machine was freshman Amanda Donath, a star for the past four years on the Kewaskum High Track team.

UW-Oshkosh finished six points ahead of Williams College (38) in the battle for the team title, with City College of New York next at 27, and Keen State College and Illinois Wesleyan tied for fourth with 26 points. UW-LaCrosse finished seventh with 22 points.

Donath helped the 4x400-meter relay team to a fifth place on Saturday evening. Earlier in the day, Donath placed seventh in the open 400. Even though she placed in two events, the freshman standout was not totally satisfied.

"I didn't run quite my best race," Donath said, but, "I'm All-American in both of them."

The Lady Titan relay was clocked in 3 minutes, 55 and .13 (3:55.13) for the fifth place.

The winning team was Lincoln University, which posted the best indoor mark by an NCAA 3 team this season. It was also a Tostrud Center record. The old record of 3:55.97 was set by a quartet from UW-LaCrosse last year.

Donath led off the relay, then came Stephanie Sisk, Sarah Schettle, and Nadine Pieske. The top six finishers eclipsed the old record in the finals.

Donath had to run a preliminary 400 on Friday evening. Her time of 57.78 was good enough to get her in the

finals, which was run in two timed heats. In the finals, her time of 58.42 was slightly higher but good enough for seventh place.

"It was a very nice facility," Donath said about the Tostrud Center, a six-lane track. Because it was a national event, and because "our times are so close we might run over each other," only four lanes were used for the races, according to Donath, who said she made a little mistake in the 400 finals when she didn't start fast enough. "I should have probably gone out faster and passed some people on the back stretch."

Rachel Anderson, a sophomore from Illinois Wesleyan, won the race with a quick 56.35. The defending champion, Bridget Burns of Wartburg, placed sixth after covering the distance in 57.93.

There were only two freshmen, Donath and one other runner, in the finals of the 400, which is usually considered the toughest race in track.

Last week, UW-Oshkosh captured the Wisconsin Intercollegiate Athletic Conference (WIAC) women's title in a meet held on the UW-Stevens Point

campus. Donath won the 400 title in that meet.

"This was the end of the indoor season. We have a week off for spring break, and then we start practice for the outdoor season. Our first meet is April 1," Donath said, indicating she will get a chance to see the Kewaskum High girls when they come to the annual indoor invitational held in the Kolf Field House on the UW-Oshkosh campus March 28th. "We all work at that one," she said.

When asked if she will concentrate on the 200, 400 and 4x400 relay in the outdoor season, Donath said, "I might do some other stuff," indicating the long jump, 400 hurdles and the open 800 are possibilities.

The coach for the hurdles and 400 is former Campbellsport High track and wrestling standout, Derek Toshner, who also competed at UW-LaCrosse. Donath said he also competed in the Olympic Trials two years ago.

While she had aimed for top-four finishes, Donath was philosophical about taking a fifth and a seventh. "I guess this leaves me a little hungry for the outdoor season," she said.

Kewaskum junior, Matt Parrent, secures spot on 2nd team

Champion Jets claim four spots on all-EWC units

The numbers were certainly in their favor, both collectively and individually.

The Roncalli basketball players combined forces toward a perfect 14-0 season, producing a second straight title in the Eastern Wisconsin Conference, and when the coaches gathered recently to pick all-conference players, the Jets' numbers were impressive enough so two of them were selected to the first team and two more to the second team.

Greg Schrimpf, the EWC's leading scorer with a 20.7 point per game (ppg) average, was a unanimous choice, and he was named as the 2005-'06 Player of the Year.

Schrimpf stands 6-feet-2 and plays the wing for the Jets, who scored a total of 906 points in the 14 league games, 43 points more than Campbellsport.

Defensively, the Jets, who opened play in the Division 3 State Basketball Tournament this morning (Thursday), allowed just 608 points, and the next closest total given up was 699 by Sheboygan Falls.

Joining Schrimpf on the first unit was teammate Alex Ahola, No. 11 in scoring with an 11.4 ppg average and the top 3-point shooter in the conference.

The other three on the first

team were Jon Iserloth, a 6-3 wing from Plymouth, Nick Whitty, a 6-0 senior from Campbellsport and Jon Coogle, a 6-2 guard from Two Rivers. Coogle averaged 17.9 points a game, second in the league, while Whitty averaged 16.9 (3rd) and Iserloth scored 14.9 per game (4th overall).

Iserloth, Whitty and Ahola are seniors, while Schrimpf and Coogle still have one more year to play in the EWC, which should send shivers down the spines of the other league coaches. Both are sharpshooters from three-point land and are capable of 30-point games.

Kewaskum, which finished the season with a disappointing 3-11 mark and tied with New Holstein for seventh place, had just one player honored — junior Matt Parrent.

After making the first team a year ago, Parrent, a 6-4 post player, was elected to the second unit, which was a bit of a surprise to Kewaskum coach Glenn Eichstedt.

"I went into it (the meeting) thinking he would be first team," Eichstedt said Sunday before his players and parents gathered for a season-ending banquet and award ceremony. "Certainly he was a known player, but, maybe the coaches thought others improved more significantly."

Parrent had good enough statistics to be among the top five

players. "Matt led the conference in rebounding, as far as I know," Eichstedt said, adding, "He was eighth in scoring."

Parrent hauled down 122 rebounds in the 14 conference games, which figures to a just under 9 per game. He scored 267 points points, a 14.1 ppg average, all that despite receiving a lot of defensive attention from opponents.

"Matt always plays hard and aggressively. For the most part, that has served us well," Eichstedt said, going on that this year teams started to double and even tripleteam him. So what the team needed him to do was to look for help from other Indians. "That also means you have to have someone scoring consistently from the perimeter."

"He always plays hard, and he always gives it his best shot," the coach said about Parrent, who was joined on the second unit were: Ben Miller, Kiel, 6-4 junior; Chris Netzel, Roncalli, 6-2, senior; Cameron Salter, Campbellsport, 6-1 senior; and Eric Pozorski, 6-2 senior.

KHS grad, Amy Piwoni, will coach KHS JV's

Berst appears a perfect choice for soccer job

Apparently the higher-ups at Kewaskum High School are impressed with the work John Berst has done with the boys soccer team, so much so they have chosen him as the new coach of the girls program.

Announcement of his selection was made recently, and now Berst, who has been the co-head coach for the boys for two seasons, is eager to get started. He sponsored a "meet the coach" night last week and practice opened on Monday in preparation for the season-opener which is set for March 30th at Lomira.

When asked if he was excited to be the girls coach, Berst quickly responded, "Yes, I am. I am looking forward to it (the season)."

Among his first tasks will be erasing memories of past losing seasons, teaching good fundamentals and building the program from the ground floor.

"I hope we can do some

good things and build a successful program," Berst said, indicating he told the players and parents, "Win, lose or draw, we're going to be positive. My goal from Game 1 to Game 22 is we're going to play better soccer ... We're going to have fun."

Berst, who coached the boys program at Living Word High School in Jackson for two years, said the meeting drew 34 players.

"We had a good turnout. We've probably got 22 to 25 who have played before," he said, indicating senior Danielle Yanke is one of the top talents on the team and is looking to end her career successfully after suffering a knee injury last spring and missing a good portion of the season.

Berst, who is director of quality at the Matenaer Corporation in West Bend, said his philosophy will be "putting some of the best players across the middle and straight up" to build a strong defense, and then look for the athletic players to create opportunities to score.

Berst was excited to an-

nounce the team will have a JV coach who has playing experience. Amy Piwoni, a KHS graduate who now works for West Bend Mutual Insurance in West Bend, played some soccer in high school and also at Marian College in Fond du Lac.

"She (Piwoni) will work with the goal keepers and such," Berst said.

"Historically, Kewaskum has had some short-term coaches. This doesn't build any continuity," Berst said, promising he will be around for four or five years at the least.

Berst also promised to move toward building continuity between the boys and girls programs and would like to see the girls get involved in club soccer and indoor programs to hone their skills and learn the finer details of the game.

After the Lady Indians play the non-conference game at Lomira, they challenge Howards Grove on March 31st, then host Sheboygan Falls in their home opener and Eastern Wisconsin Conference opener on April 4.

Eichstedt resigns after wins continue to escape hoops team

After three very frustrating seasons that netted just six victories, Glenn Eichstedt has decided to step down as head coach of the Kewaskum High boys basketball team.

Eichstedt made the announcement Sunday evening when the players and parents gathered for the annual banquet and awards program.

"There are a lot of factors involved," Eichstedt said Monday evening, but the major one in his mind was, "I haven't been able to turn the program around." Because of that, and because some of the same players are returning next year, he said he felt, "Maybe they can benefit from some new direction, new enthusiasm to help get (the program) over the hump."

Eichstedt said he started the year anticipating about a .500 season, and, "Looking at our scores, that was doable." Unfortunately, the Indians lost six games by six points or less and in countless other games, one poor quarter seemed to hamper the overall effort.

Eichstedt, who has coached boys or girls basketball for a total of 28 years, said many times it was a case of putting in good efforts, but, "We did not execute as we needed to, and we're not as fundamentally sound (as we need to be)."

Eichstedt said there were many people he wished to thank, starting with the parents who "have been extremely supportive. We haven't had any questioning or criticism," he said.

"Then there were the players themselves," he went on, praising their hard work and determined efforts, despite the pressure of mounting losses.

He especially wished the best to juniors Matt Parrent and Casey Scheel, who have worked very hard to bring the program back to respectability. "Matt is already the fifth leading scorer and by next Christmas, will be the school's leading scorer," Eichstedt said,

reporting Parrent already has 791 points, just 82 behind the record set by Travis Kempf. "He'll, by far, being the (school's) leading rebounder."

Also praised were his assistants, those in the past, and the men who worked in the program this year, including Bobbie Bannasch, Mike Hendricks, Dennis Gutbrod, and especially Tom Theusch, who was paid as freshman coach for one year and since then has been a volunteer.

"He (Theusch) was a tremendous support for me," Eichstedt said about his varsity assistant, who was also a teammate at KHS.

"I think I owe the biggest debut of gratitude to my wife (Jackie)," Eichstedt went on, noting she was the one who urged him to take the job after the former coach was let go by the school. "She has been solidly backing the KHS basketball program for a long time."

Eichstedt put in countless hours directing practices, scouting, working on game plans, as well as directing youth programs.

"The average day is 14 to 15 hours. We had 21 games. I easily scouted each team two to three times," he said, but still the desired results were not attained, and Eichstedt said, "Being from Kewaskum, it's kind of hard to admit Kewaskum is not a basketball town."

Kewaskum has had two seasons of exactly .500 records in the last 20 years, according to Eichstedt, who said a lack of continuity in the coaching staffs has affected the program.

Also, even with the development of youth programs, "In the big picture, we're not getting more players out ... we're not getting more skilled players, and we're not getting more knowledgeable players," Eichstedt said, stressing he did not want to blame anyone specifically for this but it stating a fact.

When asked about a possible successor, Eichstedt said he feels Bannasch, who coached the JVs this year, would be a good candidate, but if he isn't interested, it might be best to go outside the district to get a new coach.

"There will be some players to build on," Eichstedt said, which was better than when he took over and inherited no seniors and one junior his first year when the team went 0-21, basically playing with sophomores and freshmen. Last year, the team was 2-19 and this year, 4-17 with the team finishing in a tie for seventh place in the Eastern Wisconsin Conference.

Eichstedt will continue as the school's golf coach.
