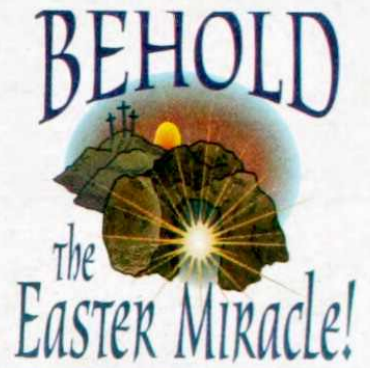

First completed development in Kewaskum's Tax Incremental District

## 53,000 square foot expansion complete at DACO Tool & Design

**Kewaskum-** A 55,000 square foot expansion to DACO Tool and Design LLC has been completed to their building located along USH 45 in Kewaskum. In addition to the expansion, the relocation of DACO Precision, Inc. from West Bend has also been completed. The newly expanded property is part of the Village of Kewaskum's Tax Incremental Finance District.

DACO Precision, Inc., the parent company, of DACO Tool and Design LLC, is a manufacturer of custom metal stampings, special washers, and tool & die services. Daco Precision, Inc has been in business since 1984.

Randy Weber and Lloyd Kanzenbach, CEO's and founders of DACO Precision, have worked together for over 22 years, generating the majority of their sales with distributors and some OEM customers covering a variety of different fields including lawn and garden, computer, railroad, small engine, outboard engine, heavy equipment, truck, trailer, recreational, aircraft, automotive and additional areas.

The company designs and builds all needed tooling in-house and produces a large variety of metal stampings, washers, brackets, shims, fasteners, spacers, handles, machinery bushings and other custom made stampings from start to finish, including secondary bending, forming, tapping, machining, assembly work and packaging.

In April of 2004 they purchased the land, building and most of the equipment assets of Quad Tool & Design Company. DACO Tool and Design, LLC was formed as a subsidiary of DACO Precision, Inc. They focus on aluminum die cast, plastic injection molds, and machining services.

The two partners were very interested in adding to their tooling sales and looked forward to designing and building high quality aluminum die cast and plastic injection mold tooling as well as stamping dies for new and existing customers.

Weber said that they hired some of the highly skilled design and tool & die journeymen that worked for Quad and added a qualified operations manager. With highly skilled people, state of the art design software and late model CNC equipment, the company's sales expanded immediately from new and existing customers that require high quality design and tooling.

Operations Manager, Mike Ca-

hoon said that they design, build and service high quality tools that can't be matched by companies in China or elsewhere and turn them around in a fraction of the time.

In April 2005, Weber and Kanzenbach broke ground on a 53,000 square foot addition to the Kewaskum facility. The partners said that this new facility will give both companies the needed space they desire to expand and grow and should help increase overall efficiency.

Kanzenbach stated that (LEAN) process-flow; automation and labor reduction ideas have been their primary focus for this new plant.

Weber explained that both companies really compliment each other and he is excited that he is now able

to have all of his office, design people, tool makers and production people all working together on cost saving ideas and value added services for their customers at one newly expanded location.

Gov. Jim Doyle has proclaimed April 17-21, 2006 as Tornado and Severe Weather Awareness Week in Wisconsin. This awareness campaign is launched every year in April to remind people of the dangers associated with tornadoes, thunderstorms, flooding and hail and to encourage citizens to take protective safety measures.

Washington County Emergency Management, along with Wisconsin Emergency Management (WEM) and the National Weather Service (NWS), are once again promoting Wisconsin's Tornado and Severe Weather Awareness Week. WEM is sending out press packets to all state media containing background information. In addition, the Wisconsin Department of Public Instruction is sending all state schools tornado and severe weather information and safety tips. Washington County will participate in the statewide tornado drill. The drill tests the notification procedures that take place during a severe weather event. Various types of watches/warnings are issued by the NWS and disseminated to local dispatch centers. From there the dispatch centers pass along the information to local public safety agencies and key personnel. These are the same watches/warnings available to the public through the media or over the NOAA weather radio system.

Weather warning sirens in Washington County are owned and operated locally by the various cities, villages and townships. Due to this fact, the sirens in your area may or may not sound on April 20th depending on participation by the local jurisdiction in the drill, or the fact that a particular system may choose not to deviate from its normal testing schedule.

All residents of Washington County are encouraged to become familiar with the designated shelter areas and weather procedures needed to be safe if you are at home, school, work, shopping or on the road. Additional information can be obtained from your local or state Emergency Management Agency, the National Weather Service or your local chapter of the American Red Cross.

#### What To Do Before Severe Weather Strikes

- Before the Storm:**
- Develop a plan for you and your family for home, work, school and outdoors.
  - Have frequent drills.
  - Know the county/township in which you live, and keep a highway map nearby to follow storm movement from weather bulletins.
  - Have a NOAA Weather Radio with a warning alarm tone and battery back-up to receive warnings.
  - Listen to local radio and television stations for further information.

#### A Disaster Supplies Kit Should Include:

- A 3-day supply of water (one gallon per person per day) and food that won't spoil.
- One change of clothing and footwear per person.
- Blanket or sleeping bag per person.
- A first-aid kit, including prescription medicines.
- Emergency tools, including a battery-powered NOAA Weather Radio and a portable radio, flashlight, and plenty of extra batteries.
- An extra set of car keys and a credit card or cash.
- Special items for infant, elderly, or disabled family members.

## St. Joseph's offers breast MRI to aid in cancer detection

WEST BEND - SynergyHealth St. Joseph's Hospital is now offering the latest technology in breast cancer detection with the addition of breast magnetic resonance imaging (breast MRI). The extremely sensitive breast MRI system offers detailed 3-D imaging for the earliest possible diagnosis of breast cancer.

This new technology provides life saving benefits for women who are at high risk for breast cancer and women who have received inconclusive mammogram results. MRIs, which use magnetic fields and pulsing radio signals to produce images of internal structures, have proven particularly advantageous in pinpointing breast cancer in individuals whose breast tissue is especially dense. The double-breast MRI allows effective and convenient imaging of both breasts simultaneously.

Breast MRI images are read by board-certified radiologists who are specially trained to read breast MRIs. St. Joseph's Hospital uses a state-of-the-art digital imaging workstation and computer

assisted diagnostics to analyze the 3-D MRI images. Breast MRI is used in conjunction with other breast imaging diagnostics. Patients should consult their gynecologist or primary care physician about the potential use of breast MRI.

St. Joseph's Hospital opened August 7, 2005. The new 180,000-square-foot hospital has 80 private patient rooms including 12 large LDRP rooms in the New Life Center, a 24-7 emergency care center with 13 private rooms and 4 cardiac/trauma rooms, four surgical suites, and state-of-the-art diagnostic imaging equipment and information technology throughout.

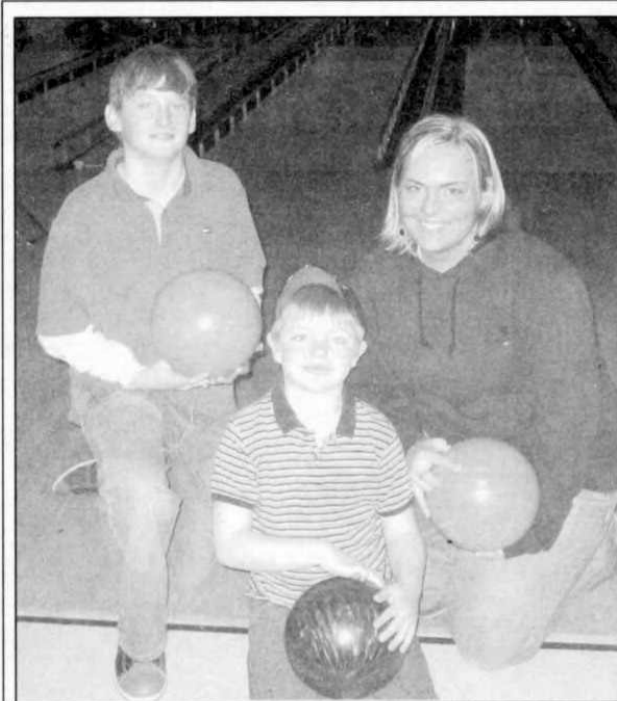

**TOWN OF FARMINGTON-** Wisconsin's traditional spring fire season is underway and local firefighters have been battling numerous wildfires in many parts of the Statesman's reader area. Boltonville Fire Department responded to a grass fire on Tuesday, April 11 along State Highway 28, west of Paradise Drive in the Town of Farmington.

Fire Chief Joe Enright stated he suspected a driver threw a cigarette out of the window of a car into the field. An area about 500' x 500' burned in Tuesday's fire. Quick action by the fire department helped prevent the fire from spreading.

A passerby spotted it and called the Sheriff's Department. The owner of the property is Richard Finch.

Fire specialists with the

Department of Natural Resources claim that wildfires not only burn natural resources, but they have the ability to put property, and possibly lives, at risk.

It's because of the warmer weather and high winds Wisconsin experiences in late March and early April that cause sometimes small controlled burns to get out of hand.

"The first step in preventing wildfires throughout Wisconsin is to avoid burning during this time of year," says John Lubbers, DNR Forestry Staff Supervisor. "Knowing your local open burning laws and regulations is another important step people can take to be more fire conscious." Contact your local DNR Office, Emergency Fire Warden, or local officials to determine what your local burning regulations are and whether you need to obtain a burning permit.

## Park land is topic at Town of Wayne annual meeting

**TOWN OF WAYNE-** Routine business was carried out at the 2005 Town of Wayne annual meeting Tuesday, April 11. Two topics getting the most attention were the town purchasing park land and the town's official newspaper. Around 20 residents attended the meeting.

The meeting started off when town resident Scott Weiss asked about the procedure used by town employees in filling time sheets. Town clerk Chris Kuehn stated employees use a time clock. Weiss asked if employees could keep track of the projects they complete by writing what was done on their time sheets. The new procedure will go into effect.

A number of town residents asked the supervisors to change the town's official newspaper back to The Statesman as many were unsatisfied with The Daily News. The town clerk stated he was very pleased with The Daily News and wished to keep the publication as their official newspaper. Kuehn stated that they favored The Daily News because it is a daily newspaper and it gives him flexibility when placing legal notices. Town residents made a motion to change the official paper back to The Statesman but Town Attorney Gerald Kiefer advised even with the motion, the decision ultimately lies in the hands of the town board.

Town Chairman Leander Herriges revealed that \$92,000 is in the town's park fund. Herriges estimated that by end of the year the balance could be as high as \$130,000. At the present time, the town owns one to two acres of park land in Kohlsville at the corner of Mill and Main Street.

Herriges pointed out the town has been advised to buy between 20-25 acres when considering a park land purchase. He made the residents aware that matching grants are available from the DNR and other sources to help finance any land purchase. All but one of the town residents in attendance showed support for a land purchase.

Residents who are interested in serving on a parks committee to further investigate land purchases and to assist in grant writing should contact Herriges at 626-2896.

Road projects for 2006 will include Wilson Road, Commercial Lane, Lake Bernice Drive, and Brookhaven being wedged and sealed this summer. The town will continue to work on improving Townline Road to Badger Road. Because the roadway runs through wetlands, the town needs DNR permits. An engineer is working for the town and trying to move the project forward.

Salaries for the town officials were discussed. Residents thought they should stay the same. Kuehn advised he will investigate what other townships pay and bring information back at the budget hearing in October. Currently Chairman Herriges receives \$8,000, Treasurer Gerald Schultz receives \$8,500, Clerk Kuehn receives \$13,000 and each supervisor receives \$5,500. They each also receive a \$40 per diem.

## Wine recorking bill signed into law

**MADISON-** State Representative Don Pridemore (R-Hartford) joined Governor Doyle Wednesday, April 5 as the Governor signed AB 619, the "Wine Re-corking Bill" into law.

The law would now allow adults who purchase a bottle of wine at their favorite res-

taurant to take the bottle with them if they chose not to finish the bottle there. The bottle of wine would be recorked and a receipt taped to the bottle. The consumer would then place the bottle in their trunk or storage compartment of their vehicle to be taken home. The

wine must be taken out of the restaurant before midnight.

"The law simply applies a little common sense to the statutes in regards to buying wine at a restaurant." Said Pridemore. "Instead of feeling pressured to finish the wine at the restaurant, diners can elect to take the wine home."

"Although this law won't cut state taxes, it is a first step towards treating responsible adults like responsible adults. As Wisconsin moves closer to becoming a nanny state, passing this law will help move Wisconsin in the right direction." Pridemore Said.

## Absolute sobriety law strengthened

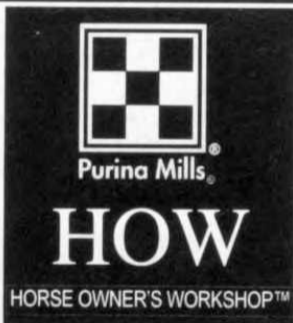
**MADISON-** A bill introduced by Representative Mark Gundrum (R-New Berlin) to update Wisconsin's statutes on absolute sobriety has been signed into law.

Under prior law, a person under the legal drinking age could not operate a motor vehicle with an alcohol concentration above 0.0.

Through his work as a local municipal prosecutor, Gundrum was surprised to learn how insignificant the penalty was for a violation. The previous forfeiture for having a blood alcohol level above .00 but below .08 while operating a motor vehicle, for someone under 21 was only \$10.

In addition, if a licensed driver under 21 with a prohibited alcohol concentration decided to drive with a minor under the age of 16 in the vehicle, the law considered this so irresponsible that the fee doubled to \$20, with no demerit points, but a brief suspension of their license could be ordered.

This new law will increase the forfeiture for persons under 21 driving after consuming alcohol to \$200 or \$400 if a person under 16 years of age is in the vehicle.

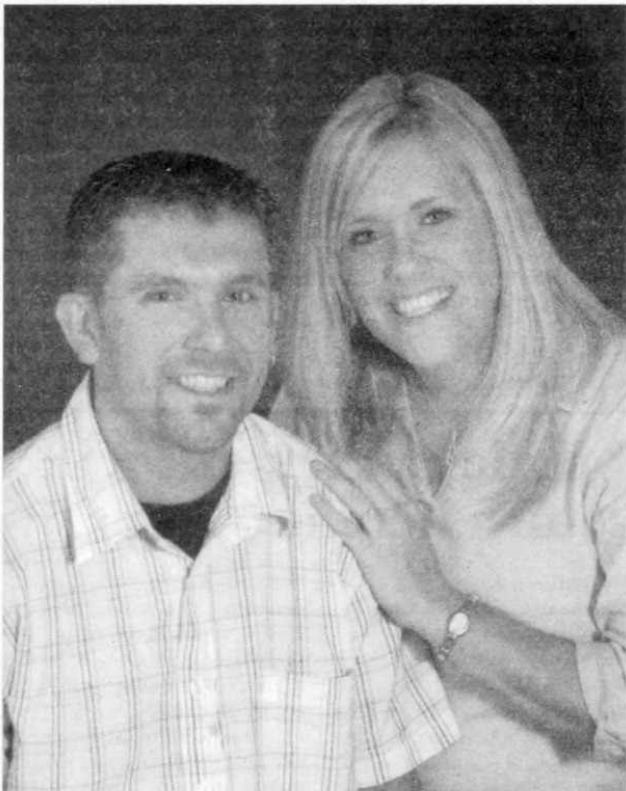

Doctors gave Julie a life expectancy of 1-1/2 years or the option of having a lung

transplant. Graham chose the lung transplant and after more tests and insurance red tape, she underwent the 12 hour transplant surgery on May 7, 1994. Three subsequent surgeries were required within a few hours of the initial transplant to control bleeding.

Graham also required a ventilator for two weeks, finally weaning off in June and was allowed to go home. She was unable to walk (due to muscle wasting), or talk (the ventilator had split her vocal cords) and required her to undergo six months of intense physical therapy. At this time Julie is the ONLY surviving PPH/PCH patient in the world!

From the time of her transplant surgery, she was warned that her kidneys had taken a "big hit" from both the surgery and, following the surgery, her anti-rejection medications.

Three years ago, Graham's kidneys began to show signs of trouble. Nephrologist Dr.

Greg Warren of West Bend, suggested that she get a kidney transplant and it was accepted. Julie's brother, Steve Zamzow of Eyota, Minnesota, was accepted as a donor, after doctors at Mayo Clinic worked to stabilize Zamzow's high blood pressure problems.

Julie then had to undergo another series of testing by the Mayo Clinic and was accepted as a recipient for a "living related donor" and she then received the go-ahead from Mayo for surgery on January 18, 2006.

Up to \$2,500 of proceeds from the card party/raffle will be matched by the home office of Modern Woodmen of America to help alleviate a portion of Graham's medical expenses. 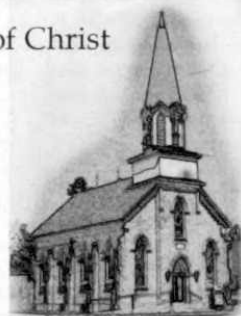

# DAYS GONE BY

## 25 Years Ago

April 3, 1981

Two 16-year-old Kewaskum girls, both juniors at Kewaskum High School, died over the weekend as a result of injuries they sustained in a one-car auto accident in the Town of Auburn, Fond du Lac County, about four miles north of Kewaskum. Sue Ann Mrstik and Tracy L. Neitzel, both 16, died after the car in which they were riding skidded off Highway 45 shortly before 10 p.m. and struck a power pole seven-tenths of a mile south of County Trunk Y, according to the Fond du Lac County Sheriff's Department.

The Kewaskum Plan Commission Tuesday evening reviewed its TIF "Proposed Projects List" in an effort to align its priorities with an eye on importance and need as well as cost. The preliminary list of 21 projects was developed over several meetings through the joint efforts of the Plan Commission and the Village Board. Tuesday's meeting resulted in selection of eight major projects which the commission feels would best benefit and improve the village. Highest on the priority list is the extension of Regal Drive approximately 3,000 feet north, which would include portions of old Fond du Lac Road. A price tag of \$754,000 covers blacktop, curbing, hydrants, culverts and signs. The second project would be connection of a new waterline from Milan Drive to Roseland Drive, forming a loop. Preliminary figures show a cost of \$103,150 for this construction. Construction of Well No. 3, with water tower, pump house, and equipment on the south side of the village is projected to cost approximately \$615,000.

## 50 Years Ago

April 6, 1956

A great deal of excitement was stirred up and an extensive search was made when two-year-old Glenn Eichstedt, son of Mr. and Mrs. Oliver Eichstedt of the Town of Kewaskum, wandered off from their rural home located about two miles southeast of the village. Little Glenn was outside playing with two other Eichstedt children around 4 p.m. Mrs. Eichstedt spotted them on a hill some distance from the house. She called and two of the children returned home, but Glenn was missing. When Mrs. Eichstedt could not find the tot, she notified her brothers and some neighbors who joined in the search. When the boy still was not located at 6 p.m., the Sheriff's Department was notified and Sheriff George Brugger radioed all available traffic and police officers from Kewaskum, West Bend and the northern part of the county to the scene. Then he put in a call to the Kewaskum Fire Department which sent the ambulance, equipment truck and all firemen who responded to the siren. When no trace of the boy was found up to the time it got dark every available searchlight and flashlight was put into use. It was after 7 p.m. when David Schaefer, 12, son of Mr. and Mrs. Ray Schaefer, neighbors, found the tot in a ditch aside of the road on Highway H, about a mile east of his home. Glenn was returned safe and sound

and had a pair of rosy red cheeks to show for his experience.

March 27, 1931

April 3, 1931

As the result of a heavy snowstorm Thursday night and Friday night, the month of March came in like a lamb and passed out like a lion. The snow commenced to fall early on Thursday morning, during which time about three inches fell. On Friday, flurries of snow fell until Friday evening when a strong northeasterly wind swept down accompanied by a heavy snow fall covering the ground with a white blanket about nine inches deep by Saturday morning.

Nicholas Rimmel, for 60 years a resident of this village,

died here Monday morning within an hour after he was stricken. He was 79 years old. He was at one time in partnership with his brother Math at the blacksmith trade and later, breaking away from that trade, he established a machine shop and was in that business nearly 50 years. Surviving him are four daughters, namely: Helen A. and Mary, at home; Rose (Mrs. Don Harbeck) and Lorena (Mrs. Louis Bath), of Kewaskum. The fire department was called out Tuesday evening to put out a fire on the roof of Roman Smith's house. The fire is believed to have started from a spark from the chimney.

The body of a slain infant, deeply hidden in a culvert was found early Saturday afternoon by John Schneider, Willow Creek farmer. Mr. Schneider saw two men park their car directly in front of the farm's entrance and then quickly dispose of the body in the culvert a short distance off. Mr. Schneider hurried to the culvert, unwrapped the package and found the dead child. He immediately called County Coroner Reinders of this village, who took the body to the West Bend Clinic, where Dr. Driessel, on examination reported its skull had been crushed. Attempts have been made to find the slayers but as yet no new definite developments have been reported.

## 100 Years Ago

March 31, 1906

The handsome new Holy Trinity Church was consecrated in Kewaskum, March 27, 1906, by the Most Rev. S.G. Messmer, Archbishop of the Archdiocese of Milwaukee in the presence of a large audience. The new church will cost, including the interior furnishings, about \$25,000. The cornerstone was laid on June 18, 1905. The church will seat 400 with its gallery.

Mrs. A.A. Perschbacher broke the ladies' bowling record last Thursday afternoon by scoring 110 points.

The smokehouse on Wil-

liam Krueger's farm three miles north of Kewaskum was destroyed by fire early last Saturday morning, along with a lot of meat which was being smoked.

April 7, 1906

One hundred and seventy-two votes were cast in the village election last Tuesday. The regular nominated ticket was elected with the exception of Henry Schneider for treasurer, who was defeated by John Marx by seven votes; L.D. Guth for justice was defeated by W. S. Olwein by five votes and J.P. Klein for assessor was defeated by John Andrea by 29 votes. The question to pay the trustees a salary of \$15 per year and the president \$25 per year was carried by a vote of 28 to 65. The following are the new village officers elected: President William Stark; trustees, Philip Meinhardt, Val. Peters, William Miller; Clerk, Edw. C. Miller; treasurer, John Marx; supervisor, H.J. Lay; assessor John Andrea; justice of the peace, W.S. Olwein; constable Mike A. Johannes Jr.

Frank Kohn bought the Albert Dehm saloon and dance hall at New Fane last Thursday for \$4,500.

The following named children will be confirmed by Rev. Lienkaemper Sunday at Wayne: Oscar Leinkaemper, Willie Coulter, Nora Petri, Viola Doms and Oliver Kibbel.

The Kewaskum Baseball Club met at the village hall on Thursday evening and elected the following officers: President Byron Rosenheimer; secretary and treasurer, John Schaefer; manager, Louis Schaefer; Captain, Irvin Koch. Otto Lay, George H. Schmidt and Martin Rimmel were appointed a committee to secure a field to play in and to purchase new uniforms.

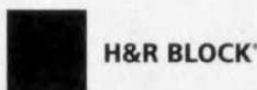

## Health Cost Warning

State health leaders are warning a proposed constitutional amendment, dubbed the "Taxpayer Protection Act" or TPA, could lead to increased cost shifting escalating private insurance costs.

Put bluntly, health insurance premiums in Wisconsin—already higher than the national average—could dramatically escalate. Business leaders regularly cite insurance costs as a major problem to expanding and adding jobs in Wisconsin. Workers also are seeing higher premium costs.

Existing high premiums already reflect the state's failure to fully fund the costs of Medicaid, the state-federal program of health care for the poor. Wisconsin Hospital Association President Steve Brenton says the failure to fully fund all Medicaid hospital costs has created a \$546 million "hidden health-care tax" in Wisconsin.

The unpaid costs are recouped from the private sector and are shifted to people and businesses under individual and employer health plans. This also occurs when the federal Medicare program does not fully fund its benefits.

"The cost shifting burden from government health care programs has already added \$1.5 billion to the price of health insurance in Wisconsin, forcing many consumers to drop their coverage," says Nancy Wenzel, executive director of the Wisconsin Association of Health Plans. "Wisconsin cannot afford to make the problem worse."

These concerns have been spelled out to the captains of business and industry, but the constitutional amendment continues to be vigorously pushed by Wisconsin Manufacturers and Commerce, the powerful business lobby. The

warning about cost shifting and higher health insurance premiums has not dented the WMC backing on the TPA concept.

Health leaders also worry about the impact on the neediest citizens. "We simply must ensure that our most vulnerable patients have access to care when they most need it," says Dr. Susan Turney, chief executive officer of the State Medical Society.

The proposed TPA might limit government collected taxes and fees, allowing the politicians to pose for holy pictures. But a constitutional amendment won't make health care less expensive or less needy. But it could place new pressure on worker and business health insurance costs.

Would business leaders then moan about those cost increases? You bet.

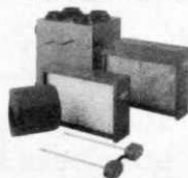

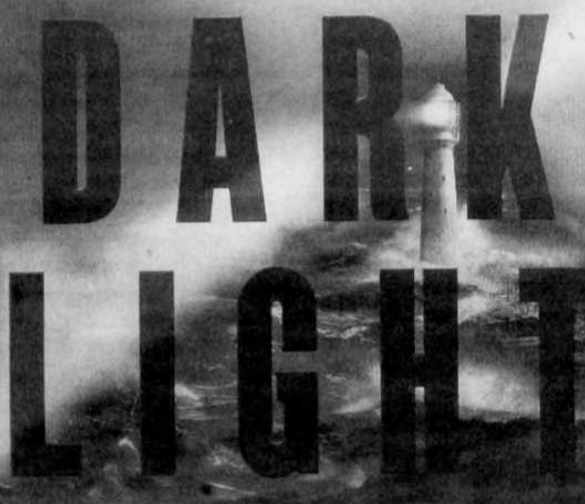

Aside from a colossal mess, I mean.

You'd see marine creatures the likes of which you'd only imagined. You'd find unbelievable land formations. You'd discover hundreds, if not thousands of wrecked planes, boats, and ships. And you'd find lots of buried secrets.

Rumor has it that a shipwreck lies a few miles off Sanibel, Florida, and in the new novel "Dark Light" by Randy Wayne White, it's up to biologist Doc Ford to get to the bottom of the ocean to find the bottom of the mystery.

A Category 4 hurricane has just hit Florida, and clean-up has begun. People around Sanibel have been through hurricanes before, and Government-issue tarps can be seen everywhere roofs once sat. Still, despite a business-as-usual attitude, the storm hurt small fisherman and other residents around Sanibel.

When Augie Heller hired Jeth Nichols to take him out over Gulf waters, Nichols did as he was asked. The water was still churned and choppy, but since the storm, Jeth was out of work and Augie paid good money. Augie was the nephew of Bern Heller, the new CEO of Indian Harbor Marina. Bern was a bully and a thief. Jeth didn't like either of them very much, but a job is a job.

And this job became a whole lot more lucrative when Jeth sees a decades-old shipwreck, uncovered by the hurricane and glowing on the GPS screen. Now a quick run over

the Gulf could mean riches.

Bern Heller wants rights to the wreck, too. It was found by someone piloting a Marina-owned boat, which means the Marina owns the wreck, right? Indian Harbor Marina, built by Heller's grandfather and protected by shady lawyers, is Bern's chance to make his good-for-nothing family take notice. They never thought he'd ever be anything other than a car dealer back in Madison, Wisconsin, but he's about to show them. Nobody underestimates Bern Heller.

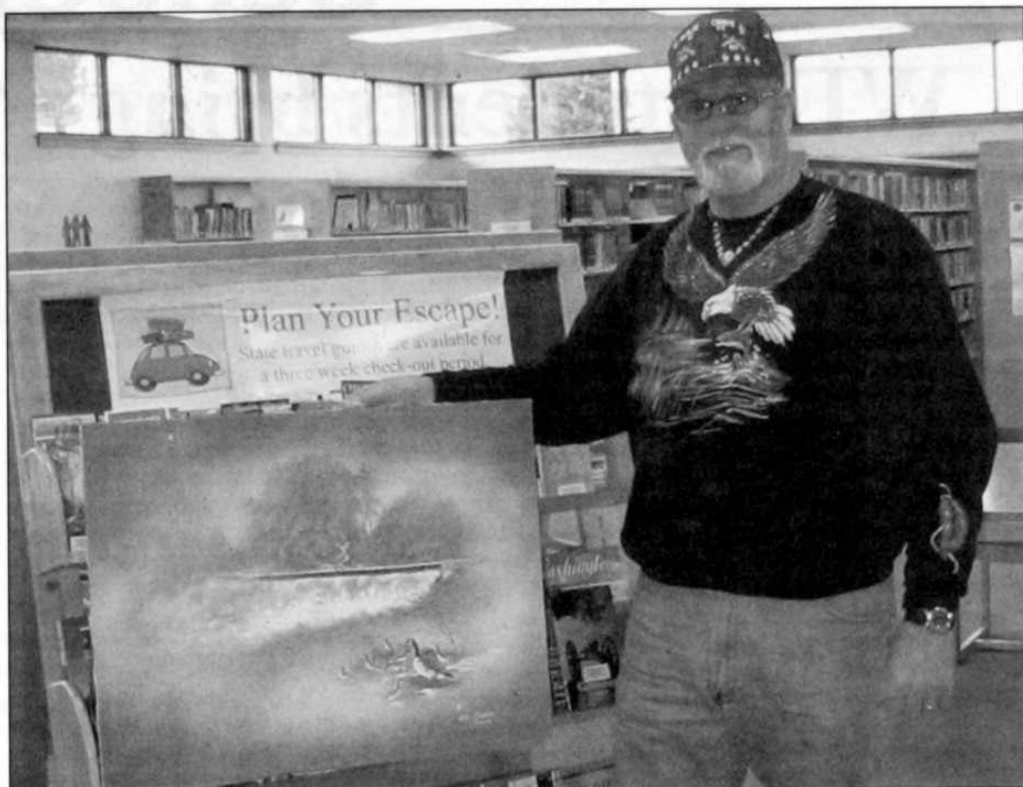
When rumors fly around Sanibel and Jeth asks Doc Ford to help with the salvage of the wreck, people suddenly become interested in what lies beneath the water. Chestra Engle is one of them, and she offers to fund the operation in exchange for a few trinkets. Chessie claims that her long-dead godmother was on that ship, and she wants to know the truth about how Marissa Dorn died.

The truth may be buried, not beneath ocean sludge, but in an old Nazi passport.

Where has this author been all my life?

"Dark Light" is fast-paced and full of intrigue, peopled with colorful characters and just enough wry humor to give it waggishness without being silly. Author Randy Wayne White only hints at Doc Ford's past in this book, which will definitely make you want to read all his other novels featuring this wise and complex special ops soldier-turned-biologist-detective. If you're ready to immerse yourself in a novel that you won't want to put down, then try this one. "Dark Light" is oceans of fun to read.

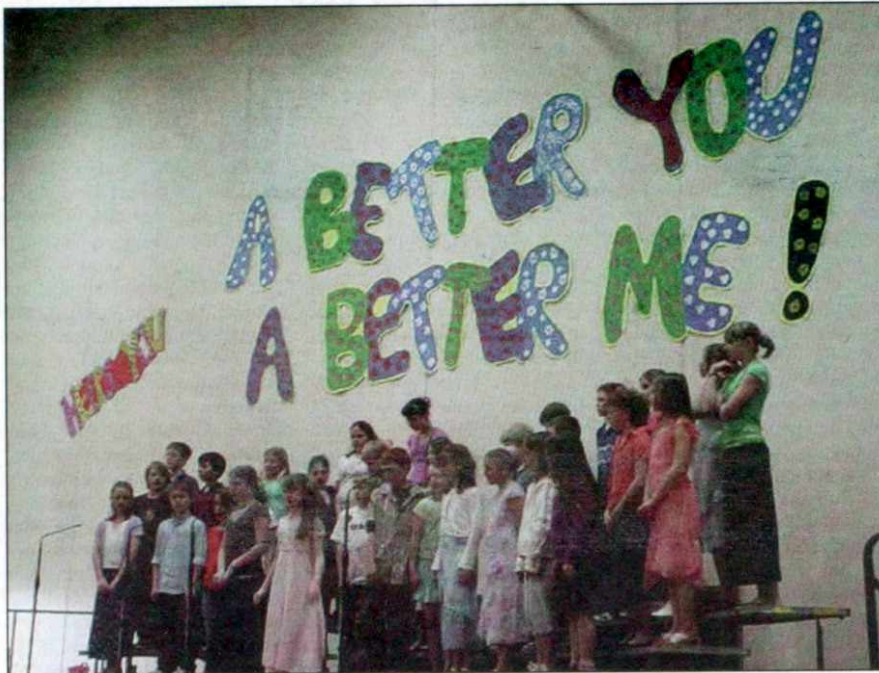

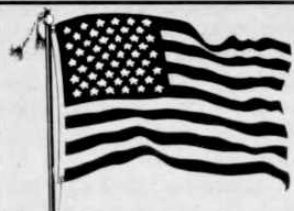

## New highway signs will advise motorists of Move Over Law

To inform motorists about the state law requiring that they provide a safety zone for law enforcement officers, highway maintenance crews and others who work on the side of roads within a few feet of fast moving traffic, the Wisconsin Department of Transportation (WisDOT) will begin installing "Move Over Law" road signs this spring, Governor Jim Doyle announced recently.

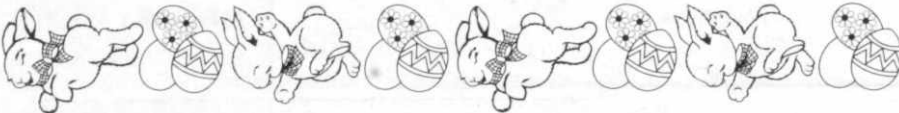
According to state law, drivers must move over a lane if possible or slow down if changing lanes is not safe when encountering a law enforcement vehicle, ambulance, fire truck, tow truck, utility vehicle or highway construction vehicle that is stopped on the side of the road with its lights flashing.

"Highway maintenance workers, state troopers, and other law enforcement officers have been injured or even killed while making traffic stops or as-

sisting motorists on the road shoulder," Governor Doyle said. "We need to remind drivers of Wisconsin's Move Over Law for not only their own protection, but to help prevent needless injuries or death to the men and women who are trying to make our roads safer through regulation or construction."

On March 7, 2006, Marc Neumeyer and Daniel Melhorn of the Winnebago County Highway Department were hit and killed while working on the shoulder of the road.

Near main entry points to Wisconsin at Kenosha, Genoa City, Beloit, LaCrosse, Superior, Hudson and on US 51 near Kiel, motorists will now see the signs that read: "STATE LAW. MOVE OVER OR SLOW DOWN FOR STOPPED EMERGENCY VEHICLES." The signs were unveiled recently at a news conference in Madison.

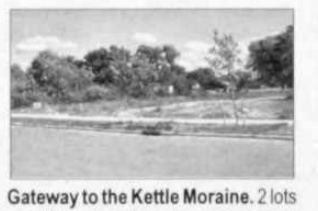

Action was taken on Resolution No. 2006-07 A Resolution of the Village of Kewaskum, Washington County, Wisconsin "Action To Allow Encroachment In The Flood Fringe By The Sewage Pump Station No. 1 as attached hereto: Roll call vote was 6 "Aye" 0 "Nay" 1 "Absent". Trustee Harry Roecker was absent.

On a motion By Trustee Derek Peterson, seconded by Trustee Thomas Piwoni and carried by the majority voice vote, the Board authorized the advertising of bids for the construction /installation of a new sewage lift station no. 1, forced main to the plant, abandonment of old pump station and retro fit bathroom facilities. Trustee Harry Roecker was absent and Trustee Kevin Scheunemann voted Nay.

### RESOLUTION NO. 2006-09

A RESOLUTION OF THE VILLAGE OF KEWASKUM, WASHINGTON COUNTY, WISCONSIN  
DECLARING THE INTENT OF THE VILLAGE BOARD TO ESTABLISH A STORM WATER UTILITY DISTRICT IN THE VILLAGE OF KEWASKUM

WHEREAS, the Village Board of the Village of Kewaskum, Washington County, Wisconsin, has approved the storm water management plans for the Tax Incremental District No. 2 ("TID 2"); and

WHEREAS, the storm water management plans for TID 2 include the use of regional storm water detention ponds for the control of storm water runoff quantity and pollutants in storm water runoff; and

WHEREAS, the Wisconsin Department of Natural Resources has approved the storm water management plans for TID 2, subject to the Village agreeing to take responsibility for the long-term maintenance of the storm water detention ponds and other facilities; and

WHEREAS, the Village installed the storm water management facilities as required by the approved storm water management plans and funded the installation of the improvements through the creation of Tax Incremental District No. 2; and

WHEREAS, it is the intent of the Village that the cost of perpetually maintaining said structures should be charged to properties within TID 2 that will derive a benefit from the facilities in the form of annual service charges.

NOW THEREFORE BE IT RESOLVED, by the Village Board of the Village of Kewaskum, Washington County, Wisconsin, that:

Section 1. Pursuant to Wisconsin Statutes §66.0827 and §66.0821 and in accordance with §66.0703, the Village Board hereby declares its intention to establish a utility district in the Village of Kewaskum, Washington County, Wisconsin, and to charge storm water service charges to properties in the utility district for a public purpose to wit: to provide storm water management service to said utility district.

Section 2. The limits and boundaries of said proposed utility district are

set forth on the map attached hereto and incorporated herein and made part hereof by reference as Exhibit 1.

Section 3. The properties to be included in the proposed district are benefited by the maintenance of storm water management facilities within the proposed district, and said actions by the Village Board constitute an exercise of the police power of the governing body of the Village of Kewaskum, Washington County, Wisconsin.

Section 4. The method of charging for costs of providing the storm water management services within the district will be determined at the hearing required under Wisconsin Statutes 66.0703(7) and the engineering firm employed by the Village shall make a report thereon.

Section 5. Said report shall comply with the requirements of Wisconsin Law and shall include:

A. Preliminary plans and specifications.

B. An estimate of the annual cost of maintaining the planned improvements.

C. An estimate as to the approximate annual cost per unit for properties affected and a schedule of the proposed annual charges for each property affected.

D. A statement that the properties against which the assessments are proposed are benefited.

Section 6. The Village Clerk shall give public notice of said public hearing and shall mail a copy of the public notice to each property owner within the proposed District.

Section 7. Each paragraph of the Preamble of this Resolution shall be and is hereby incorporated in its entirety into the substance of this Resolution and made a part of this Resolution by reference as though fully restated.

Section 8. If any provision of this Resolution is determined to be invalid or unconstitutional, or if the application of this Resolution to any person or circumstance is invalid or unconstitutional, such invalidity or unconstitutionality will not affect other provision of applications of this Resolution that can be given effect aside from the invalid or unconstitutional provision or application.

4. No roots of any kind, or material with any dirt on it.

Note: Yard waste, garden plant waste, corn stalks, sun flower stalk, leaves, grass and materials that will rot down in a compost pile can be brought to the DPW yard and placed in the yard compost bin.

## There's a big 'if' concerning more KHS tennis success

If Dan Ross can find some adequate doubles replacements, the Kewaskum High tennis team could duplicate its 2005 third place finish in the Eastern Wisconsin Conference, but that might be a big if since all six of the Indians who competed in doubles last spring have graduated.

"They were all pretty good," Ross said of his doubles starters from last year, while running off the names of Josh Bryant and Abe Foerster, who played at No. 1, David Figge and John Carpenter, who were solid at No. 2 and Adam Ziebel and Craig Johann, who won their share of matches at No. 3.

Ross does have five lettermen returning, including Mitch Paulus, his regular at No. 1, and Travis Bryant, who will be moving from singles to No. 1 doubles this season.

A day after a scrimmage against Living Word High School out of Jackson, Ross is pretty well set on his singles lineup, but there are still a few questions at doubles.

Paulus, a senior, had the misfortune of running up against some very talented EWC foes last season, and, according to Ross, he will be looking at some of the same faces across the net this year.

Unfortunately many of the No. 1 singles players are back. Only one of the top four graduated," Ross said. "That will be tough."

Paulus has also elevated his game, the coach said, and that is due, in part to the fact he played a lot of tennis since last June.

"He's looking good and will be playing No. 1 singles again," Ross said. "He's been playing year round."

The other four returning letter winners are Travis Bryant, a junior, sophomore Jacob Cochran, sophomore Dan Parker and junior Jeremy Parker.

"He'll be moving up to No. 2," Ross said about Cochran, who played No. 3 for him last year. "He did a nice job (in 2005), especially for being a rookie."

Ross said he had 24 young men out for the sport, which is down slightly from last year's turnout. "I'm glad we don't have as many since I am the only coach," he said. "Unfortunately we only have one freshman."

As far as top teams in the EWC, Ross points to Kohler and defending champion, Roncalli. "Roncalli just edged them out (for the title last year). It was super close ... They never seem to run out of talent."

Two other teams that will try to form a roadblock in Kewaskum's run for another upper division finish are Plymouth and Sheboygan Falls. "We'll have to improve on our number of wins to stay at third," Ross said.

This afternoon (Thursday), the Indians travel to Two Rivers for the EWC opener. On Tuesday, they face Kohler in the home opener.

## Trout stocking to resume on several southeast Wisconsin waters

MILWAUKEE - After a two-year hiatus, several popular southeast Wisconsin lakes and streams will receive stocked trout in time for the 5:00 a.m. inland fishing season opener on Saturday, May 6.

"Several of these waters are an important part of this region's fishing heritage," said Regional Fisheries Supervisor, Randy Schumacher. "It's pretty common to talk to adult anglers who grew up fishing lakes like Lower Genesee or Lower Nashotah, or Allenton Creek with their families. It was a family tradition to be out on the water and ready to fish by 5:00 on opening morning--and the trout usually cooperated," he said.

Over the last couple of years, stocking was discontinued because of a funding shortfall in general fishing license revenue. "With last year's increase in the fishing license fee we have enough funds to raise these fish," said Schumacher. Because state fish hatcheries could not respond immediately to

increased funding, stocking levels of the one-and-a-half year-old trout will be a little below the long-term average for each water. "The slightly reduced numbers will not mean much to the average angler. There may be a few less trout available as the summer wears on; but for the average angler that fishes in May and early June, there will be no significant difference in their catch" he added.

Waters to receive the trout stocking and approximate numbers to be stocked include:

**Waukesha County:** Lower Genesee Lake, 2,100 brown, 2,600 rainbow and 1,600 brook; Lower Nashotah Lake, 2,900 brown and 2,600 rainbow; Ottawa Lake, 1,400 brown and 1,700 rainbow; Fowler Lake, 2,100 brown and 2,600 rainbow.

**Racine County:** Waubesa Lake, 900 brown; Tichigan Creek, 300 brown.

**Kenosha County:** Palmer Creek, 150 brown.

**Walworth County:** Steel Brook, 150 brown; Lake Beau-

lah, 6,000 brown.

**Washington County:** Allenton Creek, 1,700 rainbow.

**Sheboygan County:** Onion River, 1,700 rainbow; Mullet River, 1,700 rainbow; Melius Creek, 700 brown; La Budde Creek, 1,600 brook; Glenbeulah Springs, 800 brook.

Schumacher noted that most of these waters are under trout regulation, Category 3, which is a 9-inch size limit and a bag limit of three trout. However, Sheboygan County's Mill Creek, Ben Nutt Creek and the Onion River above County Highway E have special regulations for trout where the minimum size limit is 15 inches, the daily bag limit is one trout, and only artificial lures can be used.

Groth struck out the next EL hitter, for her 11th strikeout of the game, but then she walked two straight (her 13th and 14th walks) and forced in the lead run.

Would the Indians, who were outscored 40-0 in their first three games, be able to battle back in their half of the seventh? You bet.

Heberer got the rally going when she worked Resorter pitcher Janelle Ausloos for a walk. Groth followed with a sharp single to left that was muffed by the left fielder, and Heberer sped all the way home with the tying run.

Sargent pinch ran for Groth (who took second on the error) again and stole third, then Hammen grounded to the pitcher, who held the ball, and now the Indians had runners at first and third.

Then with DeLaurier up

## Spring burning planned in county

MILWAUKEE - The Wisconsin Department of Natural Resources is proposing to conduct prescribed burns during April and early May on lands in southeastern Wisconsin. Burn sites typically range in size from one acre to 100 acres. About 1,000 acres in total may be burned depending on weather and other factors.

Prescribed burns are used to increase plant diversity and stem density on grasslands, for site preparation for seeding warm season grasses, to set back undesirable woody vegetation or other invasive species, and to improve waterfowl brood and migration habitat. A primary goal on upland sites is to improve nesting habitat for bird species such as mallards, blue-winged teal, pheasants, bobolinks, dickcissels and grasshopper sparrows. Burning is also conducted on wetland sites where levels have been lowered to improve habitat for waterfowl and other wildlife by providing more areas of open water and a larger variety wetland plants.

In Washington and east-

ern Dodge Counties potential burn sites are located at the Theresa, Allenton and Jackson Wildlife Areas and the Loew Lake Unit of the Kettle Moraine State Forest. In Ozaukee County burns will take place on Harrington Beach State Park, and at Havenwoods Environmental Center in Milwaukee County. Burns may also be conducted on other sites on private and public land in Washington and Ozaukee Counties.

This type of project does

not have the potential to cause significant adverse environmental impacts and the Department has made a preliminary determination that an environmental impact statement will not be required.

Burn proposals may be reviewed at the Pike Lake DNR office, 3544 Kettle Moraine Road, Hartford, WI 53027. Questions or comments regarding the burns should be directed to Wildlife Management staff at the Pike Lake office, telephone 262-670-3409.

## Herriges, Kison, Brock, relays shine in KHS quad competition

The weather was far from pleasant last Tuesday, but the outcome of the first outdoor track meets for both Kewaskum teams was encouraging as the Indians entertained three other Eastern Wisconsin Conference schools.

Paced by the good individual efforts of senior Erika Brock and freshman Nicole Kison and wins in both sprint relays, the Lady Indians came out on top, outscoring New Holstein for first place, 76-74. Sheboygan Falls was right in the mix with its 67.5 points, and then came Roncalli at 52.5.

The boys were faced with a bit more competition and had to settle for third place. Kewaskum scored 37 points, some distance behind New Holstein and Roncalli, which finished with 64 and 61, respectively. Sheboygan Falls was last at 31.

One of the KHS boys provided one of the top individual efforts of the night, according to coach Jerry Gosa, who beamed when he stated, "Luke Herriges went 6 feet, four (inches) last night in that cold and windy weather, and he had one nice attempt at 6-6."

Gosa is hoping his senior high jumper will clear that latter height several times this spring.

As far as the girls, Gosa went on, "I was impressed with the fact Nicole Kison won the long jump at 15 feet, 9 inches and also won the 400

meter dash."

No one came close to Kison in the long jump. The next longest jump was produced by a girl from New Holstein, who went 15-00.25.

In the 400, Kison crossed the finish line in 1:06.8, and again she won pretty comfortably. "For a freshman, she's got some pretty big shoes to fill," Gosa went on, referring to the 2005 400 ace, Amanda Donath, who is running for UW-Oshkosh this spring and already has attained NCAA III All-American indoor status.

In the 4x100 relay, won in a time of 56 and .92 seconds (56.92), it was Jessie Forbes, Alissa Clapper, Liz Potter and Kelly Uelmen. This was Potter's first meet of the season. She was recovering from a knee injury.

"Kelly ran a great anchor leg and pulled out the win," Gosa said. "They ran a fairly good time."

In the 4x200, the winning time was 1:59.98 (or officially 2:00) and in this one Kison ran the third leg instead of Potter.

Gosa was also happy to see Brock pick up a double win, taking the shot in 33-10.25 and the discus with an effort of 86-07. "Throwing into that wind was tough," Gosa said.

Other top places included: the first by Crystal Trep-tow in the pole vault, 8-0 and a second by Amber Struck in the 1,600. She was clocked in 6:00.26, nine seconds out of first. "She got beat by a girl from Sheboygan Falls, also a freshman," Gosa said. "It was kind of a measuring stick of where she wants to be."

In the boys' competition,

Garett Donath was a double winner for the Indians, turning in a time of 11.1 in the 100-meter dash and a 23.38 in the 200 where he had nearly a full second lead on Kyle Halback of New Holstein (24.32).

Unfortunately Donath had trouble in the pole vault and was unable to make the opening height, after going 12-6 in his last indoor meet.

"Zach VanWormer ran very well in the 400," Gosa said about VanWormer's 53.7, which was good enough for first place in the event.

Another KHS win came in the 4x400 relay where Donath, Dan Dymond, Jake Sabel and VanWormer were clocked in 3:38.20, almost three seconds ahead of New Holstein.

Kewaskum scored 10 points in the discus with Logan Staeger and Ben Boettcher going 1-2 on throws of 128-02 and 128-0.

Gosa was very pleased to see Ross Stockhausen take a second in the shot put. This was just his first meet, and he heaved the shot 45-01.50. "He's starting right where he was last year," the coach said.

The Indians did pretty well in the 1,600, with the second place by Bobby Gibson (4:47.71) and the fourth by Stephan Kattar (5:01.23) earning the team six points.

Sabel was the best of the long jumpers. His leap of 18-3.5 was a half an inch longer than Jaymeson Trempe of Sheboygan Falls, and Herriges added a second place in the triple jump (36-01.50).

The Indians will be at Sheboygan Falls for another quadrangular on Tuesday.

## Offense struggling; fast-pitch team drops first three games

top pitchers in the EWC last season, pitched the win for the Panthers. "We hit her though. We only struck out four times," Gosse said.

This game went five innings before ending via the 10-run "mercy rule" which is used in high school fast-pitch.

Against South, the Indians ran into a real buzz saw in Andi Pigeon, who struck out six and walked none.

"She had five different pitches," Gosse said. "As soon as I saw her throw a knuckle ball, I knew it was over."

Uttech got her single, a shot that went to right field, in the top of the fourth inning.

Kewaskum hosts Campbellsport this afternoon, then has a full week off for the Easter break before taking on Plymouth on Tuesday, April 25th, in a home game.

All home games are played at Kewaskum Kiwanis Community Park, beginning at 4:30. Doubleheaders start at 4 p.m.

Gosse is being assisted this spring by volunteer coach Josh Volesky. Jason Last is the JV coach.

The other Indian entrants, Eric Cain and Casey Scheel, posted a 78 on nines of 42 and 36. Scheel had broken his wrist during the last regular season basketball game, and coach Glenn Eichstedt hadn't expected he would be ready to play this early, but he was.

Considering the meet came after just one week of practice, Eichstedt didn't have high expectations.

"With the early start and difficult conditions, we focused on trying to make good decisions and good swings," Eichstedt said. "needless to say, we are excited and looking forward to the 26-team Washington County Invite on Saturday (April 8)."

The Campbellsport scores came as follows: Austin Luchon and Austin Sarauer, 39-34—76; Craig Hatch and Travis Zehren, 83; and Cameron Salter and Darnell Williams, 86.
