# Upscale Mediterra subdivision pitched to village plan commission, changes also approved for Cherokee Lakes

**KEWASKUM-** Tom Timblin of Kewaskum, tried his best to convince the Village of Kewaskum's plan commission that a 132 single-family lot upscale subdivision was a great plan for the village. Commissioners and village president Matt Heiser weren't so sure and sent Timblin and Greene Brothers Construction back to the drawing board. Timblin also came before the commission for a third round of changes to his original concept plan for Cherokee Lakes.

Timblin informed the commissioners that he again changed his initial plan of a 71-unit multi family building on the development. He wanted to begin construction immediately on side-by-side duplexes similar to what he developed in phase one of the Cherokee Lakes development.

He explained that the units will

have three car garages on each side. He went on to say that people touring his condos in phase one have hinted for this type design. Each unit would be 1,600 square feet.

Timblin stated that the new concept brings the density from 71 to 64 units. This will tie in directly with the other 12 units in phase one.

The village's engineering firm, Ruekert and Mileke were concerned that the addition of more duplexes would throw off the balance of housing the village currently has. Engineer Andy Petersen, informed the commissioners that taking away the multi family adds many more duplexes to the village.

He explained that currently the housing ratio in the village is 47% single family, 20% duplex and 33% multi-family with the concept plan the village approved at the start of the project. Approving Timblin's change would put the ratios at 47% single family, 22% duplexes and 31% multi

family. The village's land use plan has goals of 60% single family, 10% duplexes and 30% multi-family.

Timblin told the commissioners that if the change could not be approved he would most likely stop the project at the end of phase one.

Commissioners then approved the plan. Timblin stated that construction would most likely start on the new phase immediately.

Timblin then presented a concept plan for Mediterra Subdivision which is planned to bring 130 acres of land behind the Amerahn Ballroom into the village. His plan would add 132 single family lots with a minimum lot size of .30 acre.

"This is a pristine parcel of land. It's a shame that it can not stay farm land forever. It's a neat upscale addition to Kewaskum. We have a lot of interest in this concept, a lot of people want to build a house without having a duplex next to it," stated Timblin.

He added that the property has a

navigable stream from the Milwaukee River and large 100-year-old trees throughout. He revealed plans to build 17 upscale homes on a 100 foot bluff with views to New Fane. Timblin also boasted the bluff is either the third or fourth highest elevation in Washington County.

Petersen stated he had a problem with the grade of road leading up to the bluff. The road as depicted on the concept plan shows a grade of 15%. Village code states that village streets can not have a grade over 10%.

Timblin stated he was happy to work with the village on any of the issues they had with the development. He designed the road with the grade so that it would line up correctly to Conrad Street.

The commissioners asked Timblin and Greene to "clean-up" the plan and make another presentation at the July 25th meeting

## Fire partially destroys Town of Wayne home

T. WAYNE- Smoke could be seen from the village of

Kewaskum as a two-alarm fire partially destroyed a home on Fairview Lane mid-morning, Thursday, July 6. The home was unoccupied when fire ignited the structure.

The Washington County Sheriff's Department responded to the scene after a U.S. Postal employee delivering mail on the dead-end road noticed smoke from a

dumpster next to the garage. The garage was fully engulfed in flames by the time Kohlsville firefighters arrived at the scene.

Kohlsville Fire Chief, Ray Dornacker explained the fire started in a dumpster on the south side of the home. Family members cleaning the home put hot ashes in the dumpster days earlier. They later threw items from inside the house into the dumpster. Dornacker guesses that the combination of ashes and items from the home smoldered until it got enough air to ignite. Once the dumpster became engulfed, the garage took off and smoke and fire got in the home.

Kewaskum Fire Department was called to the scene for full mutual aid. Alenton Fire Department provided two tankers.

The home, located at 8305 Fairview Lane is owned by Ar-

mand Mertz. The garage and all of its contents were completely destroyed including a vehicle. The remainder of the home sustained extensive smoke damage.

Sheriff's Department valued the damages between \$40-50,000.

"The roof rafters were charred. We were lucky to save what we did. We had a great crew that day," concluded Dornacker.

## Participants needs for statewide private well water filtration study

MADISON- The Wisconsin Department of Health and Family Services invites 100 private well owners in the state to participate in a study on the effectiveness of household water filtration / treatment devices at removing contaminants. For those who qualify, a water quality test will be conducted at no cost to the participant.

To qualify, households must have a private well that is used for cooking and drinking and an installed Point-of-Entry or Point-of-Use water filtration system. Point-of-entry water treatment systems treat all of the water entering and being used in the home. Sedimentation filters, iron control treatment, water softener and a chlorination system used to control bacteria in the well are

all considered point-of-entry treatment systems. Point-of-use water treatment systems treat part of the water in the home water distribution system, usually at one faucet. The water is typically only used for drinking and cooking. Reverse osmosis, distillation and activated carbon filtration are examples of point-of-use water treatment systems.

The objective of the study is to determine if households with private wells that are using water treatment devices are protected from potential exposure to contaminants found in their well water. At each household, the researchers will administer a questionnaire to gather information on the selection of the water treatment type, maintenance and the reasons for use. They

will gather samples of water pre-filtration and post-filtration, and the samples will be analyzed for contaminants such as: bacteria, nitrates, and metals. The results of the analysis will be shared with the participant.

The Department of Health and Family Services will be recruiting households and sampling households throughout the summer. ## KPD partners with bankers to fight fraud

Through a partnership with the Wisconsin Bankers Association, the Kewaskum Police Department has a powerful new tool to combat the steady growth of financial crimes in Wisconsin. It's called FinCrime - the Midwest's leading anti-financial crime network.

FinCrime allows law enforcement and financial institutions to stay a step ahead of the increasingly sophisticated, brazen and unconscionable financial criminals by rapidly sharing information through e-mail alerts. Reportable crimes through the network may include check fraud, counterfeit schemes, descriptions of bank robbery suspect and identity theft scams. The alerts have proven to be highly effective in reducing monetary losses and increasing arrest rates in the 15 states where it is in use.

Statistics from the Wisconsin Bankers Association and Federal Trade Commission show that all forms of financial crimes are increasing in Wisconsin. Protect yourself from falling victim to a financial crime, like identity theft, by remembering these tips:

Never give out your personal financial information over the phone or the computer, unless you were the one to make the first contact. Banks will never ask you to "verify" your financial information via e-mail or over the phone.

When sending credit card numbers electronically, make sure the site is secure and reputable.

Check you credit card and bank accounts statements regularly and look for unauthorized charges, even small ones. Report these discrepancies immediately

Document all your credit cards and account informa-

tion, along with the card users contact information. If anything looks suspicious or you lose your credit card, contact the issuer immediately.

The safest way to make Internet purchases is by credit card. If something is wrong, you can most easily dispute the charges.

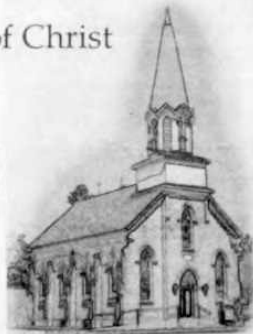

## Town of Scott tackles residents questions at June meeting

**TOWN OF SCOTT**- Residents in the Town of Scott grilled their supervisors on a variety of issues which took up the bulk of the June meeting. The township also issued liquor licenses and bartenders licenses.

The use of new fire number signs, used to identify property addresses being sold by the Beechwood Fire Department were questioned by a member of the audience. The board clarified that area fire departments requested the blue signs because they were easier to read than those currently being required by a Sheboygan County ordinance.

All residents must post the white

tile signs that are required by the Sheboygan County Planning Department. County ordinance does not prohibit displaying the blue signs, so both may be used. Batavia firefighter Bernie Baldwin voiced his opinion saying, "I would like to see the blue ones up. The other ones are difficult to spot, especially when you are fast asleep and must jump out of bed when the pager goes off at 2:00 a.m."

Supervisors approved a request from Northeast Asphalt to use gravel for resurfacing one mile of Silver Creek Cascade Road between County Road SS and Abbott Drive in the Town of Sherman. This will save that township approximately \$20,000. Town of Scott Chairman Steve Jung added that several years ago, Sherman allowed Scott

to use gravel from a pit being operated there.

Moving along after public input, Batavia Fire Chief Dennis Schulz reported that the forms for the Insurance Service Office (ISO) agreement are nearing completion. The department has met all the criteria so far, and they will now be doing the annual fire inspection of buildings.

Heberer Brothers of Kewaskum was awarded a \$540 contract to repair and bring the town hall bathroom up to code required by the Americans with Disability Act (ADA) requirements. Two other proposals were examined, \$820 from Mark Heniecke and \$965 from Navis Custom Builders.

The board took action on various items such as appointing Chris Miller

to the Lakeview Community Library for a two-year term. A claim for Russell Kempf's accident for \$750 was also accepted.

The Smart Growth Committee is setting up a schedule for future meetings beginning in August.

Building permits were issued to Mark Heise, Rick Volm and Nancy Wegner each for garage construction; Dorothy Kutz, Doug Goldrick, Chad Peters, Joe Herrmann, Chuck Morris, David Pomeroy and Roger Kumrow, each for roofing projects; Joseph Waters for siding; Randy Narbotovics for a new roof; Time Warner for electric service; Irv Lepp for ag buildings.

## County will hold comprehensive growth seminar interactive workshop

Washington County is hosting a comprehensive smart growth interactive workshop Thursday, July 20, in the Applied Manufacturing Technology Center at the Moraine Park Technical College, 2151 North Main Street, West Bend, between 2 and 8 p.m.

Washington County, in partnership with the Towns of Addison, Barton, Erin, Farmington, Germantown, Hartford, Kewaskum, Polk, Trenton and Wayne and the Village of Kewaskum, have formally agreed to work together in a single planning effort to develop a plan that fulfills the requirements of the Comprehensive Planning Law.

There will be one visioning workshop for the County and one for each partnering community to provide opportunities for citizens to learn about the countywide comprehensive plan draft inventory chapters and to provide their vision of the future. This workshop will be conducted in an open house format, where participants can choose when to attend and which activities to complete.

There are a total of six stations where participants will have opportunities to gather information and learn about

the smart growth plan and to participate in hands-on visioning activities. Activities include: mapping future land use through the use of Geographic Information System software, surveying preferred types of development through a slideshow format, evaluating Washington County's existing goals, writing a vision statement for Washington County, and sharing opinions about smart growth elements and goals.

A presentation of the draft inventory chapters and countywide survey results will be conducted at 6 p.m.

Mapping Future Land Use Station is scheduled to start on the hour. Interactive Development Preference Slideshow station is scheduled to start every half hour.

Workshops are scheduled in partnering Washington County municipalities during the months of August and September. Local government workshop dates can be found online at: [www.co.washington.wi.us/smart-growth](http://www.co.washington.wi.us/smart-growth).

The primary content in a comprehensive planning document revolves around "nine elements" outlined in Chapter 66 of the state statutes. The nine elements include Issues and Opportunities, Housing, Transportation, Utilities and Community Facilities, Agricultural, Natural and Cultural Resources, Economic Development, Intergovernmental Cooperation, Land Use and Implementation.

All municipalities and Washington County are required to adopt a comprehensive (Smart Growth) plan by January 1, 2010. The Southeastern Wisconsin Regional Planning Commission (SEWRPC) and the University of Wisconsin Extension are also involved in the process.

This joint planning process will allow, for the first time, the development of an overall vision for the County and provide an opportunity for neighboring municipalities to work through tough issues to ensure the future success, economic vitality and quality of life in Washington County.

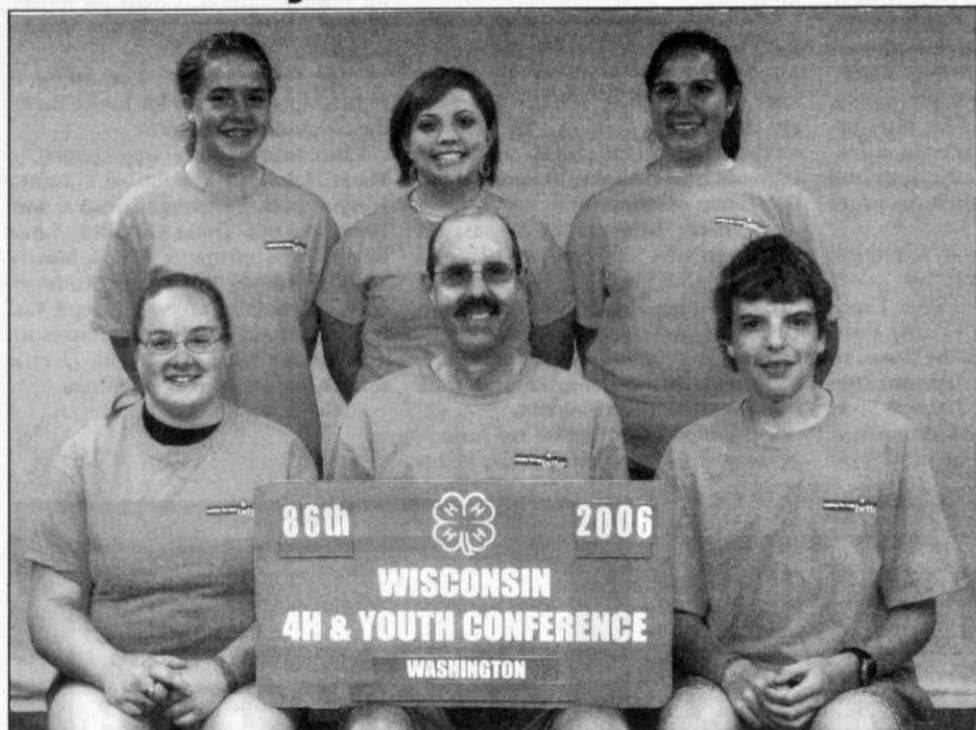

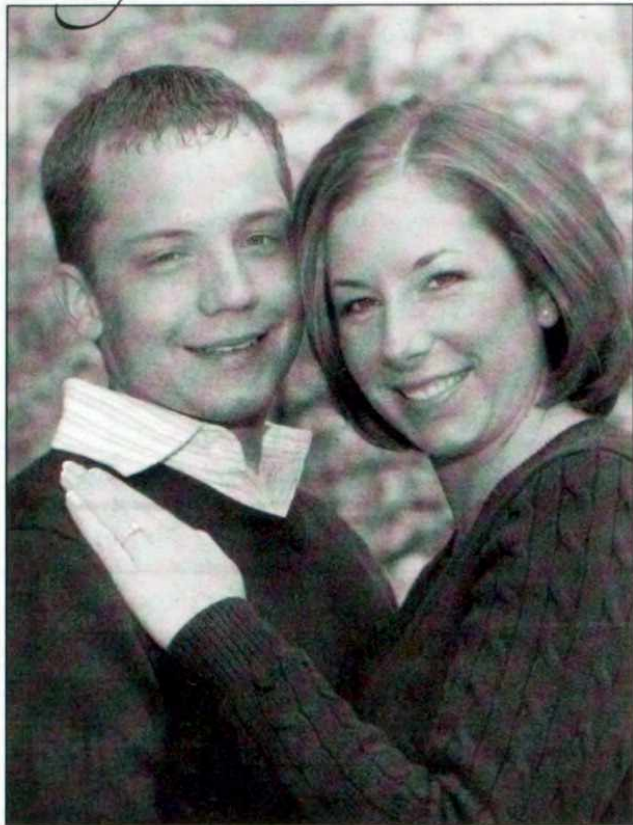

# DAYS GONE BY

## 25 Years Ago

July 10, 1981

A small trailer was gutted by fire at the Shulka Forest Products sawmill on Mill Road and Highway 28 about one mile east of Kewaskum late Friday night. Kewaskum firemen were called to the scene shortly after 11:30 p.m. More than 30 firemen who were working in River Hill Park following the fireworks that night, answered the call.

The Second Annual Mini-Olympic Day was sponsored by the Kewaskum Junior Women and the Kewaskum High School Kiwanis Key Club. The event was held Saturday, June 27 at the high school grounds and was attended by over 125 children. Thirty-five parents took part in the parent/child race.

Kewaskum was scheduled to host New Holstein in a 6 p.m. game last Thursday, but the Huskies showed up too late due to a scheduling mixup. The Indians were ordered to take the field by the umpires. Steve Muench delivered one pitch and the game was called a 7-0 forfeit. As a result of the wrong information given them by their athletic director, New Holstein finally arrived after 7 p.m. for what they believed was to be an 8 p.m. contest. The league commissioner ruled that Kewaskum should have won on a forfeit, but Kewaskum coach Perry Koth, Principal Clark Pearson and Athletic Director Dave Wietor relented and decided to give the Huskies a break by rescheduling the game as it would have been a crucial one for both teams who were tied at the time for the Eastern Wisconsin lead.

Kewaskum got to play Monday when they made the long trip to Two Rivers, where they lost a tough pitchers' duel, 1-0. Junior pitcher Jeff Geidel, an All-Scenic selection last year, was the tough luck victim again. Jeff has given up just eight hits in his last three games, but has lost all three of them. Ric Leitheiser got the Indians only hit and was one of only two Kewaskum base runners.

Tuesday the Indians traveled to Slinger for a Scenic game and the Owls gained revenge for two earlier losses to Kewaskum with a 10-3 win. The Owls hit Kewaskum pitching hard for the first time this season. Tim Heberer took the loss, allowing eight runs on seven hits in five innings. Brian Larsen came in to pitch the sixth when Severson hit a homer. The Indians only hits were singles by Scott Muench and Randy Heberer.

## 50 Years Ago

July 13, 1956

Postmaster Frank Heppe received notice on Saturday from the real estate manager of the Post Office Department that the lease for post office quarters for Kewaskum has been given to A.G. Koch Inc. The east portion of the Koch store building will be remodeled according to Post Office Department specifications and upon completion of alterations to the building, the post office will be moved there. The post office has been located in the present building owned by Postmaster and Mrs. Heppe on Main Street for the past 19 years.

Edwin Kreawald, age 62, Town of Auburn farmer, was found dead on July 11, about 1/4 of a mile west of his farm home. Kreawald was hauling hay and was pulling a load with a tractor when the vehicle ran off the road, through a ditch and into a marsh. It was not determined whether the man suffered a heart attack or dizzy spell, rendering him unconscious and causing the tractor to run off the road, or whether he died of head injuries he sustained when he was thrown from the machine.

The budget hearing for Joint School District No. 1 of the Village of Kewaskum, Towns of Barton and Wayne, all in Washington County, and Towns of Ashford and Auburn, Fond du Lac County, was held on July 9. It was moved by Marvin Martin and seconded by Walter Wesenberg to approve the tax levy of \$50,000.00 and recommend this figure to the electors for approval.

An outdoor phone booth made its first appearance in Kewaskum last week. The booth was set up on Fond du Lac Avenue on the northeast corner of the Vincent Motors used car lot.

Stephen Sekers of Milwaukee has leased the Republican Hotel and dining room and bar in Kewaskum from Mr. and Mrs. William Meredith. Sekers has moved into the hotel with his wife and family and took possession of the business last week.

## 75 Years Ago

July 10, 1931

Ralph Kohn, son of Mr. and Mrs. Frank Kohn, who graduated from the Federal Radio Institute about two years ago, returned home last Thursday from Tucson, Arizona. Ralph left for Tucson a little over a year ago, and has since then been employed as a technician over radio station KGAR.

The deer hunting season in Wisconsin was advanced nine days on Tuesday when Governor LaFollette signed

a measure introduced by Assemblyman Jerome Fox, Chilton. The 10 day season will open November 21.

A baby boy was born to Mr. and Mrs. Ben Volm of Kewaskum on Monday.

## 100 Years Ago

July 14, 1906

Joseph Eberle has leased the North Side Park from August Bilgo for a term of ten years. Mr. Eberle commenced work last Monday on erecting a new 50x80 foot dance hall and additional buildings

in the park. The new hall will have 500 square feet more of dancing space than the old one had. Mr. Eberle expects to have the hall completed in about a month.

Miss Adela Gottleben, who was with the party of young people from this village camping at Long Lake, met with quite a misfortune on last Wednesday afternoon by having her leg broke above the ankle while driving from Dundee to the lake. The accident happened while they were coming down a hill near Long Lake by the pole dropping out of the neckyoke, causing the wagon to run onto

the horses. One of the horses fell which probably avoided a worse runaway. Miss Gottleben received her injuries by jumping out of the rig. Lillie Schlosser and Lorinda Guth also jumped from the rig, but escaped with slight injuries.

The town board let the contract for building two bridge abutments to Opgenorth and Kohn last Saturday for \$550. One of the bridges is to be built at Bartelt's place south of the village and the other near Degner's place east of the village.

Phillip Meinhardt had his blacksmith shop raised and a stone wall built under it.

# Little folks open big doors to state of the art child care center

**KEWASKUM** Five years of cultivating the dream of bringing quality early learning services to the Village Kewaskum has come true for Dodie and Wayne Sargent. Formerly located in the Town of Wayne, Little Folks Schoolhouse Early Learning Center opened to their all-new state of the art facility on Wednesday, July 5.

Facility administrator Dodie Sargent, joined by her daughter, director, Jennifer Sargent, are excited to show off their new early learning center for the community's little folks. This is the only building constructed and designed for the sole purpose as a childcare facility in Washington County.

"We simply outgrew our building in Wayne. We also re-



ceiv- so that the staff can maintain a constant supervision at all times. Ordinarily, a teacher would need to take a child inside to the bathroom, which would decrease the staff-child ratio on the playground.

A lunch program is offered as a new service. The facility is equipped with a full-service kitchen with

warding to see their parents' confidence in allowing us to be an active part of their lives for so long," recounted Dodie. She remarked on how welcoming the community has been since they broke ground on the facility in late January. As a way to show appreciation to the community for their support, Little Folks School House has agreed to offer child care for families of Kewaskum Fire Fighters and Emergency Medical Technicians when they are called out.

An informal open house to get the community acquainted with their services is planned for Saturday, July 29. Advertisements will be placed in the Statesman and other publications. Watch for more details. Little Folks Schoolhouse accepts children ages six weeks to 12 years, full or part-time.

"We are a great center because our staff enjoys what they do. Our philosophy states we strive to form working partnerships with families. We respect parents' insights and concerns and want them to feel comfortable leaving their children in our care, knowing that they will be safe and nurtured as we help them to develop and grow," commented Jennifer.

There are current openings in the toddler (one-year-old) room. The preschool room (two-four year-olds) has limited openings, and the infant room has a waiting list.

Little Folks Schoolhouse is open from 6 a.m. to 5:30 p.m. Their new building is located at 1040 Milan Drive, north off

Dodie stated that she has plans to add to her staff of 14 dedicated childcare professionals as her enrollment keeps increasing. "We need to add three new teachers already, I suspect we'll be adding three more by the end of the year," she added.

Dodie says Little Folks School House sets itself apart in the childcare industry because all teachers are certified in early childhood, have degrees or are working to obtain them. The staff at Little Folks School House is constantly attending professional development seminars and workshops keeping abreast of the latest techniques in child care related issues.

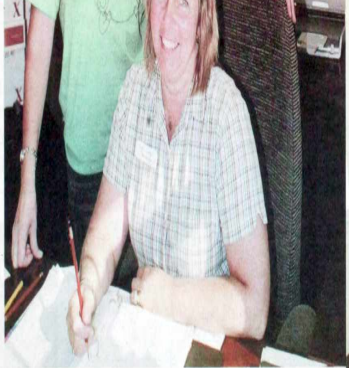
The new facility under-

went intense licensing with the state before the facility could open. At full capacity the center is licensed to have 84 students at any given time. In the 6,000 square foot facility, each age group now has their own classroom with a teacher and assistant. This enables Little Folks School House to have smaller classroom populations, thus giving the child more frequent one-on-one time with a teacher when it is needed.

Because the building was designed for the sole intent of operating as an early learning center, children are allowed to be placed in specific classrooms based on their learning style and their current development. The individual classrooms were designed to aid in the transitions children make when they go to kindergarten.

"This allows for teachers to scaffold on a student's prior knowledge and maximize it to future learning. We teach children concepts they can grasp, learn and retain," stated Jennifer.

Each toddler and pre-

of staff and children throughout the day.

A 1,000 square foot school-age classroom doubles as a large motor skills or sensory room where children will be able to use climbing equipment, tricycles and will be used as an indoor playground during inclement weather.

The center has two secured outdoor playgrounds. A small fenced area is for infants and toddlers. A larger area on the opposite side of the building is used for preschoolers and school-age children. The larger playground is equipped with an outdoor bathroom facility. Dodie states that the

The building also allows for better accommodations of special needs children. Construction was done in a manner to meet all criteria of the Americans with Disability Act (ADA). Dodie is also proud of the fact that a number of her teachers are fluent in sign language and are open to helping children with certain disabilities.

In addition to the services at their new building, Little Folks School House also offers before and after school care at Kewaskum, Wayne and Farmington Elementary Schools. This is available from 6 a.m. to the beginning of school and after school until 5:30 p.m.

A unique children's computer class is an elective for students at Little Folks School House. Dodie explained an independent computer instructor specializing in teaching children about computers comes in weekly and offers guided instruction to students.

"We maintain high standards of child guidance as it pertains to education and behavior. We as administra-

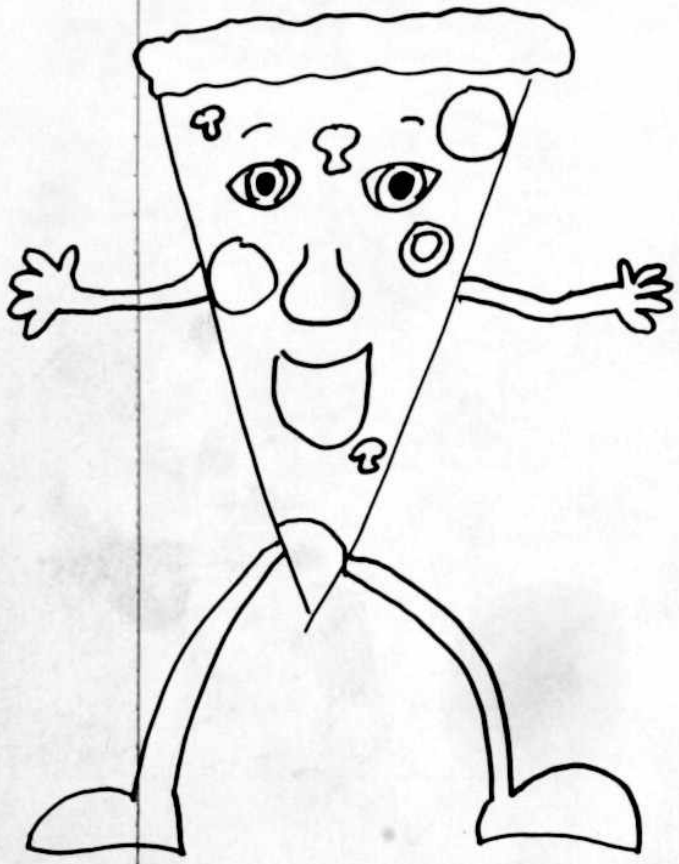

## Goeden moves up to number four Webster tripled his fun

A good year is starting to look even better for local sprint car driver, Donny Goeden, who moved into fourth place in the IRA (Interstate Racing Association) standings Saturday night after an excellent outing at the quarter-mile track in Wilmot.

Goeden currently has 1,314 points and is just one point behind Scotty Neitzel, the defending IRA champion.

Leading the way in the points standings is Mike Reinke, in the No. 92 car. He has 1,395, while Travis Whitney and his No. 9 mount have earned 1,355 points, and this four-way battle should make the rest of the year very exciting.

"We had fast time and finished fifth in the main ... We had a pretty good night," Goeden said Sunday, adding he piloted his No. 78 car to a third place in the heat race.

Goeden's time in qualifying was 13 and .533 seconds (13.533) after taking his qualifying laps "right in the middle" of Saturday's field. "They had 49 cars," he said, explaining when a driver is in this position, he normally watches to see where other racers appear to be moving well on the track.

Still, "The track changes the whole time. You've just got to hope you have the right setup," he said.

In the heat race he was assigned to, Goeden started sixth and finished third, with the top four transferring to the main event.

"We run 30 laps in the big

one. We started 10th in that," Goeden said, indicating he tried both the high and low grooves during the race and was able to move up to fifth by moving up one car at a time. "It was a good race ... but a couple guys went over."

Reinke, who is from Sheboygan, couldn't have picked a better time to win a feature. By doing so, he overtook Whitney for the points lead.

Neitzel had a bad night, according to Goeden, who said the 2005 champ was unable to transfer from his heat race because something broke on his car.

Goeden, who ran a limited number events a year ago, plans to make all the Wisconsin show this year (about 75 percent of the total number), and he is happy to have that opportunity. "It's fun racing with that club. It's fun to come back and run well."

Goeden said none of this would be possible without the generosity of the car owner, Bob Walldan of Winthrop Harbor, Ill. and without the dedication of his pit crew, led by his twin brother Dave, who is assisted by Terry Weber, Dean Wetzell, Brian Stern, Ralph Stern, Russ Borland, and three men from the Winthrop Harbor area, who work on the car during the week.

Goeden said he was also helped by Ross Krautkramer until recently when he had heart surgery. "He was there every night until then," Goeden said.

Most of Goeden's sponsors are from northern Illinois, but he is receiving sponsorship from one local business, the Grand Larsony.

"We won one (a feature) a couple weeks ago in Superior (May 26)," Goeden said, reporting, "At about 10 laps, I passed K.J. Skleton and Scott Neitzel" and stayed out front the rest of the way.

This coming Saturday, the IRA will make a stop at PowerCom Park in Beaver Dam. Qualifying starts at 6 p.m., and racing begins at 7 p.m.

One other Kewaskum driver is currently in the top ten. Scott Biertzer has scored 1,178 points with his 48 car, and is currently in the eighth spot overall.

Indians have more than enough runs

## KHS crushes Roncalli in pair of EWC games

Returning to their winning ways, the Kewaskum Indians blasted host Manitowoc Roncalli in a doubleheader held last Friday evening.

The Jets scored a single run in the bottom of the first game, then were shut out the rest of the way, first by Jon Roskopf and then by Matt Parrent, in respective 11-1 and 18-0 decisions.

Both games were shortened to just five innings because of the 10-run "mercy rule," according to KHS coach Dave Donath, who breathed a sigh of relief as his Indians tattooed the ball all over the Jets' home park after losing back-to-back decisions to New Holstein and Campbellsport.

With the two victories, the Indians improved to an impressive 22-3 overall. Against Eastern Wisconsin Conference foe, they are 18-2 and are already dusting off a spot in the trophy case for the school's first baseball title since 1992.

"Boy, I know there were a lot of hits," Donath said, reporting two of his starters, outfielder Jon Olla and second baseman Garrett Donath, went 4x6 in the two games (that only went a total of 10 innings.) "Olla had a home run in each game," Donath said, then with some coaxing from his son, added, "He (Olla) had a home run and a triple in the same inning," which he believed was the third inning of the nightcap.

Other hitting stars included Logan Staeger, who was 3x6, with four runs batted in (RBI), and Corey Torrison, who had four hits in seven trips to the plate with a pair of doubles and 3 RBI.

Donath said the junior Torrison started out as a designated hitter and has platooned with Jake Junk in right field and subbed at times for Casey Scheel at shortstop, when Scheel was having rotator cuff problems. "He's (Torrison) hitting in the .300s somewhere," the coach said.

Donath also reported freshman Nic Olla chipped in with two hits in the first game.

Roskopf allowed five hits in Game 1, according to Donath, who said, his ace did not strike anyone out in this game and only walked one.

The Kewaskum offense provided more than enough runs for Roskopf to pick up his eighth win of the season against one loss.

Parrent went the distance in Game 2, striking out three

and walking none. With this win, the big right-hander improved to 7-1.

In addition to the good pitching, the Indians played tough defense. "We turned a couple double plays, actually we had three of them," he said.

The Indian finished up in EWC play Monday, hosting Plymouth. The Indians will be at West Bend West tonight (Thursday) evening.

As expected, Kewaskum was selected as the top seed for the upcoming WIAA summer baseball sectional that will be held next week. "We (coaches) had the seeding meeting last night (Saturday), and we had the No. 1 seed," Donath said. "(West Bend) West was two ... East was three, Campbellsport is four. Slinger was five, Port Washington six, Ozaukee seven, Oostburg 8, Random Lake nine and Cedar Grove, Belgium 10."

There had been some discussion where West would end up after Paul Hoenecke of Kewaskum was declared ineligible by the WIAA recently because of guardianship and residence rules. All of the Spartans' victories had to be forfeited after the ruling was handed down by the WIAA, but the coaches still thought West deserved the second spot in the seeding lineup.

While Kewaskum appears to easily be the best team in the sectional, Donath points out, "Out of the ten teams, only one team is under .500,"

By virtue of their No. 1 seed, the Indians get a bye in the opening round. They will face the winner of the Oostburg/Random Lake game Tuesday, July 18 at Kiwanis Park in Kewaskum at 5:30 p.m.

If Kewaskum wins that game, it advances to the semifinals of the sectional at Regner Park in West Bend.

"It would be the early game (at noon)," Donath said, indicating the opponent will be the winner of the Slinger and Campbellsport game.

The other sectional semifinal will be held at 2:30 p.m. and the final game has a 5 p.m. start.

The winner advances to the WIAA state Summer Baseball Tournament at Bukolt Park in Stevens Point. First round games take place Wednesday, July 26.

"(We've got) as good a shot as anyone," Donath said, still warning, "With a couple mistakes, it (the dream) can disappear in a hurry."

Indians lose second straight game

## Early lead holds up for Campbellsport

Kewaskum had beaten Campbellsport twice this season in Eastern Wisconsin Conference baseball, but the Indians came up short in their bid to claim the season sweep, falling 4-2 to the host Cougars in a game played last Thursday.

The loss gives Kewaskum a 16-2 mark in EWC play, and the Indians are 20-3 overall.

The already-crowned conference champion Indians out-hit their counterparts nine to seven but left the bases loaded three times as they lost to Austin Backhause and his Cougars teammates.

We had our opportunities," KHS coach Dave Donath said, reporting his team left eight base runners stranded and commented, "They had eight left also."

Campbellsport wasted no time scoring, putting three runs on the board in the first inning and another single run in the second to take a 4-0 lead it would not relinquish.

"If it weren't for a looping liner in the first inning, they might not have scored," Donath said, reporting a ball hit just over third base had "a goofy spin on it," or Dan Shea might have caught the ball and, "We could have had a double play" because Campbellsport had the runner at first going."

As it turned out, the ball dropped, opening the gates for the three-run rally.

The Indians had threatened to score in the top half of the first when they loaded the bases with one out. "Matt Parrent hit a shot to the first baseman ... double play," Donath said.

KHS got its first run in the fourth on a triple by Ross Stockhausen, who wound up scoring on an infield out.

The Indians made it 4-2 in the top of the fifth, but there could have been a whole lot

more damage done. After Casey Scheel reached on an error, Jon Olla singled and Shea walked to load the bases. Stockhausen drove in Scheel with a sacrifice fly, but Backhaus would have no part of giving up any more runs as he got the next Indians to hit into a ground out.

In their last at bat, Kewaskum also had chances to score. Donath called on Corey Torrison to pinch bat, and he came through with a clutch double. Nick Whitty, who came on in relief of Backhaus for the seventh, got Scheel to fly out, then Olla got hit by a pitch, and Shea singled to put ducks on the pond.

Whitty, who had lost both previous efforts to KHS, had to face Stockhausen next, and Donath said it looked for a second like the hot grounder he hit was going to make it to the outfield, until the CHS shortstop, Austin Sarauer, came up with it, tagged second for the first out and threw to first to end the game.

"The shortstop made a nice play," Donath said. "There were three innings when we had the bases loaded with one out" and did not score.

Olla, Shea, Stockhausen and Logan Staeger all had two hits. Olla, Shea and Stockhausen bat Nos. 2, 3 and 4 in the Indians' order, and all have impressive batting averages.

"They've been doing it pretty much all year," Donath said, also noting his pitcher, John Holt, threw well enough to win. "He struggled a little bit, threw a lot of pitches, but yet, he threw well enough to win."

Even though the Indians have six times more wins than losses, Donath is a little bit concerned, especially considering the WIAA Summer Tournament is coming up starting the week of July 17.
