## Waukesha man accused of sex assault of Kewaskum teen girl

A 20-year-old musician from Waukesha is accused of having sexual intercourse with a 15-year-old Kewaskum girl. The two are believed to have met on the popular internet networking site, Myspace.

Randall Shesto has been charged with second degree sexual assault of a child in Sheboygan County Court. The charge is a class C felony.

WBKV radio reported Monday that the teen snuck out of her home to meet Shesto on Friday, January 12. Authorities were alerted to the assault after Shesto and the teen reportedly had sex and Shesto later crashed his vehicle.

From the accident, Shesto has received a citation for inattentive driving according to court records.

On Wednesday, January 24, Shesto was back in court for his preliminary hearing before Judge Timothy M. Van Akkeren.

Shesto is the lead singer of a band called Nailwounds.

## Cooperative strategy brings about new plan for wastewater treatment facility

**KEWASKUM-** Residents will have another opportunity to voice their concerns regarding revisions to a state-mandated facilities plan regarding this village's wastewater treatment facility. After paying for a second opinion, and a few meetings, the village board approved sending a revised, more economical facilities plan to the public at their January 22 meeting.

The new firm is not entirely responsible for the less expensive option however. The village's administrator, Jay Shambeau, stated that along the process, in conjunction with approving a comprehensive growth plan, village officials realized their population projections were a bit bloated.

Shambeau stated the original population estimates were based on significant growth in 2004-2005 and a perception that there was going to

be even greater growth ahead. After the numbers were officially changed, plans to retrofit the current wastewater treatment facility moved forward.

### Second opinion sought and well received

After a public hearing was held in August where residents expressed their distaste in spending \$10.9 million on a new facility proposed by Ruckert-Mielke, the board agreed to seek a second opinion using the less aggressive growth projection. In November the village board met with four engineering firms from around the state.

The board ultimately chose Graef, Anhalt, Schloemer and Associates of Milwaukee (GAS) to conduct a peer review of the original facilities plan written by Ruckert-Mielke. The cost for reviewing the existing facilities plan by GAS, cost taxpayers \$24,934.00. Originally, trustees thought they might pay as much as \$60,000 for a second opin-

ion.

At the January 8 village board meeting, GAS project manager, Dan Goetsch, presented his firm's amendments to the plan authored by Ruckert-Mielke. He reported that his company found the existing facility has its strengths and weaknesses.

The weaknesses the plant experiences are long duration of high volume peaks that go on three to five days. Goetsch also noted capacity concerns resulting in poor flow through the plant.

"The DNR is concerned with overall capacity, the primary clarifier and a lack of process control," he noted.

### Competitors working side-by-side to provide one plan

At a Public Works Committee meeting held Thursday, January 11, the two firms joined the committee

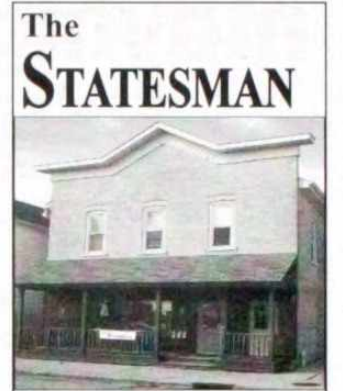

Project gets rocky start after \$90,000 change order reluctantly approved

## Pumphouse project is nearing completion

**KEWASKUM-** Good news was reported on the progress of Kewaskum's new pumphouse that is being constructed next to the fire station. Despite a \$90,000 change order that took place in August, the construction process has been a smooth one.

Director of Public Works Jerry Gilles says that great weather and cooperative neighbors have played a role in the speedy progress.

Construction on a new 16-inch forced main that runs from the new pumphouse to the wastewater treatment facility has moved forward with ease in part because of

the lack of frost in the ground. This spring, Gilles says pipe bursting of the current 10-inch forced main will occur. A new 10-inch plastic pipe will than be installed. Currently, the village has a six-inch and 10-inch forced main from the current pumphouse in Riverhill Park.

In August, the village reluctantly approved a \$90,000 change order for the project. The change order reflected the need to dewater the site at the pump station. Village engineer, Andy Petersen of Ruekert-Mielke stated the original request came from Staab, stating there was a change of site condition.

When Staab originally bid on the project, they were given specifications for bidding

purposes. Once they were awarded the contract, and came on scene, they did deeper soil borings and found water farther down. For safety of workers on site and to ensure longevity of the pumphouse, Staab wanted the site dewatered.

To dewater the site, Gilles says a well needed to be drilled and a pump rented to pump water from the site. That work has since been completed.

Trustee Kevin Scheunemann expressed concern over the change order due to the limited depth of bore holes conducted during the design phase. Trustee Harry Roecker concurred with Scheunemann but ultimately the pair was overridden.

According to Gilles, the

new pumps are in the basement, all piping is in and painting of the interior of the structure has begun. The motor control center is on order, and should arrive on time. The contractor is waiting for doors and windows for the structure.

Transitioning from the old pumphouse to the new could start as early as the end of April. The transition will proceed in two stages. The interceptor from the west will start first. The old station will then continue to pump the east side of the village. Both units will operate for a short period of time.

After the new pumphouse is fully operational, and the

old station is deactivated, the project to retrofit the former pumphouse into bathrooms for River Hill Park will commence.

The village borrowed an estimated \$3.4 million for the project. Those funds will come from a revenue anticipation note for a one-year term. In May of 2007, when notes come due for the TID, the village will lump the sums together.

The \$90,000 change order is being negotiated. Gilles reported that the village is asking for more documentation before payment will be released. After speaking with the contractor, he estimated that the end result would be 10 percent less.

## Timblin purchases outlet mall in Wausau

With the multitude of entertainment, shopping and sporting attractions, the Village is quickly becoming a destination for both in state and out of state visitors.

## Open enrollment begins Feb. 5

MADISON—The Wisconsin Department of Public Instruction has notified school districts that Feb. 5-23 is the statewide open enrollment period in which parents, who wish to choose the public school district their children will attend for the 2007-08 school year, must file open enrollment applications.

"Wisconsin is entering its 10th year of providing open enrollment," said State Superintendent Elizabeth Burmaster. "The program is one of many options our state offers to support parents' involvement in decisions affecting their children's education."

In Wisconsin, children are assigned to school districts based on the location of their parents' home. February's three-week application period for open enrollment is the only tuition-free opportunity for most parents to apply for their children to attend public school in a school district other than the one in which they live.

Under the full-time public school open enrollment program, parents must apply during the application period to the school district they wish their children to attend. Early and late applications are not accepted. Parents will be informed by April 6 whether their open enrollment applications have been approved or denied.

In most circumstances, transportation is the responsibility of the parent. However, some school districts may elect to provide partial transportation. Parents with questions about transportation should call both the resident and nonresident school district offices to find out if any transportation will be provided. Reimbursement of some transportation costs is available for low-income parents whose children are eligible for free or reduced-price lunches under the federal school lunch program.

The DPI provides the following guidelines for parents who wish to apply for open enrollment:

- Open enrollment deadlines are firm. Application forms must be submitted to the nonresident school district no earlier than Feb. 5 and no later than Feb. 23. Early and late applications will be returned. The forms are due in the nonresident school district no later than 4 p.m. on Feb. 23; a postmark will not meet the requirement.

Hand-delivery of application forms to the nonresident school district is strongly recommended.

- Parents may submit applications to no more than three nonresident school districts for each child during the open enrollment application period. Submitting more than three applications to nonresident school districts will result in all applications being invalidated.

- Forms must be filled out completely and accurately. Contact the local school district office or the DPI if assistance is needed in filling out the form. An inaccurate or incomplete form may result in denial of an application.

- Parents may request enrollment in a specific school or program in the nonresident school district; however, enrollment in the requested school or program is subject to space and other limitations and is not guaranteed.

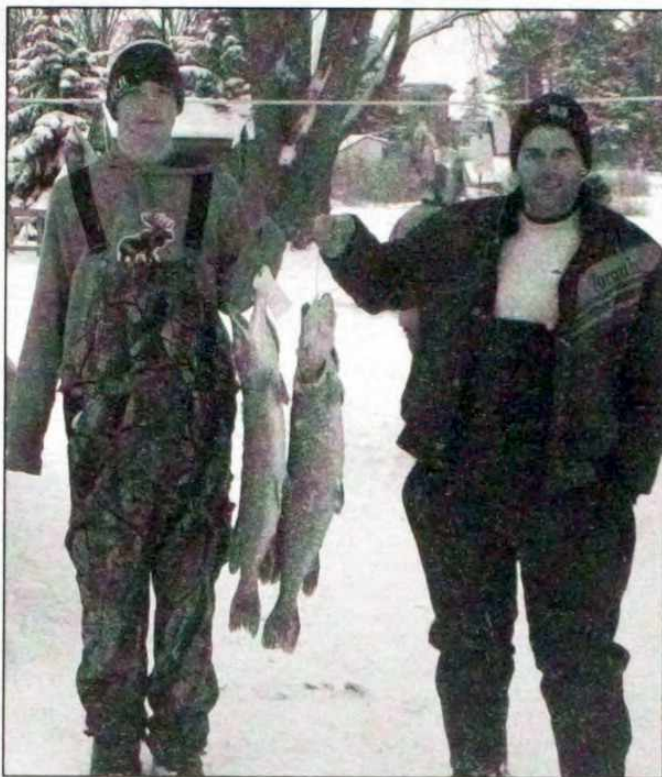
- Most students who attended a nonresident school district under open enrollment last year are not required to reapply for the 2007-08 school year. However, if the student will be entering middle school, junior high school, or high school in the 2007-08 school year, parents should call the nonresident school district to find out if reapplication will be required.

- Parents may apply for their children to attend 4-year-old kindergarten under open enrollment only if the resident school district also offers a 4-year-old kindergarten program for which the child is eligible.

Open enrollment application forms may be obtained from any public school district, from the Department of Public Instruction, or from the DPI's open enrollment website at <http://dpi.wi.gov/sms/psctoc.html>. To assist parents in submitting open enrollment applications, a directory of public school districts is available on the DPI website at <http://www.dpi.wisconsin.gov/schlrch3.aspx>. and ultimately were charged with coming up with a final revision to the original plan and presenting it to the DNR. Working separately, the two firms each came up with revised plans and then integrated the two plans into one.

On Monday, January 22, the combined plan was presented to village trustees. Goetsch said he wanted to see the village upgrade and expand the current plant through a phased improvement process. The process would essentially leave the plant in new condition and ready the plant for future upgrades if they are needed.

The retrofit would be started by the elimination of the plant's primary clarifier. That piece of equipment would be replaced with a headworks facility that removes grit and solids from flowage before it enters the plant. He pointed out that grit causes excessive wear on pumps and wastes tank capacity.

Upgrades would be addressed in the blower building to give a dedicated air source to the digesters and the sludge receiving tank. The existing air main would be used as a dedicated air source to the aeration tank.

Walls in the aeration tank would be extended to operate with a normal water level of one foot added above the current level. This measure would allow for additional treatment volume and allow the plant to treat higher flows. The new plan includes construction of a secondary clarifier to operate in tandem with the existing clarifier

and sized to handle flows beyond the design year 2026.

Updates would also take place in the sludge pumping building. A tank for receiving decant sludge would be constructed new or modified from a secondary clarifier. The Ultraviolet equipment would be relocated and expanded to add capacity for future growth. Electrical and computer systems would be upgraded throughout the plant as well.

The revised plan shows that the facility should handle 670,000 gallons daily. The facility is designed to handle a peak flow of 3.15 mgd (millions of gallons per day). The current average daily flow is at between 400,000 - 500,000 gallons per day.

The GAS/Ruekert-Mielke plan is designed to service the village until 2026 when the population is projected to increase to 5,200 people.

Environmental Engineer for the DNR, Judith Gottlieb, stated Tuesday that she has reviewed a draft from early January. "I have not seen the plan that is finalized and taken to the board," she reported.

Gottlieb stated that she accepts the new population figure, but is concerned with the method used to estimate peak flows in the amendment. She shared alternate values in a recent meeting with the Village and the engineers. "Those numbers are different enough to affect the proposal if not changed," she concluded.

Gottlieb will be present at the public hearing in March.

### Dollars and cents

The combined GAS/Ruekert-Mielke plan is projected to cost \$3,441,932. This includes all engineering and contingencies. Financial assistance is expected to be available from the Wisconsin Clean Water Fund. The fund provides long-term loans for eligible projects at or below market interest rates.

A typical residential household using 60,000 gallons of water annually, would pay approximately \$345 per year. This is more than likely to be increased in the future. The village also maintains a sewer impact fee that is charged to new developments. The village currently charges \$1,912.

All costs are dependent upon what the village charges for impact fees. The state impact fee law changed in 2006. The village must now pay its engineers to amend the needs assessment for all impact fees.

Shambeau stated that the current needs assessment does not include provisions for the retrofit at the wastewater treatment facility and that fee could see an increase. However, the water impact fee is expected to decrease. "We don't expect the combined impact fee to increase, but where money is appropriated will change," he stated.

Kewaskum's wastewater woes arose after flooding in 2004. Kewaskum, along with a significant number of municipalities, were forced to bypass overflows from the plant into the Milwaukee River. The DNR stepped in, and has forced the village to address

failures found in the facility before renewing a five-year discharge permit set to expire in 2009. The village has already addressed a number of these mandates.

The current facility was constructed in 1954 and received major renovations in 1972.

A December 31, 2006 deadline, set by the Department of Natural Resources (DNR) has already passed. Because the process is moving along, Judith Gottlieb from the DNR, has not made an issue of that deadline.

The public hearing is planned for Thursday, March 1 at 7 p.m. in the Municipal Building Annex on Fond du Lac Avenue. A copy of the revised facilities plan will be available for the public to review at the Village Hall and Kewaskum Public Library after February 1. The Statesman newspaper will also offer an electronic version of the document on its website as soon as it's available from Ruekert-Mielke.

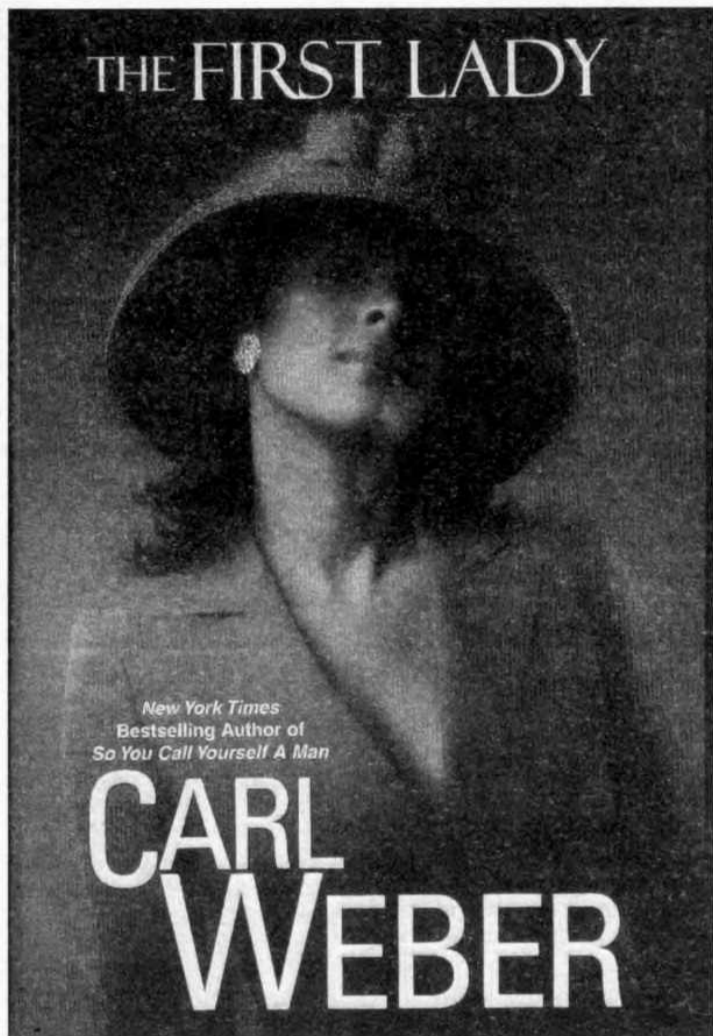
## The Bookworm Sez

### The First Lady

By Carl Weber

So are you sick to death of politics yet?

Sure, we're coming up on a big decision at the voting booth. There are a lot of good candidates for office and a lot of issues to be examined. Political ads will sprout on TV and radio like weeds in a vacant lot.

But, aside from the person who will fill the position of High Office, what about his spouse? Doesn't she count? In the new novel "The First Lady" by Carl Weber, she does indeed make a difference - even from beyond the grave.

Six months ago, when Charlene Wilson lay dying of cancer, she knew that her husband's future would be at stake. Bishop T.K. Wilson was the charismatic leader at First Jamaica Church in Queens, New York, and Charlene knew that the rumor mill would start to grind soon after her death. Members of the Church would practically demand a new First Lady, and Charlene had definite opinions on who her successor should be.

Marlene Hernandez was T.K.'s first love. They shared a daughter and they also shared a dark history of crack addiction and street life. Even when she was high, Marlene never stopped loving the Bishop and she wonders if she might have a future with T.K. again. That is, unless something cracks her fragile recovery.

Tongues wag when Monique Johnson walks in the doors of First Jamaica, and she knows it. Monique has lots of cleavage, short skirts, and wiggling hips but there's one thing she doesn't have: Bishop T.K. Wilson. When she seduces the

Bishop, it makes him pause in his search for a First Lady. It's a rather pregnant pause.

Savannah Dickens is thirty-something and unmarried but she's been preparing all her life to be someone's wife. Savannah lives with her father, a harsh and controlling Deacon of the Church. But Deacon Dickens can't control his daughter's love for something the Bishop offers.

Most members of First Jamaica think that Sister Lisa Mae Johnson is the heavy contender for First Lady. Lisa Mae agrees. She's the widow of Pastor Lee Jones and everyone knows that a woman with experience would be the best First Lady.

But then, the letters start to arrive....

Did you get enough for Christmas? If not, grab this new novel because opening a book by author Carl Weber is like opening a well-wrapped box of surprises: you never know what you're going to find amongst the paper.

I enjoyed getting to know each of the four "candidates" and I was pleased to see a few favorite characters from Weber's previous novels in this new one. I savored this book because of the way the story twists and unfolds, and because Weber's plots never give away secrets. In fact, "The First Lady" is going to keep you guessing until the Bishop makes his proposal, and beyond.

If you're sick to death of backstabbing politics and he-said-I-said debating, then turn off the radio, change channels and pick up this thoroughly enjoyable book. "The First Lady" is a first-class story.

## Tractor safety course offered

Does your son or daughter work on a farm during the summer? Do you hire a youth to work for you during the year? Do these young people have adequate safety training?

Accidents cause more deaths to individuals between the ages of 15 and 24 than all other causes combined. On the farm, the major cause of accidents is working with tractors and farm machinery. Most accidents happen when the operator does not know how to operate the tractor or machinery correctly or is unaware of the dangers involved.

To help reduce accidents, a Farm Tractor Safety Course is being sponsored by area High School Vocational Agriculture Departments and the University of Wisconsin Extension in Washington County. The course will be held on four Saturdays, February 10, February 24, March 3, and March 10 from 9 a.m. to 3:30 p.m. On Saturday, February 10 and February 24, the course will be held in Room 113 A and B of the Public Agency Center, 333 E. Washington St., West Bend. The March 3 session will be held at Slinger High School in room 205. The March 10 session will be held at the Addison Town Hall in Allenton. March 17 has been set aside as a snow date. The course includes instructions on understanding how to operate a tractor, with emphasis on safety. To complete the course, youth must attend all four sessions and pass a written and a driving exam. The course must be 24 hours to comply with federal and state requirements.

Federal law requires that youth under the age of 16 must be certified before being hired to work with tractors and tractor machinery. Effective May 1, 1996, state law mandated that no person may direct or permit a youth under 16 years of age to operate a farm tractor or self-propelled implement on a public road unless the youth has been certified as successfully completing a tractor and machinery certification course.

Prior to the law, only youth 14 or 15 years of age who operated tractors and equipment on a farm not owned by their parent or guardian were required to complete the safety course. Youth who drive a tractor for their parents may still do so without the formal training program as long as they do not operate on a public road. The law also does not apply to situations where a youth is driving a tractor and implement directly across (perpendicular to) a public road.

If you intend to hire any youth on your farm, make sure that they enroll in this course for your protection as well as theirs. There are penalties for not complying with the law. Also, some insurance companies have indicated that, technically, they can't cover an accident to an untrained youth.

Protect your child or the young person who works for you. Enroll them in the Farm Tractor Safety Course. State law mandates youth registered for the course must be the minimum age of 12 by the first session. The cost of the course is \$40 per student and limited to the first 25. To register, call the UW-Extension Office in West Bend at 262-335-4477, or toll free 1-800-616-0466, ext 4477 or 711 for Relay.

Parrent is honored as school's all-time leading scorer

## Indians battle hard but can't overcome unbeaten Jets

Just how good is the Roncalli boys basketball team? And what kind of a player is the Jets' leading scorer, Greg Schrimf?

Kewaskum coach Bobby Bannasch had nothing but praise for the Jets team and its talented 6-0 guard, who poured in 27 points and helped turn back a solid upset bid by the Indians.

Kewaskum played an excellent game Friday night but came up just short in the 61-53 decision.

With the win, Roncalli, currently rated No. 2 in the state among Division 3 teams, improved to 7-0 in the Eastern Wisconsin Conference, while Kewaskum slipped to 2-5 in EWC play and 2-8 overall.

"We played well ... they're obviously a good team," Bannasch said Sunday about the game, in which the Indians came back from a seven-point deficit after the first quarter, outscored the Jets in the second and fourth quarters and were only down by four points with just under three minutes to play.

"With about two and a half minutes left, we pulled to within four," Bannasch said, reporting he had the diamond press on at the time and the Indians had a Jet trapped in the corner of the back court. The whistle blew, and Bannasch was thinking perhaps the Indians had forced a jump ball, but a foul was called.

"It looked like it could go either way," the coach went on, noting Chris Wettstein went to the line for a one-and-one and converted both free throws. "If we could have gotten the ball back, we would have had a chance to pull within two points."

Kewaskum had three players in double figures, led

by Matt Parrent's 17 points. Junior John Holt chipped in with 15, then came guard Casey Scheel with ten.

When asked about his team's shooting, Bannasch said, "I think we played one of our best games of the season," with Parrent hitting four, 3-pointers.

Schrimf, who is probably the best player in the conference, put on a 3-point clinic, hitting a whopping seven shots from beyond the arc, and his brother, Mark, added one, and Cody Lassila canned three from long range.

"They're just a hard team to slow down. They're all excellent shooters," Bannasch said, indicating he tried a variety of defenses, including a man press, 2-3 zone, 1-3-1 zone and went back to the others before the game was over. "I think we did a good job of giving them different defensive looks, but they made the shots when they needed them."

Despite the fact his team did not get the win, Bannasch said this was "a moral victory for us ... especially after the Campbellsport game."

Parrent put on quite a show for the home fans after being honored for recently becoming the most prolific conference scorer in KHS history.

Concerning the date he passed Travis Kempf to become the school's all-time leading scorer, Bannasch said, "I believe it was the Kiel game (Jan. 4th), but we wanted to honor him at home."

Kempf had scored 873 in his three-year varsity career, and Parrent surpassed that mark and currently has scored over 900 points, giving him a good chance at being the first boy

from Kewaskum to reach 1,000 points.

Parrent, a 6-foot-4 post player, who has a good shooting touch, rebounds well and plays enthusiastically on the defensive end of the court, was presented with a basketball. "It was a special night," Bannasch said, noting, "We tried to bring Travis back home, but he had other obligations." Kempf is a junior at UW-Stevens Point and a starting pitcher on the Pointer baseball team.

Bannasch said Parrent's mother, Debbie, told him Friday night that Kempf wrote Matt a congratulatory E-mail recently.

Kewaskum is at Plymouth on Friday. "They're No. 2 in the conference," Bannasch said.

## Winter sports in county parks

The Washington County Park System is ready for another very active winter sports season. Cross-country skiing and ice skating are continuing to gain popularity; and, the free entrance to Washington County Parks has been very attractive. Most locations are served with toilets, plowed and lighted parking lots, and pay phones.

A lighted sled and toboggan hill is available at Ridge Run County Park in West Bend. A newly rebuilt and lighted sledding hill at Homestead Hollow County Park in Germantown has a run for adults and a smaller run for children as well as a new, lighted parking lot that provides better access.

Lighted ice skating is available at Ridge Run and Homestead Hollow County Parks, with unheated shelters available for skaters to put their skates on.

There is ice fishing available at Ridge Run and Henschke Hillside County Parks in West Bend, Glacier Hills County Park in Richfield, and Ackerman's Grove County Park on Highway Z in Polk. Park patrons are strongly urged to use common sense in judging proper ice conditions based on recent weather.

Cross-country skiers in West Bend and northern Washington County are encouraged to try Sandy Knoll County Park, just northeast of West Bend at Trenton Road and Wallace Lake Road. It has been growing in popularity. Its unique three-loop trail system allows for short, medium or longer outings on a scenic and not too difficult trail. Residents in Germantown and southern Washington County are urged to try

Homestead Hollow County Park at Freistadt Road and Merkel Drive in Germantown for an easy-to-moderate trail. All those seeking a more demanding cross-country ski trail should check out Glacier Hills County Park on Holy Hill Road at Friess Lake Drive in Richfield. Trails there are moderate to difficult. A heated warming room, flush toilets and water are available. Cross-country skiing is allowed on the southern portion of the Eisenbahn State Trail from Lighthouse Lane south to Rusco Drive.

Parking is available for those wishing to snowmobile on separate trails running through Glacier Hills and Sandy Knoll County Parks. Snowmobilers are allowed only on the northern portion of the Eisenbahn State Trail, beginning at Lighthouse Lane. ATV's are not allowed on the Washington County segment of the Eisenbahn State Trail. Anyone planning to use the Fond du Lac County portion of the trail should check with Fond du Lac County officials for their winter trail rules and regulations.

Heated shelters are available for public rental at Homestead Hollow County Park in Germantown, Glacier Hills County Park in Richfield, Sandy Knoll County Park near West Bend and Ackerman's Grove County Park on Highway Z in Polk.

Winter sports are available from 6 a.m. to 9 p.m. daily in Washington County Parks. For more information and free trail maps, please call 262-335-4445 or toll free 1-800-616-0446, ext. 4445.

A pair of wrestling teams from Washington County dominated the annual Waupun Invitational Saturday, with the Kewaskum Indians claiming the top spot with 213.5 points, 8.5 more than neighboring West Bend East (195.0).

Kewaskum had five athletes reach the finals, and four of them, Eric Ogi at 145 pounds, Cody Seibel at 160, Jake Turowski at 189 and P.J. Krueger at 215, came away as champions, while Andrew Haugen settled for a second place at 103 pounds.

Host Waupun, which is coming into the Eastern Wisconsin Conference beginning next fall, finished third at 170.5, then came Laconia at 148.5. The remainder of the field finished as follows: Markesan, 130.5; New Holstein, 114; Columbus, 105; New Berlin West, 89; and Mayville, 21.

"It is the third year in a row we have won it," KHS coach Dennis Aupperle beamed, pointing out Ogi and Turowski were repeat winners in the event.

Ogi pinned his first two opponents, David Valenza of Columbus in 1:23, then Vic Klapperich of New Holstein also in under two minutes (1:43).

Jeff Wild of New Berlin West was Ogi's opponent in the finals, and Ogi pretty well dominated, winning 7-2.

Turowski was a giant in the 189-pound weight class. After receiving a bye, he disposed of Waupun's Travis Core in 1:59, and then only needed 3:56 to polish off Sammi Toivonen of Markesan, meaning he only wrestled a total of 5:55 in his

two matches.

"He (Turowski) is closing in on 100 wins also," Aupperle said, referring, in part, to the fact Ogi hit that plateau on Jan. 9th against Two Rivers. "He (Turowski) should reach it in conference (the EWC meet on Feb. 3rd at Manitowoc Roncalli).

With their perfect days, Ogi climbed to 23-2, while Turowski is 21-4.

Another Indian who wrestled impressively was the sophomore Krueger, who went pin, pin, pin in his three matches to improve his record to 24-3.

Laconia's Erik Moon lasted 2:15 against Krueger, then Matt Lechler of New Holstein fought 2:51 before his shoulders were touching the mat, and in the finals, it was Krueger taking care of Dylan Quamme of Columbus in 2:27.

What really pleased Aupperle was seeing the freshman Seibel do so well.

"Cody Seibel wrestled very aggressively, pinning both of his kids," Aupperle said, looking at Seibel's day of work, which included a bye in the first round, a pin over Bob Bittner of Columbus in 1:47 in the semis and then a 3:06 fall over Markesan's Cody Friday of Markesan in the finals.

After Saturday, Seibel is 15-8 overall, which is pretty good considering he is at one of the higher weights, against many experienced wrestlers.

Haugen (16-6) started with a bye, then looked tough in the semis, pinning Tyler Lomibao in a swift 21 seconds.

In the finals, the tiny but muscular sophomore ran into a buzz saw in Juan Rodriguez of

Laconia, who beat him in a 20-4 tech fall.

To earn titles, thirds and fourths are also important, and the Indians got a handfull of them. Calob Olla (15-9) placed third at 112; "Bud" Kattar (16-8) took fourth at 119; Nathan Seitz (11-12) earned a fourth at 125; Mason Smith (17-9) took third at 140; and Matt Buker (3-4) took a third at 171.

"Calob Olla had an excellent day. He lost to the number-one ranked kid in D-3 (Division 3) from Laconia in the semis, but is really starting to come around," Aupperle said, referring to Olla's getting pinned by Ethan Pipping in :45.

Athletes who lost in the first round or the semis had to come through the wrestleback bracket in an effort to reach the bout to determine third and fourth places.

To claim third, Olla won by major decision over Mike Lefebber, 13-3, while Smith, who got pinned by Markesan's Ed Tuttle, the eventual champion, in the first round, then bounced back with several wins, including a final 11-3, major decision over Carl Cotter of Columbus for his third; and Buker topped New Holstein's Curtis Hallback by pin (:59) in the battle for third place.

Jeremy Parker picked up a couple team points for his seventh place, which featured a 3:27 pin over Kyle Davis of New Berlin West, while Mike Pfothenhauer (5-7) placed fifth at 152; and Tyler Swanson (11-12) pinned Kyle Gehrke of West Bend East in 4:39 for fifth at 285.

With the loss, the Indians fell to 0-8 in the EWC and 0-13 overall.

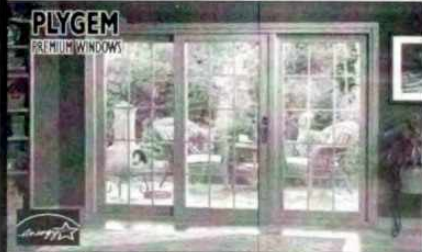
