Aerial ladder truck 1851: IN SERVICE



The Kewaskum Fire Department has taken delivery of their new aerial ladder fire truck. The truck arrived in Kewaskum on Thursday, June 11. The truck is a 2009 Pierce Dash, manufactured in Appleton with a Cummins ISM 500 Horse Power engine. It has a 105' aerial ladder, Hercules® Compressed-air foam system, waterous pump capable of 1,500 gallons per minute and has on board a 15kw hydraulic generator. The truck operates with a TAK-4 independent front suspension, side roll protection system, front/rear air bag system, LED warning lights, 12V FRC Optimum HID scene lights and 120/240V scene lights. The truck boasts a great deal of storage that includes full height compartments on both sides, under crew cab storage compartments, extraction compartment with hydraulic reels and tools. The extraction tools storage will come in handy as the truck will be dispatched to all motor vehicle crashes where the JAWS of Life may be used.

New soccer field possible for Indians

KEWASKUM- The Indians might be moving their soccer field in the fall season. Superintendent of Schools Michael Krumm has announced the District is negotiating with West Bend Clinic to lease land at the corner of Highway 45 and 28, next to their Kewaskum Clinic.

Earlier in the year the district was looking at spending close to \$600,000 to move the current soccer field to where the tennis courts are on the high school campus. The tennis courts were to move to the middle school campus. Krumm stated the DNR would not allow the move because of flood plain issue.

Krumm further stated the district also found that land they wished to use on the high school campus could not be disturbed because it is in a state cultural preservation due to it's history with the early Native American settlers of Kewaskum. Kewaskum was named after Chief Kewaskum of the Potawatomi Tribe that inhabited the village.

A plan to rehabilitate or move the high school tennis courts is on hold at this time.

Office rant turns into business for local men

KEWASKUM- Brett Favre's alleged attempt to join that rival team in purple has sparked a Biblical comparison and new business venture for a few local businessmen.

Joel Fleischman, president and owner of Campbellsport, Berlin, Kiel Building Supply, has started a Web site called Judasfavre.com selling T-shirts with the number 4 and player name of Judas.

"We got the idea when we were ranting at work and somebody said, 'He is no better than Judas Iscariot,'" Fleischman said. "Things went quickly from there. We ordered a customized jersey on-line and said, I bet this would be a great T-shirt."

Fleischman knows the sentiment isn't unanimous but thinks it's held by most.

"I understand some people don't care, some people still like Brett, but we believe the vast majority of Packer Fans feel like we do," he said. "We hope the site sells T-shirts yes, but we also hope it becomes a portal where disgruntled fans can post their Brett Favre merchandise for sale if they want, vent, or simply leave a comment for the masses."

Fleischman and Jason Strobel, both of Kewaskum, are running the site. Eric Vandermause of Kiel helped set it up.

So far orders have come from as far as Alabama. Fleischman expects more.

"Once he officially signs, we expect that this shirt will become a symbol for the army of fans that has

simply had enough," he said. "We are not blinded any more by athletes saying they did not take steroids, will retire a Packer, it is not about the money. The shirt is a symbol that us as fans are sick of being lied and manipulated. We know a traitor and betrayer when we see it. And this shirt says what we think."

Shirts cost \$14.99 each and come in green/gold or purple/yellow.

Regardless of Favre's uncertain future, fans may shop with confidence because the site says, "If Bretty does not sign with the Vikqueens you will receive guaranteed a 100% full refund back to your credit card for whatever you order!"

Shirts take four to five weeks to arrive. The site offers free shipping.

The site also sells No. 4 armbands in black to mourn the day Favre signs with the Vikings.

Anger, Fleischman said, is not directed at Favre just because he wants to play for another team.

"The reason he wants to play for Minnesota from what we understand is to 'get back' at the Packers. We believed in Brett for 16 years. He cried when he retired," he said. "He has been quoted saying, 'Play somewhere else. It will never happen. This is where my family is. This is where my heart is. This is where I belong.'"

"That quote used to give us goose bumps. Now we feel like we have a knife in our back as Packer fans," he said.

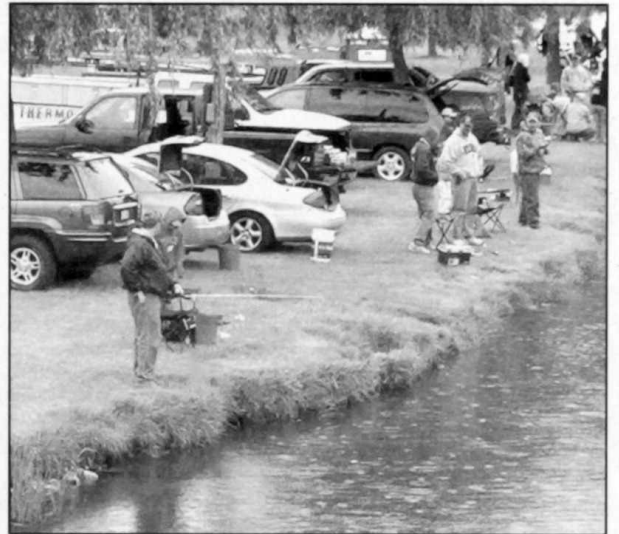

Amendment offered in school mascot bill legislation

MADISON— An amendment to the current legislation (Assembly Bill 35) banning mascot references to Native Americans was made public on Thursday, June 18.

The amendment comes from State Representative James Soletski who represents the Green Bay area.

The amendment extends the time frame for compliance by one to two years depending on the circumstances.

The bill has passed the Assembly Education Committee on a straight party-line

vote with the eight Democrats voting in favor of the bill and the five Republicans voting against it. The bill is now ready to be scheduled any time for a vote by the full State Assembly. For statewide networking purposes, the Committee Record is pasted below for your information as to the individuals and organizations supporting and opposing this bill.





Luedtke on fast track to racing career

BEECHWOOD - He was driving 70 mph before he even had his license, and someday Austin Luedtke hopes to be going much faster.

Luedtke, who turned 16 June 6, is in his third year racing at Slinger Super Speedway. It was an agonizing wait just to turn 14, the minimum age to race.

His parents, Rob and Kathy, took Austin to races as a child. He quickly got hooked.

"I would always ask my parents, 'How old do you have to be to do that?'" Austin said.

"The Ace," as he's now called, has loved the sport even more since he got into his first car.

"Just how much speed goes into it," he said. "How you have to be thinking every second, knowing your surroundings. It's just an awesome rush."

His mom gets a rush as well. She is more worried about street driving than racing.

"I'm not nervous at all," she said. "He's safer in this (race) car."

Austin's 2009 Ford Taurus with a 1984 Monte Carlo Chassis is equipped with a Hans device, a head and neck support that became popular after NASCAR legend Dale Earnhardt was killed in an accident from skull fractures. Earnhardt found the device too restrictive to use.

Austin's biggest safety device comes from above. A large sticker in his car reads "God is my co-pilot," and Austin has a talk with him before every race.

Austin always asks his crew chief for a moment of silence for about five minutes to pray for safety and fun for everyone.

Once the race starts, that crew chief, Matt "Deuce" Westphal holds Austin's safety in his hands from the spotter's box.

"He's your eyes around the track," Austin said. "We're always talking to each other. We kind of can read each other's minds."

Unfortunate luck has landed Austin in three mishaps the past three races. After a bad night, there's always next week. The goal is to bring the car back in one piece and score as many points as possible.

"Whatever the outcome is you've just got to be proud of what you did," he said.

In less than three years, Austin has advanced into the Midwest Sportsman series at Slinger against 26 racers, most who are double his age. But camaraderie is not a problem. "We get along together good," he said.

Austin's highest finish so far has been 11th and he leads in second for rookie of the year honors.

The next class up is Late Model, then Super Late Model - the class with Matt Kenseth and company.

Midwest Sportsman cars can have lap times of less than 13 seconds at the world's fastest quarter-mile oval. Higher classes, Austin said, have bigger motors and bigger tires. Super Late Model cars' lap times reach just more than 11 seconds.

There is no age limit to ad-

vance in classes.

"It's all preference and skill level," he said.

Rob hopes his son can get 2,000 laps this year and maybe jump to the super late model class in a year and a half. From there, it's anybody's guess.

"If the chance arises, I'd love to race in NASCAR someday," Austin said.

He doesn't have a favorite NASCAR driver, but he's got a good machine for practice. The car used to belong to James Swan, who won four Mid-American Championship titles and set the track record at the Milwaukee Mile.

Swan put an "easy" button in the car and would hit it every time he won a race. Austin hits it when fixing the car proves difficult.

The car has a Chevy 350 engine with about 485 horsepower. Races run 30 to 35 laps. On a good night, Austin said a race is over in six minutes.

But it's a long Sunday. Practice starts at 2:45 p.m., qualifying at 4:30 and racing at 6:30. Austin usually gets home late at night after all the races and meeting his fans. His biggest is his aunt, Lori Yogerst.

"It's fun to see the kinds come out with their parents like I did," he said. "My fans are my backbones ... along with my parents and family."

And his sponsors, who

help pay for his car.

"I'm grateful for my sponsors. Without them I wouldn't have the chance to do this," he said.

Rob said he's been blessed to have the financial ability to finance the ride, and gives credit to those who support the mission, especially Swan

and racers Brad Mueller and Lowell Bennett.

"It's a neat sport in that you get tied up with the right guys, they'll tell you everything they know," he said. "The support and everything else that's come out of it has been phenomenal."

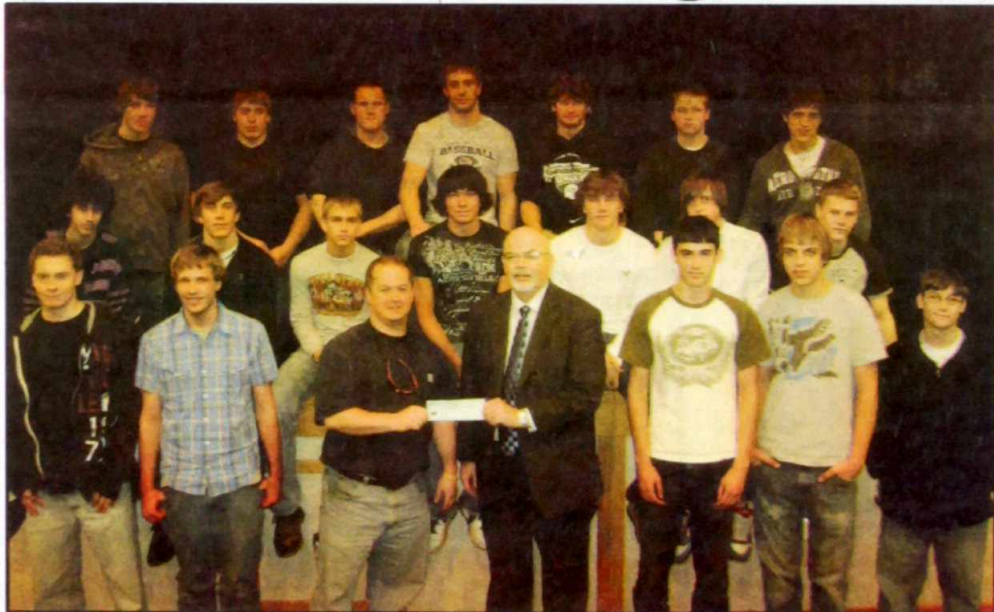

This piece of equipment will allow our students to explore the physical and chemical properties of plastic polymers as the students take them from a solid state, to a liquid, and back to a solid state." Moerchen further explained the lessons would be applied in two different courses, Metals Engineering and the Computer Aided Machining, both of which are worth college credit to Kewaskum High School Students.

With the plastics industry being as large as it is this type of donation can assist students in many ways. "Plastics are compounds that our students see, touch, and utilize every day of their lives and yet they have never really studied these compounds. With this type of course

work students will be able to incorporate more of the mathematics and science skills that they already possess and apply them towards practical engineering solutions," said Moerchen.

Because of the high school's Technology & Engineering lab the Computer Aided Machining students will be able to design and manufacture their own "mini-mold" in order to create a plastic product from scratch. "We have a great facility," said Moerchen; it allows our department to generate curiosity within the students and allows them to shine."

This department has also received inquiries from other school districts. Moerchen stated, "It's flattering to have other school districts, bigger school districts, visit Kewaskum High School to view the facilities in our department and marvel at the projects our students complete. To see the look on the visitor's faces tells me that we are challenging our students with current topics above what other school districts are attempting. This grant is another opportunity for our students to challenge themselves and explore the plastics career fields based on practical knowledge."

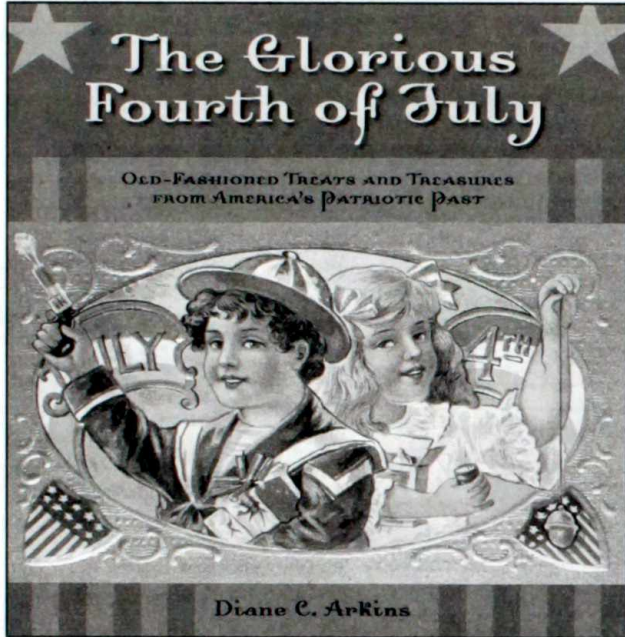
The Bookworm Sez

The Glorious Fourth of July

by Diane C. Arkins

Presents won't be necessary, but your presence is appreciated.

At this birthday celebration, there won't be many goodie bags, pony rides, magicians, or party favors. Ice cream might be nice, especially if you're having the party outdoors, and you'll want plenty of cold drinks on-hand. Birthday cake won't be necessary, but you'll definitely want candles of the Roman kind.

Before you get that party started, though, read the new book "The Glorious Fourth of July" by Diane C. Arkins, and find out how to have an old-fashioned red, white, and blue holiday celebration.

When we think about celebrating Independence Day, Arkins says, many of us automatically think about parades, picnics, and fireworks. While there are similarities, the Fourth of July a hundred to a hundred-fifty years ago was actually quite different than our modern celebrations.

First and possibly most importantly, fireworks are more regulated. Public displays of fireworks were an important part of the celebration then, but private stashes - loud, obnoxious, and dangerous firecrackers - were just as popular, which created controversy as well as injury.

"We all dread the coming of the Fourth of July now," said a commentator in 1854, referring to adults and firecrackers.

Safe and sane organizations were created in many cities in the early 1900s, and fireworks' use became more sensible.

Fourth of July in the nineteenth and early twentieth centuries almost always meant parades and community programs. Costumes were de rigueur, and no lady was seen without her crepe paper

outfit, particularly if she was having a party. And if she'd planned a little get-together, decorations and party favors were important (including the Jack Horner pie filled with candy and trinkets). Arkins includes recipes in this book, because celebrants expected nothing less than festively patriotic foods.

As for enjoying the Fourth, the New York Times had these wonderful (and still appropriate) suggestions in 1893: Don't apply hot and rebellious liquors to your blood, don't make bathing suit jokes, and don't hurry. You can do that any day.

And the Birthday Girl at this little party we're having soon? She'll be 233 years old this July 4th, so be sure to wave red, white, and blue when you wish her a Happy Birthday.

Jam-packed with old-time pictures, and postcard and memorabilia replications, "The Glorious Fourth of July" is one of those unique books that you can't stop paging through, especially if you like entertaining or pop-culture history.

Interspersed with the colorful pictures, author Diane C. Arkins offers explanations of the times and authentic articles, notes, and quotations from the past. Arkins says that it's too bad, in this age of high-technology, that ephemera (postcards, menus, invitations, and so on) aren't kept and passed down to other generations. As you savor the reproductions in this book, you'll agree.

Lovers of this most American of celebrations will enjoy this book, as will anyone who wants a patriotic look at social history. If Independence Day brings out the kid in you, pick up "The Glorious Fourth of July". It's a bang-up good read.
