## Village working on private fire hydrant issue

**VILLAGE of KEWASKUM-** Village staff is developing a draft of a hydrant flushing ordinance that mirrors that of River Falls, after residents on private drives complained their hydrant may not have been flushed for years.

An ordinance will be ready for discussion at a future Village Board meeting, but not for the next one on Oct. 5, said Mathew Heiser, village administrator.

Regardless, Nature Haven residents Jerry Stilb and Jim Verhalen asked to be on next week's agenda, Heiser said. The two came to the last board meeting to raise concerns over public safety.

While public hydrants in the village are flushed annually to clear out sediment and ensure they're working properly, private hydrant maintenance falls to private owners.

"If we're going to flush hydrants in the village it should be all hydrants," Stilb said. "My concern really is public safety."

Verhalen said hydrant flushing should be covered in the \$3,500 he paid in taxes last year.

"It just doesn't seem fair," he told the board.

Fire Chief Mark Groeschel said he didn't know any private hydrants weren't being flushed and said if his department ever tries to use a fire hydrant that doesn't work, the village and department would look "pretty bad."

In the event of a hydrant failure, the fire department would be required to bring in water like they do at rural fires or use another hydrant in the vicinity.

Public Works Director Jerry Gilles said the city of River Falls allows private developments to hire the city to flush its hydrants or hire another entity for the work. Private hydrant owners must submit certifi-

## Farmington changes its mind on hiring of Common Sense Foundation

**TOWN of FARMINGTON-** After the Plan Commission blasted the Town Board for hiring the Foundation for Common Sense to explain and alter its 2035 comprehensive plan, commission chair and town supervisor Art Seyfert decided to cancel the contract.

Seyfert said he will bring a motion to rescind the contract with the nonprofit group, the Foundation for Common Sense Inc., at the next Town Board meeting.

"I just took the advice of the people at the meeting," Seyfert said of the Sept. 22 Plan Commission meeting.

Instead, Seyfert suggests contacting the planner who helped create the town's land use plan years ago, Warren Utecht, a business banking coordinator with M&I in Appleton.

So far, Seyfert said the town has only paid for out-of-pocket travel expenses for Jay Verhulst, president of the Foundation for Common Sense, who lives in Arbor Vitae, Wis. The contract would cost a minimum of \$1,500.

Verhulst attended the last Plan Commission meeting to start work on the process of amending some of the town's plan to preserve land use rights, namely to replace "intergovernmental cooperation" with "coordination," a legal term that Verhulst says gives a town an equally ranking seat with other government entities in negotiations over land use.

He handed out a workbook with the definition of coordination and some court cases from other states using the term.

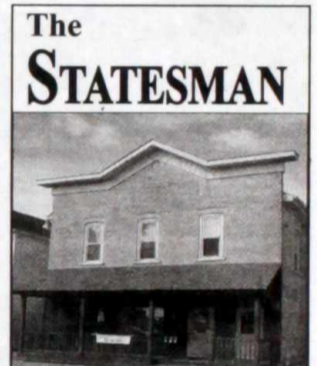

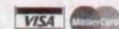

cates to the city showing the hydrant is flushed. Penalties ensue if the hydrants are not flushed.

Trustee Kevin Scheunemann liked that ordinance and understands what's at stake.

"There is a public safety issue," he said.

Gilles said according to the state's Public Service Commission, water utilities are not responsible for private hydrants, but they may have ordinances offering to do the work for a charge.

Even if the village had a similar ordinance to that of River Falls, it would not apply to the Nature Havens issue. According to the developer's agreement, while the water and sanitary sewer are to be dedicated to the village and become a "public" infrastructure, the streets are to remain private which would require easements for the village to legally enter the property to flush the hydrants. Those easements have not been completed, Gilles said.

The issue is playing out in a similar fashion to the great garbage debate of '08 in which residents on private drives

complained that some of their garbage was being picked up and others' was not, yet they all paid taxes that covers public street garbage pickup. The village ended up developing a blanket garbage policy differentiating between public and private drives.

After Verhulst completed his portion, the meeting quickly turned into a contentious debate over the credibility of Verhulst and hiring the foundation in the first place. The commission disagreed with the Town Board's decision and said it would rather use planners in answering questions about the 2035 plan.

Commission member Brian Bausch cited a statement from Wisconsin Towns Association Executive Director Rick Stadelman, who said the idea of coordination is "silly" and a "waste of time." The Towns Association attorney and a University of Wisconsin planner are against the

"That's why we're against this," Bausch said.

Commission member Diana Susen said she wants to take Stadelman's advice. She said the appropriate person to work with is a planner, "not an outsider."

Debora Sielski, deputy administrator for the county's Planning and Parks Department, warned that the plan in its present form meets all state requirements. If the town changes it, she suggested sending it to the Department of Administration for approval before adopting it. The state's deadline for municipalities to approve their plans is Dec. 31.

Sielski said she and Nancy Anderson, a chief county assistant planner with the Southeast Wisconsin Regional Planning Commission, would be willing to answer any questions the town has about the plan for free. Joshua Glass, a planner with the Washington County Planning and Parks Department, offered help as well.

Verhulst said they could all come to the meetings and comment as audience members while the town works on the plan.

Seyfert and Town Chairman Gary Schreiber, who voted to hire Verhulst, said they wanted someone to explain the plan to them in ways they can understand. Seyfert warned that the entire plan is an ordinance once adopted, and he wants to make sure he understands what he is voting on.

Schreiber said he wanted Verhulst so "I can understand this (plan) to the best of my ability." He doesn't want this board to be on the hook years from now when a town resi-

dent has a land use issue that derived from the 2035 plan.

Bausch said he agrees with Schreiber in principle but not on the choice of who to help translate the plan.

"I just don't see the academic credentials to do this," he said of Verhulst.

Verhulst is not a lawyer and does not have a planning degree, but the foundation's board has a lawyer who has had success out west invoking coordination. Verhulst said he reaps no financial benefit from his work.

The next Town Board meeting is slated for 7 p.m., Oct. 13.

I am attempting to locate the relatives of the 800 plus military personnel from Wisconsin who were killed (Killed in Action - KIA or MIA - Missing in Action or body not recovered) during the Korean War or died from Non-Hostile causes anywhere in the world during the period of June 25, 1950 to January 1955 or the current date for anyone Killed in Action.

The American Battle Monuments Commission (ABMC), Arlington, VA, has a website ([www.abmc.gov](http://www.abmc.gov)) that has a one page print out on those who were killed or died during the Korean War. The information is sometimes incomplete and a photo is also lacking if a relative or someone does not provide it.

As an Air Force veteran of the "Forgotten Victory," having served there in 1952-1953, I hope that with your help, we can be certain that all information is correct and a photo provided to the ABMC for those from Wisconsin who gave the supreme sacrifice. Your knowledge on anyone from Wisconsin, not just this community or county, would be appreciated.

A Matter of Public Safety...

During the week of 10-14 August, 2009, the Village of Kewaskum Water Utility, under the responsibility and direction of the DPW Director, conducted the annual hydrant exercising and water main flushing to ensure sediment removal and proper valve functioning.

Excluded, however, from this important maintenance

procedure, were the 32 hydrants located on private streets or drives. It should be noted that while these 32 hydrants have never been included in this annual exercise, the residents impacted by the location of the hydrants, pay for its cost on their quarterly water utility invoices.

Not maintaining all hydrants, not informing the public of this exclusion, and not notifying the Village Fire Chief of this fact, has compromised the safety of these residents, and the safety of the Fire Department members who are responsible for the activation of all hydrants in their role as firefighters.

Now the Village has further compounded these shortcomings by not taking immediate action to have the Water Utility flush the remaining hydrants,

thereby continuing to jeopardize the safety of its residents.

Applying common sense to safety issues should always prevail. Initially, this maintenance should have been conducted by the utility on all hydrants, and continued annually, thereby avoided the now compromised situations.

This is not about public vs. private locations, easements or intentions, it is about one thing, safety and lives...ours, our spouses, our children/grandchildren, our parents, our grandparents, our pets. The Village should act responsibly and ensure the safety of all residents in Kewaskum.

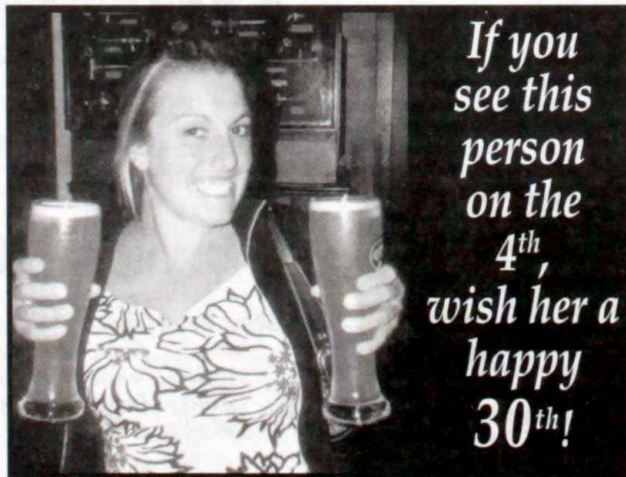

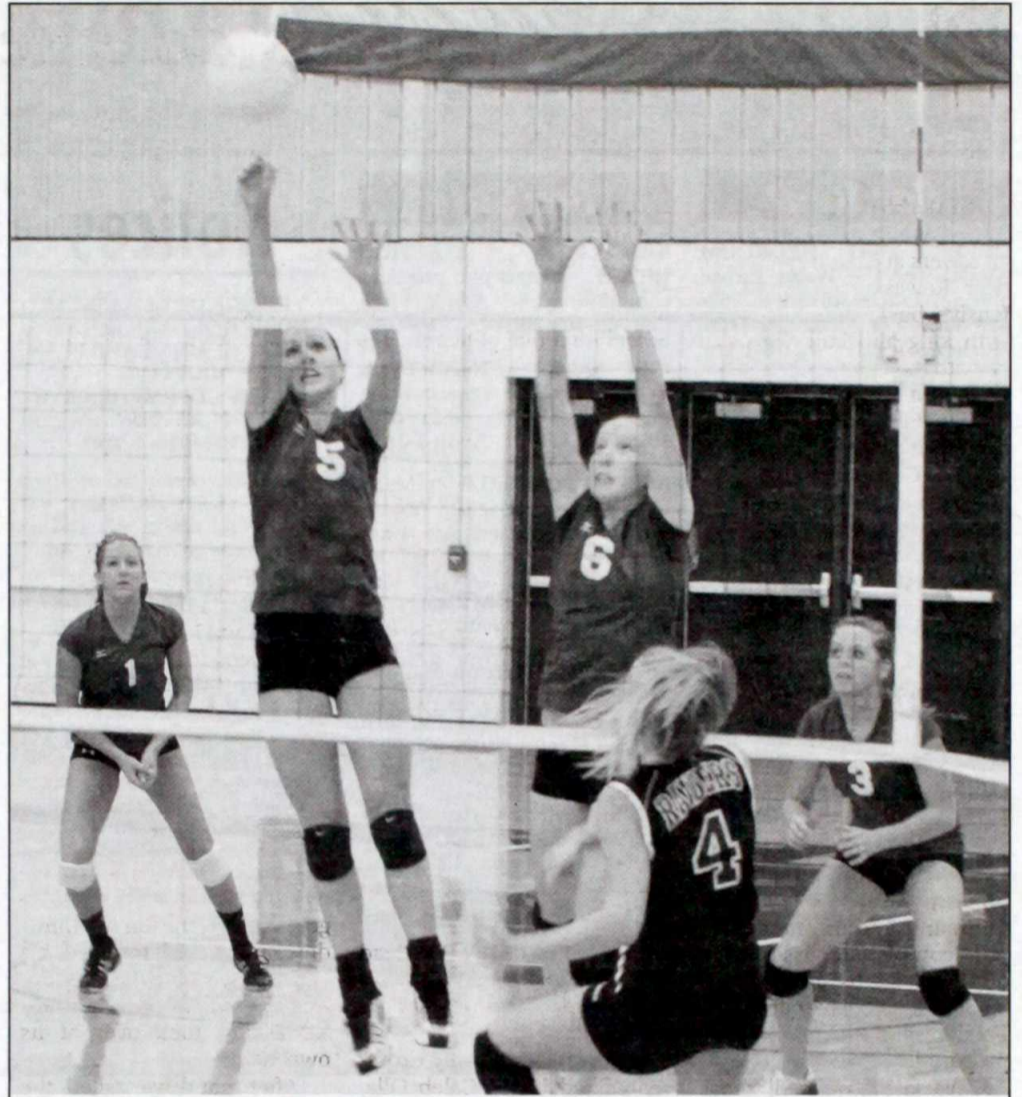
Rauch had six aces on 19 serves and five digs. Elissa Miller had 10 kills. Erika Heberer had 15 assists and Ashley Faber seven.

While the other teams were in Grafton, the fifth grade Indians were in Brookfield to play Brookfield East White. What a thriller the game was, with the only TD coming in the third quarter, giving Kewaskum (2-1) a 6-0 victory.

"Kyle Pamperin scored on a 92-yard scamper," coach Mark Walcheske said, reporting, "They had us pinned down on the 8-yard line on a third-and six" when Pamperin broke free around the end. "He got a nice block from Nick Ellenbecker, got around the corner and turned on the afterburners."

The defense was up to the

challenge. "They shut down Brookfield pretty much," Walcheske said, citing defensive end Brady Hanson for leading the charge. The Indians put a lot of pressure on Brookfield's quarterback, and while the hosts were able to move the football, drives were stalled by penalties.

The eighth graders (0-3) were down 8-0 at half, thanks to a miscue on a punt, but the roof caved in on them the rest of the way as they lost 32-0.

## Dbacks anchor Indians' defense for fifth straight win

**KEWASKUM-** At 6 feet, 3 inches, Waupun's Austin Armga towers at least three inches over Kewaskum's tallest defensive back, and he comes with long and lanky arms to go with it.

But it was the second-ary last Friday that stood tall against one of the Eastern Wisconsin Conference's (EWC) top receivers in keying a 22-7 home win in the rain.

Three different defensive backs made three acrobatic interceptions - another nearly came up with a fourth - forced some sacks through tight coverage and held Armga to 53 yards on four catches. Through two conference games, he had seven catches for 201 yards and nearly a 29-yard average per catch.

"They did an outstanding job. Great coverage, a lot of breakups," said Coach Jason Piittmann. The only time Waupun completed passes were on "breakdowns," he said.

Senior defensive back Cody Lemke said his team came prepared.

"We knew most of those plays," he said. "We keyed on Armga - number 12 - the whole game."

All-conference running back Cody Seibel had his third straight 100-yard game, rushing 19 times for 115 yards and two touchdowns, and Kewaskum moved to 3-0 in the conference and 5-0 overall. The Indians are tied with Plymouth for the top spot in the EWC.

Warrior quarterback Cody Nickel was held to 7-18 passing for 82 yards. The combination of Kewaskum's rush and blanketing coverage had Nickel scrambling much of the night. While the passing game didn't work well, Matt Kolitz gashed the middle of the Indians' defense for 129 yards on 21 carries often keeping drives alive.

The Indians' offense hit the snooze button in the first quarter for the third straight game, with two three-and-outs and a lost fumble, but this time rolled out of bed well before halftime.

The Warriors took a 7-0 lead on a 53-yard drive that nearly ended in a turnover. What looked to be an option pitch from the Kewaskum 8 was ruled an incomplete pass. Quarterback Cory Nickel took advantage of the break a play later, hitting Jordan White in the middle of the end zone. With 10:56 in the half, the Indians were scored on first for the third straight game.

This time, they instantly answered. Speedster Brandon Zolp returned the kickoff 22 yards to the Indian 40, and

all-conference running back Cody Seibel went to work, getting the ball on four of the next five plays. It was eight yards up the middle, another eight going left and three more up the middle on another controversial play. Seibel hit a pile of teammates and defenders that momentarily stopped his forward progress. But he quickly broke left out of the pile to a wide open field, only to have the play stopped by a whistle as officials ruled Seibel's quick stoppage ended the play.

No problem. On the next play, third and two, Kewaskum tried a run left and Seibel didn't stop this time until he sped 36 yards to the end zone.

"It was supposed to be a double iso. (isolation) up the middle," he said. He broke it left when he found a "hole." The hole consisted of enough open field on which to park a convoy of semis, and Seibel blew by any defenders in range.

Kewaskum took the lead on the point after attempt on a busted play that almost looked designed.

Backup kicker Tony Crossman filled in for Caleb Olla, who got hurt in a soccer tournament. The snap was a little high and skidded through the holder's hands past Crossman. A halfback by nature, the junior scooped up the ball and began running right.

And he just kept running. The right side was sealed off like a designed sweep and Crossman trotted in for a 2-point conversion. Kewaskum had the lead less than halfway through the second quarter and didn't look back.

The Indians' defense held the Warriors to three and out on the next possession, keyed by a 12-yard Matt Ballard sack on third and four.

From their 45, Seibel ran for eight and Cody Nuernberg hit Jordan Blank for 24 yards on a catch and run down the right sideline. Nuernberg took it the final 23 yards on an option right, shaking one defender and outrunning another.

"He did a much better job running the option," Piittmann said of his quarterback.

This time, the special teams unit opted for the more conventional - yet much less entertaining - point after as Crossman booted it in down the middle. It was 15-7 with 6:45 left in the half.

The Warriors began a drive of their own to respond. Armga outjumped a double team for a 26-yard catch on the drive.

From Kewaskum's 44, Nickel threw a rainbow to the right side and Indian defensive back Steven Chapman jumped to tip the ball. Lemke had raced over, snagged the ball and stayed in bounds to end the

drive at Kewaskum's 16.

"I saw the ball go up and I had a feeling it would be tipped," he said.

A blocked punt in the third quarter had the Warriors in scoring position at the Kewaskum 28. On third and five from the 10, defensive back T.J. Schlice knocked down a jump ball, and Waupun missed a field goal on fourth down.

Later in the third quarter, the Warriors again threatened after Seibel nearly had a second punt blocked. He tried to run around the rush but was tackled for a five-yard loss on fourth and 11.

On second and 16 from the Kewaskum 41, Kudek perfectly timed another play. Standing behind a receiver, he jumped and went over the top to knock down the ball the instant it arrived.

Not to be outdone, defensive back C.J. Bowe did one better on the next play. Bowe got his fingertips on the third-down pass and touched his toes barely inside the left sideline as he fell out of bounds. Kewaskum took over at its own 30.

After that drive stalled, the Indians got off a clean punt. Blank and Toles combined to sack Nickel for no gain on third and 14, and then the Warriors had their own punting problems. The snap sailed over the punter's head and he recovered it on the six.

Seibel went left off tackle for his second score and with 8:12 to play the Indians went up 22-7.

On the second-last play of the game, Indian defensive back Steven Chapman gave the fans their money's worth.

Nickel tossed a ball across the middle and Schlice tipped it in the air. Several players got their hands on the wet ball as they actually looked like they were playing hot potato. Maybe two seconds later after what seemed to be days, Chapman took the ball out of the air around his own 40 yard line and began to run.

On a play that would invoke ESPN's Chris Berman to recite his famous "rumblin' bumblin', stumblin'" call and seemed to move in slow motion, Chapman dodged defenders, followed his blocks, changed directions several times and used the entire field to twist, turn and plow his way toward the end zone as the crowd grew louder in anticipation. He was finally brought down at the six.

"I was a little tired after that," Chapman said after the game, still huffing and puffing. "T.J. made a great play and tipped it around. I turned around - green jerseys everywhere."

It was the second straight

game Chapman picked off a pass late in the fourth quarter. On Sept. 21, Chapman intercepted a pass with eight minutes to play and the Indians up 14-7 on Campbellsport that helped seal the game.

While Kewaskum can close games, Piittmann and friends are still trying to figure out how to open them.

"That's the mystery question right now," Piittmann said.

"It's just mental preparation," Seibel said. "We've got to get more fired up and run our plays right."

### NOTES

Nickel went out for one play with a knee problem after Seibel blew through the line and nailed him for a three-yard loss. Ballard, Blank and Mat Toles greeted Nickel's replacement by instantly greeting him with a two-yard loss.

While Crossman took care of the extra points, Nuernberg did the kickoffs. Both impressed, with accurate and long and deep kicks.

Zolp was held to 10 yards on six punt returns, including one fair catch. He has one punt return for a touchdown this season and has often put the Indians in good field position with 30-yard-plus returns.

Zolp, who had two catches last week, both for touchdowns, was held without a catch against Waupun. But he almost had an interception in the fourth quarter in diving to his left to corral a low ball. Officials called it incomplete.

The rain stopped at halftime and didn't return, but the damage was done. Local media and the Indians' statisticians relegated themselves to the press box or just outside its door, fearing Mother Nature would soak them if they dared return to the field.

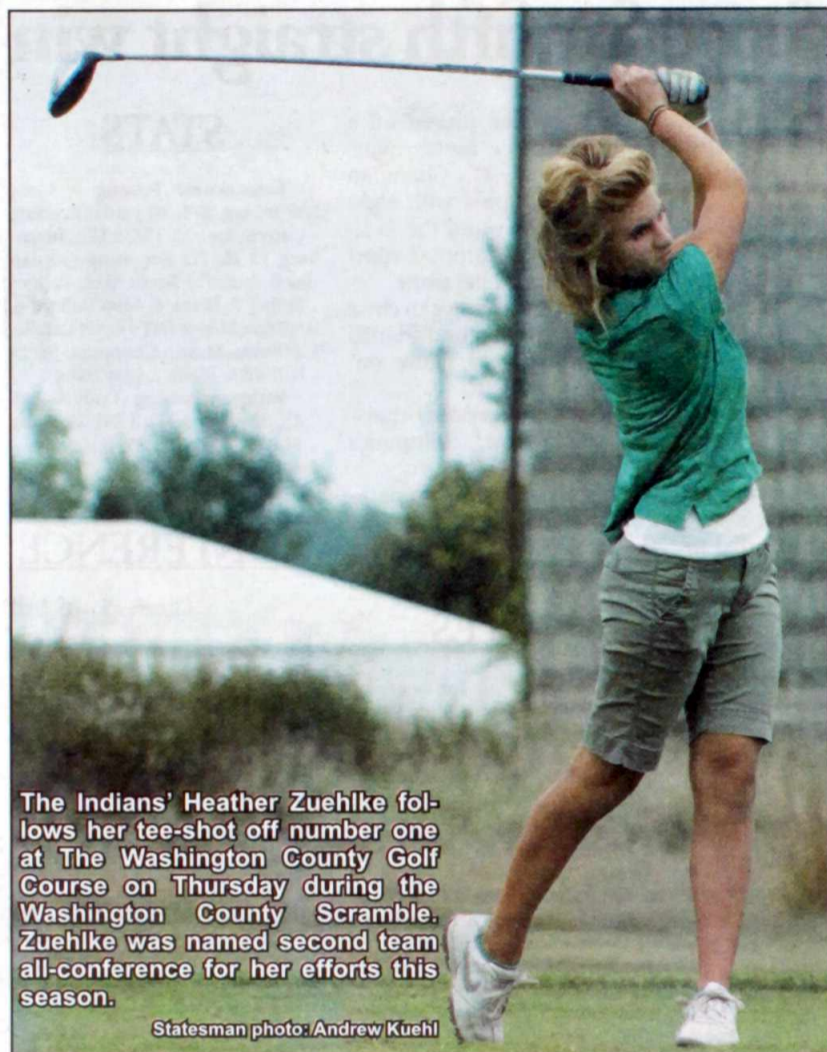
