## District lays off six teachers

**KEWASKUM-** For the first time in at least a decade the Kewaskum School District has laid off teachers to help balance its budget.

On Monday, the School Board approved six teachers be laid off, in addition to other staffing reductions through non-renewals and attrition for a savings of \$599,000.

One of the six, elementary school teacher Heather Collien, pleaded her case with the board.

"What are some ways we as a school district have been able to take some of the budget cuts instead of staff reduction right away?" she said. Board member Jim Leister said the decision is in response to the contract negotiations, which are in mediation.

"This is, more or less, the option you told us to go with - your representation," he said. "Your represen-

tation came to us and that's what they wanted."

It's not exactly what Collien wanted.

"Our union reps aren't the ones who are lower on the totem pole," she said. "It's not a full representation of those losing their jobs."

Leister also cited declining enrollment as one factor. The district has 40 less students this year and is expected to be down another 10 to 20 next year.

Board member Mary Miller said "We have to justify the budget to the people in the community, the people in the district."

Collien said she came to Kewaskum because "it was a district that put kids first" but questions that given the layoff. She still likes working in the district.

"I love my job and I don't want to lose it," she said. She stayed for the entire meeting and left in tears.

Board member Bruce Braidigan was sympathetic.

"In the best interest of the school district we have to make decisions and they're hard decisions. We don't like making them," he said.

The board got its first look at the working 2010-11 budget that at one point carried a \$620,000 shortfall. Administration looked for reductions and "unfortunately, staffing was the main area we came up with," said Paul Reichert, district business manager.

"It's not an easy thing to do ... but this is in the best interest of the school district," he said.

The six include two middle school and two elementary school classroom teachers each, a high

## Crash kills woman

**TOWN OF AUBURN-** A Milwaukee woman lost her life after being involved in a two-vehicle crash on Friday, April 9, at 6:14 p.m. Authorities suspect the deceased was driving drunk.

Deputies from the Fond du Lac County Sheriff's Office responded along with the Kewaskum Fire Department and Ambulance to the crash on County Road G, one tenth of a mile north of Dietrich Drive.

The investigation revealed a vehicle driven by Faith R. Krueger, 46, of Milwaukee was traveling north on County Road G when authorities suspect she failed to negotiate a curve and traveled on to the shoulder of the road. It's believed she over corrected and the vehicle then slid sideways across the highway and into the path of an oncoming southbound vehicle.

That southbound vehicle was driven by Terri L. Phelps, 43, of Campbellsport.

Sergeant Ryan Waldschmidt of the Fond du Lac County Sheriff's Office reported that Krueger was under the influence of alcohol and believed to have played a role in the crash. He also reported she was trapped in her vehicle and died at the scene as a result of her injuries.

Phelps sustained numerous injuries and was transported to St. Joseph's Hospital in West Bend for treatment.

The crash remains under investigation by the Fond du Lac County Sheriff's Office.

A Mauthe Lake Ranger also assisted at the scene.

## Kewaskum Indians, but for how long?



Wisconsin State Senators have approved a bill that could pose hefty fines for school districts that don't drop their mascots with Native American themes. However, its been reported that schools can keep their names if they prove their mascots are not promoting discrimination. Otherwise keeping the names could cost the districts as much as \$1,000 each day the name is used. Kewaskum's representative to the Senate, Glenn Grothman has remained opposed to the legislation since it was introduced over a decade ago while he was a member of the state assembly. The bill would require a district resident to make a formal complaint to the State Superintendent. The school district could continue to use the nickname only if it showed in a hearing that the name does not promote discrimination. The senate bill is similar to the bill passed by the state assembly earlier in the year. The two bills will now need to be identical and approved by both the senate and assembly before Governor Doyle could sign it into law.

## Letter carriers to collect food for pantries

school math teacher and a elementary physical education teacher.

The motion to lay off the six teachers passed, 5-0. Board president John Kenworthy was absent and excused and Miller abstained.

The district is cutting a total of 7.67 staff members and adding one, a middle school Spanish teacher. Besides the six layoffs, an elementary reading specialist resigned and is not being replaced and a 0.67 high school family and consumer education teacher's contract is not being renewed.

Beyond that, another \$153,000 is being saved through eliminating a payroll secretary, reducing paraprofessional staffing and retirements of a teacher and maintenance employee that will

result in paying less salary/wages and benefits to the replacements.

Reichert said after the meeting he has never seen layoffs to balance the budget in the 10 years he has been with the district, but he remembers one year when 10 teachers resigned or retired and weren't replaced.

The budget, which must be approved by the end of June, now stands at a balanced \$25,864,834. The general fund is slated to be \$20,898,462 with a tax levy of \$9,487,133.

The budget takes into account the 2005 referendum has run out. It called for spending an additional \$430,000 per year for five years on technology and textbooks. That is helping drive down the mill rate, now estimated to be

\$8.48 per \$1,000 of equalized value, down from this year's \$8.66.

Should the mill rate estimate hold, the owner of a \$150,000 home would pay \$1,272 in school taxes.

## Tornado and Severe Weather Awareness Week April 19-23

WEST BEND - Gov. Jim Doyle has proclaimed April 19-23, 2010 as Tornado and Severe Weather Awareness Week in Wisconsin. This awareness campaign is launched every year in April to remind people of the dangers associated with tornadoes, thunderstorms, flooding and hail and to encourage citizens to educate themselves regarding protective safety measures.

The Washington County Office of Emergency Management, along with Wisconsin Emergency Management (WEM) and the National Weather Service (NWS), are once again promoting Wisconsin's Tornado and Severe Weather Awareness Week. WEM has sent out a press packet to all state media containing background information. Additional information can be found on the WEM website: <http://emergencymanagement.wi.gov> or

On Thursday April 22nd, Washington County will participate in the statewide tornado drill. The drill tests the notification procedures that take place during a severe weather event. Various types of watches/warnings are issued by the NWS and disseminated to local dispatch centers. From there the dispatch centers pass along the information to local public safety agencies and key personnel. These are the same watches/warnings available to the public through the media or over the NOAA weather radio system.

Weather warning sirens in Washington County are owned and operated locally by the various cities, villages and townships. Due to this fact, the sirens in your area may or may not sound on April 22nd

depending on participation by the local jurisdiction in the drill, or the fact that a particular system may choose not to deviate from its normal testing schedule.

If actual severe weather occurs anywhere in the state on April 22nd, the drill will be postponed until Friday, April 23rd.

All residents of Washington County are encouraged to become familiar with the designated shelter areas and weather procedures needed to be safe if you are at home, school, work, shopping or on the road. The best way to stay informed about severe weather conditions is to purchase a weather radio.

Additional information can be obtained from your local or state Emergency Management Agency, the National Weather Service or your local chapter of the American Red Cross.

## Flight for Life called to C-Sport for fallen child

At 5:15pm, Fond du Lac County Sheriff's deputies responded along with Eden First Responders and Campbellsport Ambulance to N3436 USH 45 in the town of Osceola for a report of a two year old boy that fell to the ground from a second story window of the residence.

Upon arrival emergency personnel found the child, Jayden Gill, conscious, but due to the potential for internal injuries Flight for Life helicopter responded to the scene and transported the toddler

to Children's Hospital in Milwaukee.

Deputies learned that that child had been sitting on the inside ledge of the open window and fell backwards into the screen, which did not support his weight. The toddler fell more than 13 feet to the ground and landed on his back. No foul play is suspected the incident appears to be an accident. Parents of the child are Veronica A. Volkitis and Jacob Gill, who does not live at the residence.

## Washington County to collect household and agricultural waste

Hazardous waste materials are often labeled with indicator words such as "caution", "warning" or "danger". The Environmental Protection Agency defines a hazardous substance as any material that may be toxic, ignitable, corrosive, or reactive. These items become hazardous if you use, store, and/or dispose of them improperly.

Throughout 2010, Washington County residents will have the opportunity to make a clean sweep of basements, garages, barns, and sheds for unused hazardous chemicals such as solvents, pesticides, oil based paints, and wood preservatives. The Clean Sweep program is coordinated by the Land & Water Conservation Division of the Planning & Parks Department.

2010 Full Service Clean

Sweep events will be held on Saturdays: April 17th, June 19th, August 21st and October 16th allowing pre-registered Washington County household residents and farmers to drop off materials at the Washington County Highway Facility located at 900 Lang St., West Bend. Collection times will be from 8:00 a.m.-11:00 a.m. Participation is limited for each event and a \$10.00 per vehicle fee will be assessed. You may register for the Clean Sweep collections by calling 262-335-4808.

The following materials will not be accepted: latex paint, tires, oil, batteries, medical waste, needles/sharps, radioactive items, smoke detectors, cylinders, and gas grill propane tanks.

Additional services provided during the collection include both an Electronic Goods and Pharmaceutical Collection. End-of-life electronic products must be recovered from residential and business sources in order to refurbish, resell, or recycle these products.

Help protect Washington County's waterways, prevent accidental poisonings, and reduce substance abuse. Bring your expired and unused medicine in the original container (if possible). Never flush or pour unused medicine down the drain.

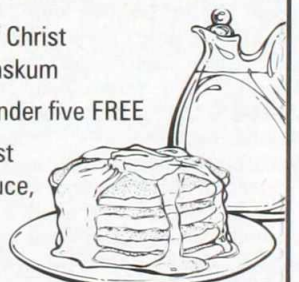

## Potential Foreign Exchange students looking for homes

KEWASKUM- Two teens looking to attend classes at Kewaskum High School in fall as part of an exchange program are looking for homes. The last several years have proven to be a great learning experience for students at KHS as they played host to cultures from all over the world.

Two students, a young lady, Sixtine, 17, from Belgium and young man Kay, 16, from Germany will experience Kewaskum culture with the help of two willing families.

Sixtine will be a 12th grader at KHS. Her stay will conclude after 10 months. Her interests include acting, computers, music, movies, animals, photography, reading, travel, sports, writing among other things.

Sixtine currently lives with her father who is an architect; her mother, a 12-year-old brother and 16-year-old sister. She is somewhat comfortable with living with children, but will not consider living with a single person. She also does not have a problem living with animals. She has four years of English.

Sixtine says she wishes

to discover the everyday life of an American teenager and speak English fluently.

Kay, 16, an 11th grader from Kiel, Germany will be coming for a 10-month stay as well. He has seven years of English which will prohibit any sort of language barrier for his host family.

According to Carrie Schultz, foreign exchange student coordinator, Kay enjoys cooking, travel, movies, sports with an emphasis on soccer, politics, video games, computers among other things.

Kay currently lives with his father, a sea pilot and mother, a school employee. and an older brother and sister.

In regards to a host family he is willing to live with a single person. He is also willing to live in a double placement or in a home with small children.

"I would like to gain something from learning a new culture," Kay explained in his reasoning for joining the exchange program.

Schultz says the process of finding students is more than just putting a young man or

woman on a plane. The student is first interviewed in his or her country, and must pass a lot of scrutiny. Then, the student's papers are sent to the USA and coordinators choose the students they feel would work best in the various schools they organize for.

Interested families are encouraged to contact Schultz. The prospective family is first interviewed, then the family must complete an application, and members must subject themselves to criminal background checks and have references, which are checked. Schultz visits with the family and takes photos of the home, family and bedroom. The only cost for a host family is food. However, students pay for their own school lunches.

## Simulation Fire Drill at Farmington Elementary

On Monday, April 19th at 9:30 a.m., Farmington Elementary School will be doing an emergency simulation fire drill in cooperation with the Town of Boltonville, Boltonville Fire Department, Fillmore Fire Department, Kewaskum Police Department, Kewaskum EMS, and Washington County Sheriff's Department. Before the planning of this drill, each agency had its own plan on how to handle a fire at Farmington Elementary. Through collaboration, conflicting procedures have been eliminated and a plan has been put in place that will work for all those involved.

On the day of the drill, artificial smoke will be released in a pre-determined location of the school which will set off the smoke alarms. 911 will be called and all students and personnel will evacuate. All agencies involved will respond as if it is a real fire. Sirens will sound and emergency vehicles will be using their flashing lights. Access to the school will be blocked and all students and personnel will be bussed to the Farmington Town Hall.

District personnel will respond to the Farmington Town Hall and assist with a mock

pick-up drill. Predetermined students will be picked-up by their parents and eventually brought back to school when the drill has been completed. The remaining students will stay on the busses with their teachers. Back at the school, emergency responders will go through their procedures. For the drill, a few individuals will be declared missing so the fire departments have practice in locating individuals. One individual will be treated by EMS and they will transport the individual to the town hall. Once all of the emergency responders have completed their procedures and cleared their fire hoses and equipment, everyone will be brought back to school. Lunches will run as normal and we will try to go through the rest of the day as normally as possible.

### Proper Attire for the Simulation Fire Drill

We are asking that students avoid wearing good clothes the day of the simulation fire drill. As you know, April can at times be very wet and muddy. We do not want to see good shoes, socks, or pants getting ruined. Please keep this in mind as you send your child off to school on April 19th.

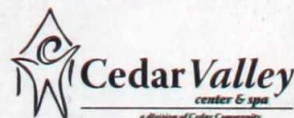

## Cedar Community announces new site purchase

On the heels of a recent purchase of additional property in West Bend, Cedar Community is inviting the public to help create a vision for future aging services needs in the area. "As we plan for the future, we're seeking the community's perspective on how we can best use this land to serve our area seniors," said Steve Jaberg, Cedar Community's chief executive officer. According to the Wisconsin Department of Administration, there are 16,548 seniors aged 65+ residing in Washington County. About seven percent, or 1100, live at one of Cedar Community's Washington County locations. Those aged 85+ currently number 2,312. The

WDOA projects that, in 2030, Washington County residents aged 65+ will increase 95 percent, to 32,206. Those aged 85+ will number 4,015 (a 74 percent increase).

To maintain a seven percent residency rate, Jaberg reported in January, Cedar Community would need to provide housing and services for 2,140 seniors — about double the number they provide today. "Based on these projections, Cedar Community must be proactive to meet this growth. Growth for growth's sake is not our goal," he said. "Our goal is to provide a wide variety of senior services — from retirement housing to community and home-based services and particularly memory care.

"In 1976, Cedar Community built the nation's very first nursing home for people with Alzheimer's disease and related dementia," Jaberg said. "A 2009 Alzheimer's Association Research Study indicates that nearly half of those with Alzheimer's disease — nearly 2.7 million people — are age 85 and older. By 2030, the first wave of Baby Boomers will reach that age. That's an estimated 3.5 million people with Alzheimer's. This property may well provide an ideal setting for meeting this and other expanded needs."

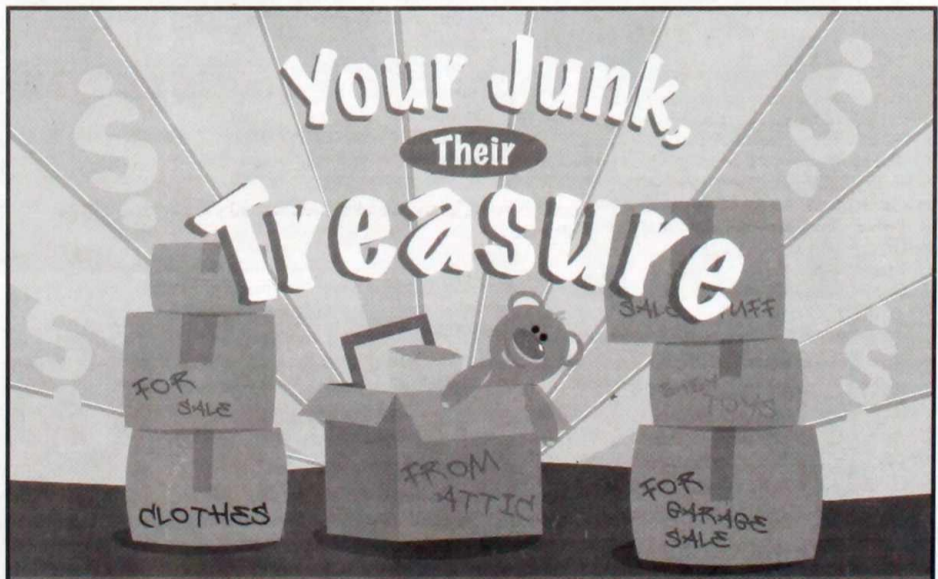

Damian Wilmot works the Bois Brule River on April 17th for wild steelhead. The Vice President of the Brule River Sportsmen's Club will lose three steelhead in-river from Lake Superior on this afternoon and land and release two beautiful brown trout to 16-inches.

Damian Wilmot was in no hurry to lift a wild steelhead or brown from the Bois Brule River. That would come with time, as it always has since his father first handed him a fly rod at age five and introduced him to this special addiction and its certain promise of natural highs.

So Wilmot stood again with the Brule Thursday, reading the water and laying down his stone fly or egg fly again and again to ride the current over those places where

his instincts told him a trout might be holding. He laid out his patience, too, and he took his fix. Long before the first steelhead rose to the fly.

This is beautiful Douglas County. A river runs through it. It also runs through Damian Wilmot. Three decades after a father first showed a son just how it's all done.

"I love this river," he said. "I don't go out steelheading on the Brule on any given day expecting to catch fish. But I go out of my way to find the riv-

ers like this with self-sustaining, wild trout. I don't want to sound arrogant because some rivers need stocked fish. But there is just something special about a wild fish."

"For these steelhead, their home is this river, and each of these fish is doing their own part to sustain the species. They don't need anything from us. With the exception of releasing them again when we do catch them."

Maybe these steelhead making the journey inland

from Lake Superior don't need man. But man, from the Department of Natural Resources (DNR) fisheries experts to the Brule River Sportsmen's Club, to the Wild Rivers Chapter of Trout Unlimited, lends the occasional hand regardless to ensure that the fish and the spawning areas necessary for the trout to naturally reproduce are adequately protected.

"Dennis Pratt (DNR Fisheries Biologist) saw to it that the one-fish bag limit with a 26-inch minimum size limit was adopted," Wilmot said. "That, along with a growing catch and release ethic by the fishermen, has made a tremendous difference. It used to be a five fish bag and a lot lower size limit. People were carrying backpacks of steelhead out of here."

To emphasize the need for proper regulations and self-restraint, Wilmot said that more anglers each year fish the Brule originating near Solon Springs at the north end of Lake St. Croix before eventually feeding Lake Superior 44 miles to the northeast, than the steelhead that inhabit it. He asks a visitor to consider the consequences of lesser restrictions.

"Quite literally, more people fish the Brule than there are fish," said Wilmot, a part-time guide from South Range, Vice President of the Brule River Sportsmen's Club and fulltime machinist. "If everyone kept one fish, think about the damage to our fishery. I stress a catch and release ethic. My clients know before we go that every steelhead they catch will be released. Oh I've made exceptions when someone catches a real trophy for the wall. Then I might bring up the option."

To help the fish help themselves, the Sportsmen's Club and Trout Unlimited have also worked closely with state fisheries managers to make natural reproduction easier though improved habitat. "We have created and improved several spawning areas more successfully than I think anyone ever imagined," Wilmot said. "We even had a black hawk helicopter hauling in gravel to remote parts of the Brule."

Thursday, three hours of massaging the beautiful Brule

eventually coaxed the good fight from three steelhead and two browns. Only the browns, one at 16-inches, surrendered to a man with a fly rod whose only priority was to get the fish back in the water anyway.

"I just love this river area," he said again during the walk out through the hardwood ridges. "I hunt here. I fish here. But I am a catch and release advocate. It's the future of our fishery."

One thing is for sure, there won't be much specialization on the Kewaskum High boys track team this spring. For the team to be successful, all of the Indians will have to compete in two or more events.

Coach Jerry Gosa definitely has some quality athletes, but there just aren't enough of them to go around for all the 12 running events and six field events.

"I think the girls team will definitely be better than the boys," Gosa said, considering the number of candidates on the two squads.

Among the 27 boys out for the sport are nine letter winners, led by sprinters and relay runners Scott Steldt, Brandon Zolp and Mat Toles.

The team's major strength, according to Gosa, is the 400 with Steldt and Zolp, who have designs on winning Eastern Wisconsin Conference titles and earning berths in the WIAA Division 2 State Track and Field competition.

"The leadership you get from Scott and Brandon is very good," Gosa said. "They've never been to state. They're going to give it everything they've got to get to state ... They want to go!"

Sophomore Eric Perkins,

another of the returning lettermen, will probably run the sprints and team with Steldt and Zolp again in the 4x200-meter relay. "Eric is quite quick," the coach said, also looking at the multitasking Perkins to compete in the long jump, with Zolp being called on to be a top scorer in the triple jump where he has gone 37 feet, 3.5 inches (37-3.5).

Another solid returnee is junior Lucas Kopeschka, who can run sprints or middle distances and is expected to be a member of the 4x400 relay.

T.J. Schlice did a nice job for the team his sophomore season, and already Gosa has witnessed him show his talent in a couple of events.

"T.J. is doing a nice job in the high jump," Gosa said, and when he cleared 10-6 in the pole vault in the indoor meet at Sheboygan North, the coach was convinced he found his No. 1 vaulter for the year. While he is nowhere near the 14-0 cleared by Jake Dickmann (who is currently competing for UW-Oshkosh), Schlice has the capability to go an extra couple of feet by the time he graduates in 2011.

Other lettermen include senior distance runners Zach Herriges and Tim Hall, along with sophomore pole vaulter Joey Wollner.

Herriges can run anywhere from the 800 to the 3,200 in the open races, and he's fast enough to run one of the legs on the 4x400 relay team.

One newcomer who has showed potential in the weights is junior Ryan Ogi. "He's raw, but he's a good-sized kid," Gosa said, adding, "Maybe he can give us some help."

Normally Gosa could count on having nine or 10 sophomores and the same number of freshman on the team, but this year's turnout was somewhat smaller, with just five sophomores and four freshmen reporting.

Three of the freshmen, Jordan Hanson, Teddy Wollner and Corey Burdick, have a lot of promise and not just in one event.

"Hanson ran a 57 (seconds in the 400 at Sheboygan)," Gosa said, indicating he could be the fourth runner in the 4x400, and he also is being looked at in a couple field events.

"Teddy will keep Eric (Perkins) on his toes. He's just not strong enough (in the sprints) yet," Gosa said, and, "Corey is doing some high jumping and pole vaulting. He's doing a nice job."

Summing up what he has seen thus far, Gosa said, "We

don't have a lot of people, but we have some quality in several events."

This could be the year!

If they can stay healthy and improve in the weight events, Kewaskum's girls track team could challenge for the Eastern Wisconsin Conference (EWC) track and field title.

So thinks veteran coach Jerry Gosa who said recently, "With our depth, people should know we're there," adding the key for the Lady Indians to move up from their fourth place 2009 finish up to the top spot is once again "hard work."

When track camp opened a couple weeks ago, Gosa and his staff (Jason Meinen, jumps; Randy Backhaus, distances; Josh Parrent, pole vault; Matt Gundrum, weights; and LuAnn Potter, hurdles) were greeted by 15 letter winners and a squad of 37 that includes better than a dozen talented freshmen.

"I think our strength is going to be Amanda Witek and Candace Beine in the high jump," Gosa said, noting Witek qualified for the 2009 WIAA Division 2 State Track and Field Meet and both are capable of clearing 5-feet (5-0) or better on a regular basis.

"They should be up near the top in every meet," Gosa went on, adding, "With Bryana (Keller) and Candace, we should be strong in the triple jump."

"(Another strength is) Haley Gregoriou in the hurdles. She missed going to state by one person," Gosa said. Her best time in the 300 hurdles was a swift 47.87, which she ran at the sectional.

Witek, Gregoriou, Beine, middle distance runner Jessie Beaupre, sprinter/relay runner Anna Butler and pole vaulter Kassie Legate are the senior letter winners returning, with Sienna Warnecke (shot put), Keller, Molly Potter (hurdles) and Emily Maki (shot put) the junior award winners back.

Veteran sophomores include Ally and Abby Backhaus, both distance runners; Tess Bandy, sprints; Whitney Bastian, weights; and Megan Ringwell, middle distances/relays.

Gosa was thrilled to have sophomore Heidi Johnson report for the team. "She's a great addition," Gosa said, reporting Johnson might be his third or fourth fastest sprinter, an area that has become a KHS trademark in recent years, especially in the 4x100 and 4x200 meter relays.

Three members of those relays, Butler, Gregoriou and Butler, are back, still it will be a challenge to find someone to replace the tenacious Jess Liniewski, who has graduated.

Those four won the EWC 4x100 relay in 52.61 and were also champs in the 4x200 relay winning with a time of 1:50.51.

A year ago, points from distance events were often very low, but Gosa is optimistic that can change this year with the Backhaus twins returning, April Stern coming out with a season of cross country under her belt, and Ashley Stahl and Ariel Sanders, both freshmen, show promise in the 800.

"We're still struggling a little bit in the shot," Gosa said, quick to add, "We're making progress but we're not there yet."

"We have a lot of nice kids," Gosa said, listing Plymouth and Two Rivers as the top competition in the EWC. Defending champion Plymouth has a larger enrollment to draw from and Two Rivers "has a strong track tradition," according to Gosa, who is optimistic his Indians will be in the mix for the conference crown.

Underclassmen may have to step into varsity roles for the first month of the outdoor season. Gosa indicated Haley

Gregoriou and Witek are out for half the season on athletic code violations.

The girls will open the outdoor season on April 13th, hosting Plymouth, Sheboygan Falls and Two Rivers in an EWC quadrangular meet.

## Beine leads the way with 9th at Oshkosh

Freedom and Chilton held the upper hand at the 32nd annual Oshkosh High Invitational held in the Kolf Field House on the UW-Oshkosh campus on March 30.

The Irish and Tigers finished with 60 and 53 points, respectively, while the Indians, led by Candace Beine, came in with 22 points, good for ninth place.

The senior Beine was responsible for 13 of the Indians' points, finishing in a tie for second place in the high jump after clearing 4 feet, 10 inches (4-10) and taking third in the triple jump with a leap of 33-01.5.

"She came close to equaling her personal best," Gosa said, referring to the 34-01.5 Beine came in with at the sectional meet last spring.

The triple jump was a good event for the Indians as Bryana Keller added a sixth

place (3 points) with her jump of 30-11.5.

Freshman Brianna Jacak also contributed a point with her eighth in the high jump after making 4-8.

The only points coming from the running events with a fifth in the 4x200-meter relay where Tess Bandy, Heidi Johnson, Anna Butler and Mikkin Abfall combined for a time of 1 minute, 57.44 seconds (1:57.46), good for fifth place.

"They ran better than the girls did last year (in the same event)," Gosa said, and that's pretty impressive, considering Bandy and Johnson are seniors and the anchor Abfall is a freshman.

Kassie Legate chipped in with one point from her effort in the pole vault, clearing 8-0.

While she did not place, freshman Ashlee Stahl was praised for her performance in the 800 where she ran a 2:44, dropping seven seconds from an earlier competition.

There were no meets schedule for Easter week, but the Indians will host a quadrangular meet with Plymouth, Sheboygan Falls and Two Rivers on Tuesday April 13th. The field events start at 4 p.m. and the running at 4:30.

# Indians come from behind to conquer Cougars

It could have played better, but Kewaskum's fast-pitch softball team couldn't have won in a more dramatic fashion over heated rival Campbellsport on Tuesday.

Down 4-3 in the bottom of the seventh inning with one out and runners on second and third, up stepped the last hitter in the Indians' lineup, catcher Abby Amerling.

The junior shot a hot grounder between first and second base. The Cougars' second baseman fielded it but couldn't throw to first since going for the ball pulled the first baseman too far from the bag. She ran to tag the base instead.

In the mean time, Ashley Faber scored from third and Caitlin Rinzel motored around from second to score the winning run without a throw as the Indians' bench and fans went wild. The final was 5-4. It was redemption for Amer-

ling who was tagged out at home to end the sixth inning in trying to tie the game.

"It was so hard. I was frustrated at the beginning but I had to shake it off and keep playing the game," she said. "Going up there I was really nervous. I knew we just needed one to get into extra innings. Figured I would just go up there and see what happens. That's all I can do. Just put it in play. See what happens."

The Indians moved to 2-0 on the season and 1-0 in the Eastern Wisconsin Confer-

ence. Campbellsport played its third straight one-run game and is 1-2 overall, 0-1 in the EWC.

Faber started the seventh-inning rally with a grounder up the middle. Rinzel followed with a soft popup to short right center. The Cougars didn't communicate or camp under the ball and it fell to the ground. Kewaskum had runners on first and second with nobody out.

Pitcher Erica Heberer struck out swinging before Amerling's grounder won the game.

"We put the ball down when we needed to, I guess. In the end it was risky but we did our job," Faber said.

It was a tense beginning to the bottom of the seventh.

"I was nervous. First two weren't good but I was happy that we had another chance. It was time to start it up," Faber said.

It wasn't exactly how Coach Jeff Gosse drew it up. Or at all, actually.

"To be honest I was playing for one. I was playing to get Ashley home. Take it in extra innings," he said.

The rest of the team had other plans.

"Once Ashley got on three batters in a row missed signs. We got lucky there, very lucky," he said. "We missed three signs in a row and each time they missed it something came out of it different. It came out good."

The Indians were fortunate to get a win given their performance in practice and throughout most of the game. The Cougars used an Indian error for a three-run second inning that gave them a 4-1 lead. Kewaskum came back with two runs in the fourth and both teams' pitching and defenses dodged scoring threats the rest of the game before the bottom of the seventh.

"I wasn't very happy with them because last night we were very unfocused at practice," Gosse said. "For the first three to four innings you saw that out on the field. Just not making plays we should have been making, not communicating, swinging at pitches above our heads. I told them we were like some ship afloat in the sea. Completely lost."

The Indians took a 1-0 lead in the second inning on a one-out home run by Courtney Krueger. The junior first baseman clocked a long fly to right center and raced around the bases, scoring without so much as a throw home. It was the first homer of her career.

"Before the game he (Gosse) told us to look for our pitch. I saw it coming and just hit it. I knew right after I hit it, I was like, ahhh!, and I started running," she said.

In the bottom of the fourth, shortstop Monica Dehler was hit in the head with a pitch and saved by her helmet. Michele Marquardt then sailed a fly to right field that ticked off a Cougar's glove. Dehler slid home all the way from first, beating the throw, and Marquardt coasted in for a triple. Freshman Jenny Reicher followed with a rope to left field that scored Marquardt.

Heberer went the distance for Kewaskum, allowing four runs on five hits and three walks, including one run walked in.

"They weren't swinging until they had to swing. That frustrated her. You could see that in the one inning when she walked that one in," Gosse said.

Sophomore Aubrey Hart went all the way for Campbellsport, allowing five runs on six hits and one walk. She struck out seven and hit one batter.

The Indians play at EWC foe Sheboygan Falls Thursday, host Elkhart Lake on Friday and host Hartford Union on Monday.
