## Crypto case confirmed in Kewaskum but not believed to be widespread or serious

The village is reassuring residents there is no evidence the municipal water supply is contaminated with cryptosporidium but it is having water tested from the swimming pond in Kiwanis Park after a swimmer was diagnosed with the disease.

Village Administrator Mathew Heiser said he received a call on Aug. 6 from one swimmer diagnosed with cryptosporidiosis and began to investigate. A water sample was sent to a lab for testing. Results should be

available Aug. 24.

On Monday, Heiser received another call from another person with cryptosporidiosis who was concerned with the municipal water supply. The possibility, according to the lab doing the swimming pond testing, would be like winning the lottery. Cryptosporidium lives in surface water and the only way an underground well can be infected is if rainwater runoff would leak into it.

The Kewaskum Water Utility is in

compliance with mandated testing and recently underwent more testing after putting on a new roof and fire protection storage tank on its largest water tower. All tests were clean.

"We're very confident that our municipal water supply is not contaminated," said Heiser.

Washington County Health Department Director Linda Walter said she doesn't believe the small number of confirmed cases to become widespread. She looked back on number

of confirmed cases the last four years and this year is still in the normal range.

"I don't think we've got anything really festering. We're still in that normal range, but we're watching it, I'll be honest with you," she said.

Through interviews with those with confirmed cases, she said the department has not been able to identify a common source, which isn't unusual. Infections like salmonella, e. coli, cryptosporidiosis and others with symptoms of diarrhea are spread

## Town of Farmington to propose referendum for road repairs

**TOWN OF FARMINGTON** - The town's road budget has gotten so bad it will pose a referendum question in November asking residents if they'd like to contribute more money.

The Town Board on Monday discussed putting two questions on the ballot: one asking for \$200,000 and one for \$450,000. To raise \$200,000, the owner of a \$200,000 home would pay an extra \$100. To raise \$450,000, the same home owner would pay \$221.

\$450,000 would allow three roads to be reground and resurfaced. \$200,000 would allow for overlays. The town has 66 miles of road.

Residents may vote no to either or both questions.

Town Chairman Gary Schreiber said four years ago the town would receive \$170,000 from the state for roads. Now, that number has dwindled to \$60,000.

Costs have risen as well. Board member Art Seyfert said several years ago it cost \$65,000 to regrind and resurface a road. Now, it costs \$150,000. And Seyfert said much heavier equipment travels on roads today than years ago.

The town will send a mailing to all residents explaining the referendum.

The Town Board took no action during the review of Brad Riekoff's conditional use permit one year after a debate over the noise his auto tuning business makes.

Riekoff, who runs West Bend Dyno at 8450 Trading Post Trail, received a conditional use permit to run his

business last September but under town-imposed hours. The Town Board allowed the business to be open Mondays, Wednesdays and Fridays from 9 a.m. to 6:30 p.m., Tuesdays and Thursdays from 9 a.m. to 9 p.m. and Saturdays from 9 a.m. to 3 p.m.

On Monday, Town Chairman Gary Schreiber said he only received one complaint on a regular basis from the same person. Supervisor Mark Foyse said he hadn't received any.

Chris Elbe said he hadn't received any complaints from the people living in two houses he owns that are next door to the business.

Since the board didn't take action on the permit, Riekoff is allowed to continue to run his business.

The Town Board approved a salt contract with Morton Salt of \$61.70 per ton for up to 2,500 tons. The rate is cheaper than last year.

The board had approved the contract at its July meeting, pending looking into one more offer. On Monday, the board learned that offer was not as good and the Morton contract's approval stands.

A Farmington bar owner received approval from the Town Board on Monday night to let customers take drinks in plastic cups outside the back of Buddies Place, in reaction to the state's new law that doesn't allow smoking in bars.

"It has been done but on a very limited basis," said Buddies Place owner Karen Nick.

Supervisor Art Seyfert said he talked to the Washington County Sheriff's Department about the issue

and was told it should be reviewed by the board but otherwise is fine.

"I don't have a problem with it, but I would like it reviewed once a year," said Town Chairman Gary Schreiber.

The request only allows plastic cups to be taken outside, not bottles or glasses, and specifies the south side of the building in the horseshoe and volleyball area. Customers may not bring drinks outside the front of the bar, though Nick said some do go out there to smoke.

The board unanimously passed the request, 3-0.

The Town Board on Monday approved a host of new additions and remodeling fees as required by state law and added one the state doesn't mandate.

The new fees will only be enforced on houses built after 1980. Those built before 1980 will only have a zoning fee of \$50. The fees, as recommended by the Plan Commission, are:

1. Residential additions/remodel up to 500 square feet, \$400
- 500 to 1,000 square feet, \$550
- More than 1,000 square feet, new home rated by square foot
2. Decks fee, \$100
3. Swimming pool fee in-ground, \$150; above ground, \$100
4. Storage sheds up to 120 square feet, no fee; sheds 121 and larger (including detached garages), \$150. This is not required by the state but added by the town.
5. Basements/rec rooms, \$50, depending on additions/modifications

## Hwy. 144 construction to begin in 2011

The State Department of Transportation is planning to do a \$7 million resurfacing and reconstruction project on Highway 144 from West Bend north to the county line in 2011. State and federal sources will pay for the project, aside from local costs of utility moves like sewer, water and manhole adjustments. Those costs have not yet been determined, said DOT engineers at a recent public information meeting.

In addition to milling and resurfacing Highway 144, reconstruction of several areas includes: the Wallace Lake curve, Newark Drive, Highway H and Forest View Road intersections, the hill south of Highway A, the Highway A and Club Lane intersection, cul de sac at Highway HH, south 28 and Highland Drive intersection and the Scenic Drive and Jay Road intersection, including extending its box culvert.

The road will be open to local traffic throughout the project except for three to four weeks when the hill south of Highway A is lowered and the Wallace Lake curve is reconstructed, DOT engineers said.

The project is slated to run from June to December in 2011.

The next public information meeting is slated to be held sometime this fall. Real estate impacts on all properties should be available, and real estate people will be available to explain the process.

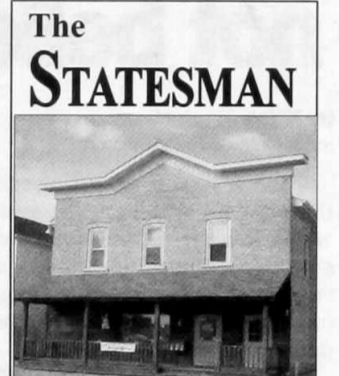

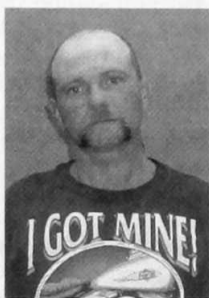

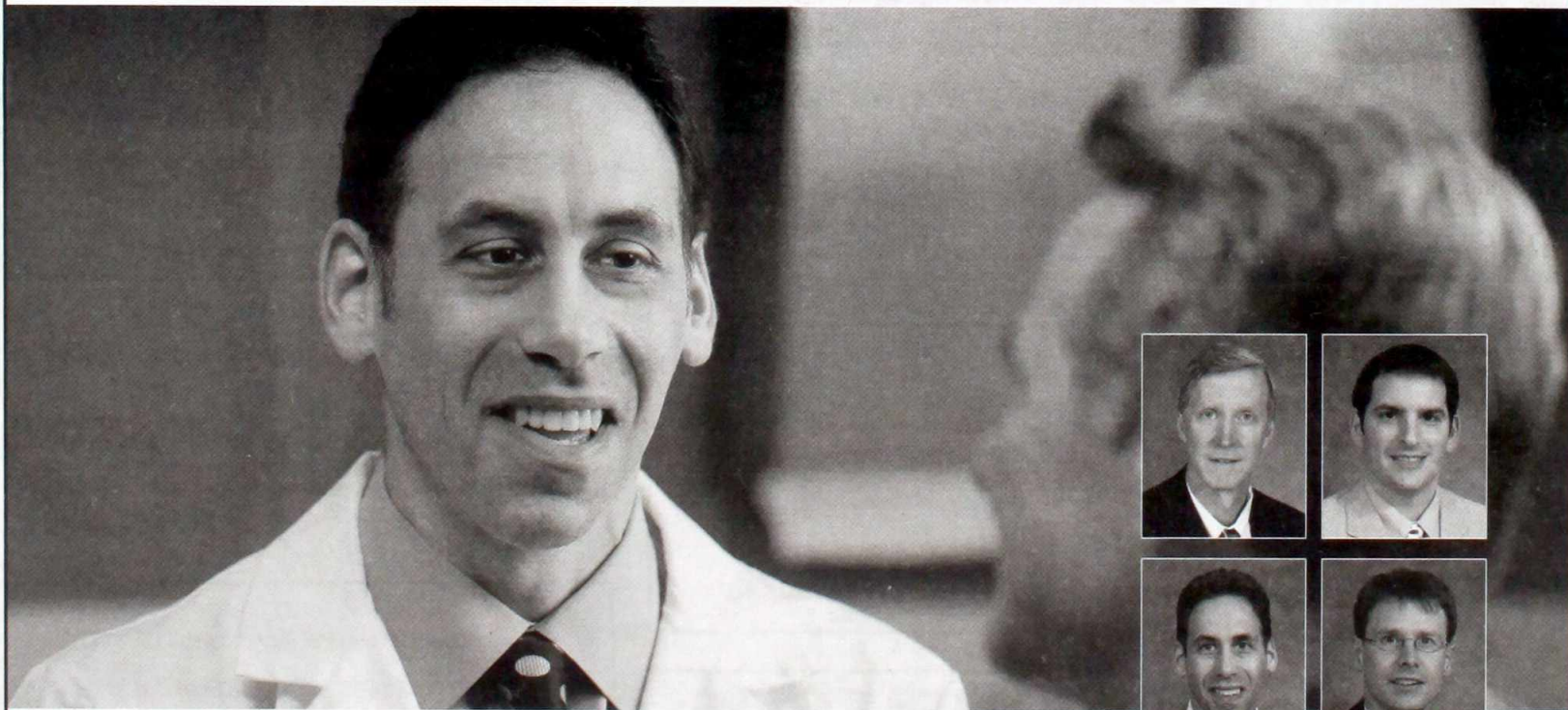
This 7:00 PM performance will take place on Thursday, August 12th at the Kewaskum High School Theatre, 1510 Bilgo Lane in

through animal feces and thus more common in summer because of summertime activities like fairs, picnics and swimming, Walter said. Atmospheric conditions in summer also allow for longer life spans of the bacteria.

"This stuff is carried primarily by animals and we come in closer contact with it. This isn't totally unusual," she said.

Anyone with symptoms of any of those diseases should take proper action, including not swimming for one week.

"If someone is sick, particularly with diarrhea, they really shouldn't be swimming. It's not unusual if they seek medical care the physician is probably going to ask them for a stool sample," Walter said. "We stress hand washing and staying home."

The village remains in close contact with the department, the village health officer and the lab doing the water testing, Heiser said. The village put a statement on its Web site explaining the issue. Go to <http://www.village.kewaskum.wi.us>.

Walter commends Kewaskum for its response.

"I think the village is be-

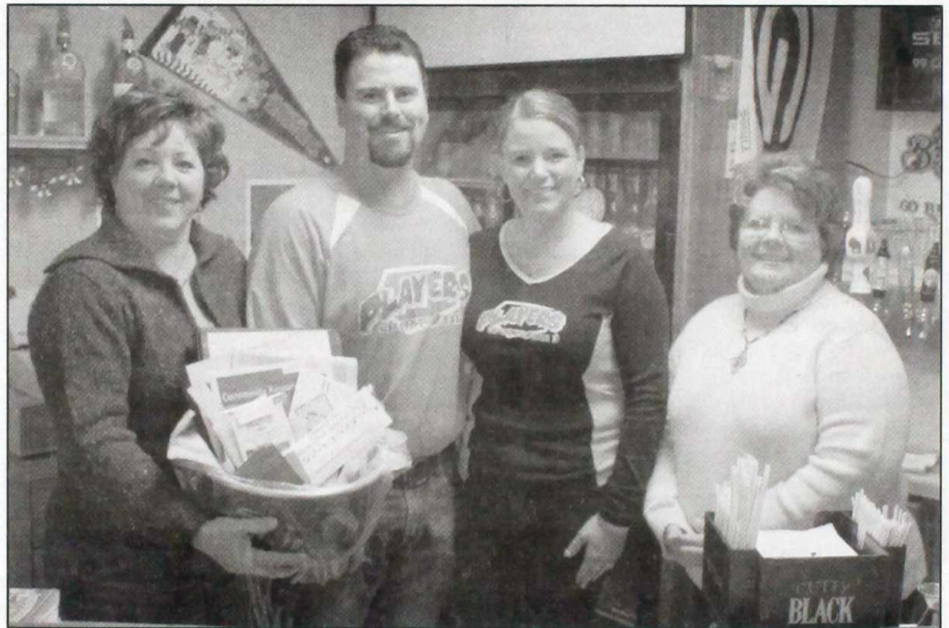
ing very prudent," she said.

The swimming pond test, however, will only show results from that moment. Cryptosporidium could have been in the pool and died off since, or could have been introduced after the test, Heiser said.

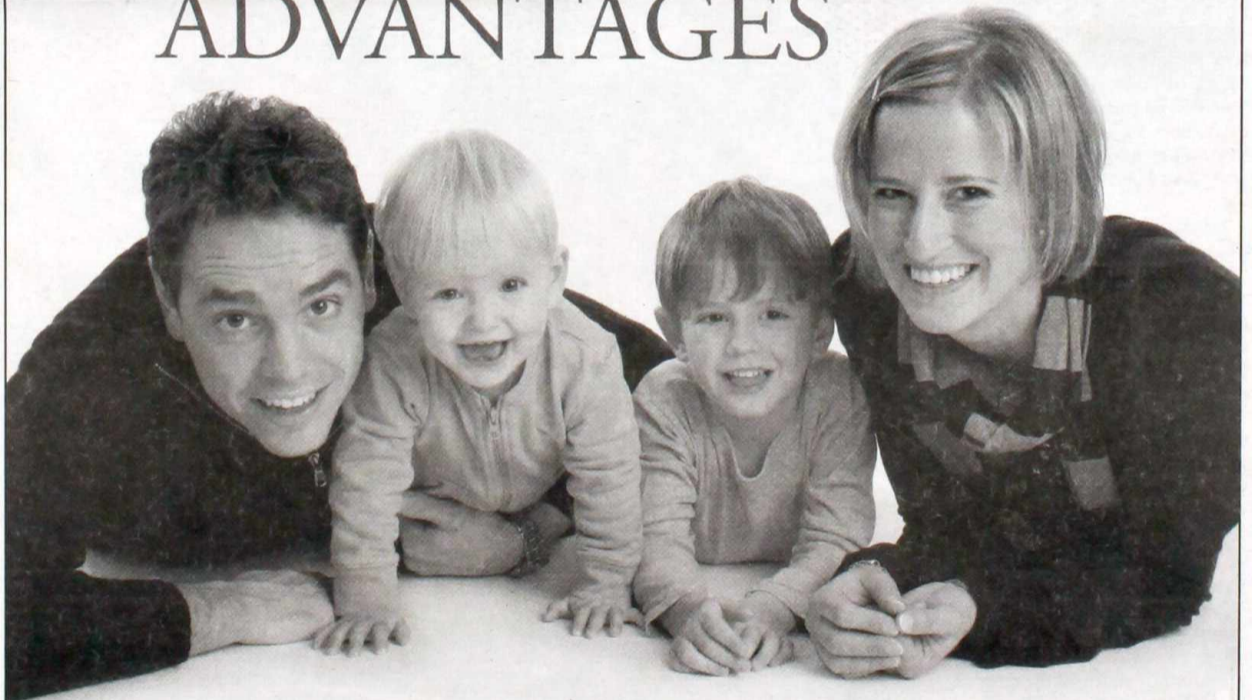
6. Decks converted to screen porch (three-season room), fee same as addition.

All the fees include \$50 for zoning. All improvements need a permit or letter of approval from Washington County.

While state law requires the work be done, municipalities may determine their own fees. Board member Mark Foyse thought the fees were too high and voted against the motion.

Town Chairman Gary Schreiber and Supervisor Art Seyfert said they're not fans of fees, either, but don't want the town to lose money. Schreiber said the fees will not make the town money. Town building inspector John Derler said some of the fees were one third of what other municipalities charge.

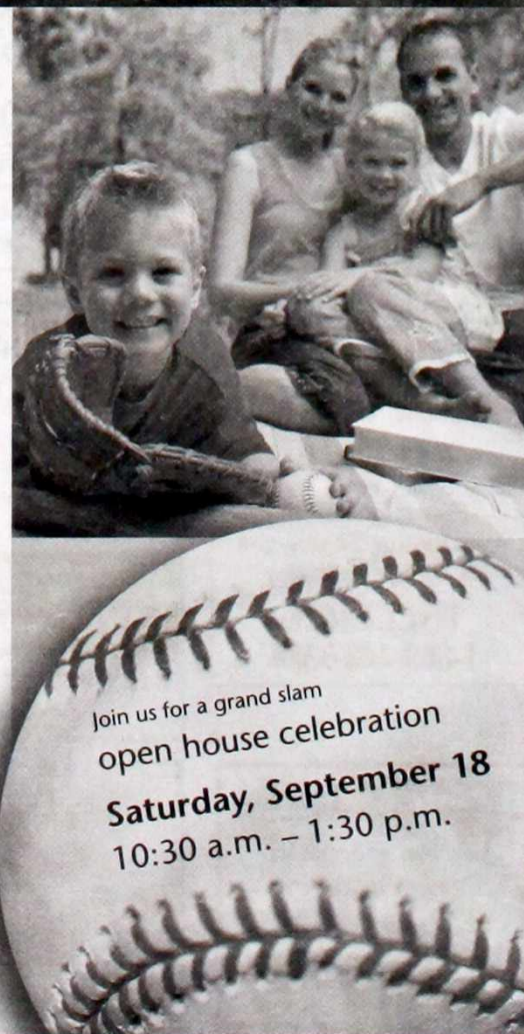

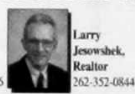

**OFFICIAL NOTICE - VOTING BY ABSENTEE BALLOT**

Any qualified elector who is unable or unwilling to appear at the polling place on election day may request to vote an absentee ballot. A qualified elector is any U.S. citizen, who will be 18 years of age or older on election day, who has resided in the ward or municipality where he or she wishes to vote for at least 10 days before the election. The elector must also be registered in order to receive an absentee ballot.

**TO OBTAIN AN ABSENTEE BALLOT YOU MUST MAKE A REQUEST IN WRITING.**

Contact your municipal clerk and request that an application for an absentee ballot be sent to you for the primary or election or both. You may also request an absentee ballot by letter. Your written request must list your voting address within the municipality where you wish to vote, the address where the absentee ballot should be sent, if different, and your signature.

Special absentee voting application provisions apply to electors who are indefinitely confined to home or care facility, in the military, hospitalized, or serving as a sequestered juror. If this applies to you, contact the municipal clerk.

You can also personally go to the clerk's office or other specified location, complete a written application, and vote an absentee ballot during the hours

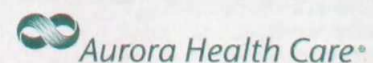
