MABAS implementation helps area fire departments

The next time Campbellsport or another nearby municipality has a huge fire, area residents can rest a little easier knowing the entire Kewaskum Fire Department won't be depleted in helping to put it out.

The Washington County Fire Chiefs Association decided to join the Mutual Aid Box Alarm System (MABAS) that allows for responding to various emergencies with small help from several departments rather than using all of the closest ones.

Kewaskum Fire Chief Mark Groeschel said MABAS only takes 20 percent of any one department to help respond to a scene, a failsafe in case a fire or another emergency breaks out in the assisting department's coverage area.

MABAS has a numeric system

of codes that allow for responding departments to ask various levels of help, depending on the type and severity of the emergency. Each level has a predetermined list of which and how many departments are to be called, and what kind of trucks and manpower will assist, such as tankers, ladders or chiefs.

This way, Groeschel said, chiefs on the scene of a fire don't have to stop and think of what neighboring departments to tell the Sheriff's Department dispatchers to call, as they did before MABAS. They just rattle off a code and the corresponding calls are made.

One portion of the code specifies which department is calling - Kewaskum is 18 - and another signifies the type of emergency. Nine categories range from fires using hydrants to fires using tankers and from emergency

medical calls to water rescues. Another number specifies the level of help requested. The larger the number, the more departments chip in.

Beyond that, chiefs on scene may request portions of a certain level, depending on the need. If they have enough manpower to fight a fire but need more tankers, they may ask for a certain level and say "tenders only." The system went live Sept. 1. Kewaskum held a training session on it and Groeschel said the binders with all the codes and even cheat sheets are kept in the trucks.

"I think overall it's a very good system. Not depleting another department is a good thing," Groeschel said.

Kewaskum has been involved in several MABAS calls already, but none

Two injured when wheels come off semi trailer



An employee of Bobholz works to load up a vehicle involved in a motor vehicle crash shortly after 10 a.m. on Tuesday, Dec. 7. Kewaskum Rescue Squad joined Washington and Dodge County Sheriff's Deputies, Theresa Fire Department and Rescue Squad and the Wisconsin State Patrol at the crash in both lanes of US Highway 41, just south of State Highway 28 in the Town of Wayne. Sgt. Tim McGrath of The Wisconsin State Patrol stated, two people were injured after the driver's side rear dual tires of the trailer of a southbound N&M Transfer Company semi came off, crossed the median and entered the northbound lanes of traffic striking the driver's side front panel of a northbound compact car driven by James, E. Likeric, 29 of Waukesha. Likeric braked and his vehicle spun out of control eventually coming to rest in the median. The semi driver, Gary J. Hoefs, 52, of Greeleaf noticed the problem and got his vehicle under control on the shoulder of the highway. Theresa Firefighters extricated the driver of the car with Jaws of Life extrication equipment. Karina Likeric was a passenger in the car and was transported to Hartford Memorial Hospital with James Likeric. Neither had life-threatening injuries. Hoefs was uninjured. As of this printing, it is unknown if Hoefs will face forfeitures for the accident.

Land acquisition underway along Hwy. 144

The state's \$8.5 million project to upgrade eight miles of Highway 144 north of West Bend is already in the land acquisition phase.

The annoying portion for travelers - when Highway 144 will be closed from the city limits north to Highway A - is scheduled to arrive sometime in July and last three to four weeks.

An 11.36-mile detour route has southbound traffic getting off of 144 and going west on Highway H to Highway 45, then south to Highway D and back into West Bend. Northbound traffic follows the opposite route.

On Tuesday, property owners and others could see plans for the roadway improvements and talk to real estate personnel at a public information session at St. Andrew Lutheran Church on Highway 144. A total of 125 parcels of land will be affected.

A gravel road will be open at all times for those who live on 144.

The project, according to the state Department of Transportation, tries to improve the condition of the riding surface, intersection operation, sight distance and safety throughout the corridor.

The completion date is slated to be Nov. 11, 2011.

Federal funds cover 80 percent of the project's cost and state funds the other 20 percent.

Village Board freezes wages of Village Hall employees

KEWASKUM - On Monday, the Kewaskum Village Board took action to freeze the wages of employees in the village hall.

A proposal to have Village hall employees receive a two percent raise (one percent in January and one percent in July) and have their step increases (eliminated in 2009) restored, was eliminated when Trustee Craig Garbisch presented a motion to freeze the wages.

His motion received a second from Trustee Harry Roecker and saw a passing vote of 4-3. Voting against the motion was Village President Andy Pesch and Trustees Tom Piwoni and Norman Kufahl.

A Trustee stated village staff was visibly upset at the meeting. When questioned about their reaction, Village Administrator Matt Heiser stated, "Professionally, I don't think it's appropriate for me to comment on the motion."

Three injured in Barton crash

TOWN of BARTON -

Three people were injured in a two-vehicle crash Thurs., Dec. 2. Flight for Life Helicopter responded and flew one of the victims to Froedtert Hospital in Milwaukee.

The Washington County Sheriff's Office was notified of the crash at County Road D and Woodford Rd. at 12:19 P.M. According to Lt. John Buck, a southbound vehicle operated by Karen Ackerman, 74, West Bend crossed the centerline while negotiating a curve in the road. Her vehicle traveled into the path of a northbound pickup

truck operated by Chad R. Marshall, 27, of Hartford and the vehicles collided head-on. The northbound pickup overturned after the initial collision.

Ackerman had to be extricated from her vehicle. She was taken from the scene to Froedtert Hospital by Flight for Life.

Marshall and his passenger, Myles Hesse, 18 of Hartford, were taken to St. Joseph Hospital by West Bend Fire Department Ambulance. All involved were wearing seatbelts. Speed and alcohol were not factors in the crash.

Letter to the Editor:

I waited a couple of weeks to hear and read the responses of individuals regarding the actions of superintendent Mike Krumm to paint over the depiction of Chief Kewaskum. Without being redundant, I agree with Mr. Timothy Ramthun (Nov. 18, 2010 letters to the editor). In the past, vandalism to school property by individuals was dealt with severely, complete restitution and sometimes jail.

I believe Mr. Krumm's actions to do not fall under the realm of vandalism, however, it is quite obvious that he acted with full knowledge that if his intentions were presented

to the school board, or open discussion with residents and students, past and present, the painting would still be in the field house. Mr. Krumm's actions, not to communicate, was a cunning move on his part. He knows full well that he would be met with a surge of negative reaction. But with a lot of issues, people become passive and soon forget. I believe that was what Mr. Krumm was hoping for. That surge of negative reaction against him would now become an Ebb. Everything would be back to normal, Mr. Krumm's idea of normal.

Lest we forget, let me take you back to Mr. Krumm's remarks at a special meeting

held on April 28, 2008. The meeting was held for the purpose of moving the administrators to offices at Regal Ware and using the building that was specifically built for the administrators to be turned into an alternative school. Mr. Krumm was one of the first people to address the crowd. He gave two main reasons to move all administration under one roof:

1) Communication. It seems there was a lack of communication at the time. Everyone had to be huddled together overlooking the Milwaukee River to make decisions.

2) Lack of accounta-

bility. I did not fully understand this reason, but I had an idea.

In Mr. Andrew Kuehl's account of this meeting (The Statesman, Thursday, May 1, 2008) he wrote: "Krumm stated this would aid in effective communication..." and "we look to improve our efficiency." In keeping with Mr. Krumm's two main points above, communication being number one, the article continues, "this move... is in the best interest of the kids and the interest of the school district." It is too bad Mr. Krumm did not follow through with his two main points. He sold a bill of goods, with political rhetoric, to the

school district taxpayers of Kewaskum.

I hope the school board acts in a fitting manner regarding this incident, listening to the people who elected them. It won't be forgotten.

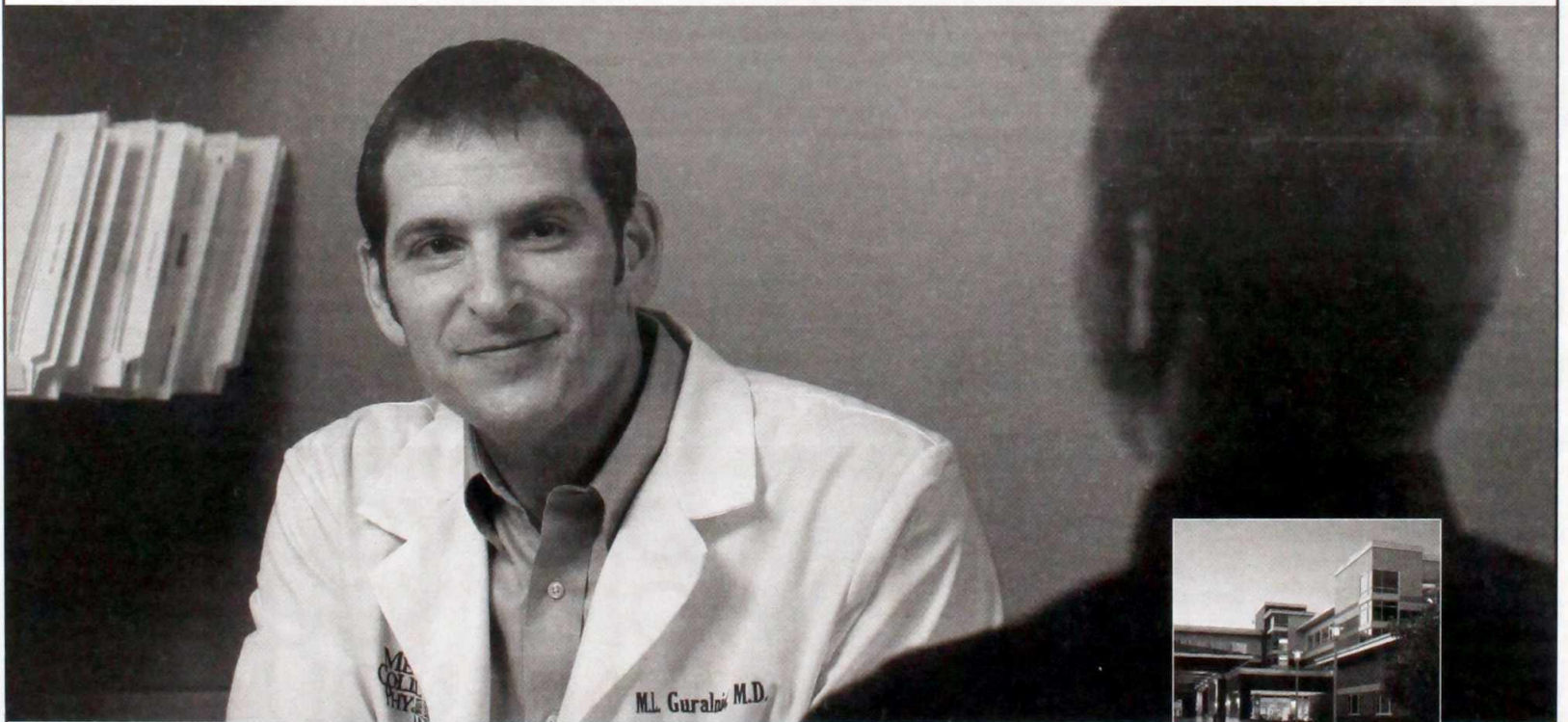

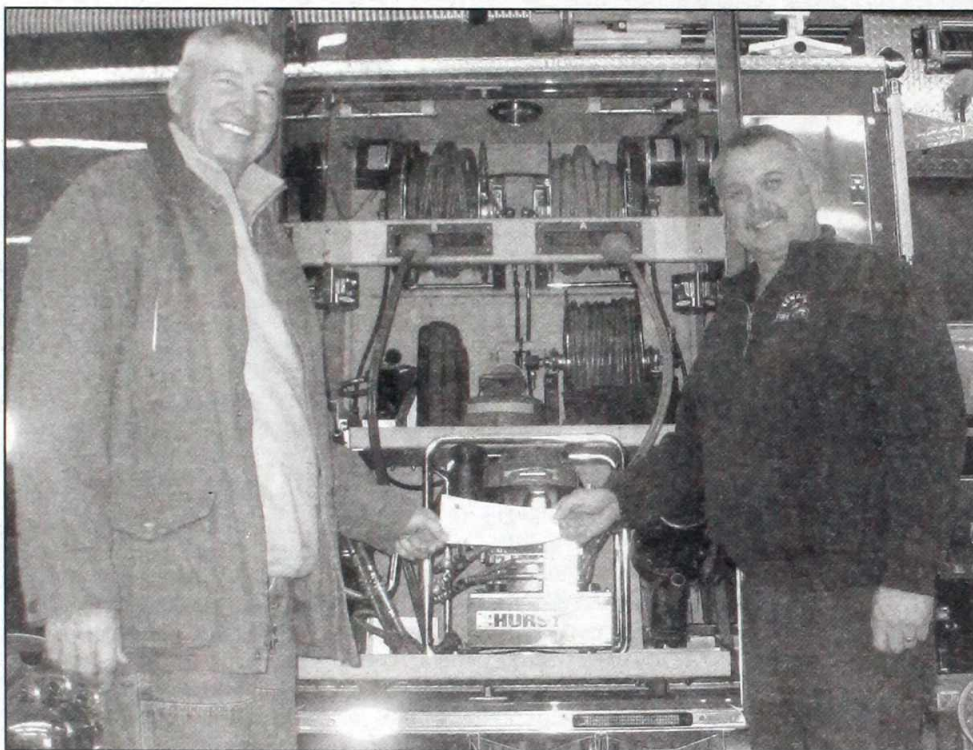

Sheriff's Dept. offers alert for email scam

WEST BEND - The Washington County Sheriff's Office has been informed of an email scam that has recently affected Washington County residents. The scam originates when an individual's computer is infected with a web based worm virus and hackers take over a subject's email account. An email is then sent out to everyone in the subject's email address book. The email usually states the subject has traveled to a foreign country and now is in some type of trouble. It goes on requesting you wire transfer money to them so they can get home.

At this time the Washington County Sheriff's Office has not taken any reports of residents who fell victim to sending money by wire transfer, but area residents have had their email accounts hacked into and fraudulent email sent out from their accounts.

In general, if you receive an email requesting you wire transfer money it's likely you are the target of a scam. If you receive an email similar to the one described above, or had an email sent from your account you should follow the steps below.

If you receive an email from someone you know requesting you wire transfer

money:

Before you consider sending money you should always speak with the person making the request over the phone to verify they indeed made the request.

If you know the email is a scam, you should make contact with email account holder and advise them their computer maybe infected with a virus. If you discover hackers have sent an email from your account:

Immediately attempt to change your email password.

If you can access your email, send an email to all subjects in your address book

advising them the previous email was a scam and sent out without your permission.

If you cannot access your email account, contact your email provider to attempt to regain access to your account so your password can be changed.

Your computer may be infected with a virus and you should take steps to have the virus removed.

Supervisors needed in town of Farmington

Farmington Town Chairman Gary Schreiber and Supervisor Art Seyfert have already filed papers of non-candidacy for April's election.

This means at least two thirds of the three-member board will flip next spring.

Paperwork to declare candidacy is available through each municipality or the Government Accountability Board Web site. Three forms are required: campaign registration statement (GAB-1), nomination paper for nonpartisan office (GAB-169) and declaration of candidacy (GAB-162).

Twenty signatures are

required. Residents are reminded to only sign as many candidates' papers as there are seats available. For example, only sign one town chairman's or village president's candidate's paper, but sign up to two town supervisors' papers and up to three trustee or school board candidates' papers.

The deadline to turn in papers is 5 p.m. Tuesday, Jan. 4.

yet initiated by its own department. It has assisted with two structure fires in Campbellsport, house fires in Newburg and West Bend and a barn fire in Jackson.

"We've never responded to a fire in Jackson before," Groeschel said.

Kewaskum was one of many departments ready to help with the monstrous Patrick Cudahy fire a couple of years ago as a Washington County task force was assembled, but that call was later canceled.

Given its size, that fire could have depleted several area departments, exposing area communities to danger should a second fire break out.

"It's proven itself," Groeschel said of MABAS. "Look at the Patrick Cudahy fire."

As the system gets put into use and a department finds room for improvement, changes may be made to the codes as to how many departments and what kind of help is sent at various code levels.

The system cost next to nothing, save for the binders and training. While Groeschel said he knows the system will have some bugs to work out, he said he thinks "it's a very good system."

About 50 of Wisconsin's 72 counties use MABAS, including every major population center. The state

put its stamp of approval on the system in 2006 when Senate Bill 642 was passed by the legislature and signed by Gov. Jim Doyle.

MABAS started in the late 1960s in Chicago and has been growing ever since, according to its Web site. Pleasant Prairie was the first department in Wisconsin to adopt the system in 1987.

Land acquisition underway along Hwy. 144

The state's \$8.5 million project to upgrade eight miles of Highway 144 north of West Bend is already in the land acquisition phase.

The annoying portion for travelers - when Highway 144 will be closed from the city limits north to Highway A - is scheduled to arrive sometime in July and last three to four weeks.

An 11.36-mile detour route has southbound traffic getting off of 144 and going west on Highway H to Highway 45, then south to Highway D and back into West Bend. Northbound traffic follows the opposite route.

On Tuesday, property owners and others could see plans for the roadway improvements and talk to real estate personnel at a public information session at St. Andrew Lutheran Church on Highway 144. A total of 125 parcels of land will be affected.

A gravel road will be open at all times for those who live on 144.

The project, according to the state Department of Transportation, tries to improve the condition of the riding surface, intersection operation, sight distance and safety throughout the corridor.

The completion date is slated to be Nov. 11, 2011.

Federal funds cover 80 percent of the project's cost

and state fund's the other 20 percent.

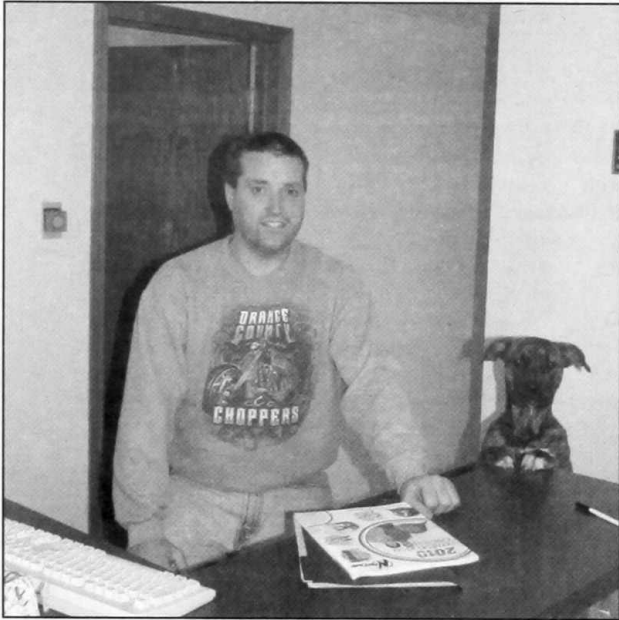

Technical queries can now be answered locally as A&A Computer Repair opens here

KEWASKUM - Ken Adamek, 37, owner of A&A Computer Repair, at 1051 Fond du Lac Ave., Kewaskum, says he had two reasons for choosing the "A's" in naming the business he opened eight months ago.

His surname begins with an A, as does that of his mother Ruth, one of his employees. Then too, his fiancé Hilary Baker, another of his employees, will soon claim the Adamek name.

Secondly, "Having the A's was a way for me to be the first in the phone book," Adamek said.

At A&A Computer Repair, he assists customers in solving their software and hardware issues. He has a \$100 flat rate for assisting with software problems.

Adamek also sells used computers and parts and builds computers, upon request. "I can build something like a super powerful gaming system or make a graphic-designing system for customers who need more power," he said.

Currently, he is running a

special, offering a 50 percent discount on used computers and a 30 percent discount on labor.

When customers drop off their computers at his shop, he will equip them with a loaner, as long as he has one in stock.

He will also make service calls within a 15-mile radius of his shop. "We will pick up computers within that area and bring them in, free-of-charge," he said.

In addition, he will work on networking errors at a customer's home for up to two hours. If he can't solve the problem within that time frame, he takes the computer to his shop. "In those cases, there is a \$30 service charge," he noted.

Adamek admitted to becoming addicted to computers shortly after he received an Atari gaming system in his teens and spent hours tinkering with it. "Computer programs are like a big video game," he said.

This is Adamek's second business venture. He also owns a tree-removal business, A&A Tree Service, and

has operated that for more than 15 years.

"Computers were a side-line thing at home," he noted. "Friends would bring in computers for me to repair. I learned to repair them by playing around with them at home in winter. I also built computers."

He noted he is a self-taught computer geek. "There is a ton of research on the Internet that I use," Adamek said. "The Internet is the largest library in the world. I used to spend hours at my desk learning about computers and would often fall asleep there. I also had a friend, Rory Binkowski, who helped me."

Learning the intricacies of computers entails dedication and patience, he affirmed. "They are really not that complicated," he said.

He related background details regarding his decision to open a computer-repair business. About six years ago, he began running a printing press during the winters for Circular Marketing Inc., a Milwaukee-based advertising agency.

"They found out I was good with computers, so I became their Internet tech," he recalled. "I was also the Internet tech for two other companies in the building -- General Lumber and Commerce Group."

Adamek later decided to branch out on his own and followed through. Meanwhile, he and his father Dave Adamek also provided the tree-removal service this past summer.

He is reaping rewards in his new business. "I enjoy

helping the customers, particularly when they come in stressed out from trying to deal with their computer problems and then seeing the smiles on their faces when we say we can help them," Adamek said.

The average repair time is between two to three days. However, this is not always the case.

"The biggest challenge is getting the parts here," Adamek said. "If we have to wait for a week for parts, that is frustrating."

The most difficult repairs for Adamek involve laptop

hardware, he noted. "The cases on laptops are all different," he said.

Adamek advises computer owners to have their computers repaired as soon as the computers slow down or are not running smoothly. By waiting longer, it will take more time to repair them," he explained.

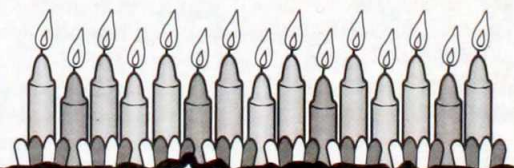

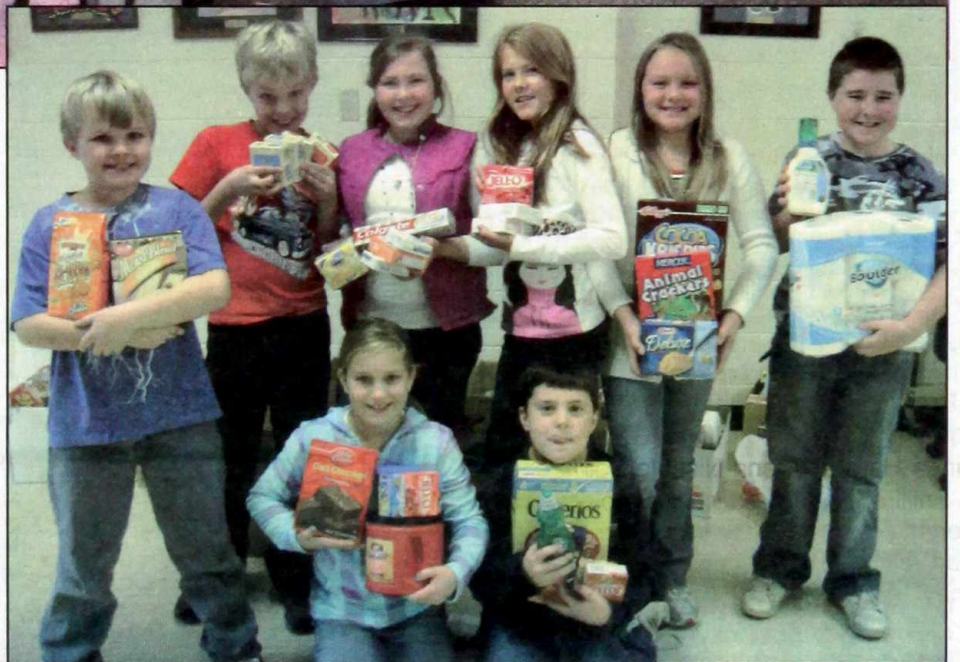

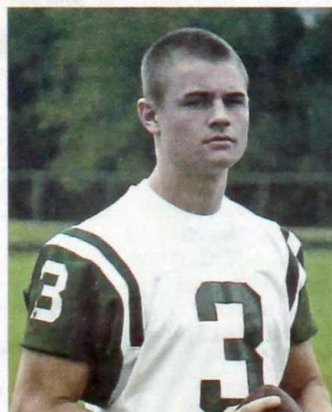

Early on, she worked at Serigraph and most recently in the office at West Bend Vacuum Center.

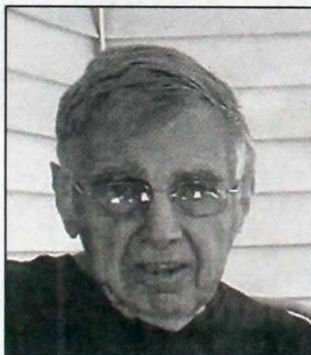

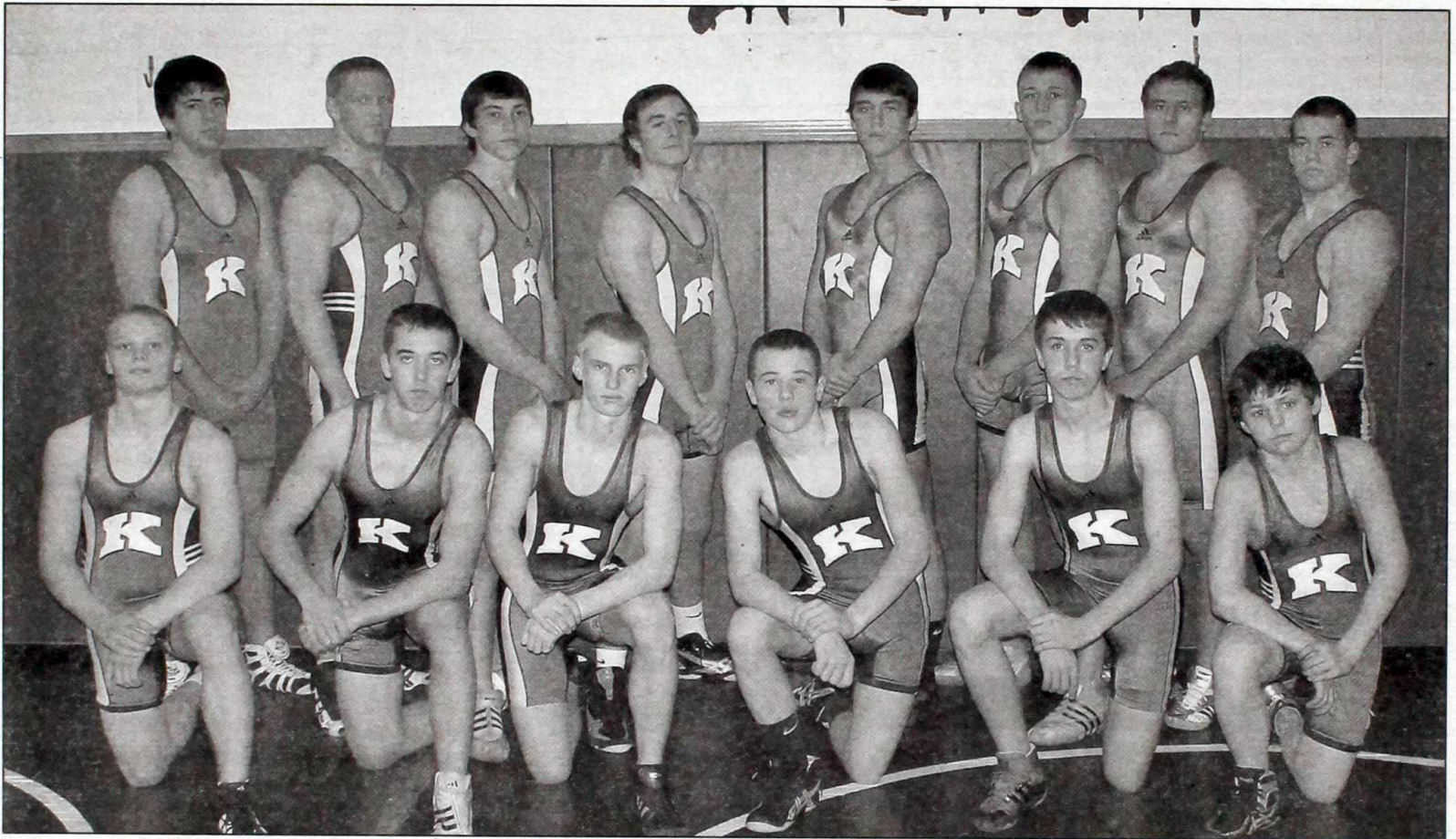

Indians football players receive end of season recognition

Culminating another 10-win season, Kewaskum's football team handed out its usual plethora of postseason awards at the annual banquet Sunday. The Indians finished 10-2 overall and reached level three of the Division 3 playoffs for the second straight season. They finished second place in an eight-team conference that sent five teams to the playoffs. Kewaskum was 6-1 and behind 7-0 Plymouth for the second straight season.

In the playoffs, The Indians beat Ripon, 21-0, and then Luxemburg-Casco, 15-13. Kewaskum lost another close game for the second consecutive season at eventual state champion West De Pere, 28-21.

"We improved as the season went along. We got better and played some pretty good football in the playoffs against some pretty good teams," said Coach Jason Piittmann.

One thing that stood out about this year's team was its age.

"We were a young team. We haven't started that many juniors in a number of years. The seniors provided great leadership, but they weren't many in number," Piittmann said. "The fact that our team was young led to us playing inconsistently at times, which was probably the most frustrating part of the season. The hallmark of this group of kids was their competitiveness. They carried on the tradition of playing 'Kewaskum Football' and playing with a 'never say die' attitude."

In the first of Kewaskum's two defeats, it was stopped at Plymouth's seven on fourth and goal in a 14-6 game. The Indians had converted three fourth downs on that final drive, including a fourth-and-16 pass from quarterback Cody Nuernberg to a sliding Tony Gonring, good for 24 yards.

Against West De Pere, the Indians dug a 28-7 hole in the fourth quarter before lighting up 14 points in less than three minutes as the offense opened up and Nuernberg zinged the ball all over the field. Tight end Andy Doll tipped the ball twice in keeping it away from two defenders for a 39-yard touchdown pass, and speedster T.J. Schlice got behind the defense for a 44-yard gain to the 10 before Nuernberg scored a couple of plays later. A turnover stopped the Indians from completing the comeback.

"If you look at our two losses, the kids did everything they could to give us a chance right down to the final seconds of both games," Piittmann said. After the Plymouth loss, the

Indians let Sheboygan Falls feel their wrath in a 45-6 shellacking, and Kewaskum didn't even play that well.

Other season highlights include a comeback win at rival Campbellsport, turning a 14-10 deficit into a 30-14 victory, and the special teams coming through when it needed to the most against Luxemburg-Casco. The field goal team went through a lousy stretch of blocks in weeks prior and had a point-after attempt blocked earlier in the game, but was called on to take the lead in the fourth quarter.

Brad Boegel made a good snap, Sam Olla a good hold and the line held up. Sophomore Hunter Flanders sent a 33-yard kick through the uprights for a 15-13 lead. A hard-hitting defense, a Bo Seibel fumble recovery and an offense that ran out the clock preserved the victory.

"They persevered in overcoming a rough first half against Campbellsport and battled tough for a close playoff win over Luxemburg-Casco. They bounced back after a tough game at Plymouth and took it out on Sheboygan Falls," Piittmann said.

Kewaskum's offense had a lightning rod that doesn't come around too often in the form of halfback Eric Perkins. The 5-9, 165-pound junior rushed for 1,383 yards on 171 carries, averaging 8.08 yards per carry and 115 per game. He scored 17 touchdowns rushing and receiving. Once Perkins cleared the defensive line, he usually scored, often in embarrassing fashion, lengthening his lead on hapless pursuing defenders as he neared the end zone.

Piittmann said Perkins runs the 40-yard dash in 4.4 seconds in hand timing. Schlice runs a 4.5. Both times could be considered NFL speed.

But playing well and winning, Piittmann said, comes from more than those who get the headlines.

"We had so many kids contribute in ways that don't make the newspaper articles each week. Their contributions on the scout team units, special teams, and in reserve roles are as big a key to our success as are the kids who start or play most of the snaps on offense or defense," he said. "We have been fortunate to develop an atmosphere where kids do a great job in all of these roles - for the benefit of the team and program."

Some offbeat season highlights include:

Bo Seibel, usually no. 13, wore no. 4 against West De Pere in honor of his older brother. Cody, a 2010 graduate, a nasty, hard-hitting linebacker, running

back and punter who was the heart of 2009's defense, couldn't play in last year's game against West De Pere due to injury.

Trainer takes a stand: Beloved trainer Emily Mueller went down in week one after a late hit sent a portion of Kewaskum's bench falling like dominos. Mueller was last in line and got knocked on her back, her head barely missing the asphalt track. The trooper toughed out the rest of the game and was never knocked down the rest of the season, an 11-game streak. For you stats fans, Mueller is batting 0.916 and kept a good sense of humor about the incident all season, as people were quick to regularly remind her.

It's a blowout: The Indians outscored their opponents by a combined 349-147 points, which comes to 29.08 to 12.25 points per game. Kewaskum eclipsed 40 points four times and recorded two shutouts.

Going grey: In week one with a 20-6 lead on West Bend East, Schlice intercepted a bomb but fumbled as he was tackled. Seibel jumped on the ball, preventing the Suns from being in position to score and make it a one-possession game.

Piittmann yanked off his hat and rhetorically asked anyone within earshot, which would have been most of the village given the decibel level of his voice, "What's after grey hair? No hair?"

As of press time, the coach still had hair.

The Pits? Anything but: This was Kewaskum's sixth straight season with 10 or more victories, all under head coach Jason Piittmann. The team never lost more than two games per season in that span, won four straight conference titles and advanced to the semifinals four straight years. Piittmann is 75-19 in his eight years as head coach.

"We've got a great coaching staff. Hell of a job. Coach Piittmann is the greatest coach I've ever been around in any sport. We have a great senior class, great leadership, just really a great group of kids to be around every day. I'm honored to be a Kewaskum Indian. That's all I can say."

Boys basketball team improves to 3-1 with win over Campbellsport

CAMPBELLSPORT - The most poignant sign yet that the Kewaskum's boys' basketball program is turning around came at the expense of the Indians nearest rival.

Kewaskum beat Campbellsport last Thursday, 55-41, to improve to 3-1 on the season.

That equals the win total

of all of last season.

About as impressive is how and when the Indians sealed the game. Kewaskum cruised through the first three and a half quarters with seven- or eight-point leads before the Cougars took advantage of a couple of Indians forced to sit with foul trouble. Campbellsport started the fourth quarter with an 8-0 run and came all the way back to tie the game at 35-35.

The home crowd finally had a reason to roar, and it was litmus test time for the Indians. They would either find a way to lose or buckle down and pull out a victory.

This year, the Indians are bargaining for the latter, and they're getting help from plenty of players.

Sophomore Hunter Flanders flew down the court, drew in the defense and dished to point guard Eric

Perkins inside for a bucket to take the lead. Brett Nuernberg followed with a jumper and the Indians wouldn't look back, building a double-digit lead.

The defense, in the meantime, held the Cougars scoreless for more than four minutes straight. By the time Campbellsport found the bottom of the net again, with less than a minute to play, the game was out of reach.

"I just had had to calm everybody back down and get everybody back into the flow of the game," said Perkins. "We were too aggressive and people were too out of control."

"We knew that they were jumping all over us on every possession," Nuernberg said. "We started to slow down a little bit and thought we had the game in hand. We need to learn to play with a lead."

"We just got a little careless and I think we lost our focus a little bit," said Coach Quinn Heintz.

He summed up his team's response once the game was tied. On the road in the conference, he said, "you gotta dig in."

"I think we did what good teams do," he said. "We didn't panic. We played tough. We learned from what we did against West (West Bend West, a 55-44 loss on Nov. 30)."

Perkins scored a team-high 14 points, 10 in the fourth quarter. Nuernberg and senior post player Lucas

Kopeschka each scored 11. Junior forward Brad Boegel and junior guard Tony each added seven.

Teams trying to foul the Indians to get them out of sync can so far forget it. Five players combined to go 12-for-13 from the line in the fourth quarter - Perkins was 4-for-4. Six Indians combined to go 19-for-21 for the game.

"It closes teams out," Perkins said.

"It's a totally different game if we don't make our free throws," Heintz said.

The Indians are 1-0 in the Eastern Wisconsin Conference and the Cougars 0-1 and 1-3 overall. Kewaskum gets a week break before hosting Plymouth on Friday.

"In a way it's needed," Heintz said, given several early games were packed into the schedule. He said the team will work on skills and team-building activities.

2011 Wisconsin State Park admission stickers and trail passes available

MADISON - The 2011 admission stickers to Wisconsin State Parks and Forests are now available at park and forest offices, Department of Natural Resources service centers, and now, for the first time, over the internet through the Friends of Wisconsin State Parks website [www.fwsp.org] -- a small shipping and handling charge is charged for the online option).

"If you know someone who enjoys camping, swimming, hiking, biking, skiing, or wildlife watching, Wisconsin state park admission stickers and trail passes make excellent holiday gifts for those that enjoy being outdoors," says Kimberly Currie of the DNR Bureau of Parks and Recreation.

The stickers and trail pass-

es give outdoor enthusiasts access to thousands of miles of trails, hundreds of nature hike opportunities, dozens of beaches, and some of the most scenic areas found in Wisconsin, Currie says.

"Park stickers are also the perfect gift for those just interested in absorbing simple solitude and the natural beauty of Wisconsin's outdoors," she adds.

The sticker provides vehicle admission to 60 state parks and forests across Wisconsin. There is no increase in sticker or trail pass fees for 2011. Admission stickers cost is \$25 for Wisconsin residents or \$35 for nonresidents. A family with more than one vehicle registered to the same household

may purchase additional state park stickers at half price. A senior citizen annual sticker for \$10 is available for Wisconsin Residents 65 years of age and older. Annual trail passes are \$20 for residents and nonresidents.

A state trail pass is required for all people age 16 or older biking, in-line skating, horseback riding, cross-country skiing, or off-highway motorcycling on certain state trails. A state trail pass is not required for walking or hiking.

Admission stickers and trail passes are valid from the date of sale through Dec. 31, 2011, so cross-country skiers can use a 2011 trail to enjoy the ski trails yet this December.

Cougars Clip Indians 42-38

Down nine points entering the fourth quarter after a horrid first half, Kewaskum's girls' basketball team refused to go away in its home and conference opener against Campbellsport on Friday.

Sophomore Ashlee Stahl scored nine points in the final frame - her team's entire first-half total - including an inside basket while being fouled with 4:06 to play. Stahl made the free throw and cut the lead to four, igniting the home crowd and giving life to a team that seemed dead most of the game.

The Cougars, though, hit enough free throws down the stretch to keep the Indians two possessions away. Stahl hit two free throws to cut the lead to three with 11.6 seconds left but it was too late.

The Indians ran out of clock as the Cougars hung on, 42-38.

"We just didn't play good tonight. We didn't execute. We'll improve some things tonight. We'll get better," said Coach Mike Kleinhans.

Kewaskum is now 2-2 and 0-1 in the Eastern Wisconsin Conference as it readies to travel to Plymouth (2-2, 1-0) today. The Panthers won at Kiel, 60-43, on Friday.

Down 30-21 entering the fourth quarter, the Indians began to chip away. The inside opened up a bit after the tallest player on the court and the Cougars' leading scorer,

forward Amandla Daniels (6-0), left at the end of the third quarter with an ankle injury and didn't return. The Indians finally began working the ball in the paint, drawing fouls and snagging a couple of offensive boards.

Point guard Christine Bohn hit her only shot of the game, Kayla Bastian hit an inside shot and Stahl hit two, getting fouled on the second. A good free throw put the game at 34-30 and the Indians had hope and momen-

tum. From there, the Cougars and Indians mostly traded free throws the rest of the way. Stahl hit two with 11.6 seconds left to shave the lead to 41-38, the first time it was a one-possession game since the first quarter.

One free throw pushed the lead back to four, where it would stay.

"It was a good effort," Kleinhans said of the second half. "I thought it was close when we got to about

four minutes in the fourth. We made that little run, but I just didn't have them ready to play tonight."

Stahl ended with a game-high 13 points.

"Ashlee Stahl played well. She had her moments," Kleinhans said.

Bastian ended with eight points and 11 rebounds, and Chelsea Watzig scored eight, including two three-pointers in the third quarter that kept Kewaskum close.

The comeback nearly made up for a horrendous start. The Indians fell behind 11-3 after one quarter and 20-9 at half. They went 4-for-21 from the field and had in the neighborhood of 15 turnovers to the Cougars' six. The teams' combined traveling violations racked up enough frequent flyer miles to visit loved ones across the country for the holidays.

Kewaskum ended with an unofficial 23 turnovers, but Kleinhans said he thinks it was more.

"I just need to do a better job of coaching. I've got to have our kids better prepared than what I did tonight," Kleinhans said.

Daniels led the Cougars with 11 points in her three quarters of play. She scored eight in the third.

At the line, Kewaskum went 6-for-13 to the Cougars' 15-for-31.

Kleinhans said the game plan and offensive execution need improvement, as does free throw shooting.

"We've got to work a little

more on our zone offense. I've got to do a better job of teaching that offense. I need to get some better out of bounds plays," he said. "I've got to work on shooting with the kids more. I've got to work on post moves with the kids more."

The Indians swept the Cougars last season on their way to an 11-3 conference record, good for second place, but that was with eight seniors. On Friday, three sophomores were in the starting lineup along with one senior. Kleinhans will work on developing the young talent.

"I've got to prepare them better. We've got to do a better job," he said.

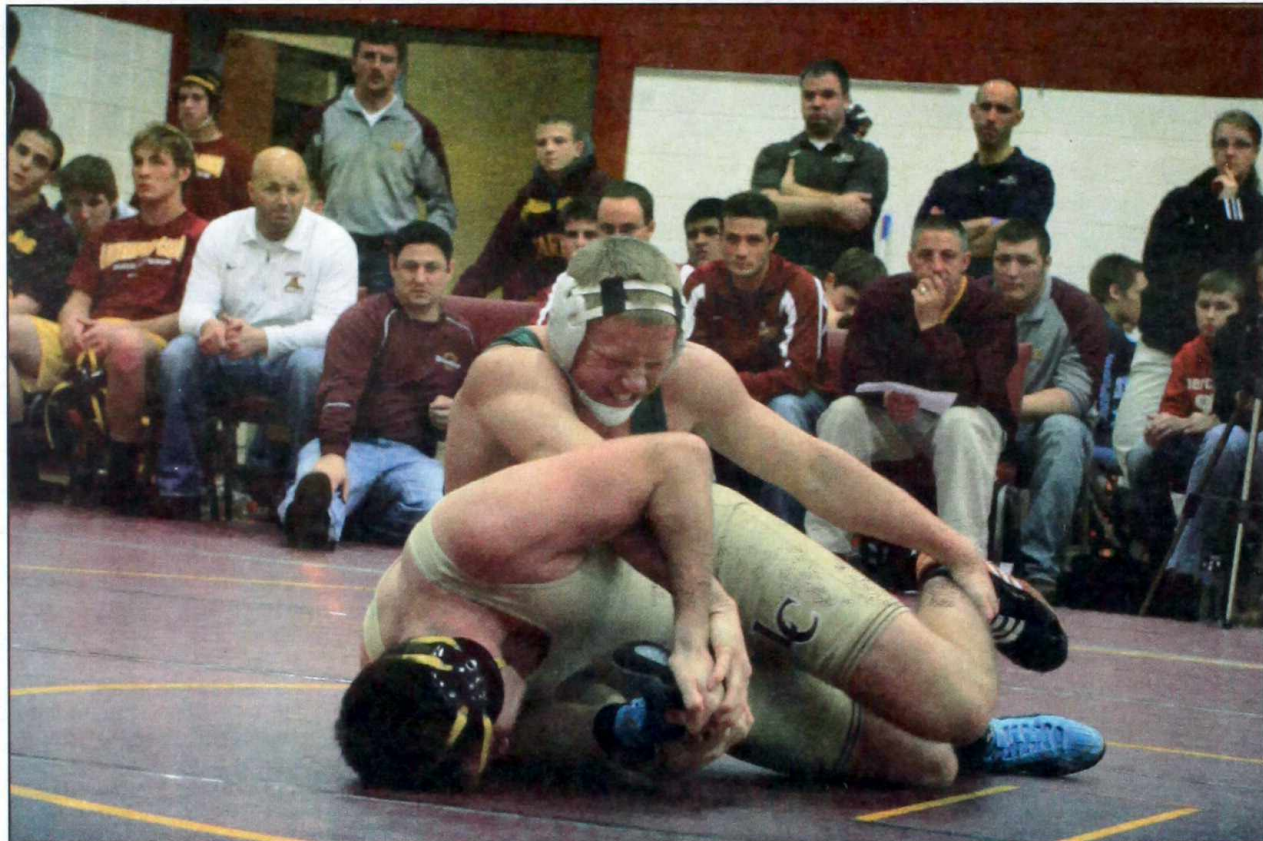

An investment for the future

Taking a 4-1 lead after the first period, Seibel breezed to a 9-4 victory. For the day, Seibel finished 5-0, and the Indians were 2-3 as a team in a very strong field.

KEWASKUM— Until two years ago, the Kewaskum wrestling team spent the first Saturday of December in Lomira, beating up on the other wrestlers who came to the Lions' annual dual meet tournament.

Coach Dennis Aupperle became concerned his athletes needed more competition in the early season, so last year the Indians accepted an invitation to the Spartan Duals in Luxemburg-Casco.

KHS finished 4-1 there a year ago, and even though the Indians slipped to 2-3 (4th place) last Saturday, Aupperle is certain the tough competition will help, especially in the stretch run of the season.

The host Spartans, currently ranked No. 3 among Division 2 wrestlers, finished a perfect 5-0 and won going away, 57-18 over Bayport, 42-20 over Port Washington, 60-12 over Kewaskum, 73-3 over Sheboygan Falls and 72-0 over Mosinee.

Kewaskum started out with a come-from-behind 39-22 effort vs. conference rival Sheboygan Falls, then lost a tough 36-39 decision to Bayport, and a 27-36 decision to Port Washington before finishing off the day with a 49-22 victory over Mosinee.

"You come up here, and there are so many good

matches," Aupperle said. How true. The field included a couple state champions and a dozen or so place winners from the 2009 tournament.

Rob Maertz faced two top opponents at 152 pounds and split against them. "Rob had Jordan Roosa from Mosinee and beat him 4-0. He (Roosa) finished fourth in the state," Aupperle said.

Maertz didn't fare as well against Port's Alex Dieringer, who is nationally ranked and the No. 2 rated wrestler in the entire state behind Germantown's Jesse Thielke. Just 1:09 into the match, Dieringer, who signed a letter of intent to wrestle for Oklahoma State, ended it with a fall.

Maertz, who breezed through his other three matches, winning 10-0, by pin in :43; and with a solid 9-3 decision.

The only two to finish unbeaten for KHS were Brad Bentz at 160 and 171 and Bo Seibel at 189.

Bentz's wins came via a pin in 1:56, a pin in 2:55, a pin in :56, a 9-2 decision against Zeke Peters of Luxemburg-Casco, and an 8-4 decision in the finale vs. Mosinee.

Including the pin over Campbellsport's Jamie Straub in the season-opener, Bentz is currently 6-0.

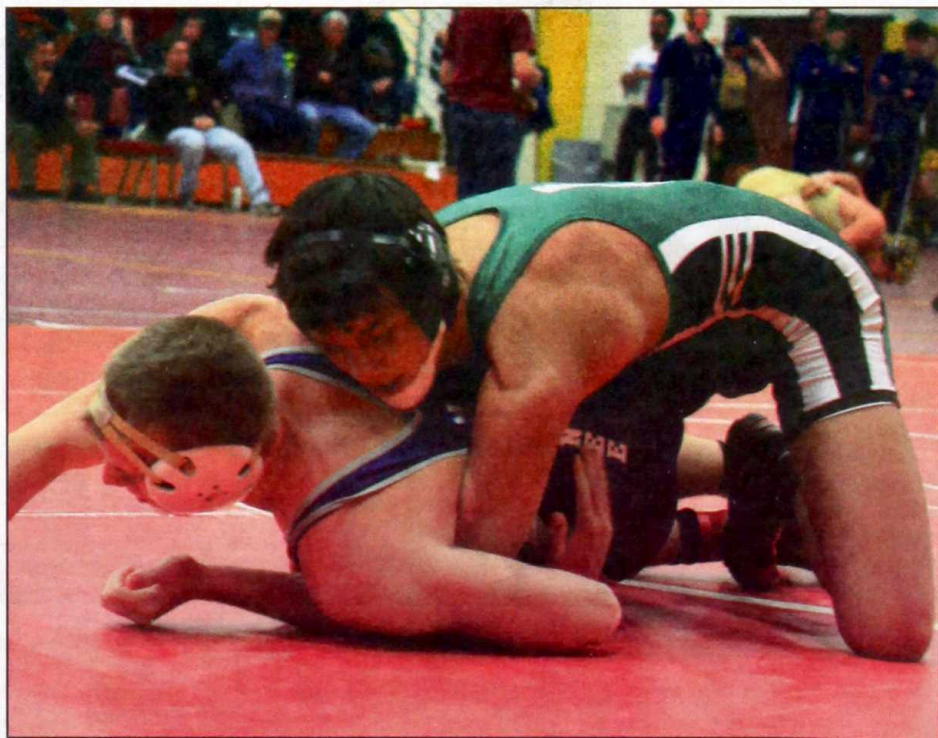
Seibel, who placed fifth in the state tournament last year, also is perfect for the year. He pinned opponents

from Sheboygan Falls, Bayport and Port Washington in a combined time of 4:10, then comfortably topped the Spartans' Matt Ronsman 9-4 before receiving a forfeit from Mosinee.

Jared Koffke also wrestled well to finish 4-1. His only

loss came against Lux-Casco where he got pinned in 3:05.

In his other matches, Koffke had a pin in :50, a thrilling 5-4 overtime decision over Bayport's Alexander Walls in which he got a reversal with three seconds left, an 8-3 decision, and a forfeit.

One of the pleasant surprises of the day was the 5-1 finish by sophomore Derek Aupperle, who had three pins and a decision. His lone loss was a pin against Luxemburg-Casco.

Because Bentz and Aupperle both weigh 160 pounds, coach Aupperle is able to move them back and forth at 160 and 171, depending on which matchups give the Indians a chance to win both bouts.

Brett Scoles finished 3-1, forfeiting the final match because, according to his father, he was having some breathing difficulties. Scoles, who was trying to get down to 119 pounds but now has settled in a 125, won 8-3, 7-4 and 6-4.

His only loss, and first loss of the year, came against Alex Blaney of Bayport. Blaney got a takedown in the first period and that was enough for a 2-1 decision.

Records of the other KHS wrestlers are as follows: Steve Bohn, 0-5 at 112, Matt Ringwell, 1-4 at 119; Austin Goeden, 2-3 with two pins at 135; Joey Seitz, 2-3 at 140; Joey Wollner, 1-4 at 145; Cole Roberts, 3-2 at 215; and Brandon Ehn, 1-4 at 275.

Aupperle said it was tough having to forfeit at 103, and he is confident the team will get better when Bohn and Ringwell move down one class and Logan Dreher reaches 119.
