

Village mill rate projected to rise by 1¢; budget to decrease

Kewaskum's budget is decreasing slightly from last year and the mill rate is projected to rise by a penny.

The Village Board on Monday set a public hearing date of Nov. 7 for residents to provide input on the budget.

2009's mill rate of \$7.15 per \$1,000 of equalized value went to \$5.91 last year, mostly due to the village's reassessment. This year's mill rate is slated to be \$5.92, meaning the owner of a \$150,000 home would pay \$888.

The entire 2011 proposed budget is available on the village's website at <http://www.village.kewaskum.wi.us/>. General fund revenues are up 2.64 percent from \$1,338,514 to \$1,373,907. Total revenues are down from \$2,461,167 to \$2,421,883. Expenditures are down 2.26 percent from \$2,461,167 to \$2,405,482.

The board sought to know how much savings it could pick up by having village employees, not including the police, pay 15 percent of their health insurance instead of 12. The total came to \$6,000, not enough for anyone to recommend the switch.

Trustee Mike Berger suggested eliminating Music in the Park to save more money, which totals \$1,800 for the three bands that play.

Trustee Kevin Scheunemann said he would like to see civic organizations sponsor the event instead of canceling it.

Village Administrator Mathew Heiser said some civic organizations already pay about 25 percent of the cost. The village picks up the rest.

Fire Chief Mark Groeschel said the fire department makes about \$2,500 on the event through selling concessions. Trustee Craig Garbisch said he is worried the village is going into another year when it doesn't have money to

fix its roads in case something would come up. He was one of two trustees last year (Harry Roecker) who voted against the budget because it didn't put any money away for future village projects.

"I think last year we made a mistake that hurt us this year," Garbisch said. "We're sitting in a hole we can't dig ourselves out of."

Trustee Jim Hovland said he understood but said cutting \$500 here and there doesn't add up to "significant savings."

Garbisch said he agreed but said he doesn't want to get to the point of borrowing money.

Scheunemann said he only sees two ways to fix the village's financial situation: grow the village and manage debt.

"Other than that I don't see a short-term or long-term solution," he said.



School Board votes down moving meeting

The Kewaskum School Board will be meeting Nov. 14, Green Bay Packers on Monday Night Football or not.

A proposal to move the meeting to Tuesday, Nov. 15, because of the Packers game, sparked a several-minute debate that led to a 4-3 vote.

"If we're going to be changing meeting dates for football games, what else are we going to be changing meetings for?" said board member Steve Jensen.

He asked if a Grateful Dead concert would meet the standard.

Board member Troy Hanson said because of the Packers' large draw many people may not come to the meeting who otherwise would.

Board member Mary Miller said she missed two meetings due to the induction of her daughter into the National Honor Society. She mentioned the community's vote at the annual meeting to only pay board members for School

Board meeting attendance, switching from an annual salary that didn't address attendance.

"Family comes first," she said.

Hanson and board member Tim Ramthun said the switch would be more for the public than board members. Ramthun at another point in the meeting mentioned it was "unfortunate" district business manager Paul Reichert was not in attendance because he was at the Milwaukee Brewers game.

Jensen said to leave the meeting on Monday and let the people come if they want.

Board president Bruce Braidigan suggested moving the meeting up, but then it interferes with subcommittee meetings. Shortening the agenda or splitting the meetings into two days were shot down as well.

"Why are we shortening an agenda of a School Board meeting for a Packer game instead of just moving it to another day?" said Hanson.

Ramthun, Jensen, Braidigan and Miller voted no on the motion to move the meeting.

Kewaskum won't be approving an ordinance to not allow firearms in village buildings.

The Village Board decided to not take up the issue on the advice of interim Police Chief Richard Knoebel.

Municipalities across the state are discussing the issue after the State Legislature approved a conceal and carry law earlier this year. West Bend passed an ordinance to specifically allow firearms and Germantown voted against not allowing them.

Knoebel said firearms already aren't allowed in police departments or municipal court, according to state law.

Village Administrator Mathew Heiser said approving an ordinance not allowing conceal and carry would open the village up to a possible state constitutional challenge.

Trustee Kevin Scheunemann said the way he read the law if the village follows the new conceal and carry law it is protected from legal liability; if it doesn't it is not.

Nobody recommended disallowing firearms be put on a future agenda.

Village trustees will be getting paid less beginning in 2013, as discussed at the last Village Board meeting, but even less than originally proposed.

An idea to cut \$300 from everyone's pay - trustees from \$1,500 to \$1,200 and the village president from \$2,000 to \$1,700 - was brought up a couple of weeks ago.

That reduction was never put on the table. Instead, Trustee Craig Garbisch moved for a \$500 reduction of both - taking trustees' salaries to \$1,000 and the village president to \$1,500.

"I think if we're going to

start a precedent it needs to start at the top," said Garbisch.

Trustee Harry Roecker said the issue should wait until Jan. 1 when budgets start for next year.

Trustee Kevin Scheunemann said the cut is not "substantive" but "symbolic to show the rest of the staff we're taking a cut." He suggested voting on Monday because the 2012 budget is in the process of being finalized and salaries are being set.

The \$500 cut would save the village \$3,500.

Trustee Mike Berger wondered if the cut would prevent people from running for office.

"Is it a deterrent?" he said. The \$500 cut across the board passed, 4-3. Roecker, Berger and Norman Kufahl voted against.

September circulation at the Kewaskum Public Library totaled 6,478 items, up 15 percent from last September's

5,627, said Trustee and Library Board member Norman Kufahl.

For the year, 60,006 items have been circulated, compared to 57,245 items at this time last year.

Forty-seven new cards have been issued in September compared to 37 last year.

The village has received 22 applications for police chief as of the Sept. 30 application deadline. Village Administrator Mathew Heiser told the Village Board.

A panel of outside chiefs has met once and is starting to evaluate the applications, he said.

Richard Knoebel retired this July after 22 years as chief and 38 with the department, and was then hired back as an interim to handle a disciplinary proceeding in the department. His contract runs into December but may be extended if needed.

Dear Editor-

I am writing this letter to clear up some misinformation in regards to last weeks letter to the editor about the Kewaskum-Plymouth football game. For those of you who don't know me, I have been a coach for the Kewaskum Football team for the past fifteen years. I want to address what happened in the game on each play in question. On the first penalty (roughing the passer), our players had chased the Plymouth QB across the field and as he was going out of bounds, one of our players simply shoved him. There was no contact by the helmet or shoulder pads for either player. Personally, I thought the referee should not have made the call. There was no injury on the play and the quarterback was just fine.

On the next play, the Plymouth QB scrambled across the field and headed out of bounds. Our player did clearly hit the QB out of bounds and the referee correctly called a personal foul penalty and ejected our player. Our coaching staff immediately addressed our player and also checked on the injured Plymouth player. Since our player was ejected, he had to sit out the next game and will not be nominated for any all conference awards per the team rules. I am not excusing what our player did, but the game was very emotional and hard hitting by both sides.

On the point after attempt, we had a reserve linebacker in to take the place of our player who was ejected. For whatever reason, the right end from Plymouth blocked the wrong person and our player got a direct run through at the kicker. While going for the kick block, our player missed the ball by a few inches and then proceeded to run into the kicker. The referees then correctly called a roughing the kicker penalty. Unfortunately, the kicker suffered a concussion but, in my opinion, there was nothing flagrant about what our player did. He was simply doing his job and happened to run into the other player. I look at it this way; if our player gets a hand on the kick, no penalty would have been called we would have been congratulating our player on blocking the kick. A few inches were the difference between a great play and a major penalty.

In closing, I would like to say that our coaching staff has never taught or encouraged dirty play or late hits. We do push our kids to excel on the field, in the classroom and in life. I would also like to say that I am very proud of our players and coaching staff and ask that we not be judged on a couple of plays in one game but on our whole body of work in this and the previous seasons.




Superintendent search under way

School Board member Tim Ramthun, charged with starting the search for a permanent superintendent, told the board on Monday he has started networking in looking for candidates.

Ramthun said he prefers an in-house search first, but board approval must be sought to do so.

Beyond the board and district, a few members of the community are involved in the search.

"The community will be part of this process," he said.

The district now has interim superintendent David Ewald for the year, filling in after Mike Krumm retired last year. Ewald, a retired administrator from the Milwaukee area, has not expressed interest in the permanent position.

Board pay stays annual

The School Board on Monday voted down switching its pay system to monthly instead of annually.

The community at the annual meeting voted to pay board members according to their attendance at board meetings, a switch from the usual annual salary not tied to attendance.

The board discussed changing its payment schedule to monthly instead of annually, but the motion failed, 3-2, with two abstentions. Tim Ramthun and Troy Hanson voted for the

switch; Steve Jensen, board president Bruce Braidigan and Bill Kesting voted against it; Sue Miller and Mary Miller (not related) abstained.

Board gets lessons on open meeting laws

The Kewaskum School Board tried to not violate any open meeting laws Monday night, after a law seminar last week showed that's exactly what it had been doing.

Several board members attended a Wisconsin Association of School Boards seminar on law at Wisconsin Dells last week, opening their eyes to just what may and may not happen at board meetings.

The board had been engaging the public in issues brought to it through the public comment sessions and had often responded to the public yelling out comments from the audiences on various issues throughout recent meetings.

Those are open meetings no-nos. The board may listen during the public comment sessions but is directed to not discuss those issues, given they are not listed on the agenda and the general public is thus not informed that the board will be taking up a given issue. Taking comments from the audience during other issues is also not allowed.

The law seminar clearly pointed out these violations.

"They were real specific," said board president Bruce Braidigan.

A New Fane star is born

Horse enthusiast Leah Rodenkirch, 16, has gifted New Fane with a claim to fame.

This past summer, officials of the American Quarter Horse Association (AQHA) invited the Kewaskum High School junior and New Fane resident to participate in the AQHA's Regional competition (Region 3), at St. Paul, MN., from Aug. 15-21. Rodenkirch accepted the offer for the prestigious event and earned two Grand Champion awards -- one in the Novice Youth Hunter under Saddle class (for novice youth, ages 14-18), and the other in the Rookie Western Horsemanship class. She also nabbed the Reserve Grand Champion title for the Rookie Pleasure class.

Her accomplishments deserve accolades, since she competed with equestrians from Wisconsin, Illinois, Missouri, Iowa, Minnesota and Manitoba, Canada. In the contests, Rodenkirch rode a Quarter Horse, whose show name is "Classical Promotion," alias "Doug." Gina Flentji, a Baraboo resident, owns 4-year-old Doug.

"Gina and I entered into a partnership," Rodenkirch said. "She owns the horse, and I showed him. Doug is registered with the American Quarter Horse Association, and those are some of the greatest horses you can have."

Rodenkirch boarded Doug at a neighboring horse farm, the Paluso Horse Co. Laura Sheedy, an associate independent trainer, affiliated with the Paluso Horse Co., and owner of the Kewaskum-based Laura Sheedy Performance Horses Co., was Rodenkirch and Doug's trainer. It was Sheedy who arranged for the partnership between Flentji and Rodenkirch.

So how does equestrian Rodenkirch feel about her accomplishments in AQHA regional competition? "I feel proud, because I was just a small-town 4-H girl in the Equestrian 4-H Club of West Bend, who evolved into circuit champion," she said.

"I was surprised that I earned those awards in regional competition, because I was just a 'rookie' in the Novice classes, which are offered to those who have earned less than 25 AQHA points in that class during circuit competitions."

She explained the methods used in judging her horse in the AQHA regional competition. The Hunter under Saddle class is about movement and balance of the horse and the position of the rider. For example the give and take in the rider's elbow is important. The rider must have stiff elbows during those events.

The horse is judged by his walk, trot and cantor -- all three of these judged equally. "It's about how pleasurable the horse looks, the long and graceful strides," Rodenkirch noted.

Hunter under Saddle is a type of English riding. Thus, she wore a strapless helmet, suit jacket, breeches and knee-high, leather boots in the competition.

Regarding the Rookie Western Horsemanship competition, "I was new to this class, so I was surprised to earn Reserve Grand Champion," Rodenkirch admitted.

In Western Horsemanship, judging is based on overall pattern smoothness in lead changes and transitions. Horses walk around cones and over beams on the floor, etc. The rider must remain centered in the saddle during lead changes. For the Western Horsemanship contest, Rodenkirch was attired in a sparkly shirt, chaps and boots.

In addition to the blue ribbons she was awarded, she also received two Montana silver-smith belt buckles, customized with inscriptions "Regional Championship" and the name of the classes in which she competed. She received a bridal bag too.

But that's not all. There was a higher honor. "I was offered a spot on the American Quarter Horse Association's Wisconsin Congress, which is about as competitive as the World Show," Rodenkirch said.

"But I turned it down," she noted, adding, "I just don't have the heart for riding anymore."

Rodenkirch's interest in horses sparked when she was about 7 or 8. "I live across the street from the Paluso Horse Co., and all of my friends own horses," she said.

She owned her first horse, a Quarter Horse named Jackpot, when she was 9. Then, the following year, she received a new horse, an Appendix, named County. Two years later, her parents purchased Ricco, a Quarter Horse.

Rodenkirch first entered equestrian competition at the Washington County Fair, while she was a 4-H member.

She then competed in open shows, and this past April, she began competing in circuit shows, sponsored by the American Quarter Horse Association. "We traveled throughout the Midwest for these shows, which take place on weekends or every other weekend," she said.

"The AQHA keeps records,"

Rodenkirch explained. "My horse and I racked up the youth points. Then shortly before regional competition, I received an invitation from the American Quarter Horse Association to compete at regionals. The invitation said I had a free slot in the Novice Youth Hunter under Saddle class."

Her trainer Sheedy and some other clients of Sheedy's accompanied Rodenkirch to St. Paul. To celebrate Rodenkirch's awards, the contingent went out to dinner.

"This accomplishment was not only a cool thing for me but for my trainer, Laura Sheedy," Rodenkirch said. "I really enjoy this feeling of accomplishment. Training helps you learn you can accomplish something new each day. It has also been nice to bond with my horses."

Despite her outstanding

accomplishments as an equestrian, Rodenkirch has decided she will no longer be competing. Meanwhile, she is concentrating on her studies, aspiring to enroll at the University of Wisconsin-Whitewater to major in accounting after graduating from high school.

She has a part-time job as customer service representative at westbury bank in Kewaskum.

Sheedy, a professional horse trainer for 18 years, who earned a Bachelor of Science degree in animal science with an emphasis in equine at Murray State in Kentucky, said she is elated with Rodenkirch's success.

"Leah is wonderful, dedicated and has a good work ethic," Sheedy said. "She is knowledgeable about horses and cares about animals."





Postal Service Announces Holiday Mailing Deadlines for mail going to service members overseas

With the leaves starting to fall and autumn upon us, it's not too early to start thinking about holiday cards, letters and packages destined for service members and their families stationed overseas. The first deadline for the 2011 holiday season is just around the corner.

Friday, November 12, is the deadline for sending holiday packages to troops stationed overseas using Parcel Post to all Air/Army Post Office (APO) or Fleet Post Office (FPO) ZIP Codes.

"We encourage everyone planning to send something special this holiday season to remember these early deadlines," said Kewaskum Postmaster Monica Lepak. "Meeting the deadlines will help make sure that cards, letters and packages to loved ones serving overseas will reach their destinations in time for the holidays."

All military mail, regardless of destination, is sent by domestic mail rate. International rates do not apply to military mail delivery.

The Priority Mail Large Flat Rate Box (12" x 12" x 5 1/2") offers a \$2 discount to APO/FPO destinations and ships for just \$12.95. Customers can access shipping information by

adding Delivery Confirmation, which is available for almost all military destinations, including those outside the United States. Delivery Confirmation provides customers with the date, ZIP Code of delivery, and time the package was delivered. This information can be accessed online at www.usps.com.

The Postal Service's popular Military Care Kits also help military families and friends keep free shipping supplies within reach. Each kit contains six Priority Mail Flat Rate boxes (two large and four medium-sized boxes), six customs forms and envelopes, six Priority address labels and one roll of military tape. The kit may be ordered by calling the USPS Expedited Package Supply Center at 1-800-610-8734. All packages and mail must be addressed to individual service members, as required by U.S. Department of Defense regulations.

"Nothing lifts the spirit higher than using the mail to communicate with our service members during the holidays," adds Lepak. "Receiving a card, letter or package brings them closer to family and closer to home." The complete list of military mailing deadlines follows:



5 - Health Insurance committee has been formed and is examining additional opportunities to retain an attractive benefits package while saving money along the way.

6 - School Board meetings will be broadcast on K-TV.

While all of the above and many more positive areas are in the works, I have had a better feeling about the direction of our district. Then, I attended the October 10th School Board meeting. Once again, I am frustrated with the direction the ship is being steered. Our school board members are being advised to sit at their seats with zero interaction back to the public during the Comments/Concerns portion of the meeting. We were told that it is against the open meetings law for the board to engage with concerned citizens. That is just plain untrue.

With very little effort, I was able to find a Wisconsin Open Meetings Law Compliance Guide produced by our state attorney general, J.B. Van Hollen in August, 2010. Within it, a very clear and easy-to-understand idea of how the School Board is allowed to interact with the public during these meetings. Read for yourself...

"Although it is not required, the open meetings law does permit a governmental body to set aside a portion of an open meeting as a public comment period. Wis. Stat. §§ 19.83(2) and 19.84(2). Such a period must be included on the meeting notice. During such a period, the body may receive information from the public and may discuss any matter raised by the public. If a member of the public raises a subject that does not appear on the meeting notice, however, it is advisable to limit the discussion of that subject and to defer any extensive deliberation to a later meeting for which more specific notice can be given. In addition, the body may not take formal action on a subject raised in the public comment period, unless that subject is also identified in the meeting notice."

More than once we have heard comments from the board and Interim Superintendent alike that refer to the idea that the public should be grateful to even be allowed to speak at these meetings. What is stated in the above paragraph is true. The board is not required to allow a public comment period. However, I believe this community wants and expects healthy discussion on topics that matter. Handled appropriately with good, solid leadership, isn't that what is best for our district? Good, solid and regular community involvement?

I urge every member of the board to think for themselves

on this issue and to listen, hear and implement what we, the taxpayers expect - interaction and discussion. This is clearly allowed within open meetings law.

Dear Editor-

In a recent article in the DailyNews ("Library service can be costly," 10/14), Washington County supervisor Paul Ustruck reminded residents that every time they cross county lines to use a library, tax dollars leave Washington County.

This is true, but Kewaskum residents may not understand that they are not negatively effected by this issue. The tax money leaving Washington County comes from township

library taxes, of which residents of Kewaskum are exempt; no village of Kewaskum library tax levy money leaves Kewaskum. In order for the money to leave, you must be a resident of a town or village that does not have a library and you must physically go across county lines to get material.

For example, if you live in the townships of Wayne, Farmington, or Kewaskum, and use the Random Lake, Campbelsport, or Theresa libraries, then your county library tax money will go to those communities to reimburse them for the material you check out. If you live in the Village of Kewaskum and use those same libraries, they receive no compensation. This also means that the county taxes of anyone

who lives in the townships of Aubura or Ashford, if they cross county lines to use the Kewaskum library, goes to the Kewaskum Library.

For the past four years, this has meant revenues for Kewaskum of \$14,000-\$19,000 a year. In fact, we are the only community in Washington County that has benefited from cross-county reimbursements. This extra income has eased the tax burden for residents of the village of Kewaskum and has allowed us to expand our collection and services over the past few years. And don't

worry--the items you order through our SHARE catalog are just part of basic library service and have nothing to do with the county library tax.

As long as you check out your material in Kewaskum, all of the money stays in Kewaskum. If you have any questions about how the Kewaskum Public Library is funded, please stop in and talk to me!



Eyes enlarged; smiles lit up their faces. Kewaskum's volleyball players on Tuesday couldn't stop beaming at merely the mention of last Saturday.

It's been five years since the Indians put a volleyball banner on the Fieldhouse wall to signify conference champs, and it never happened since Waupun joined the league. Both of those were to change at the mini-conference tournament at New Holstein, and it couldn't have happened in more of a fitting fashion.

The Indians and Warriors had both cruised to 3-0 records on the day, moving Kewaskum to 11-2 in the Eastern Wisconsin Conference and Waupun to 12-1. The final match would decide if the Warriors won another solo EWC title or if they had to share one with Kewaskum and Plymouth.

Four days after losing a five-game heartbreaker at Waupun, Kewaskum turned it up a notch and disposed of their biggest obstacle, 25-19, 9-25, 25-23, 26-24. The Indians and their fans went ballistic.

"It was great. It was like a feeling none other. Kewaskum, I don't think, has ever beaten Waupun that I can remember. Our put a banner up on the wall and in the process beat Waupun and we definitely did that," said senior outside hitter and four-year varsity player Kayla Bastian.

"Oh, that was amazing ... best game ever," said senior setter Heidi Johnson.

"It was amazing. We just had that, like, adrenaline drive, like, all the way through. Even, like, when we lost the first game,

really scrappy," said Phillips.

"That was way exciting," said Coach Joe Moser. "We played well. Looked good. We just played smart volleyball. Our kids were pumped up and they were very excited for the win."

They weren't the only ones. The Indians picked up some unlikely fans in Plymouth which also sealed a share of the conference title with Kewaskum's win over Waupun. The Indians ironically needed Waupun to beat Plymouth earlier in the day to set up the title match, and the teams cooperated nicely.

Leading up to that point, Kewaskum beat Kiel, 25-18, 25-22, 25-15; Two Rivers, 25-11, 25-17, 25-12; and New Holstein, 25-16, 25-19, 25-5.

Kewaskum, Waupun and Plymouth each finished with 12-2 records in the EWC and if the conference had a tie-breaking system the Indians would come out on top. Kewaskum lost to Plymouth in four games back in the season's conference-opening triple dual and then swept the Panthers later in the year. The Indians lost to Waupun in five and then beat the Warriors in four.

So in adding up the games, Kewaskum is ahead of the other two. But the Indians will gladly take a share of the championship.

Against Waupun on Saturday, Kayla Bastian led the team with 11 kills and Aycock added 10. Steph Henk had five, Ashlee Stahl and Becca Fahney three each. Boehlke made 16 assists and Johnson 11. Phillips made 21 digs and Kayla Bastian and Sam Smallish nine each.

The team was good on 79 of 88 serves for nearly a 90-percent clip. Kayla Bastian was 18 of 19, Smallish 18 of 20, Boehlke 13 of 14, Phillips 12 of 13 and Aycock 12 of 14. Aycock jump served four aces and Boehlke had three. Phillips was good on 26 of 29 service receptions, Kayla Bastian 18 of 21, Smallish 11 of 14 and Henk seven of eight.

Kewaskum played the Milwaukee School of Languages on Tuesday in what served as nothing more than a warm-up for Thursday. The Indians won, 25-11, 25-11, 25-12.

Moser played everyone in the last home match of the season. Kayla Bastian had eight kills on 11 attempts and had eight digs. Aycock had six kills, four aces and three blocks. Fahney had four kills. Boehlke had nine assists and four aces. Phillips and Caitlin Rinzel each had seven kills. Johnson had four assists.

Thursday, Kewaskum (31-6), which got a no. 3 seed in a tough regional, travels to no. 2-seeded Milwaukee Lutheran, which finished third in the North Shore Conference with an 8-4 record (29-7 overall).

Kewaskum's playoff nemesis, no. 1-seeded Kettle Moraine Lutheran, could possibly be their opponent in the regional final on Saturday.

Moser knows the team must be more focused on Thursday than in was on Tuesday.

"We've really got to focus on our communication, fundamentals. We can't be

missin' 13 stinkin' serves," he said. "That's a lack of focus right there. That's just looking past a team and not thinking about what you're supposed to do. It's not like there's a kid blocking that. You've got to be able to put in your serves. It's just a lack of focus. So we've got to clean that up, play smart and play hard on Thursday."

The Indians say they'll be ready to go.

"I think we're ready for it. We're definitely excited. Our next goal is to win our regional. We have to beat Milwaukee Lutheran," said Kayla Bastian.

"We just need to bring our game. That's all we need to do.

I feel we can beat 'em," said Johnson.

"We're not really nervous but we're just going to have to play our game definitely, right from the start. We're feeling pretty confident about it," said Phillips.

"A lot of effort, heart. That's how we beat Waupun," said Whitney Bastian.

"When the competitor's a lot better we play so much better. And I really think, our team - we want this very bad. We're going to bring up the level of play and we're going to compete with them," said Aycock.

For a one-win team, it didn't get any more exciting than the home playoff game, Saturday, Oct. 8 against Denmark.

Ian Kenworthy came through in the clutch in the final seconds, and Tyler Voge came up huge in his first time defending penalty kicks.

Kewaskum's soccer team won in sudden death penalty kicks after double overtime couldn't break a 2-2 tie.

The game nearly never went to a first overtime. Kenworthy scored the tying goal with 22 seconds left in regulation off of a corner kick.

In the first round of penalty kicks, Voge made a save on a ball right at him, one to his left and one up high he barely tipped up to hit the cross bar and send the game into sudden death.

"I don't know. It's hard just to guess which way to go but I guess I guessed right most of the time," said Voge. "It's an awesome time to get our second win of the year."

Hardy put the Indians up, 1-0, before Voge's sudden-death save.

After winning the play-in playoff game, knocking the sectional teams from 17 to 16, Kewaskum traveled to No. 1 seed Green Bay Notre Dame on Tuesday. They got a taste of the measuring stick in an 8-1 loss. The Indians ended the season at 1-19-3.

CEDAR GROVE- After Games played last Saturday, the eighth and sixth grade Gridiron teams can say, "we're No. 1" because both ended up 6-0.

Big plays were instrumental in the eighth grade team's 20-12 win over the Broncos.

"Cedar Grove had the ball for seven minutes (of the first quarter)," coach Jones Korth said, indicating the Broncos ran out of steam at the Indians 35, then on the Indians' second play, Brandon Thull broke loose for a 65-yard run.

After the Broncos answered with a 50-yard TD, Thull scored again, this time on a 50-yard scamper.

Both PAT kicks were missed, according to Korth, who said, "talk about difficult conditions," referring to the wind, which also kept both teams from passing successfully.

On the ensuing kickoff, CG fumbled deep in its own territory, but the Indians returned the favor on the next play. Then Sam Fechter and Ben Watzig tackled the Bronco QB in the end zone for a safety.

The score was 14-12 at half, and the lone score after the break was a 50-yard cutback run by Josh Baker.

The Broncos got close to midfield, but Joe Sanborn intercepted, and the Indians ran the clock out.

The linebacking trio of Thull, Beret Elmazi and Charlie Witek were cited for good play.

Korth said this was the first time since 1999 the eighth graders have finished 6-0 in league play.

In the first round of the playoffs, all four Kewaskum teams will be at Grafton. This schedule is based on the fact Kewaskum won the Northeast A Group II title, while the Blackhawks were a perfect 6-0 in the Northeast A Group I division.

Once again, the sixth graders, who won 26-19, opened their game with a bang when they returned the kickoff for a touchdown.

"(Cole) Surprenant had a bouncing ball in the middle, took it and ran it back about 65-70 yards," coach Joel Tietz said.

The Indians scored once more before half, putting together a 60-yard march capped by Surprenant's 30-yard sweep. Patrick Krier added the PAT run.

Early in the third quarter, Faton Elmazi stole the ball from a Bronco runner, setting up Surprenant's third score. Cedar Grove fumbled the kickoff, and the Indians needed just two plays to go ahead 26-6 as Krier broke free for a 37-yard TD and Matthew Ramthun ran for the extra point.

The Broncos scored twice against Kewaskum reserves in the final minutes.

While he was happy the team finished a perfect 6-0, Tietz said, "Next week, it's back to business," referring to the preparations for the playoffs.

According to assistant coach Jeff Brettingen, this is the first time since 2002 a sixth grade team has run the table in the regular season.

The fifth graders wound up 2-3-1 after battling to a 6-6 draw with the Broncos.

Kewaskum scored first, capping an opening drive with a 5-yard pass from Ryan Prochnow to Luke Christianson.

"We chewed up a lot of clock with that drive," coach Mark Walcheske said, adding, Cedar Grove also scored on its first possession, "Then we battled back and forth all day."

Defensively, Talon Ralph "did a pretty good job," according to Walcheske, who said, "He had a couple of solo tackles."

Try as they might, the seventh grade (0-6) fell to the Broncos 26-0 and ended the year without a win.

"We took the opening kickoff, had a nice drive and got to the 30 (yard line). We needed a yard to keep the drive alive and didn't get it," coach Tom Kudek said.

The Indians gave the ball up to Cedar Grove which scored three times in the first half for a 19-0 advantage.

Indians end regular season with perfect record

SHEBOYGAN FALLS

He's the most prolific rusher in Kewaskum history, for a single season and maybe for a career. Eric Perkins showed why last Friday night, running over, through and around Sheboygan Falls' defenders, sometimes so badly they fell to the ground coming up with nothing but air. But he didn't know it.

After the game, Perkins was informed he had broken the single-season rushing record, held by his half-brother, Garrett Donath, since 2005.

"I didn't even know I was close to the single-season rushing record," he said. "I was hoping to break it at some point in the season."

Not a bad way to end a perfect regular season.

"It's nice. I'm gonna text my brother tonight," Perkins said.

He could have given him this statistic. His 268 yards on 28 carries put him at 1,647 for the season, past Donath's record of 1,441. Perkins entered the game 62 behind.

Donath, Perkins said, has been behind him all the way.

"He was rooting for me," he said.

The Indians, 9-0 after a 34-3 shellacking of playoff-bound Sheboygan Falls, head into the postseason by hosting Brown Deer Friday night at 7 p.m. The Falcons are 5-4 overall, 5-3 in the Woodland-Blue Conference.

"The kids know that this is the second season. First season is done, can't rest on your laurels. Now, it's a one-game season, week by week," said Coach Jason Piittmann.

On a blustery evening, the Indians last week closed out the first season with a dominating performance of 400-plus yards rushing that got off to its usual slow start. Kewaskum won the Eastern Wisconsin Conference outright at 7-0, ahead of Plymouth's 6-1 record, for their first title since 2008.

Besides Perkins making defenders look like they were

cardboard cutouts and thus unable to move, Brad Boegel made three catches on the night, two on offense and one on defense.

In the first quarter, the 6-foot-4 beast caught a pass nowhere near him, sticking out his Plastic Man-like arm seemingly with Stickum on his right hand, pulling in an 8-yard pass as he fell out of bounds, wowing his sideline.

"I just seen the ball sailing because of the wind. I just threw a hand up and made a quick prayer and then ended up coming down with it," he said.

In the second, Boegel made a much easier catch with two hands thrown by the Falls' quarterback. The Indians capitalized on it 30 yards later with a touchdown. In the third quarter, he caught a dart in his gut from Sam Olla in traffic on fourth and seven that set up another touchdown.

Walking off the field with conference perfection had the team excited.

"Incredible. It's awesome. I'm jacked," Boegel said.

The defense came up big against speedy running back Bobby Musil after having some holes to fill. One linebacker and a defensive end were hurt, and another linebacker was on suspension.

"Watching him on film, man he is dangerous. Reminds me a little bit of Eric. We did a good job of bottling him up," said Piittmann. "Brendan Dowd, Derek Aupperle did an outstanding job stepping in this week. Nick Banks did a good

job when he got in there, too. Reading their keys and filling just like they've been in there all along. I'm very, very happy with that, and it helps us develop some depth going into the playoffs, too."

Musil did return a kick 83 yards to Kewaskum's three in the third quarter, but the defense stiffened. One Musil run went nowhere. An illegal procedure penalty pushed the ball back to the eight, followed by a holding penalty that moved Falls back to the 16.

On a counter play, Garrett Yahr, Kenny Gigstead and Mack Donath combined to escort Musil to a three-yard loss. From the 19, a pass to the corner of the end zone slipped just out of the hands of a Falls' receiver as he fell.

The Falcons settled for a 36-yard field goal, blowing the shutout but allowing Kewaskum's defense a victory.

The Indians figured out their own kicking game, after extra points alone have recently have given fans their admission's worth of entertainment. Junior Hunter Flanders was good on four point-after touchdowns, and hit field goals of 39 and 25 yards. The former came on the last play of the half, the second time he hit a 39-yarder this season to close out a game's first 24 minutes.

"It was pretty windy so I aimed toward the left. I just kicked it left and it went right through," he said of his longest kick. "We know that during playoffs it might come down to an extra point. We had a lot more

focus in practice for the extra point."

Perkins ended the night with three touchdowns, the first an off tackle right in which he blew through a colossal hole untouched for 29 yards, capping a seven-play, 66-yard, 2:18 drive. The second came on a 20-yard burst up the gut that would be good for any highlight reel. With two men to beat to get to the end zone, Perkins juiced to shed one tackler and faked right and cut left to rid himself of the second one, sending the safety with outstretched arms lunging to the ground with nothing to show for his effort.

On a carry in the third quarter, Perkins tallied 40 yards and almost broke as many tackles. He took a pitch right and cut back to the middle as tacklers fell off of him as if he had butter on his jersey. When a couple did get a good shot, Perkins used his power to plow through them.

Nearly every Falcon had a shot to tackle him and failed, before he was finally corralled at Falls' 8-yard line, igniting Kewaskum's sideline in a career-defining carry that words don't do justice.

"I've just been trying to break more tackles ... when I break more tackles everybody else gets more hyped up," Perkins said.

Once he reaches the open field, he has a specific, tactical strategy he shared with The Statesman.

"Just try and make a few guys miss and get to the end zone," he said.

"He's a special athlete, you know," said Piittmann. "He did a lot of great things with the ball. He showed some speed, showed some power running inside, he definitely showed his agility with his cutbacks tonight."

It doesn't hurt to have an offensive line that holds its blocks, and a fullback to lead the way, and Perkins has both.

"(Brad) Bottleman and (Garrett) Yahr are doing a great job on that side. (Joey) Herriges

and (Mark) Miller aren't bad on the other side either. Lots of times you can develop one side as they go to sleep. This year I think we can go either way," said Piittmann.

As far as fullback Teddy Wollner, "He's getting better and better, too," the coach said.

Wollner said he enjoys bulldozing the way for No. 10.

"It's just amazing 'cause no matter what you do he's going to make a play off of it. He's got great vision and can cut on anything," he said.


