Indians pass 1st Team Sectional test, come up short in the 2nd

PEWAUKEE- Momentum was quickly on Kewaskum's side in its 49-24 victory over East Troy in Tuesday's WIAA Division 2 Team Wrestling Sectional. Unfortunately, the Indians were unable to sustain the pace against a solid Chilton/Hilbert squad in the finals, losing their bid to advance to the state competition by a score of 48-16.

The Indians used five pins and a decision in the opener to stun the Trojans. Senior Austin Goeden's

third period pin over Zach Lamb (31-6) at 138 pounds set the stage for the avalanche effort.

Joey Seitz followed with a 5-2 decision, then came successive pins by Max Maertz (:22), Brett Scoles (1:52), Eric Wade (3:54) and Ted Wollner(5:38), propelling Kewaskum to a commanding 33-0 lead.

Also helping the cause were freshman Ben Watzig with his 8-0 major decision and Garrett Buth with a win by injury over Seth

Brahm.

In the championship match, Seitz picked up his second decision to give KHS a 3-0 lead but only three other Indians came up with victories.

Scoles moved up a weight to 170 where he won by major decision 10-2, while Watzig posted a 10-3 decision, and Goeden ended the night by notching his second pin, this one in 1:26.

Beechwood Cheese to go to auction

TOWN of SCOTT- Beechwood Cheese will go on the auction block next month.

The company, which has been in business since 1894 in the southwest corner of Sheboygan County, filed for receivership in August last year.

Court documents state the cheese company and Bullpen Enterprises 1598 LLC, owe more than \$960,000 to Port Washington State Bank.

Seth E. Dizard, attorney with O'Neil, Cannon, Hollman, DeJong & Laing in Milwaukee, is listed as the court appointed receiver - one who manages the affairs of the company in order to discharge its debts.

The auction will be held at 10 a.m. March 18 at the Milwaukee Athletic Club and will include the facility located at N1598 W. County Road A, in Adell (town of Scott), all machinery, equipment, fixtures and other assets owned by the business.

The cheese company's website only mentions the company is going through some changes.

A post-auction hearing will be held at 3 p.m. March 19 at the Sheboygan County Courthouse before Judge L. Edward Stengel to approve the sale.

The Statesman will report new information as it becomes available.

Churches to become chapels, mass times decreased

Changes in store for St. Kilian, St. Martin Parishes

It is becoming a situation that has become all too common in the Catholic Church in recent years.

The declining number of priests in the Archdiocese of Milwaukee prompts the closing of more churches or the combining of smaller parishes and chapels under the direction of one pastor.

That will be the case this summer when Shepherd of the Hills near Eden and St. Matthews in Campbellsport will be combined, and the new pastor assigned to those parishes will also be responsible for nearby St. Killian and St. Martin parishes.

Currently, Fr. Neil Zinthefer is the pastor of St. Matthew and the smaller churches. He is retiring in June, as is Fr. Joseph Juknialis, the pastor of Shepherd of the Hills.

This will obviously mean there will be changes coming for all parishioners involved, but it will not mean the permanent closure of St. Killian and St. Martin.

Fr. Zinthefer said earlier this week, there will continue

to be Sunday Masses at the two chapels, but the number will be reduced.

Since 2007, St. Kilian has had Masses on the first, third and fifth Sundays, and St. Martin on the second and fourth, but beginning in April, they will just have one Mass per month. Mass will be celebrated at St. Martin on the second Sunday and at St. Kilian on the fourth Sunday.

Fr. Zinthefer said these Masses will continue to be celebrated at 7:30 a.m., a time he said was voted on by the parishioners several years ago.

The reduced Mass schedule will begin about the same time the two smaller church corporations will become part of St. Matthew Parish's corporation. They will be designated as chapels under that becomes official.

Currently 100 families are registered at St. Kilian and another 82 families at St. Martin. The numbers of households registered at St. Matthew is 600 and at Shepherd of the Hills 929.

"We've kept both of them (church buildings) up, so my successor will not have any big expenses," Fr. Zinthefer said.

Parishioners at St. Kilian and

St. Martin were fortunate that their final full-time pastors, Fr. Victor Kemmer and Fr. Wayne Barta, continued to say Mass at the churches after they retired until they passed away.

As far as his successor, Fr. Zinthefer said other priests in the diocese may indicate their interest in taking the assignment. Sometime during the month of May, Fr. Zinthefer will go to the archdiocese to meet with the candidates to answer any questions they might have.

Both St. Matthew and Shepherd of the Hills have schools, which the candidates might wish to discuss with Zinthefer.

"At that point, we still won't know (who it will be)," he said, adding the official announcement comes in mid-May when all transfers and assignments are usually made by the Archdiocese, and "The new pastor will be coming in mid-June."

Fr. Zinthefer plans on remaining in the area. "I'll be retiring from administration, but I'll work as long as the Lord allows," he said, indicating he plans to help the new pastor and other area pastors with weekend Masses.

Sheriff's deputies handle snowy OWI crash

TOWN of FARMINGTON—A Port Washington man was arrested for suspicion of drunk driving after spinning out of control and hitting another car on Highway 144 Thursday, Feb. 7.

According to an accident report from the Washington County Sheriff's Office, the crash occurred about 10 p.m. near the intersection of highways 144 and 28.

Chad Kawczynski, 41 was traveling northbound when he lost control on the snow covered roadway, spinning into oncoming traffic where Tyler Benz, 24, Kewaskum, was traveling south on Highway 144.

Kawczynski's 2003 Honda Accord struck Benz's 2010 Toyota Corolla with the rear bumper. Kawczynski's Honda came to rest in the west ditch and Benz's Toyota in the east ditch, according to the accident report.

Reports also state that Kawczynski appeared to be under the influence of alcohol. He was arrested at the scene, treated for a head laceration and released from St. Joseph's Community Hospital.

Boltonville Fire Department was joined by Kewaskum EMS at the scene.

On Thursday, the WCSO reported there were approximately 71 vehicles involved in accidents or sliding into ditches.

Loss of Saturday mail delivery not a big deal locally

After August 5, you won't have to check your mailbox on Saturdays, if the United States Postal Service has its way.

On Feb. 6, Postmaster General Patrick R. Donahoe announced that in the face of a \$15.9 billion loss in 2012, the United States Postal Service plans to do away with Saturday mail delivery.

The Service expects to generate cost savings of approximately \$2 billion annually once the plan is fully implemented.

Donahoe said in the past his office faced objections and delays from lawmakers, but added, "We're now at a point where it is absolutely necessary to make that move."

Kewaskum Postmaster Monica LePak said her office was notified of the decision by viewing Donahoe's video Wednesday morning. She says although full time carriers will not be out delivering mail, there will be Saturday parcel deliveries, the retail window and post office boxes will still be accessible, keeping its regular 9-11 a.m. Saturday hours.

While five-day delivery may be a topic of conversation in Kewaskum, many say it won't have an adverse affect on their lives.

At Regal Ware, Senior Vice President Dave Lenz, and Aaron Smith, service manager at Mike's Automotive Service both say curtailing Saturday deliveries won't disrupt business.

"A lot of our business information comes via the web," says Lenz.

And Tina Thull, an owner at Kettle Moraine Gardens, and Gino Guidice, owner of the Bonnie Bell Motel say they will have to remember to send bills on Fridays instead of waiting for Saturday.

Donahoe's announcement was countered by Jeanette P. Dwyer, president of the National Rural Letter Carriers Association, who issued a release which stated in part that many "customers rely on the Postal Service to deliver prescription medications, social security checks and financial statements."

Thull said while some residents at the Gardens may receive prescriptions by mail, when it comes to their monthly check, the Social Security Administration mandated a switch to electronic payments by March 1.

In his video message, Donahoe said the post office has seen a steady decline in first class mail since 2008.

"People pay their bills on line; it's simple, it's easy, it's free, and you cannot beat free," he said.

At Hair on Main, owner and hairdresser Wendi Dreher says a customer told her she is going to save her stamp money, setting up an auto pay system with her bank.

But Dreher was relieved to hear that the window at the post-

office will remain open. As a Mary Kay Cosmetics representative, she will still be able to ship packages on Saturdays.

The post office defaulted \$11.1 billion of its obligation to pre-fund retiree health benefits and both the service and the NRLCA blame fiscal problems on the 75 year pre-funding of retiree benefits, which is mandated to be fulfilled in ten years.

Dear Editor-

I've heard this numerous times. The poor don't pay any taxes.

There is a new study that has just been released from the Institution on Taxation and Economic Policy [ITEP]. It looks at taxes in all states in the country and who pays, please Google it and look it up. Taxes are not just about income taxes, there is much more and many of these taxes and fees, including sales is very regressive.

Seven states currently have NO income tax, Florida, Texas, Alaska, S. Dakota, Nevada, Washington and Wyoming. When you look at these states with no income tax the total taxes paid as a percentage of one's income gets progressively smaller the more money you make. In fact some is quite extreme with the poorest paying up to 16% and the top paying about 2% of their income.

The report breaks down income into brackets, lowest 20% [income of 20k and less], 2nd 20% [21k-36k],

middle 20% [36k-57k], next 15% [86k-150k], next 4% [150k-362k], and the top 1% [362k income and more]. In Wis. taxes are as follows starting at the low end, 9.6%, 10.7%, 10.7%, 10.6%, 9.7%, 8.3%, and 6.9% for the top 1%.

Taxes will soon be becoming increasingly much more regressive in this state also with new laws starting this tax year with the "domestic production tax credit" pushed through by our very own Glenn Grothman. This is a tax credit for corporations and large dairy farmers with "pass through" entities such as LLC's, S corps and C corps that push through the tax onto the personal income rather than the corp. tax.

Many of these claim to be small business but in fact employ many thousands of people. This is exactly why there was an earned income credit [which Walker and the Republicans] have changed effectively raising taxes on some poorer people. Now the Republicans are talking about eliminating the income tax

altogether. This really is the only true FAIR tax. To me this is IMMORAL. It is high time religious leaders call out some of these politicians for this.

This Valentine's Day Butschlick reflects on keeping a healthy heart

Sue Butschlick and her husband Tony have been partners since they attended Kewaskum High School.

In his senior year, Tony, a football player was on homecoming court. He invited Sue to be his date. They graduated in 1970, and for 41 years, they've worked shoulder to shoulder, raising five children and enjoying nine grandchildren.

On July 15, 2012, their partnership added a different dimension when Sue, 60 suffered a heart attack.

Now Tony is also her partner in wellness.

"When I'm working, he calls me at noon to ask if I've gotten my walk in," says Butschlick.

This month the American Heart Association is celebrating the tenth anniversary of Go Red for Women, which dispels myths and raises awareness about the number one killer of women.

Sunday July 15, was a hot day. Sue had picked up sub sandwiches for dinner and when she arrived home, she felt a pressure in her chest.

"I'd had that before and thought, 'it'll go away,' says Butschlick.

Two weeks earlier, Sue was taking one of her regular walks around the neighborhood when she started to experience chest pain.

"I was half way home, so I kept on going. At no point did I think I was having a heart attack," says Butschlick.

Mathilde Egge, clinical exercise physiologist at Froedtert Health St. Joseph's Hospital says whether childbirth increases

"They gave me nitro and the pain started going away, little by little," she says.

While Butschlick's symptoms were what people think of when it comes to heart attacks, Egge says because women's blood vessels are typically smaller than men's, symptoms can vary.

While some, like Butschlick, experience chest pain, Egge says women overlook other symptoms, like nausea, sudden onset of light headedness, dizziness, shortness of breath, unusual fatigue, upper arm discomfort or pain between their shoulder blades or at the jaw line.

"Some people think they have a toothache instead of angina," says Egge.

At St. Joseph Community Hospital Butschlick's condition was stabilized and she was transferred to Froedtert Hospital in Milwaukee. There, she was diagnosed with a blocked artery in lower left vessel of her heart.

Heart problems are not new to Sue's family - her mother died of a stroke and her dad of heart failure. Her youngest son had Friedreich's ataxia, an inherited disease that causes progressive damage to the nervous system and can lead to heart disease. He died of a cardiac arrest at age 21. Her brother Dick died of a heart attack at age 54.

Like Sue, her son and brother were physically fit.

A non-smoker, non-drinker who wasn't overweight was occasionally teased by coworker because of her healthy diet.

"I'd eat celery and peanut butter and bring salads to work," says Butschlick.

The morning after Butschlick arrived at Froedtert doctors inserted a titanium stent and found more blockages, which are being treated with medication.

She continued her recovery at St. Joseph's with a 36-week stint at St. Joseph's Cardiac Rehabilitation Unit, where Butschlick found a supportive staff and made friends with others who were going through similar rehabilitation.

"You're scared when you get there, but they help build up your confidence - that's a lot

of what rehab is all about," says Butschlick.

In addition to rehab, the Froedtert offers classes on exercise, nutrition, taking medications, information on cholesterol levels, blood pressure and how to manage stress.

"Don't become discouraged, take it step by step. It will eventually lead you to a healthier heart," says Butschlick.

Her cardiac rehab "graduation day" was Oct. 24, 2012, but that didn't stop her from listening to her body.


"When my rehab was over, I found that I needed to priori-

tize and take time for myself, by keeping up with exercise and eating healthy. It also helps to have such a loving family that stands behind you for support. As a reminder for me, all I have to do is see them or look at their pictures. They make me smile, and it gives me the number one reason to stay heart healthy," says Butschlick.

Butschlick urges others to take the time to care for themselves, voice their concerns to their doctor and follow their advice.

"I don't take things lightly anymore," says Butschlick.



Visit to the Siberian Outpost
Farmington Elementary School

Farmington Elementary School students led by teachers Mrs. Gruett and Mrs. Nelson, on January 3 visited the Siberian Outpost in Malone. This field trip connected with a winter theme unit where students read books about dog sledding and the Iditarod.

Some of the books the students read included, Balto, Stone Fox, and Akiak. The books focused on the culture of living in Alaska and how people adapt to the environment. The students explored the conditioning and training of the dogs and mushers to complete a race of that caliber. Students learned about this in Balto as the teams raced to Nome, Alaska to save

the lives of those suffering from diphtheria. The great race, known as the Iditarod, now runs 1,180 miles on this trail from Anchorage to Nome.

After reading various books and discussing how important it is for dogs to train pulling sleds through the snow and harsh weather, students were ready to visit the Siberian Outpost. The group was greeted by the very knowledgeable owner, Jim Feyen, who allowed the students to pet the dogs and look at the facility and equipment.

Students were able to experience firsthand the dedication of a musher as well as the training and intelligence of the dogs. They were able to see how

the dogs were harnessed based on their position in the team to pull the sled. Each sled had ten dogs pulling; therefore, they could pull 1,000 pounds. Each dog is capable of pulling about 100 pounds. The students all got to experience a ride on the sled.

After the rides, students gathered together to learn more about dog sled racing. Feyen explained the different positions of the team and what makes a lead dog or a wheel dog. Students were able to answer questions based on what was learned in class and read in books.

KHS' Steers is national board certified educator

KHS social studies teacher Jeffrey Steers achieved his national board certification in Social Studies/History, Adolescence and Young Adulthood.

The assessments include four portfolio entries that feature teaching practice and six constructed response exercises that assess content knowledge, which are reviewed by trained teachers to evaluate how well the educator has demonstrated their teaching knowledge, skills and practices.

The certification program usually takes between one and three years to complete.

Steers is one of 27 teachers that earned their certification in 2012. According to a press release from the state Department of Public Instruction, Wisconsin now has 818 educators, among the state's 60,000 teachers teaching in state schools who hold a national certification.

Wisconsin is one of several states that provides salary incentives and covers some of the costs toward the advanced credential.

"I'd say ninety-five percent of them liked it," Grotenhuis said. "For some it was a challenge. Others could have taken one of the harder trails."

"More than skiing, the kids see snow on the pines, and deer," Chad Gornjak said.

Grotenhuis wore an outdoor trail camera during the exercise. It took a picture every thirty seconds. He uses it to catch the reactions of the students and their skiing techniques and may show the students clips. Grand money paid for the bus trips to the trail, and for the equipment used by the

students.

The parking lot for the trail is located on County SS not far north of the park office on County G, north of Kewaskum. Check the conditions of the trails before heading out.
